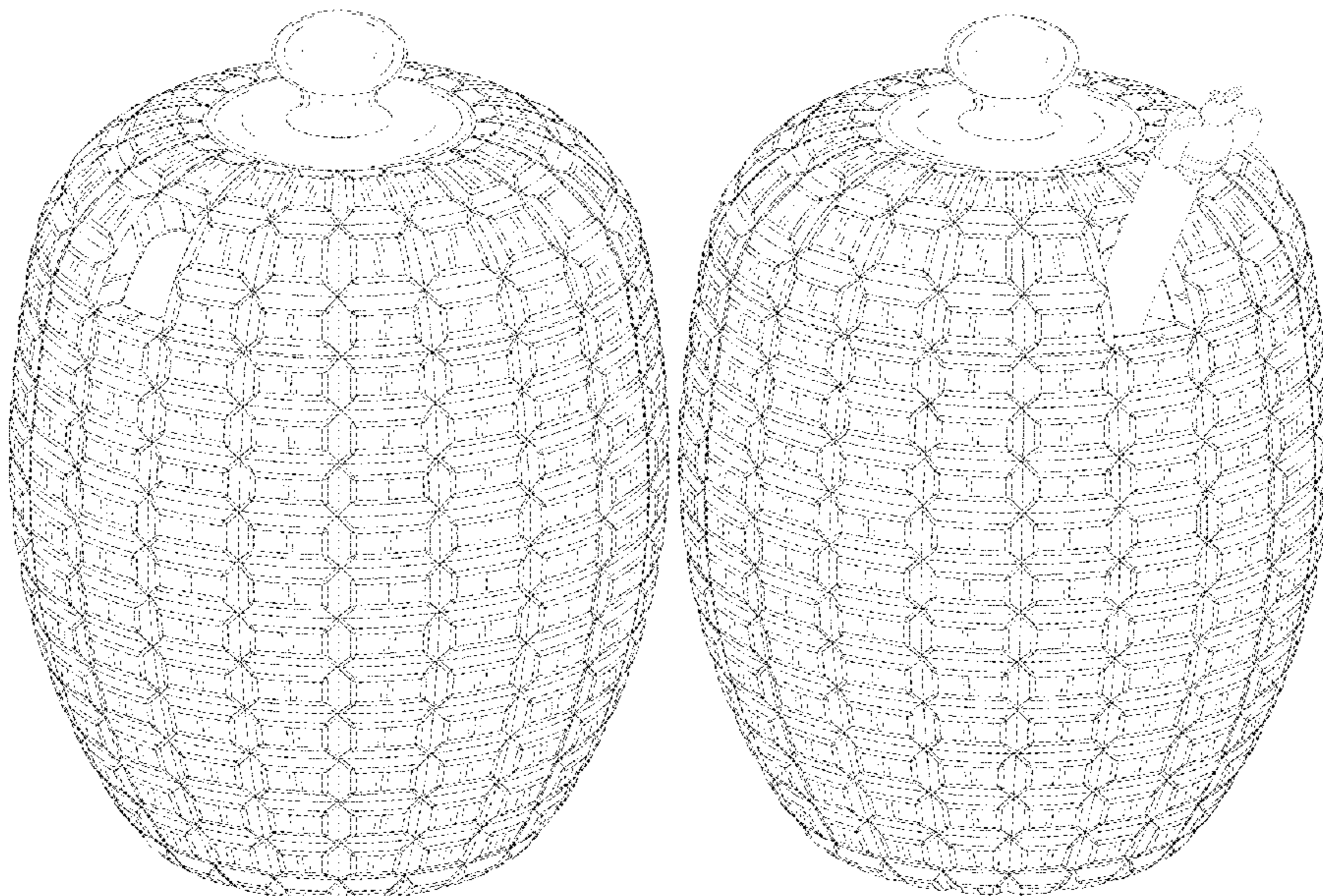
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front and top perspective view of a honey jar, showing my new design;

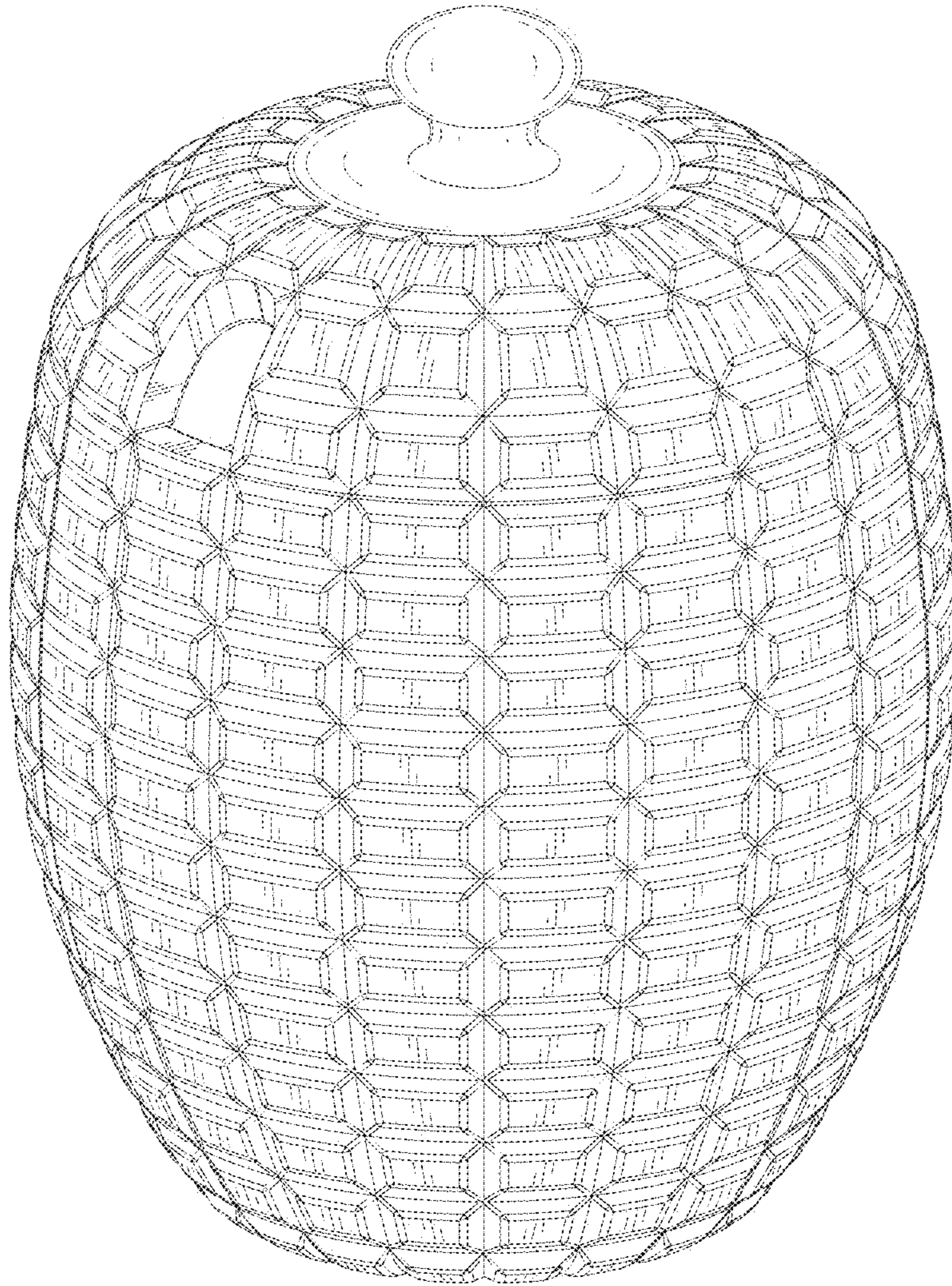

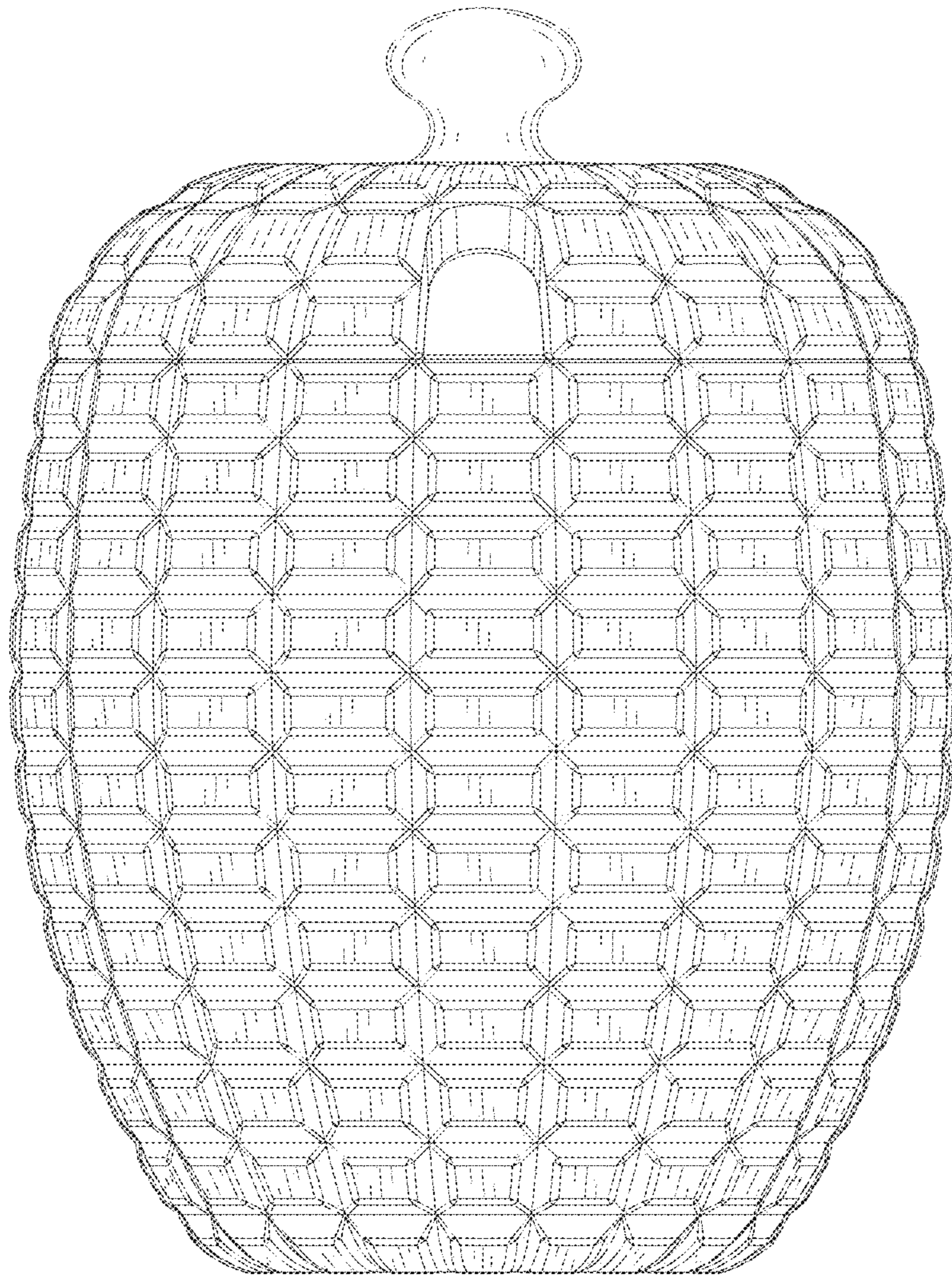

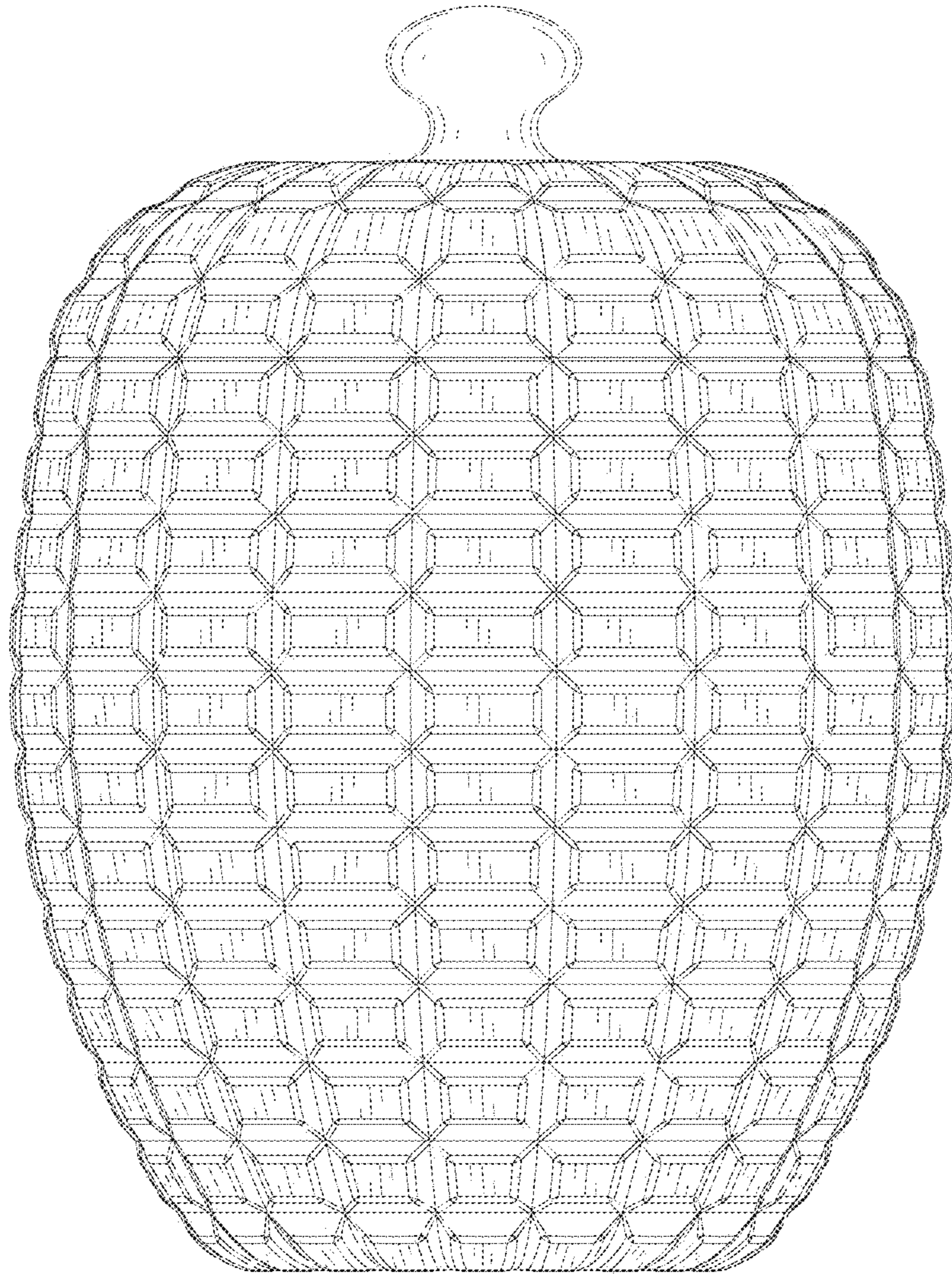

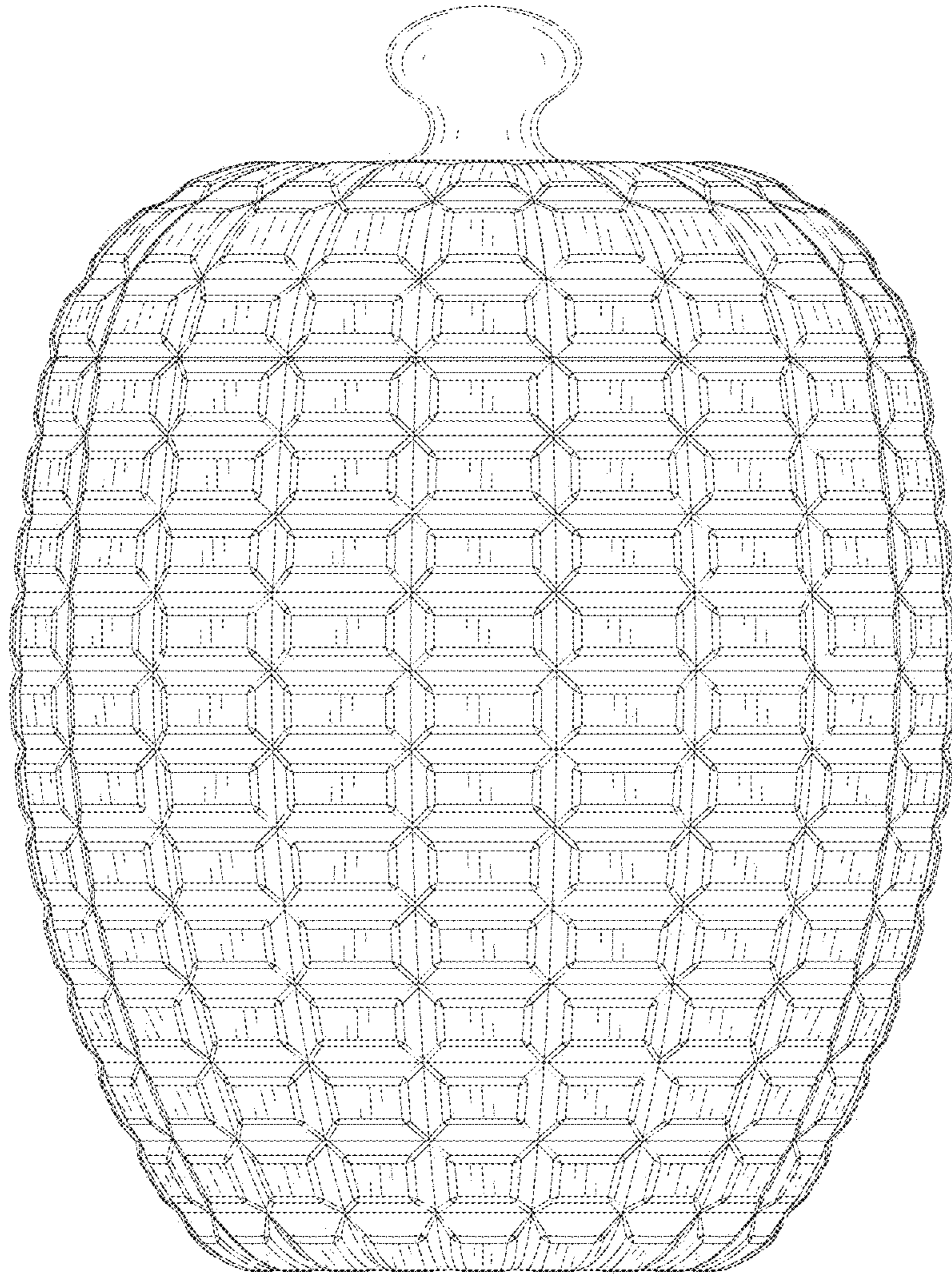

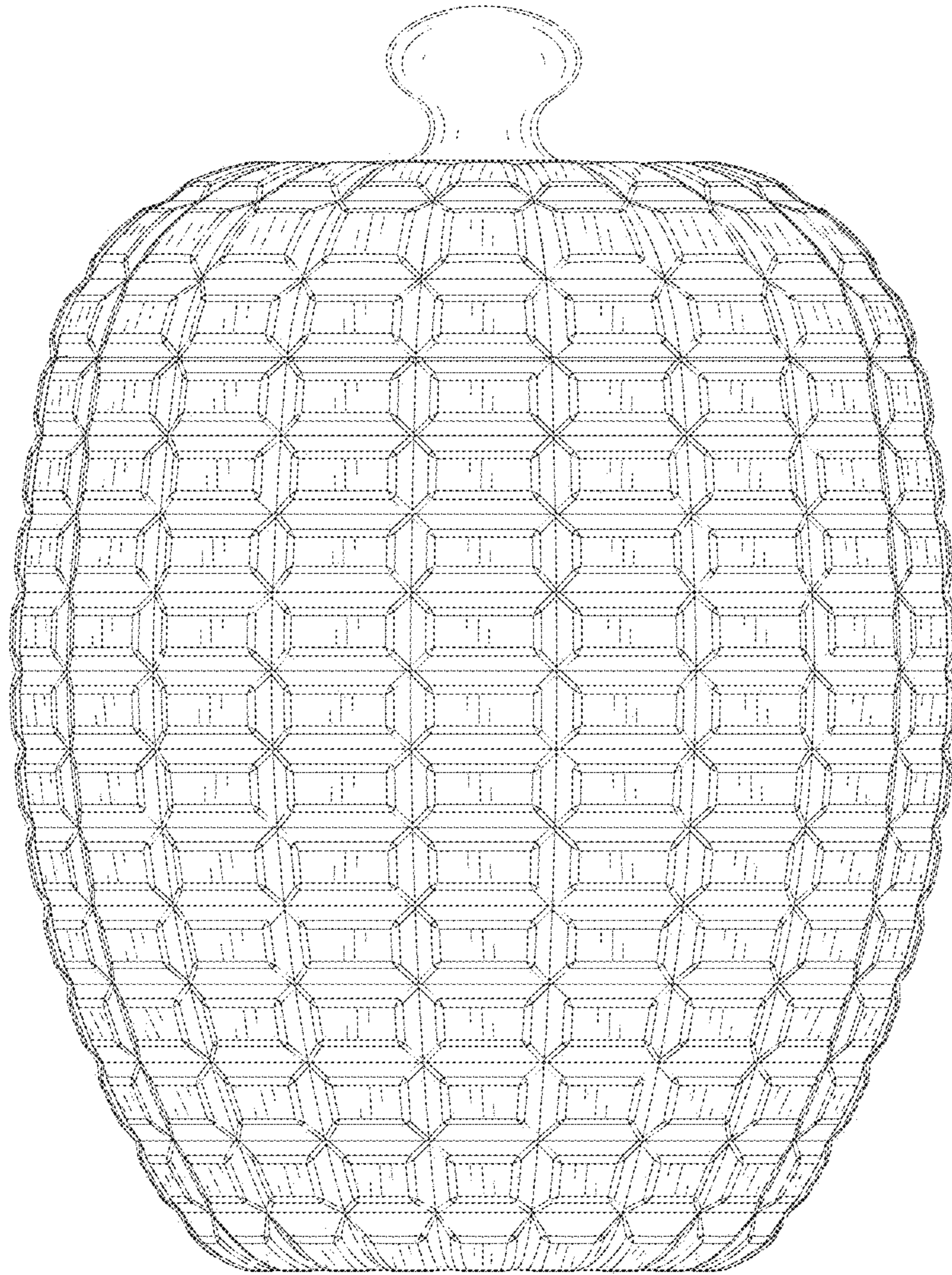

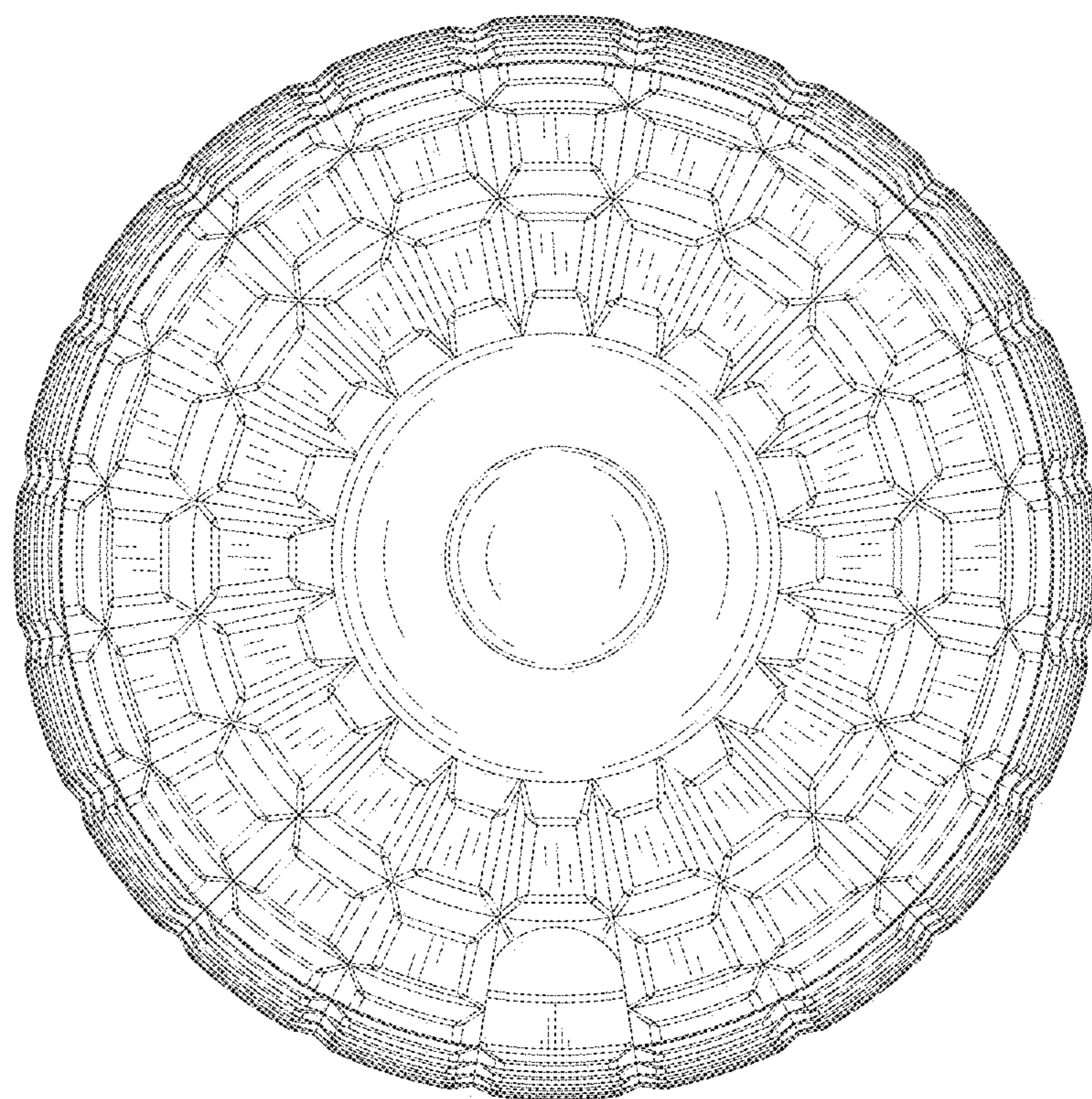

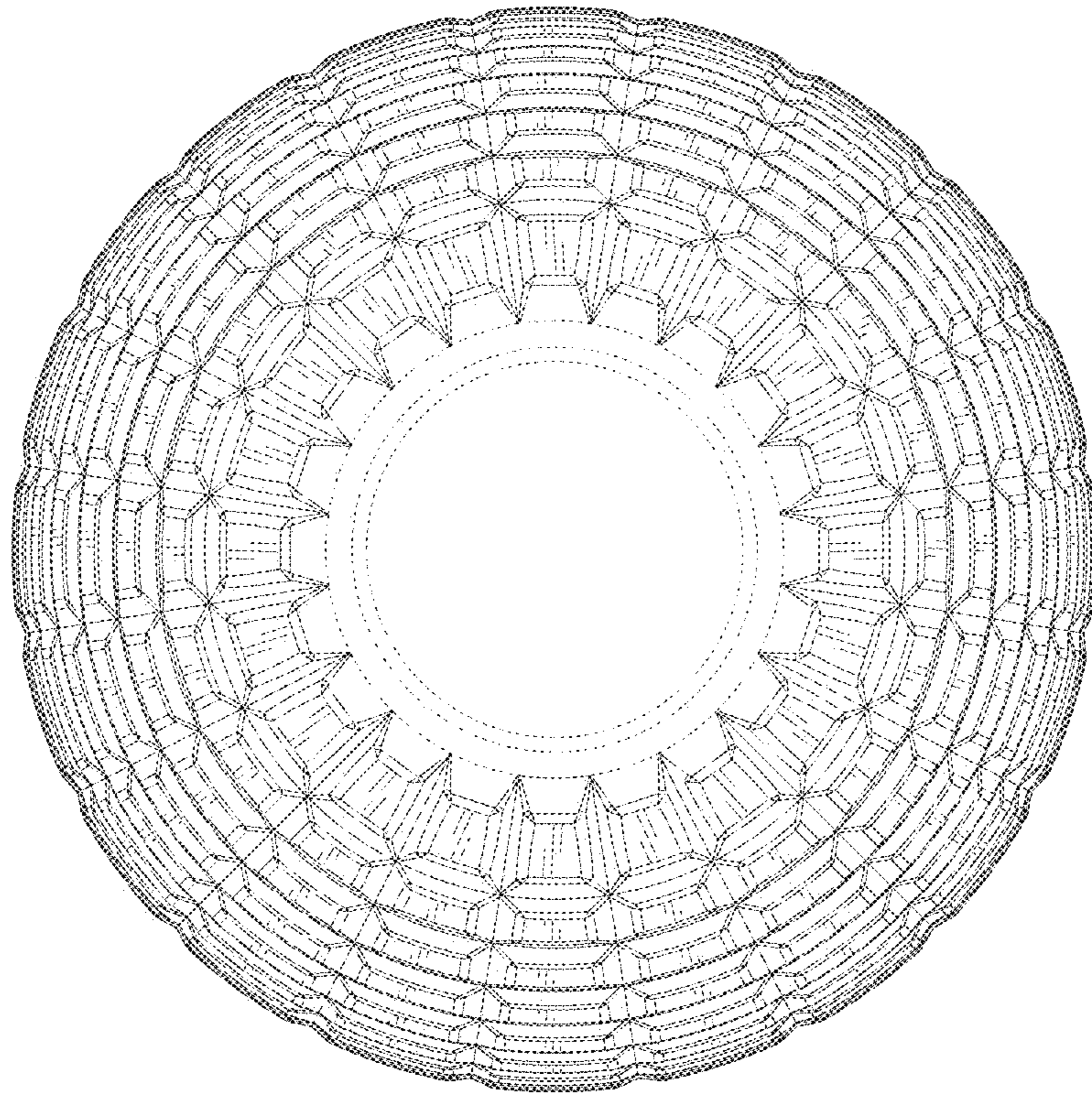

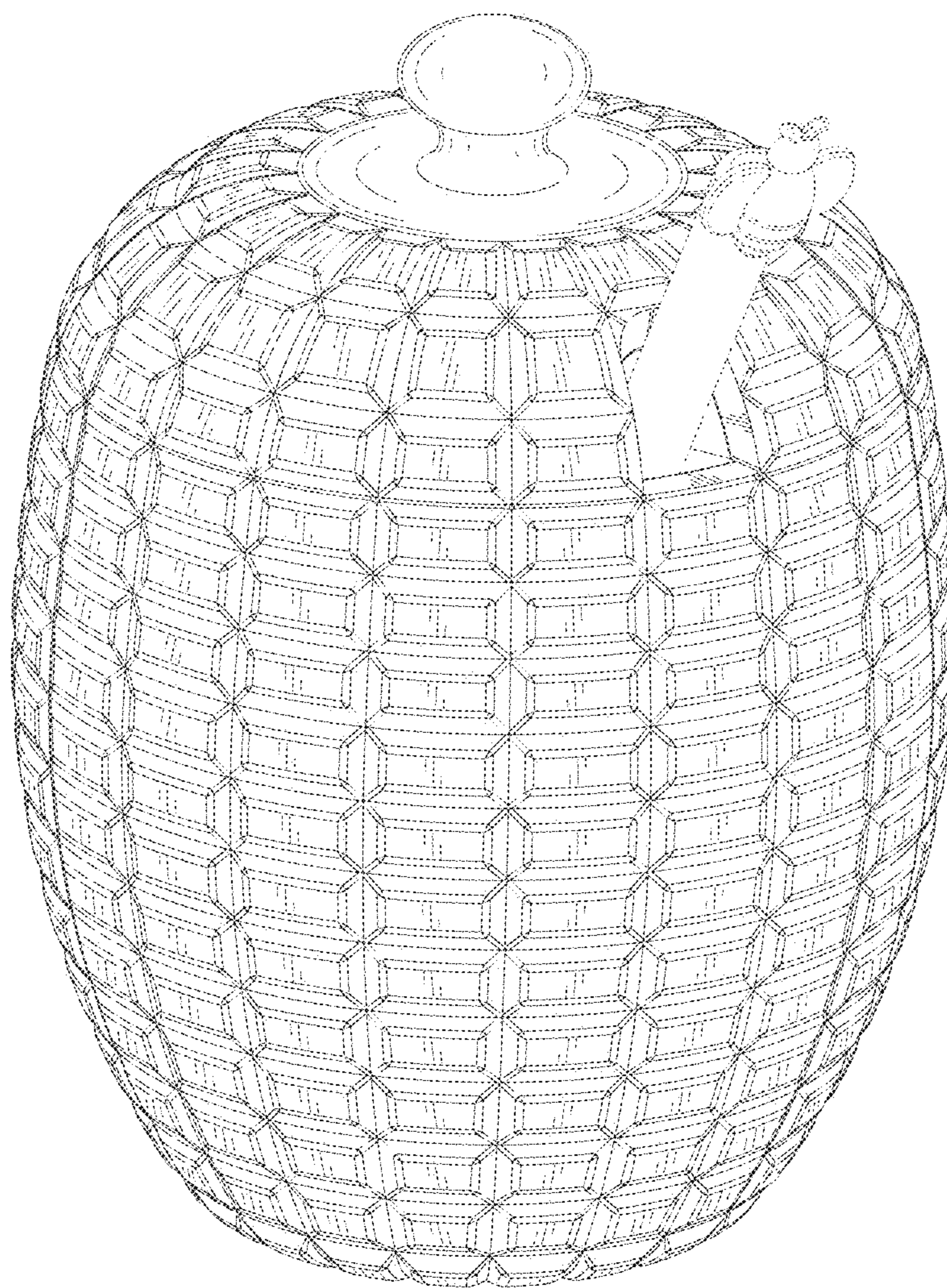
