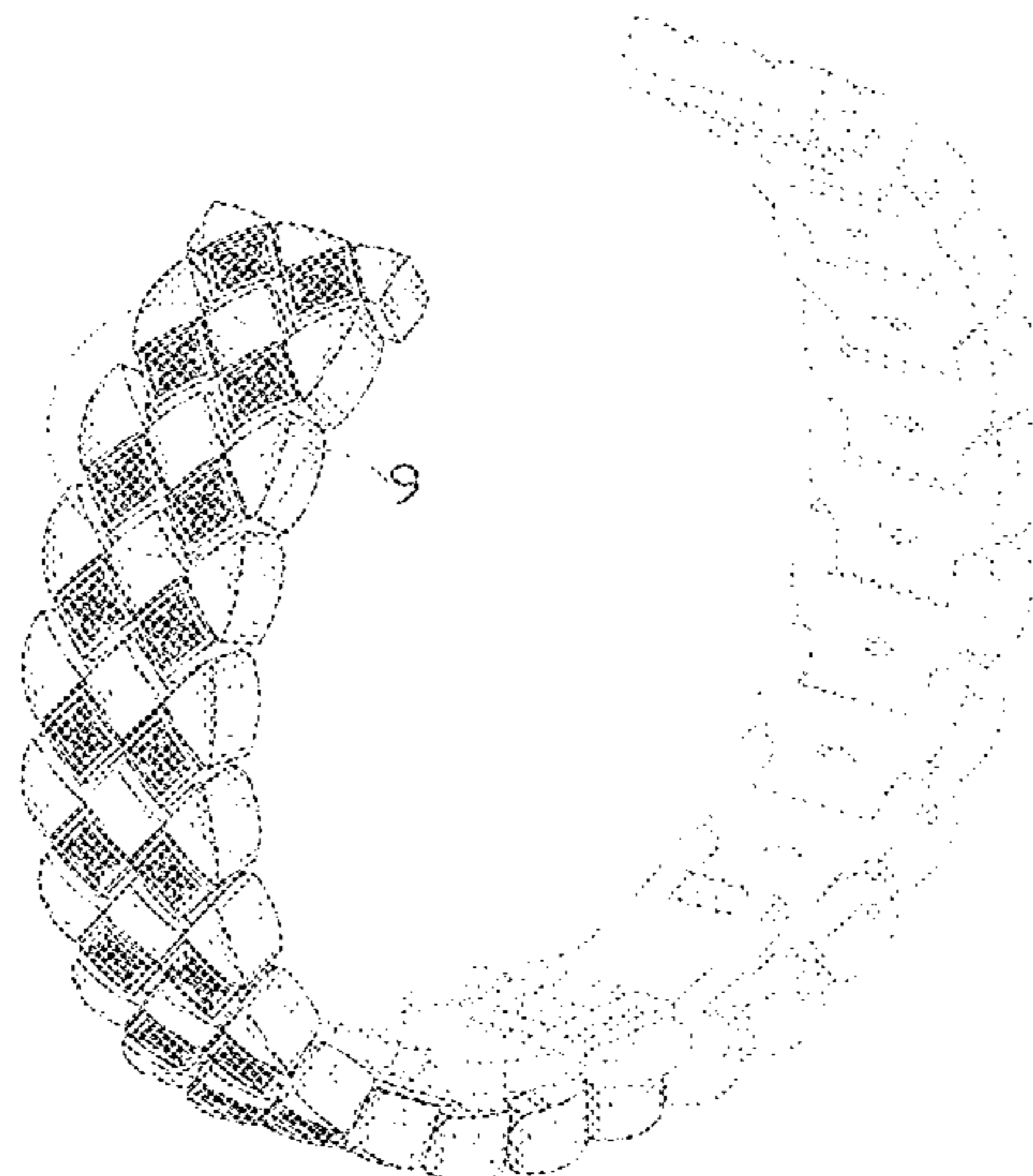
The ornamental design for a watch strap, as shown and described.

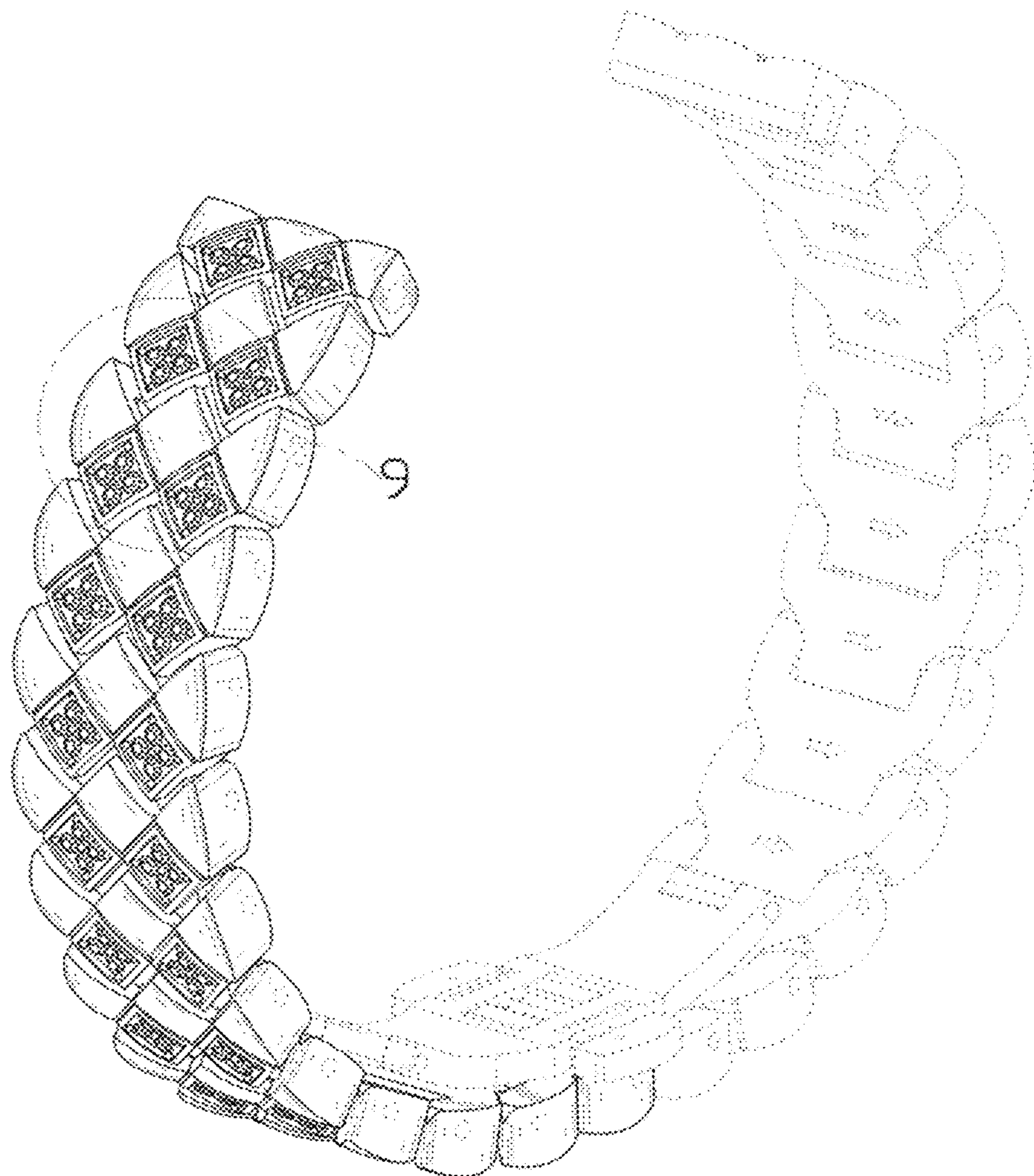

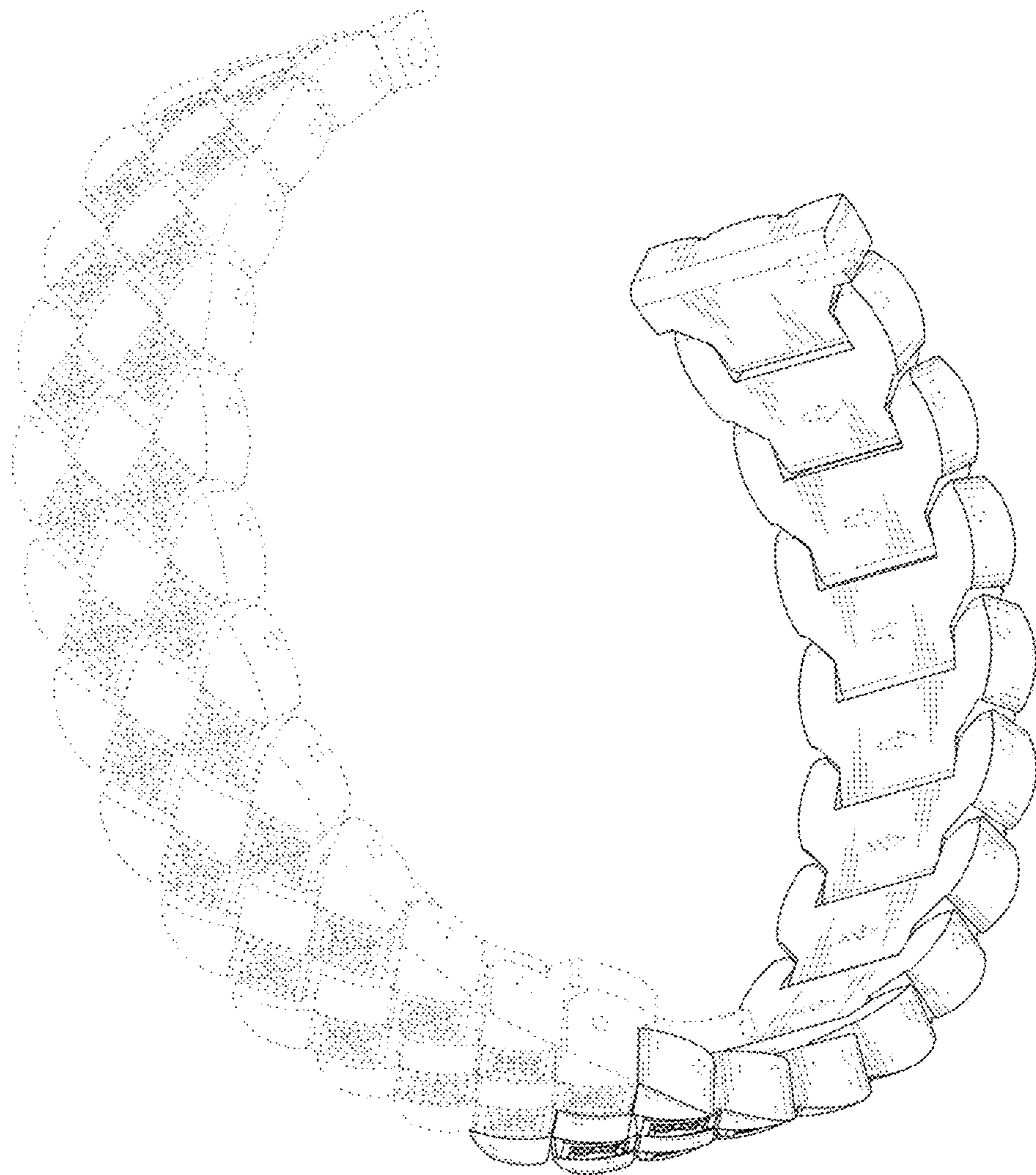

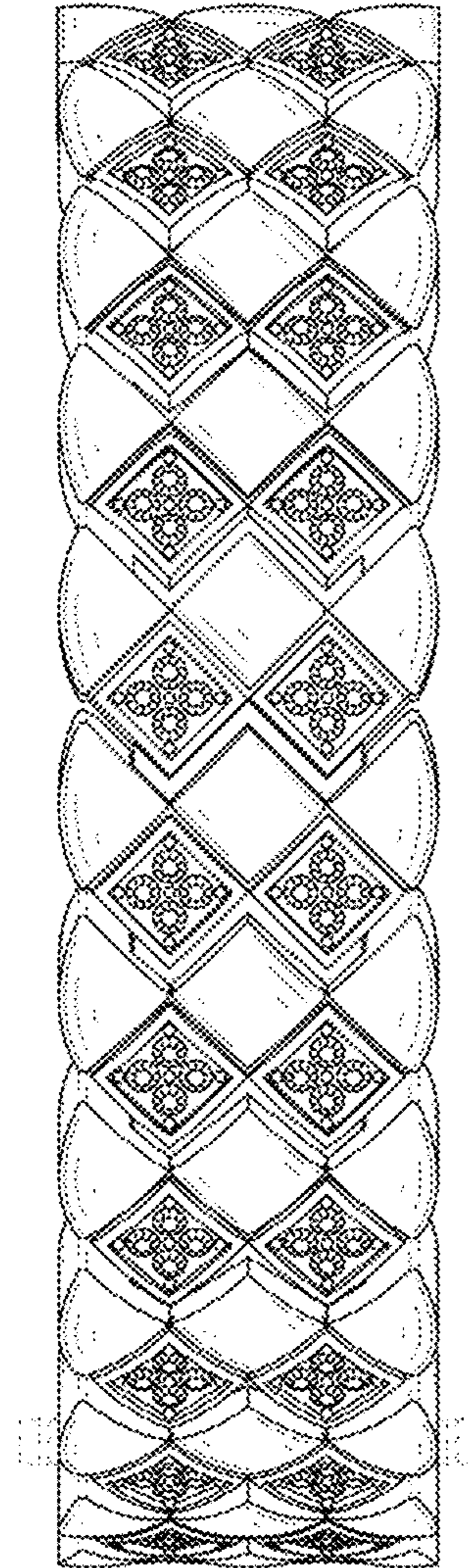

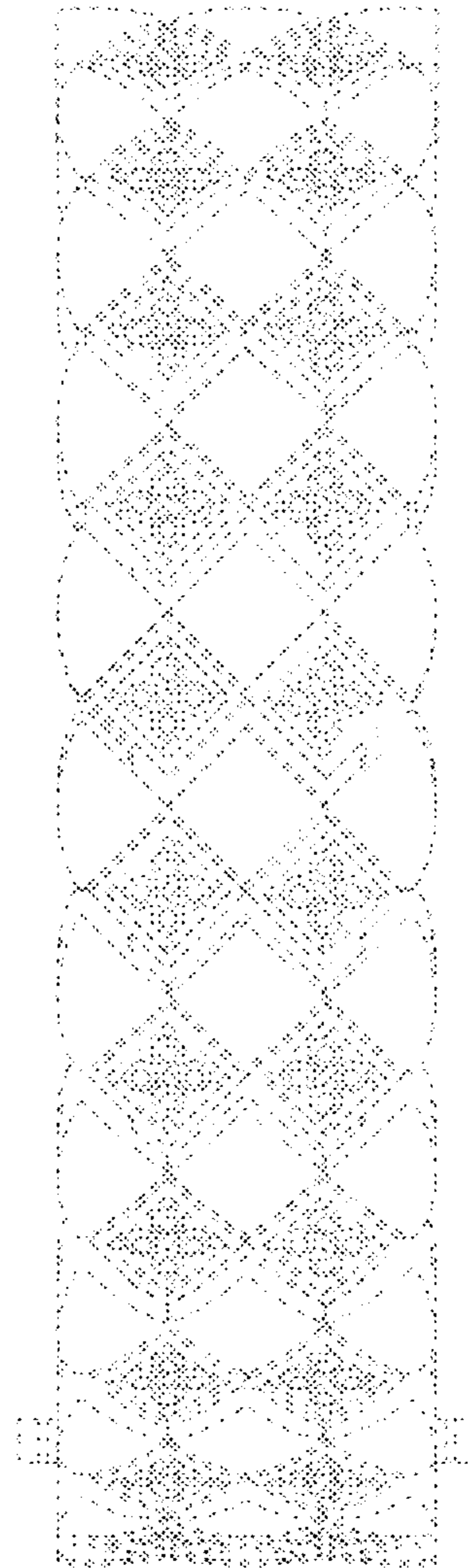

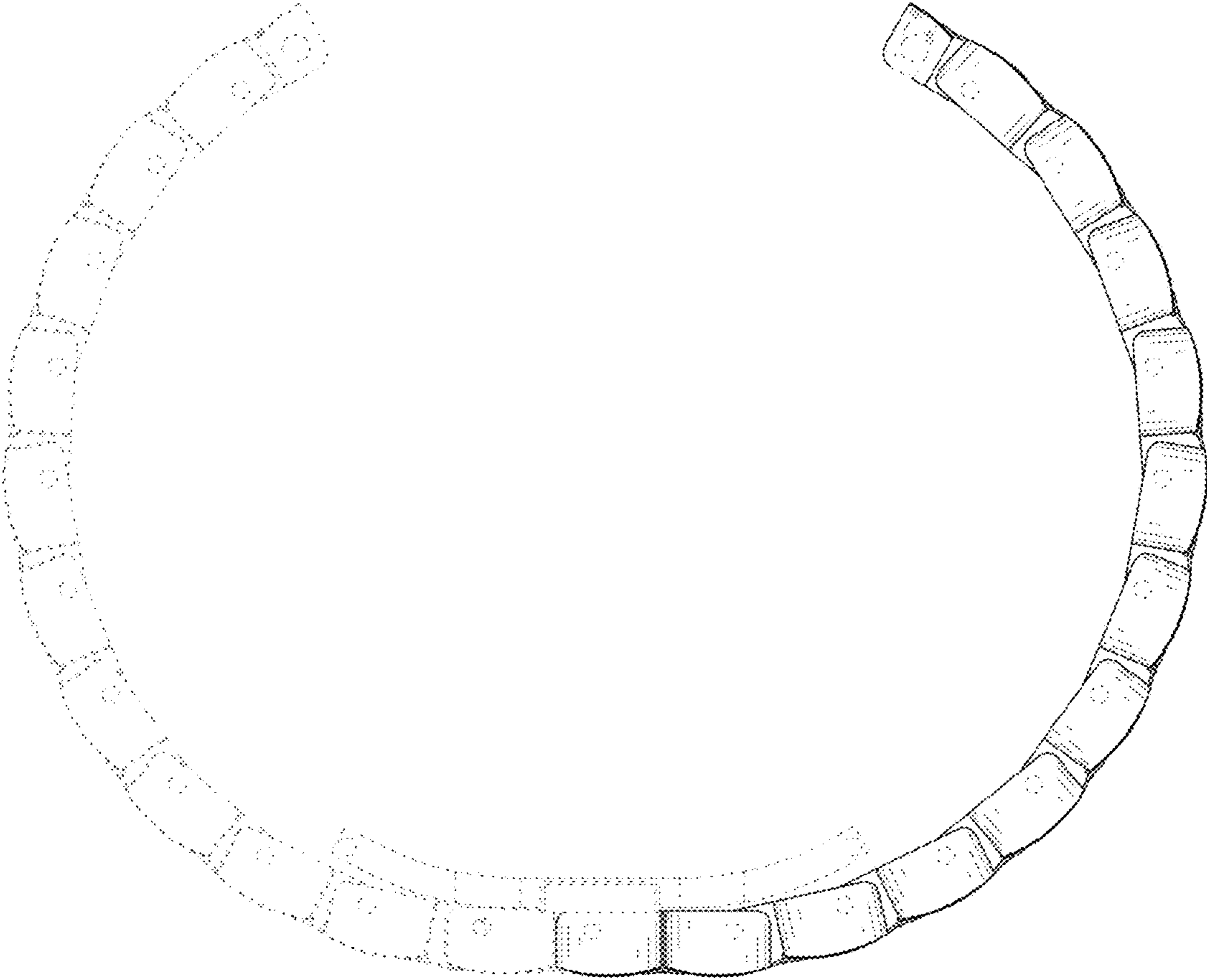

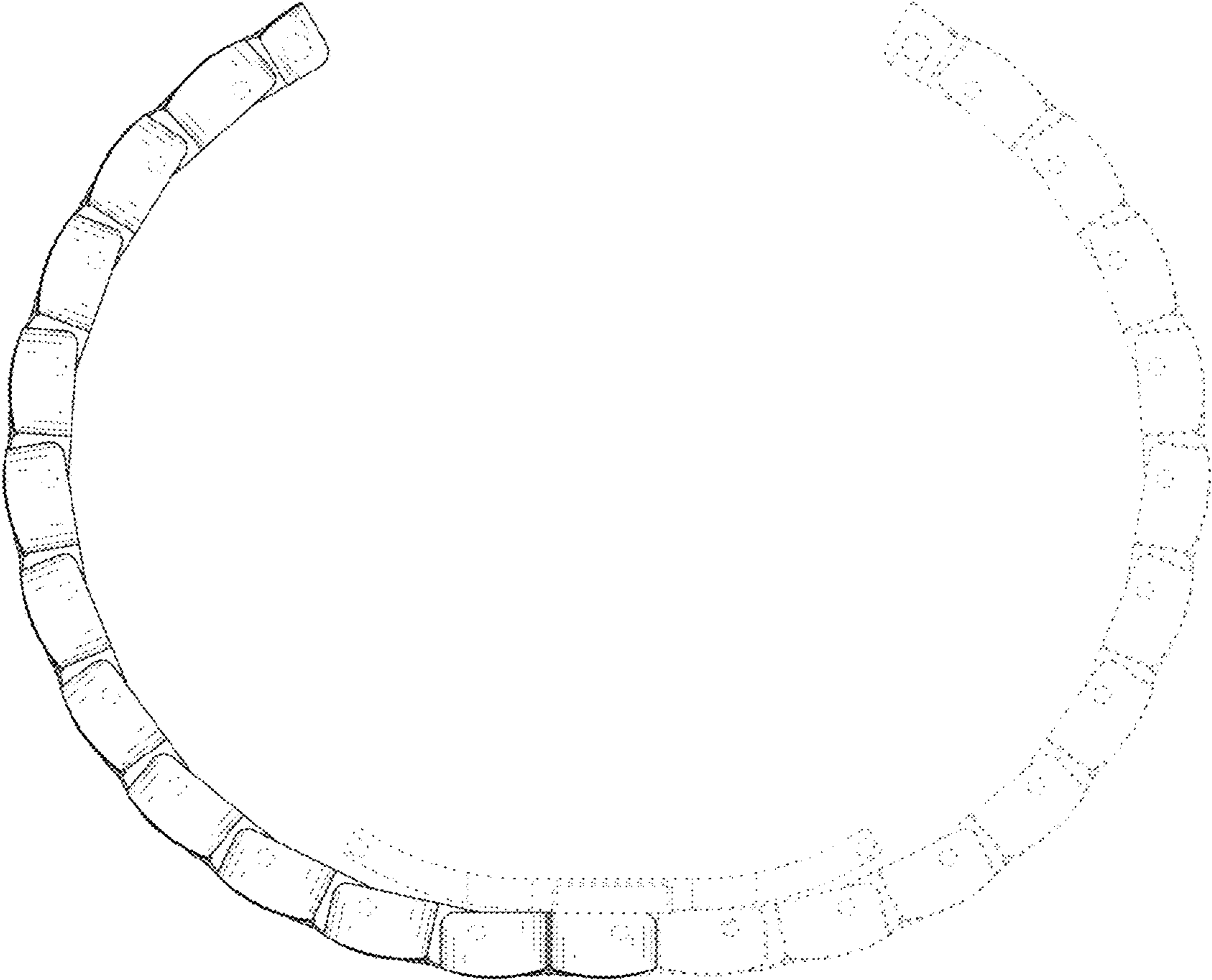

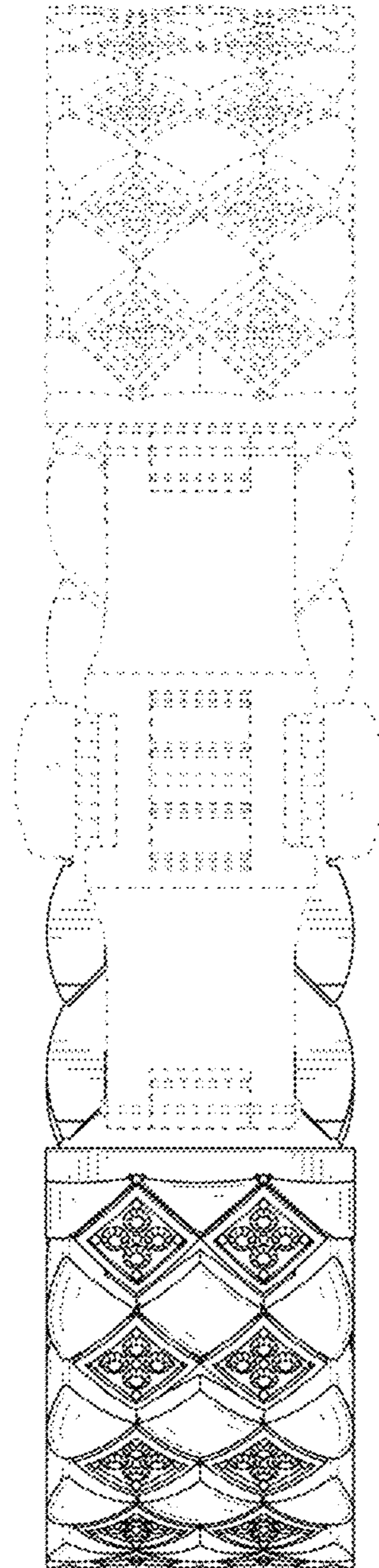

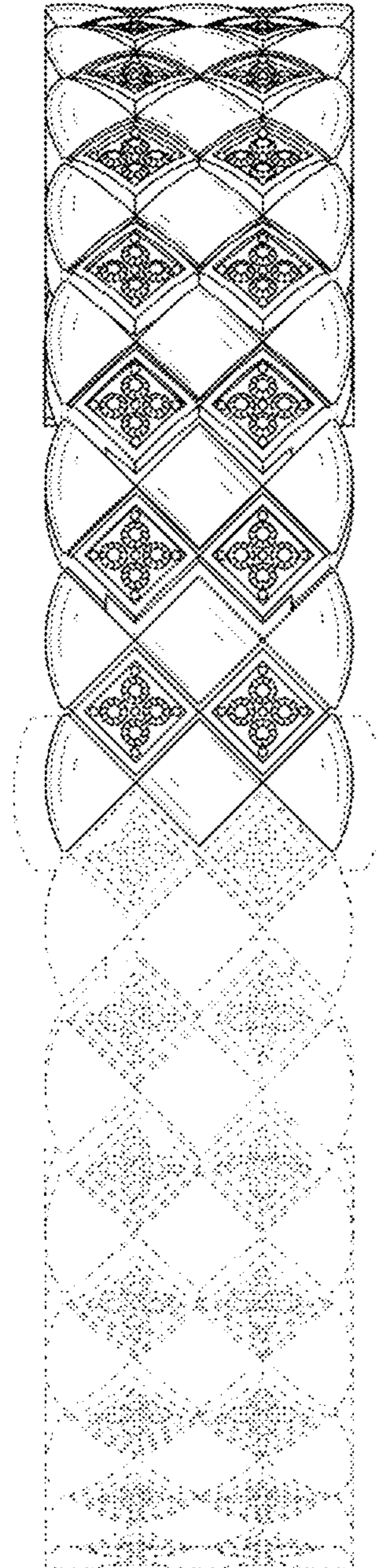
