FIG. 4 is a rear view of the artificial floating lily pad cluster of FIG. 1.

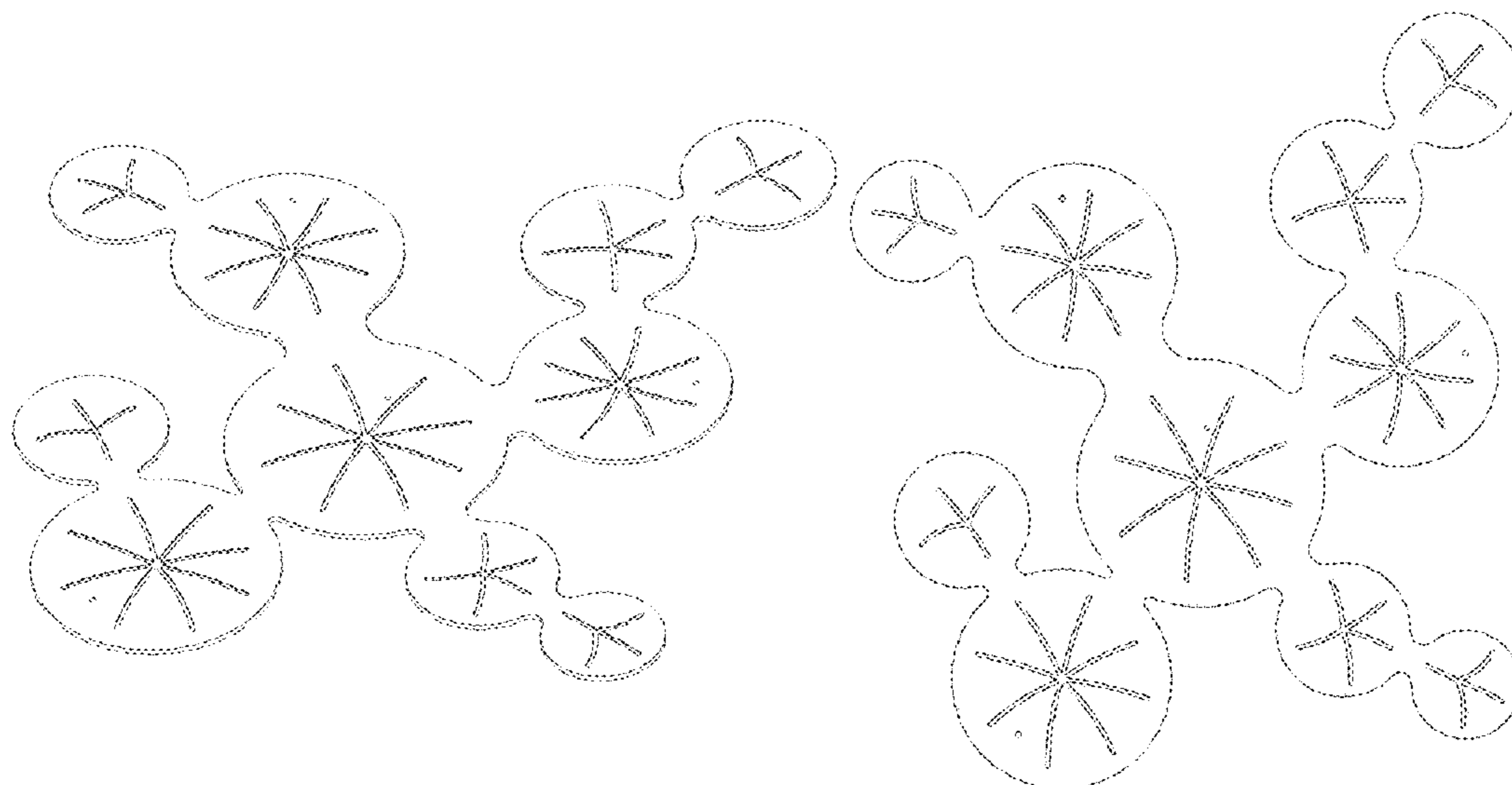
FIG. 5 is a first side view of the artificial floating lily pad cluster of FIG. 1.

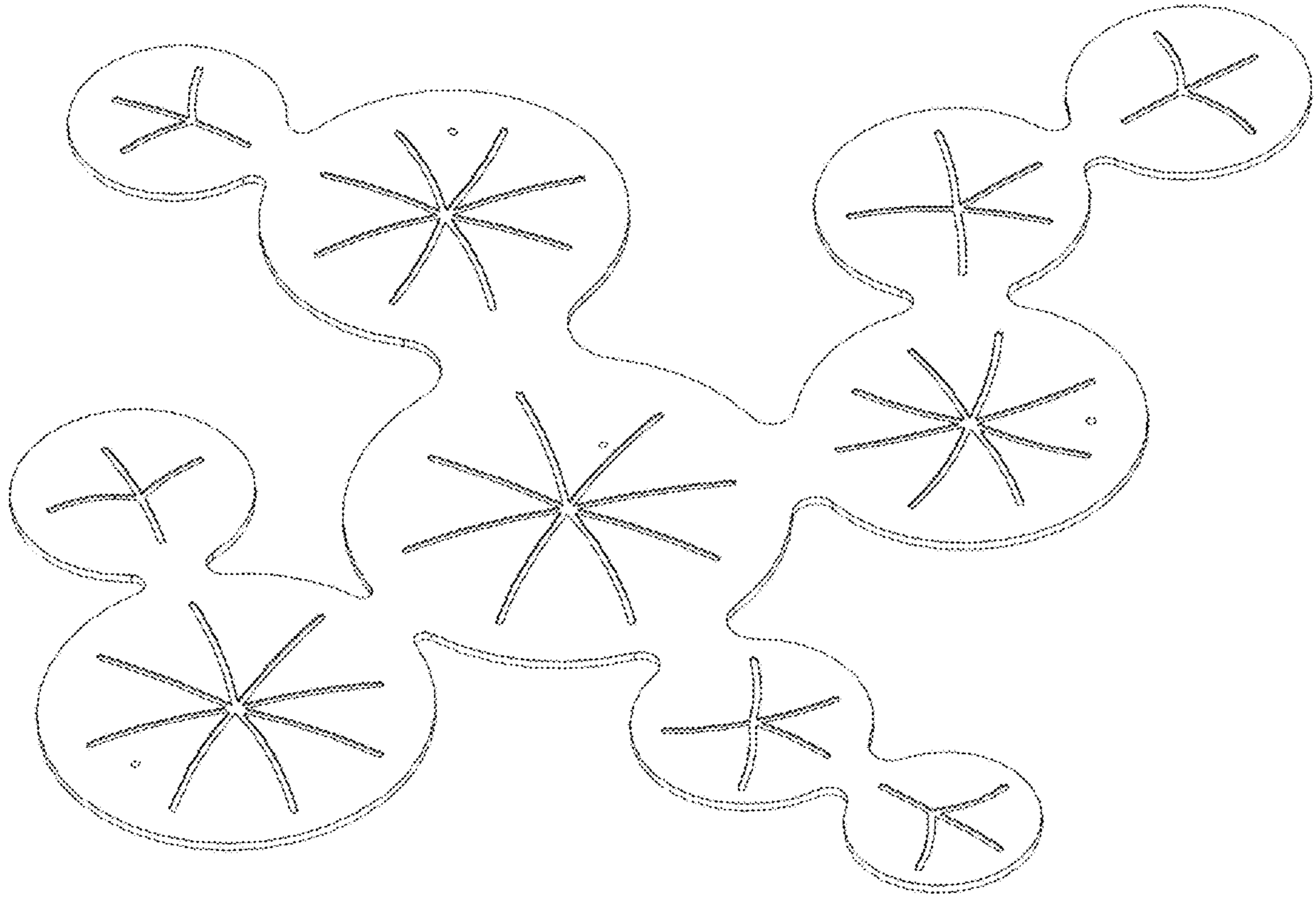

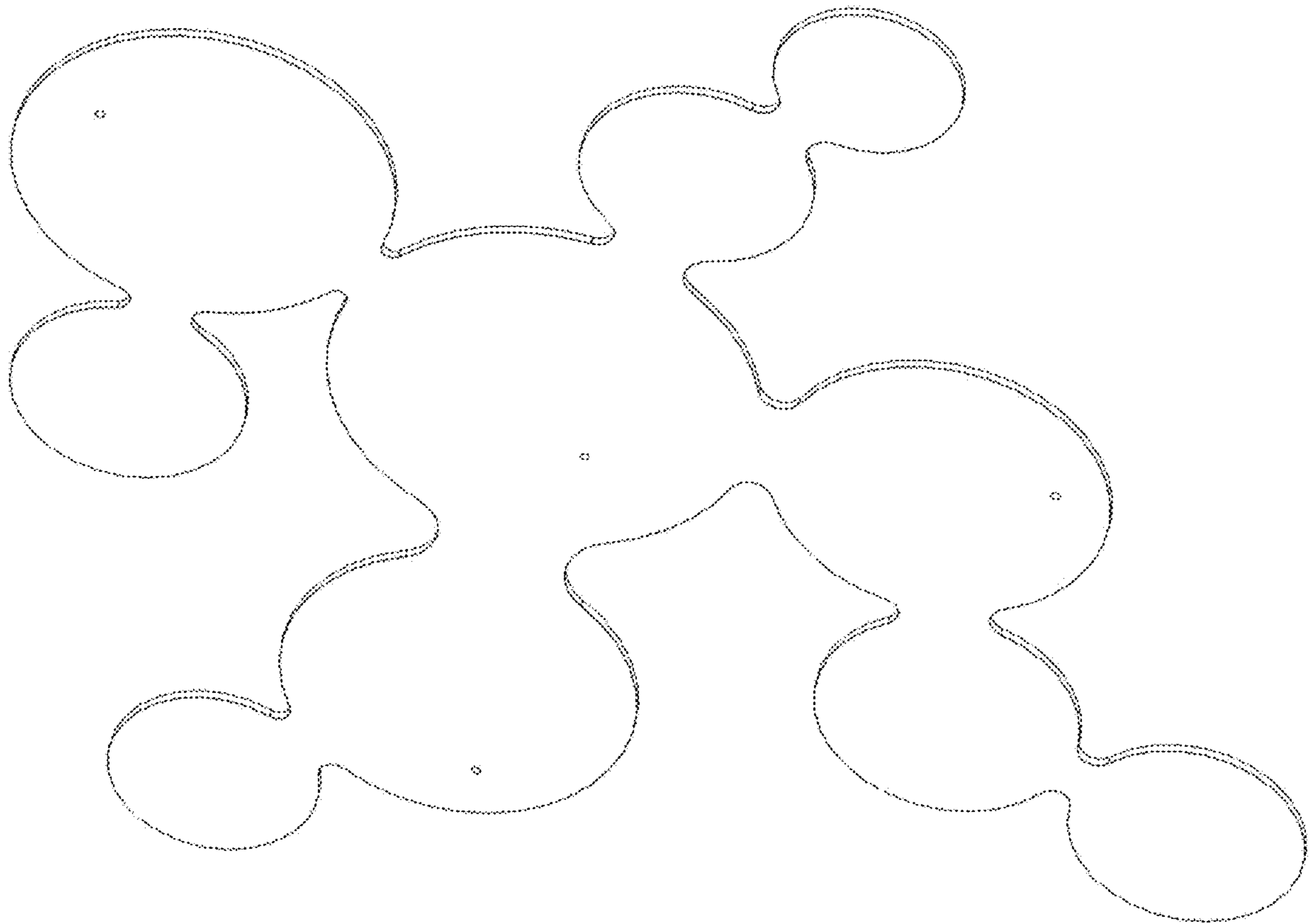

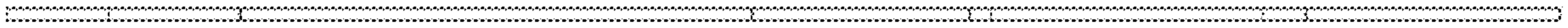

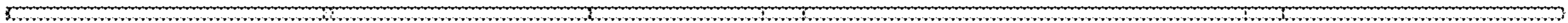

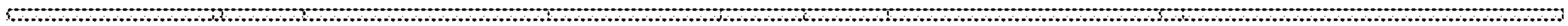

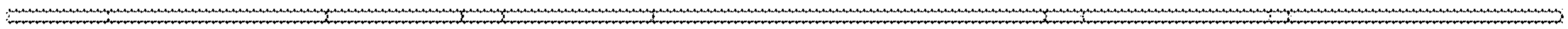

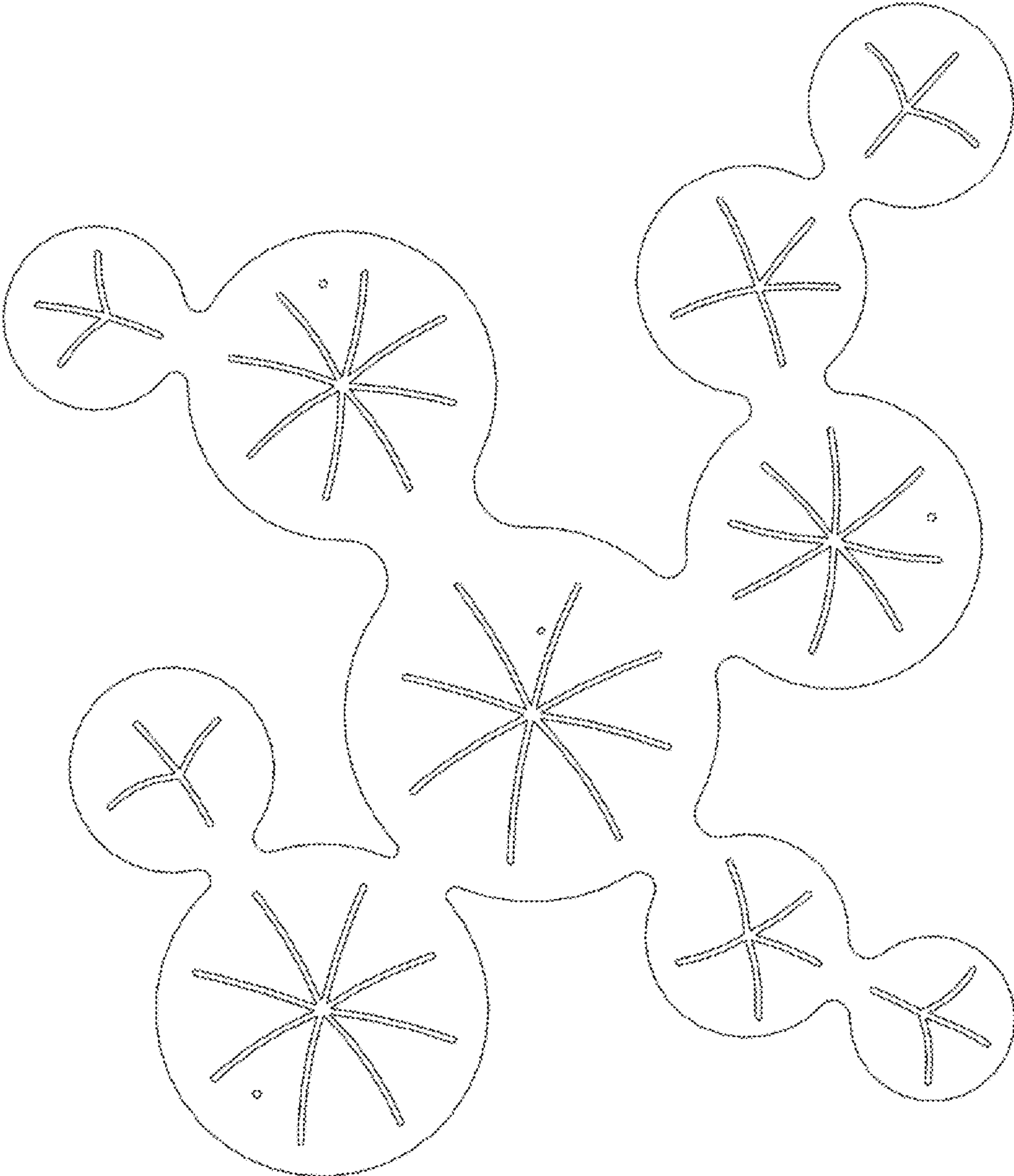

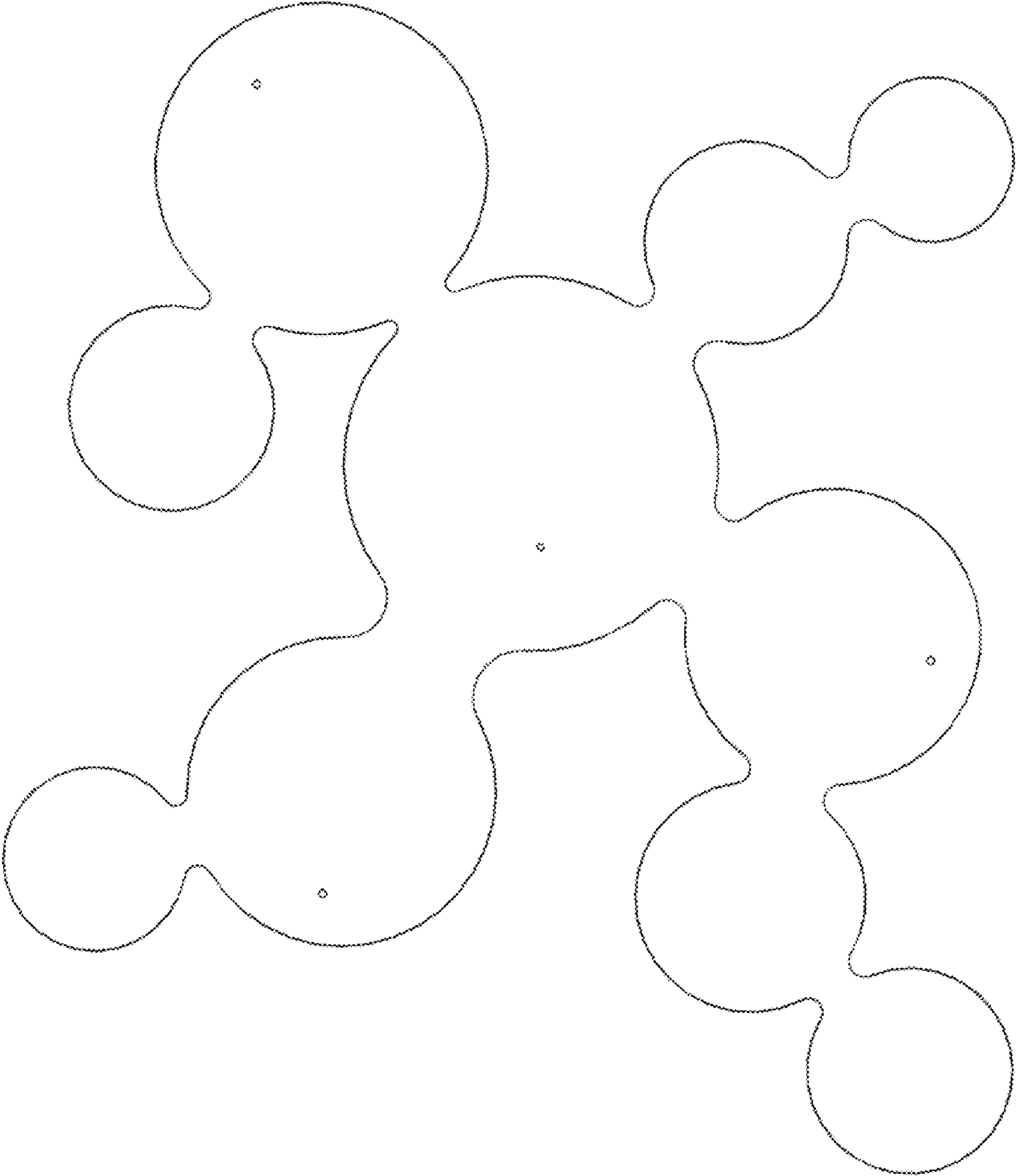
