The ornamental design for a vehicle front bumperette, as shown and described.

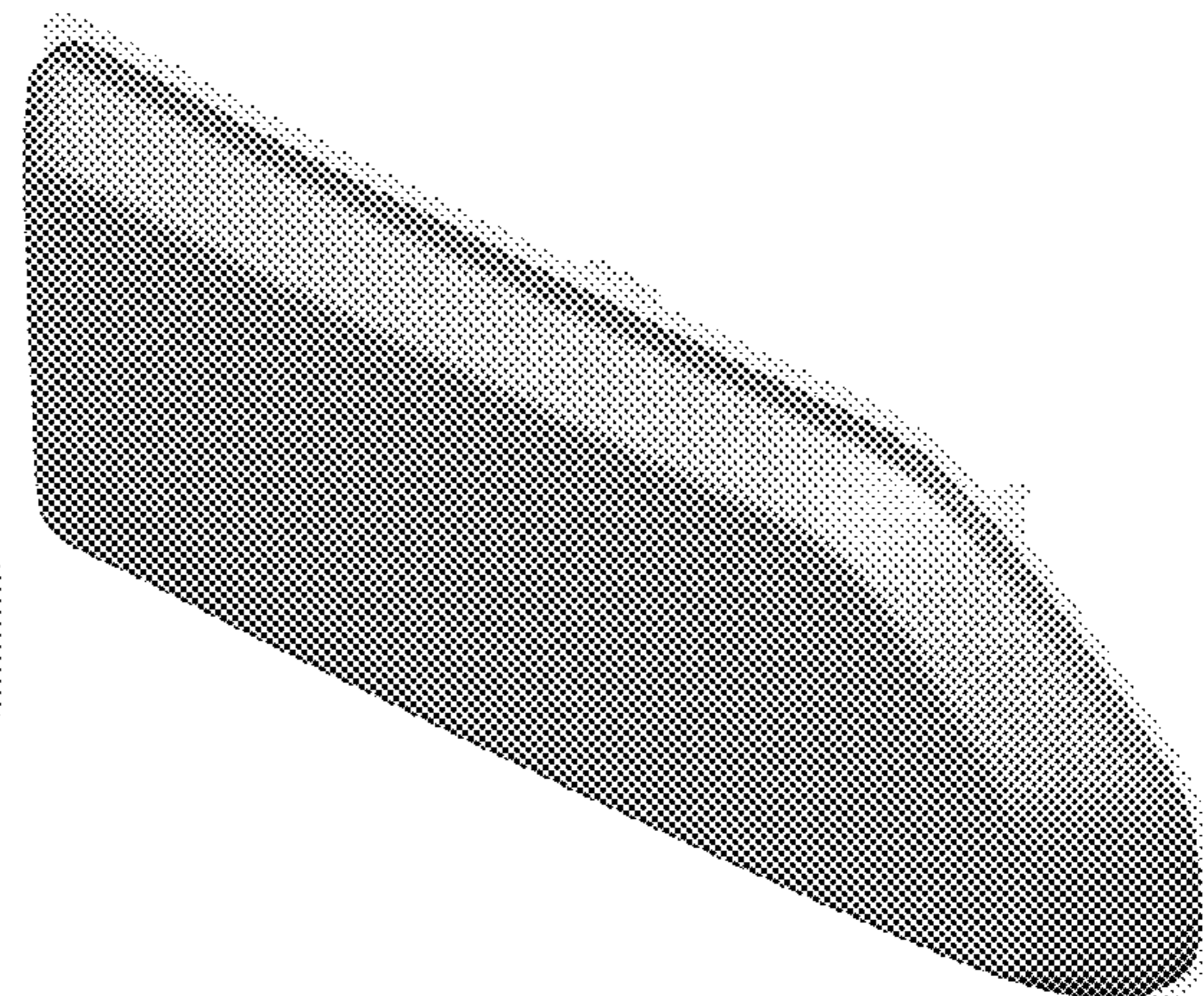
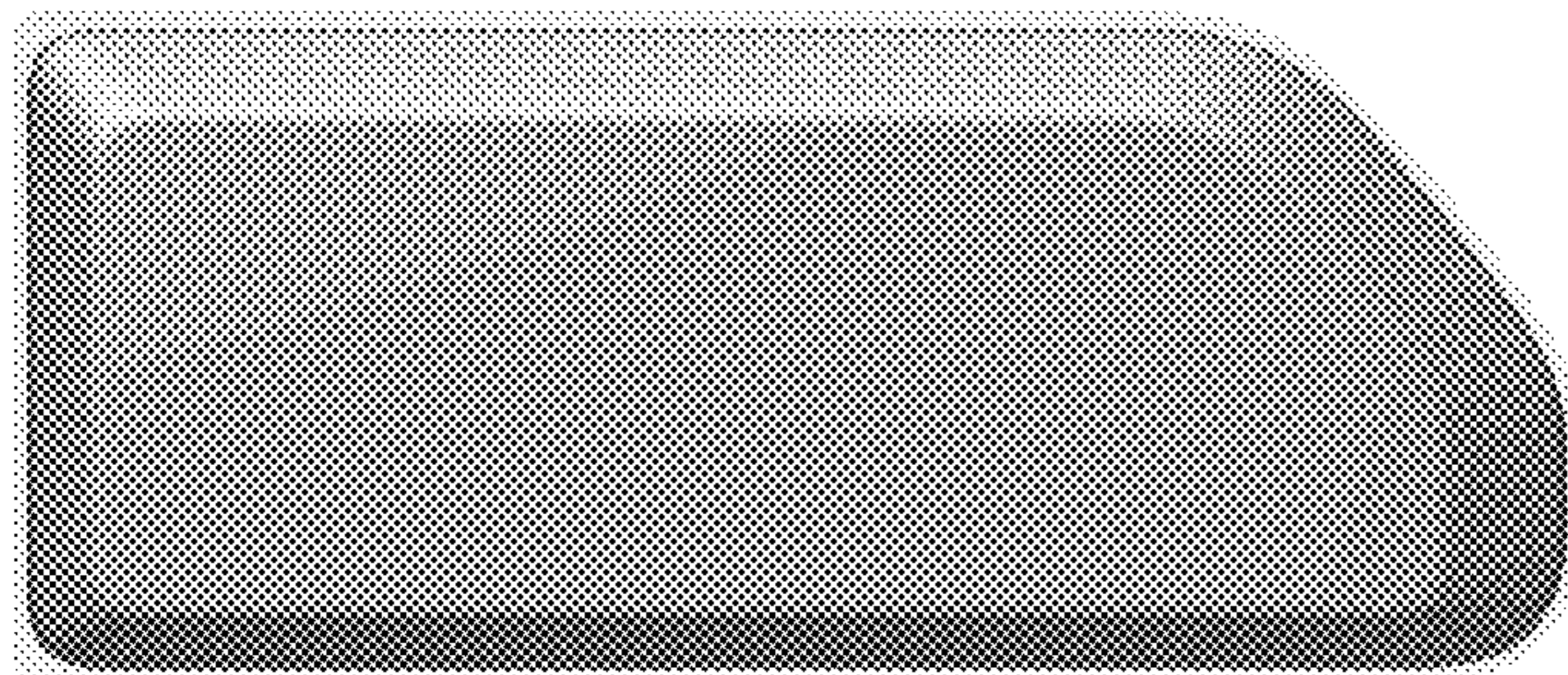
**DESCRIPTION**

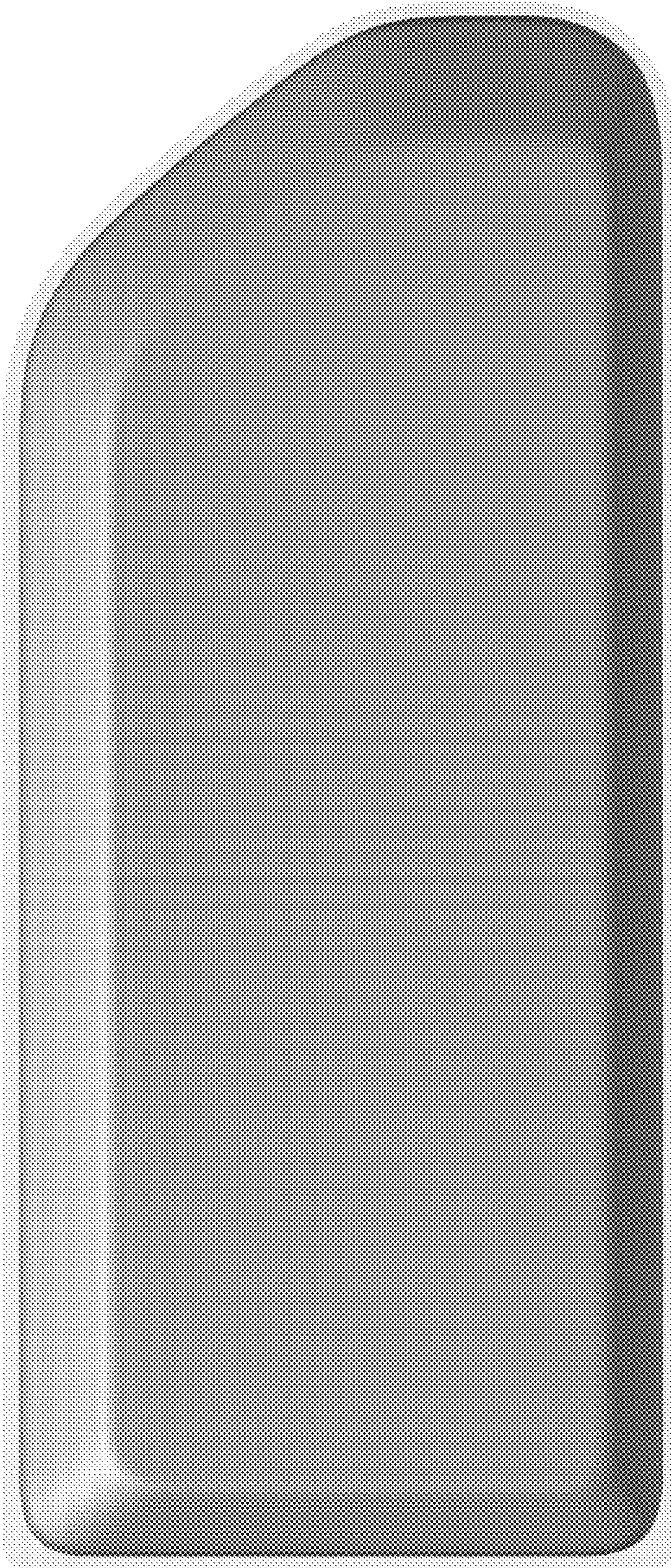

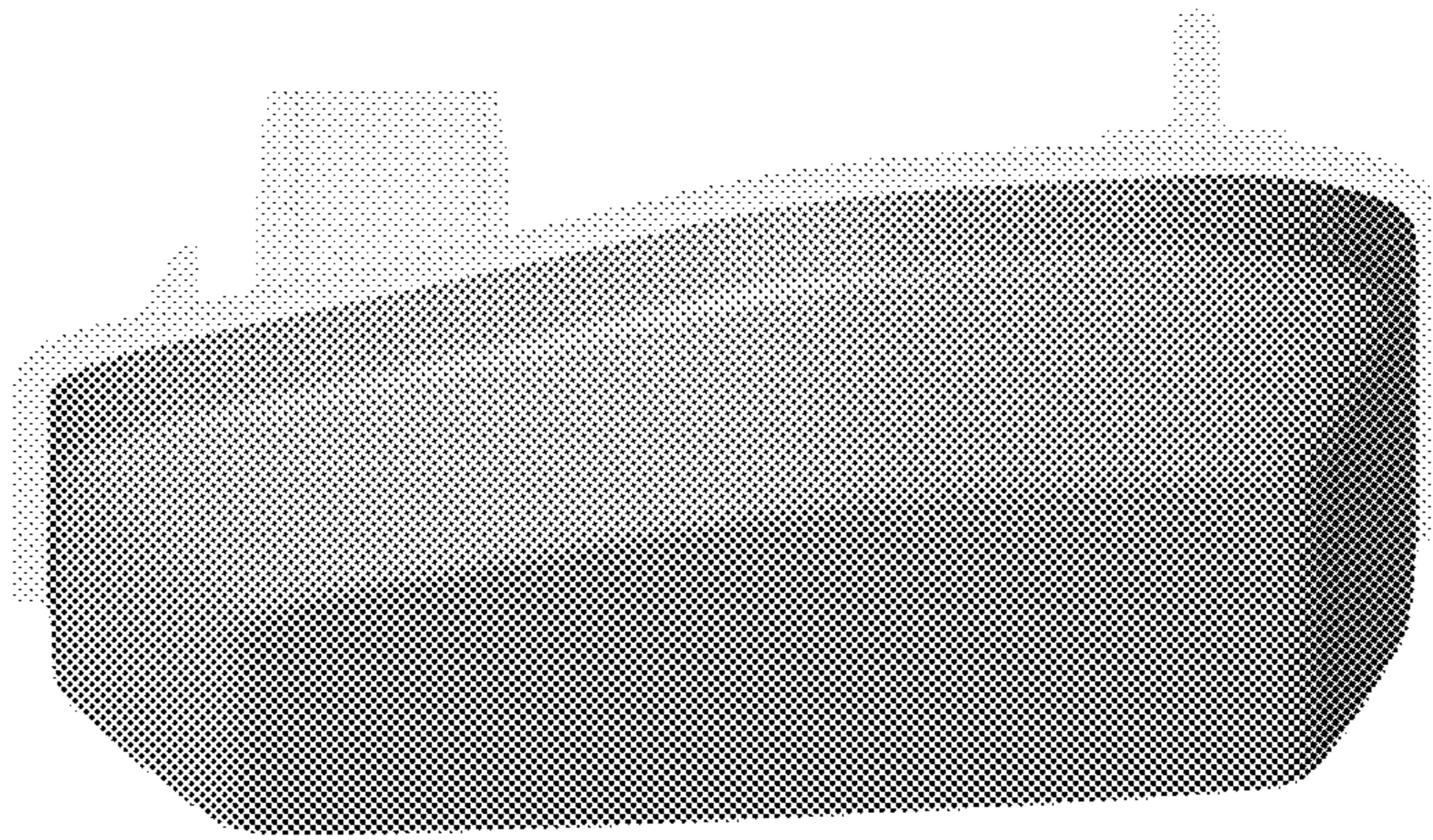

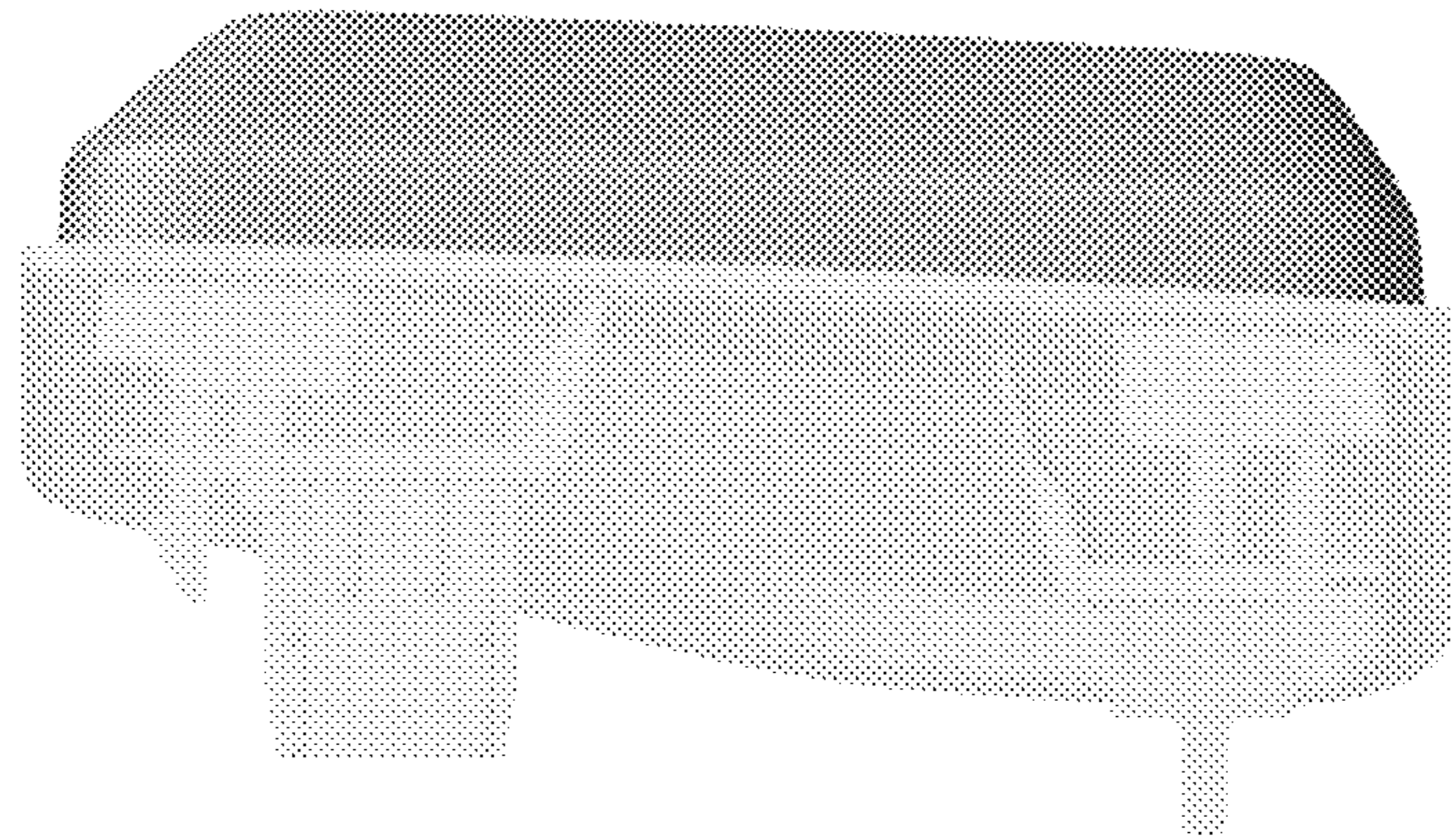

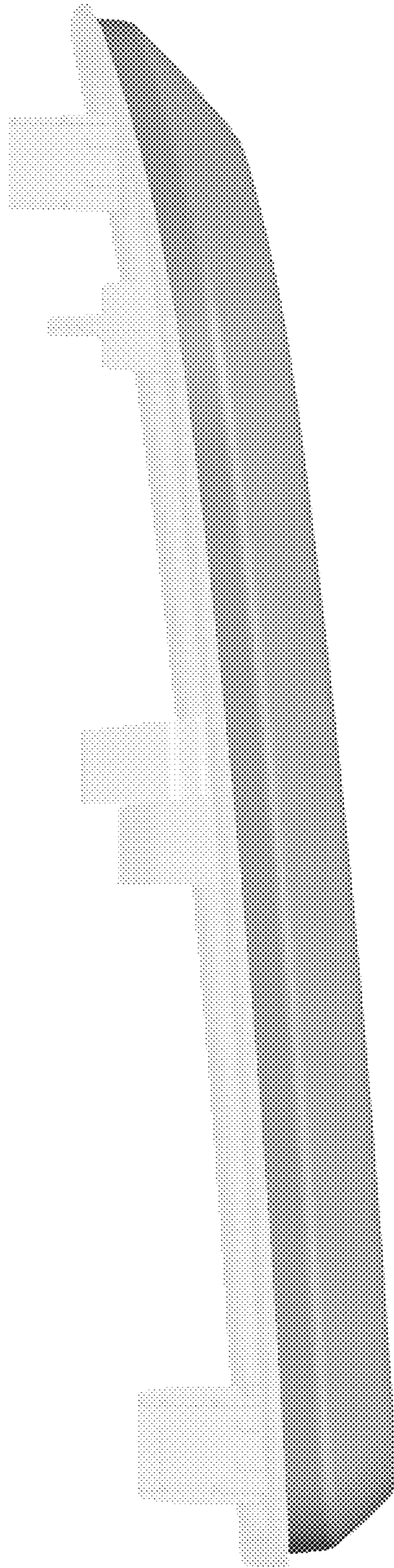

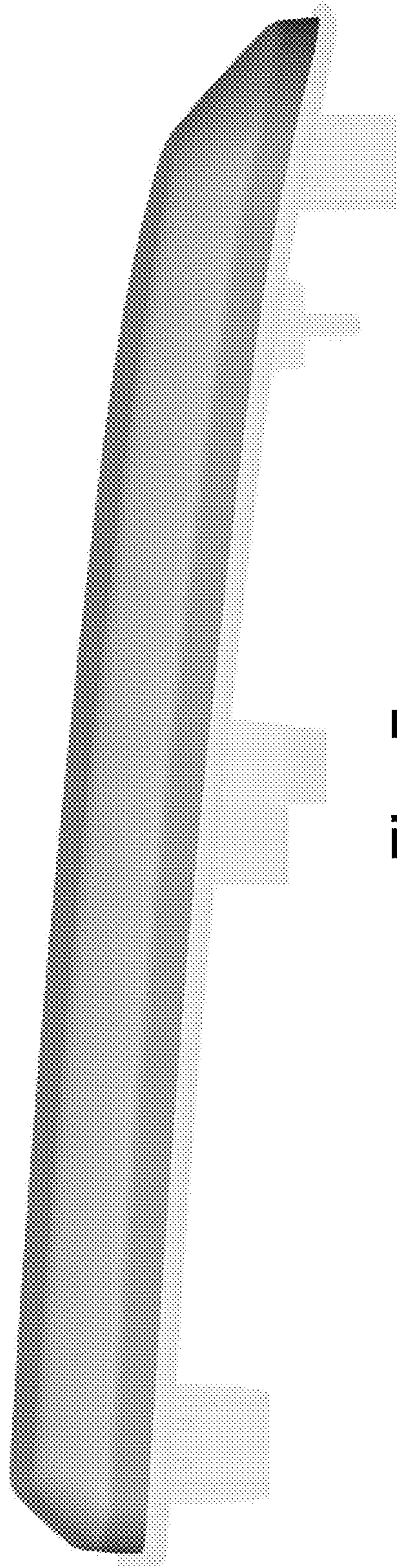

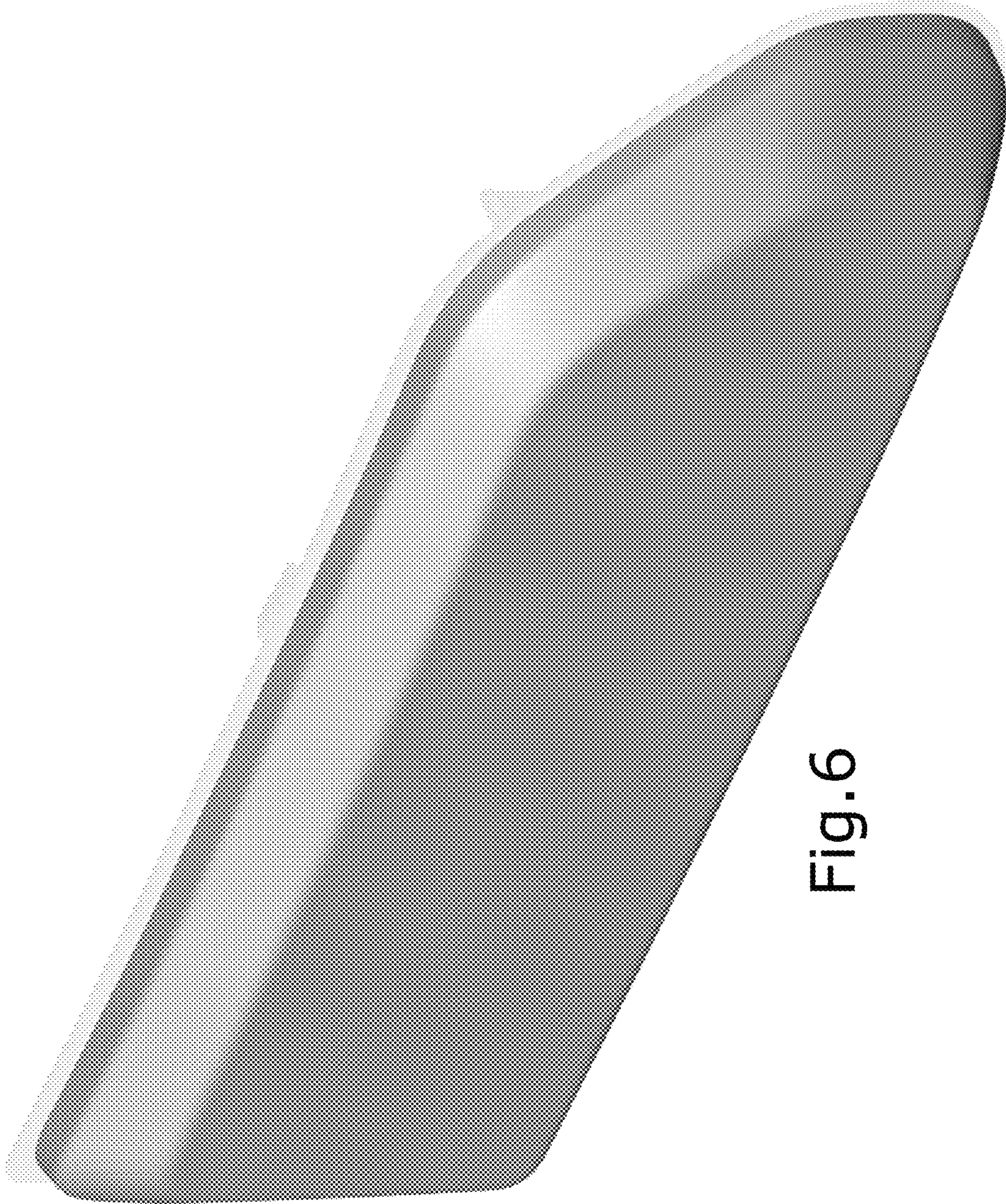

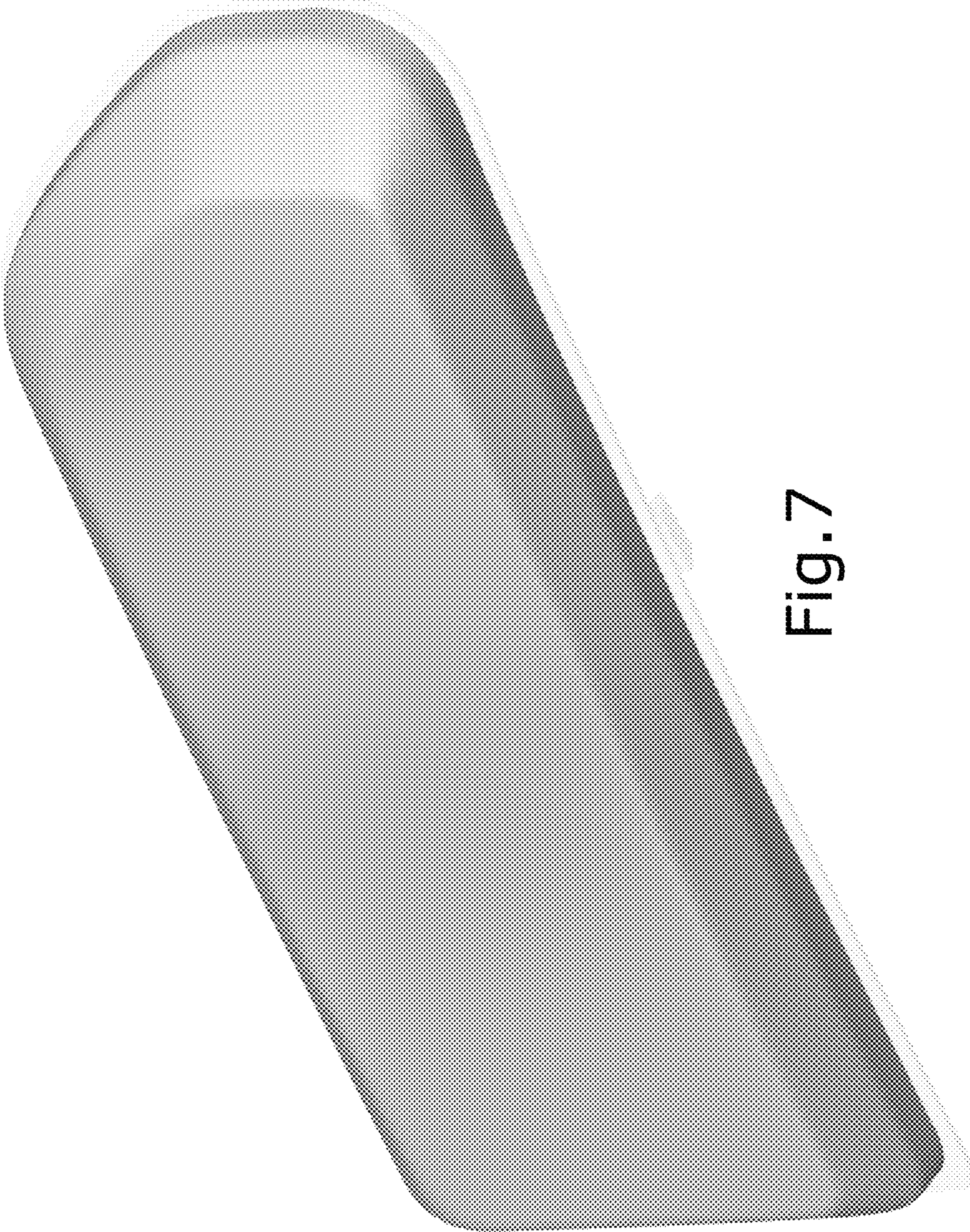
