(57) **CLAIM**

The ornamental design for a truck bed mounted entertainment box, as shown and described.

DESCRIPTION

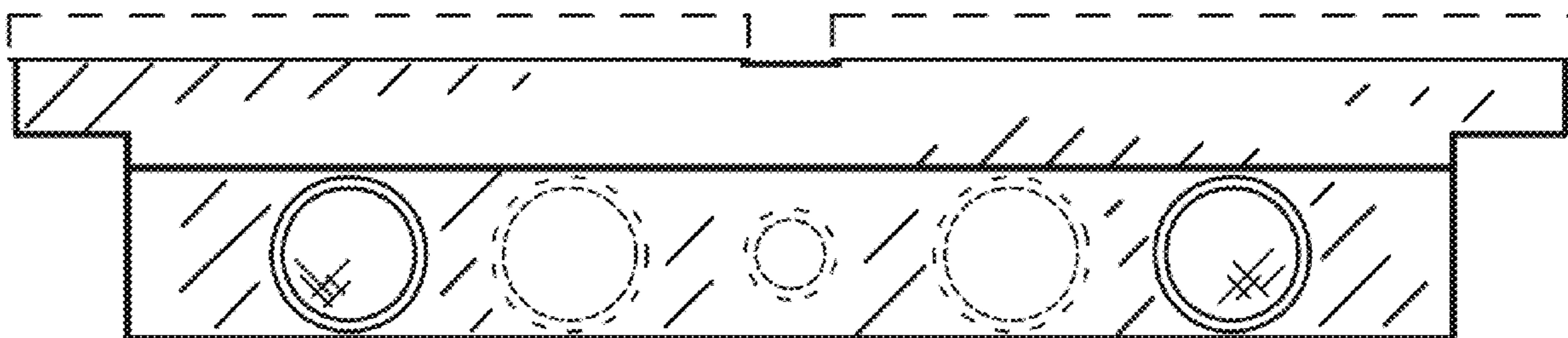


FIG. 22 is a perspective view of a fourth embodiment including a front, a top, and a first side of a truck bed mounted entertainment box;

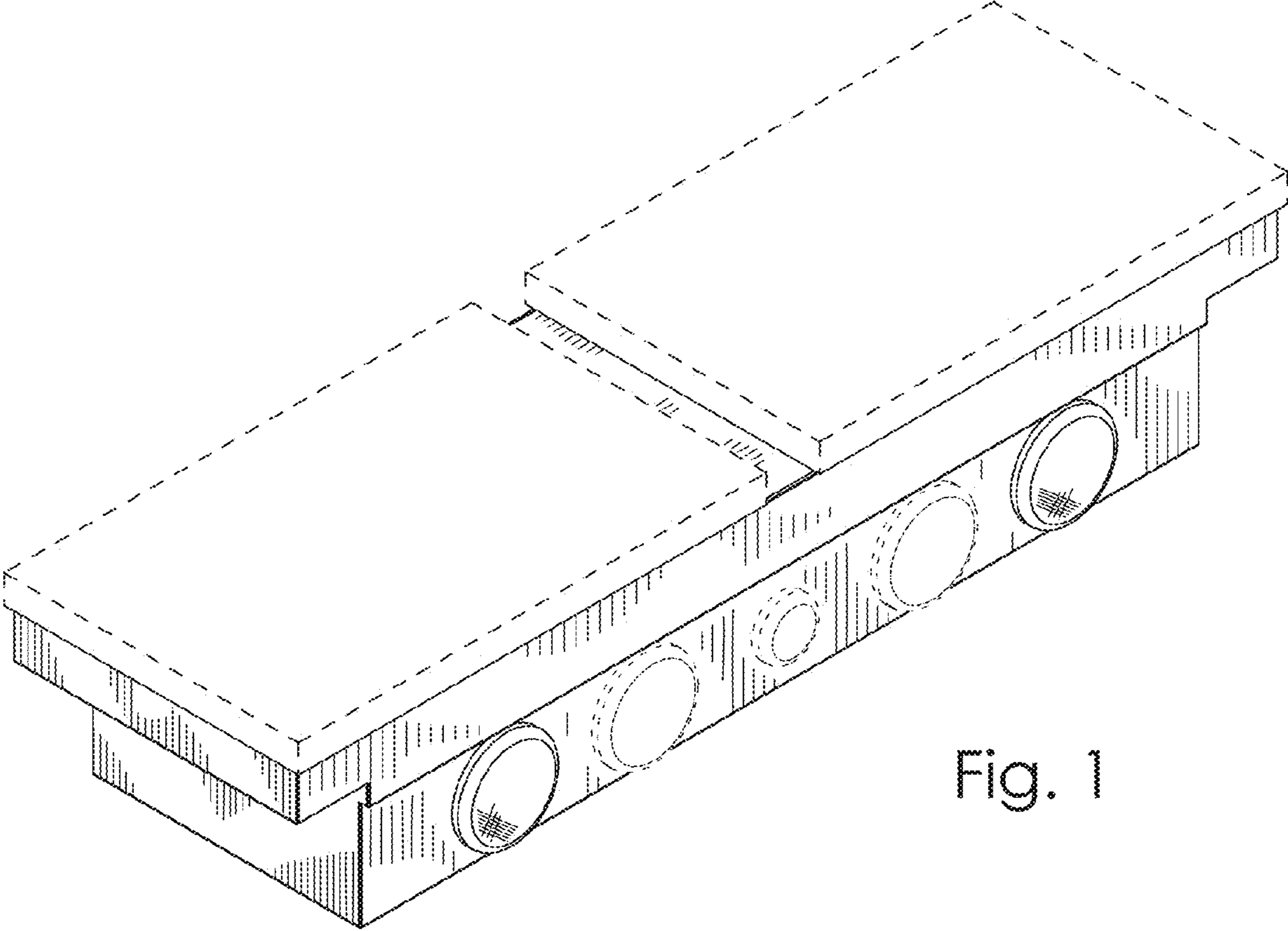

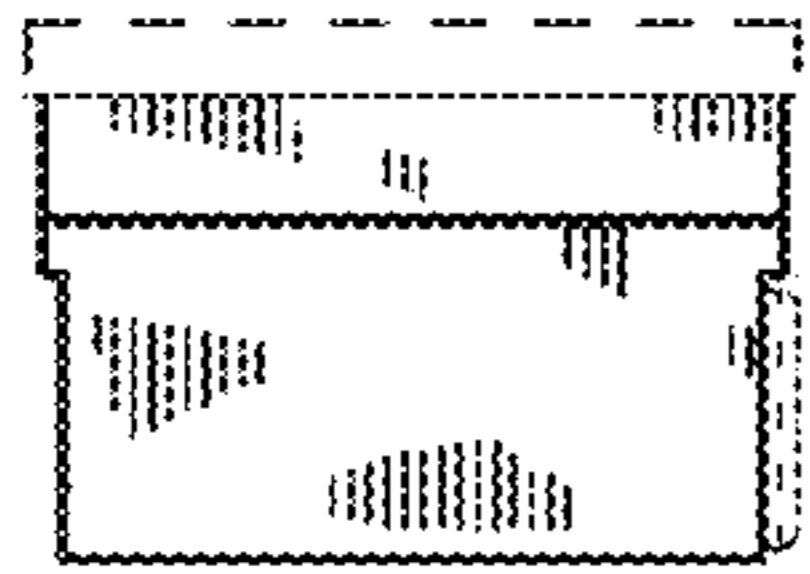

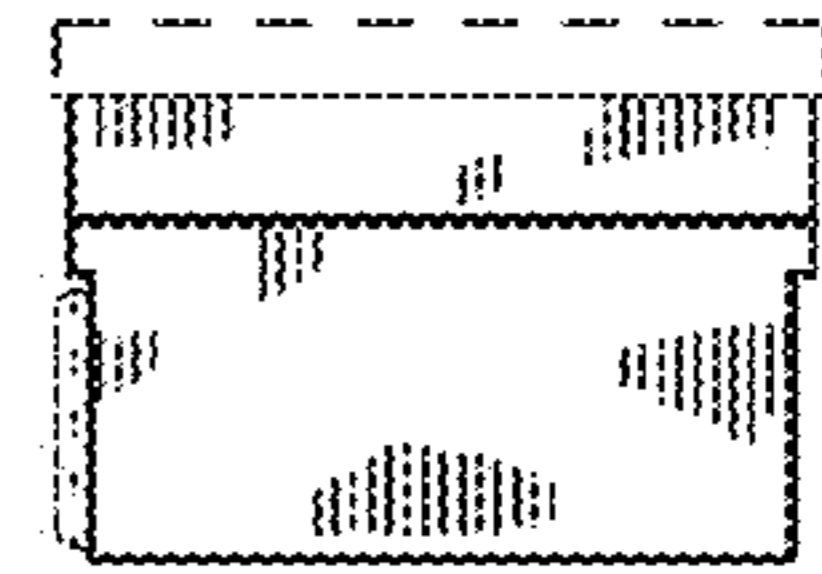

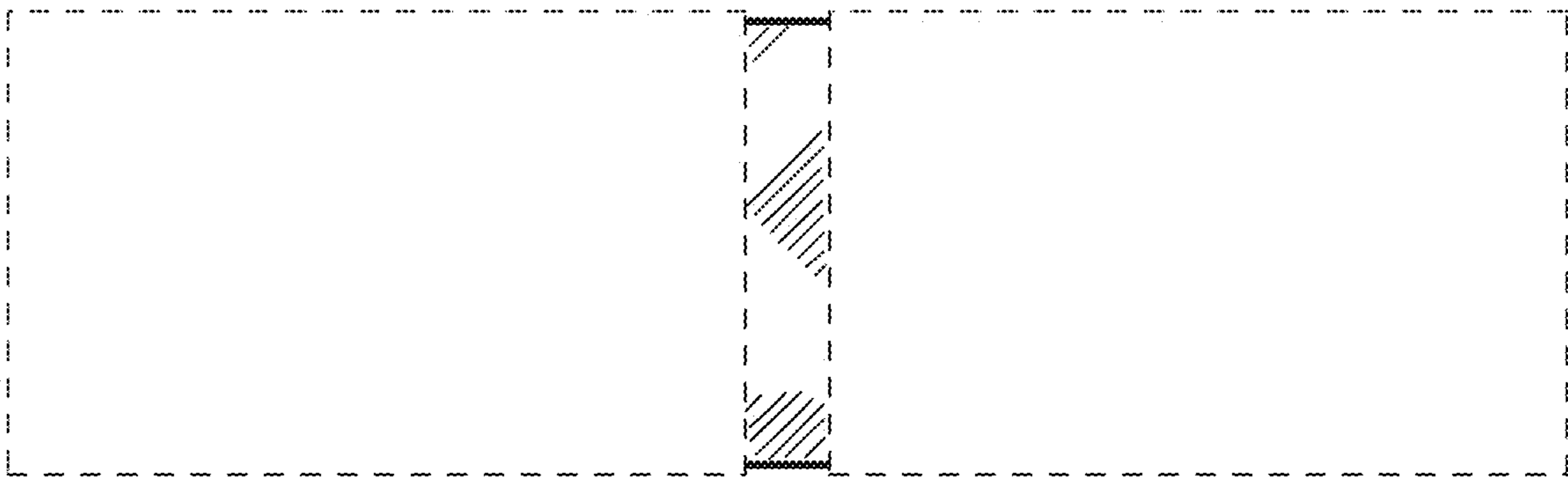

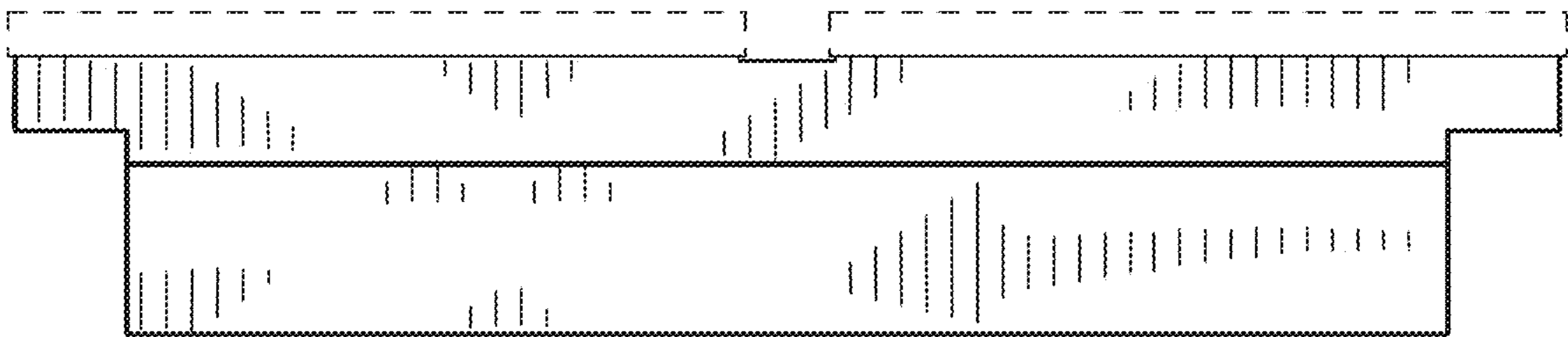

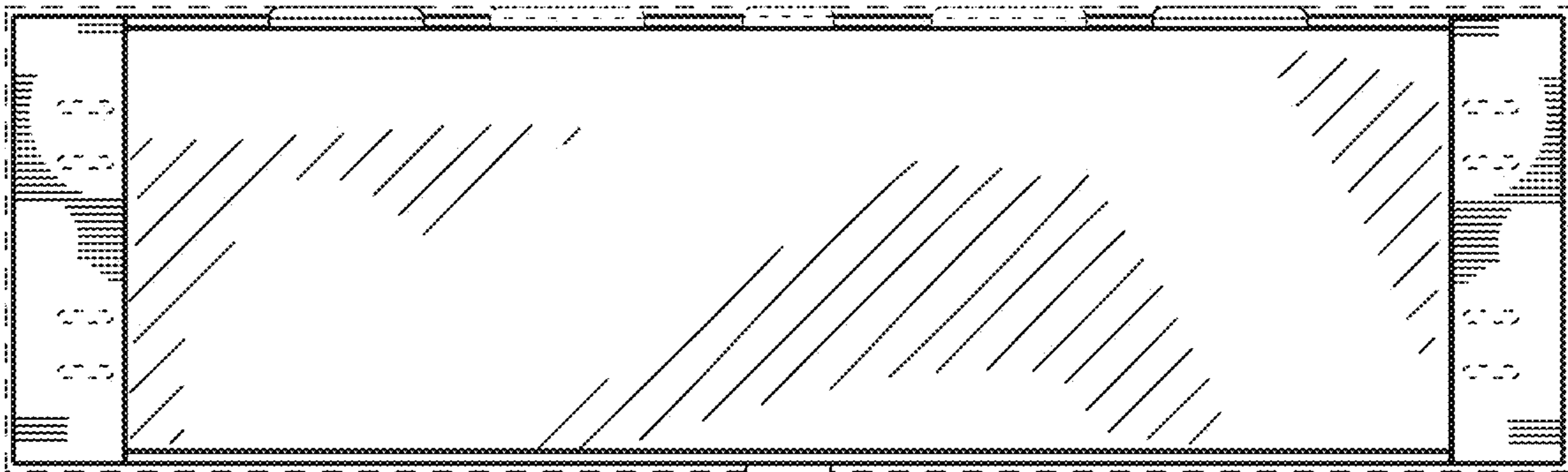

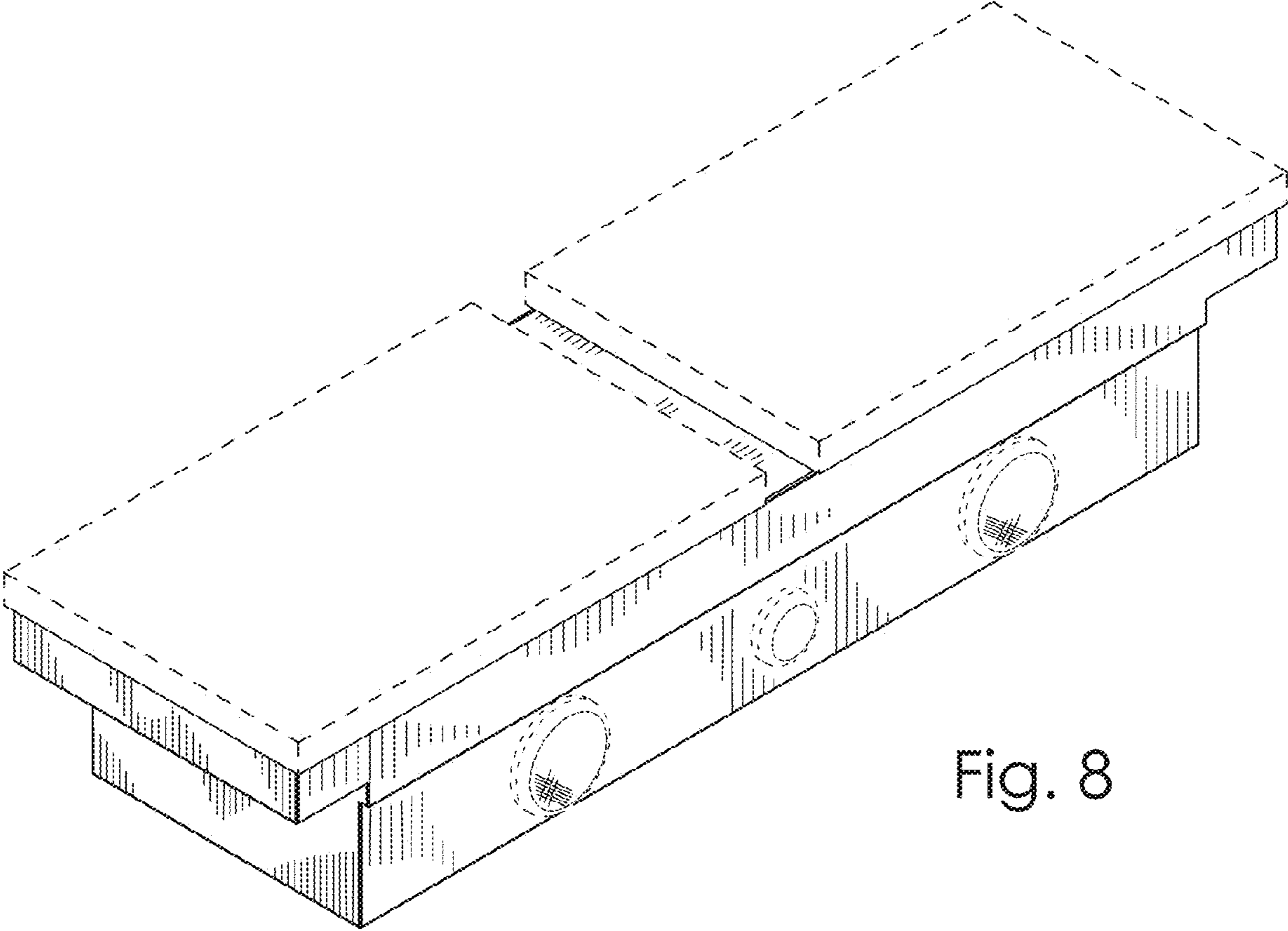

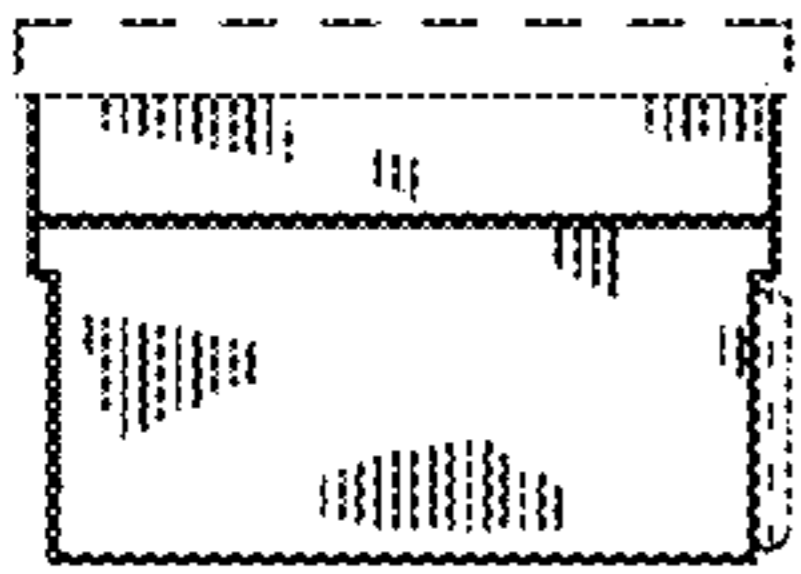

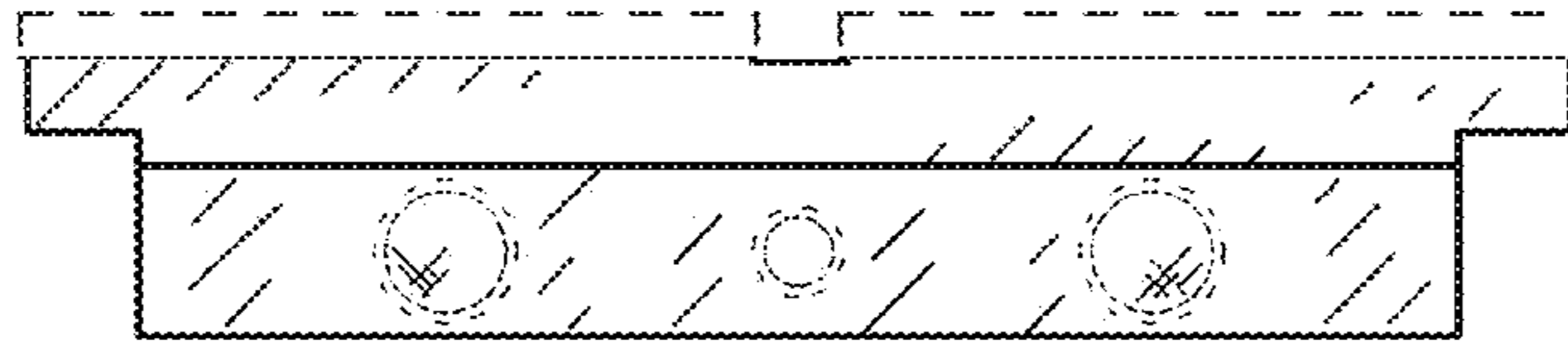

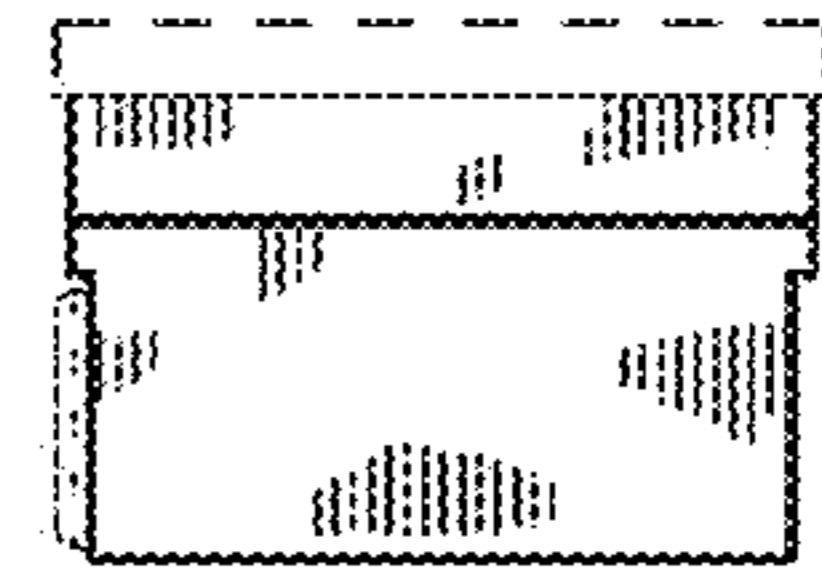

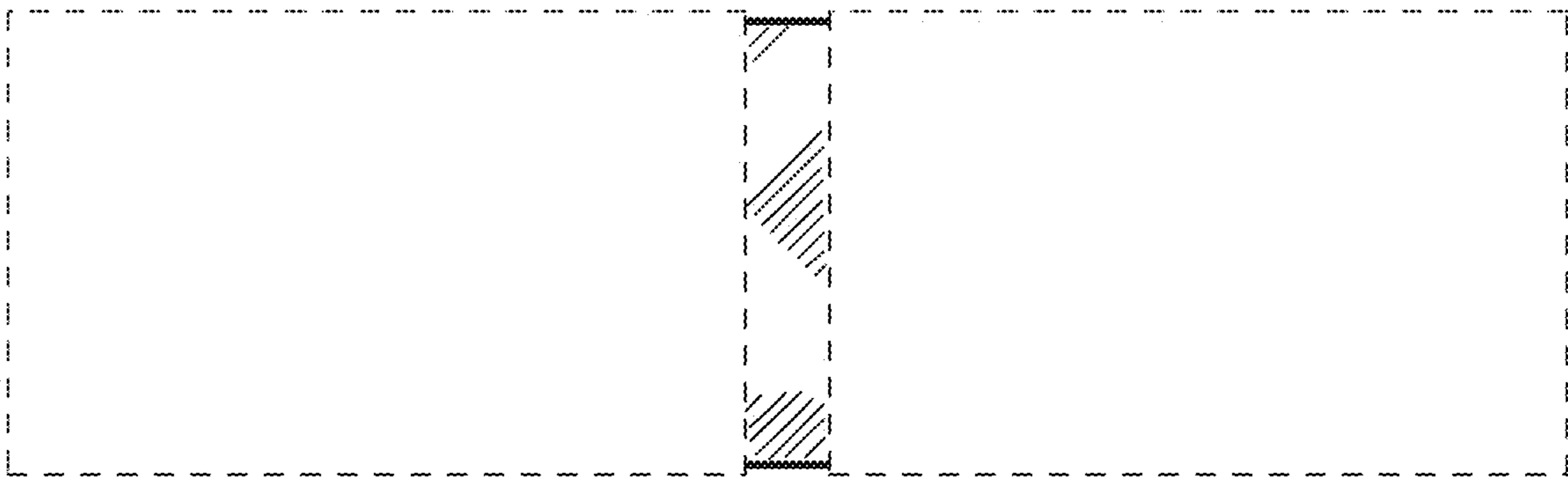

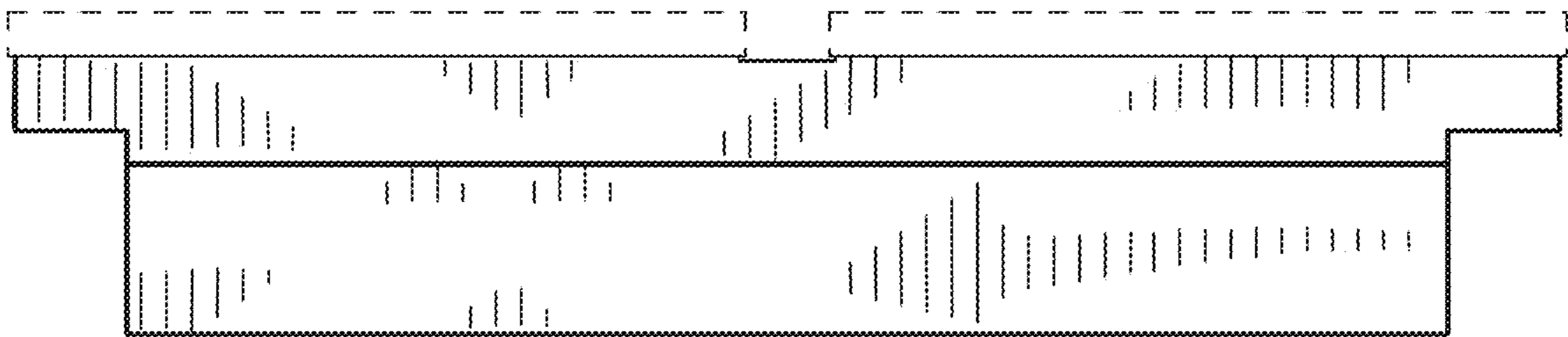

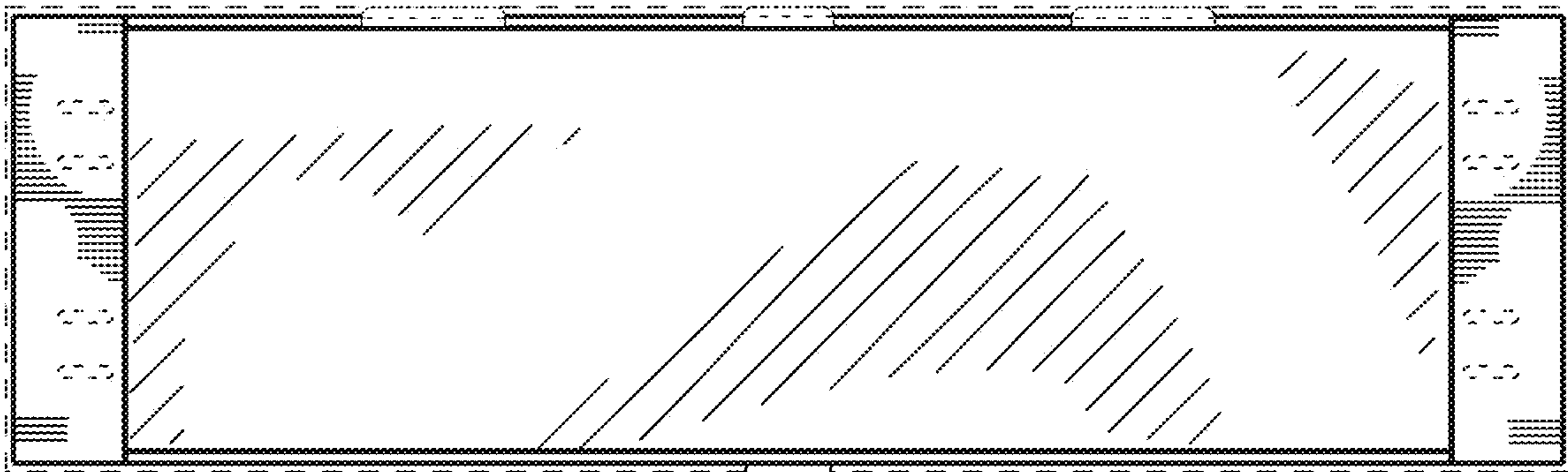

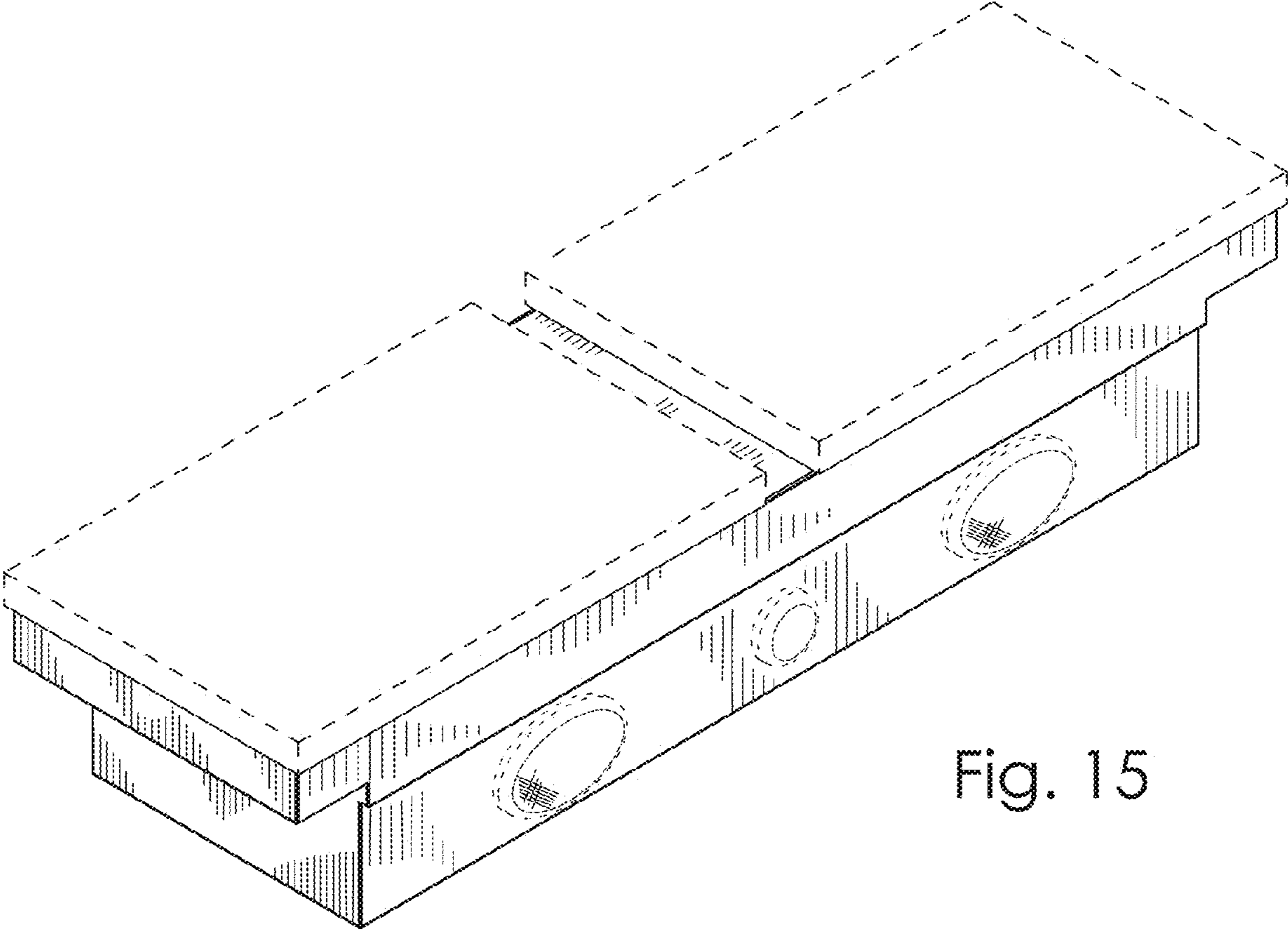

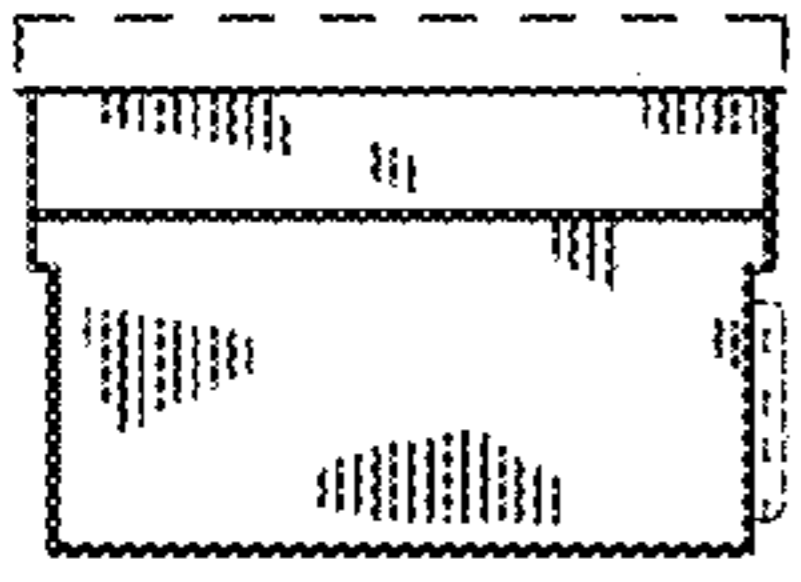

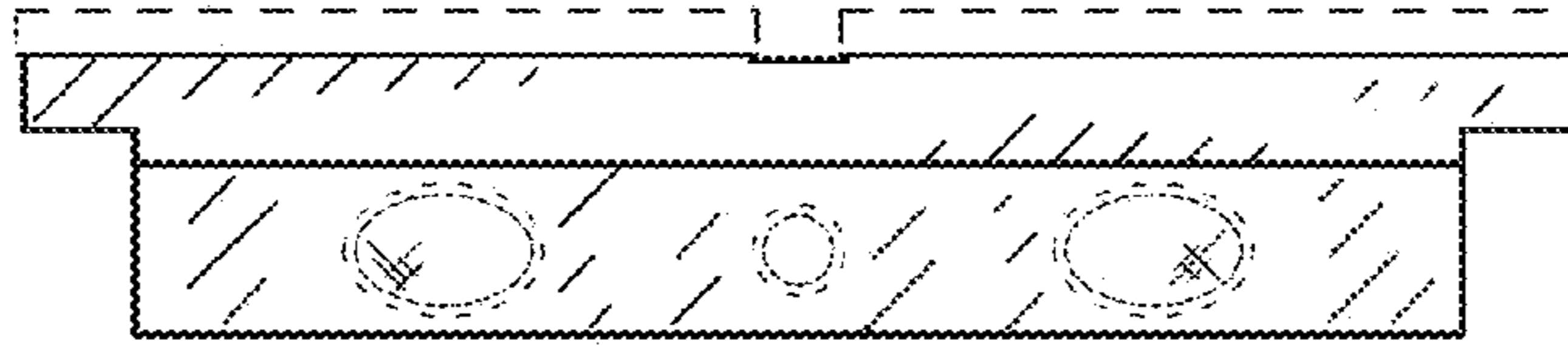

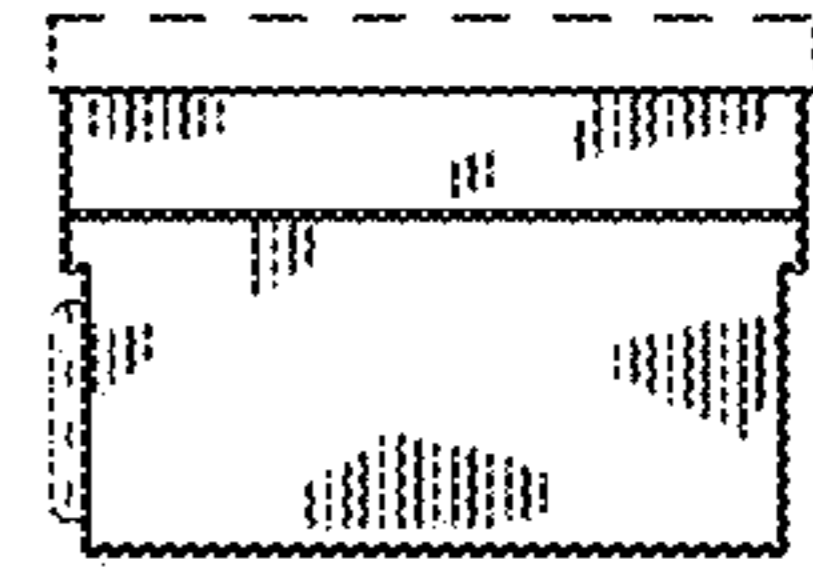

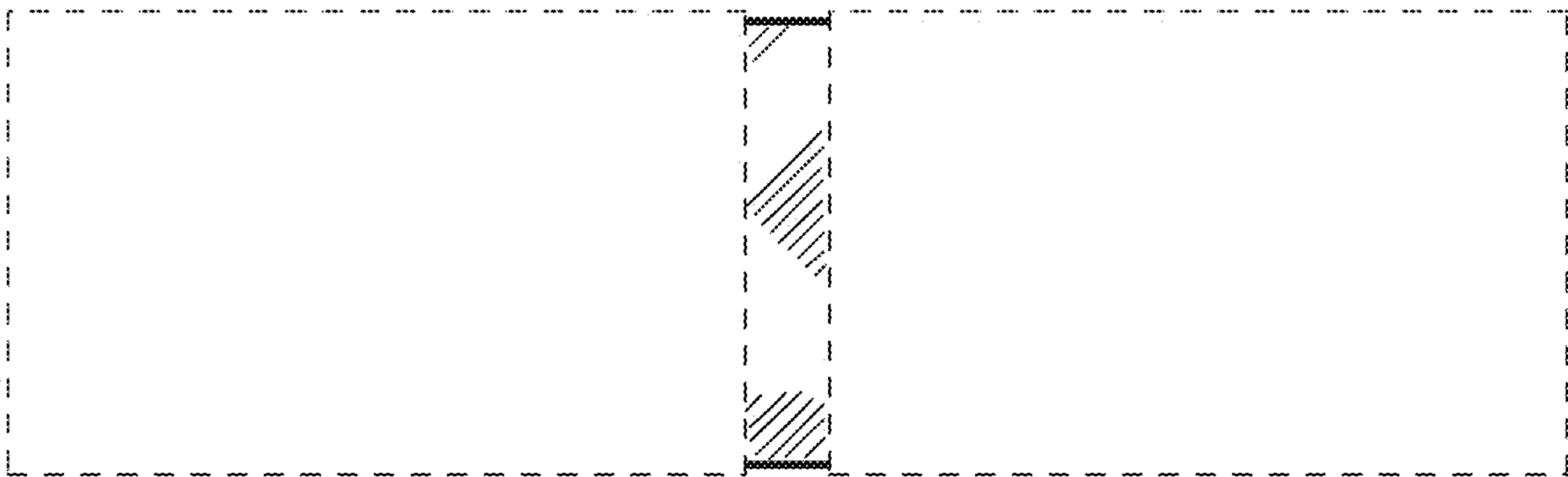

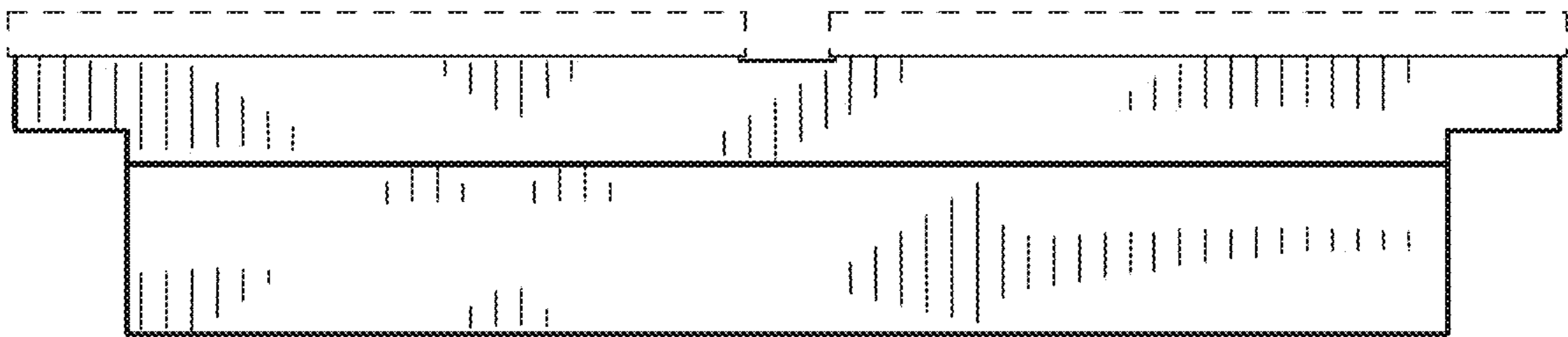

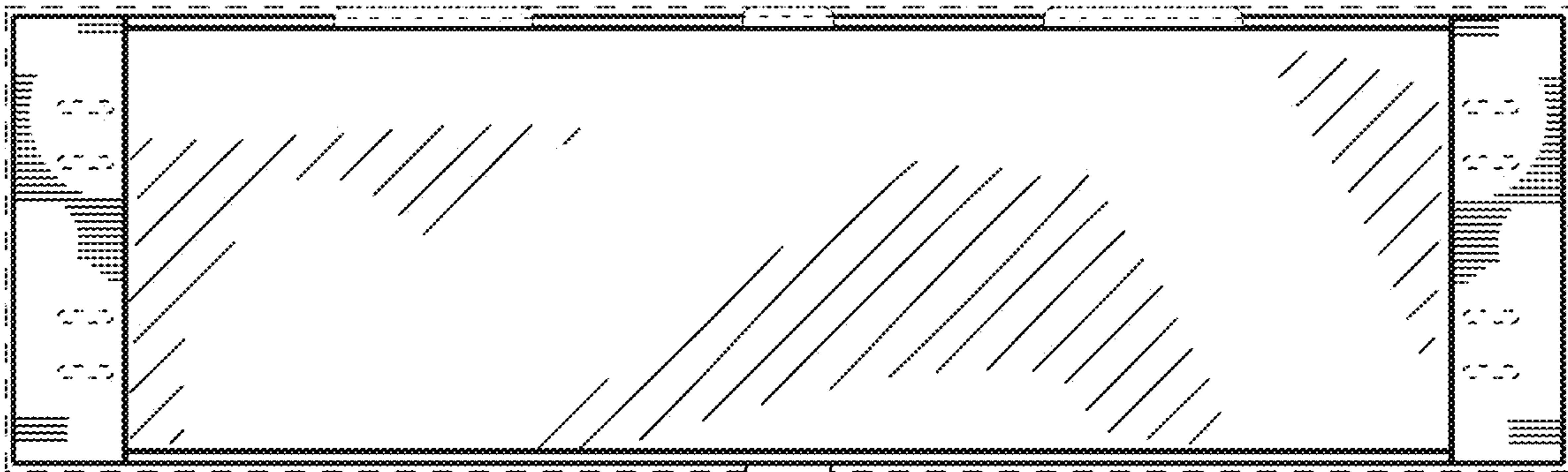

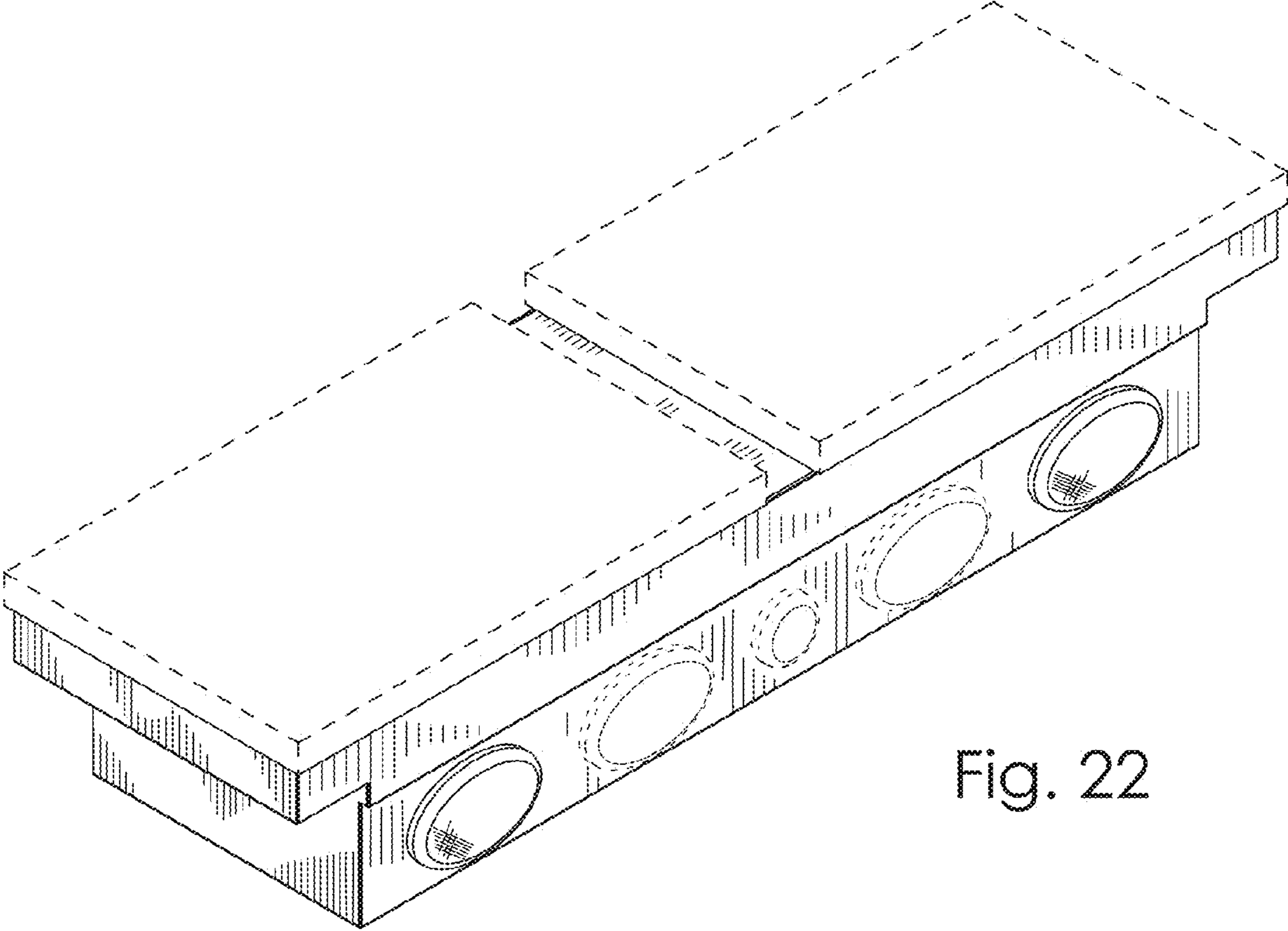

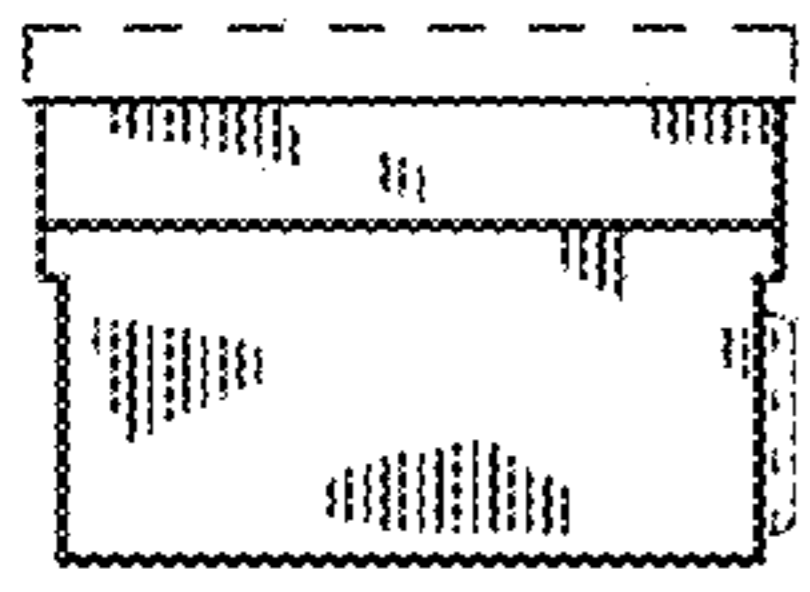

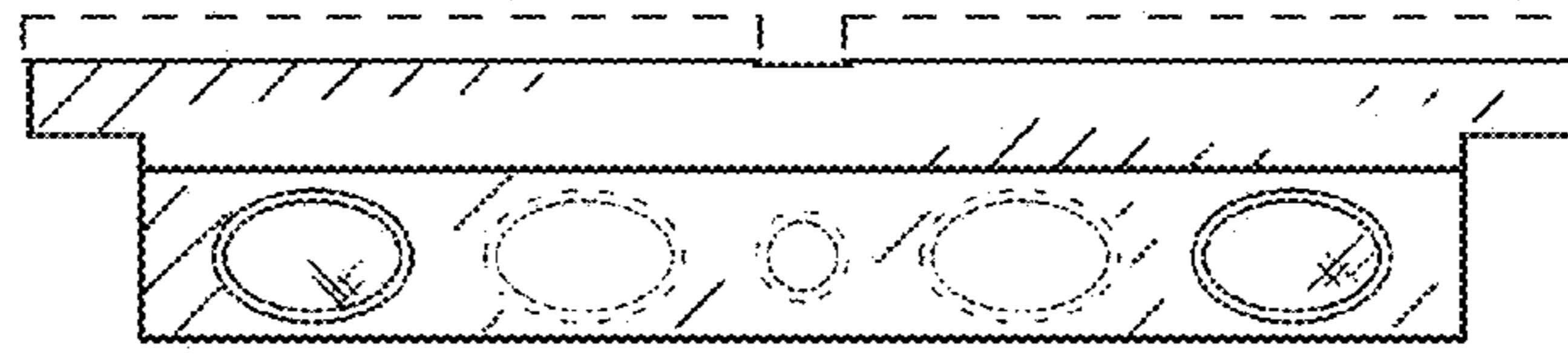

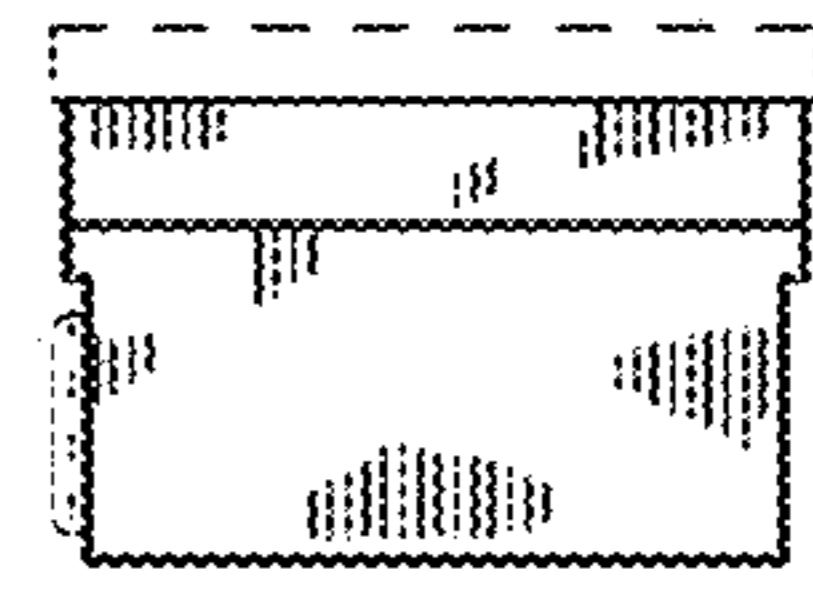

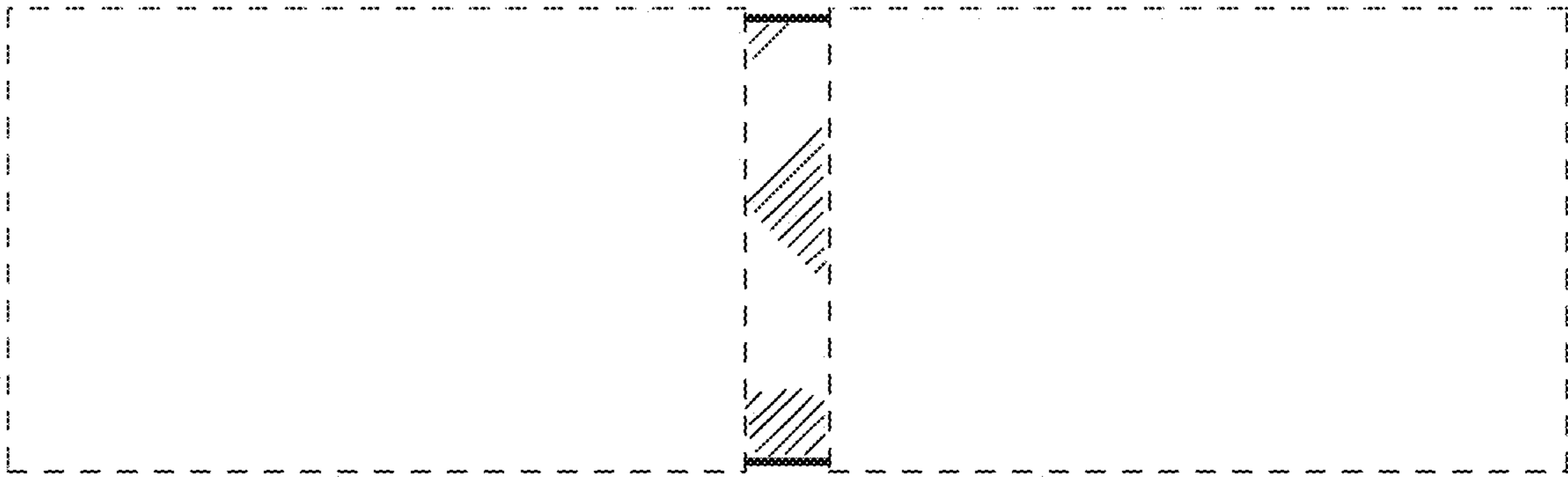

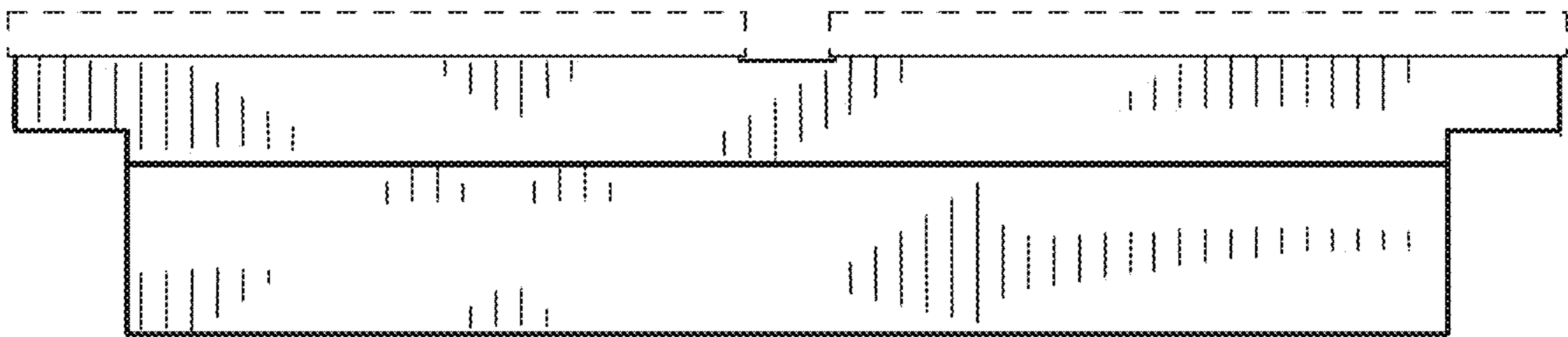

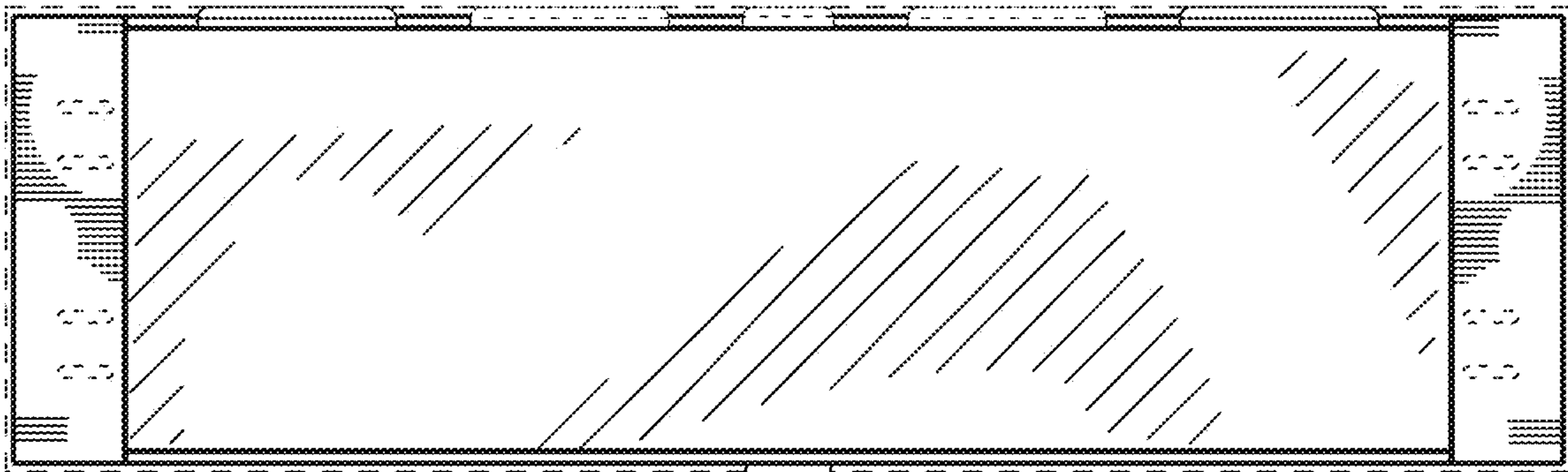
