The ornamental design for a tumbler press machine, as shown and described.

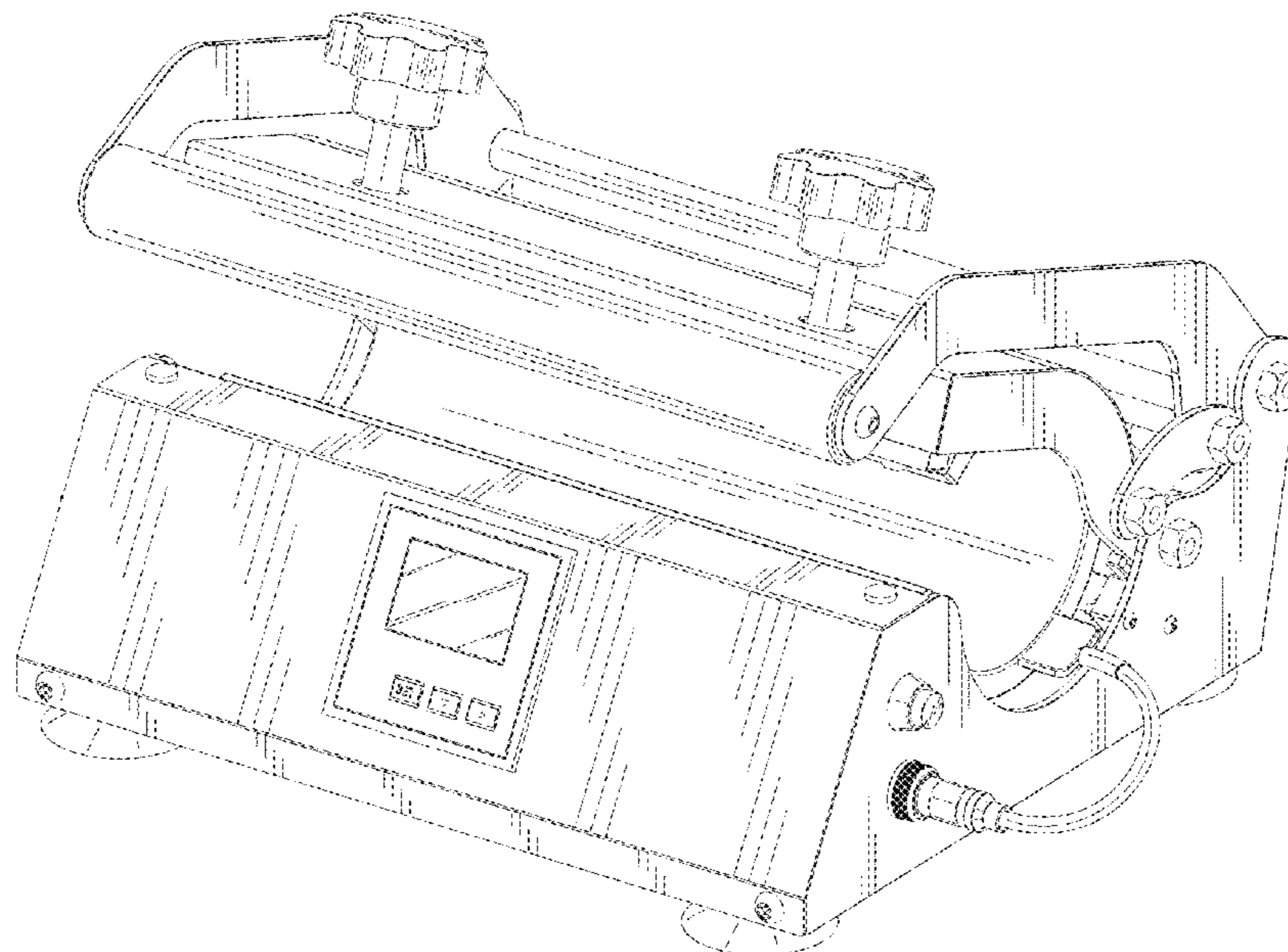
DESCRIPTION

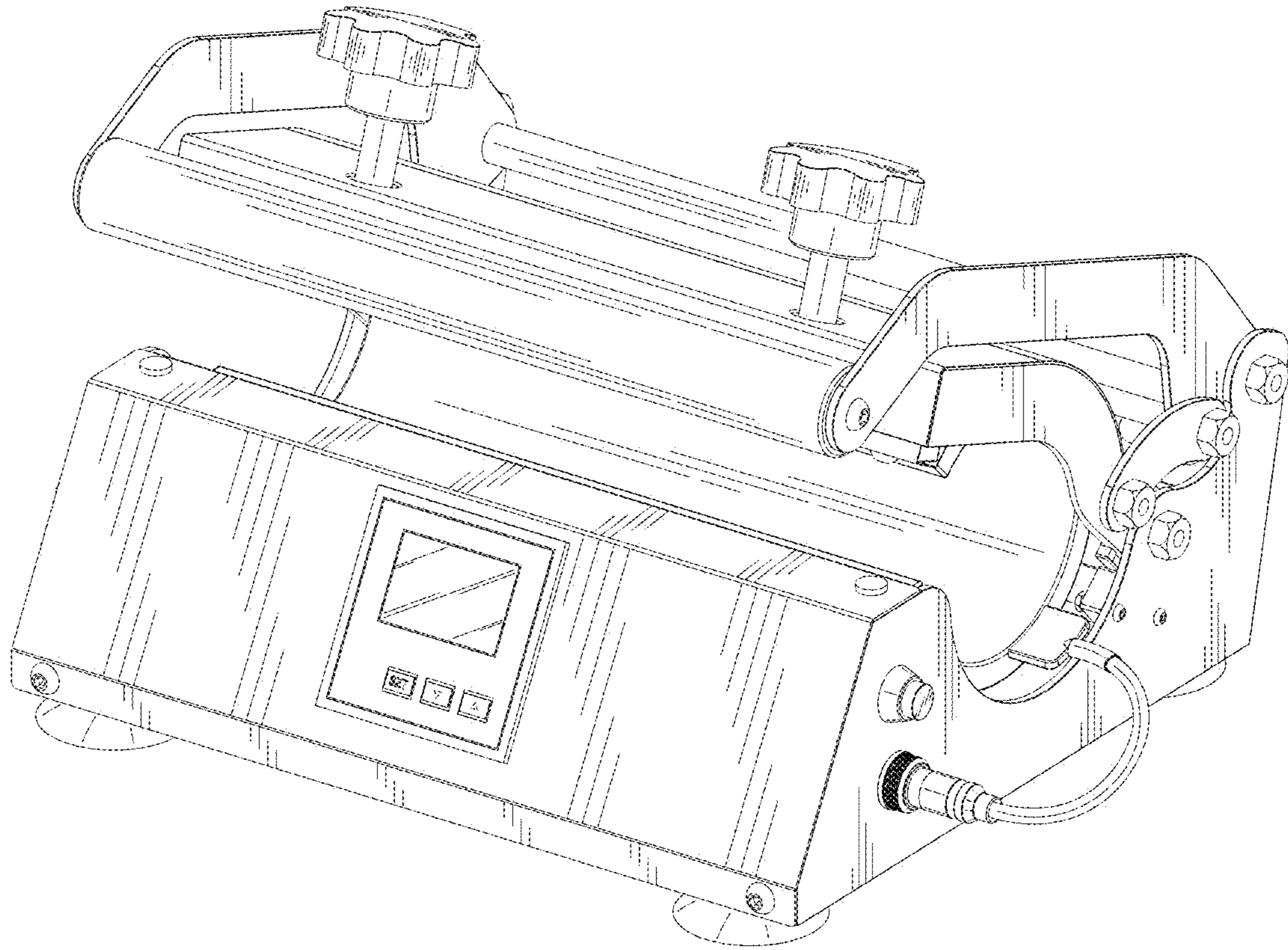

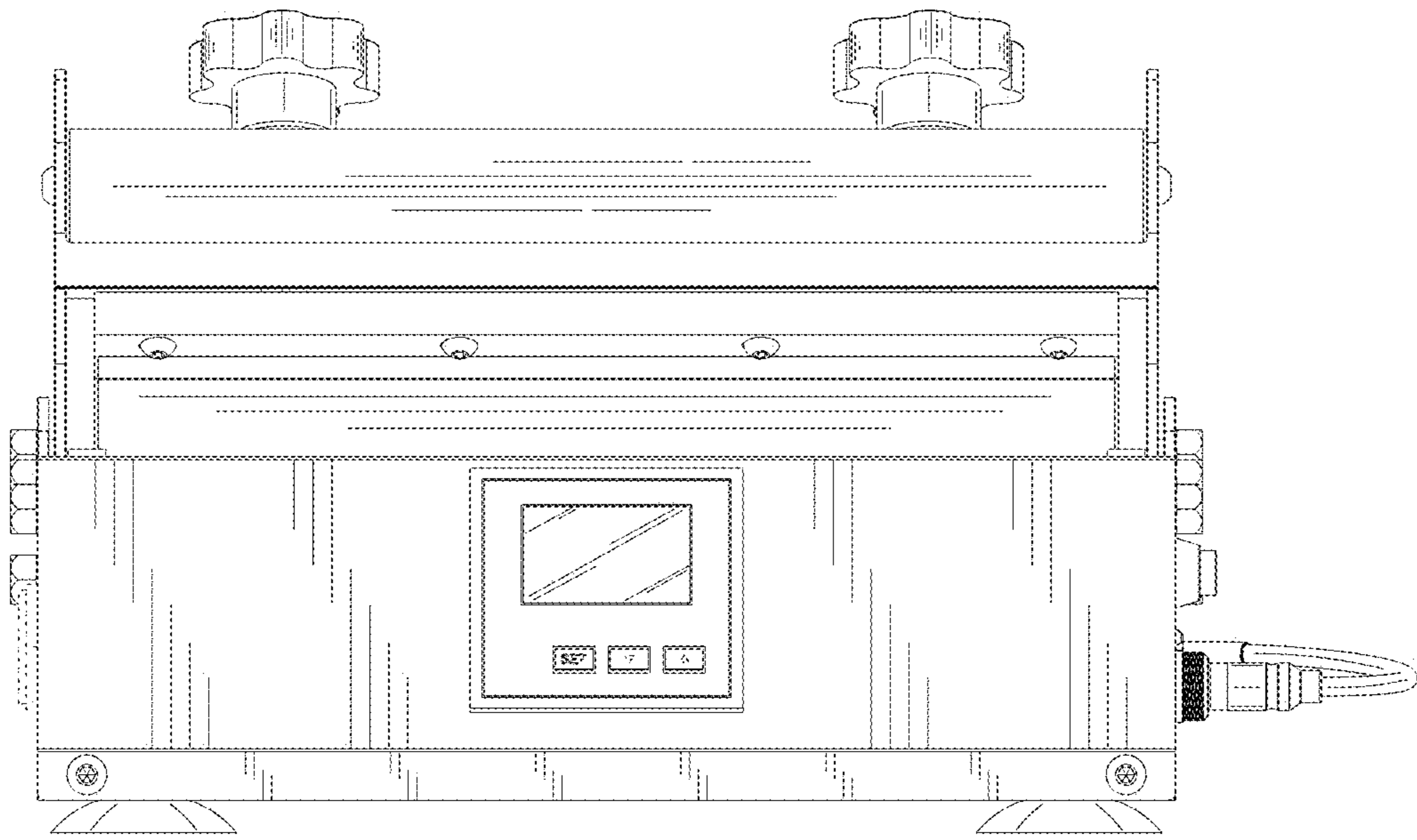

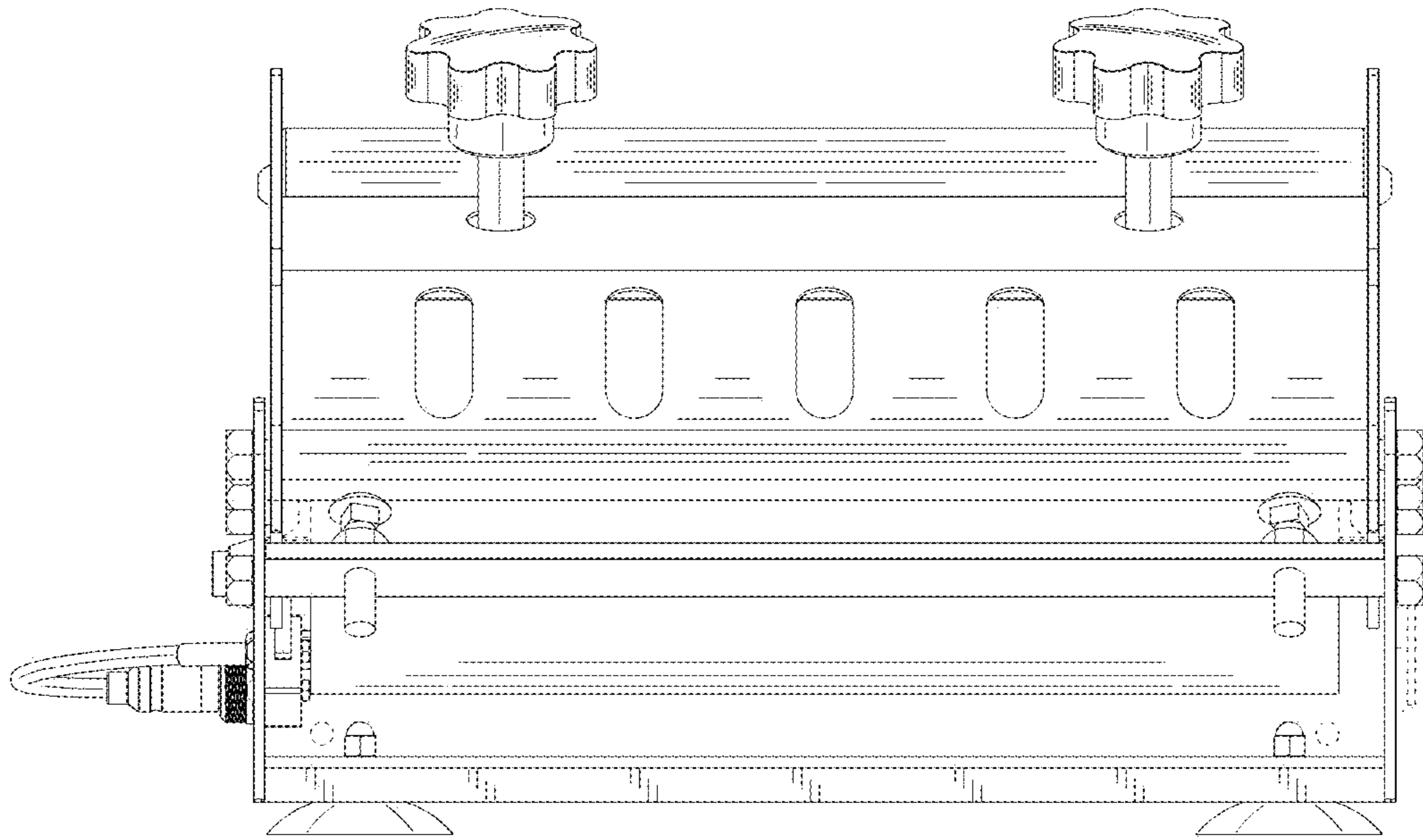

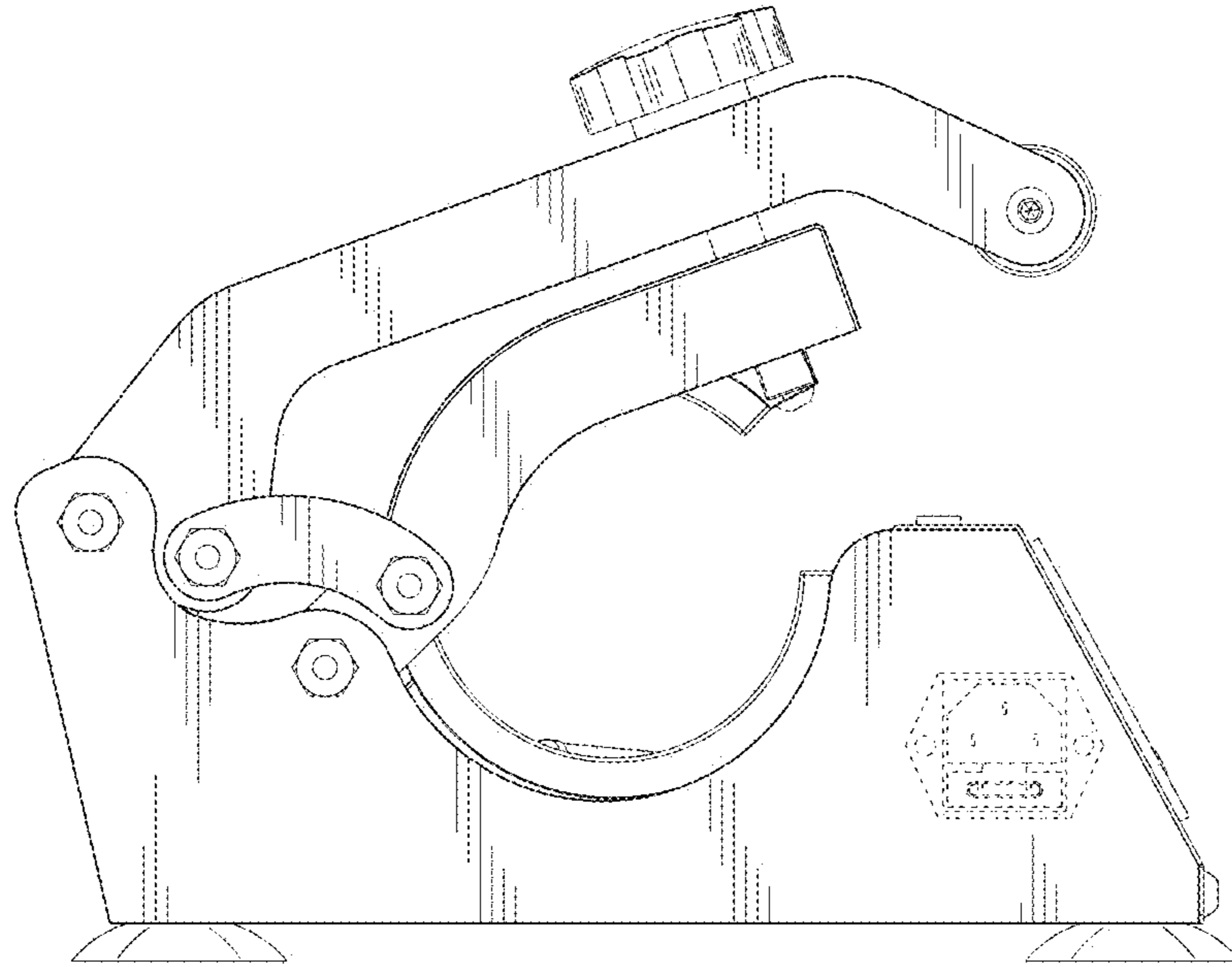

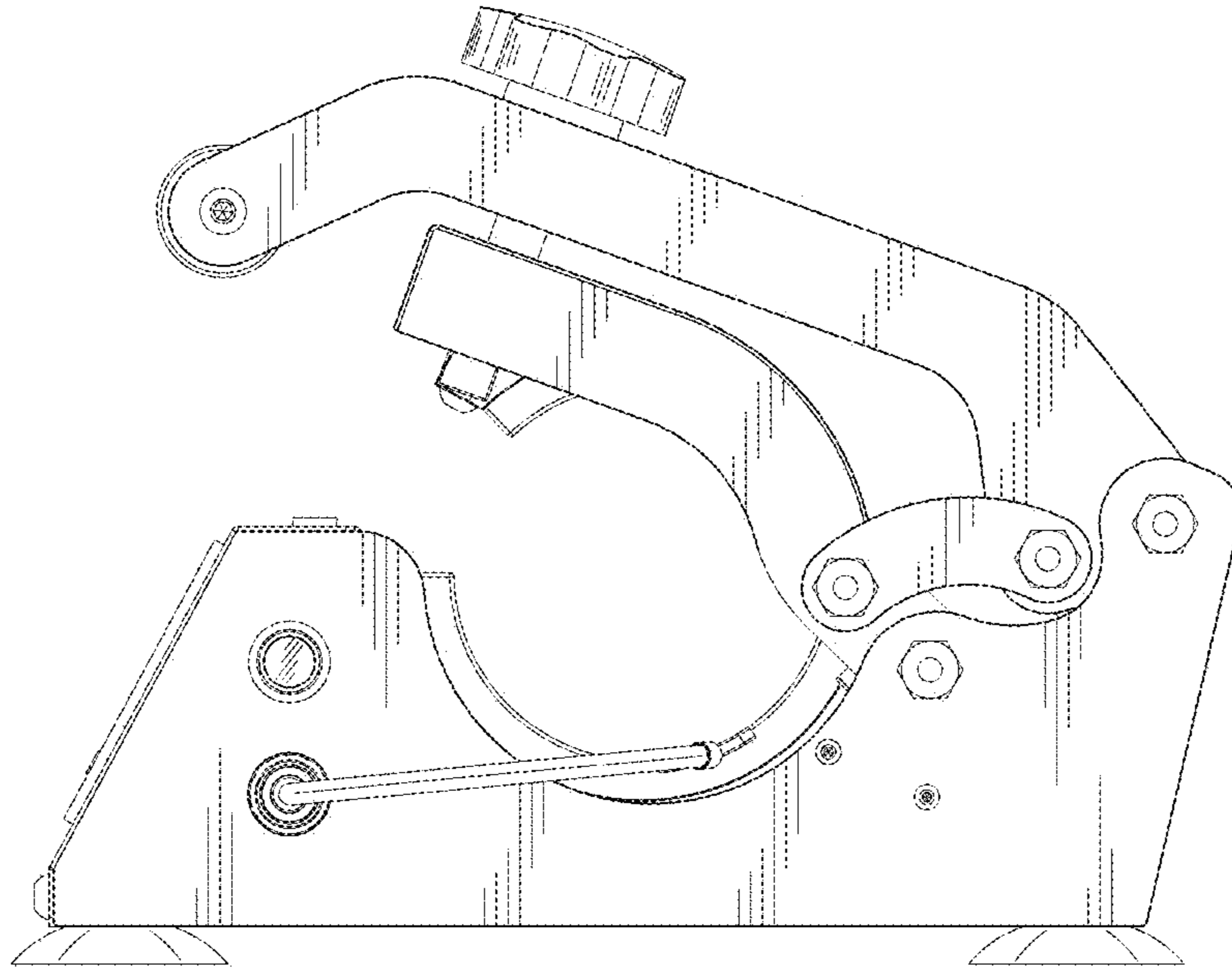

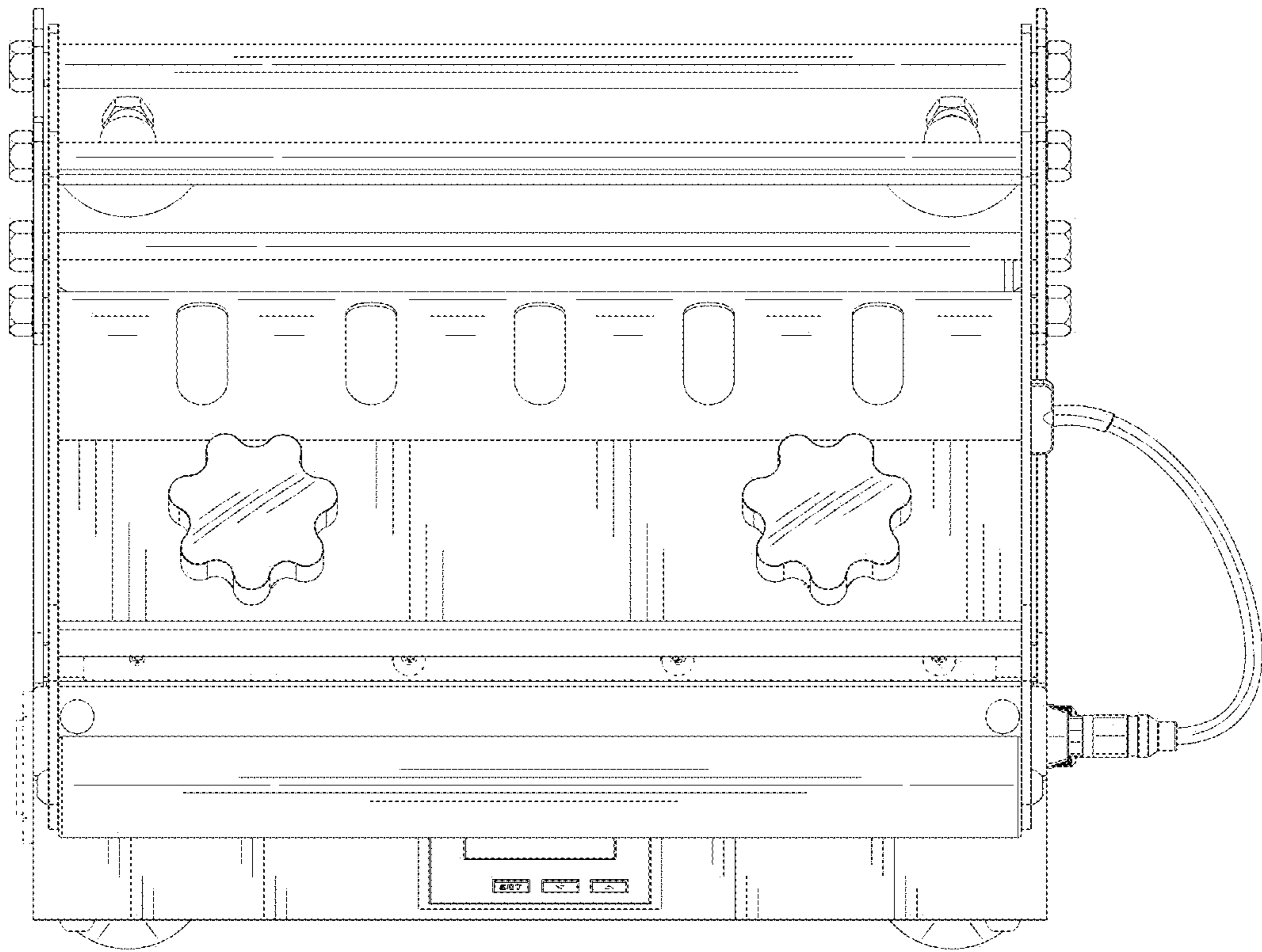

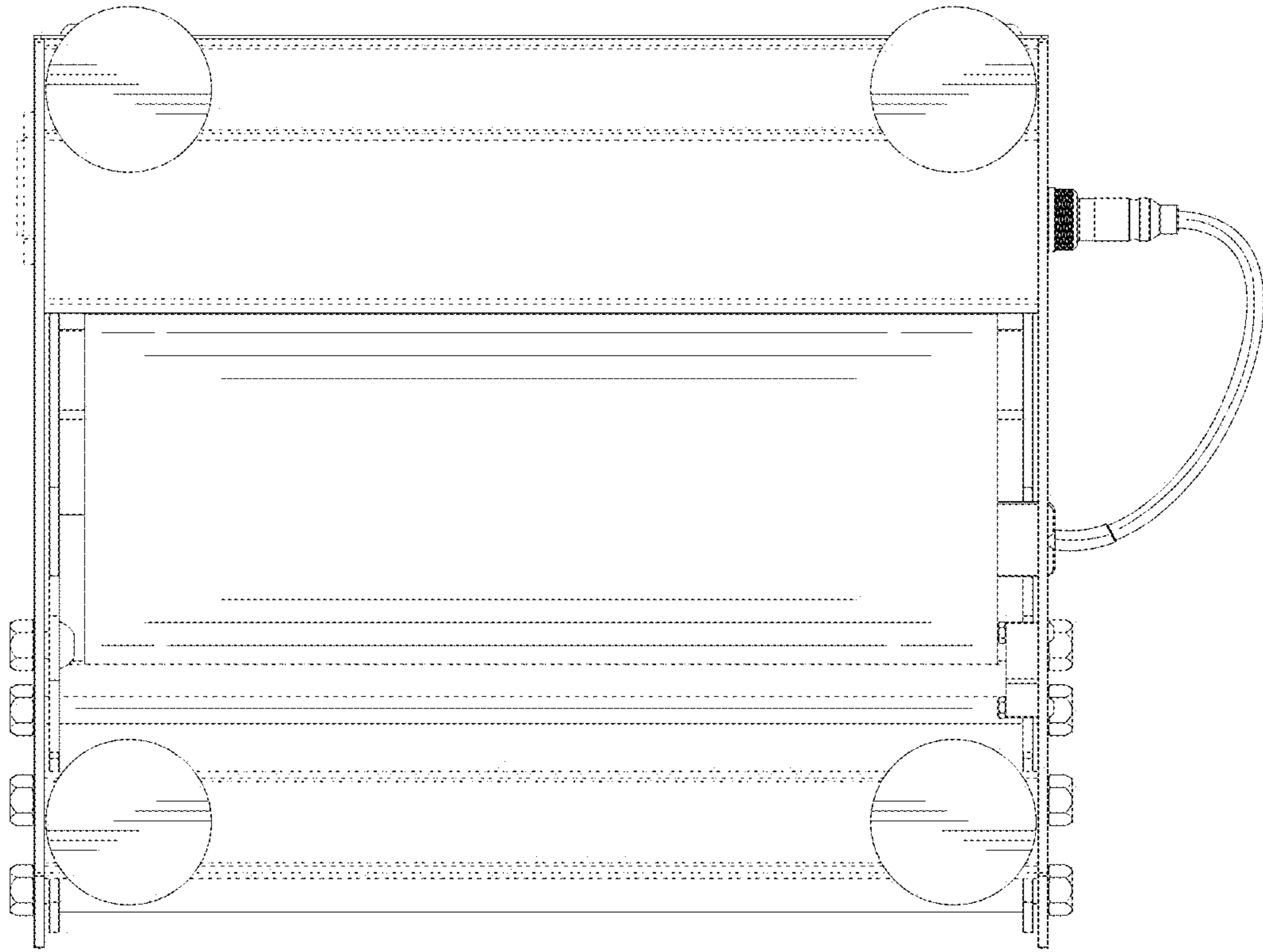
