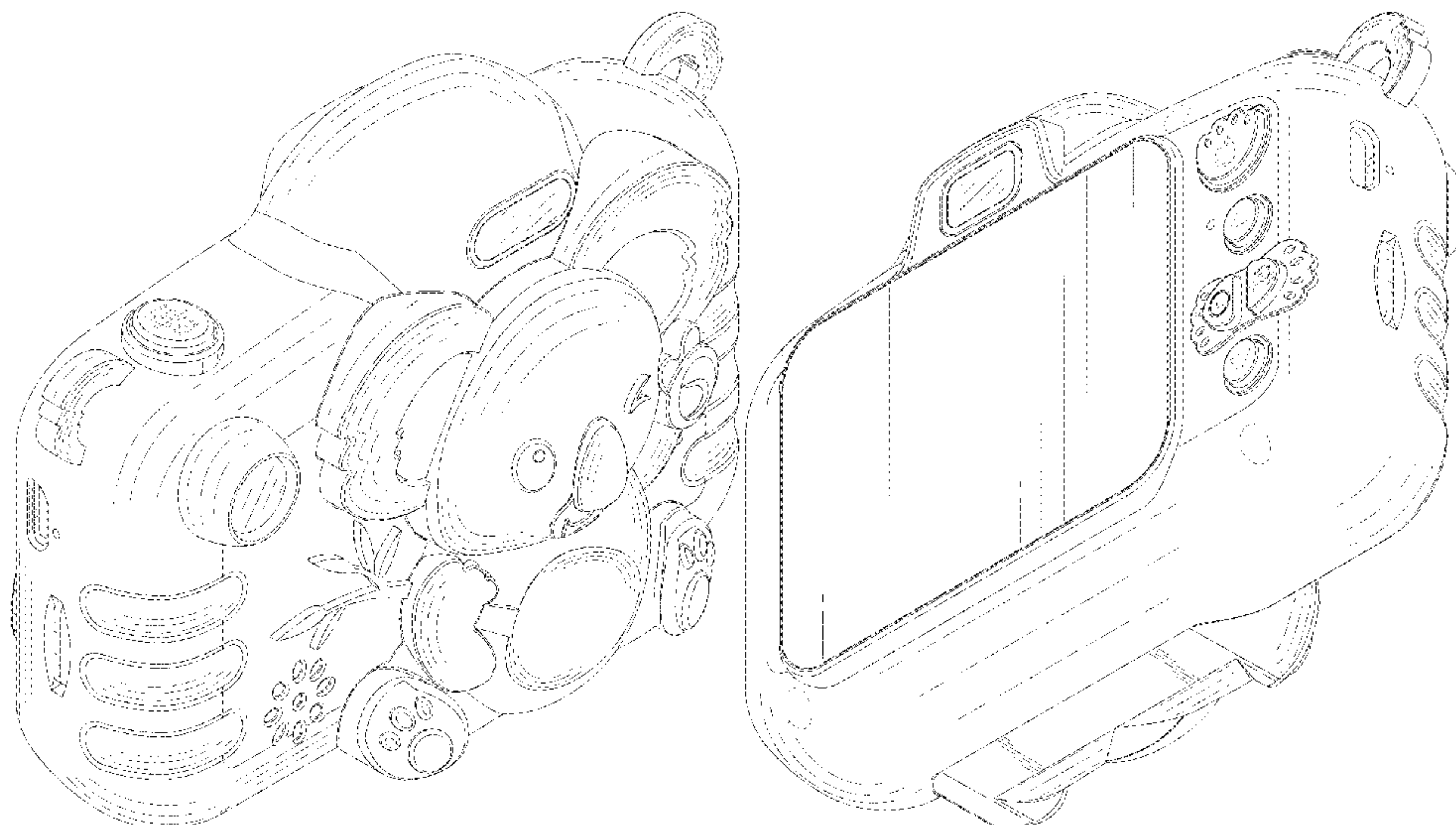
The ornamental design for a kids camera, as shown and described.

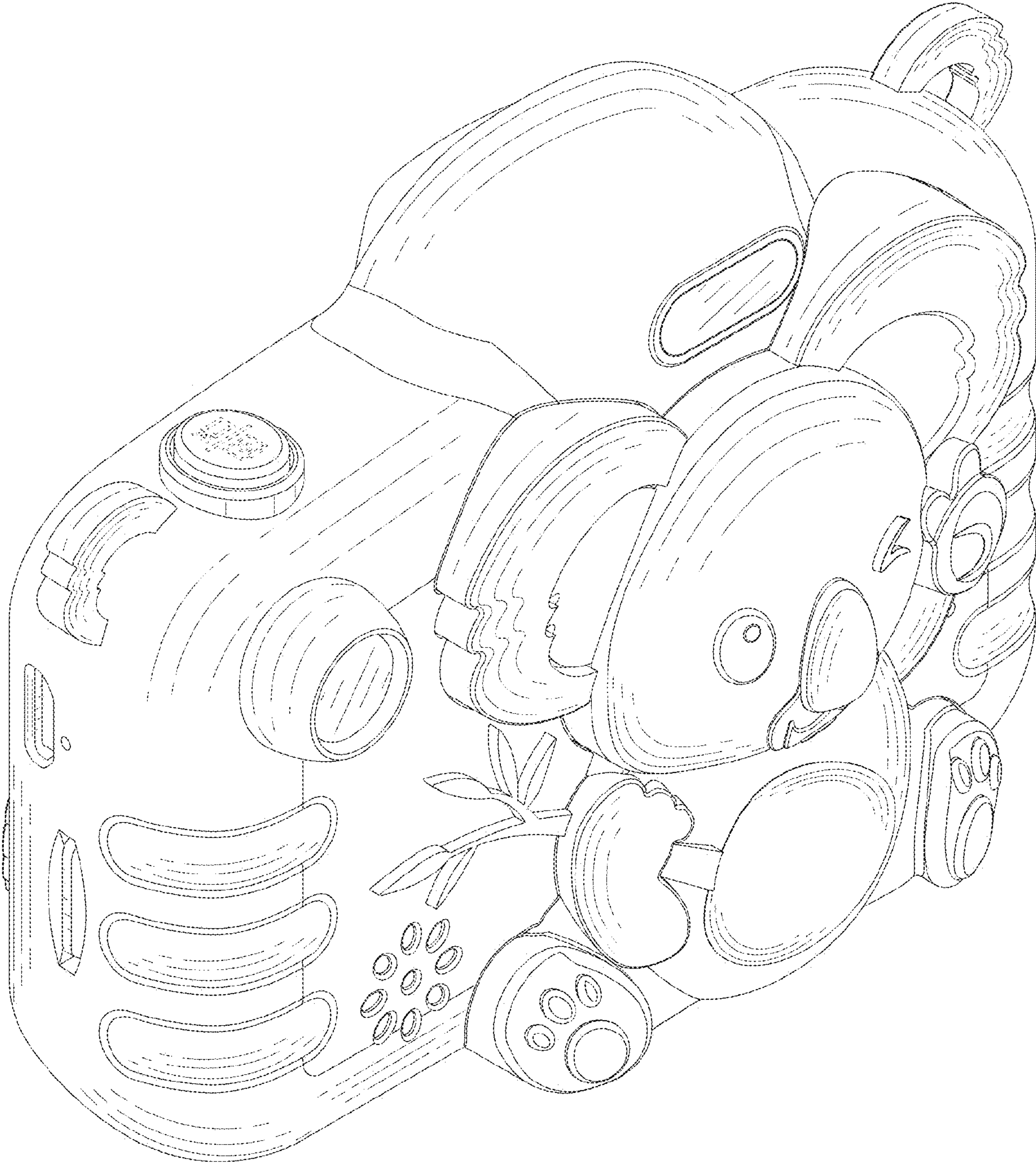

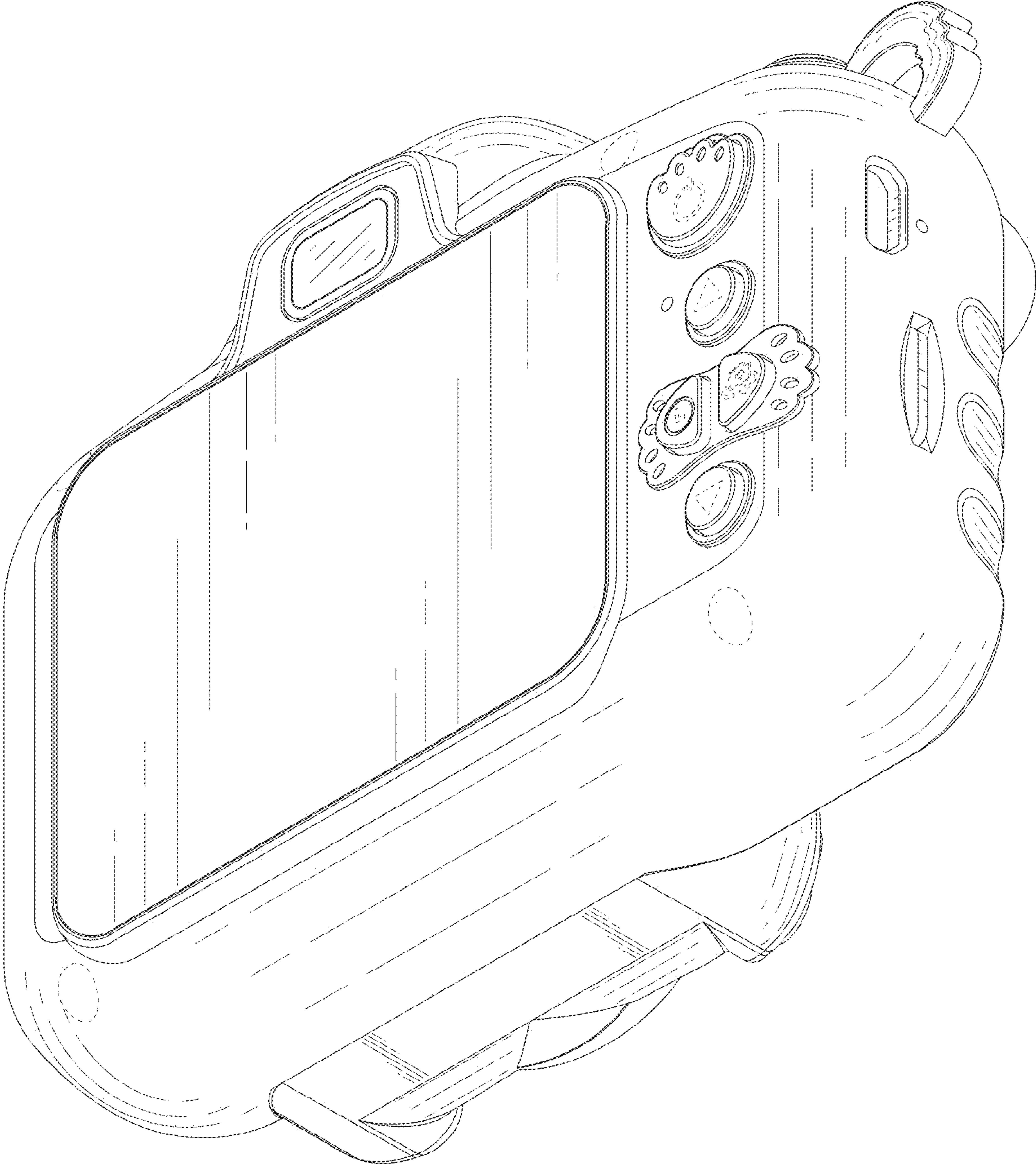

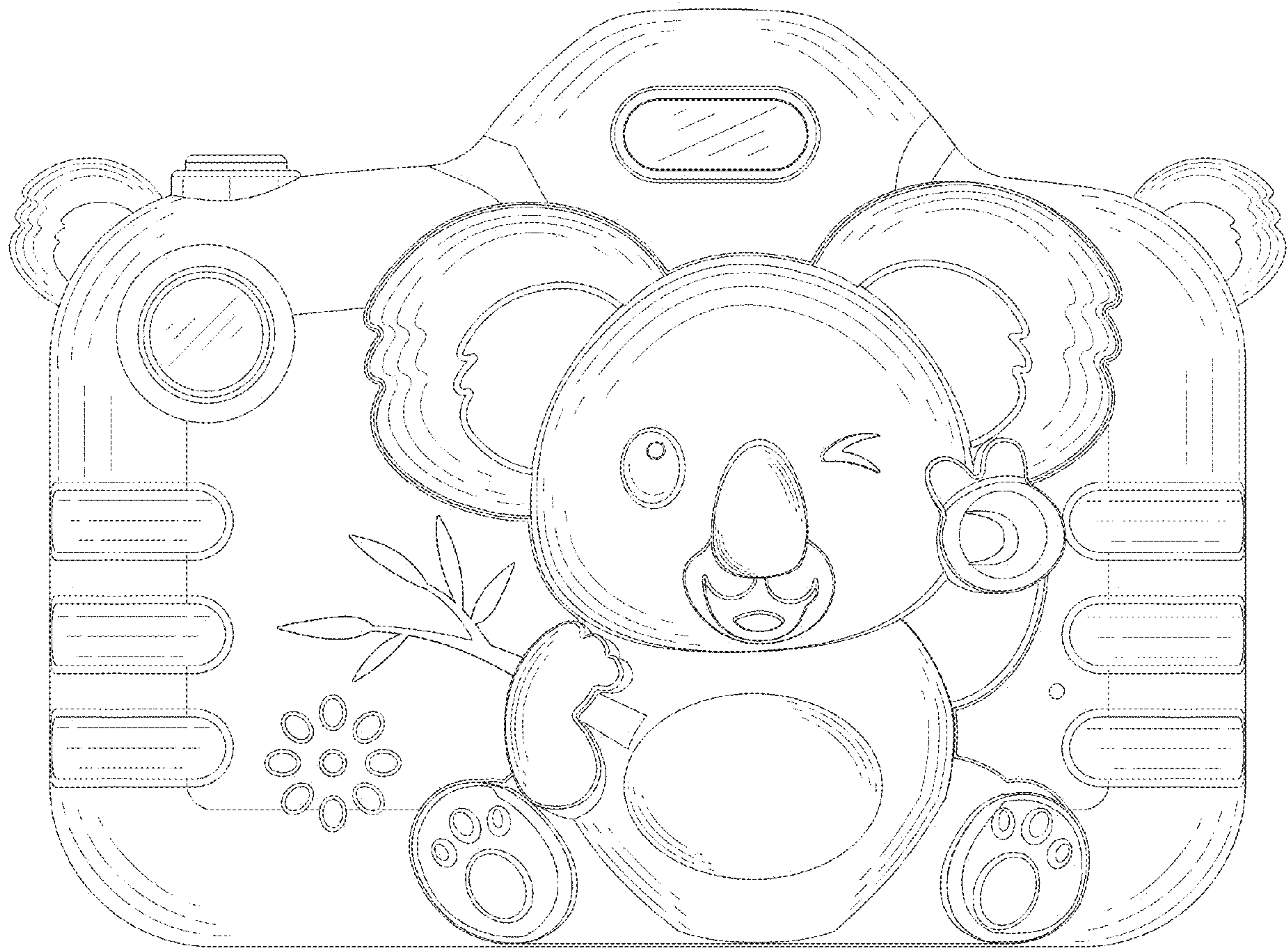

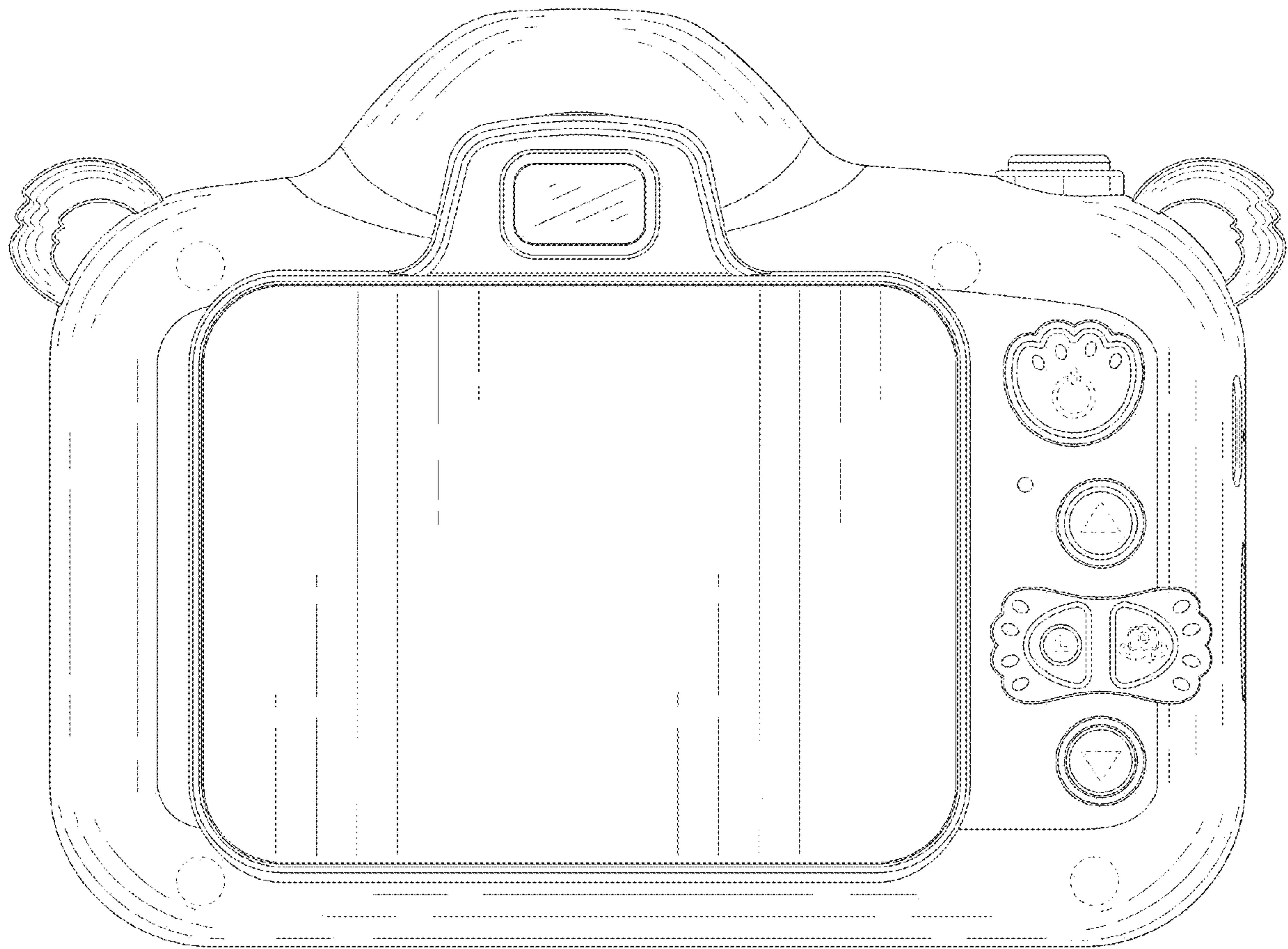

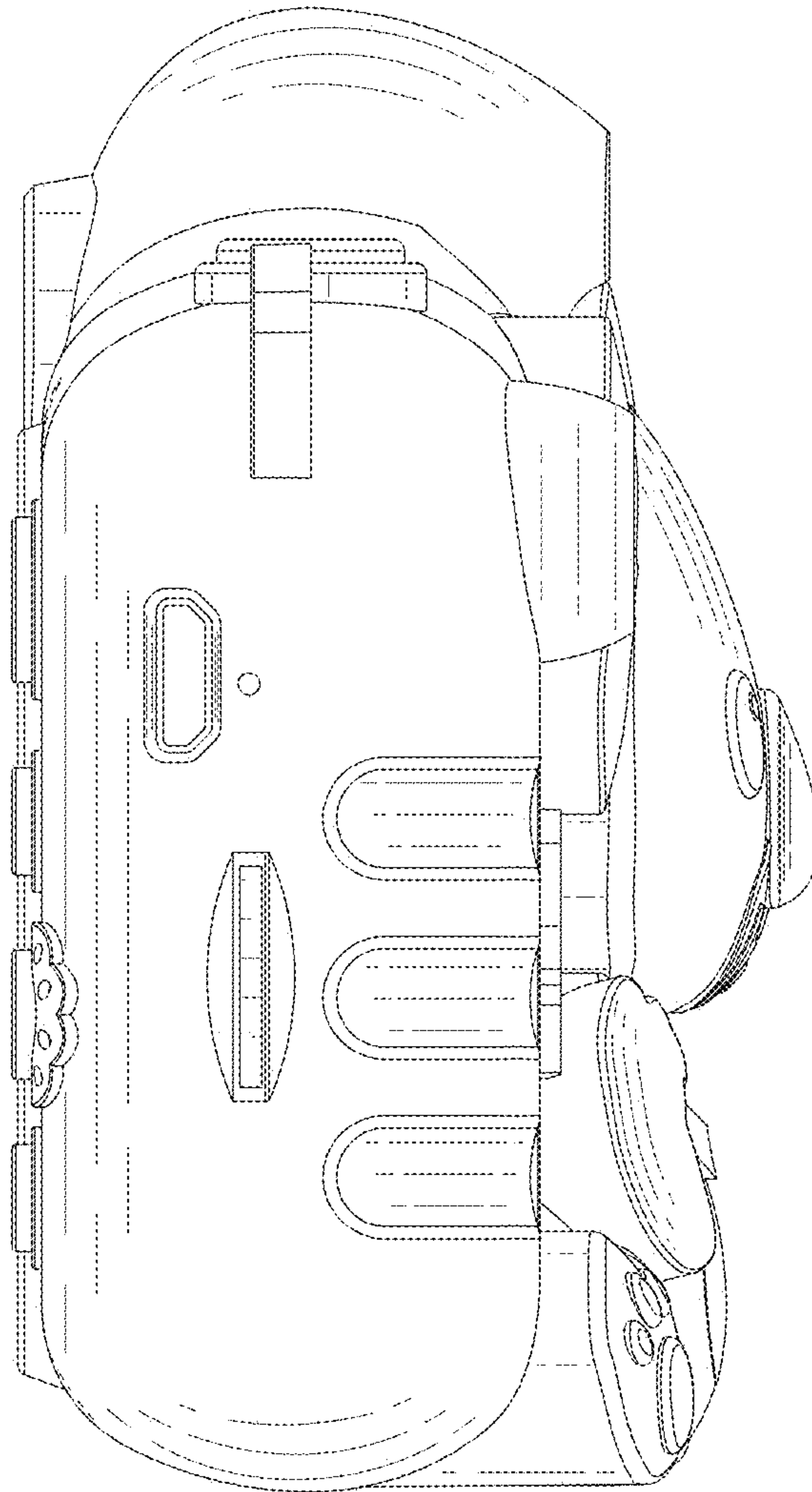

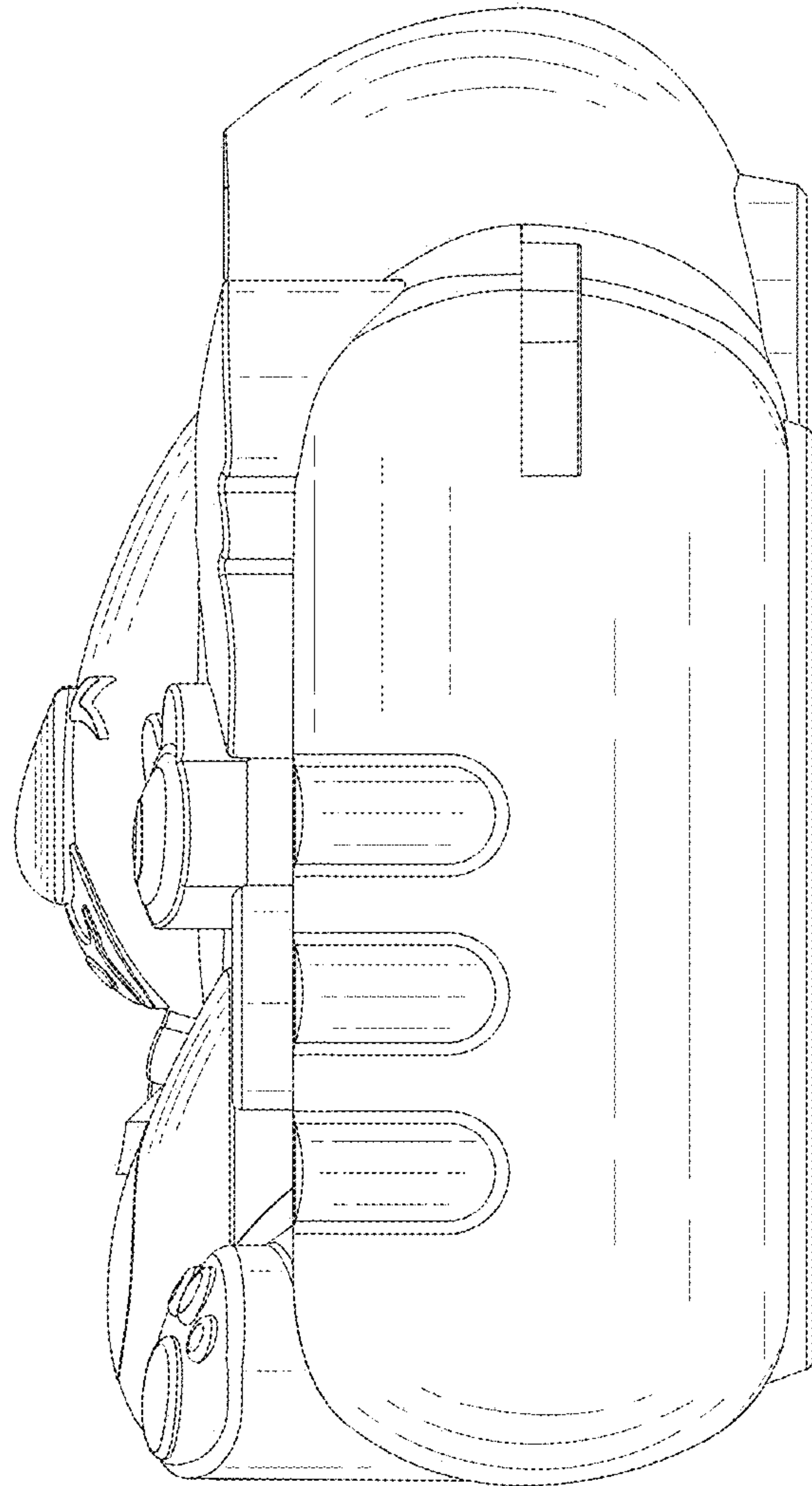

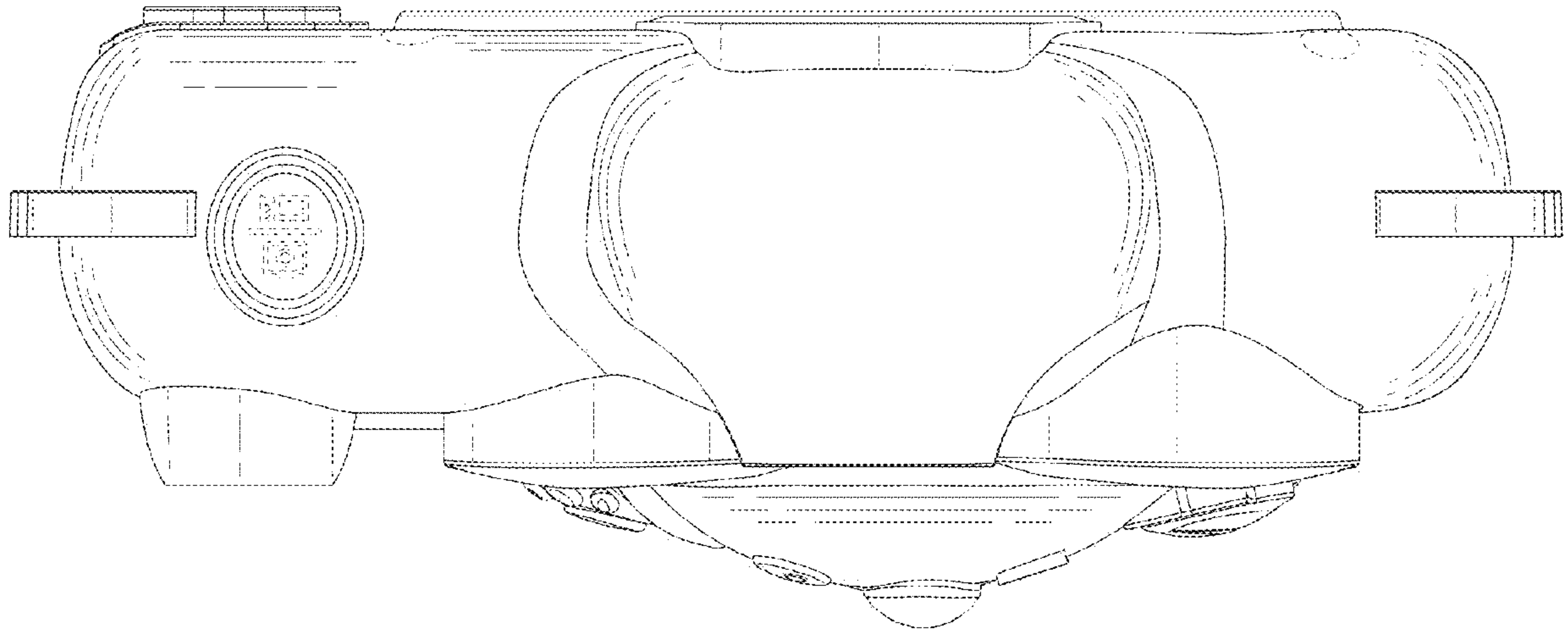

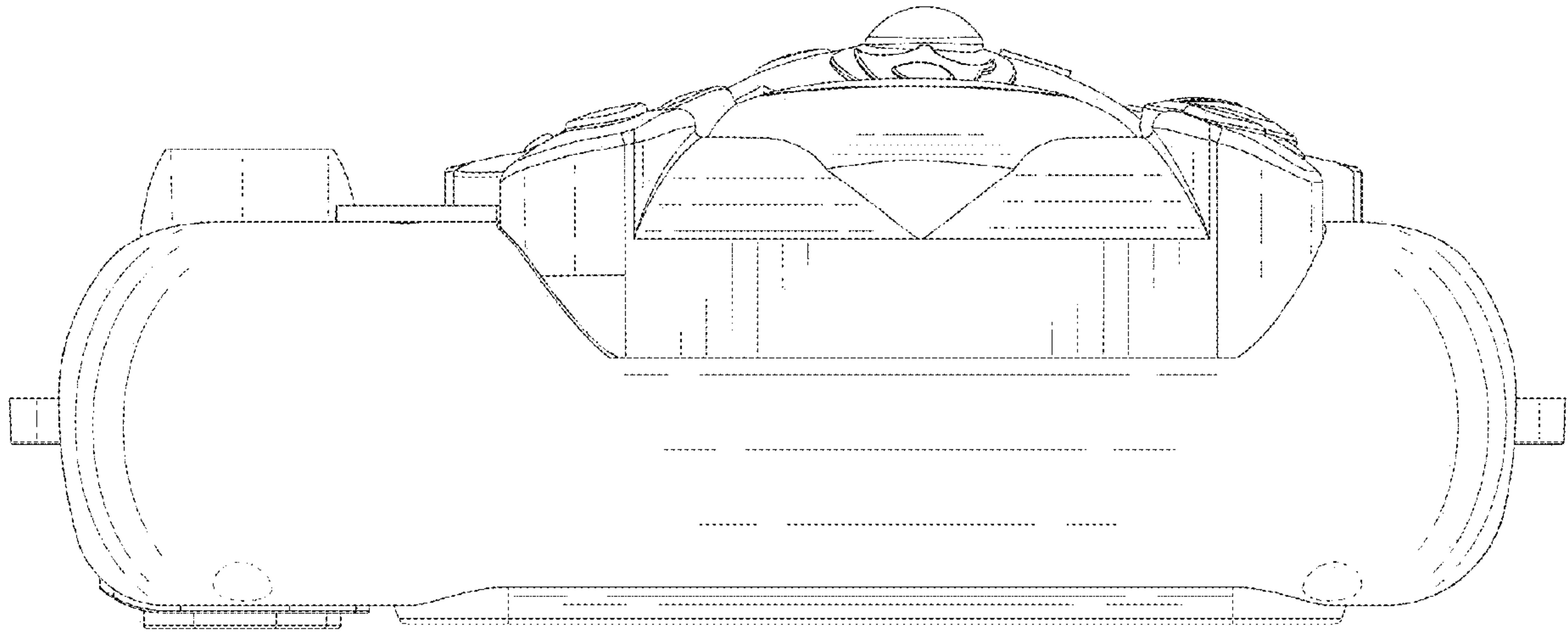
