(57) **CLAIM**
The ornamental design for a table tray for toy beads, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, and right side perspective view of a table tray for toy beads showing my new design; FIG. 2 is a rear, top, and left side perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is a right side view thereof; and, FIG. 8 is a left side view thereof. The broken lines shown are included for the purpose of illustrating portions of the article which form no part of the claimed design.

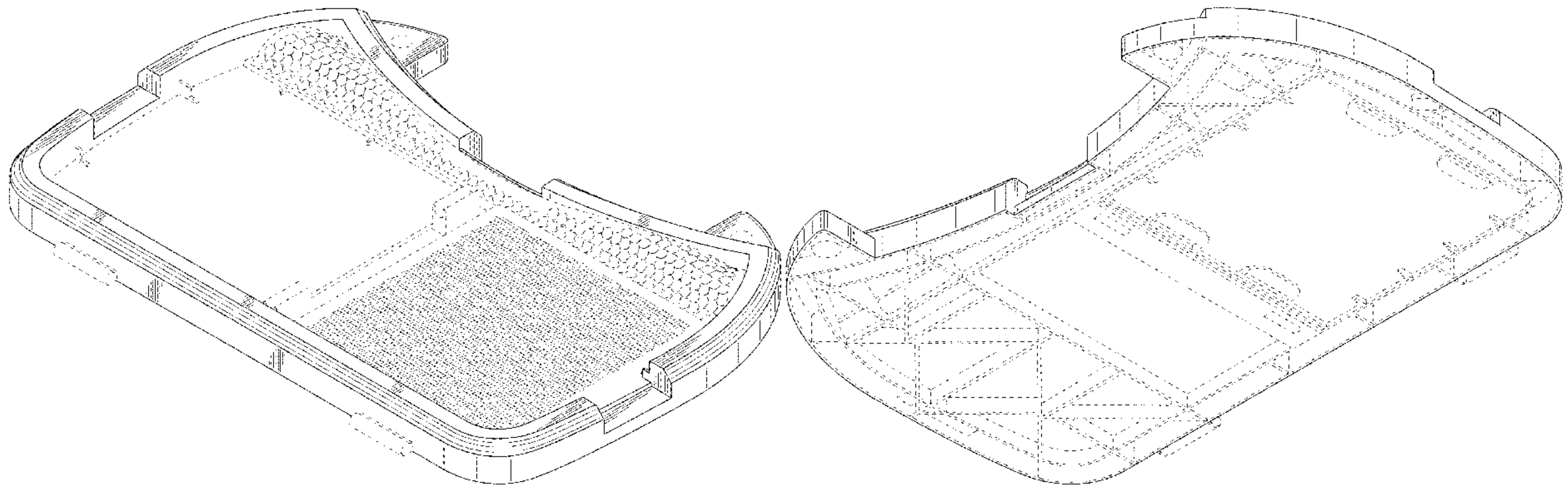

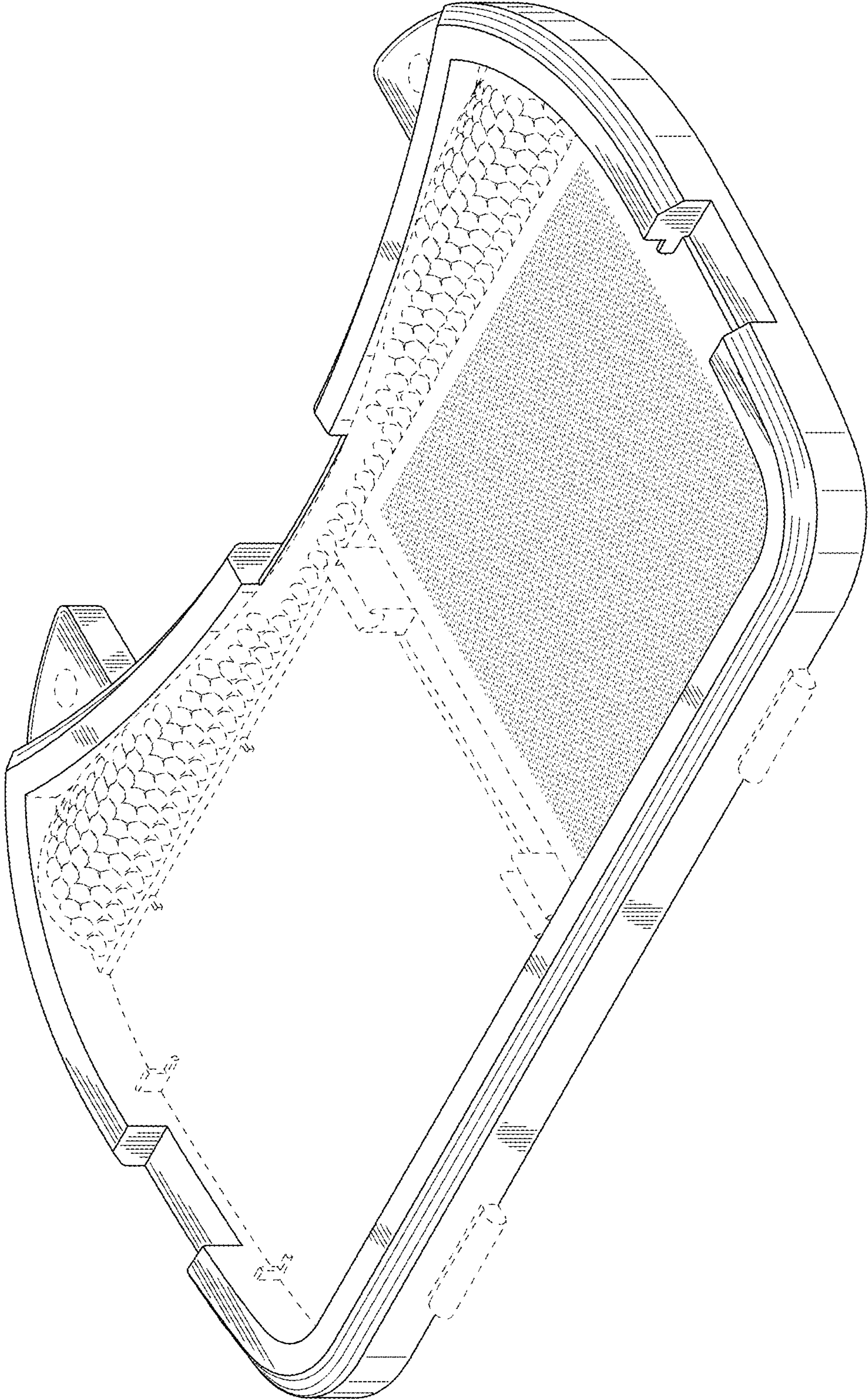

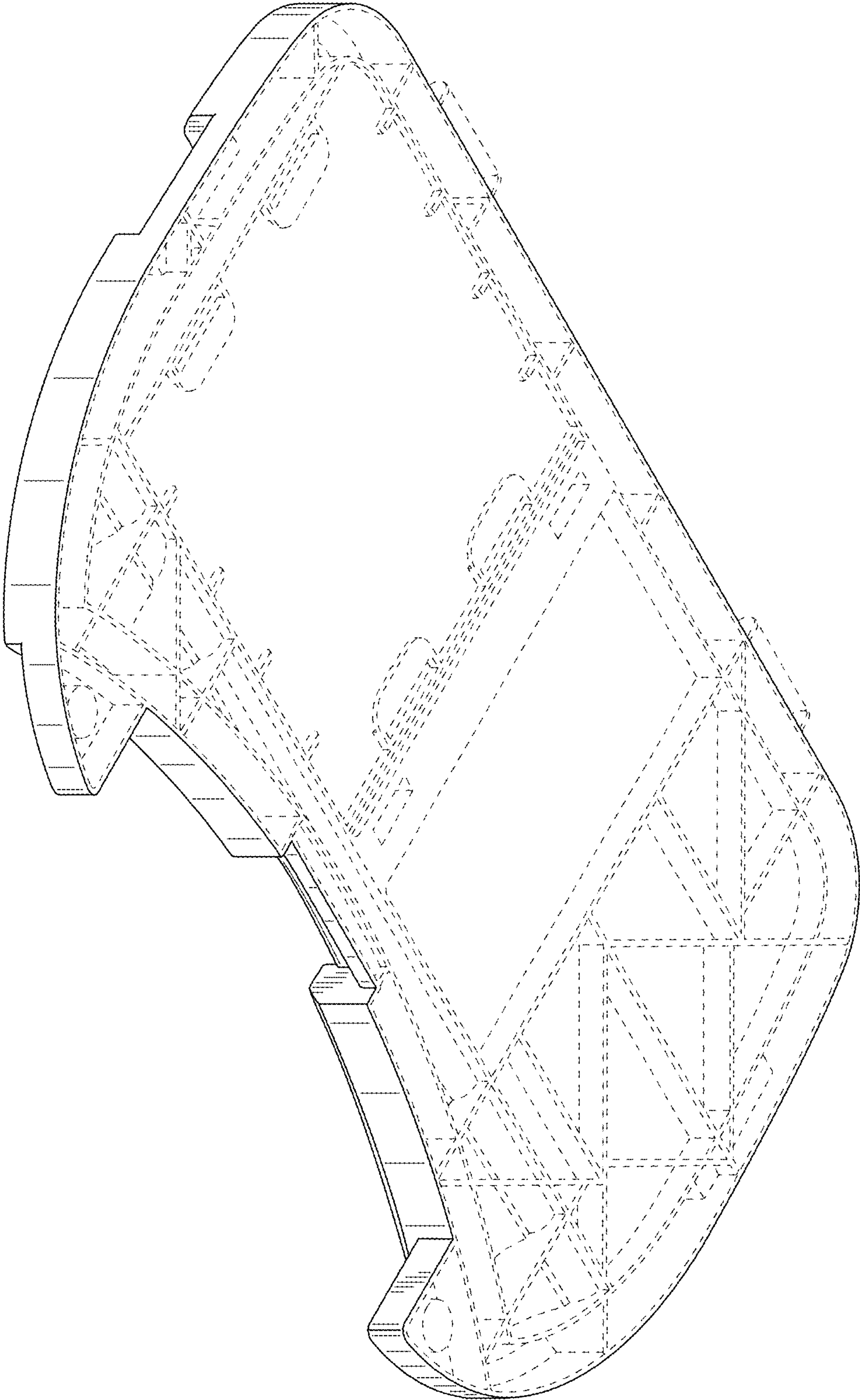

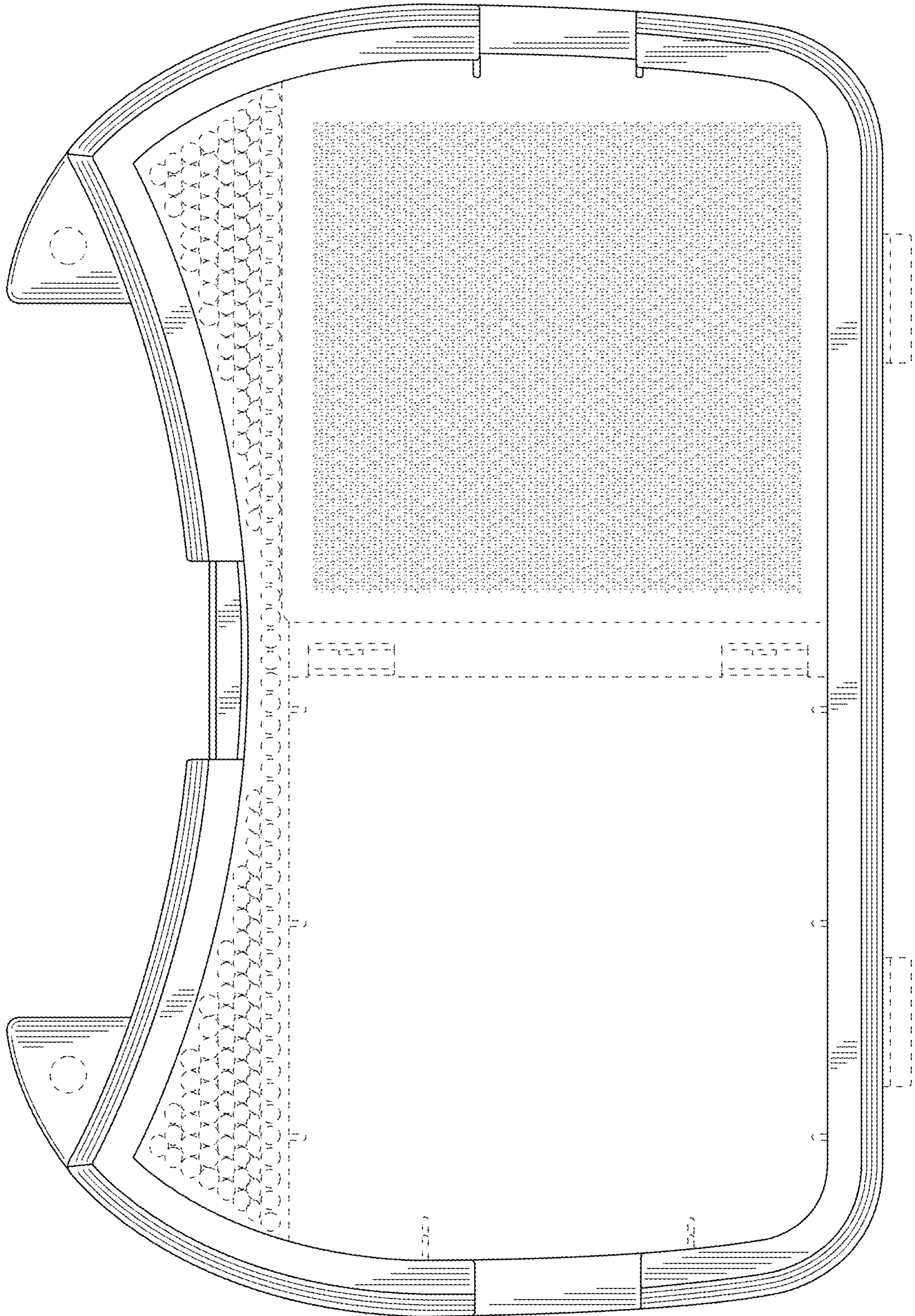

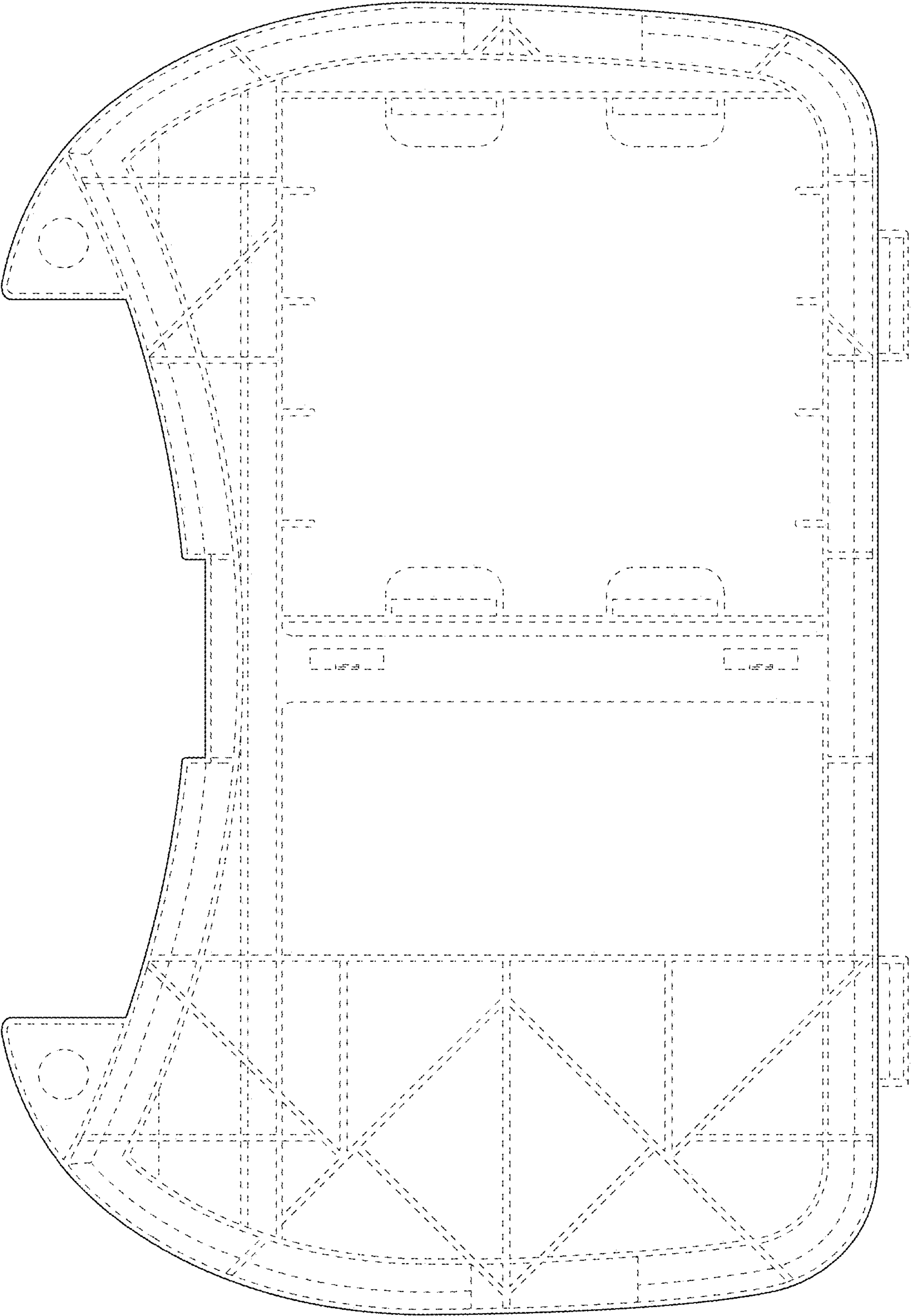

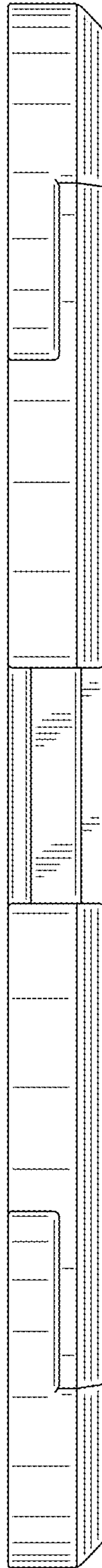

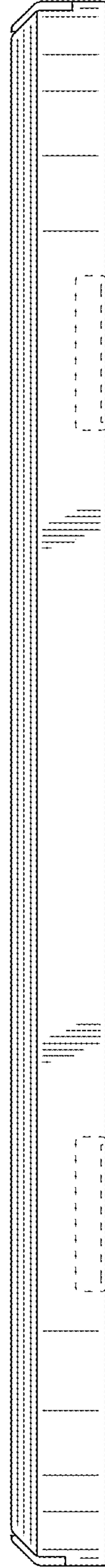

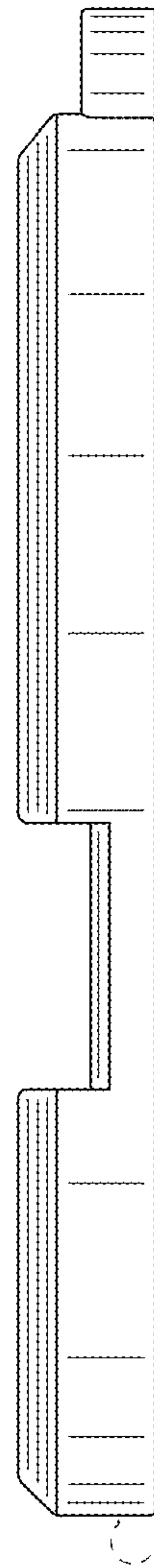
