(57) **CLAIM**

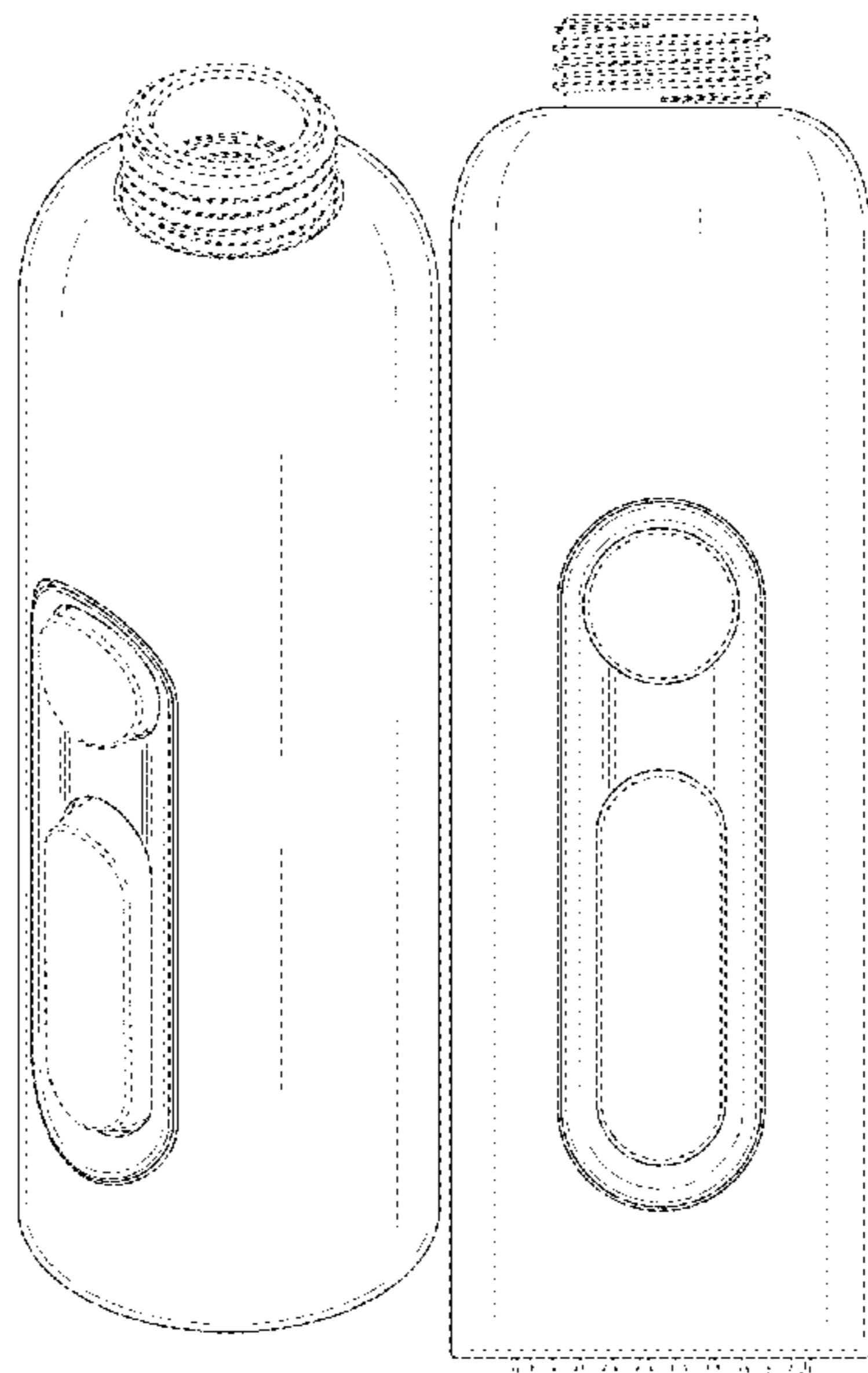
We claim the ornamental design for a handshower, as shown and described.

**DESCRIPTION**

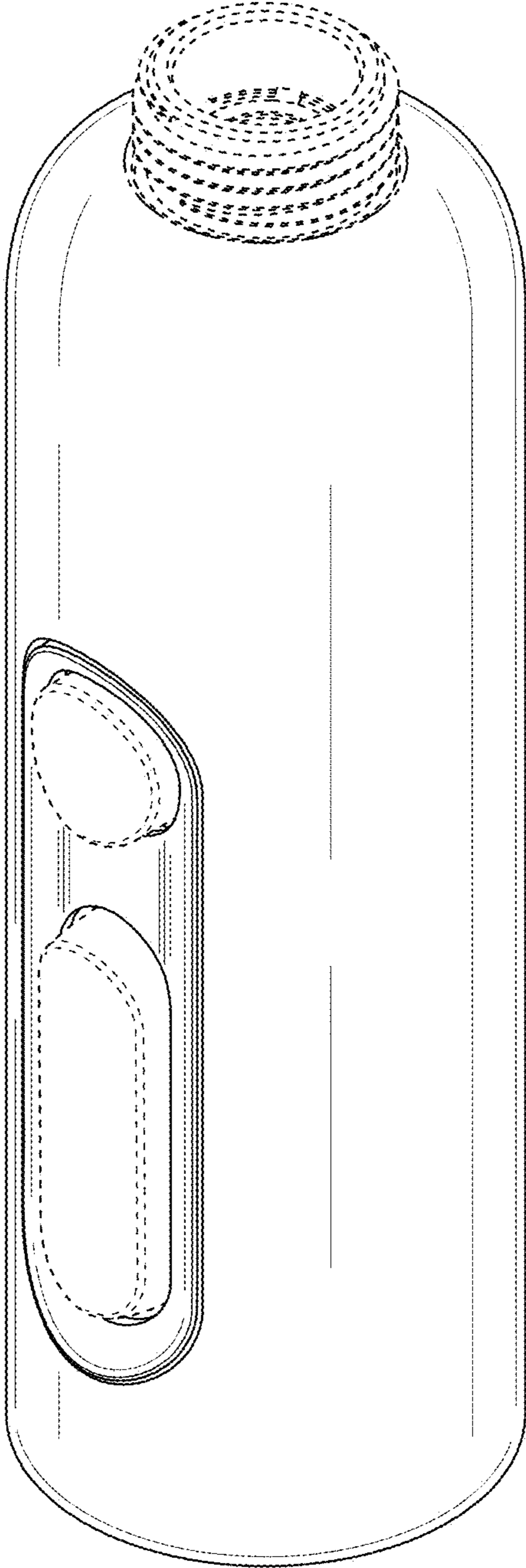

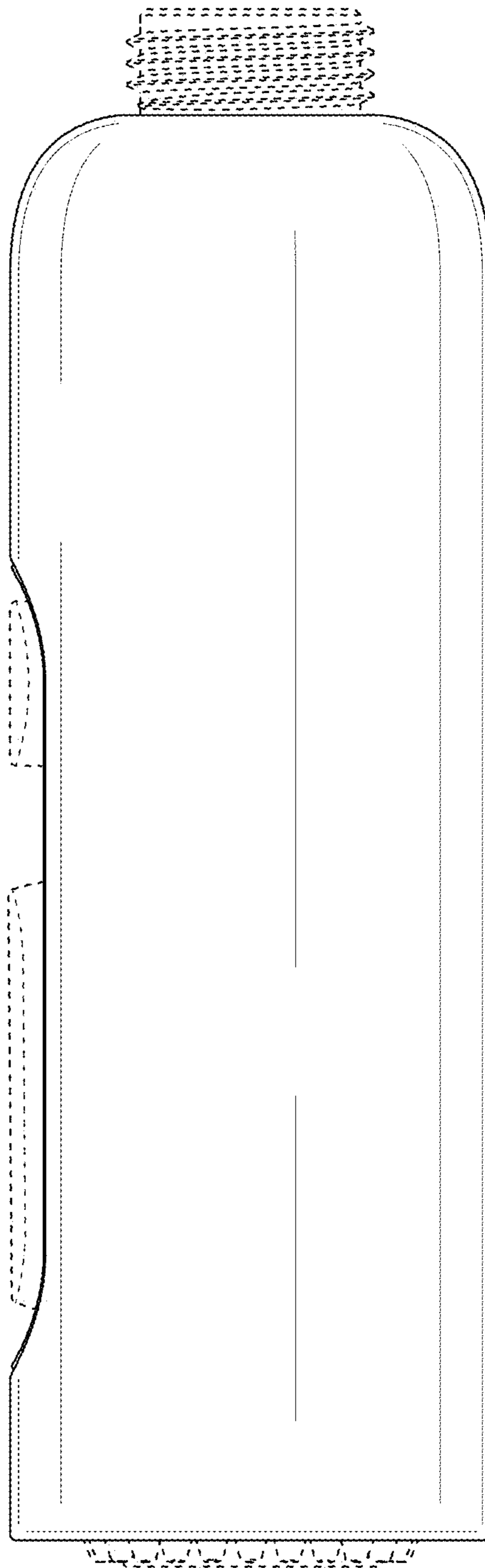

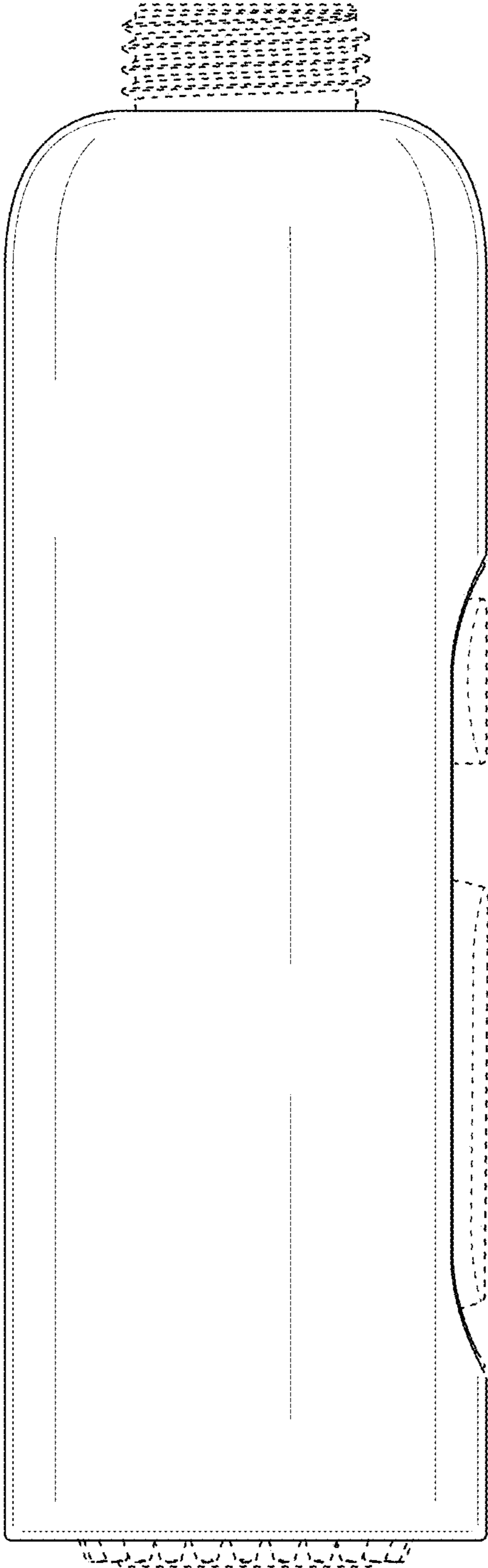
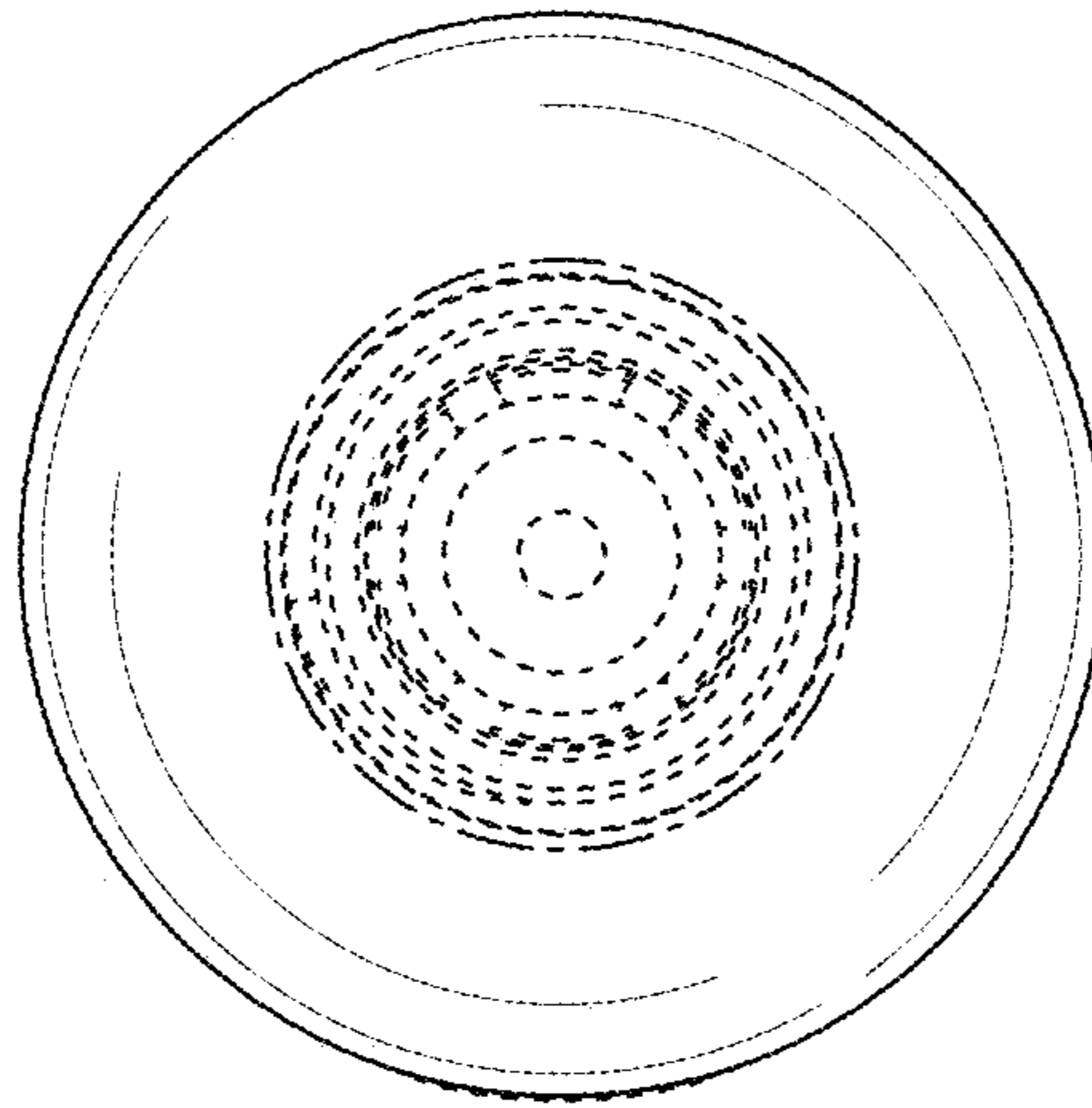
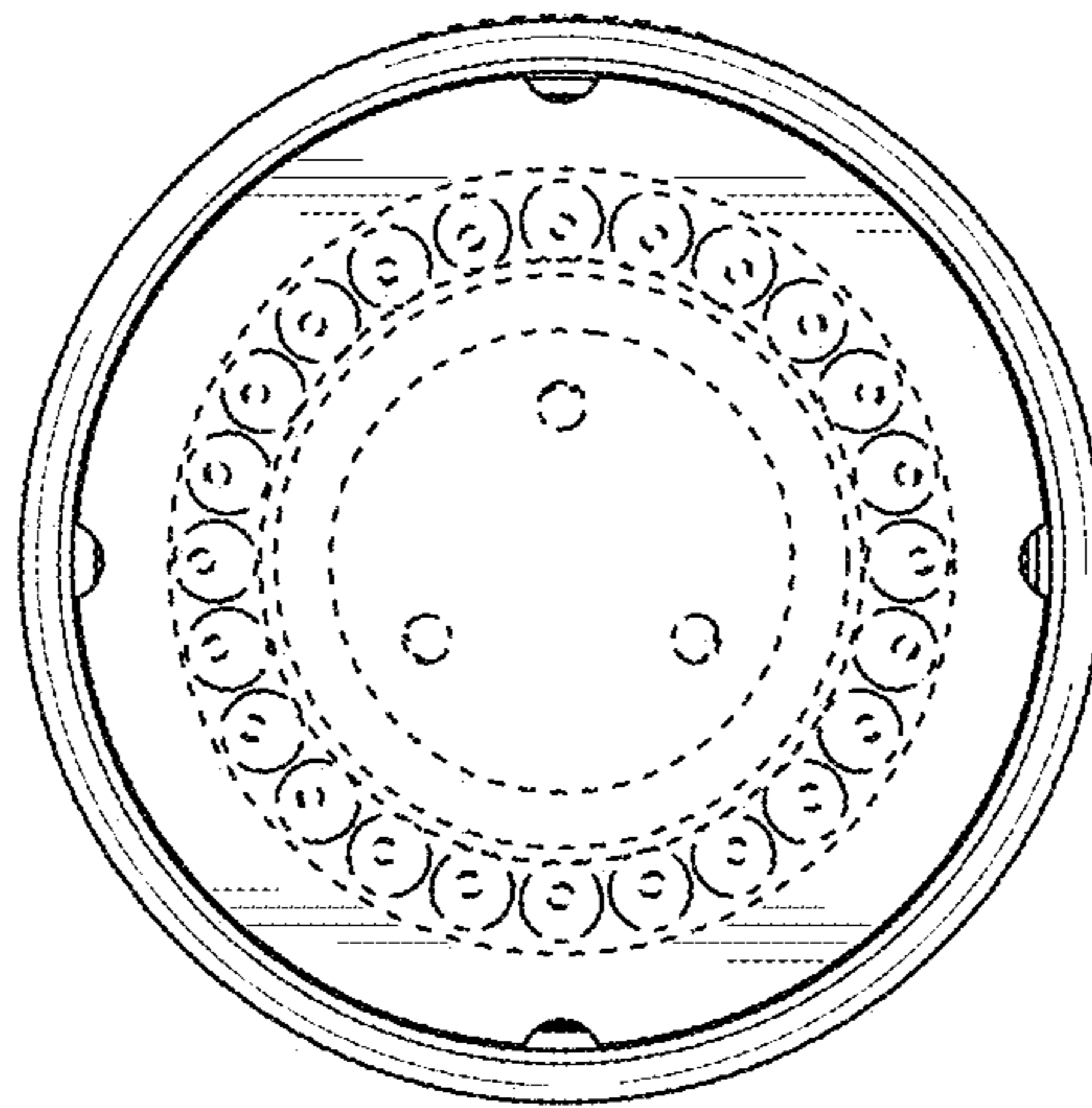

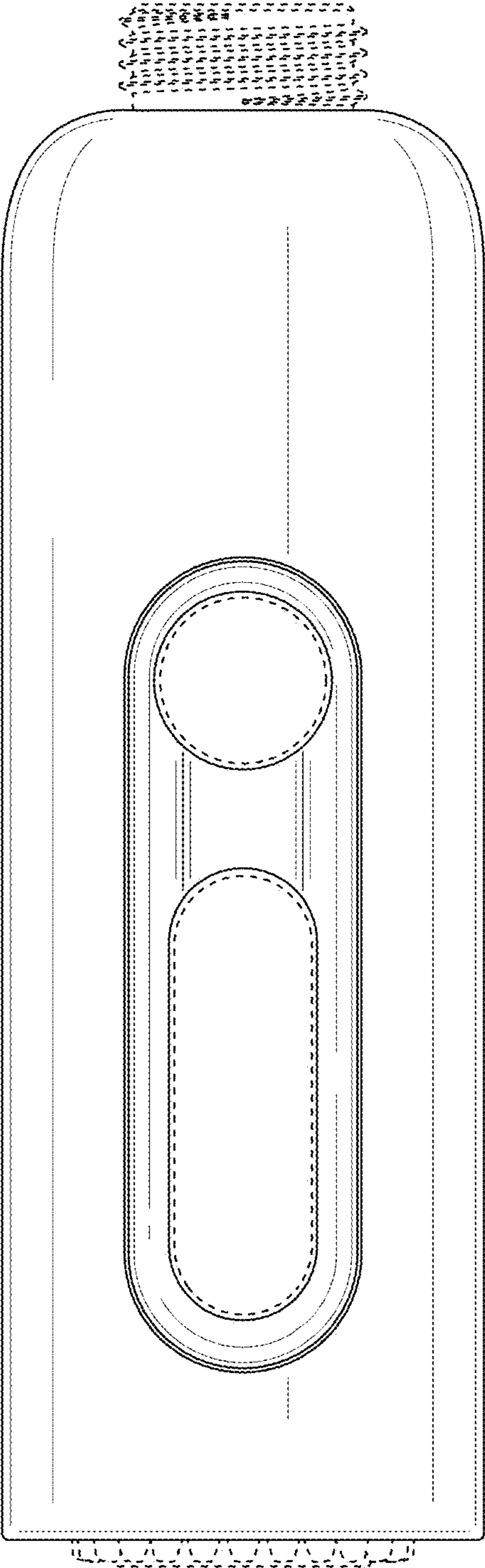
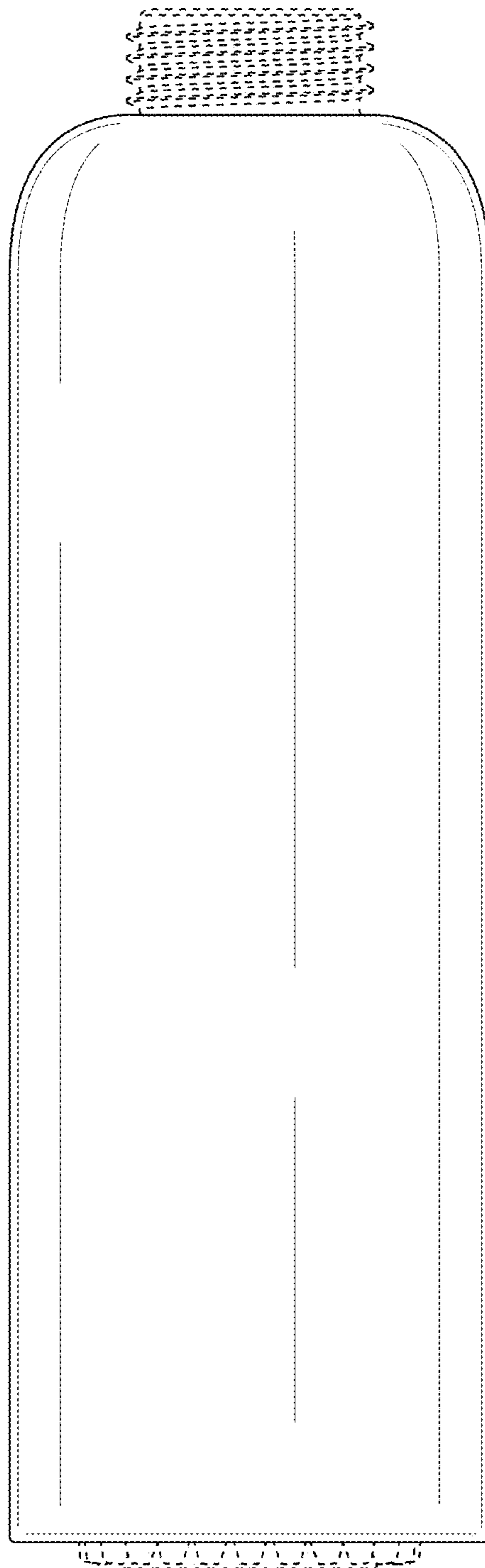
