(57) **CLAIM**

The ornamental design for a chain link fence assembly, as shown and described.

FIG. 1 is a front perspective view of the chain link fence assembly;

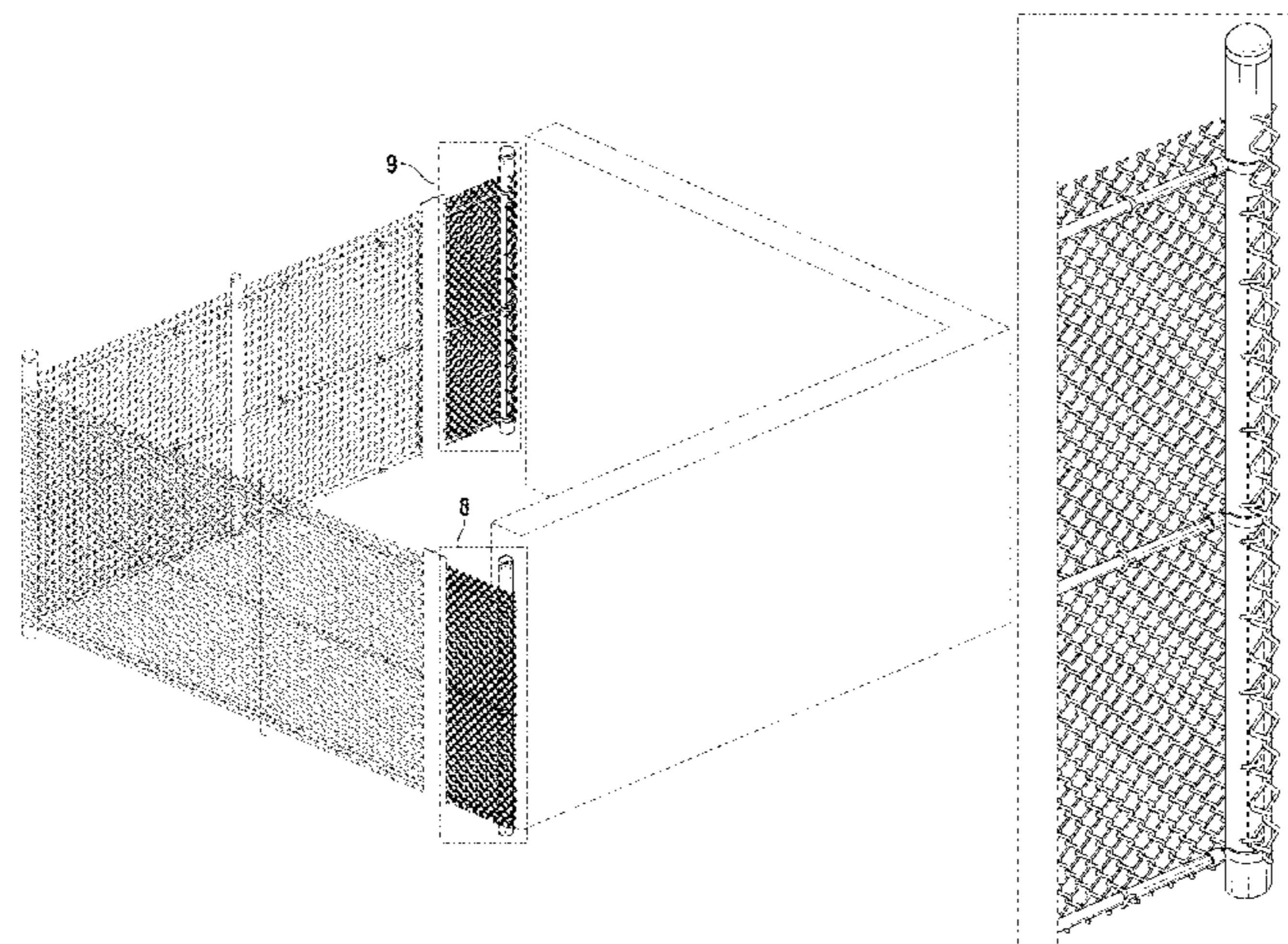


FIG. 22 is a left-side view of the fence post of the chain link fence assembly;

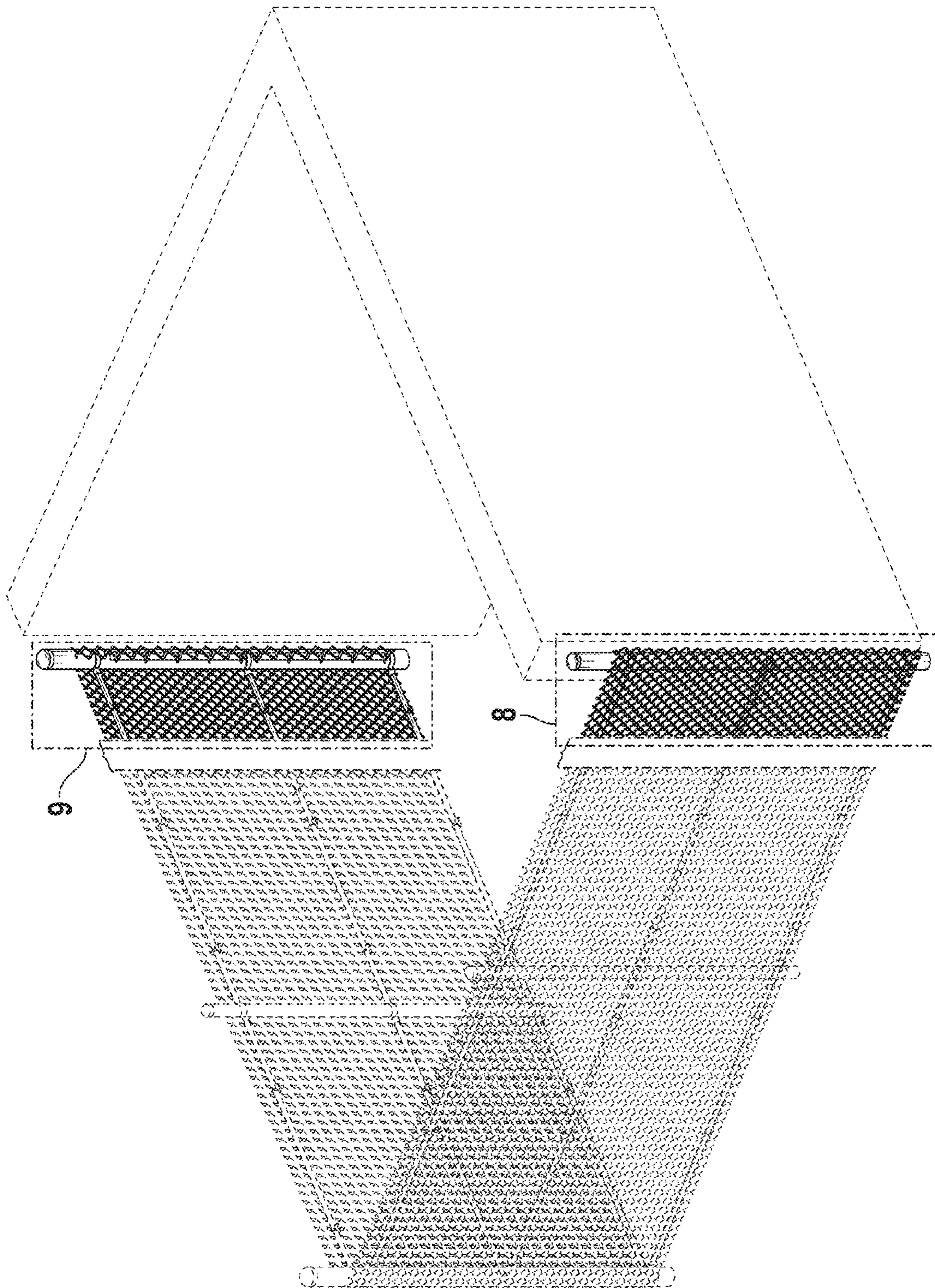

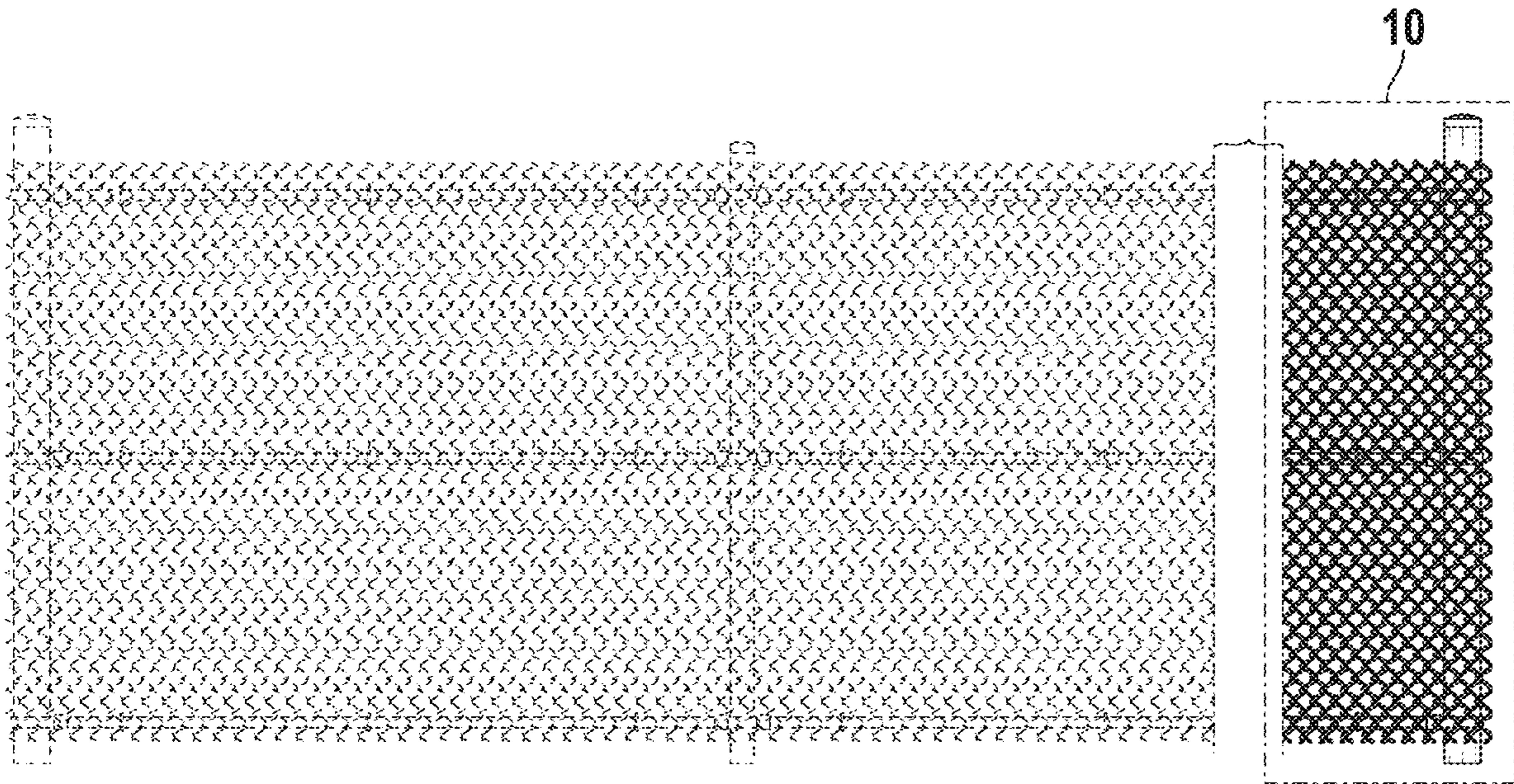

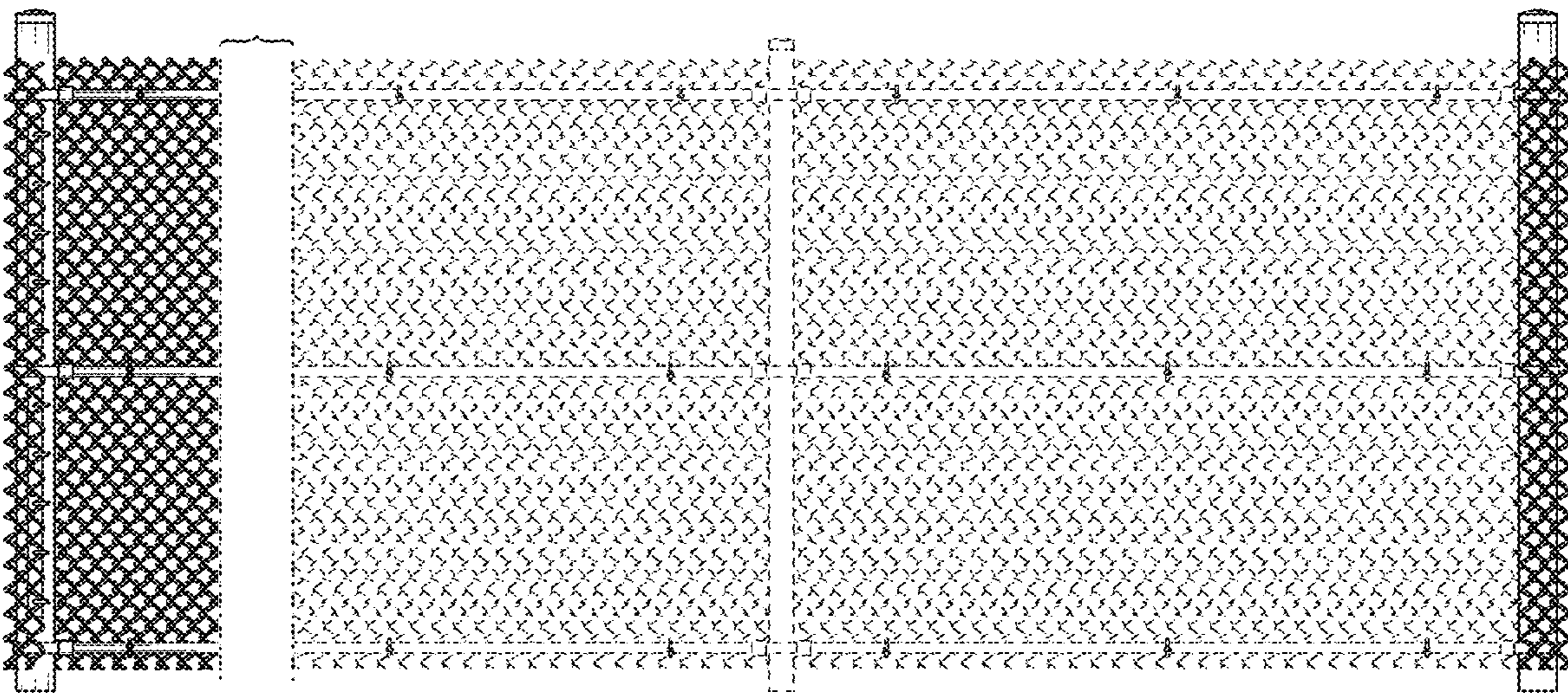

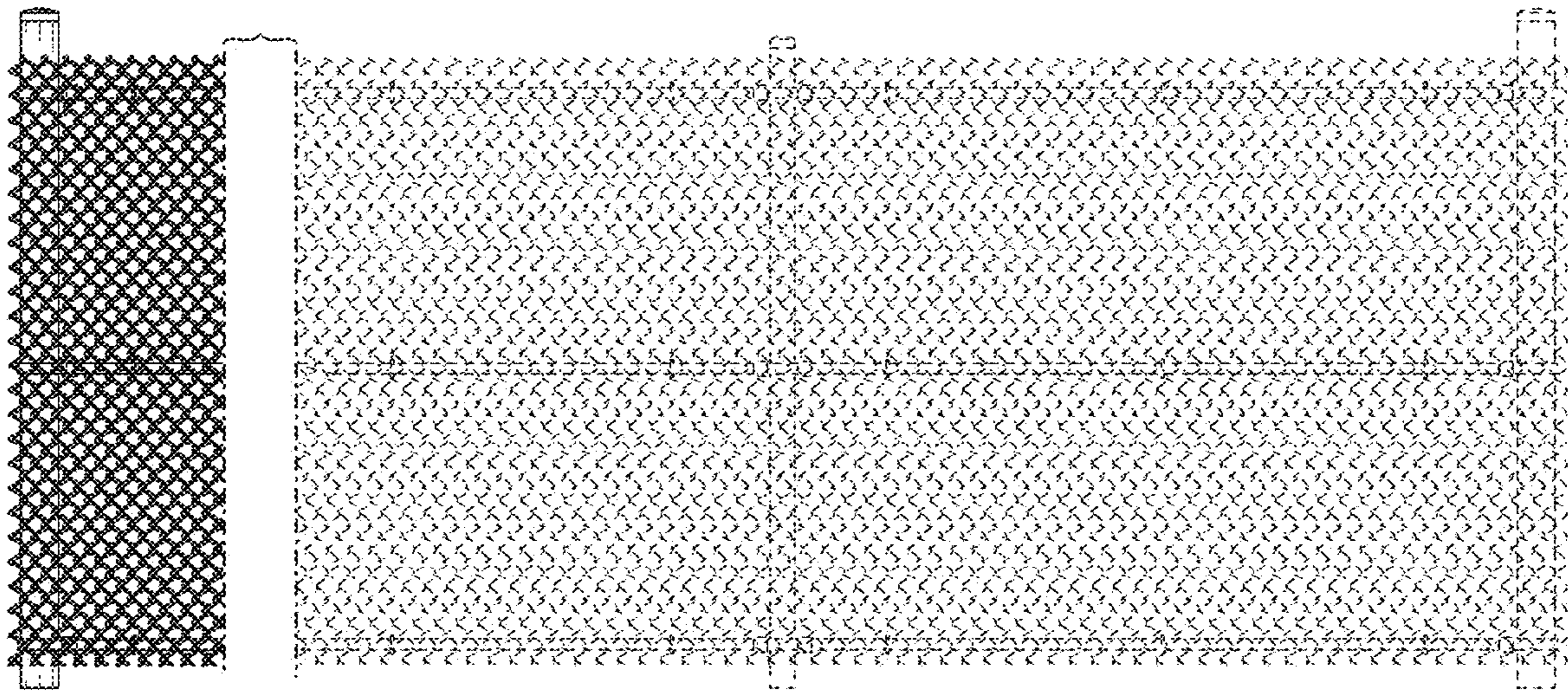

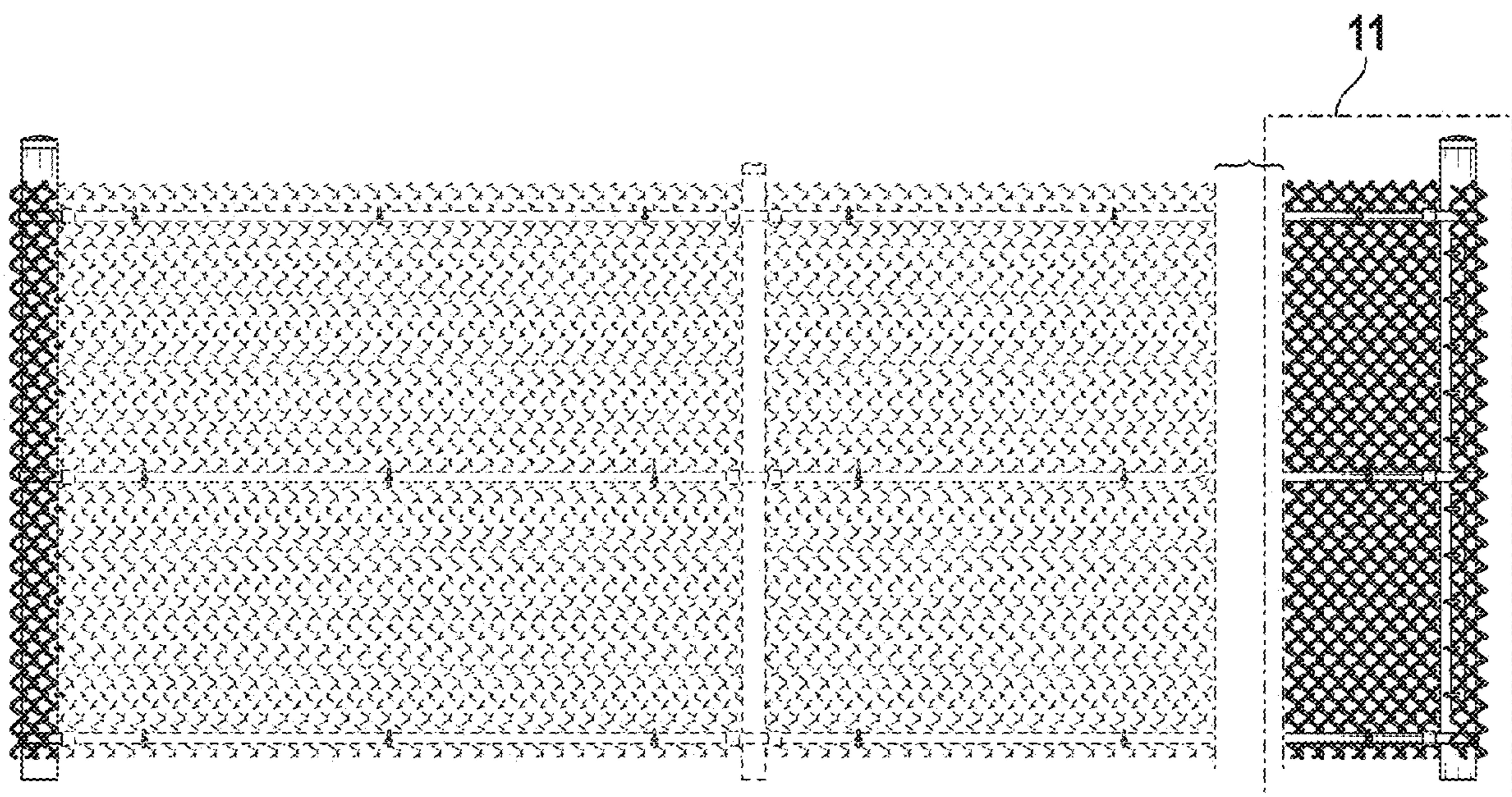

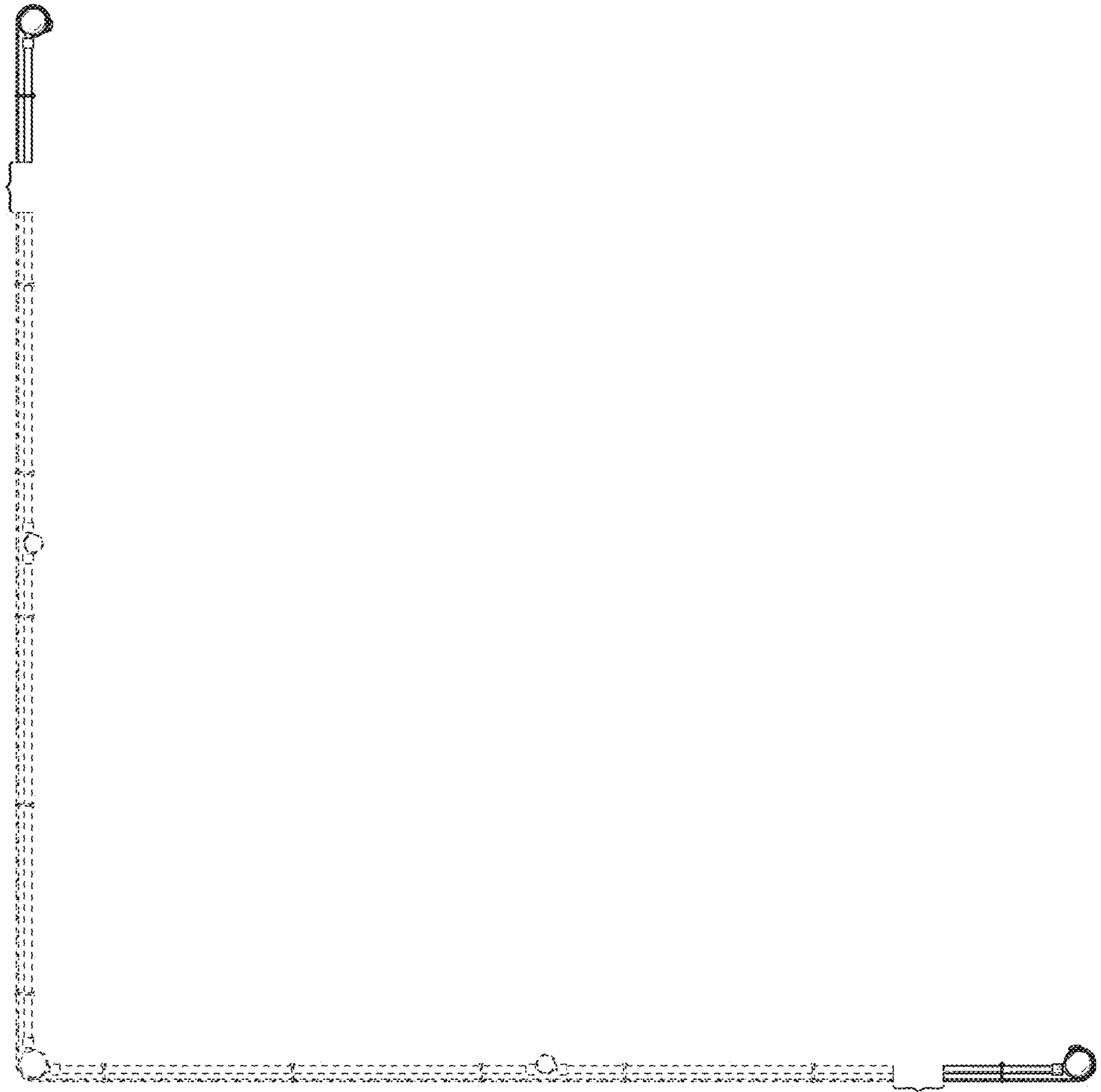

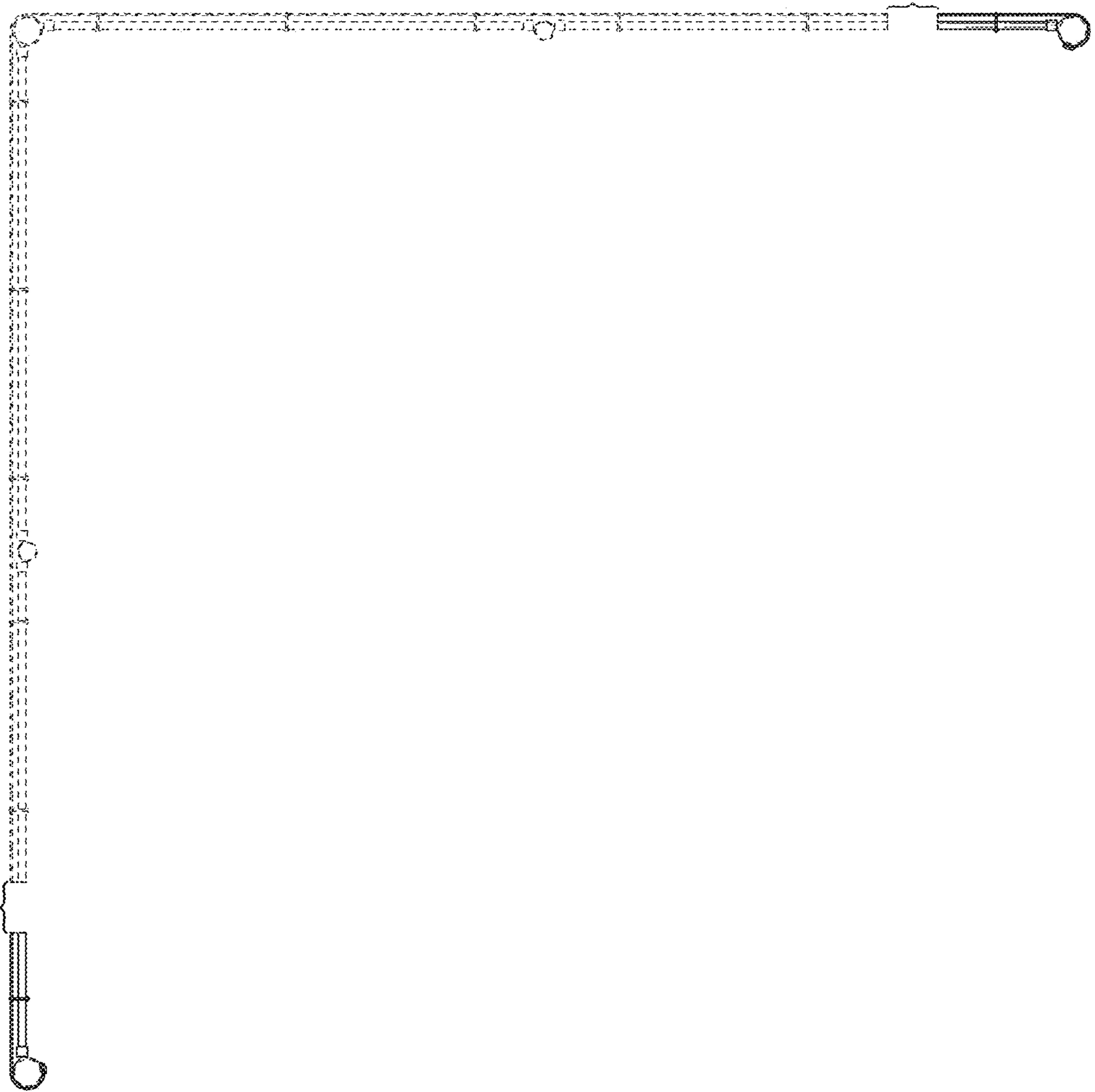

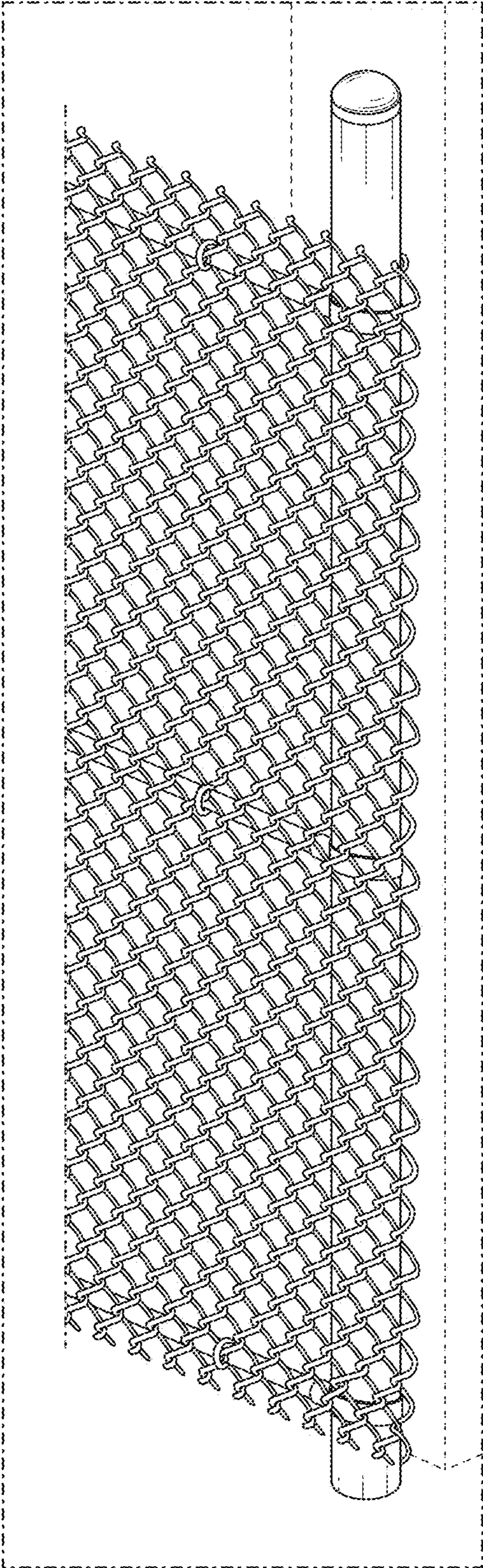

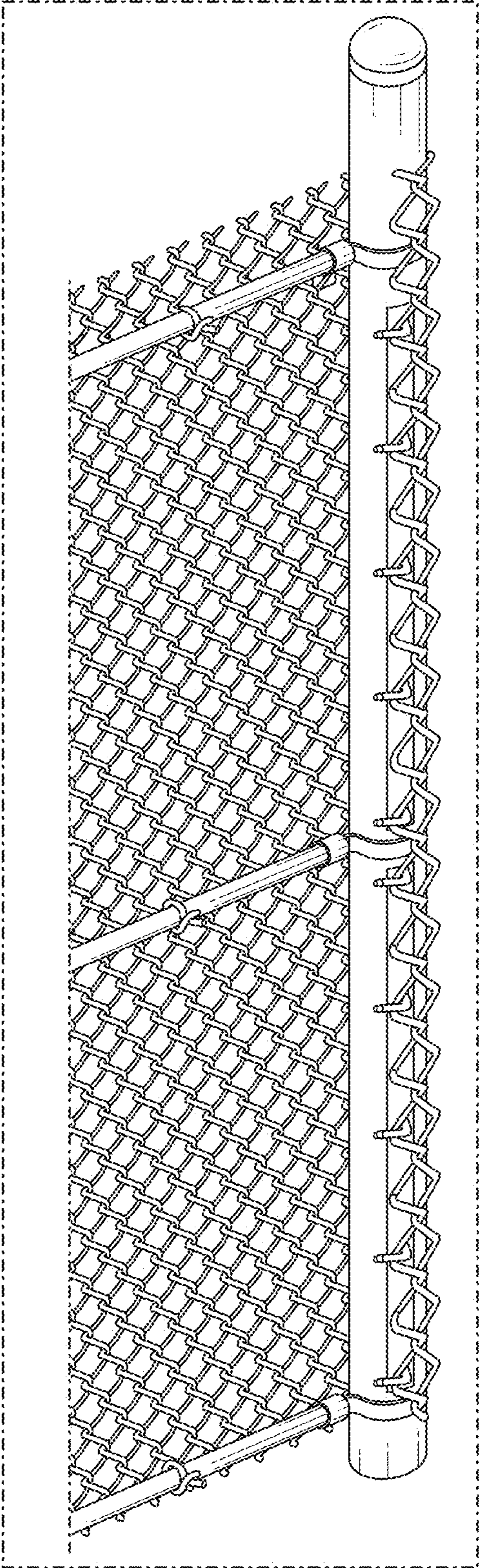

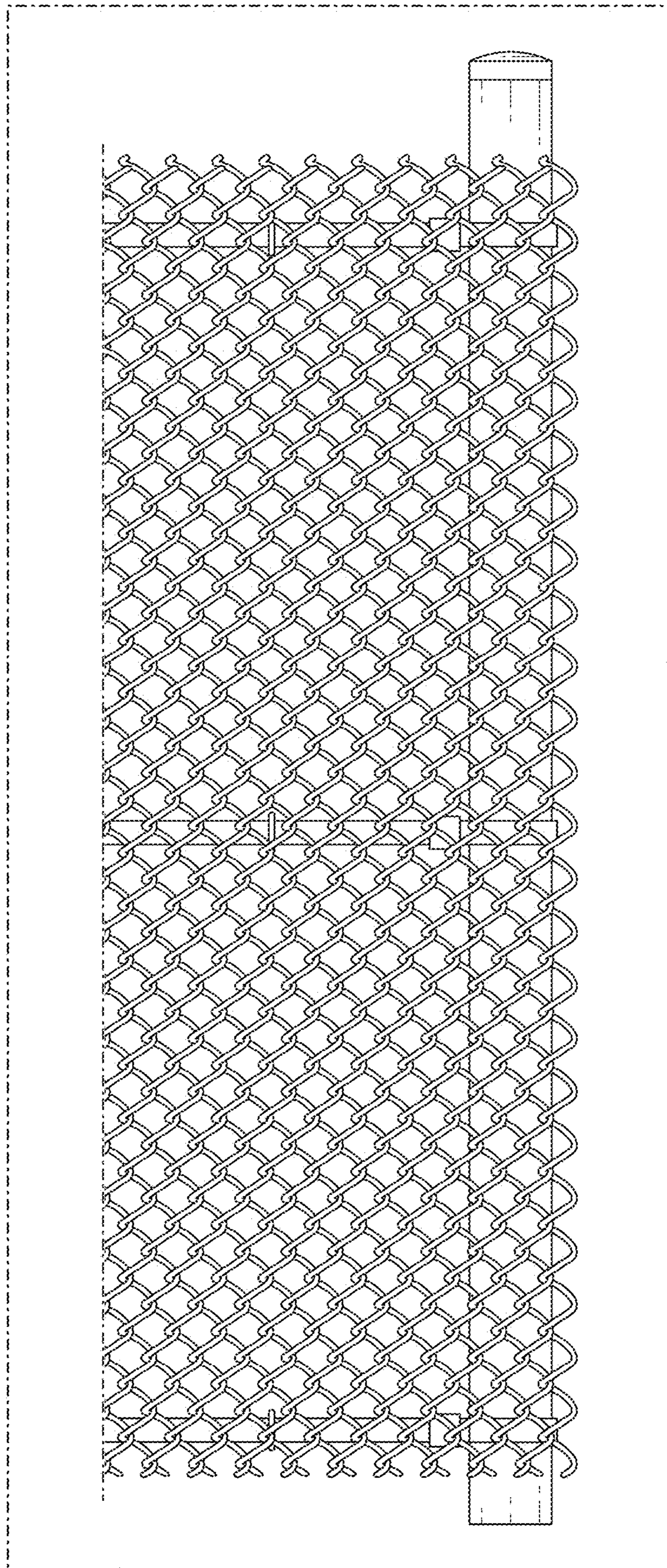

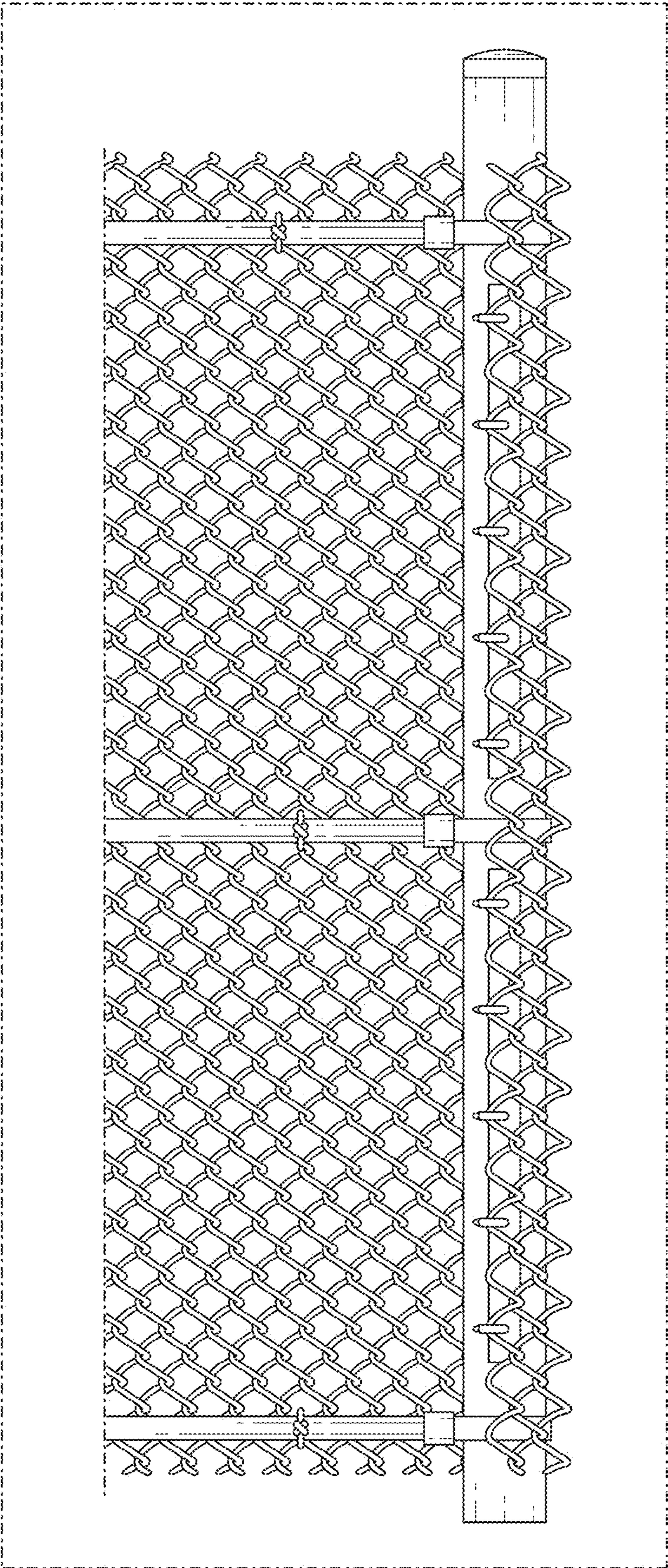

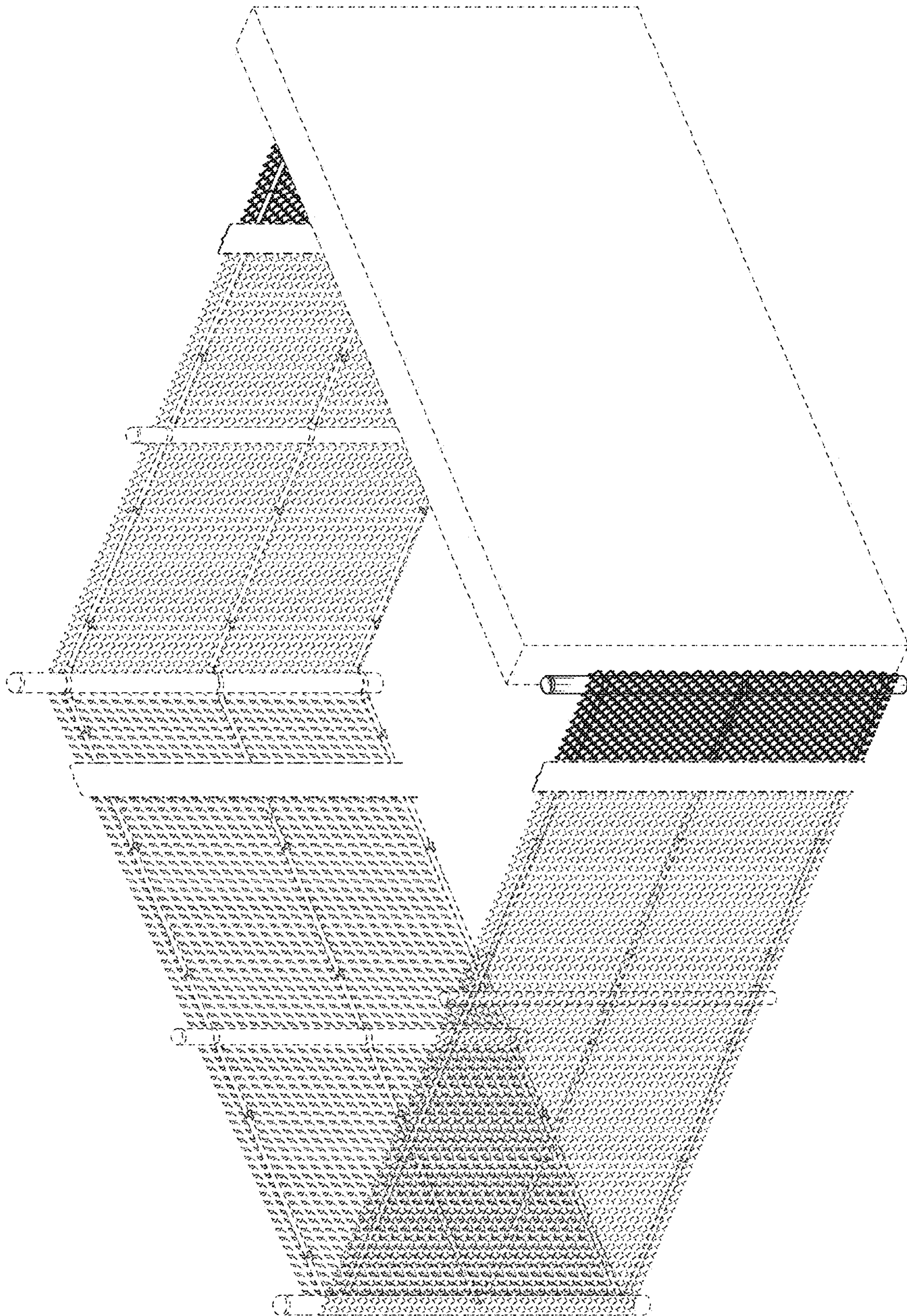

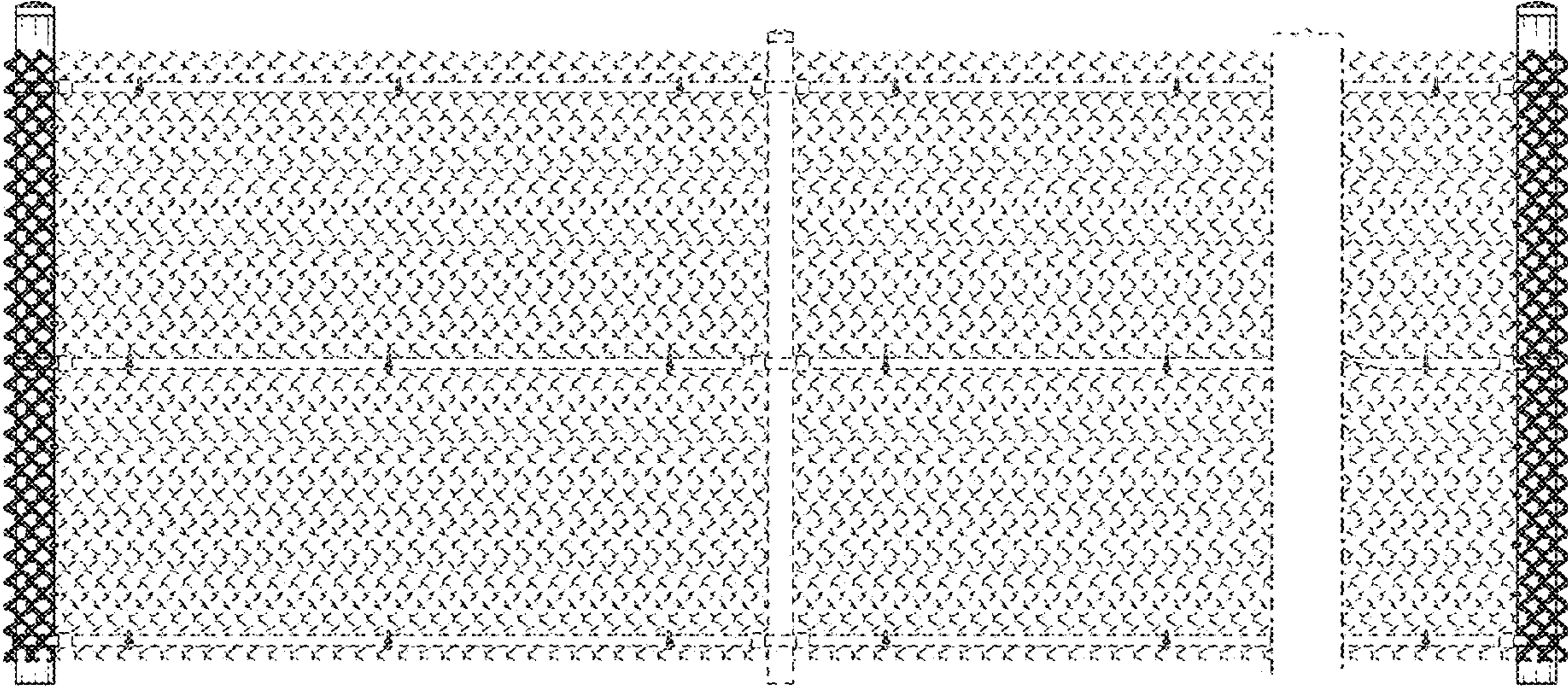

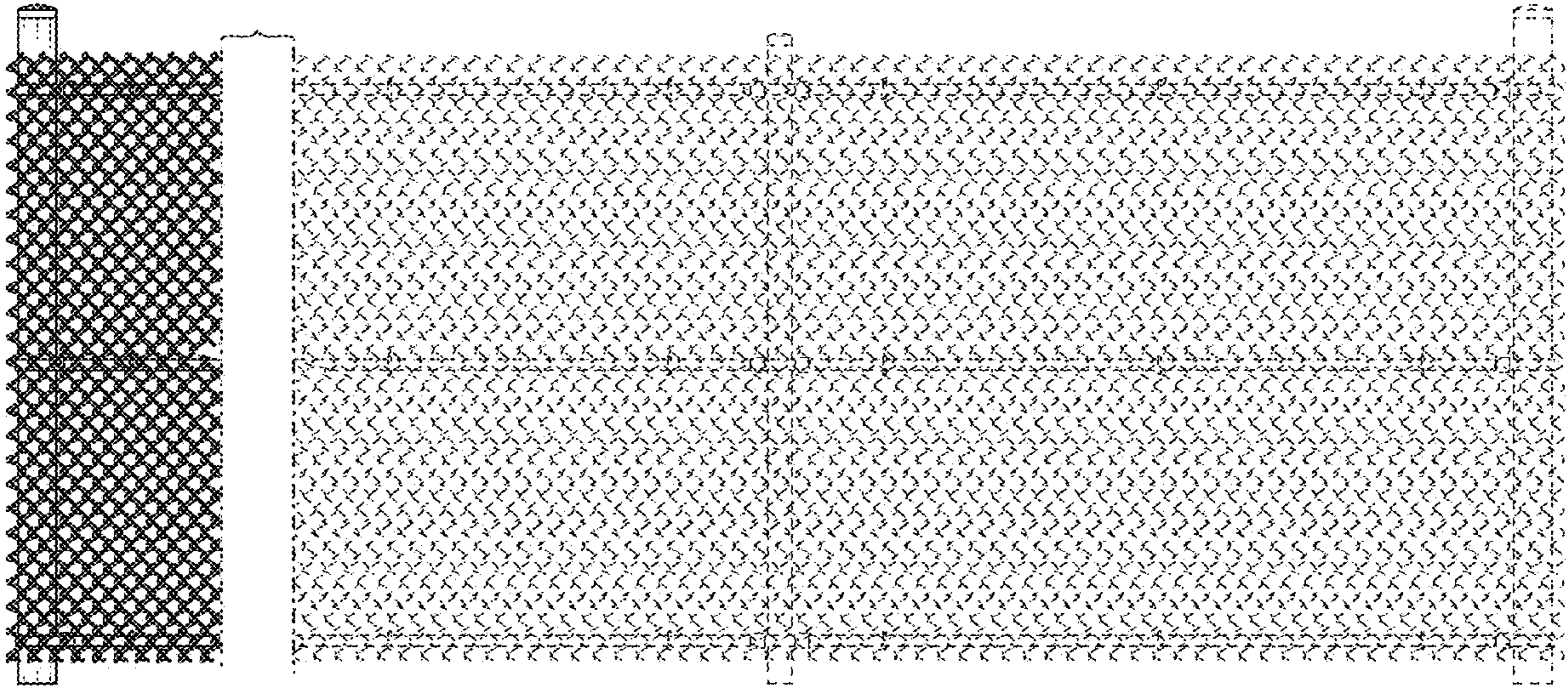

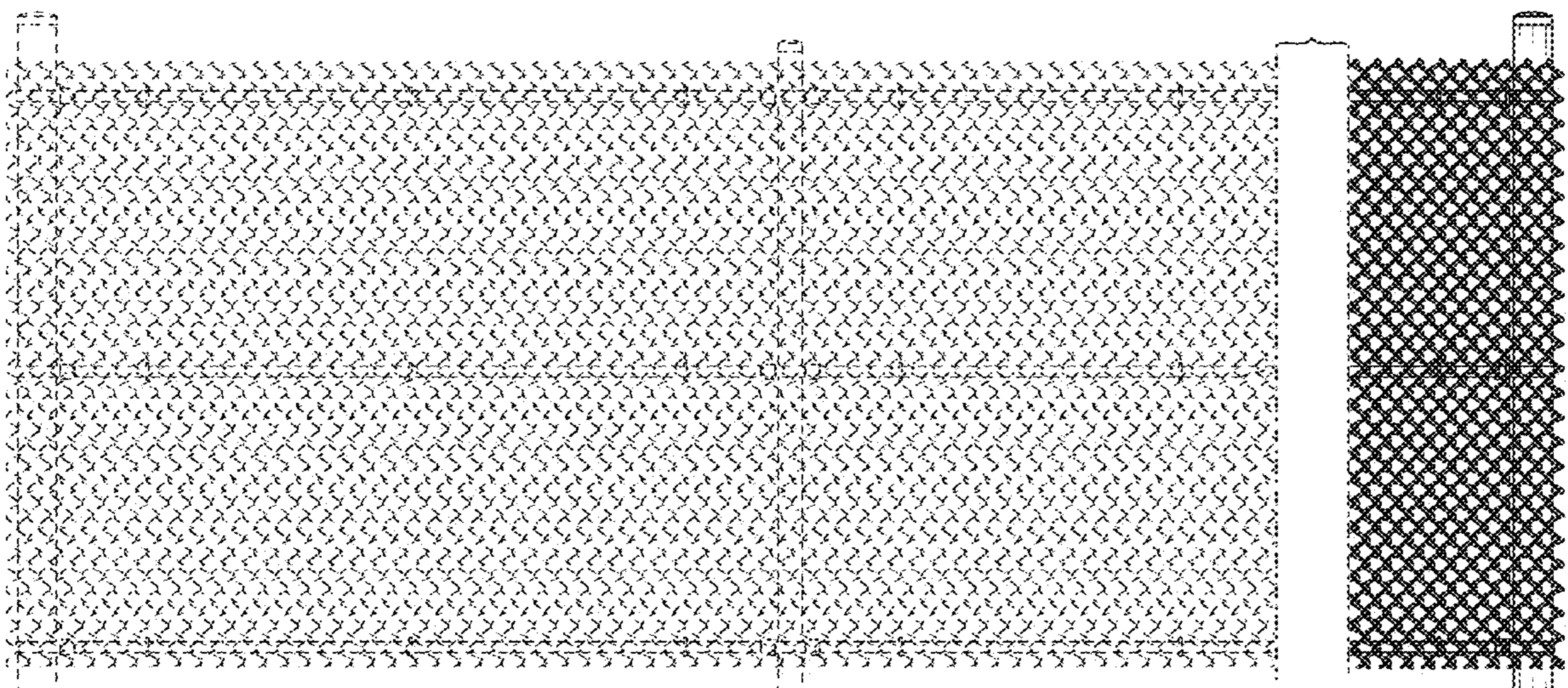

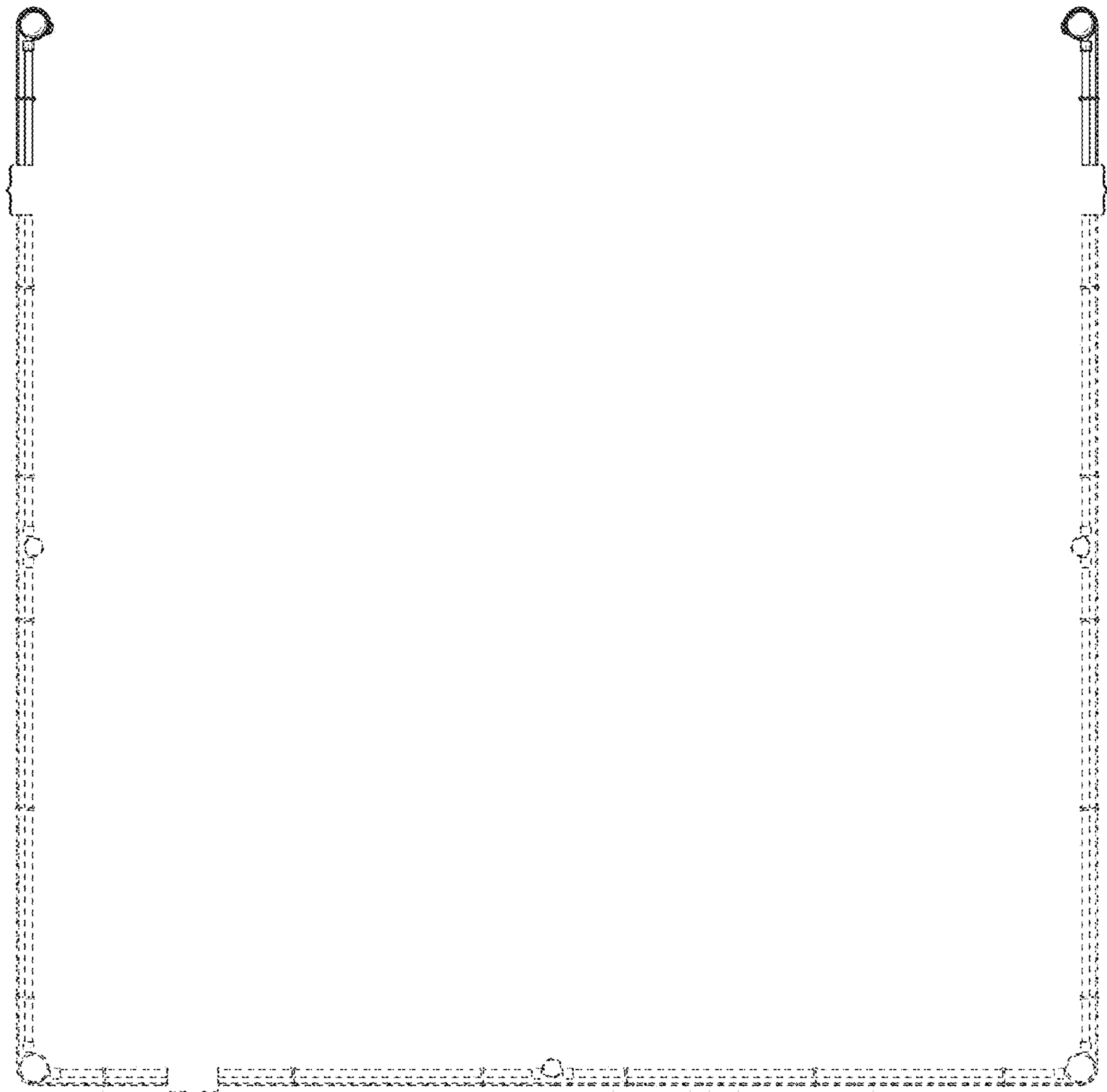

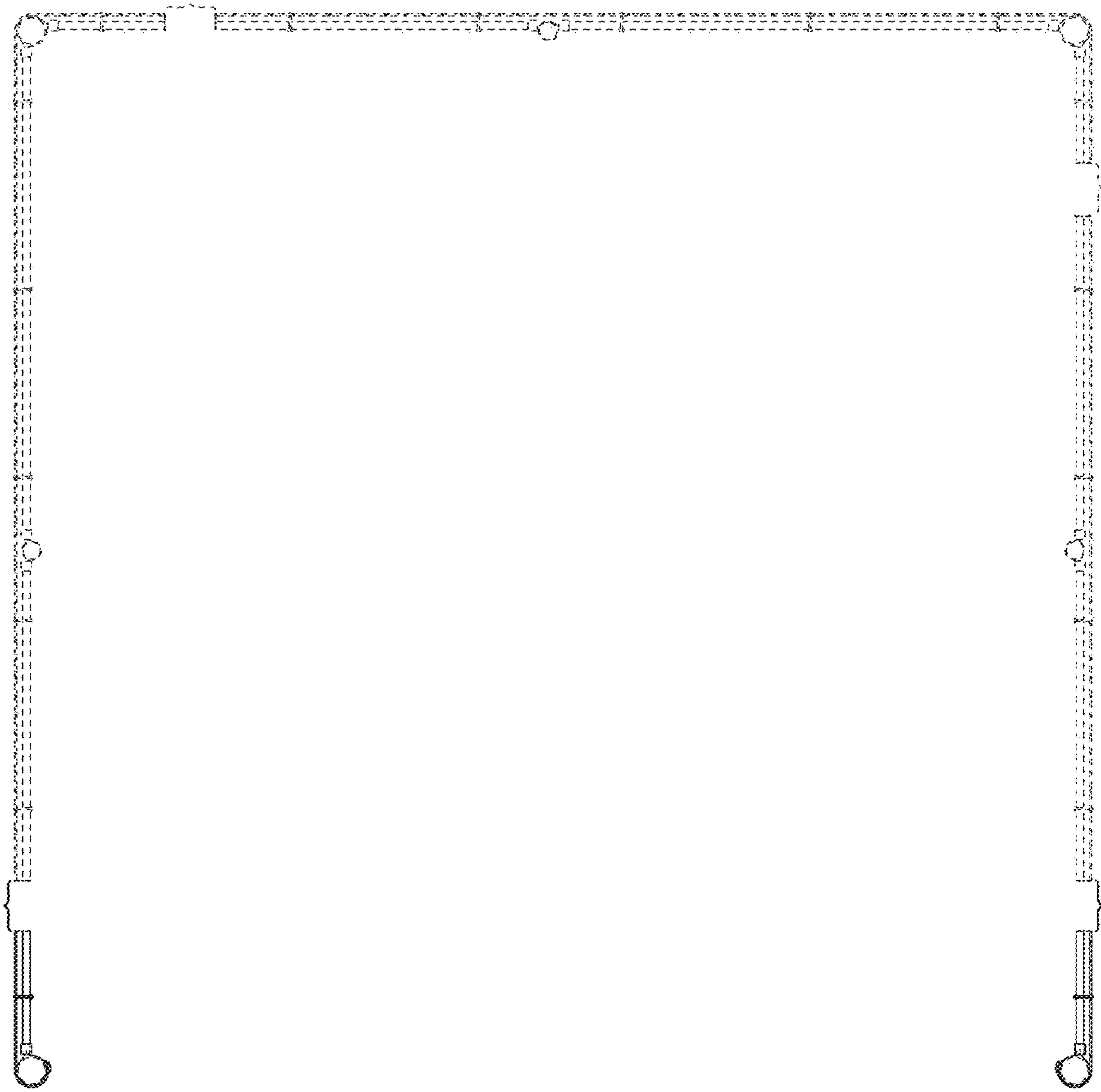

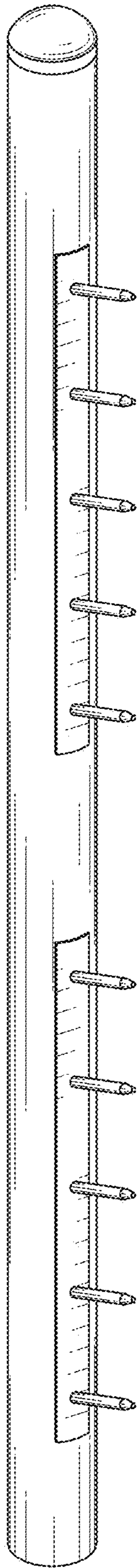

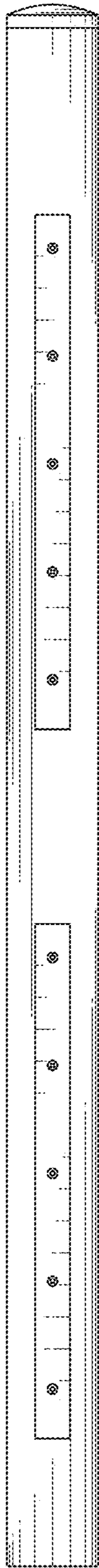

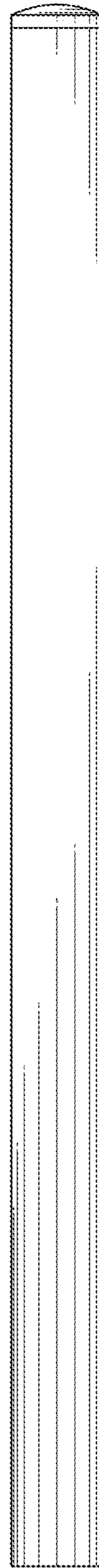

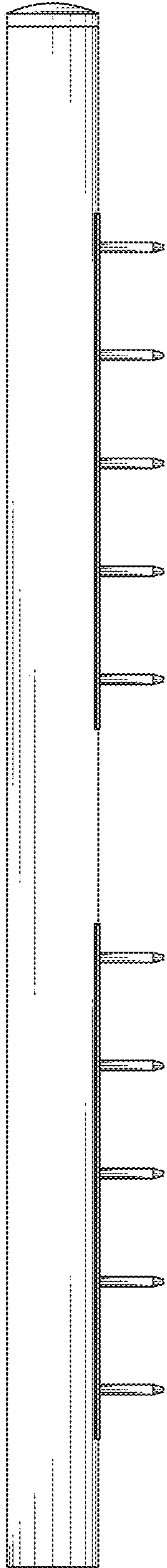

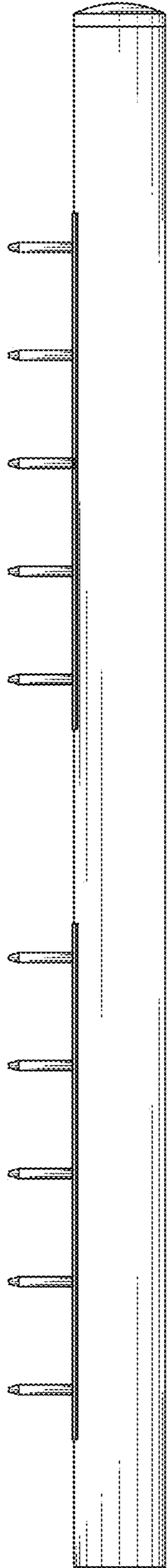

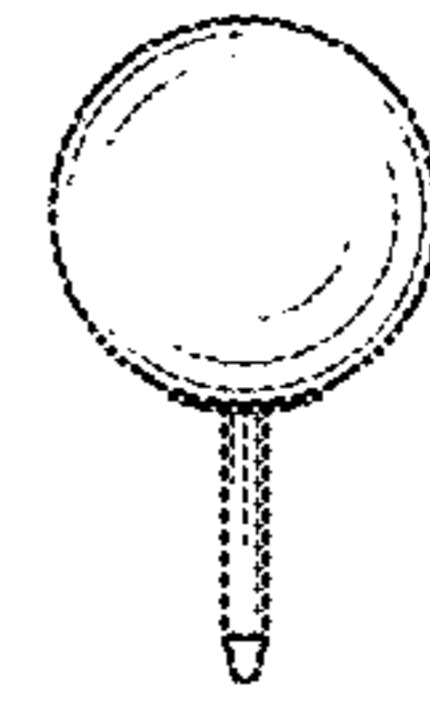

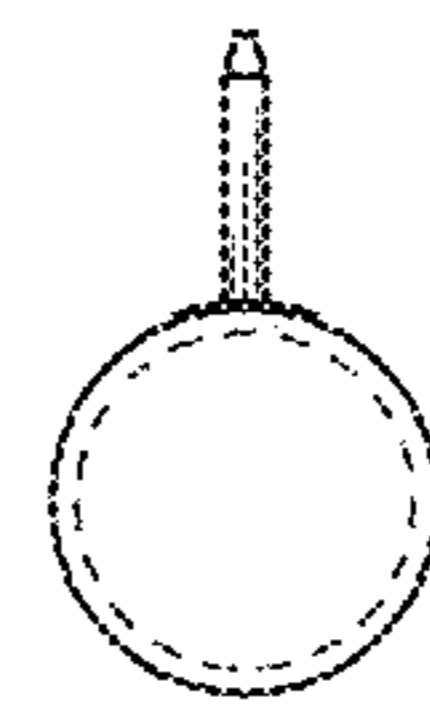

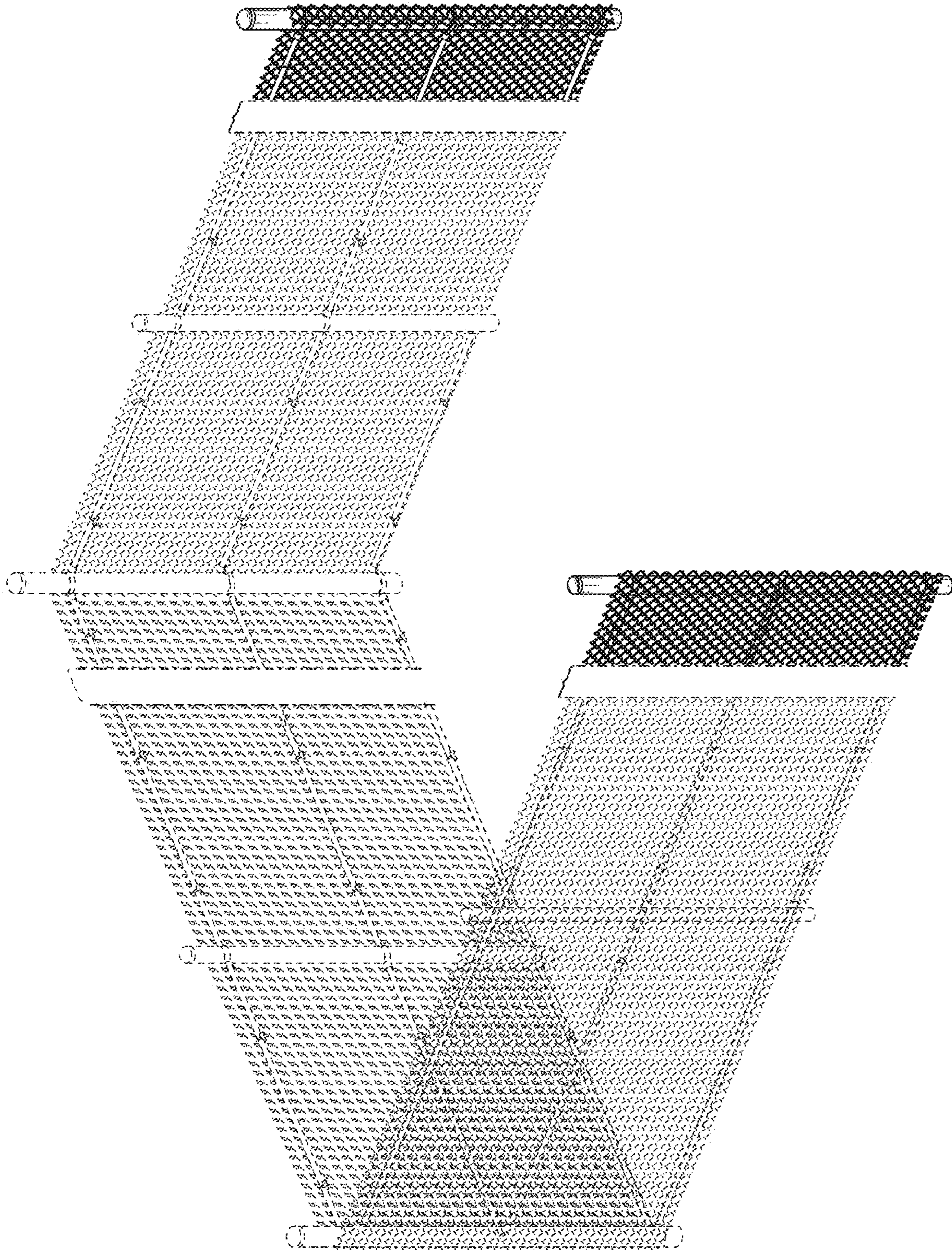
