(57) **CLAIM**

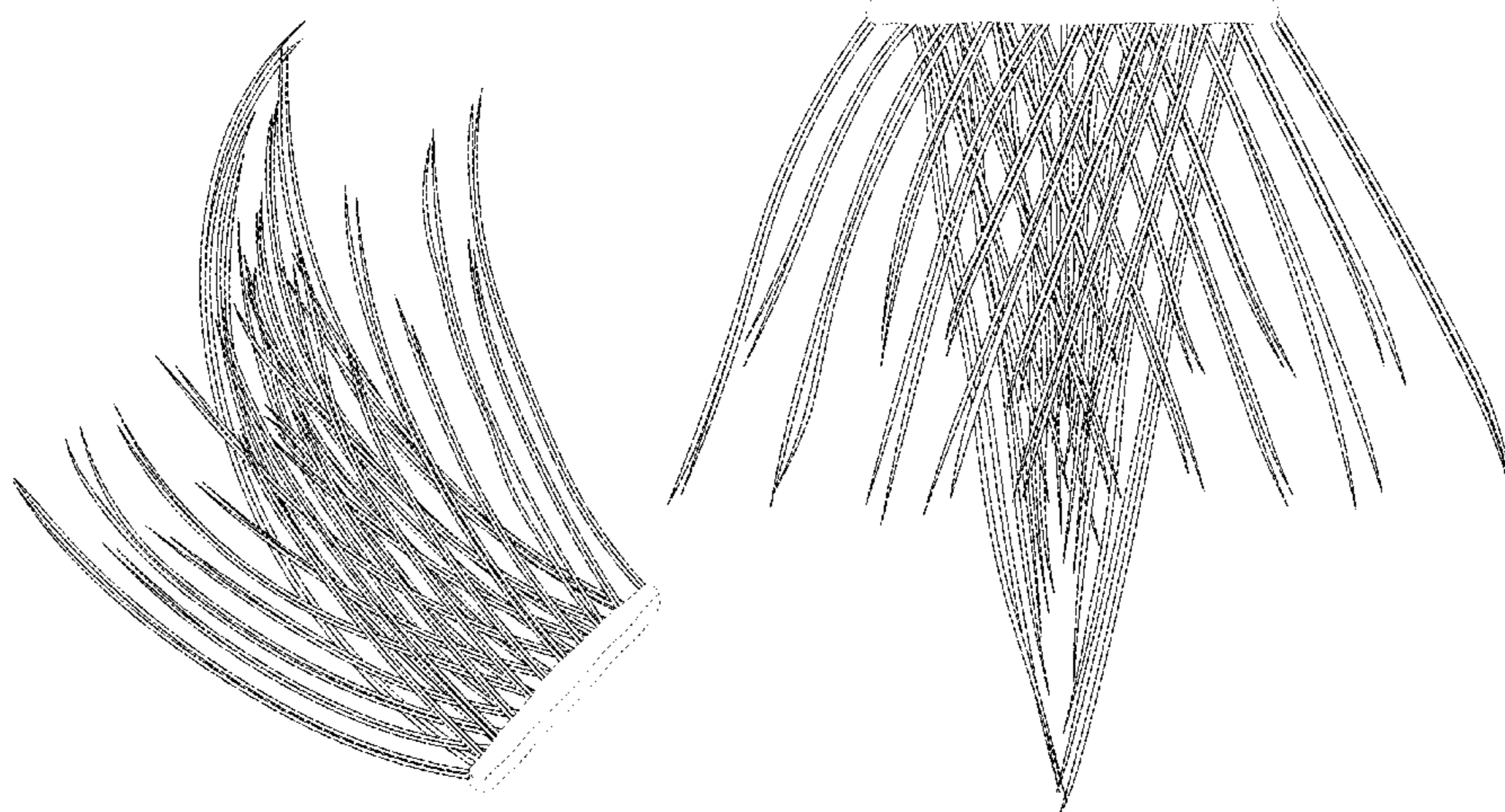
The ornamental design for an artificial lash extension, as shown and described.

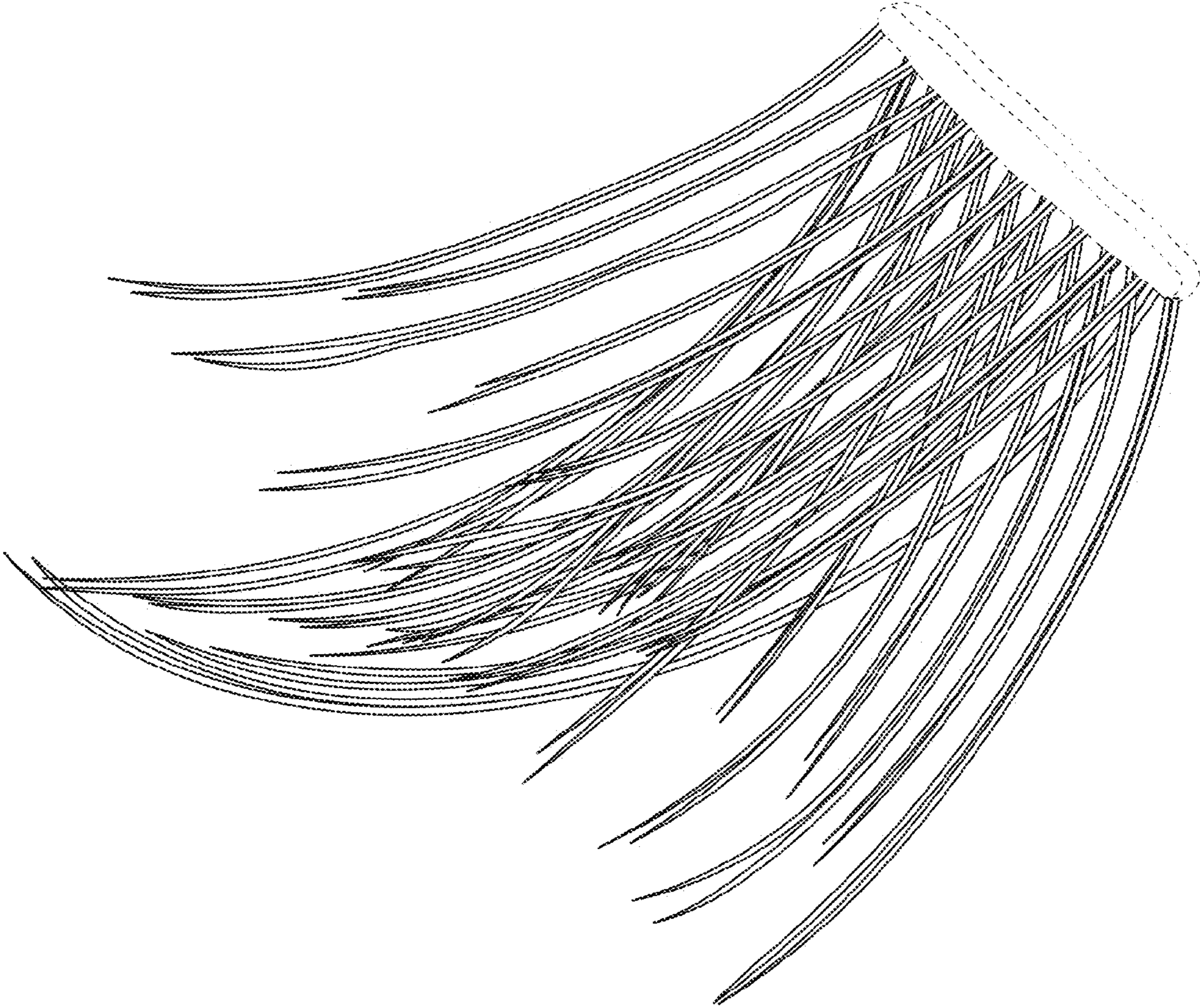

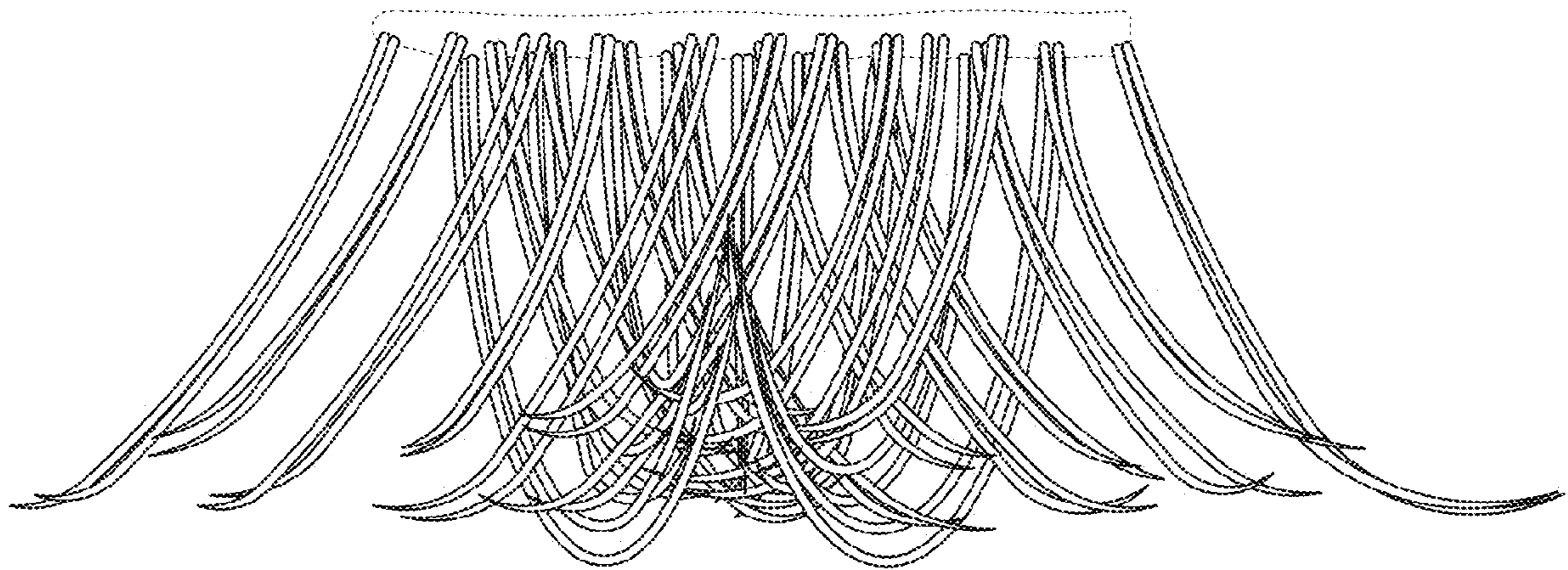

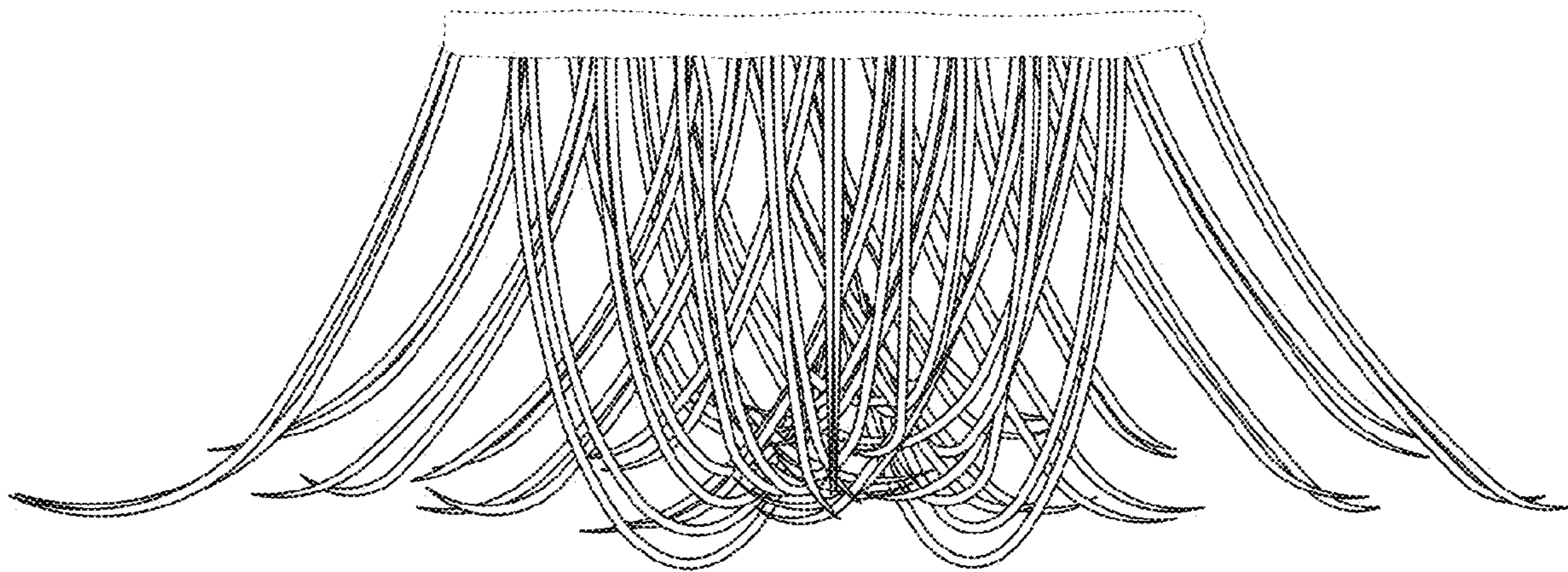

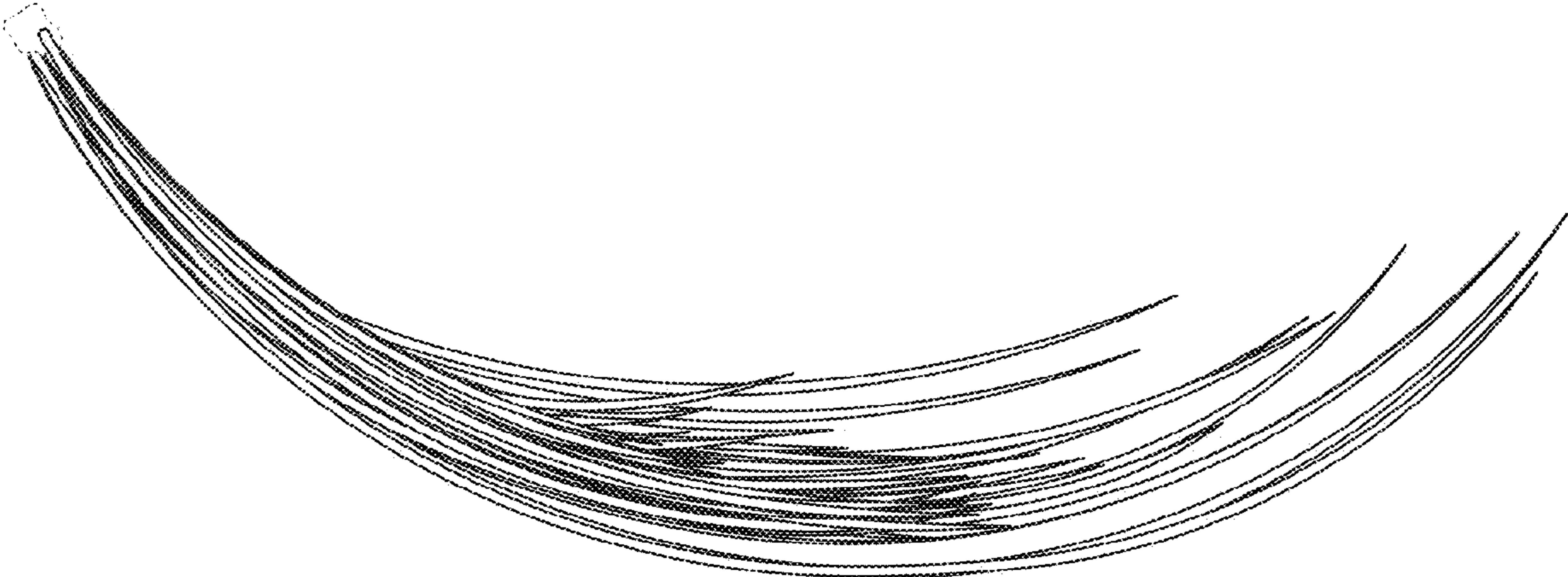

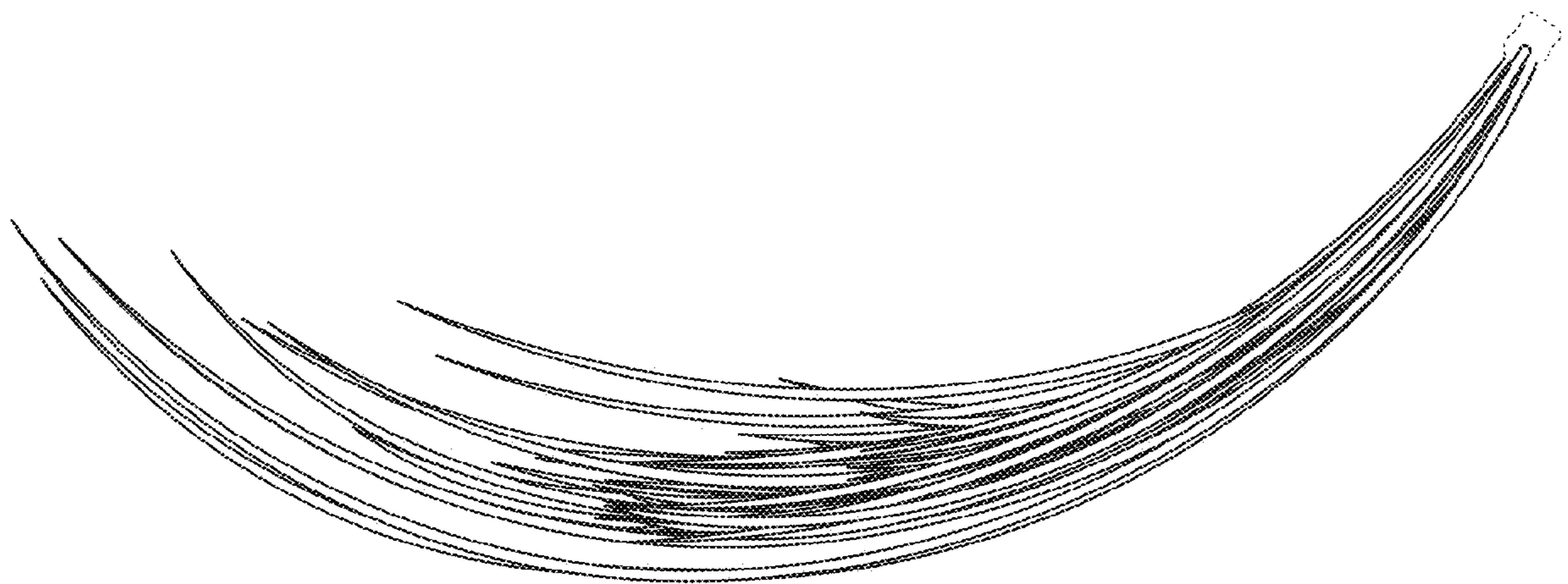

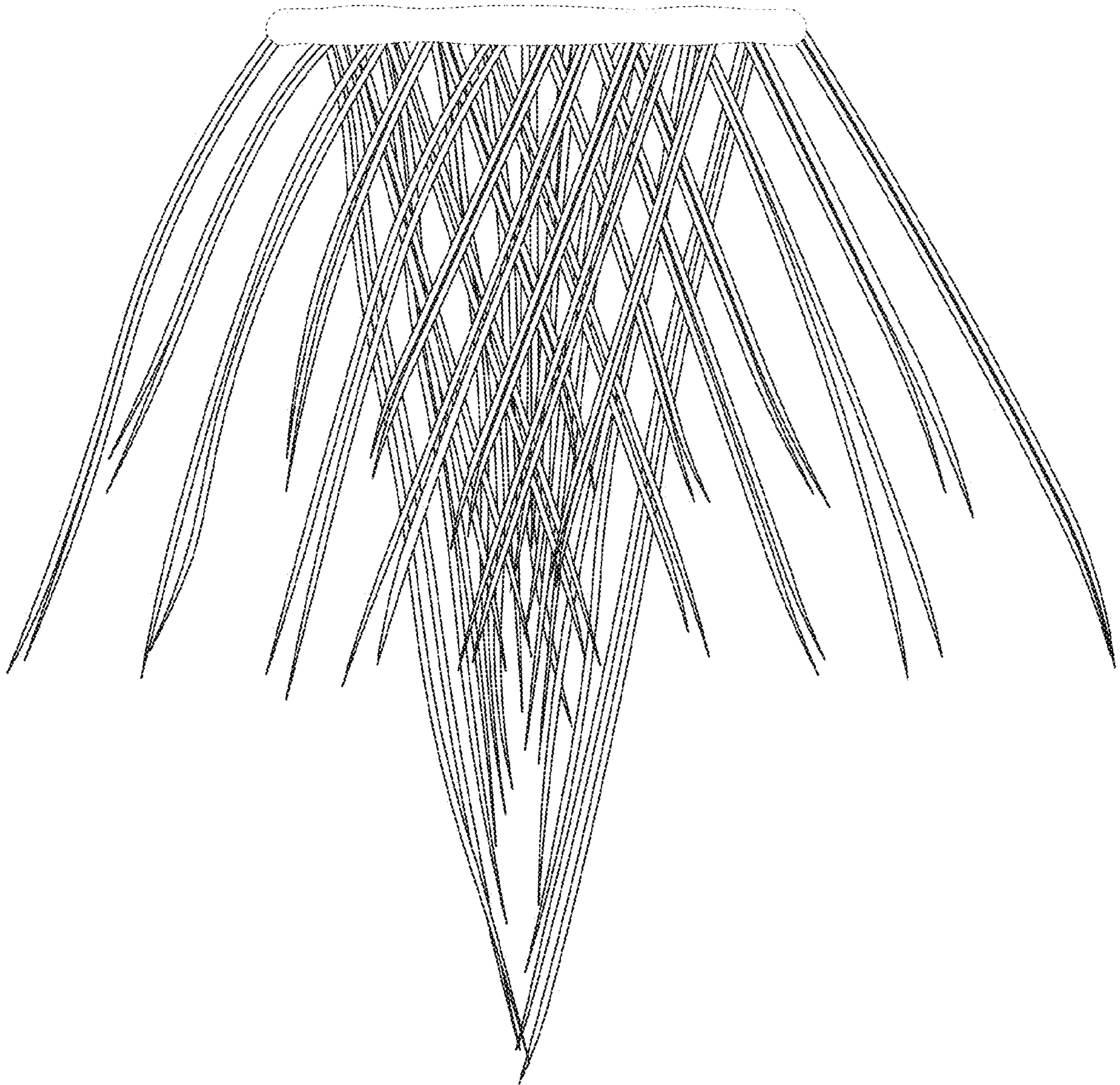

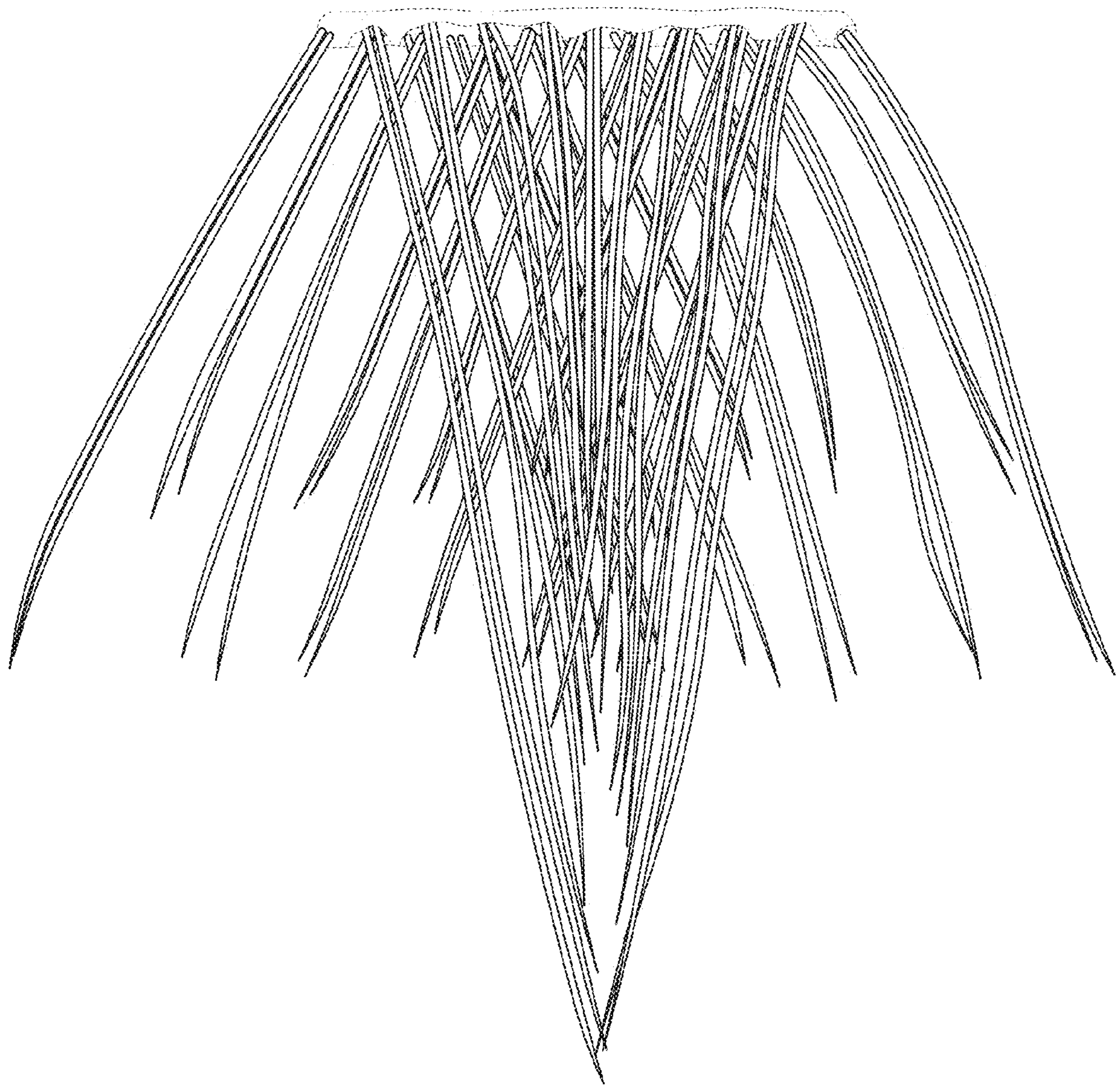

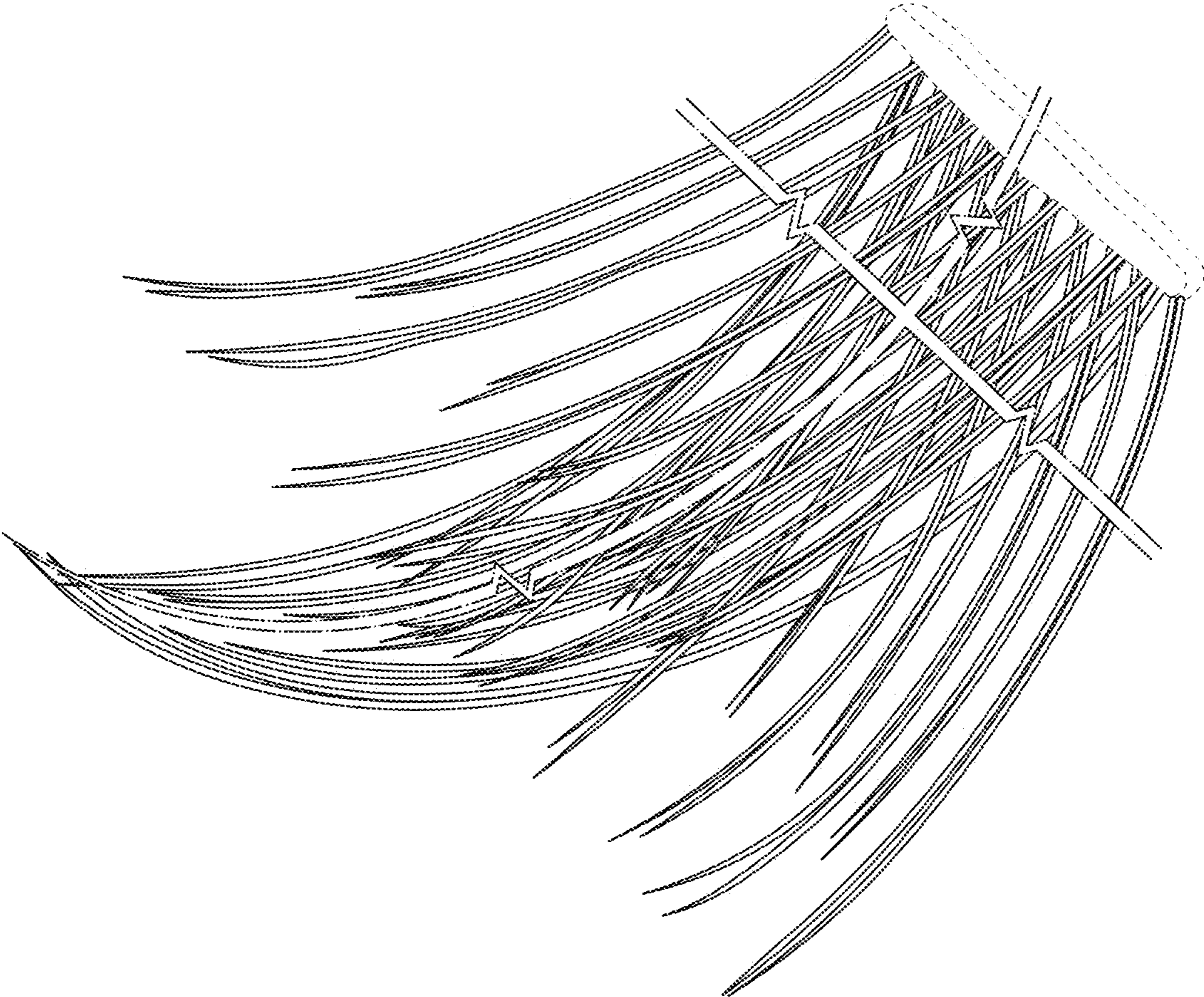

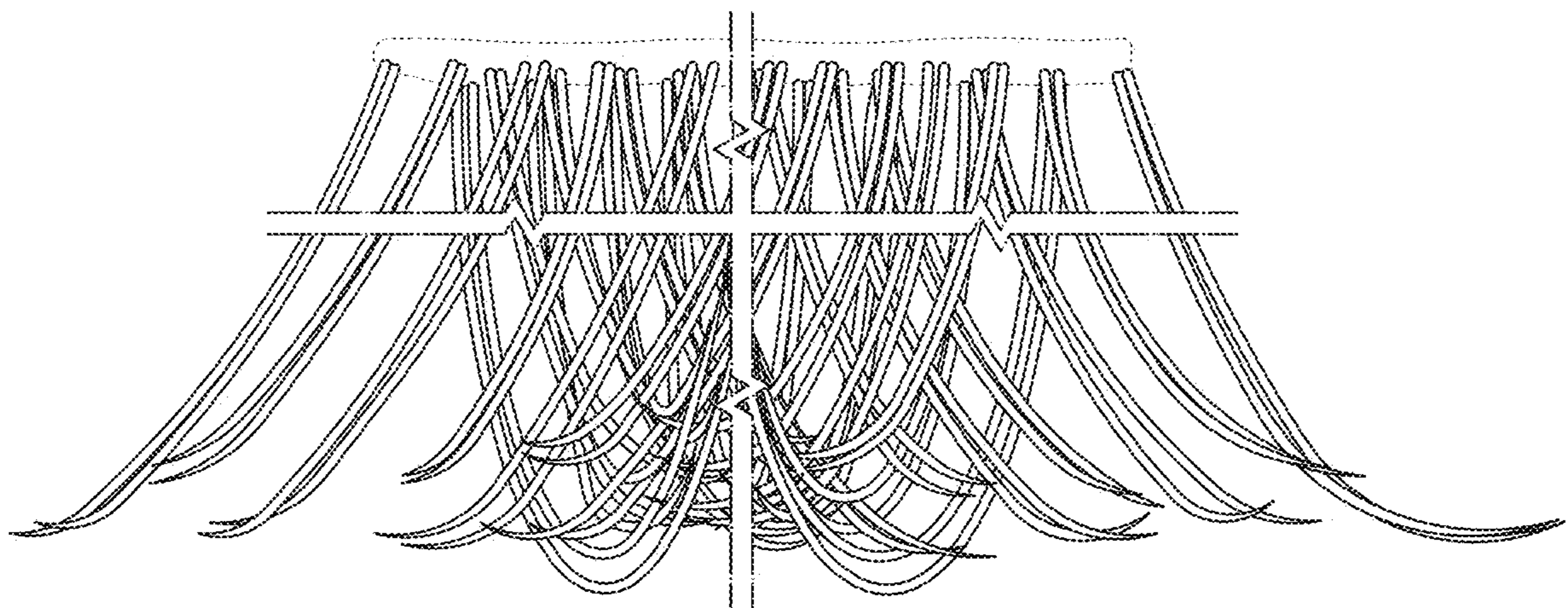

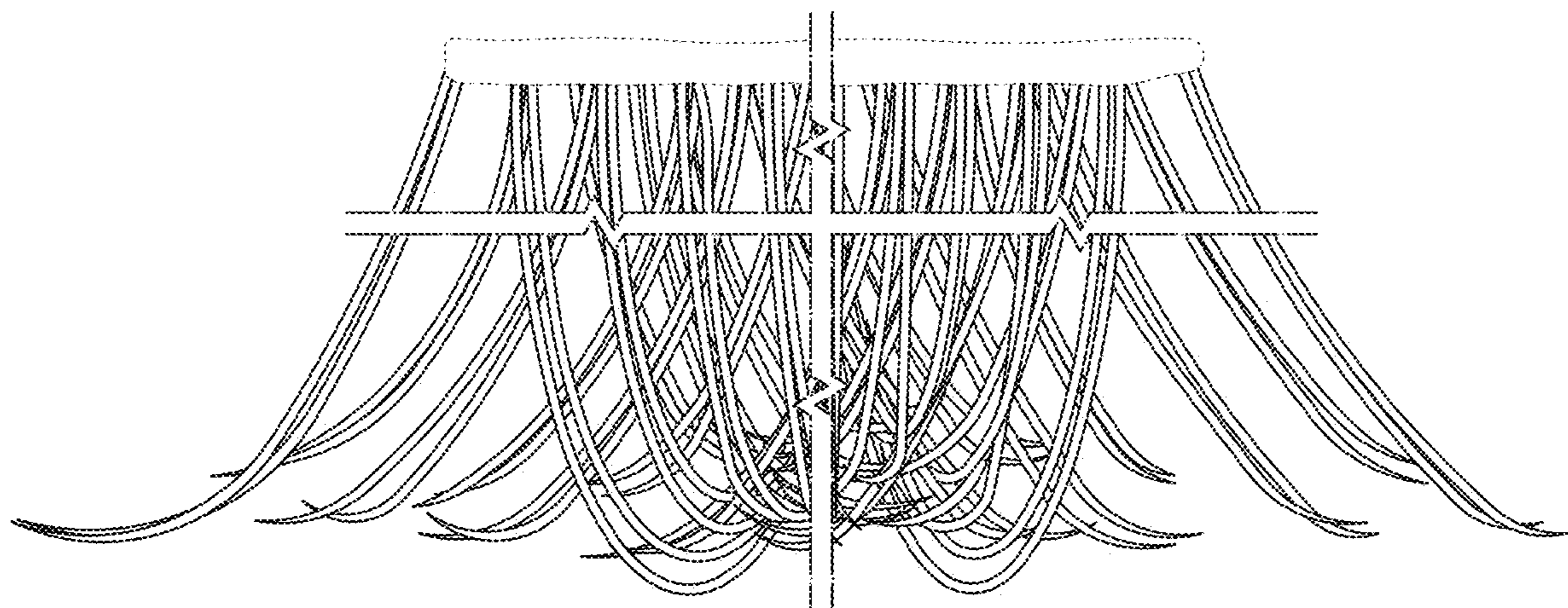

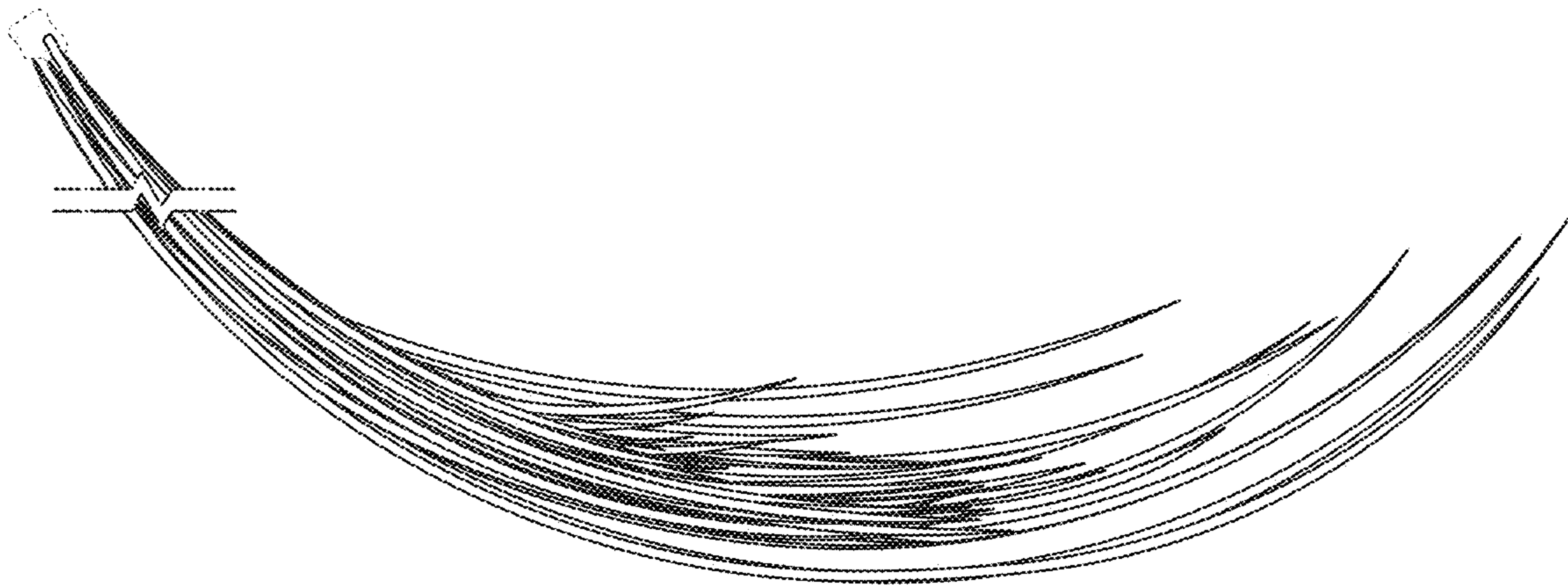

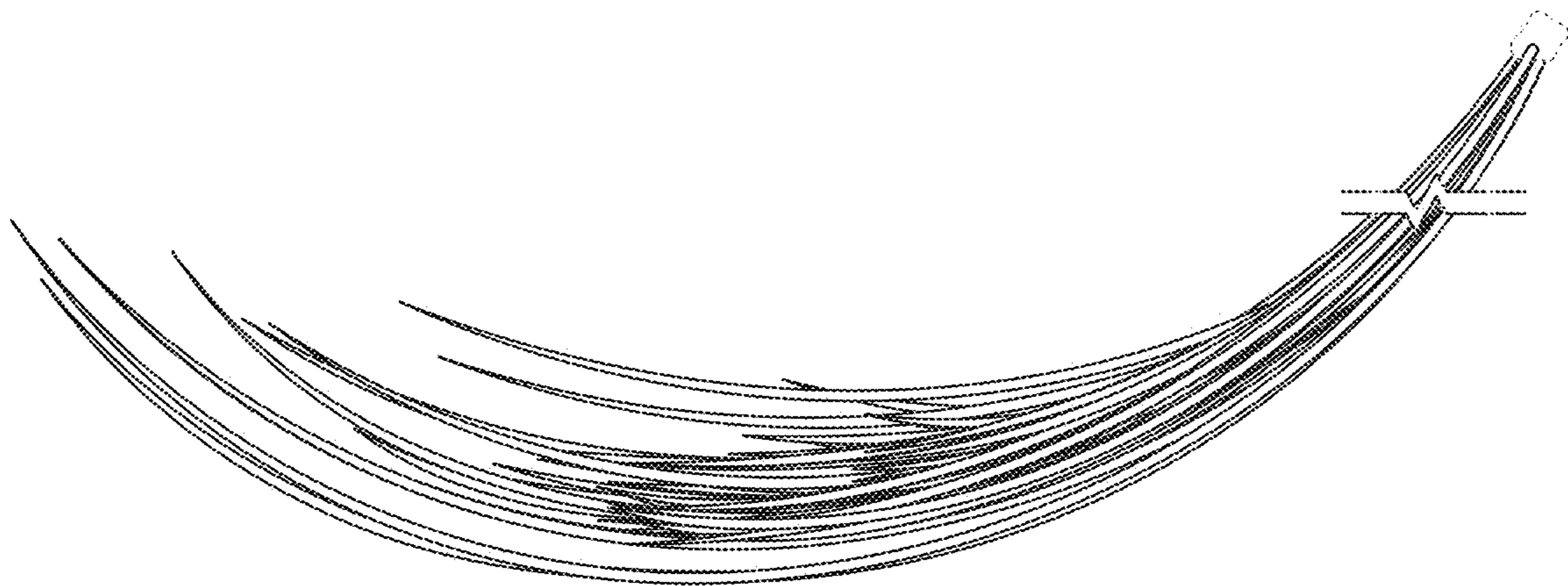

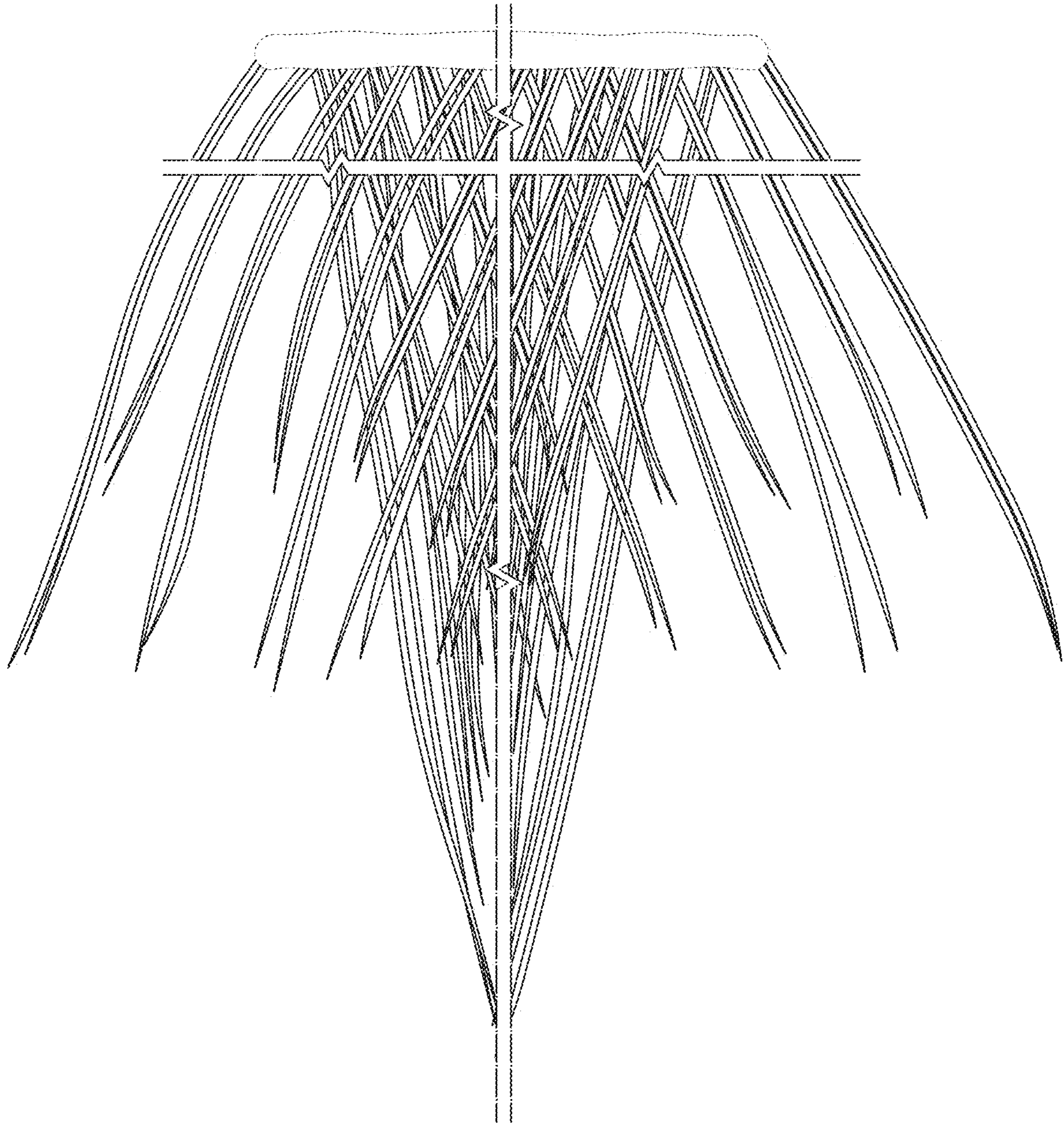

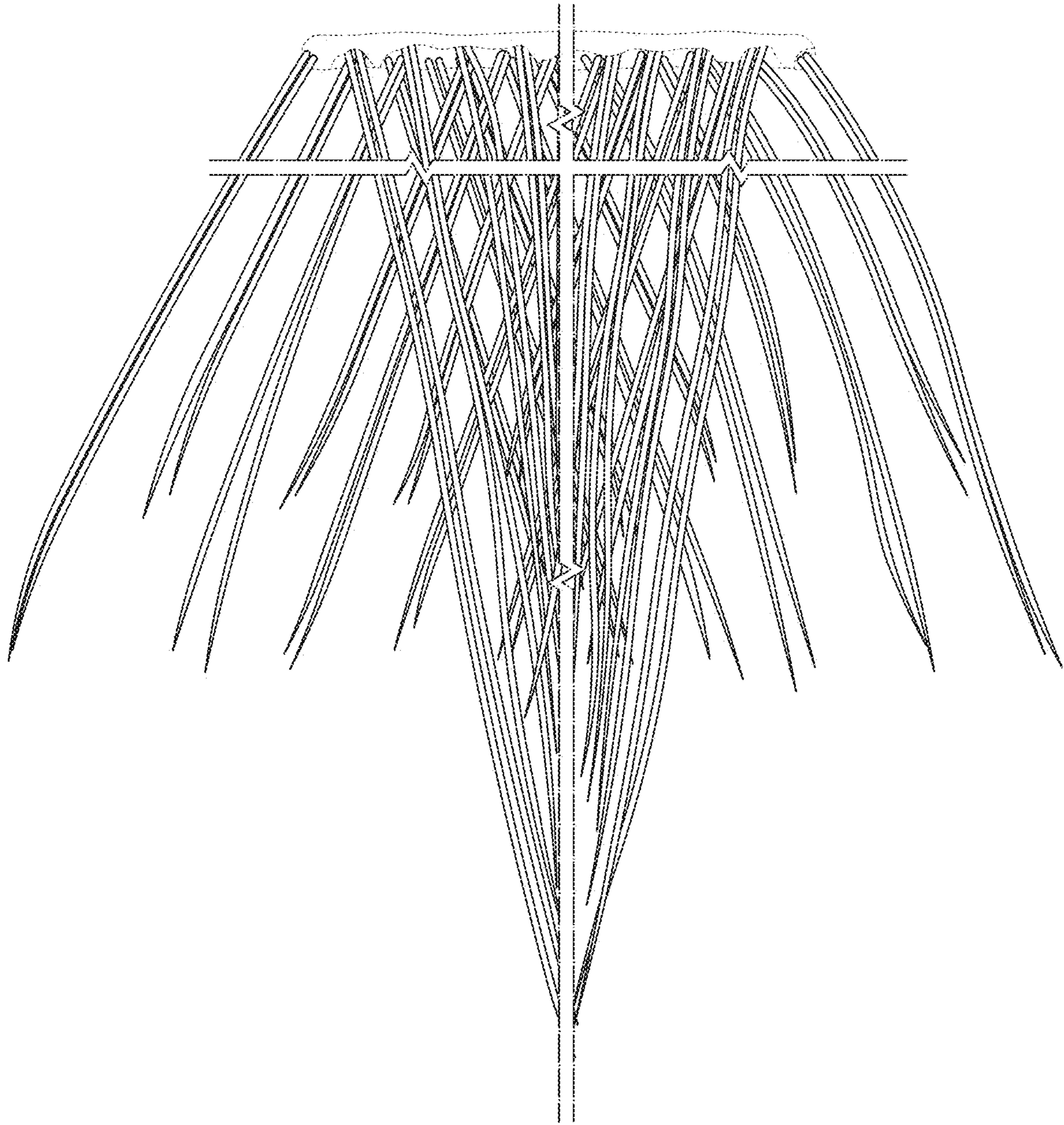

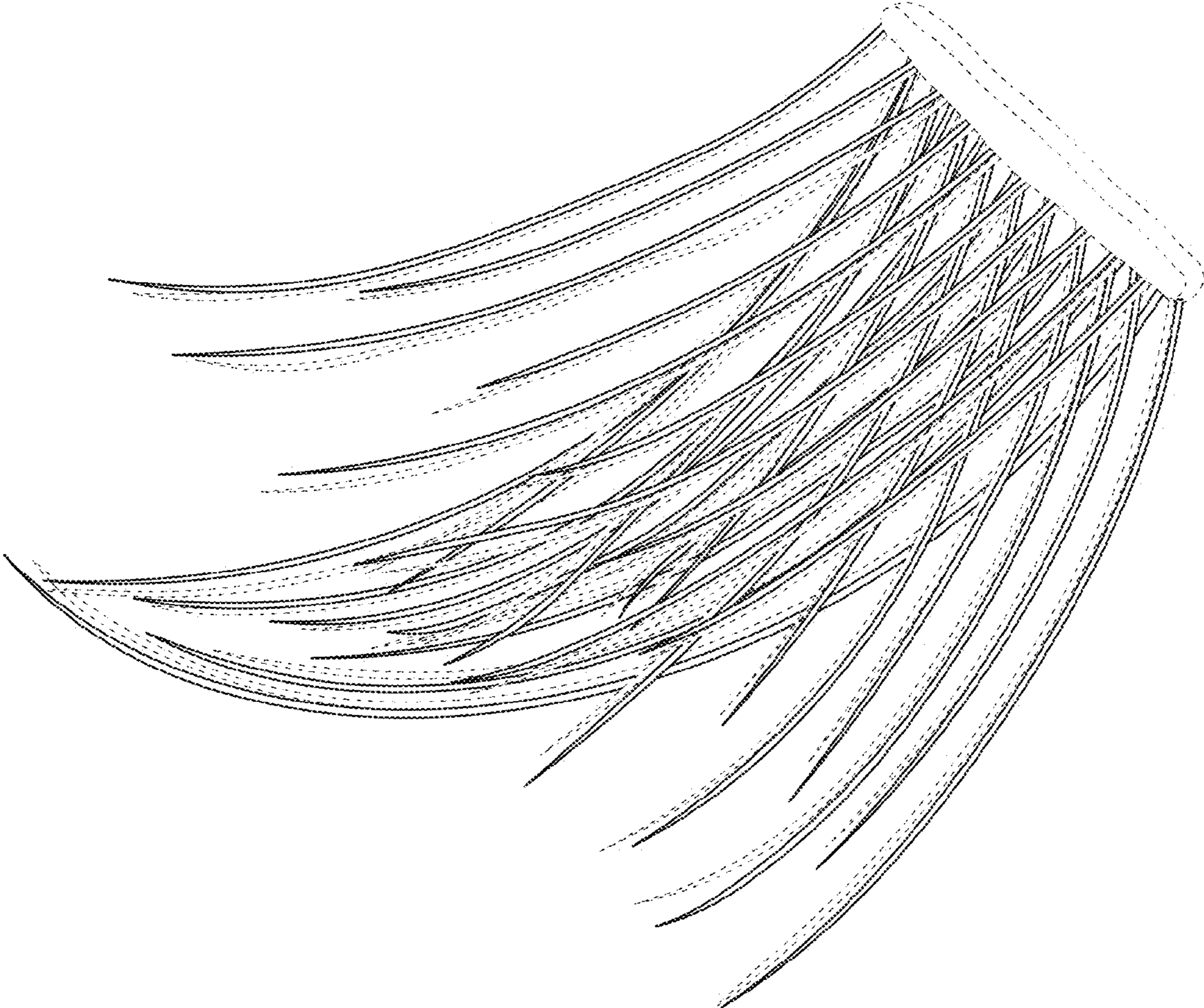

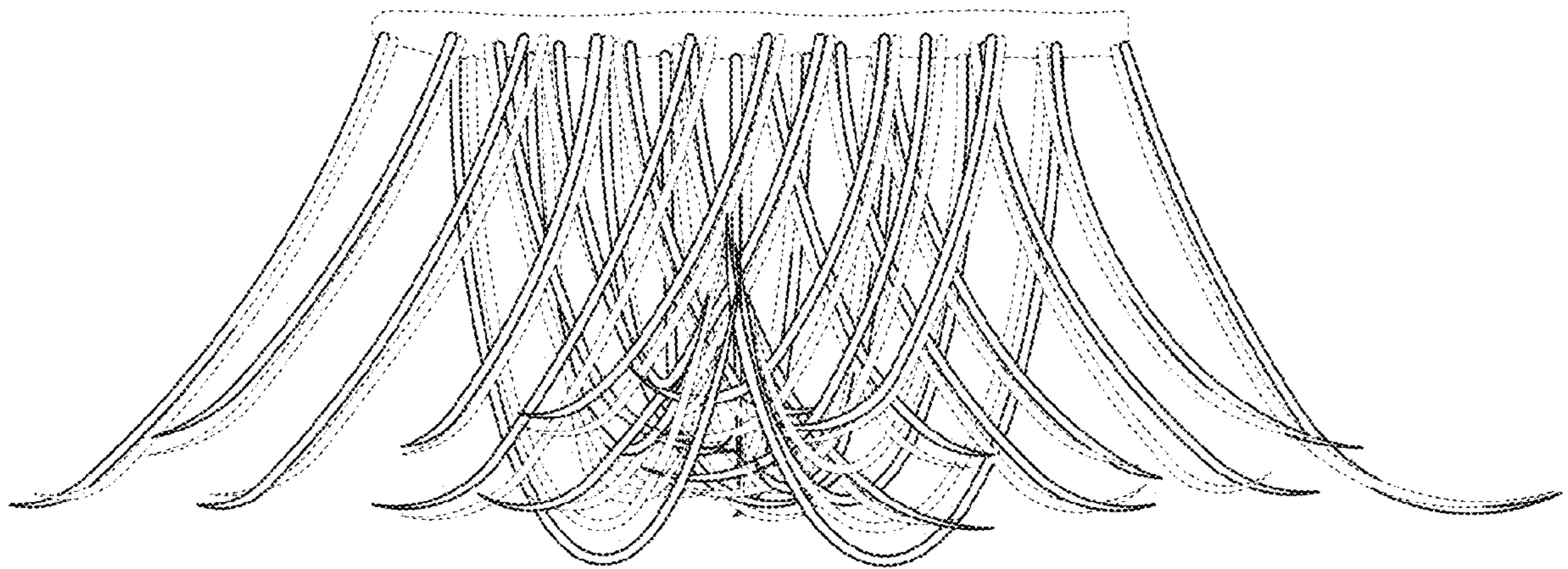

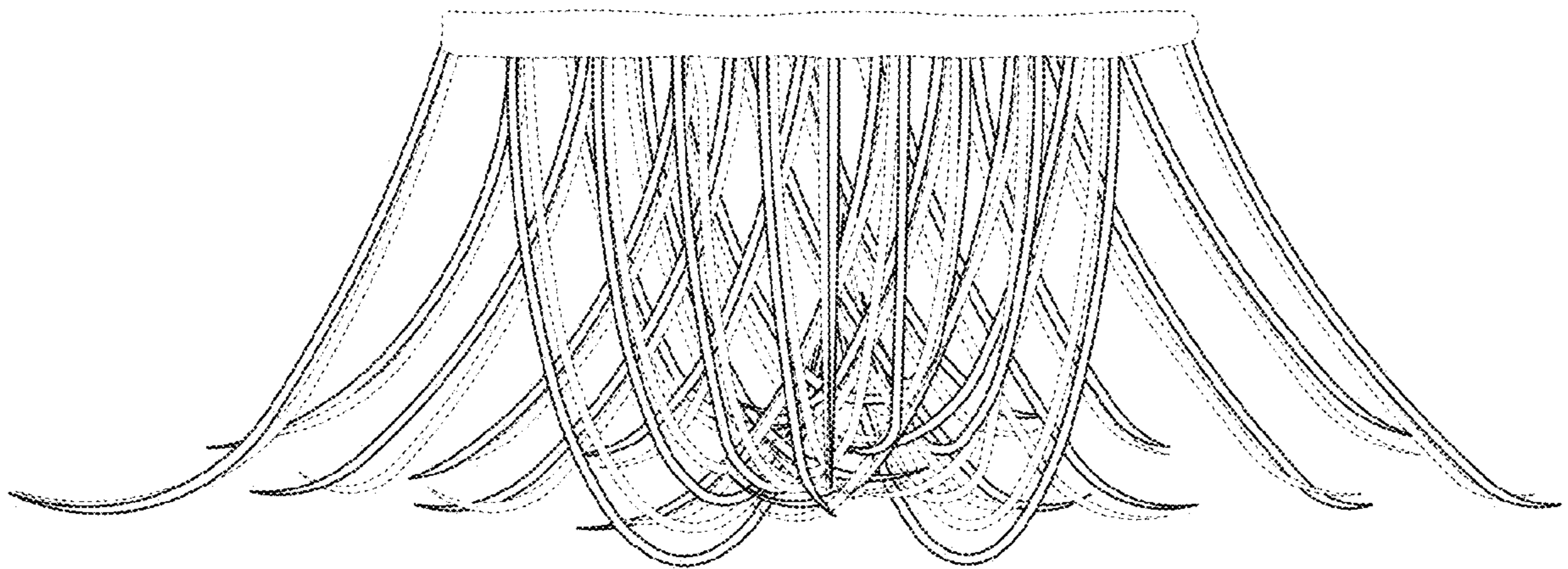

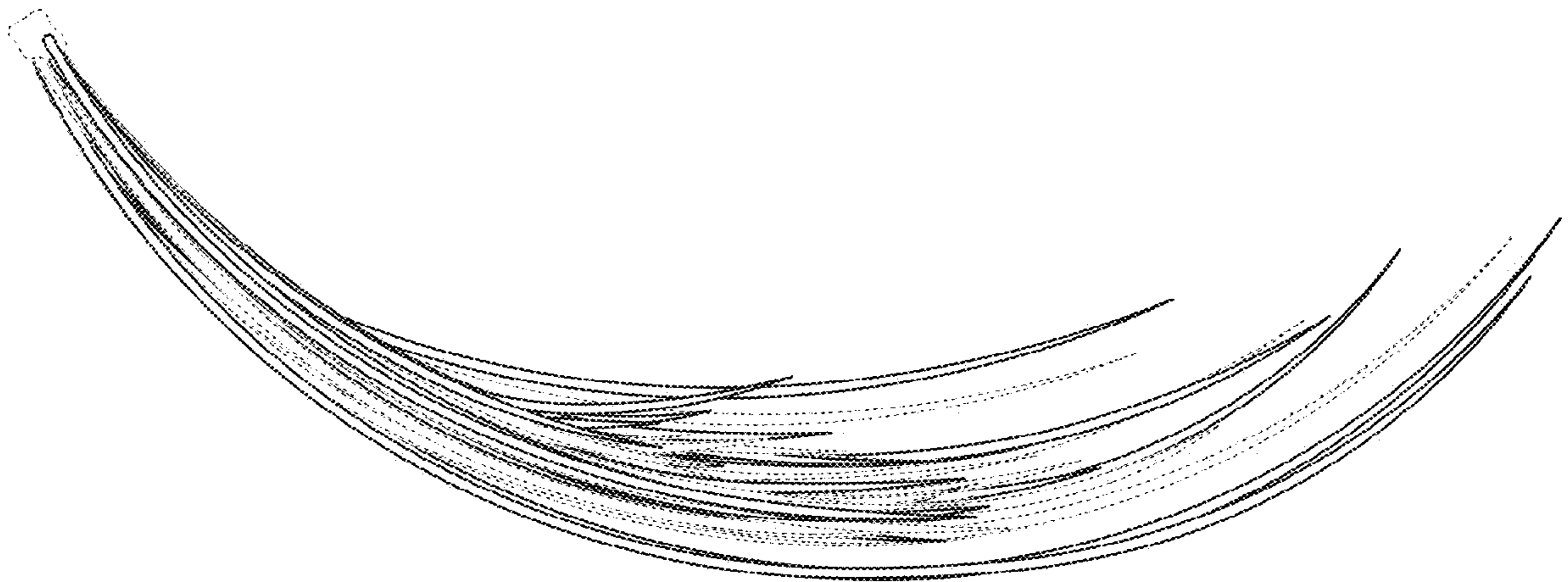

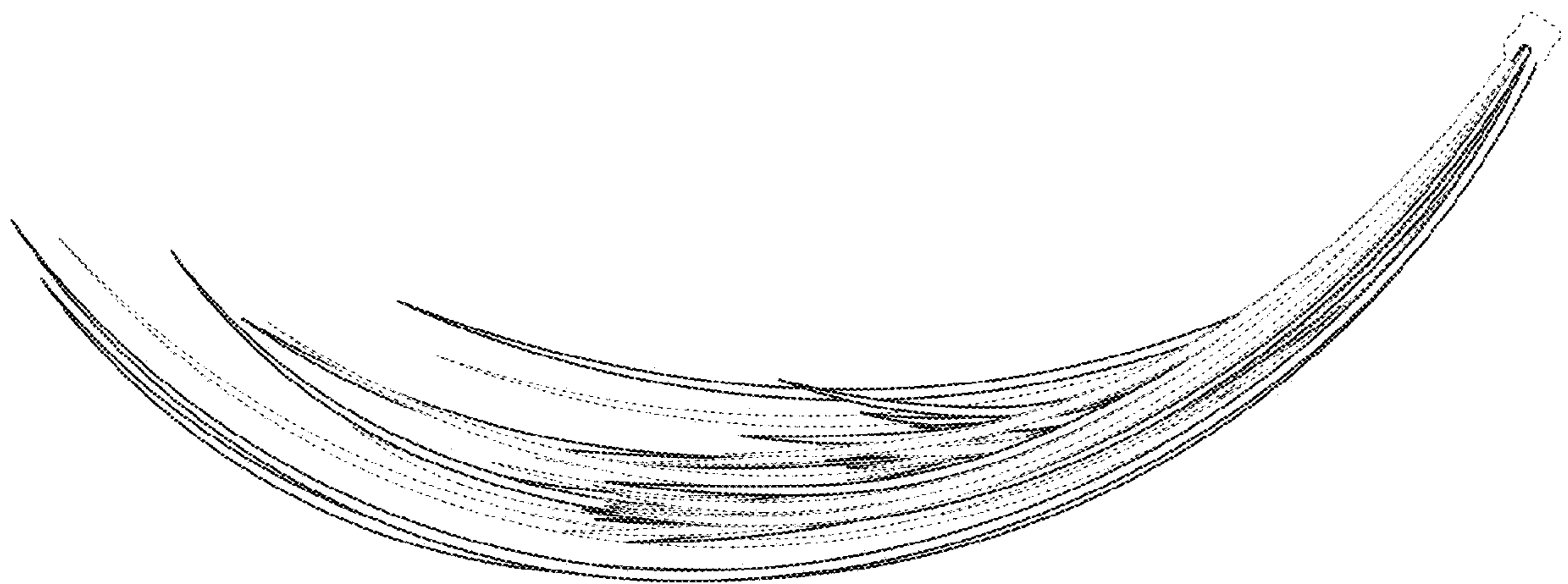

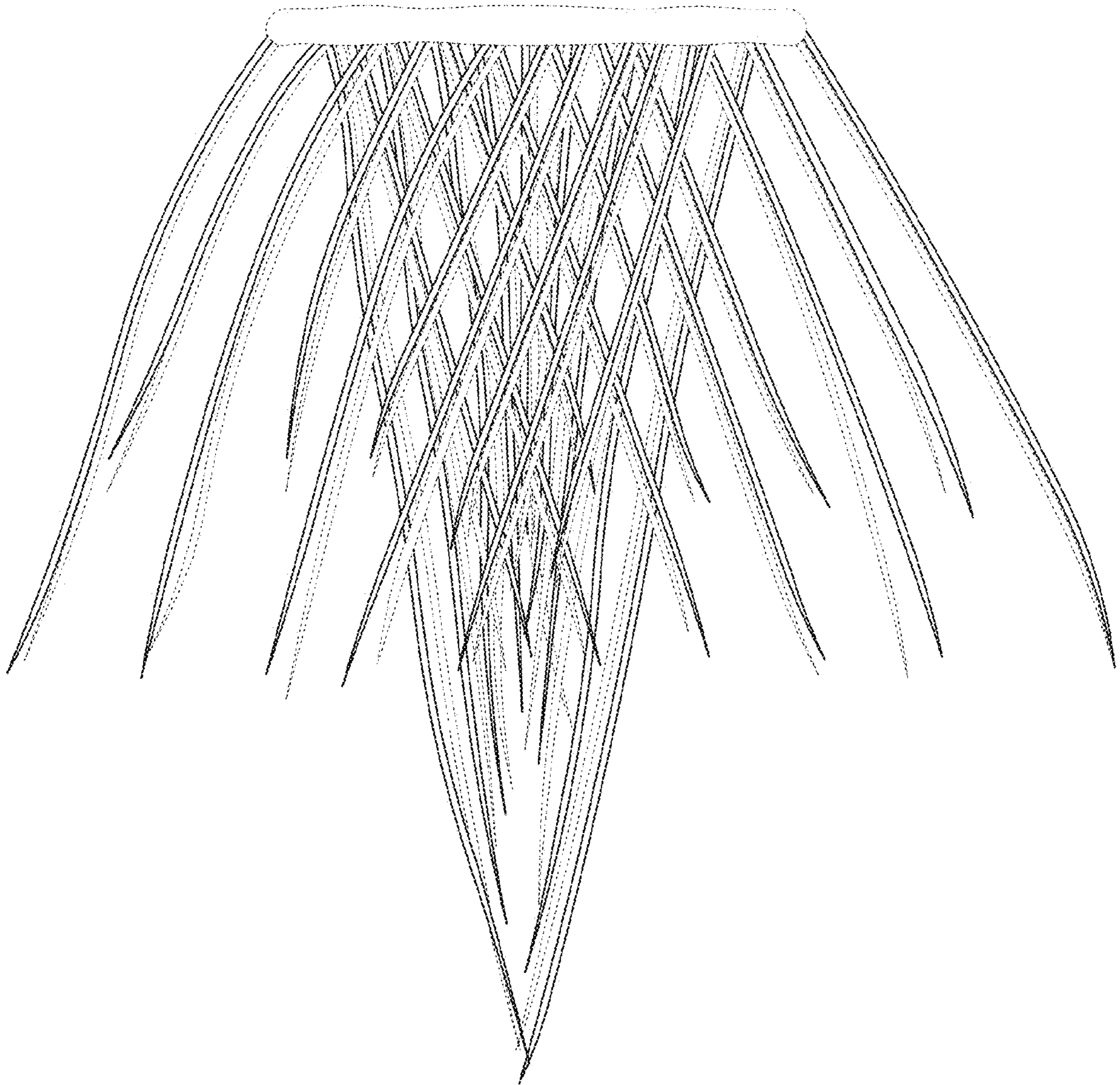

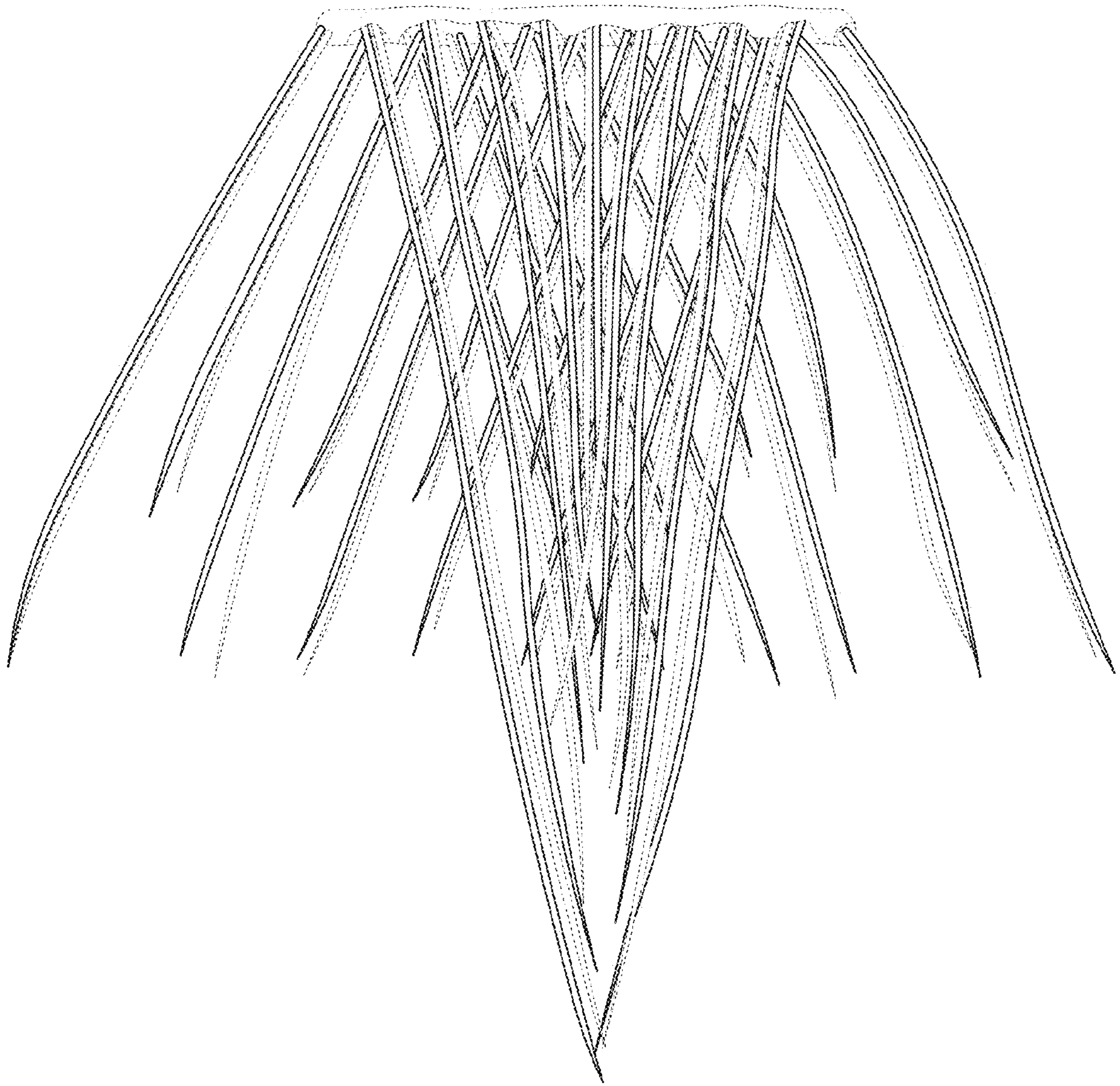

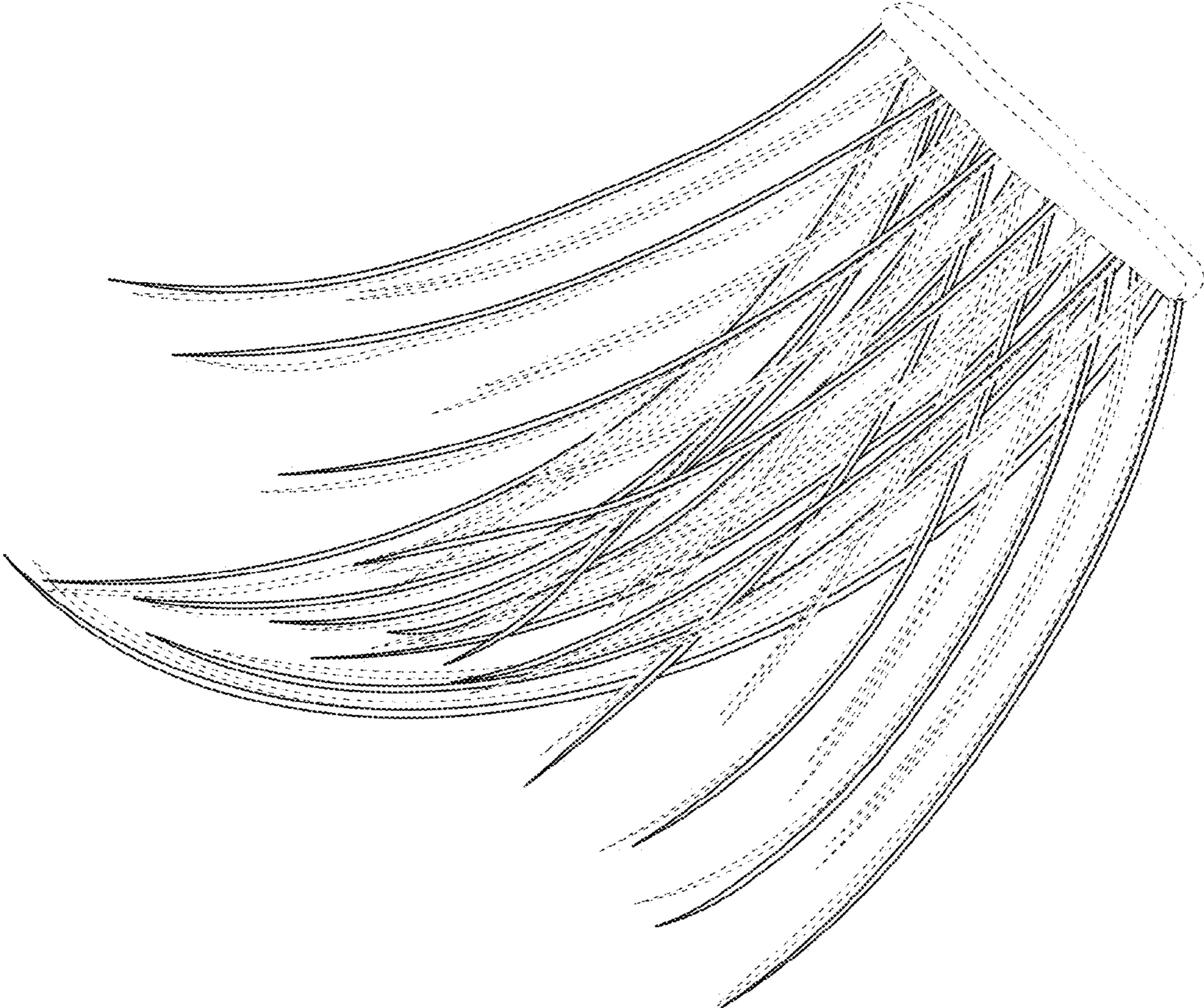

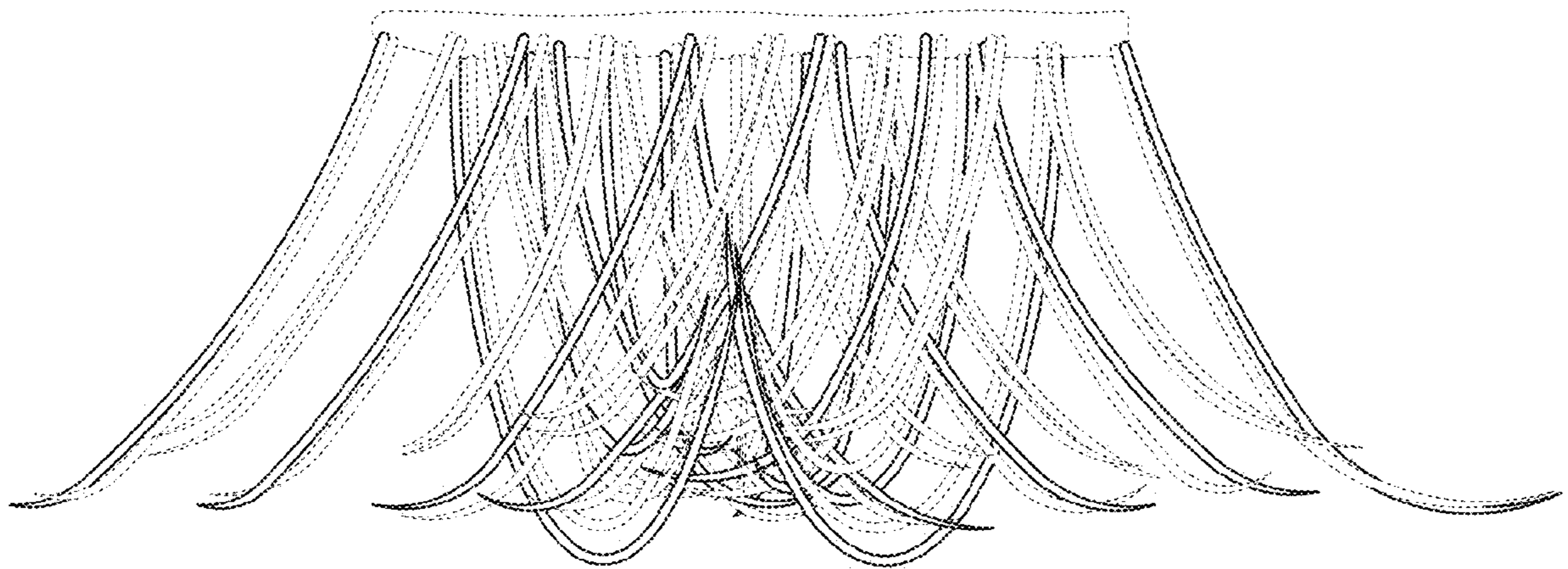

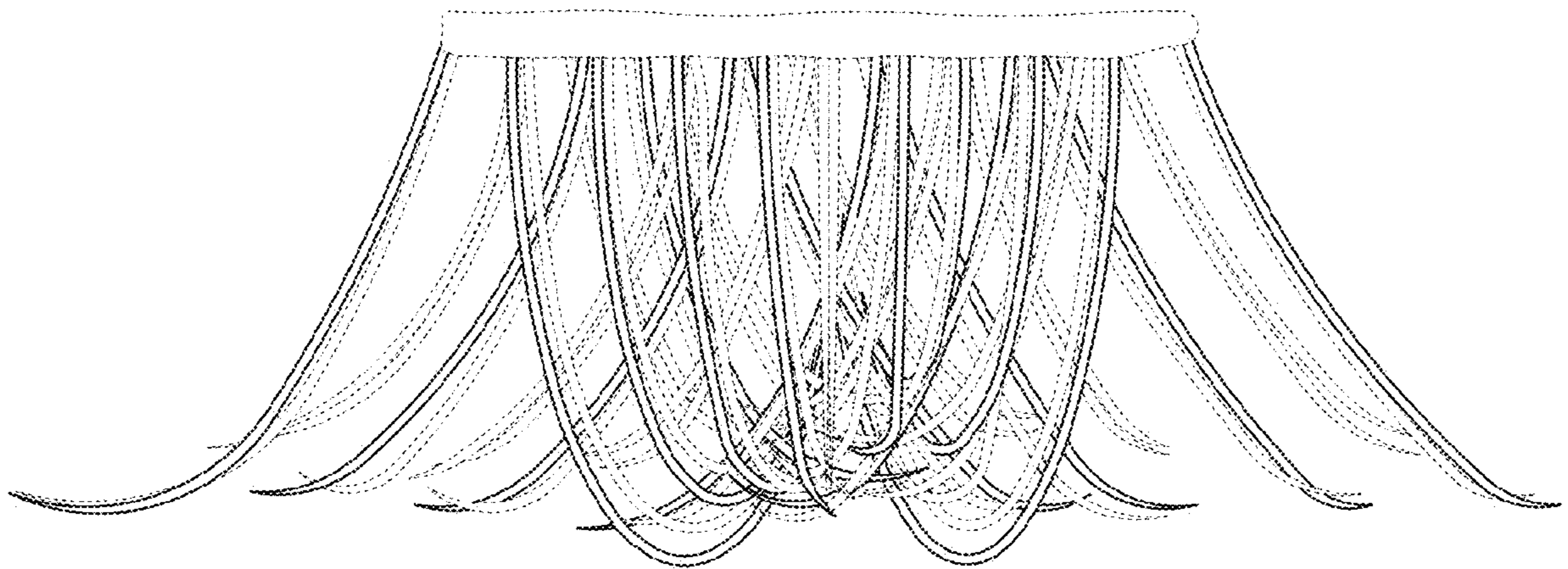

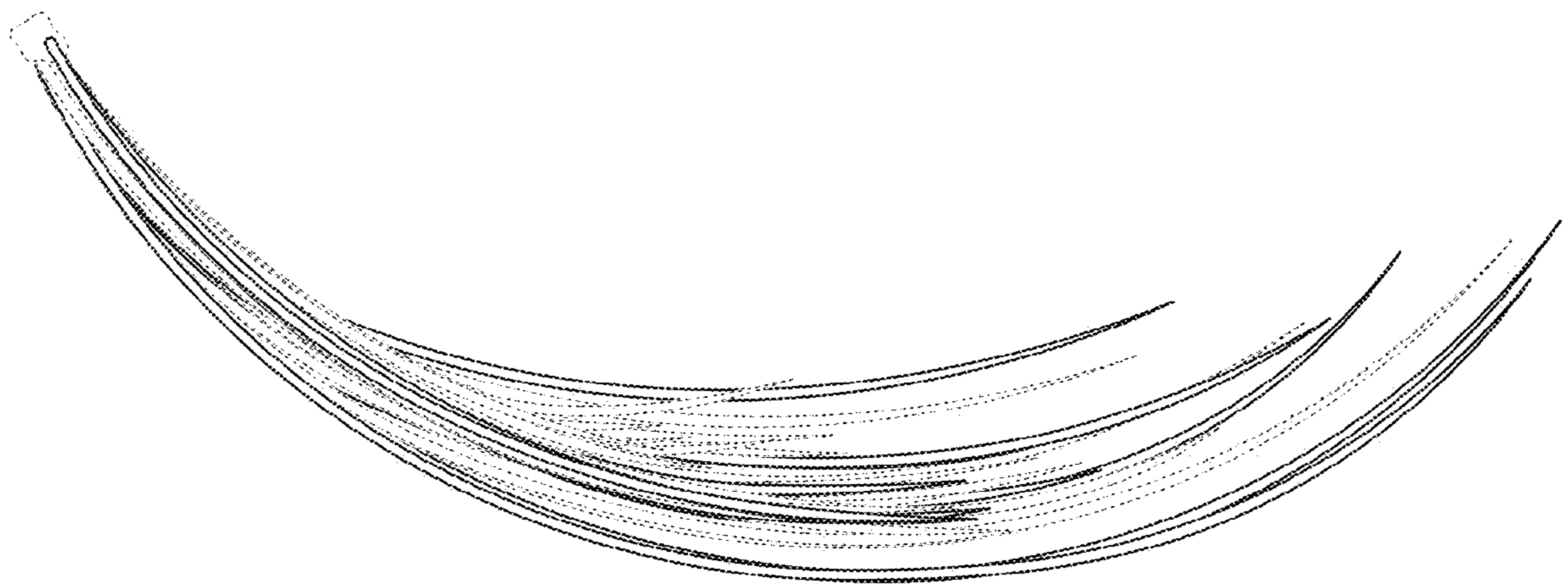

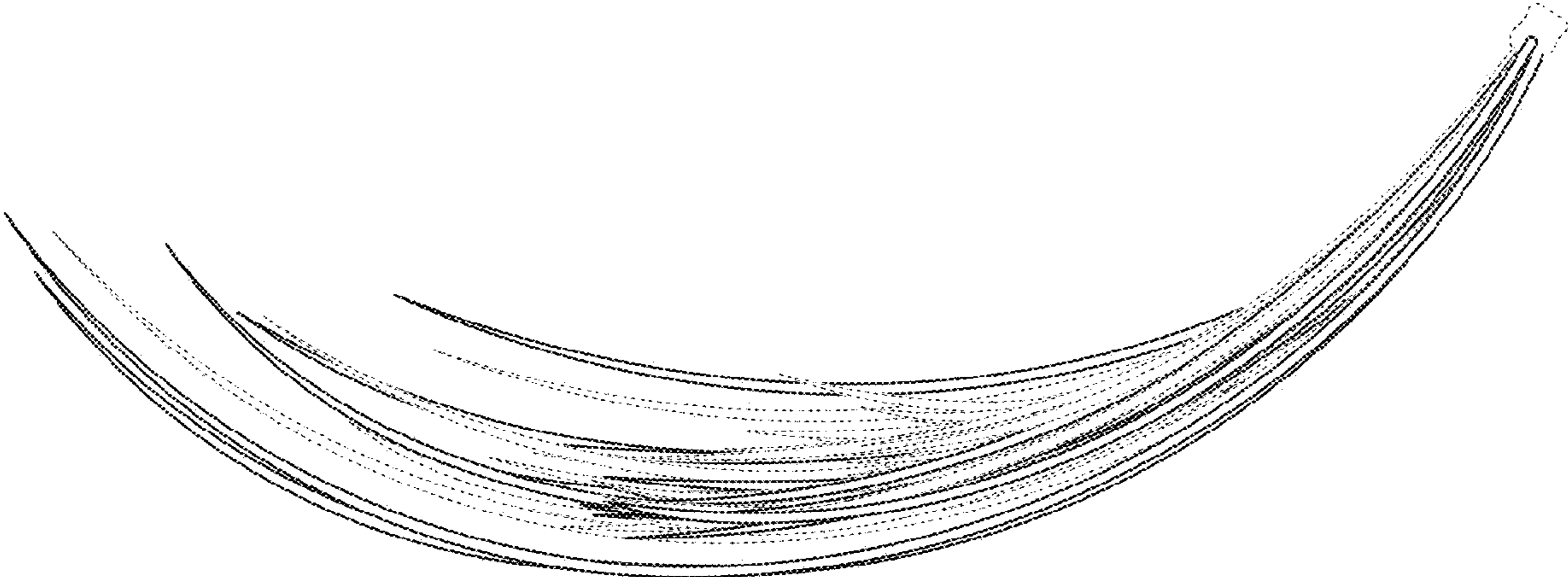

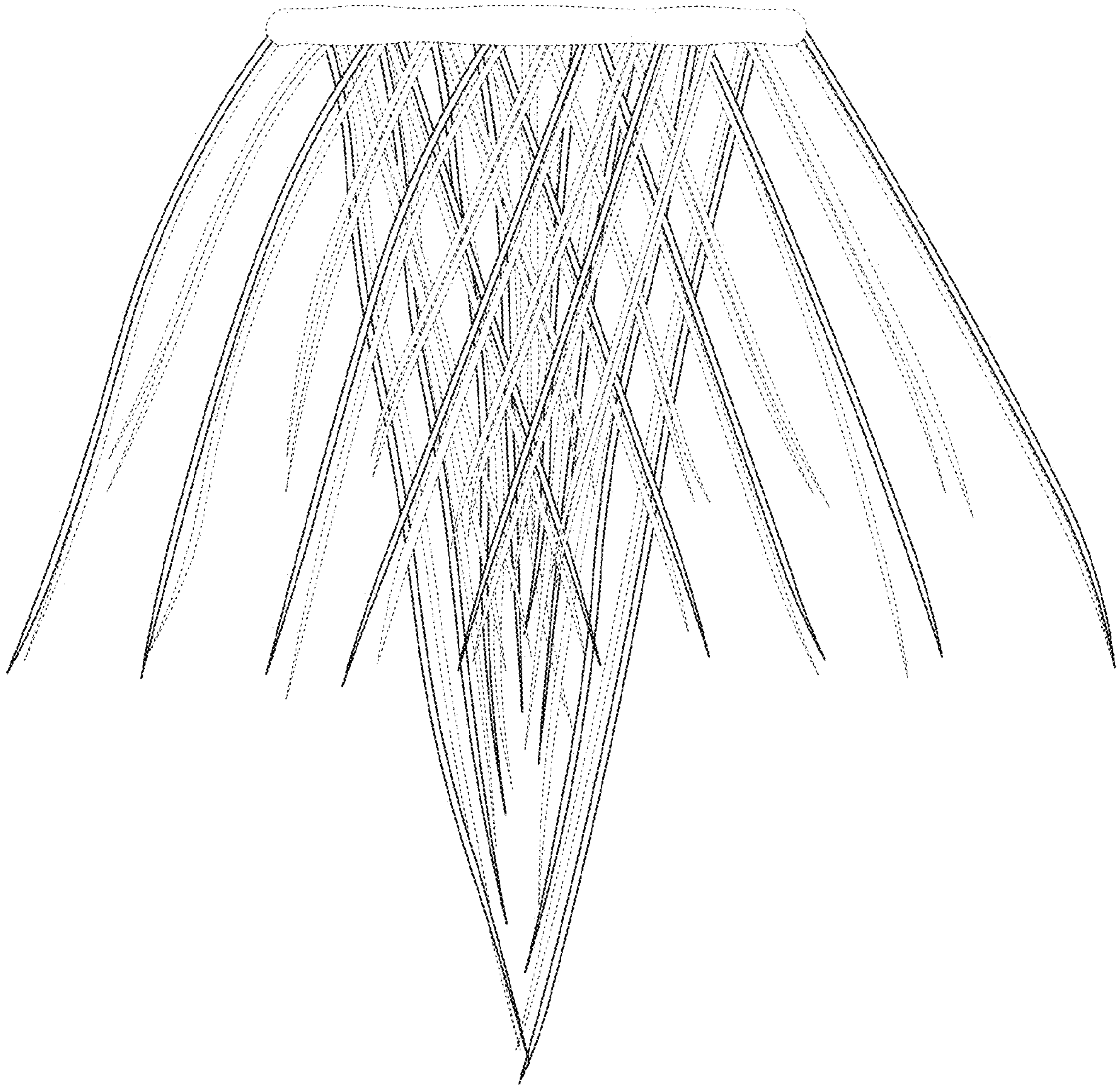

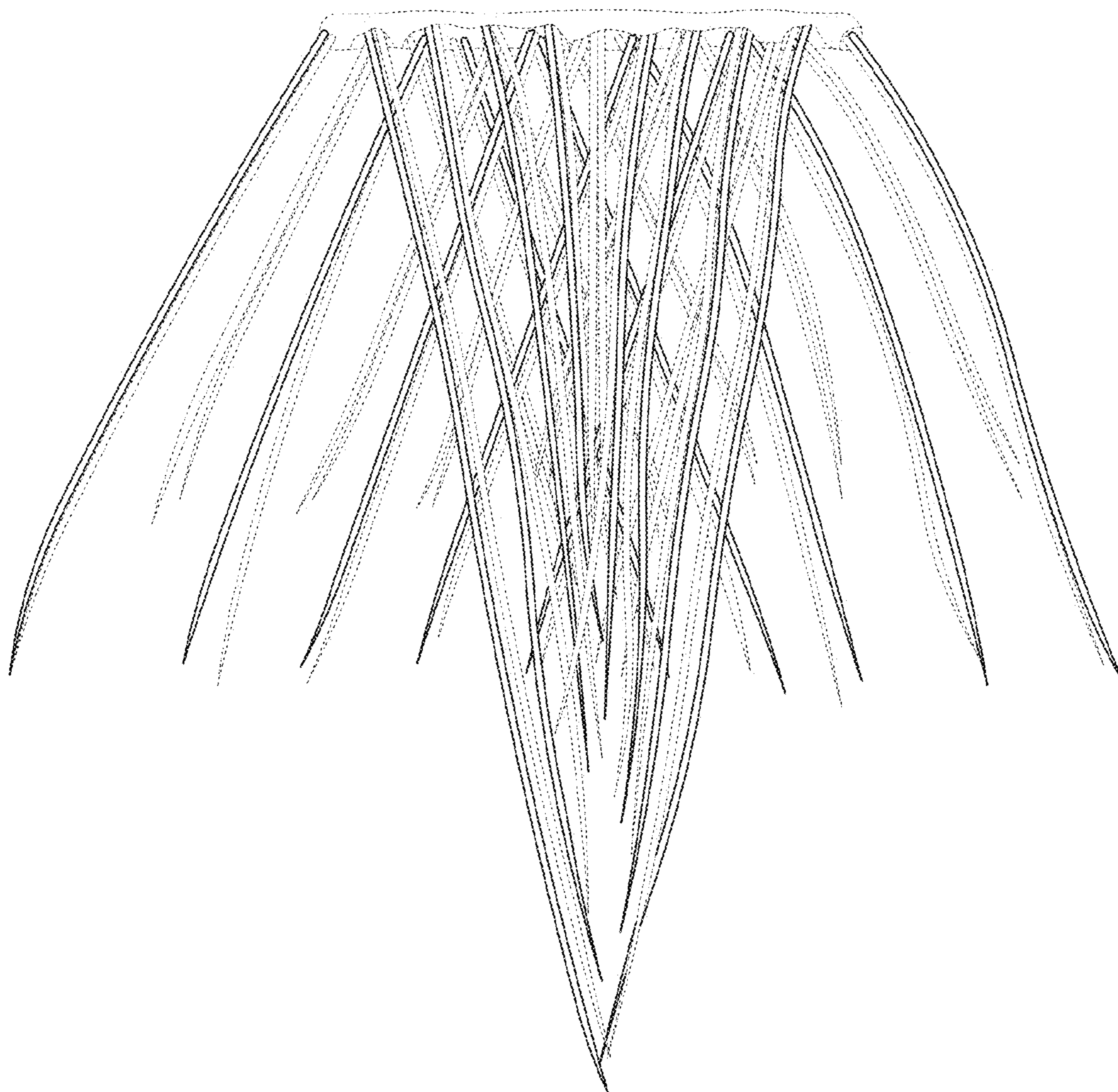
