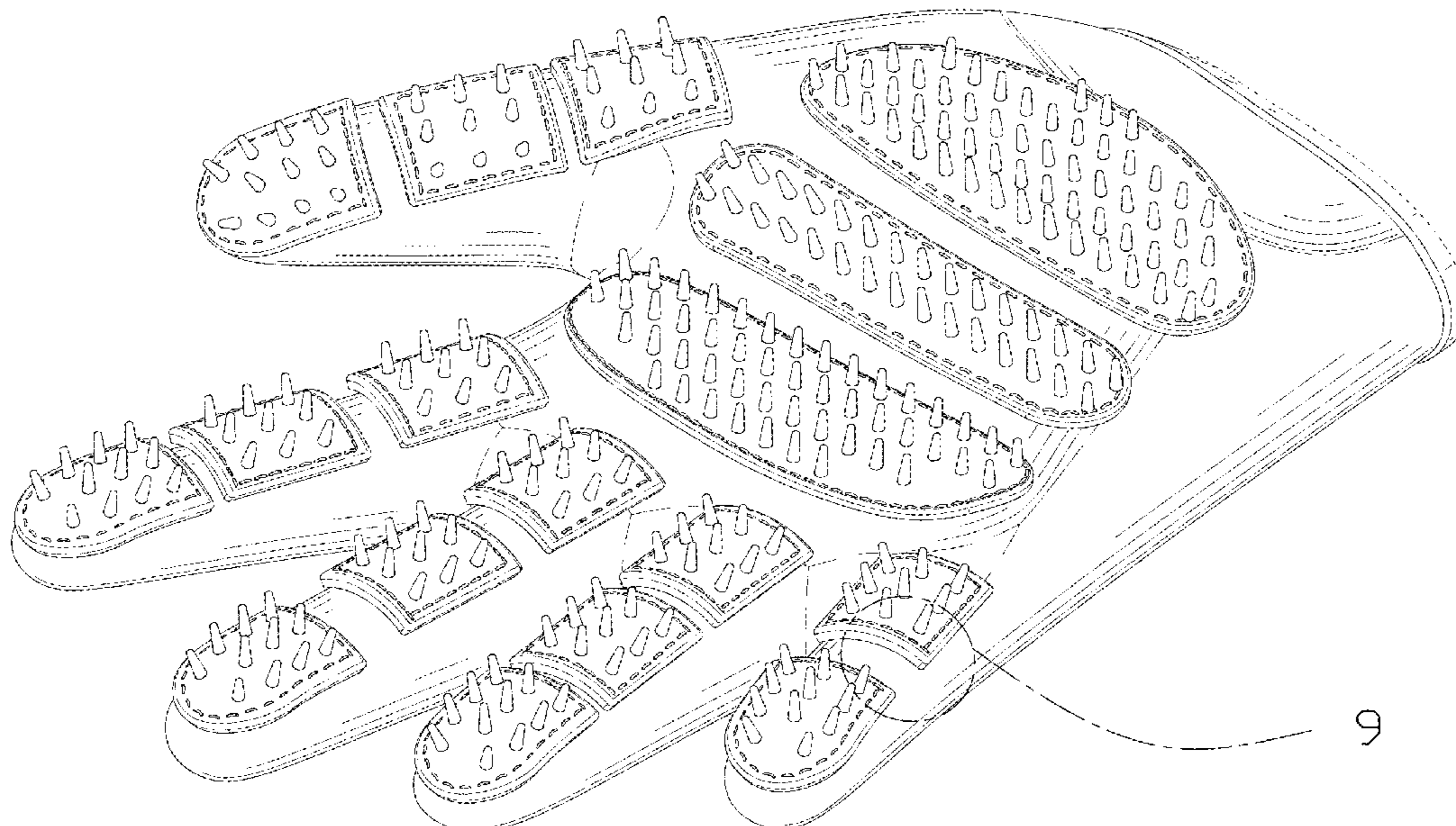

DESCRIPTION

FIG. 1 is a front, right, and top perspective view of a pet grooming glove, showing my design.
FIG. 2 is a rear, left, and bottom perspective view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a left side elevation view thereof.
FIG. 6 is a right side elevation view thereof.
FIG. 7 is a top plan view thereof.
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is an enlarged detail view of area 9 shown in FIG. 1. The dash-dash broken lines that illustrate portions of the pet grooming glove. FIGS. 1 and 9 show dot-dash broken lines that represent the boundaries and indicators of the enlarged views. The broken lines form no part of the claimed design.

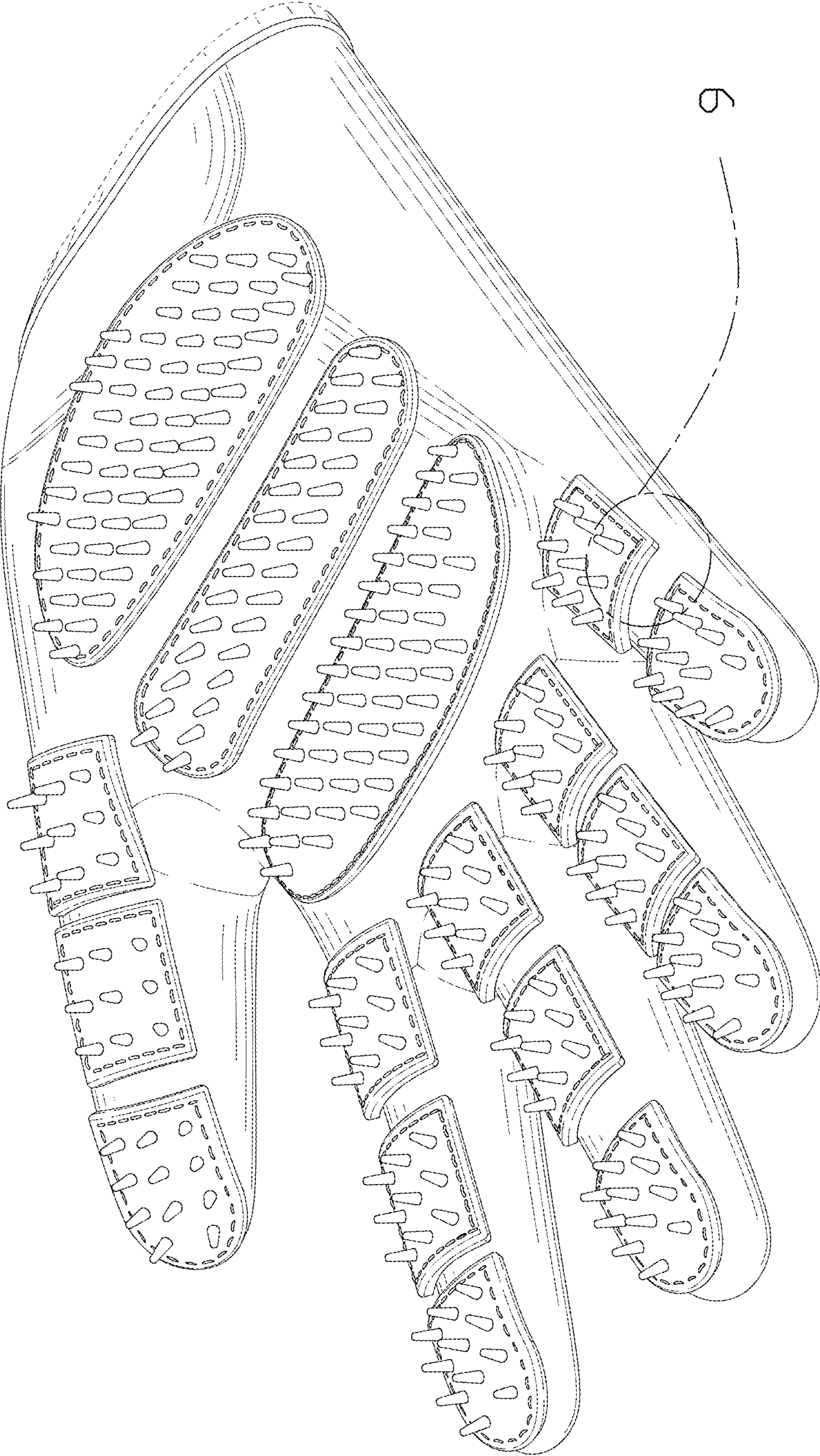

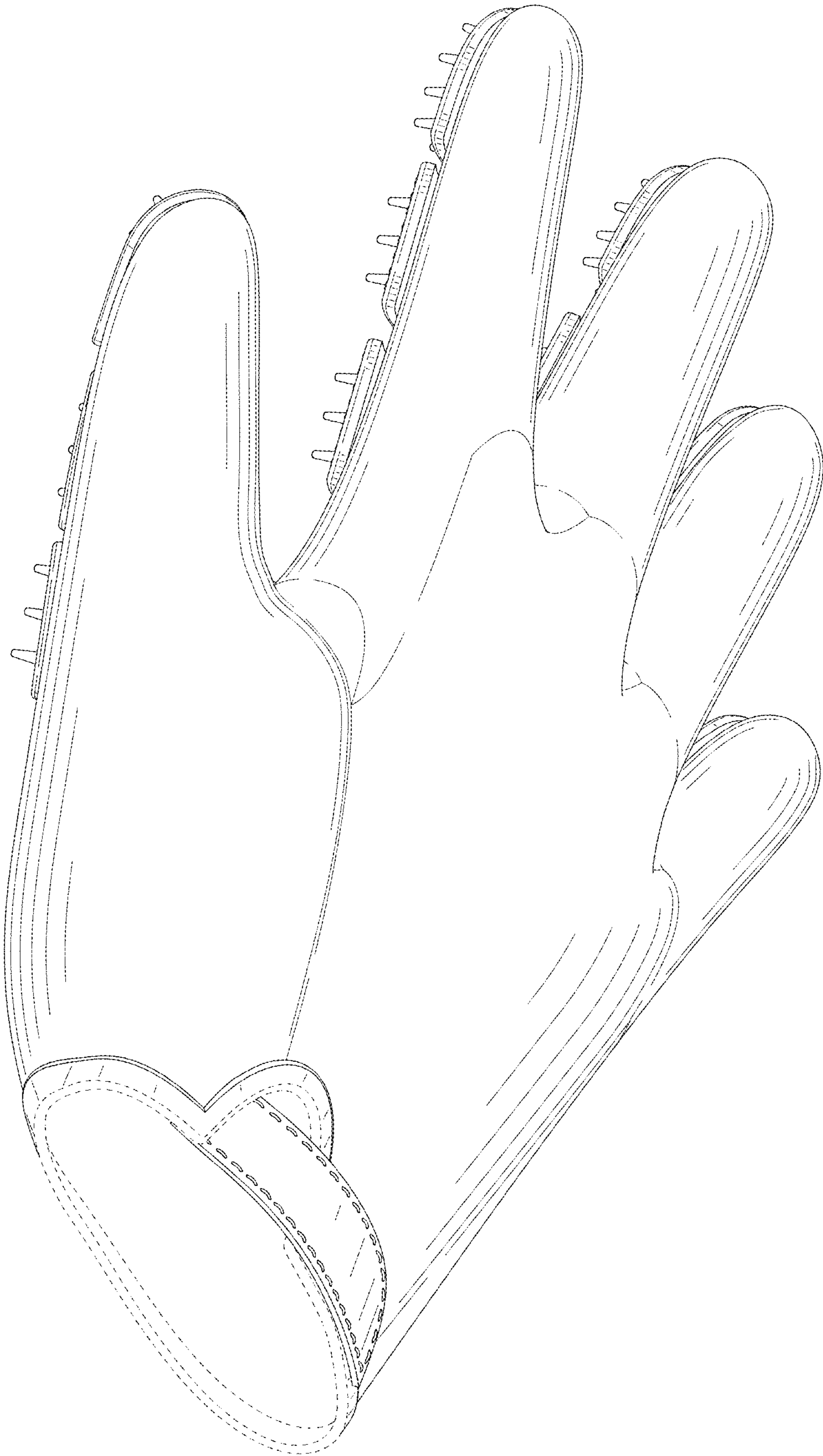

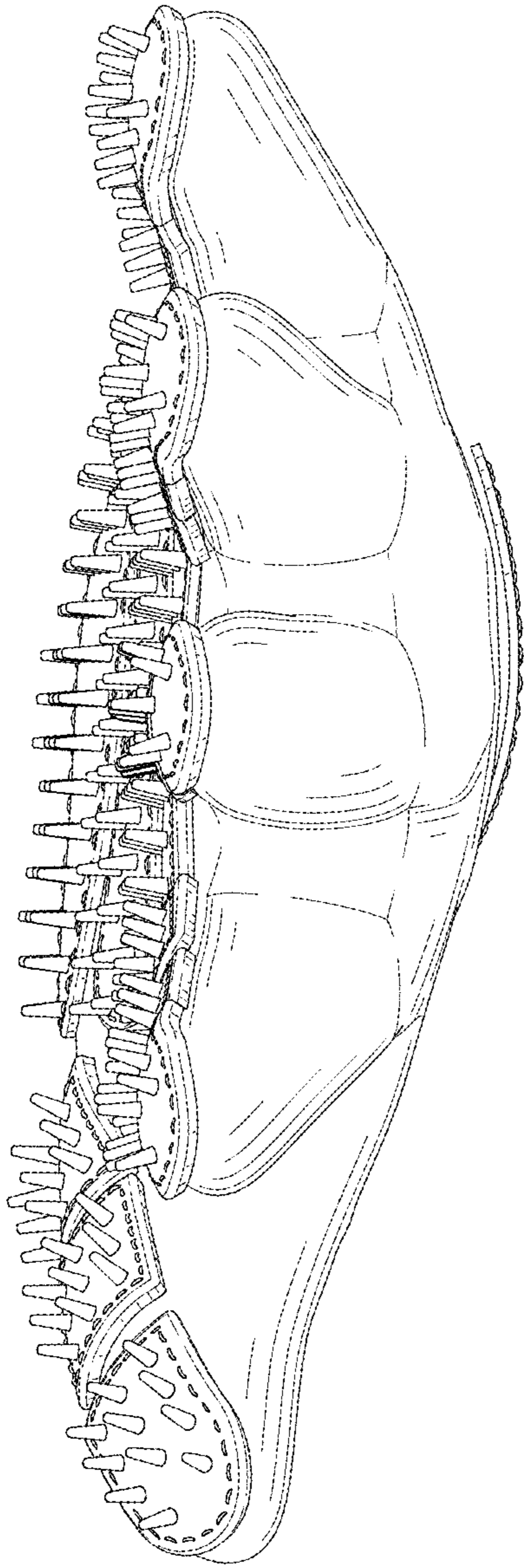

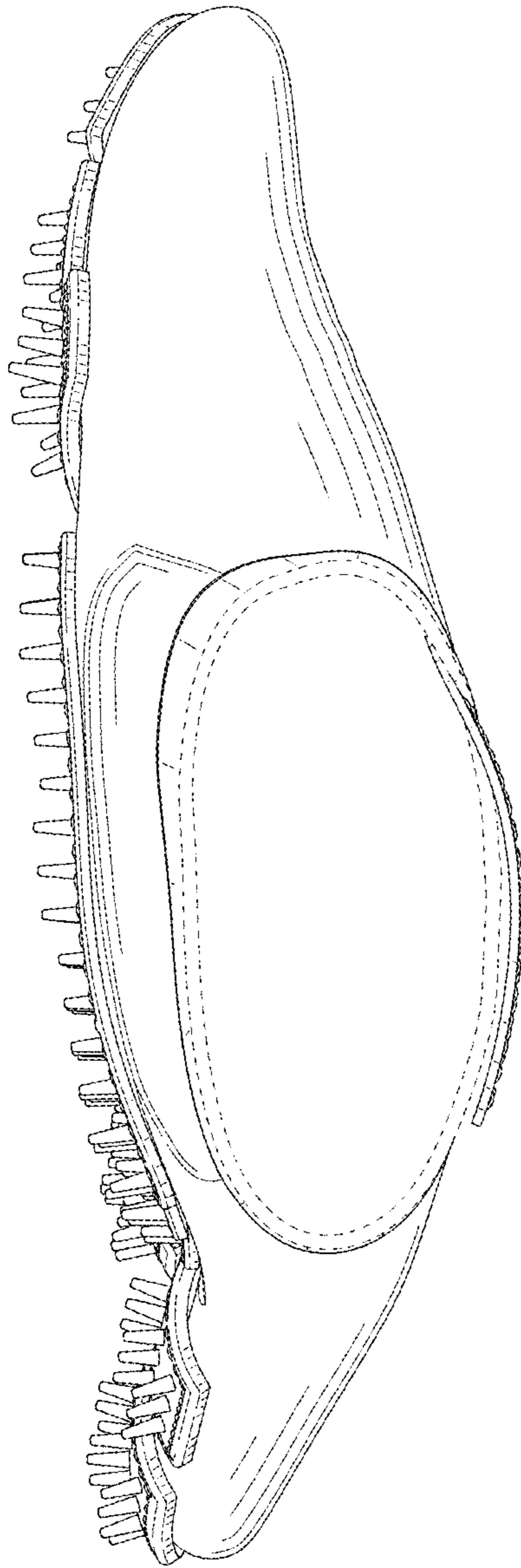

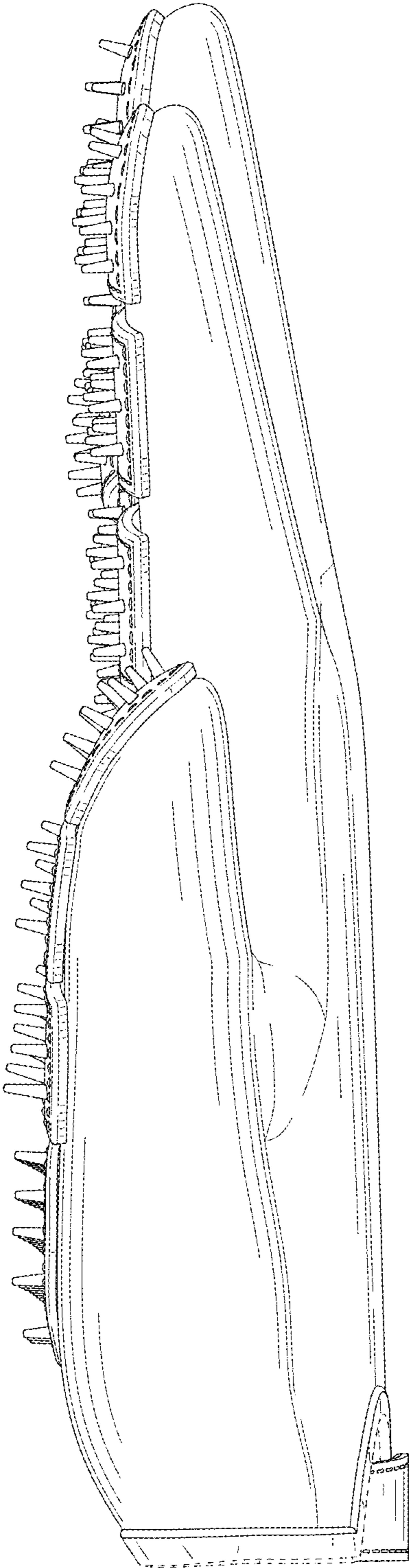

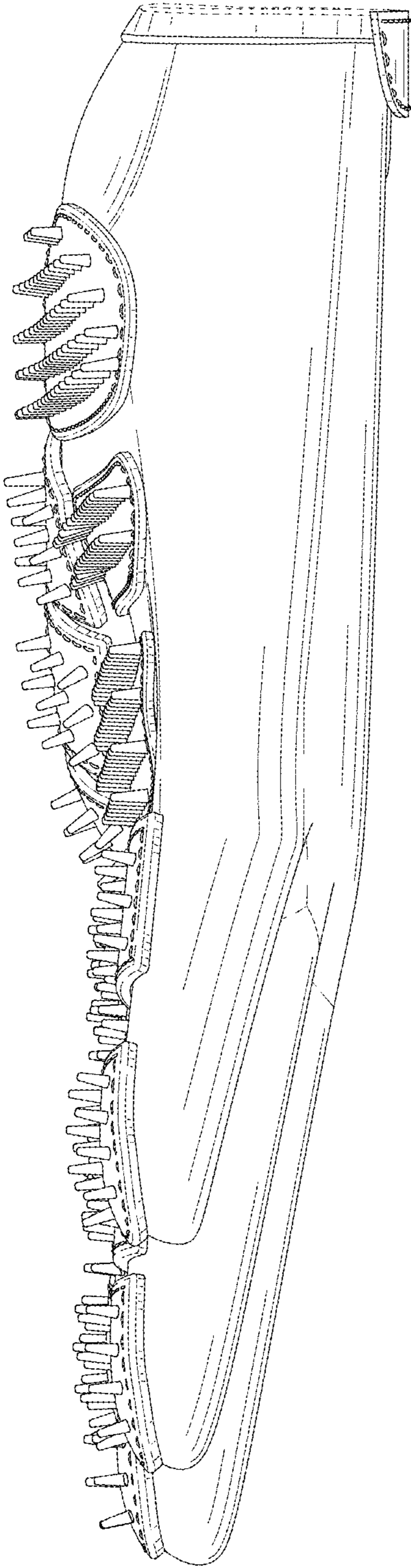

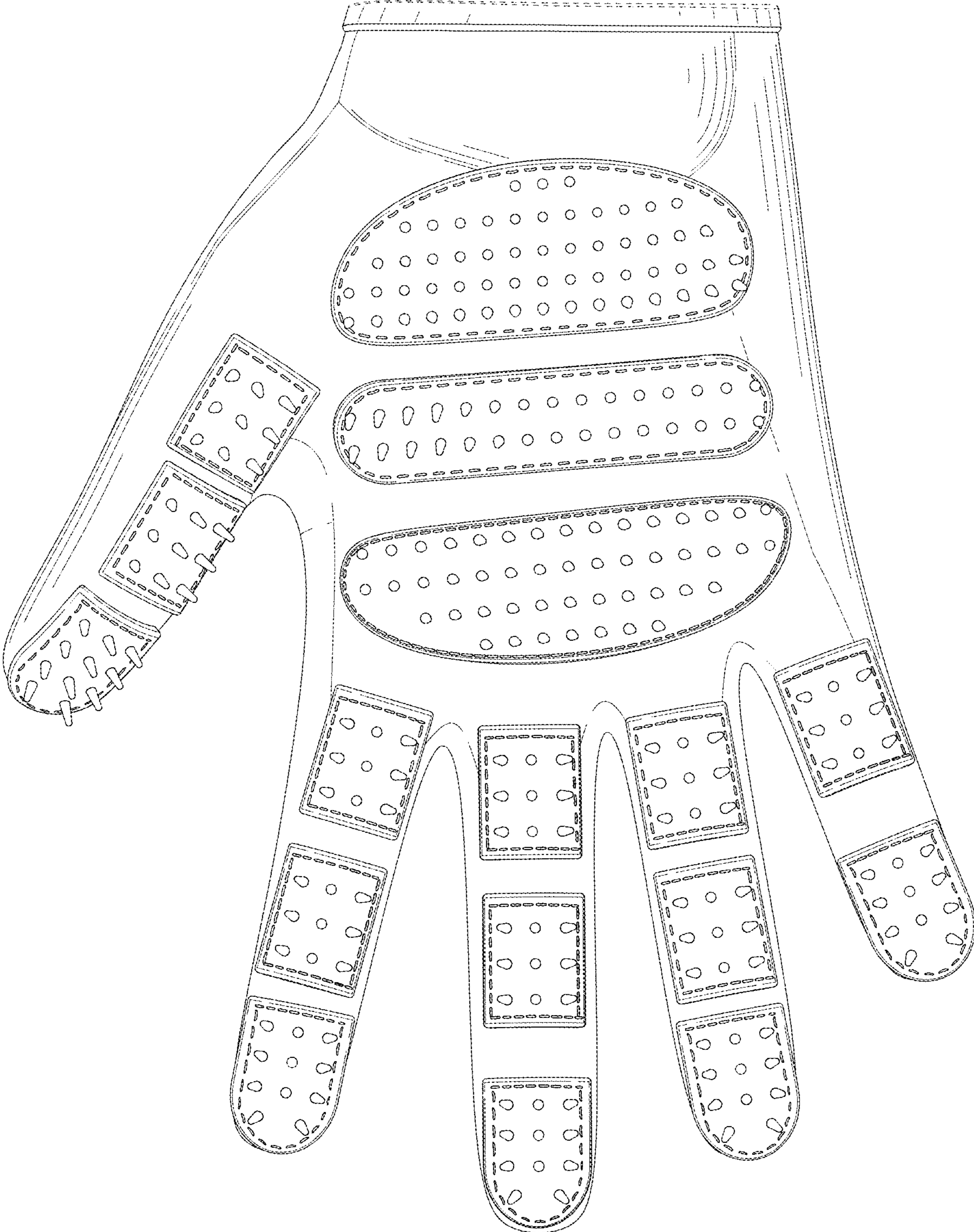

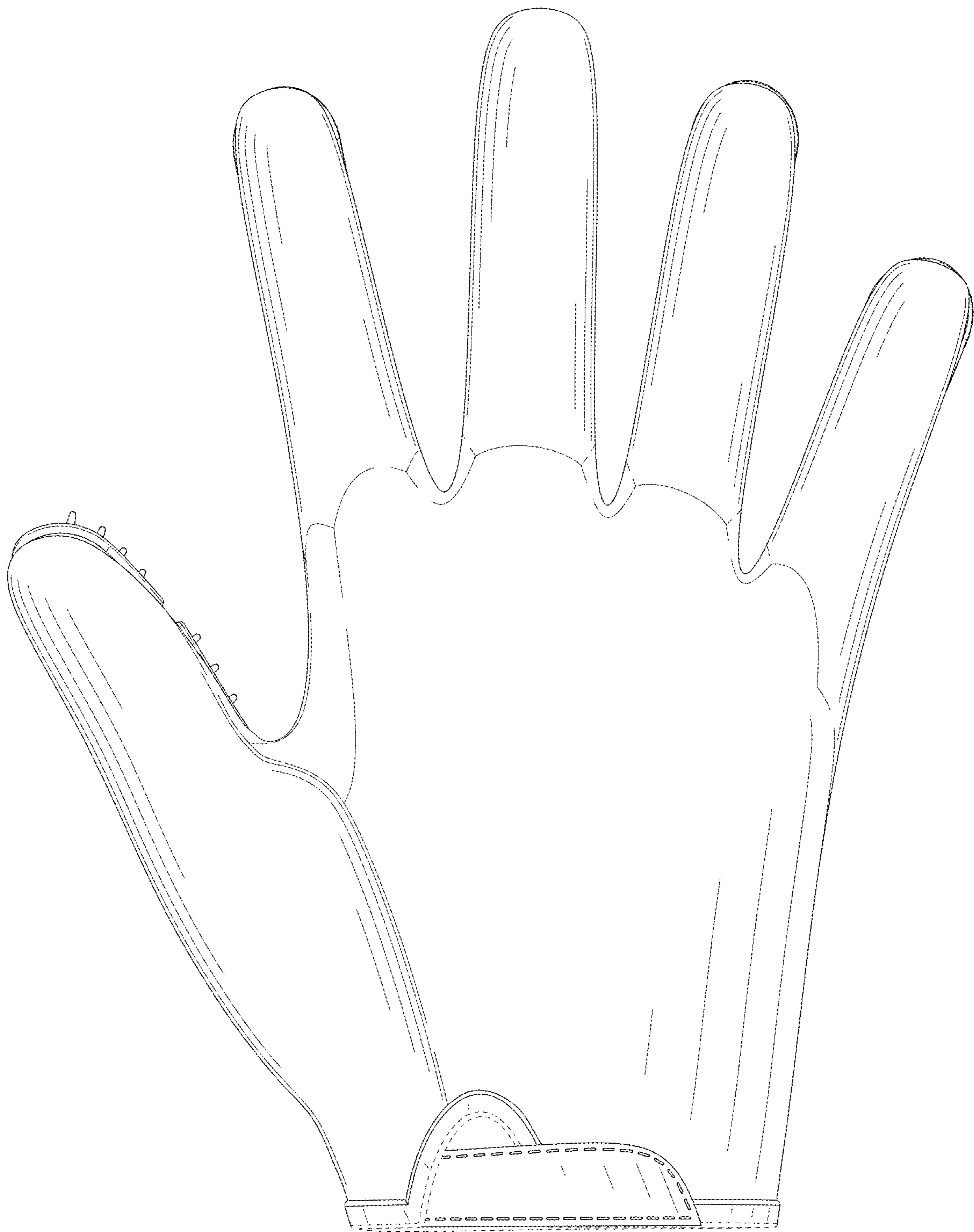

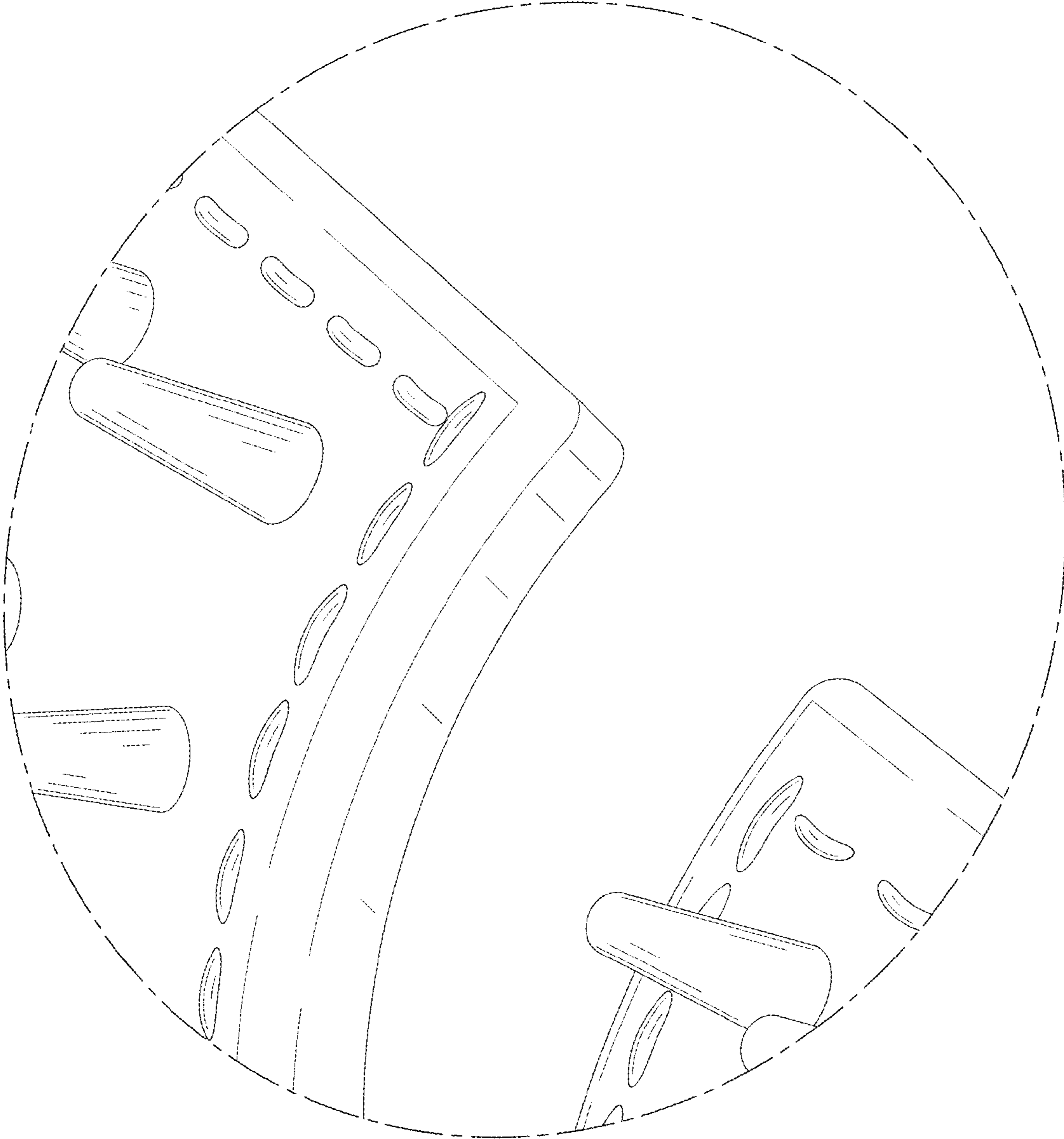
