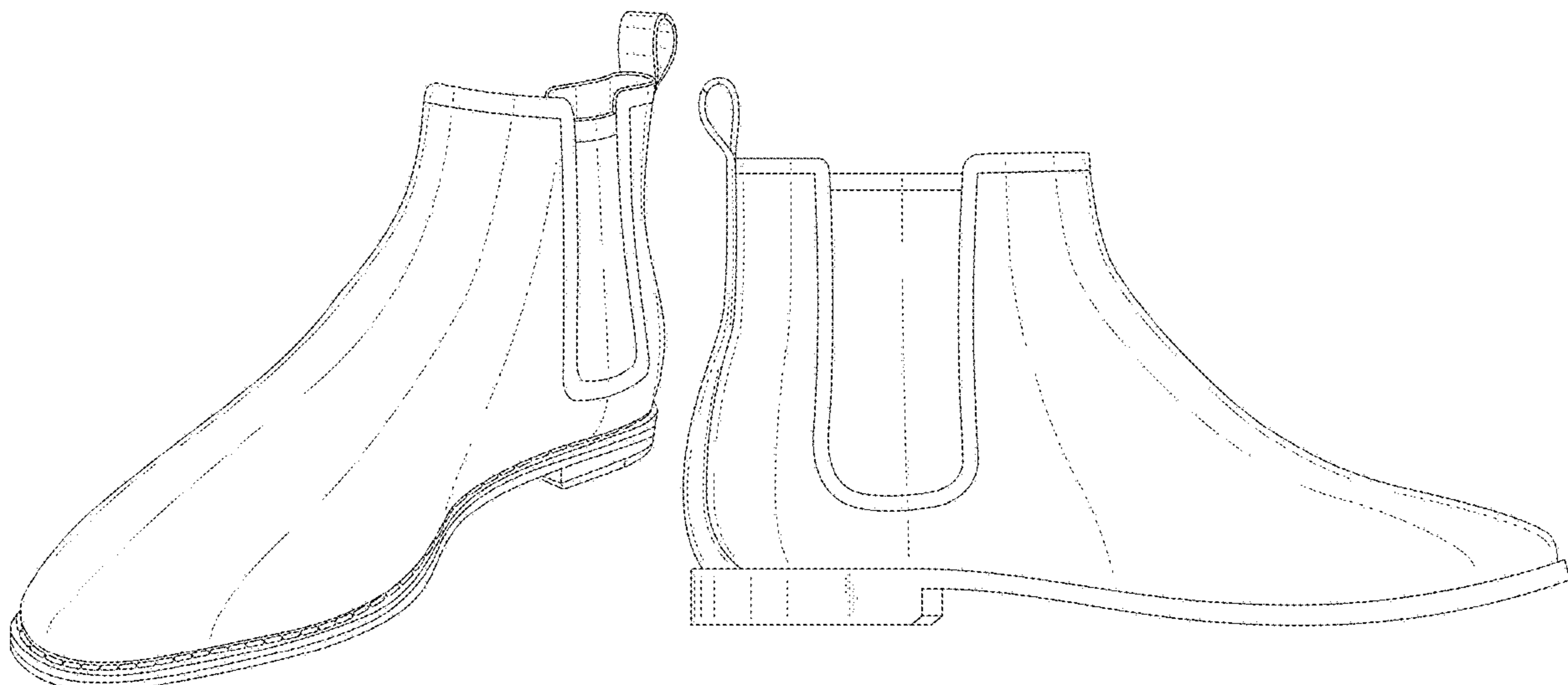
(57) **CLAIM**

The ornamental design for a boot, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a first embodiment of a boot showing our new design;

FIG. 9 is a front left perspective view of a second embodiment of a boot showing our new design;

FIG. 12 is a back view of the design shown in FIG. 9;
FIG. 13 is a right side view of the design shown in FIG. 9;

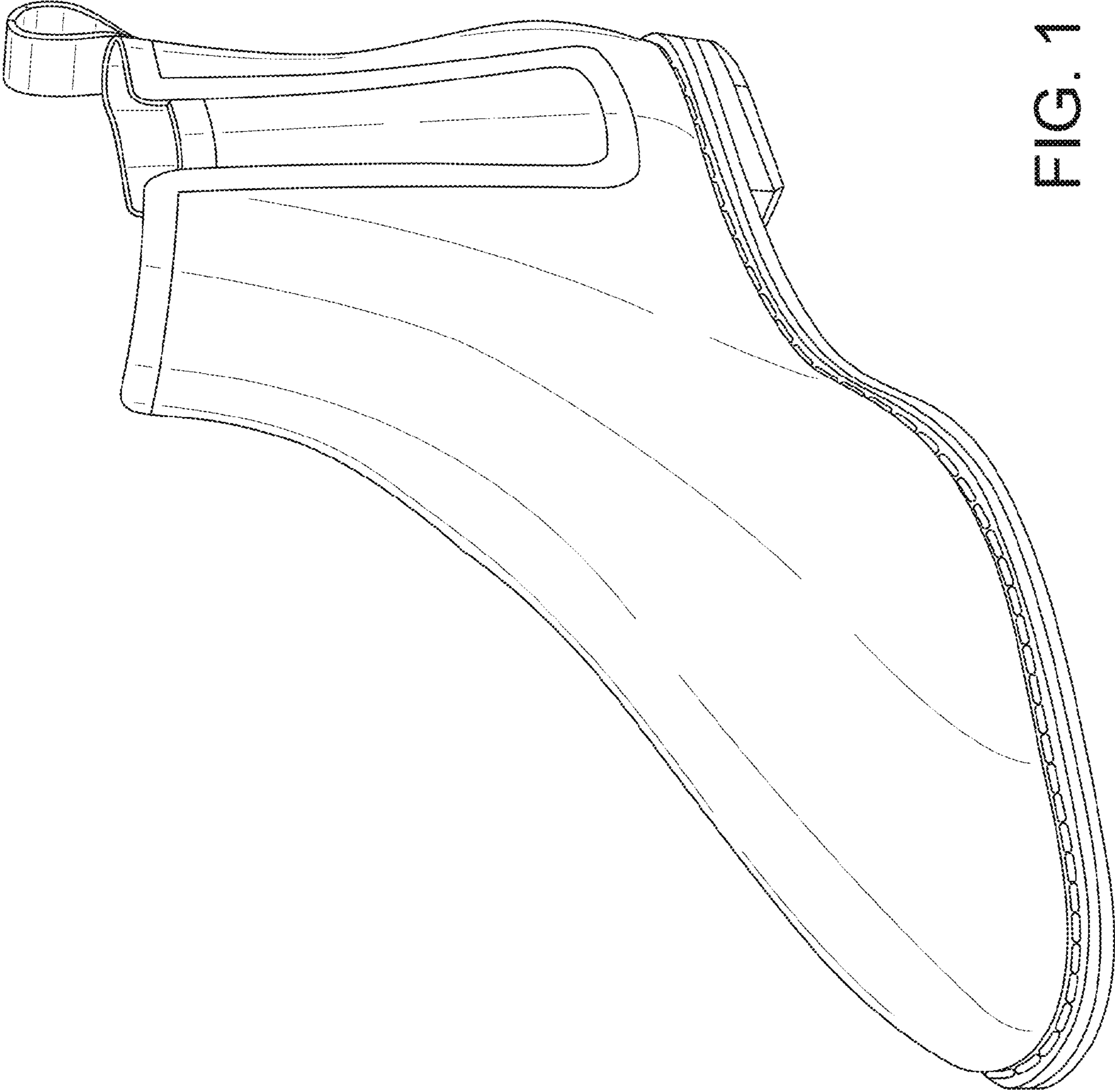

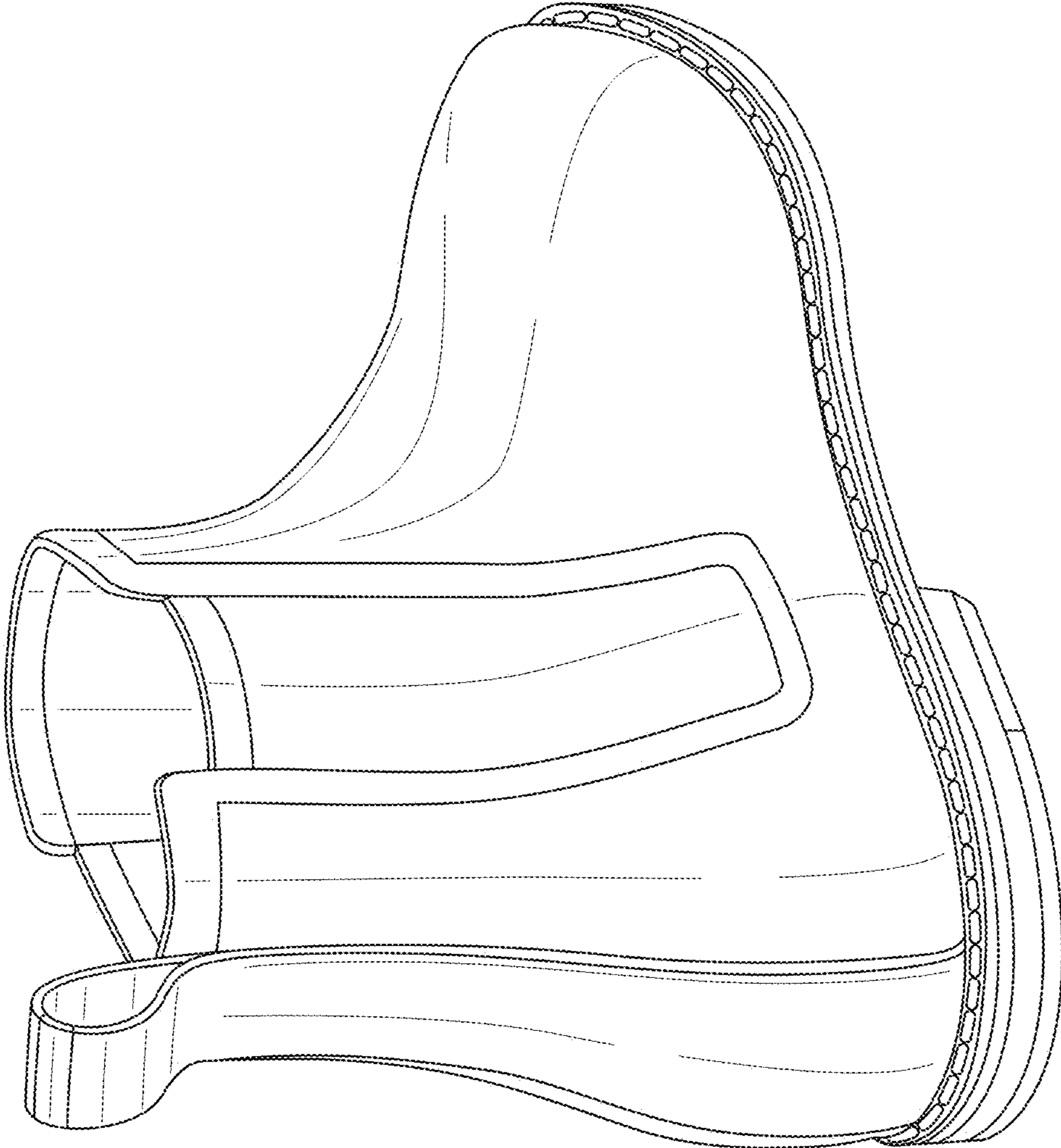

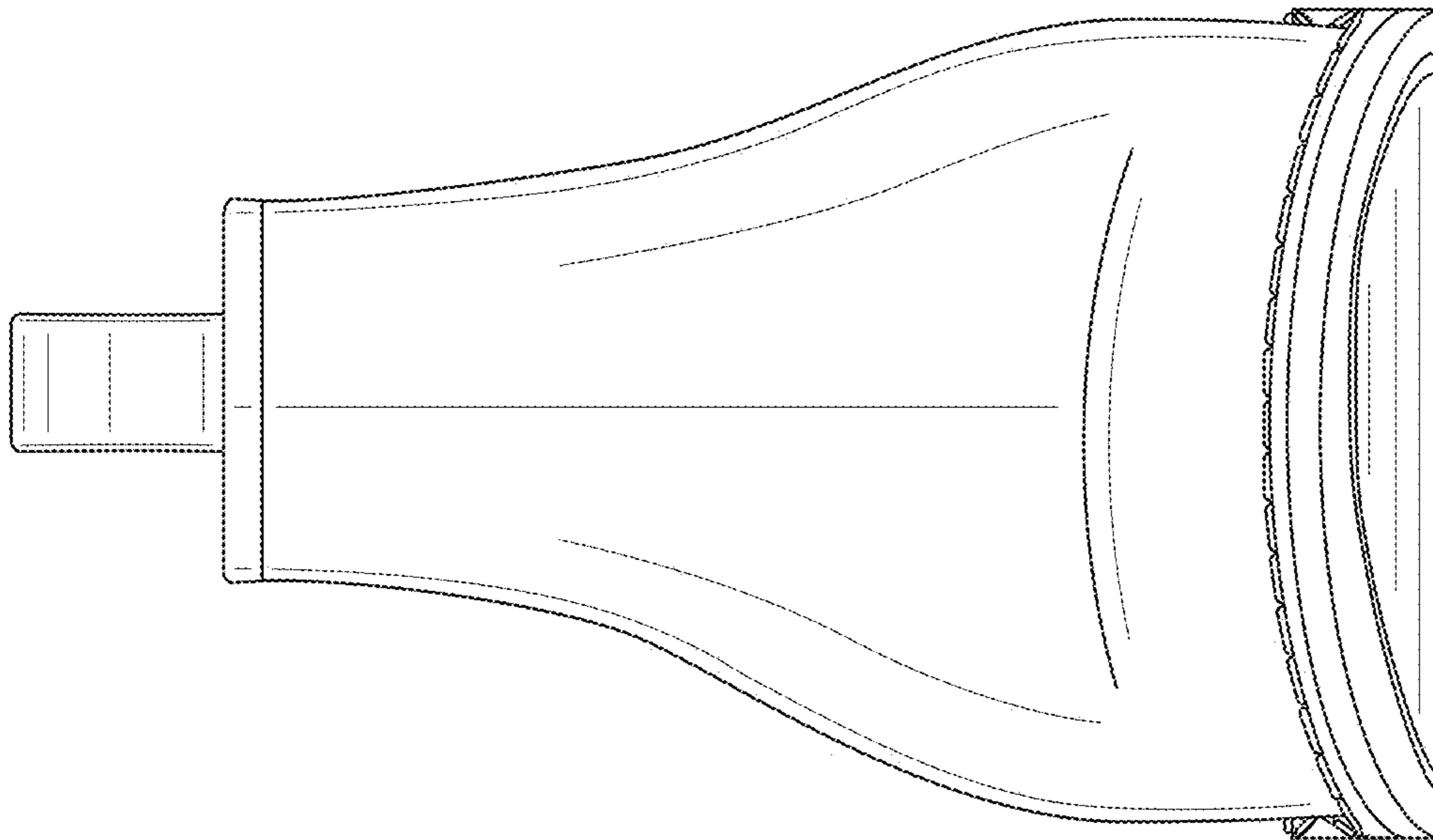

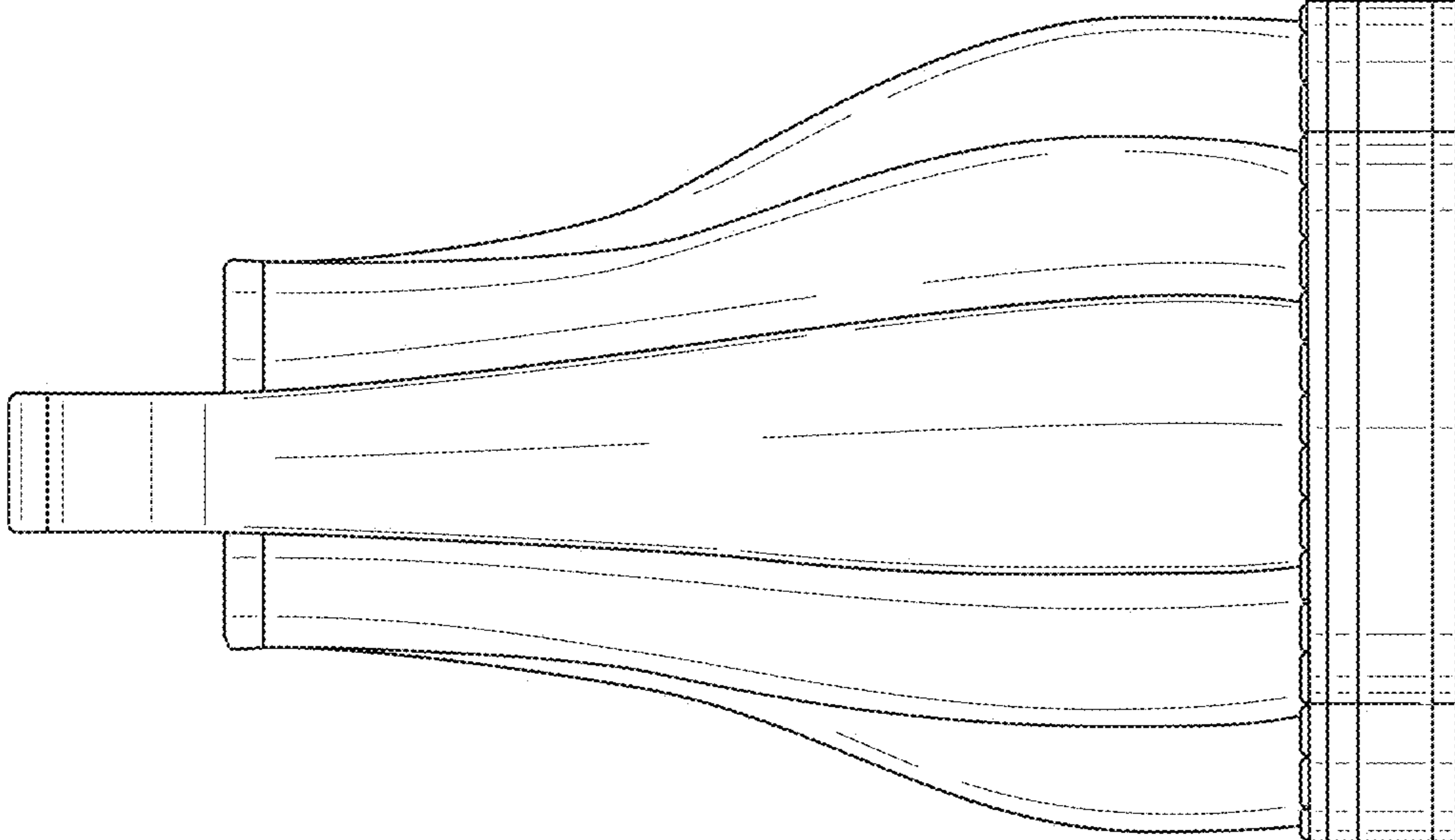

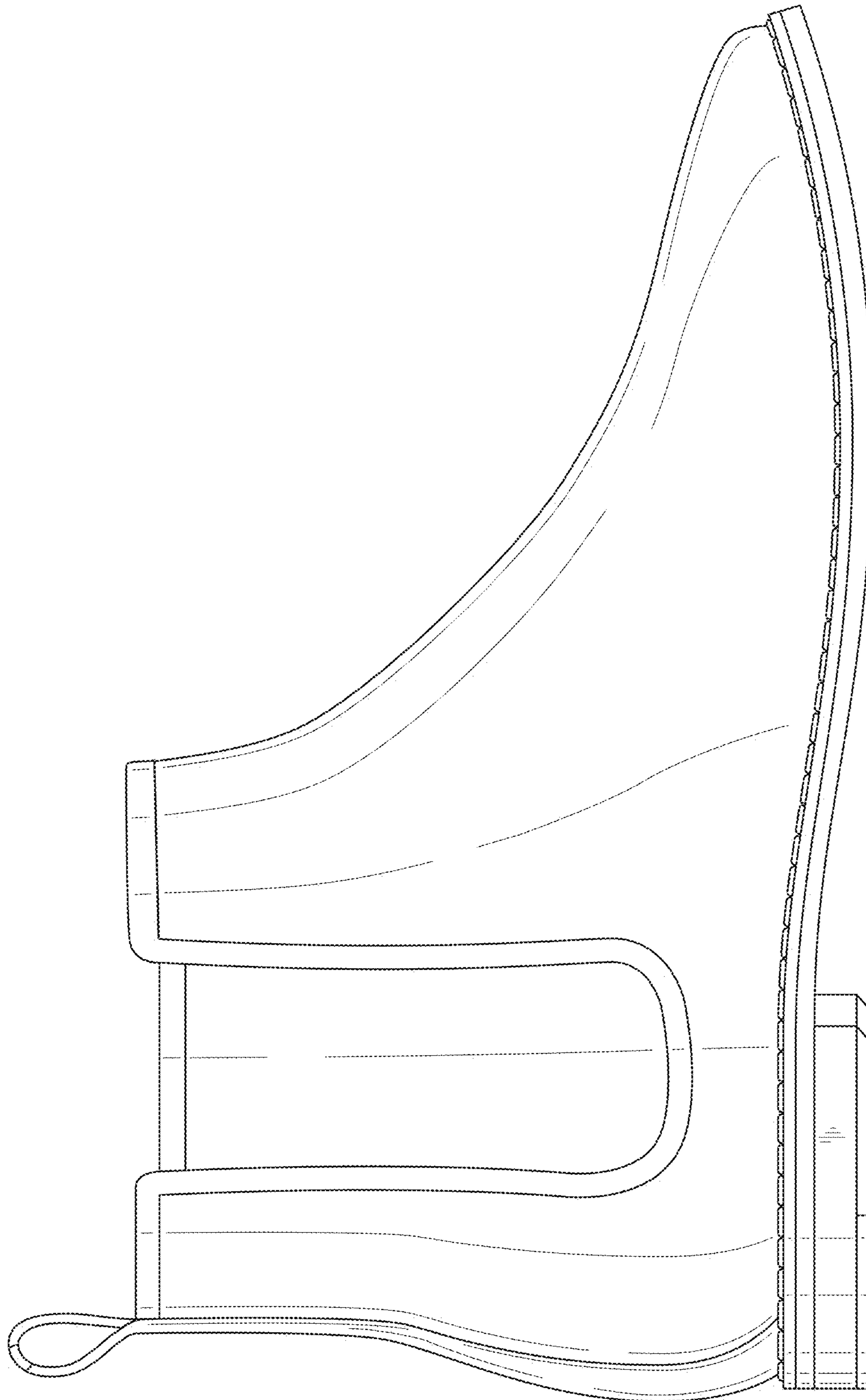

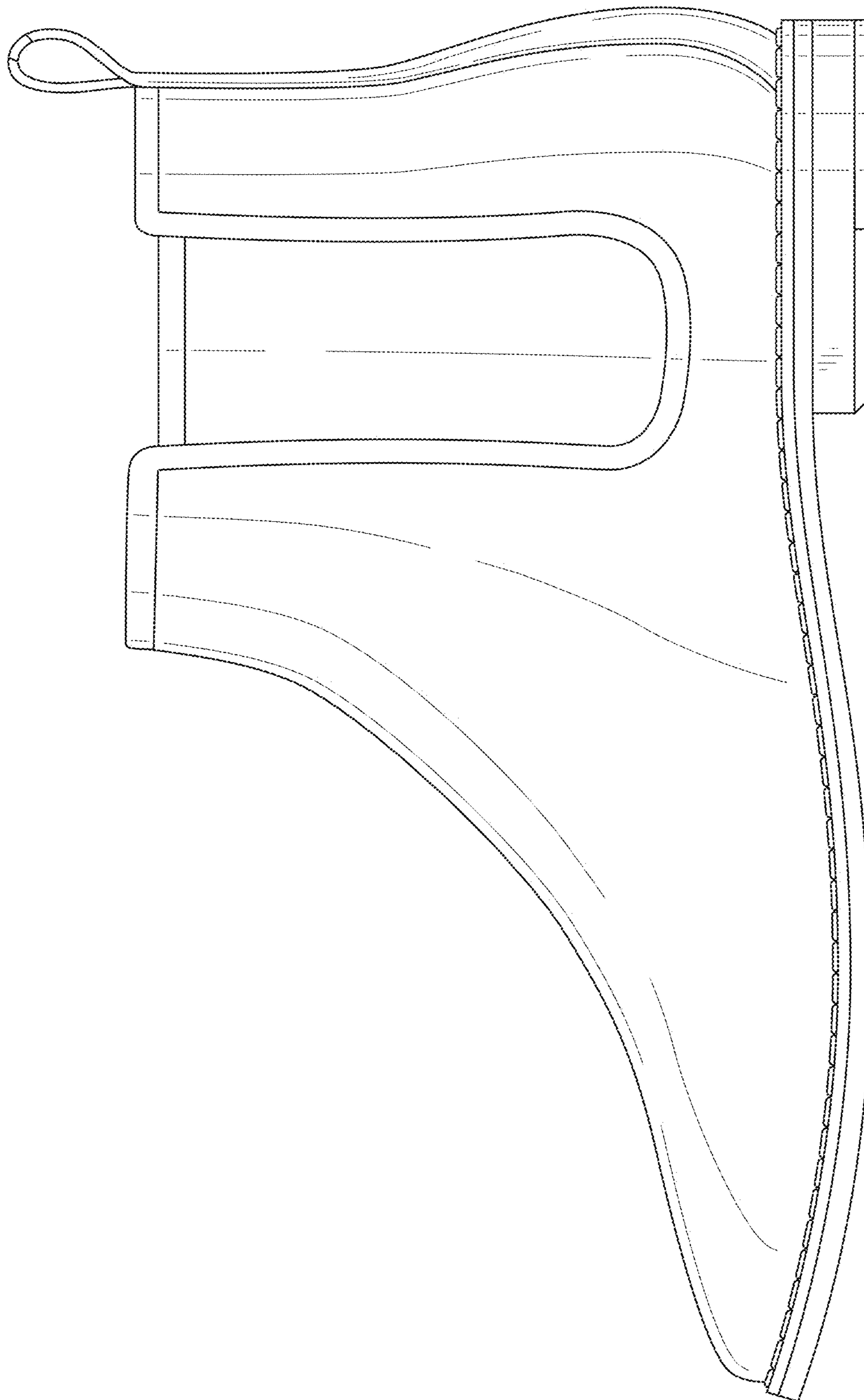

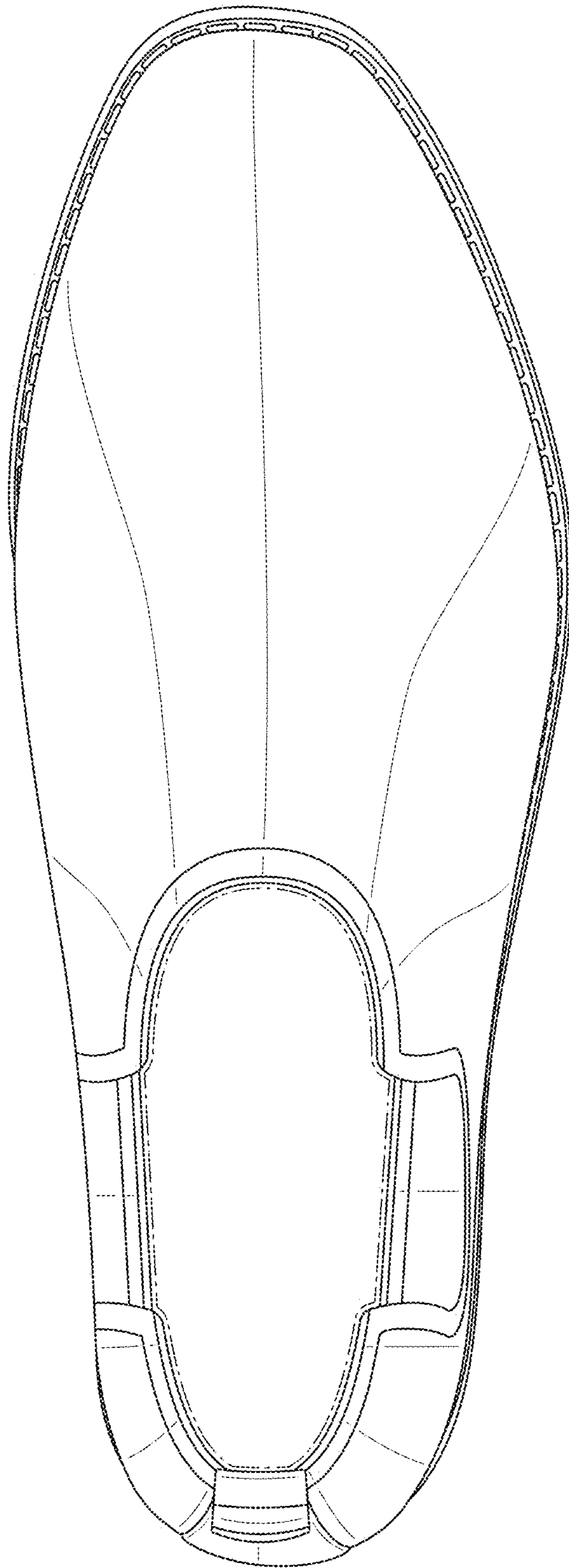

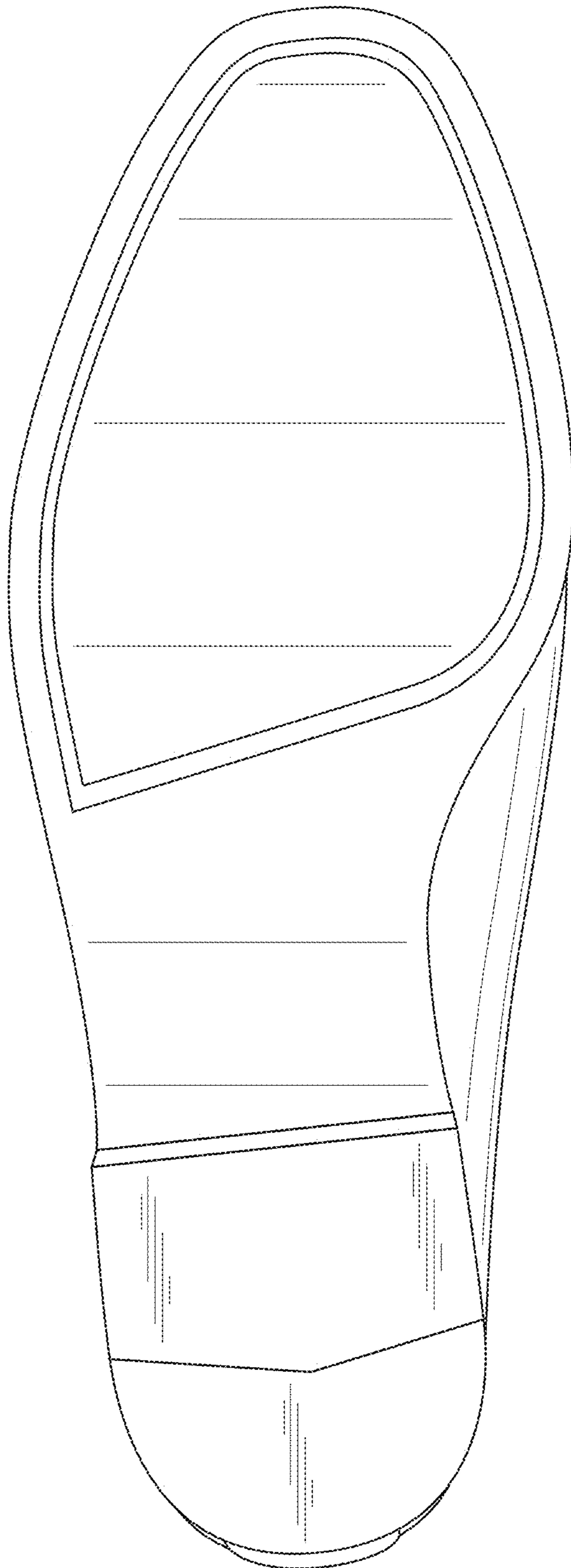

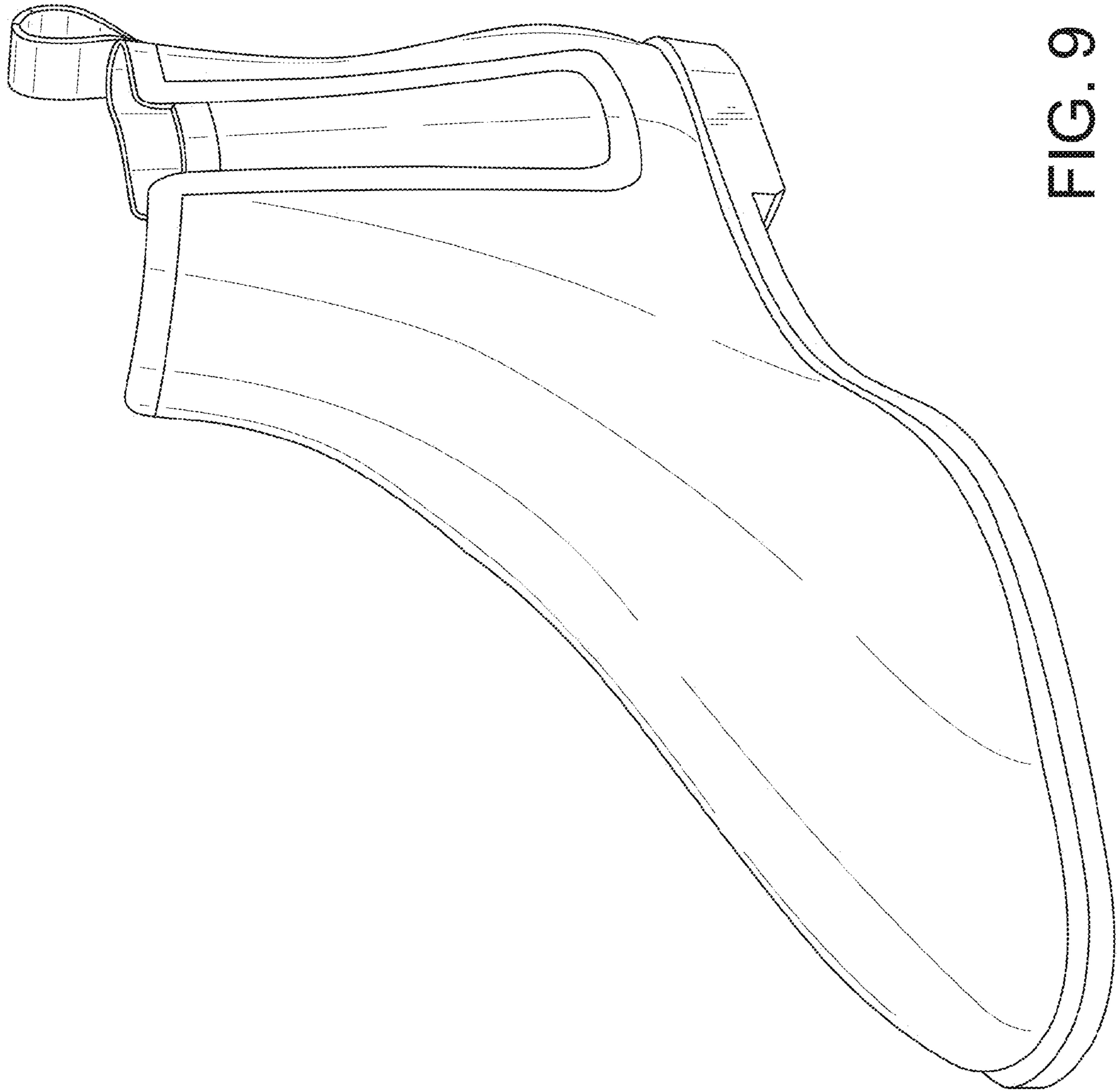

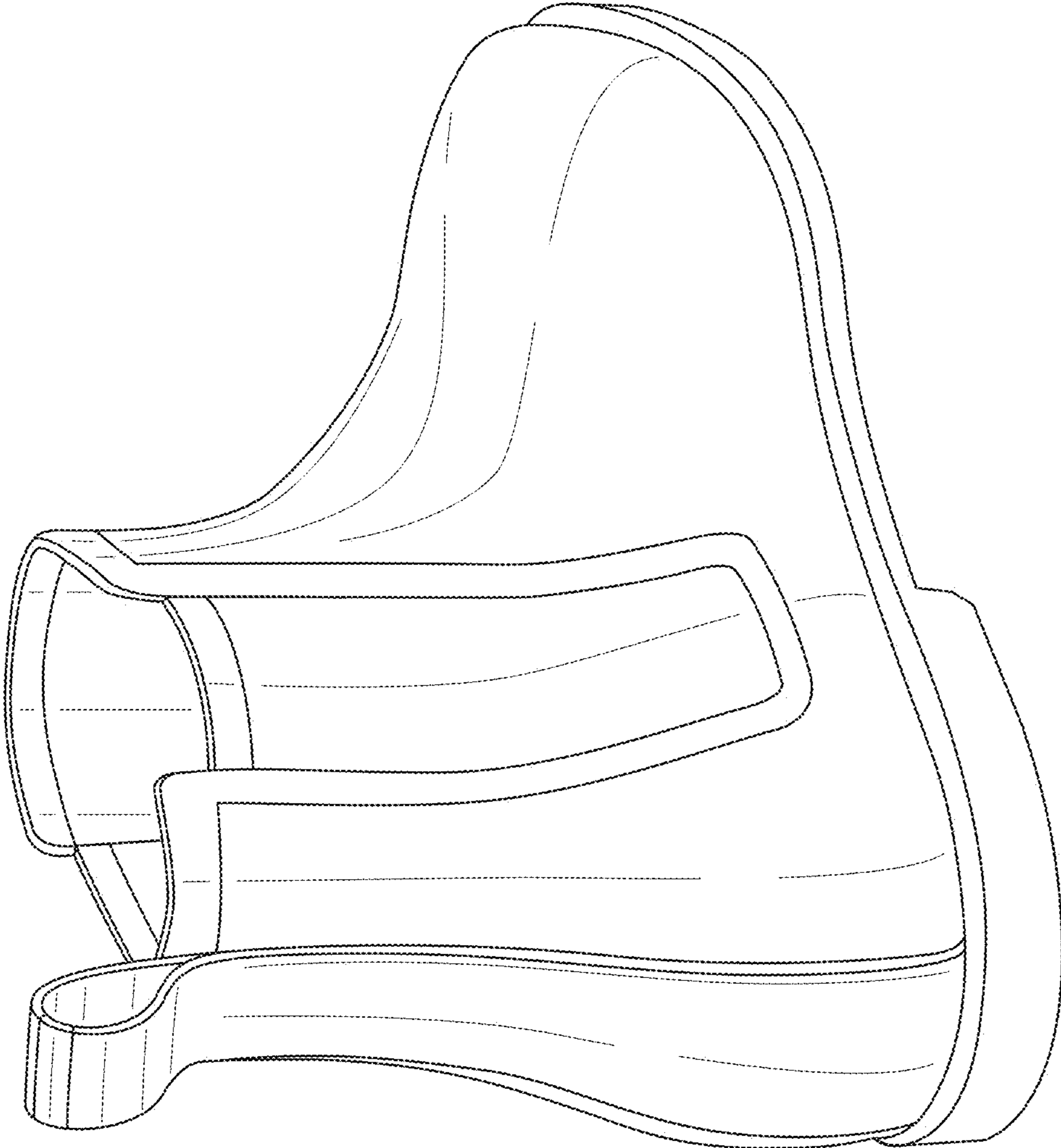

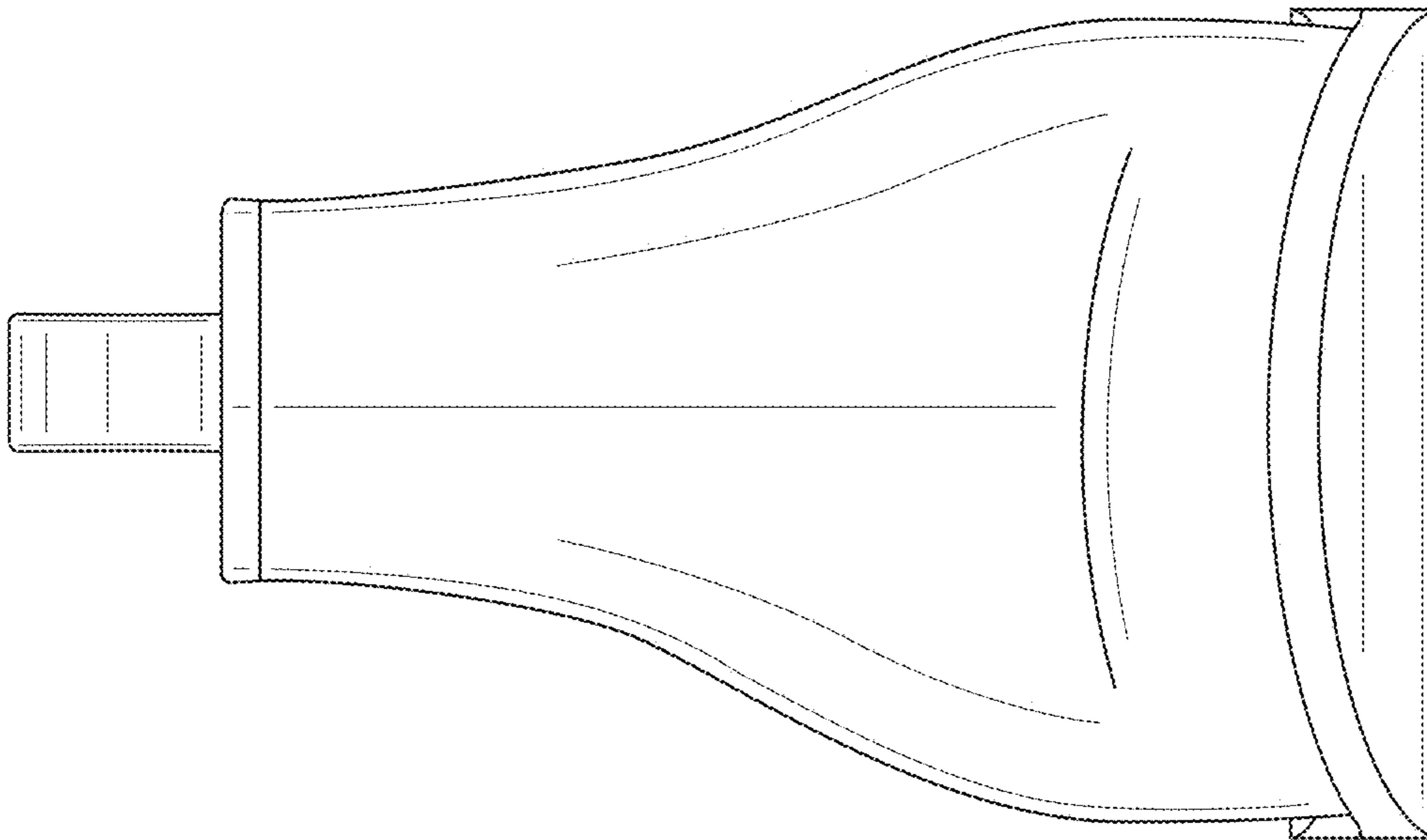

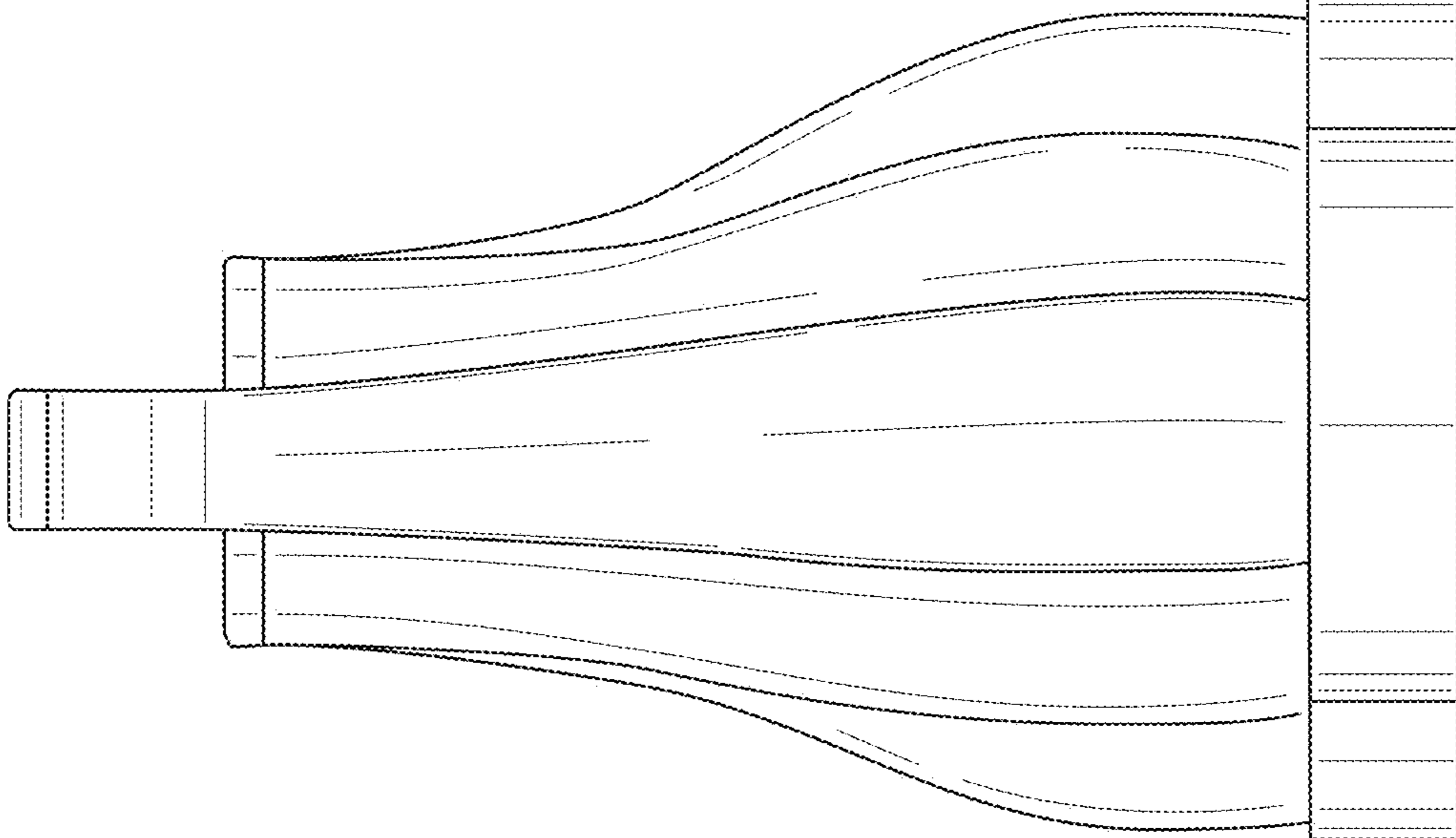

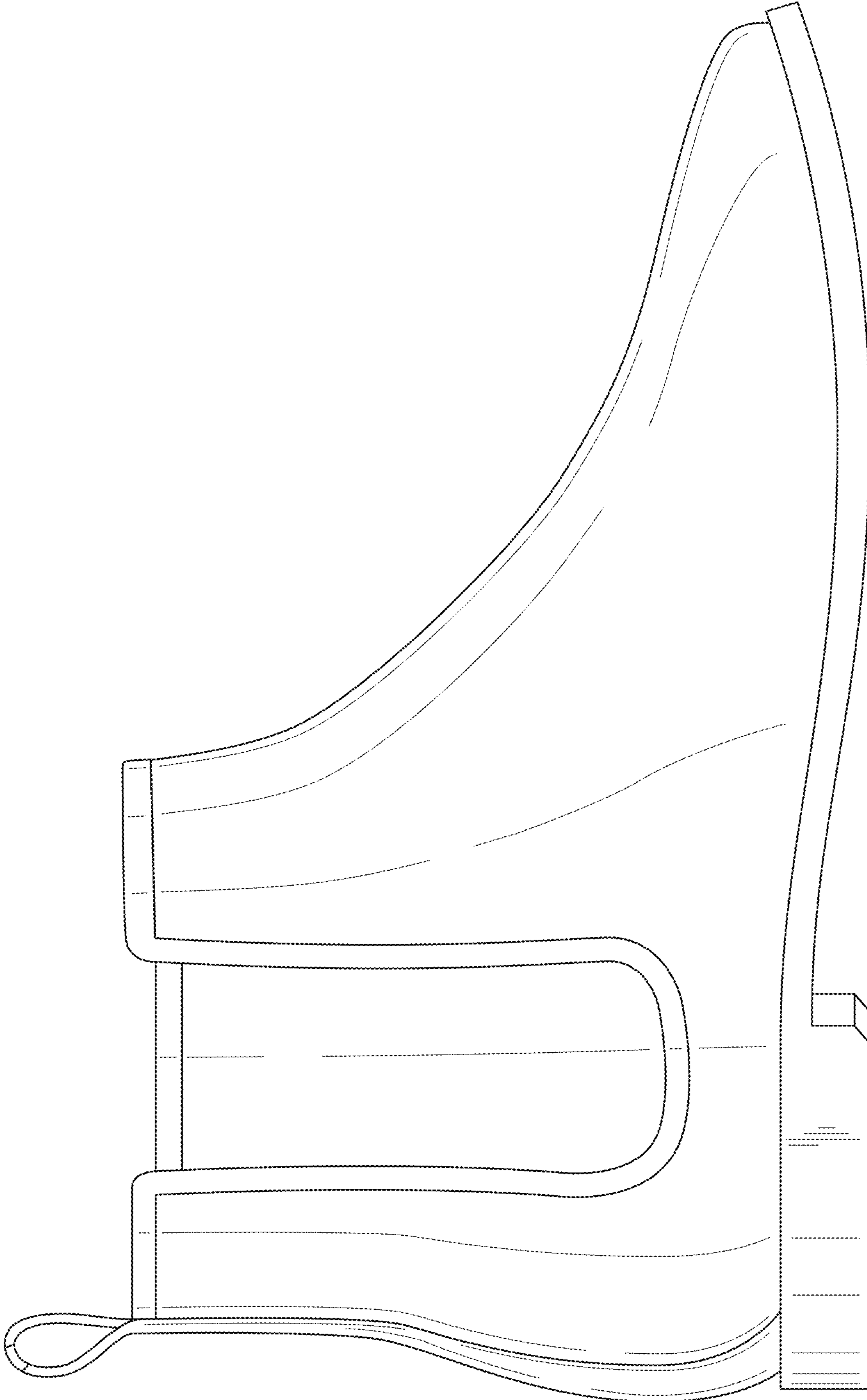

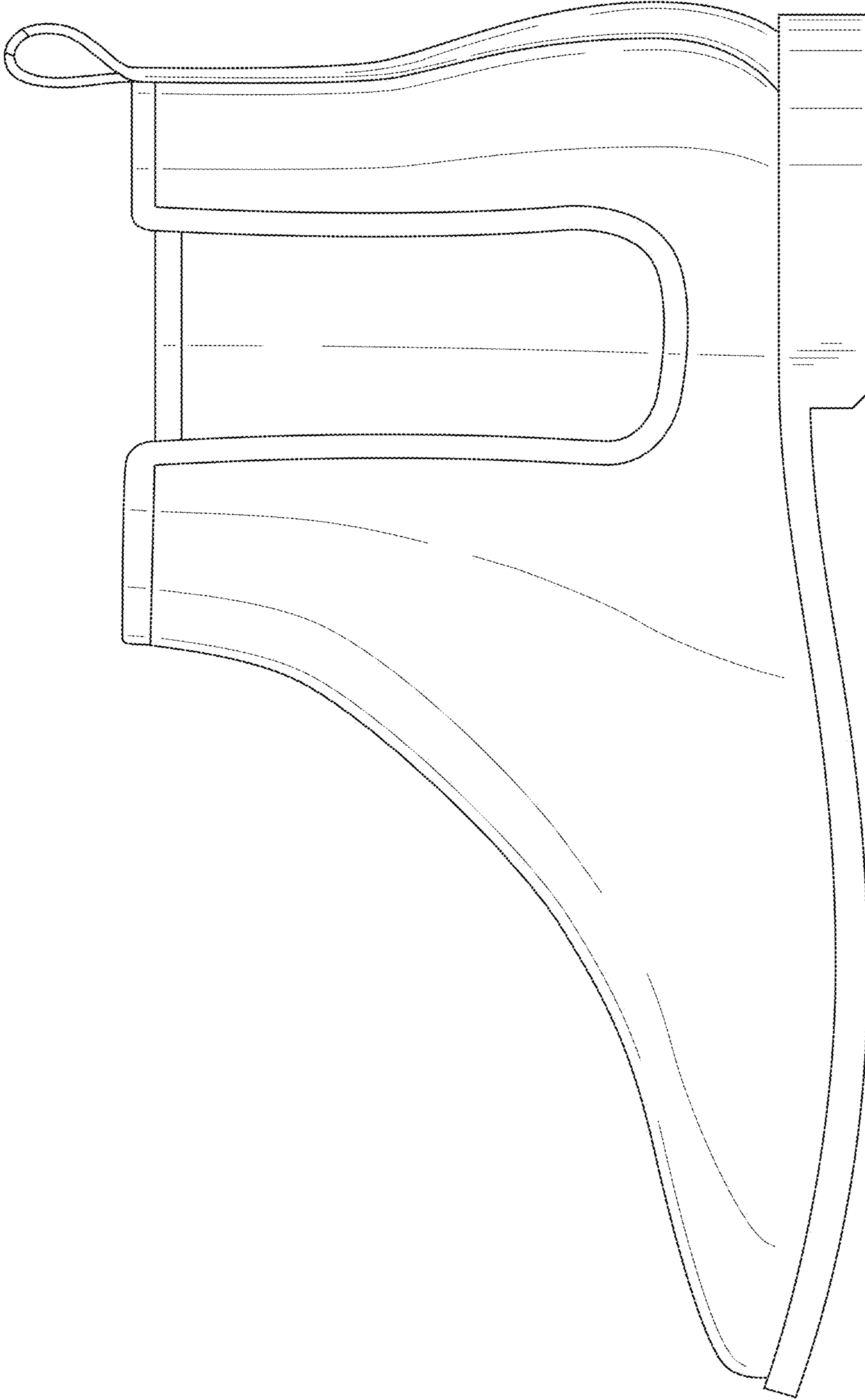

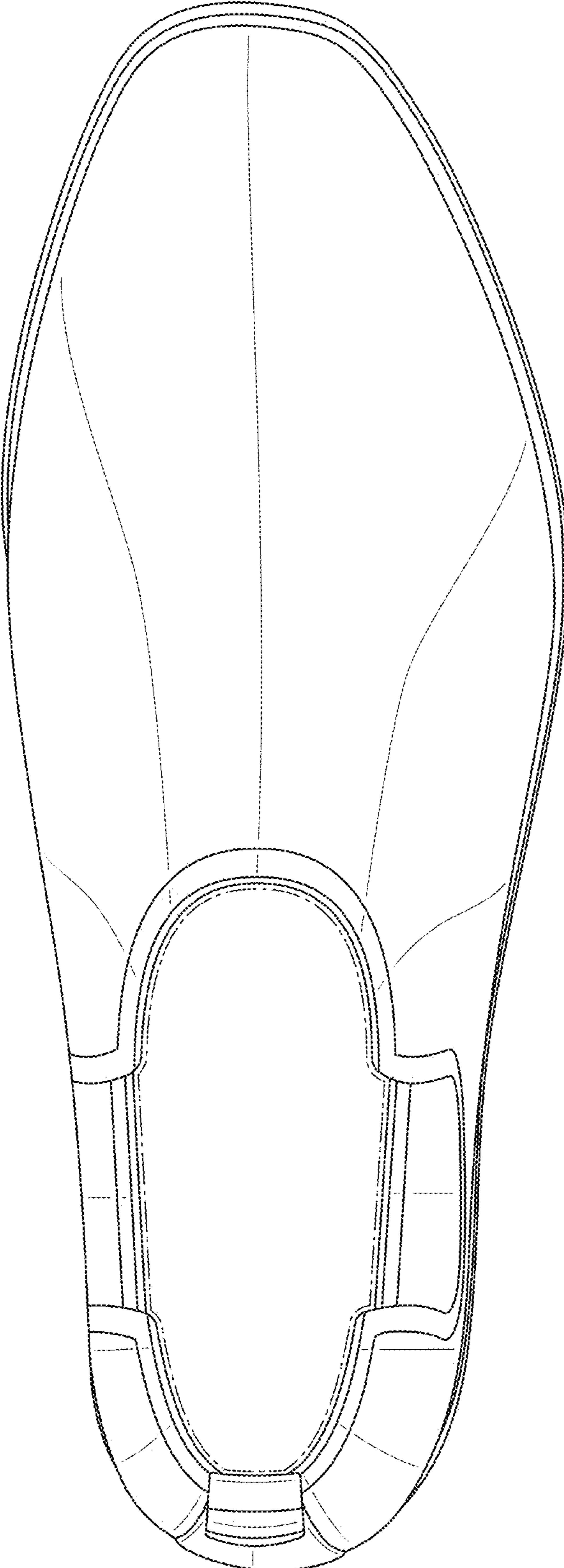

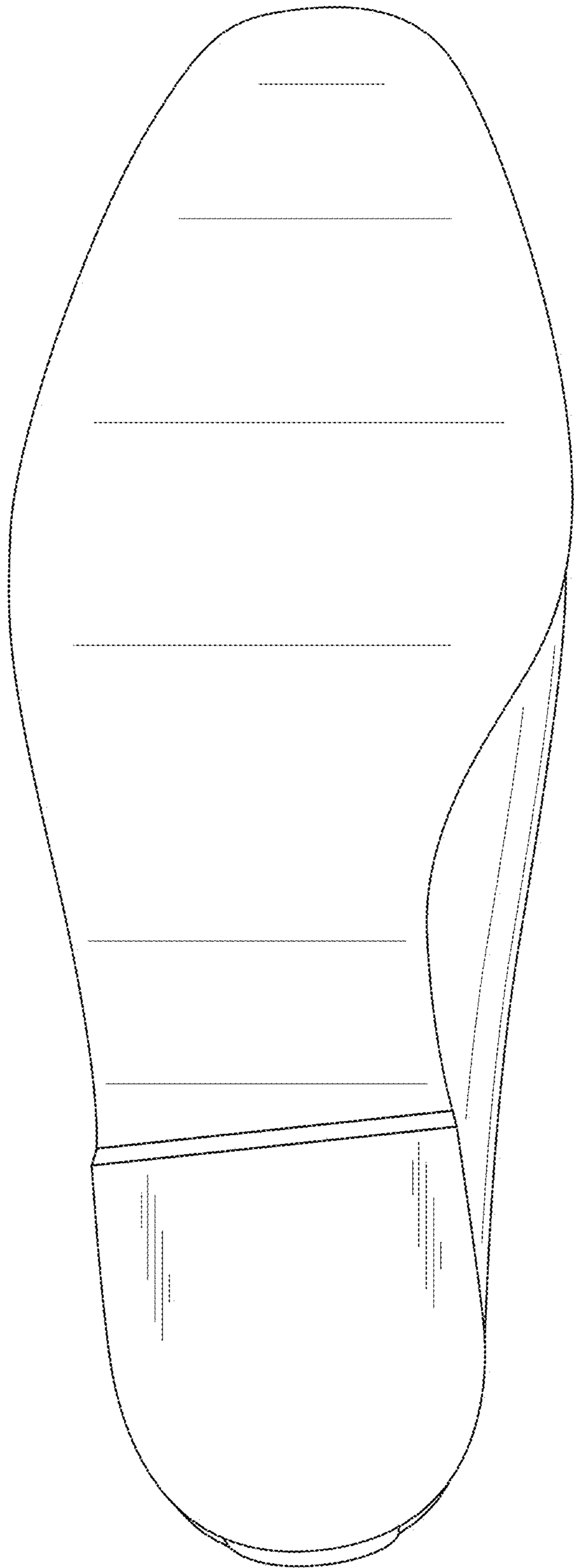
