(57) **CLAIM**

The ornamental design for a handbag, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a design of a handbag.
FIG. 2 is a bottom view of the design of the handbag of FIG. 1, showing the shoulder strap in an alternate position.
FIG. 3 is a back view of the design of the handbag of FIG. 1.
FIG. 4 is a left side view of the design of the handbag of FIG. 1.
FIG. 5 is a right side view of the design of the handbag of FIG. 1; and,
FIG. 6 is a top view of the design of the handbag of FIG. 1. FIG. 2 shows an alternate position of the shoulder strap in the claimed design.

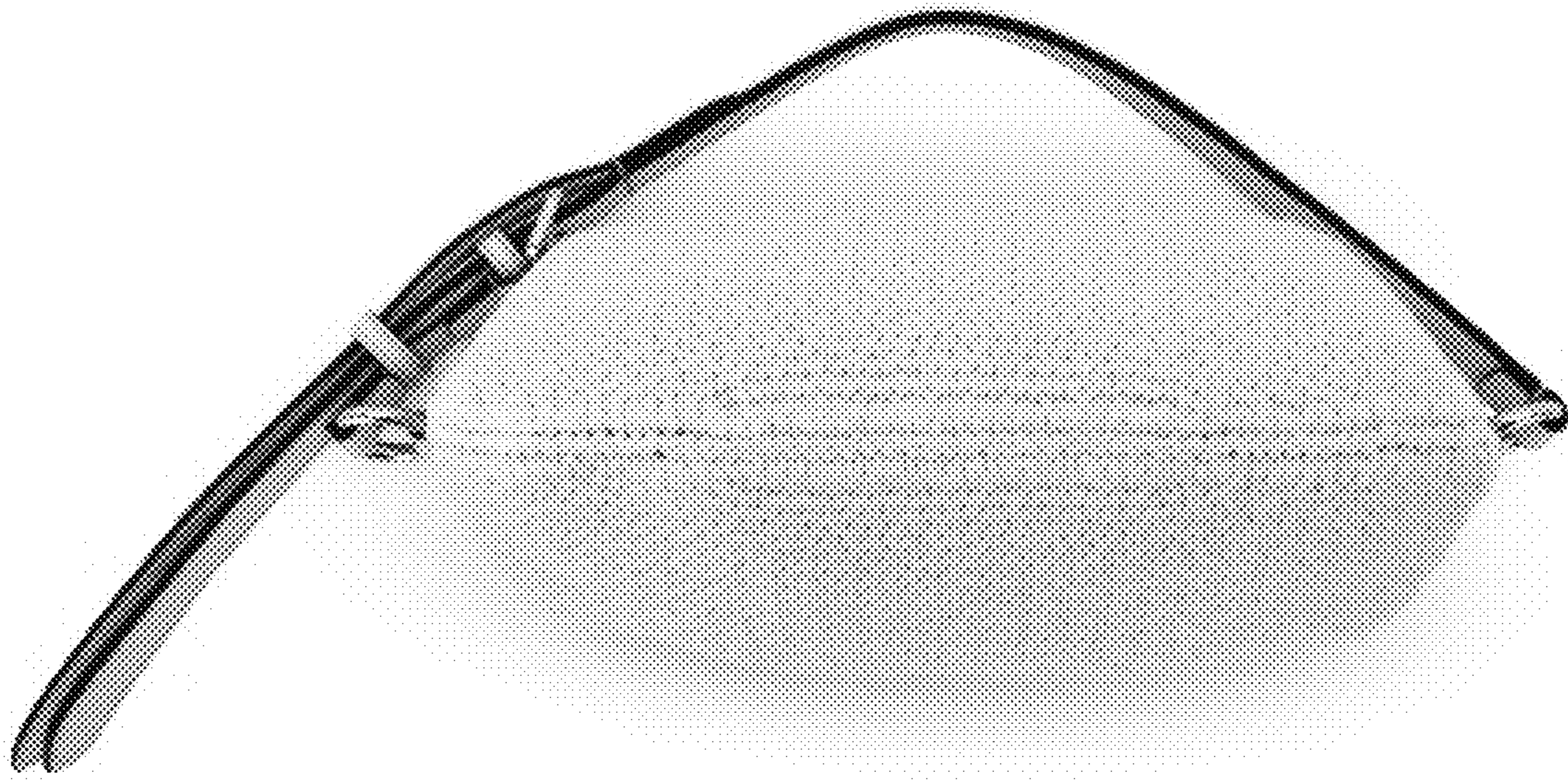
