The ornamental design for a floor mat brush, as shown and described.

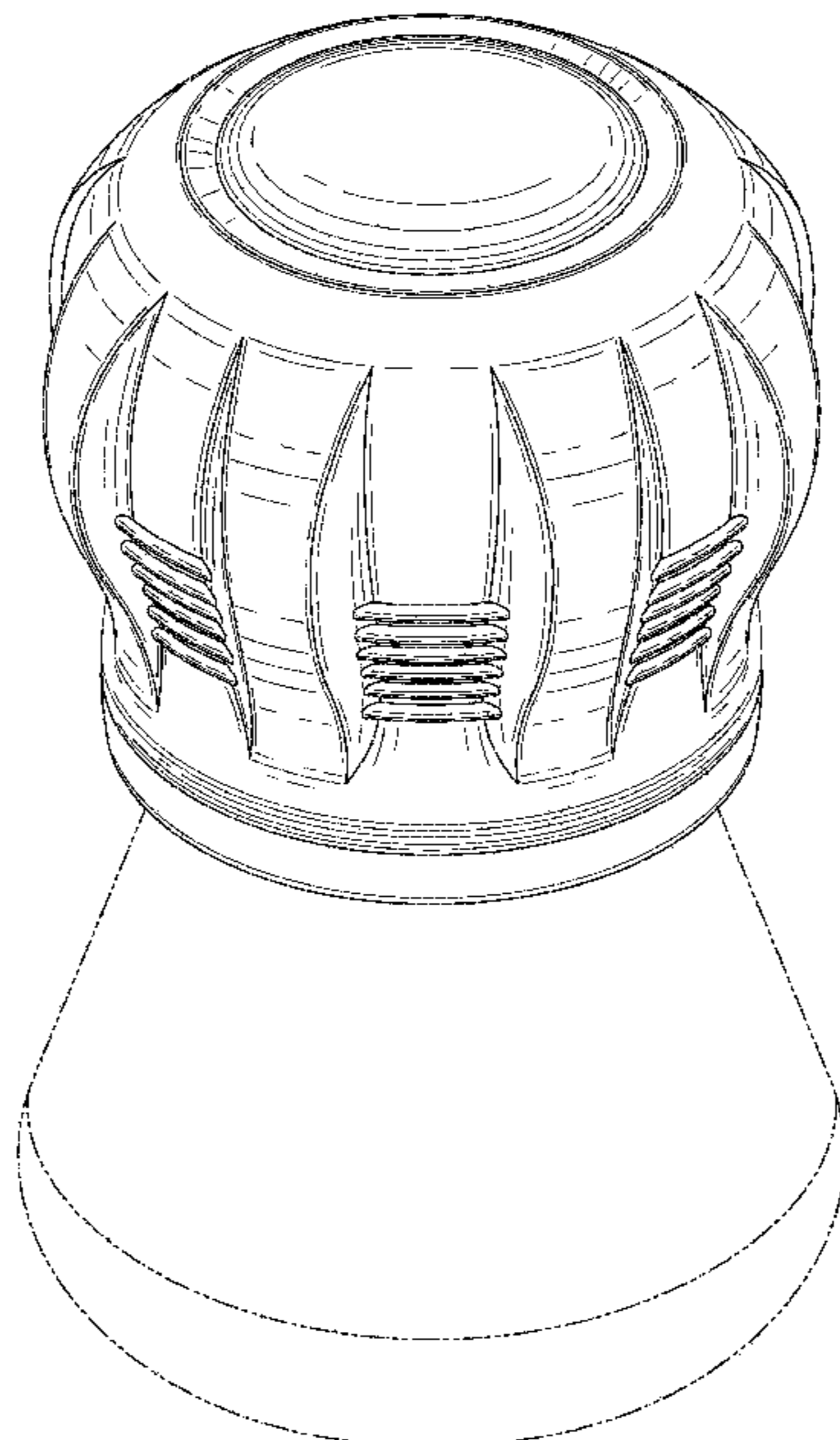
DESCRIPTION

FIG. 1 is a perspective view of a floor mat brush; FIG. 2 is a left side elevational view of the floor mat brush; FIG. 3 is a right side elevational view of the floor mat brush; FIG. 4 is a rear side elevational view of the floor mat brush; FIG. 5 is a front side elevational view of the floor mat brush; FIG. 6 is a top plan view of the floor mat brush; FIG. 7 is a bottom plan view of the floor mat brush; and, FIG. 8 is a perspective bottom view of the floor mat brush. The broken lines illustrate portions of the floor mat brush and form no part of the claimed design.

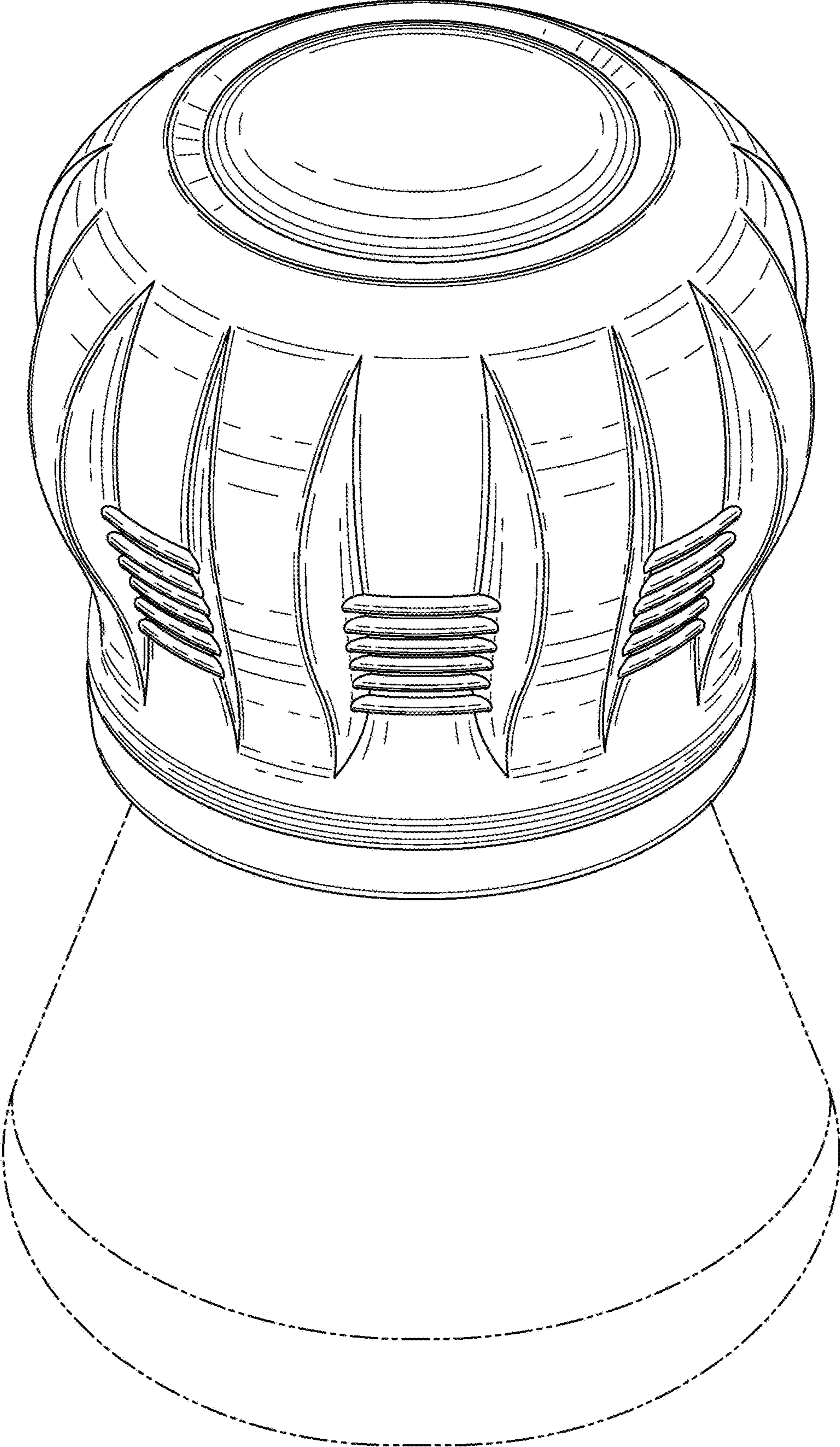

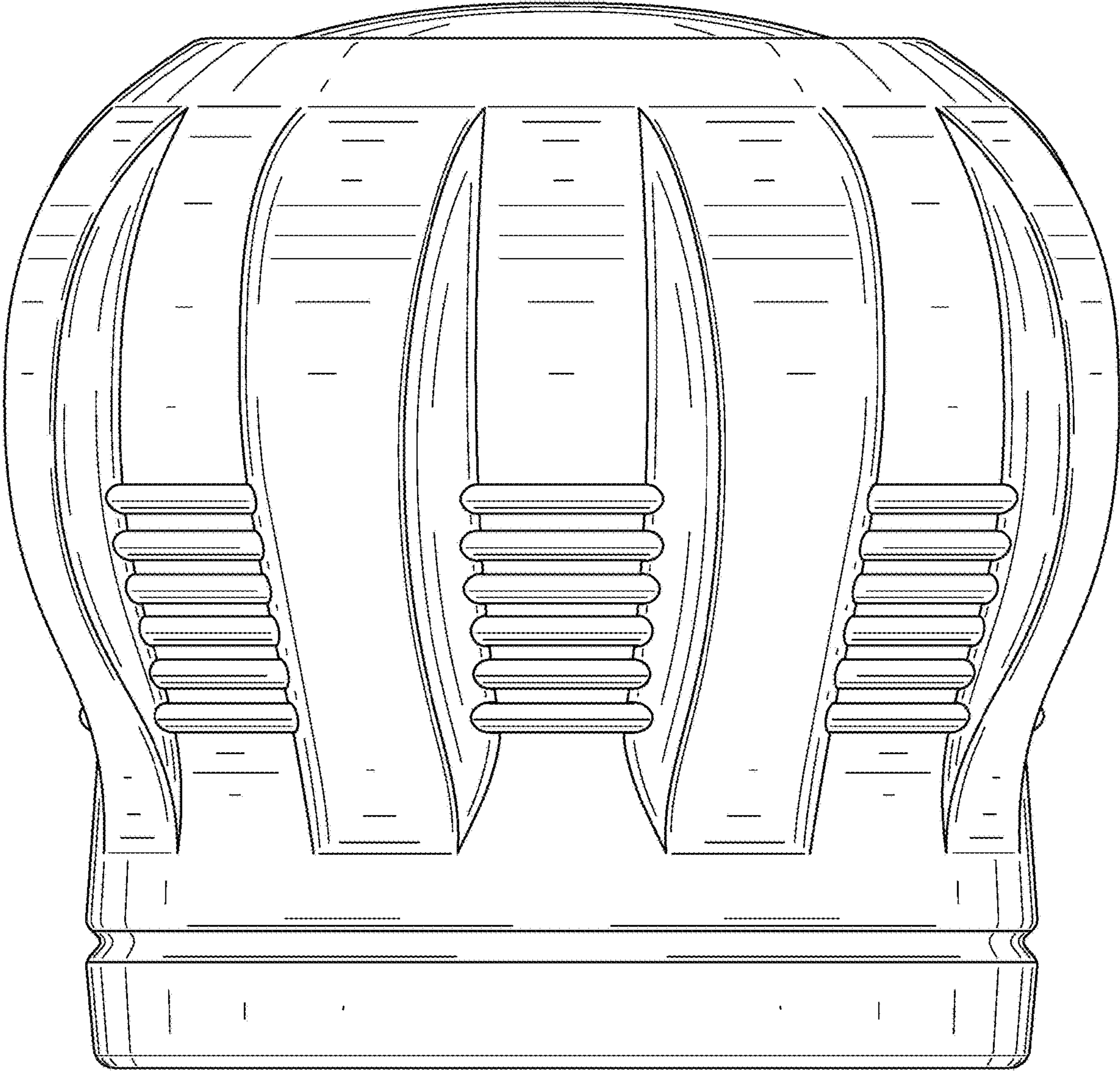

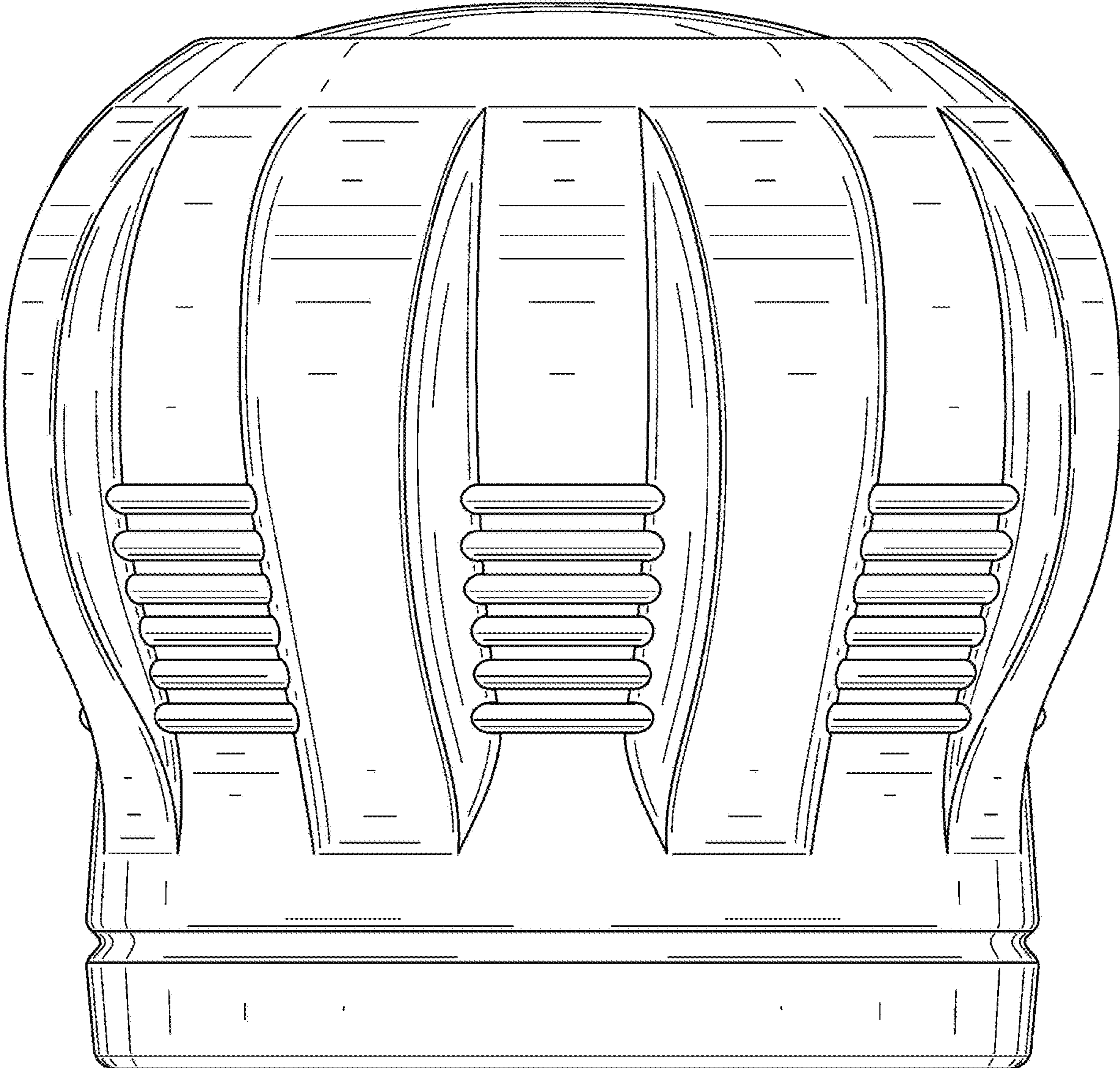

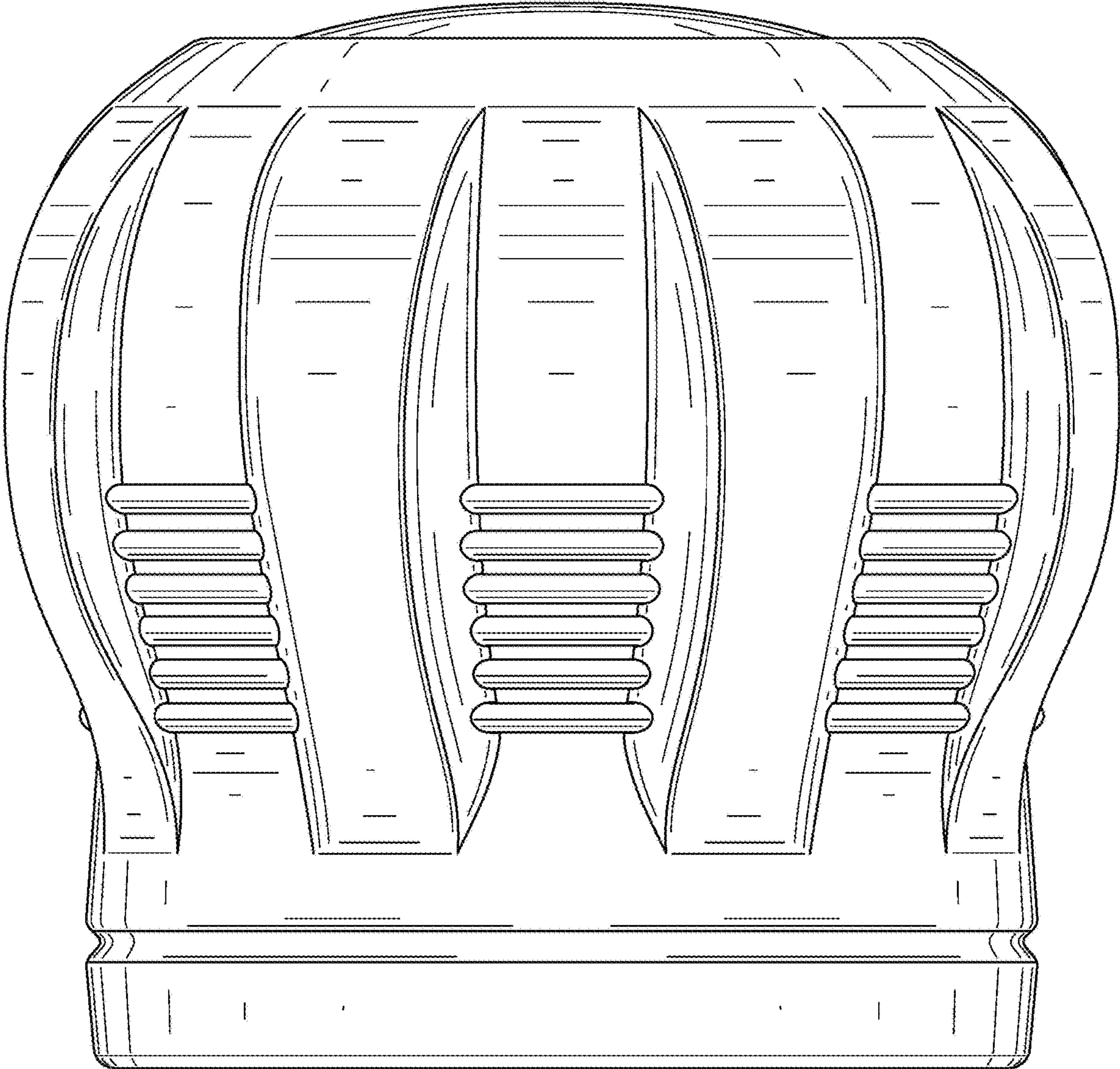

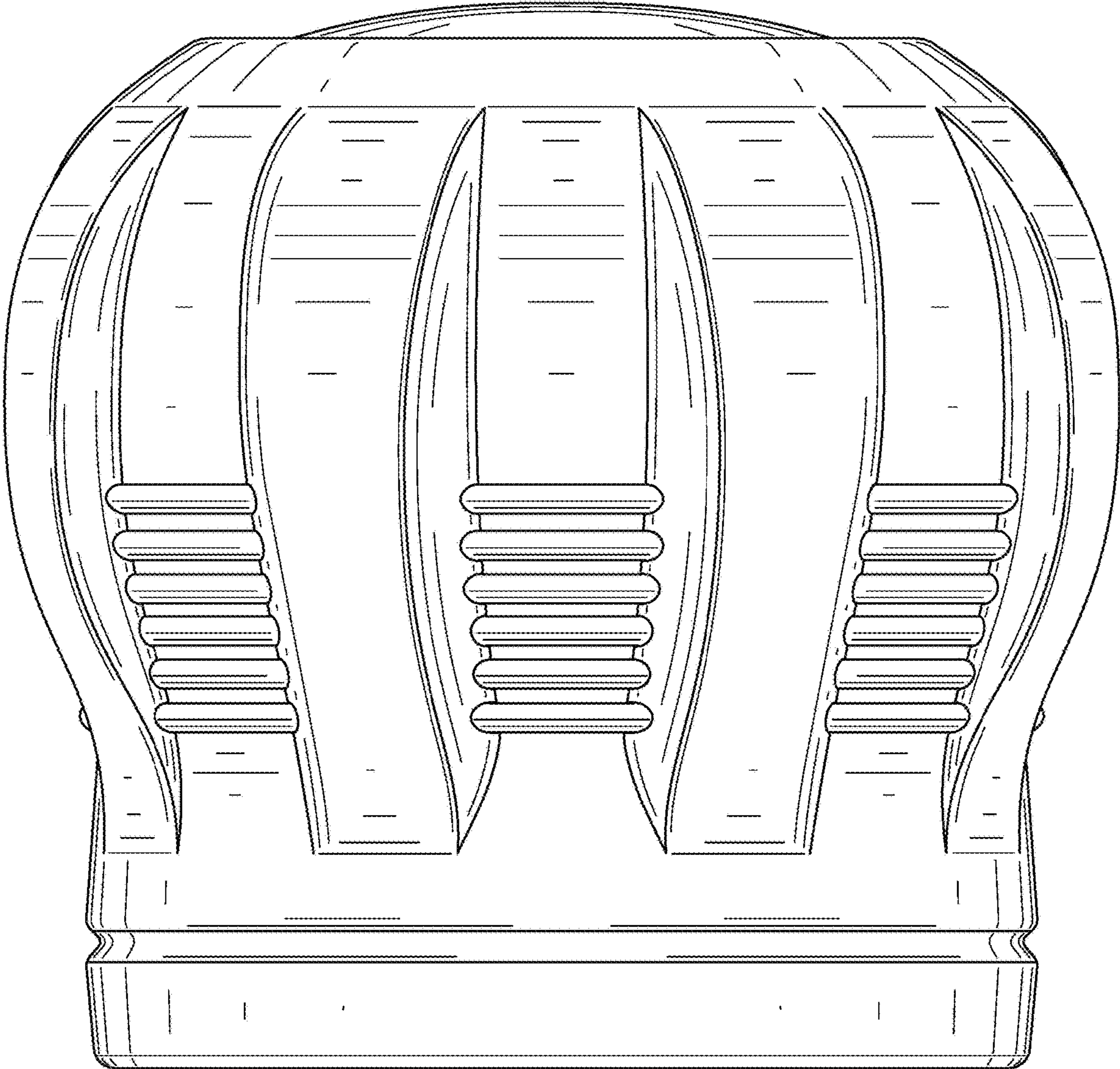

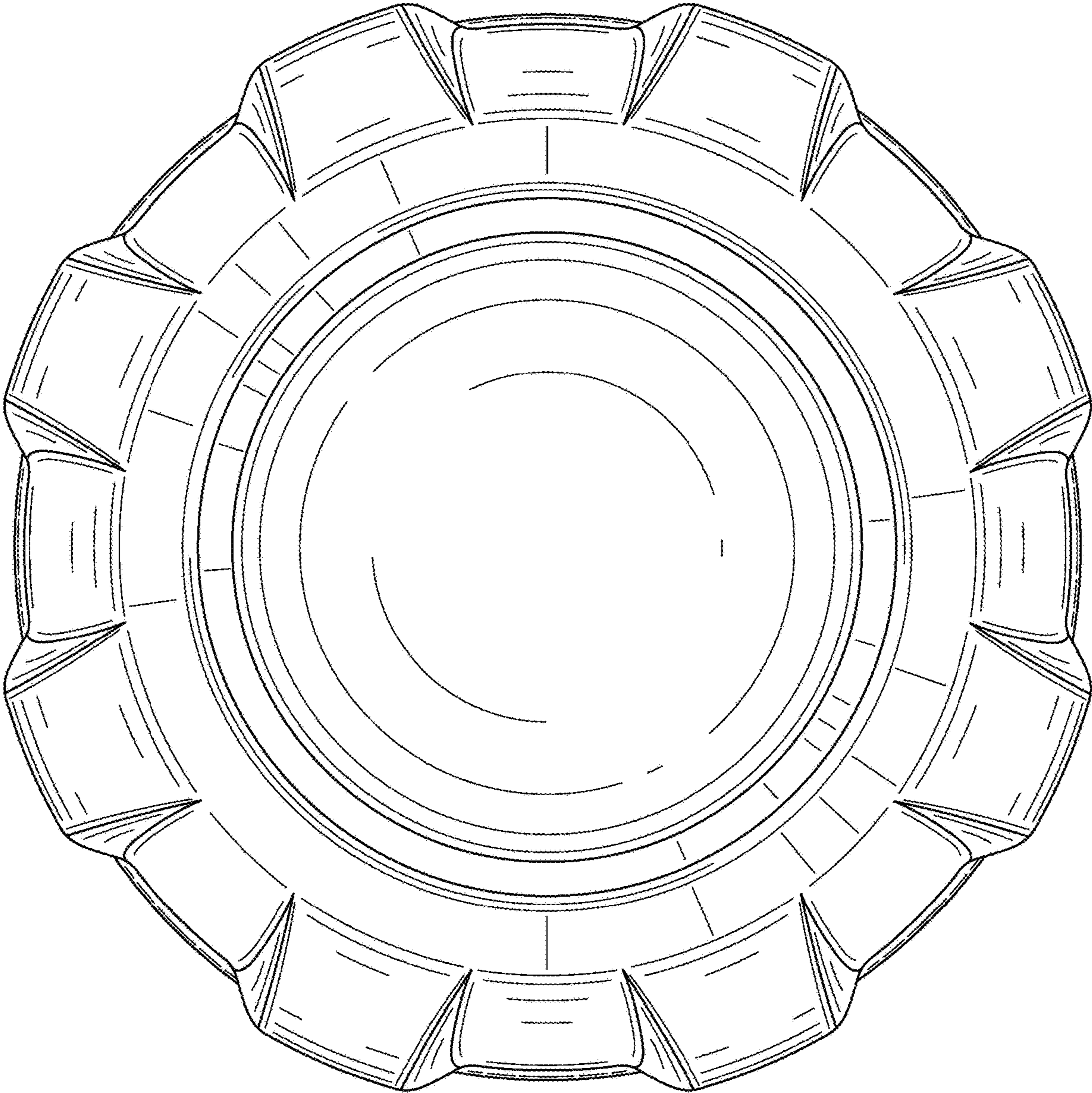

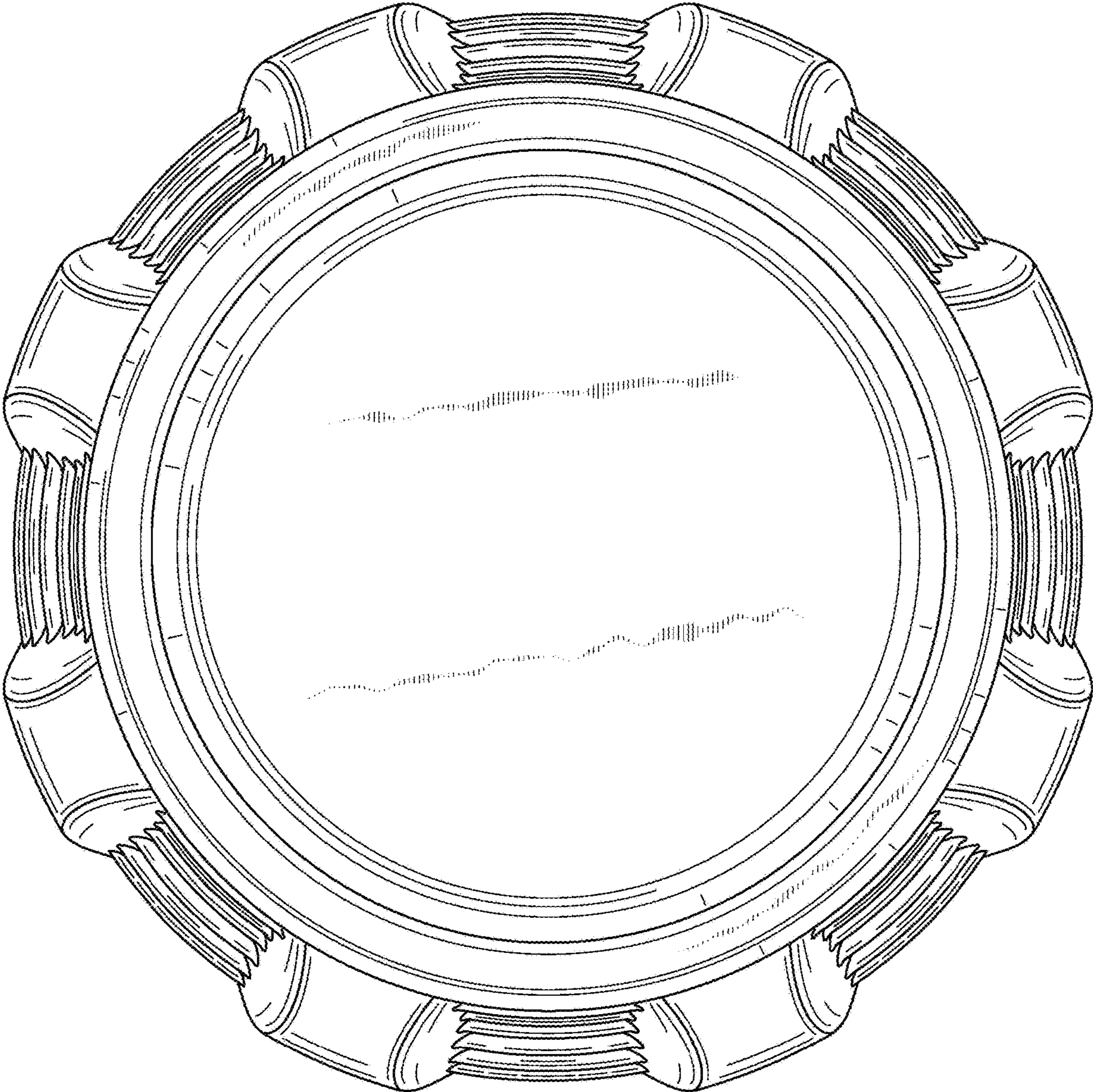

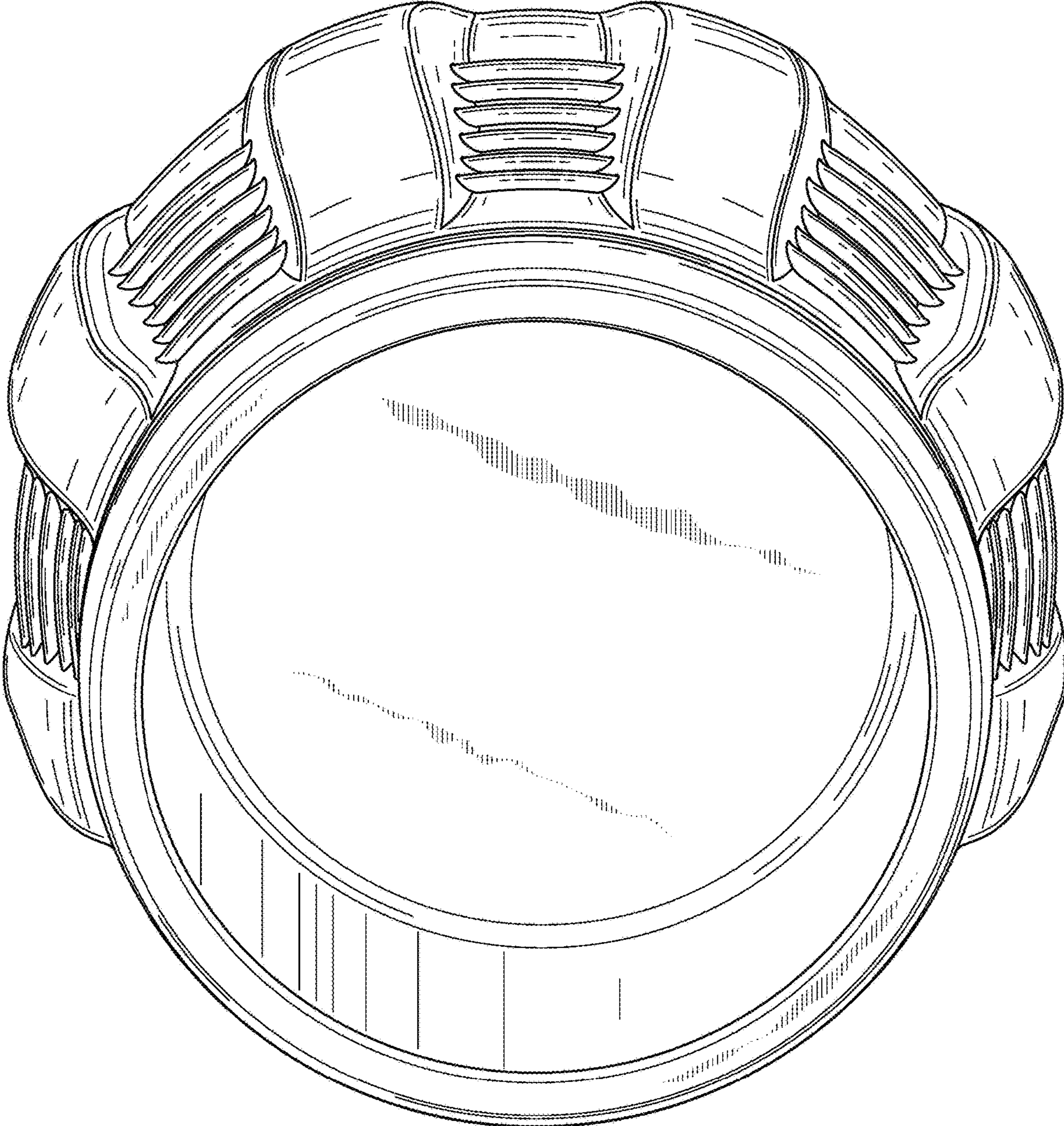
