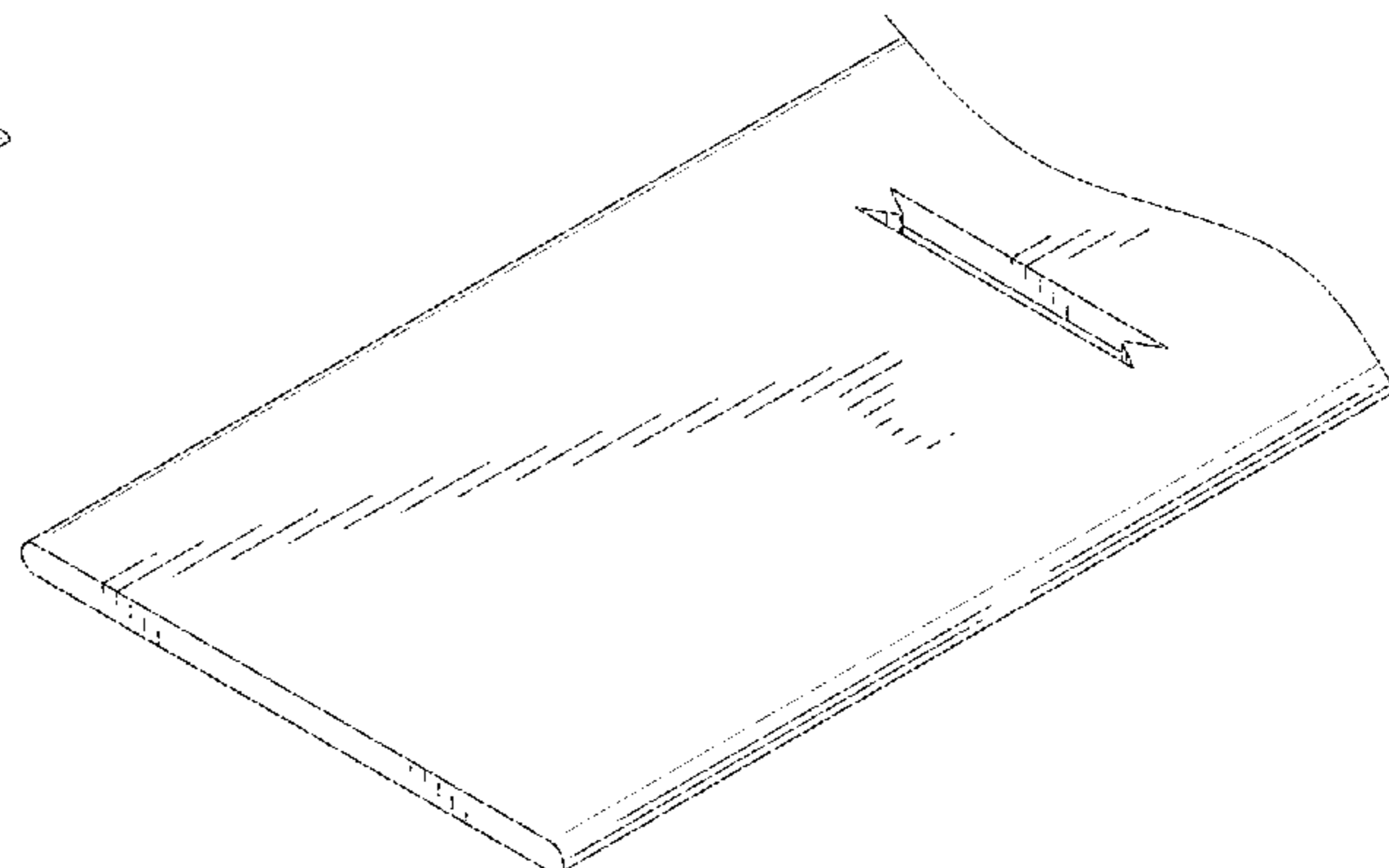
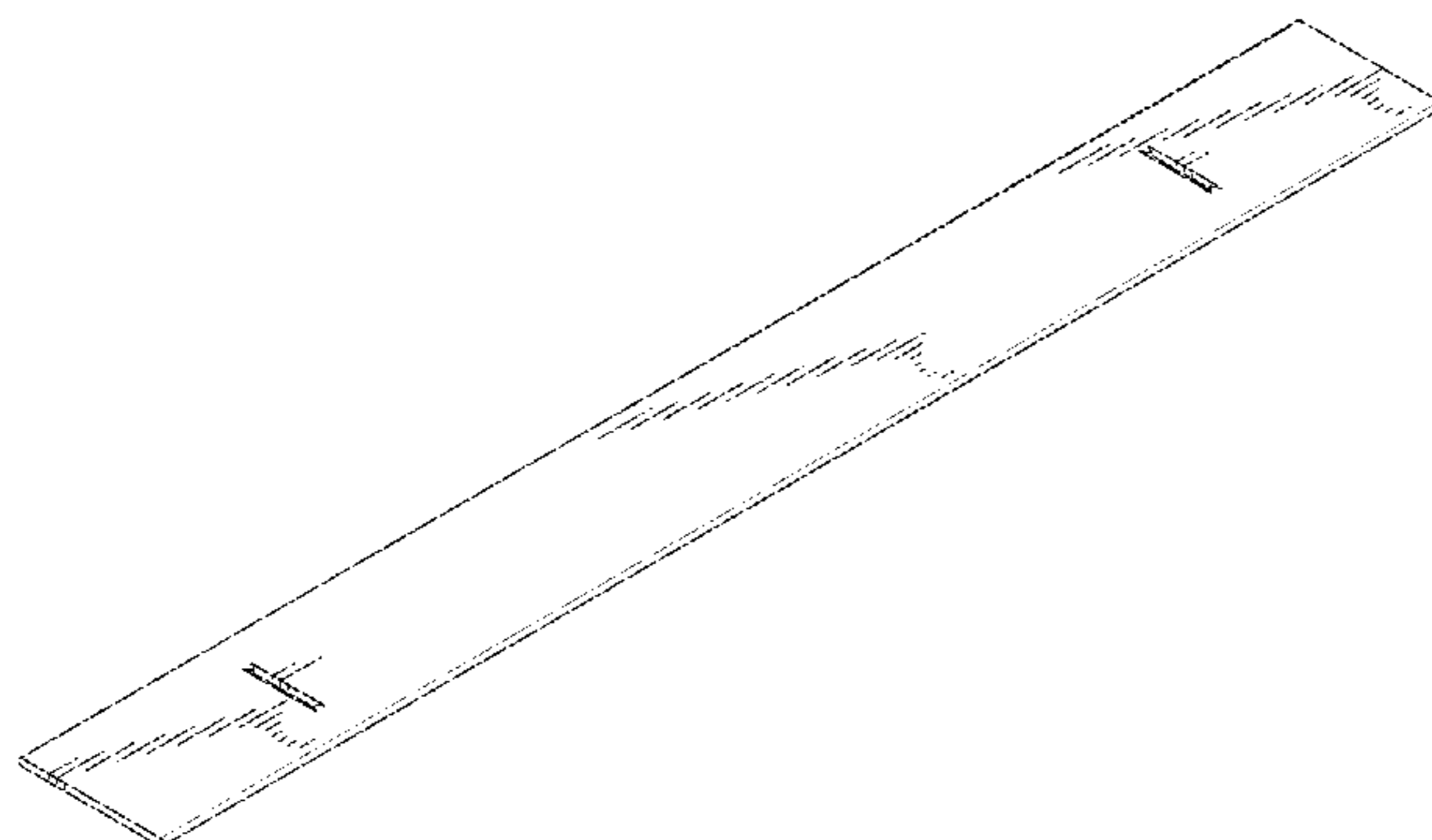
(57) **CLAIM**

The ornamental design for a venetian blind slat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a venetian blind slat, showing the new design;
FIG. 2 is a front view thereof, the rear side being an identical image;
FIG. 3 is a left side elevational view thereof, the right side being an identical image;
FIG. 4 is a top plan view thereof, the bottom side being an identical image; and,
FIGS. 5 and 6 are enlarged, broken away perspective views of the venetian blind slat in different viewing angles, respectively.

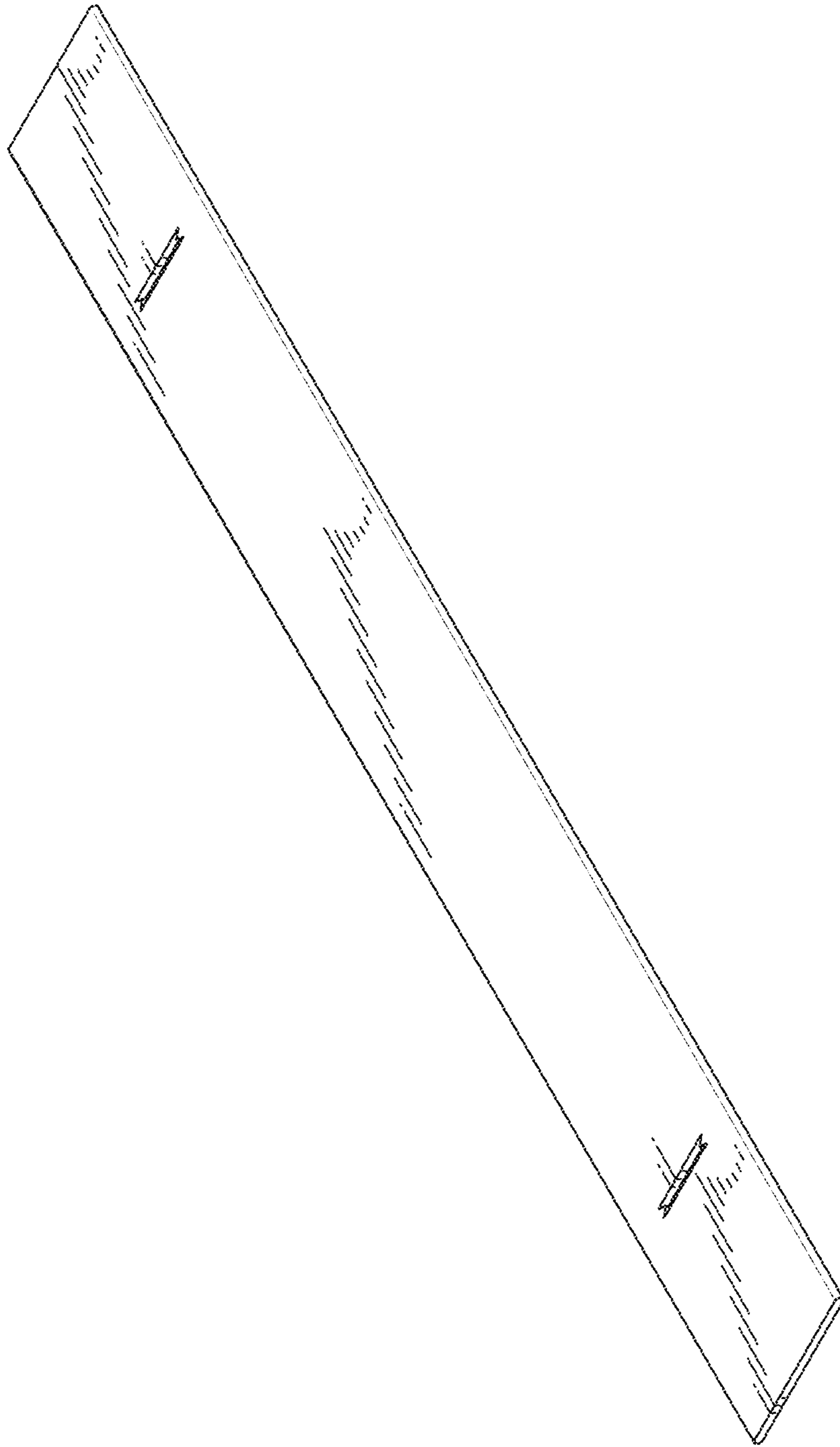

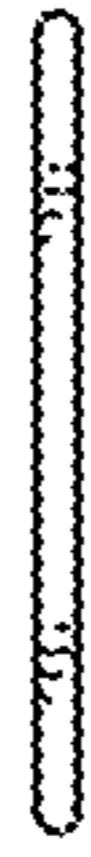

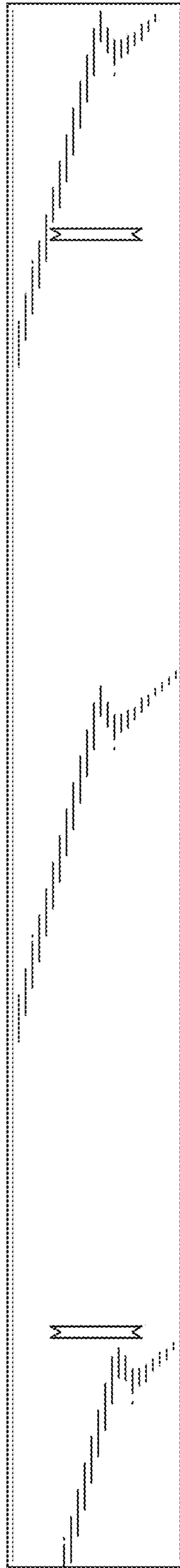

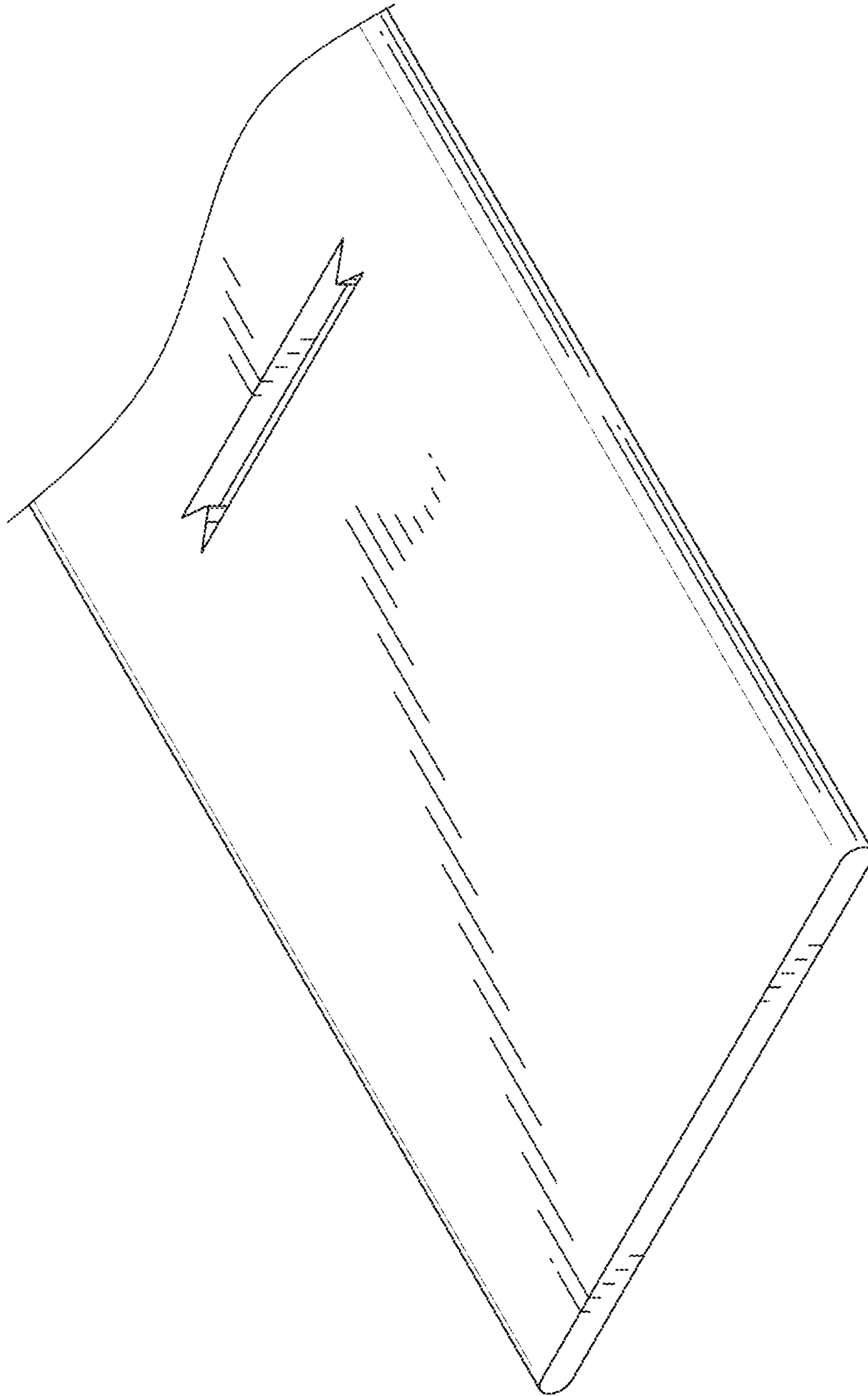

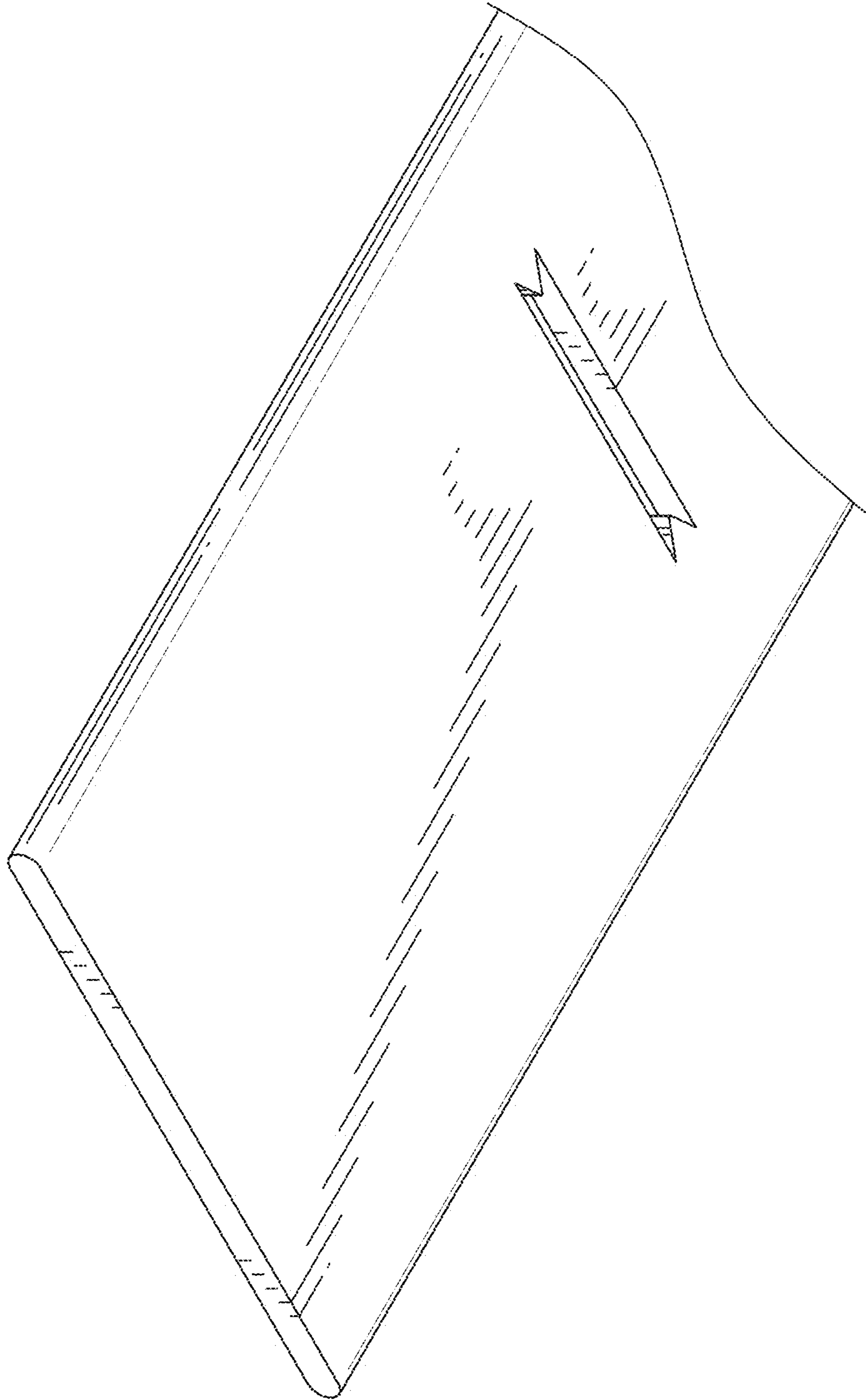
