(57) **CLAIM**

The ornamental design for a beverage container, as shown and described.

DESCRIPTION

FIG. 1 is a top isometric view of a beverage container showing the design.

FIG. 2 is a side elevation view of the beverage container of FIG. 1, with the other side views being symmetrical thereto.

FIG. 3 is a top plan view of the beverage container of FIG. 1.

FIG. 4 is a bottom plan view of the beverage container of FIG. 1.

FIG. 5 is a bottom isometric view of the beverage container of FIG. 1; and,

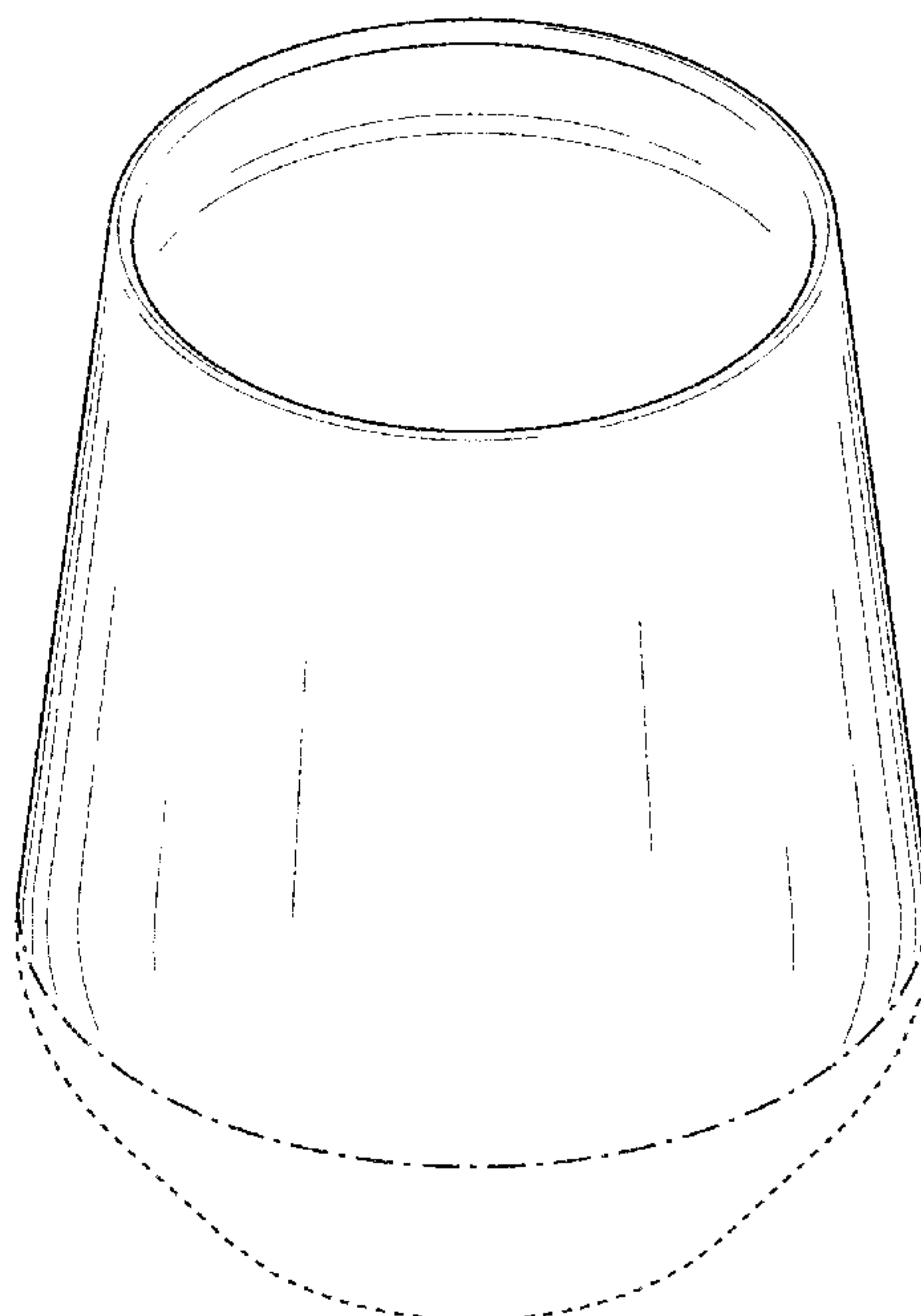
FIG. 6 is a cross-sectional view of the beverage container of FIG. 1 showing a section taken along line 6-6 of FIG. 2.

The dashed lines in the drawings illustrate portions of the beverage container that form no part of the claimed design.

The shading lines shown in the drawings represent the approximate three-dimensional contour of the claimed design and are not intended to indicate surface decoration.

The dash-dot broken lines in FIGS. 1-2 and 5-6 depict the boundary of the claim and form no part thereof.

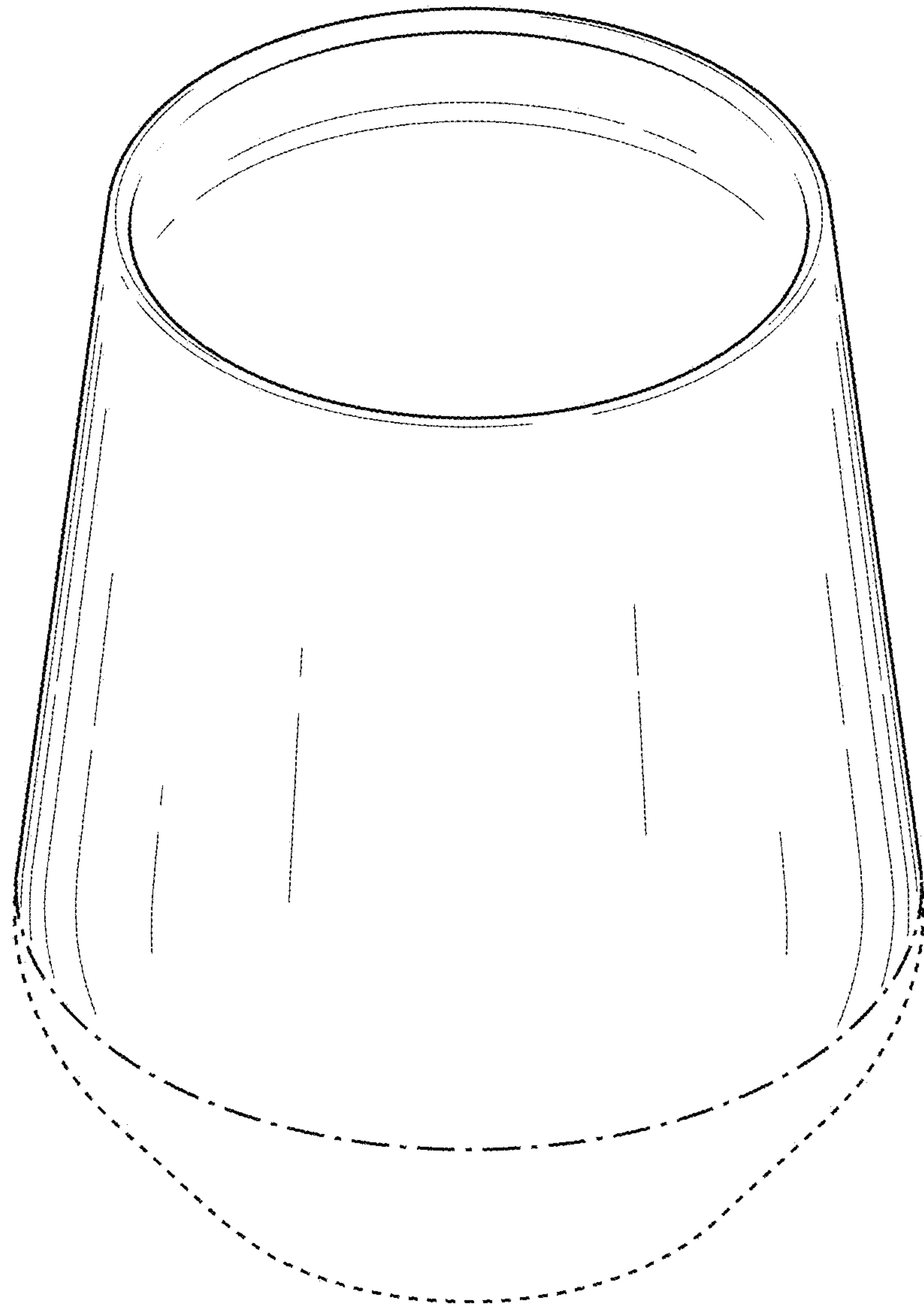

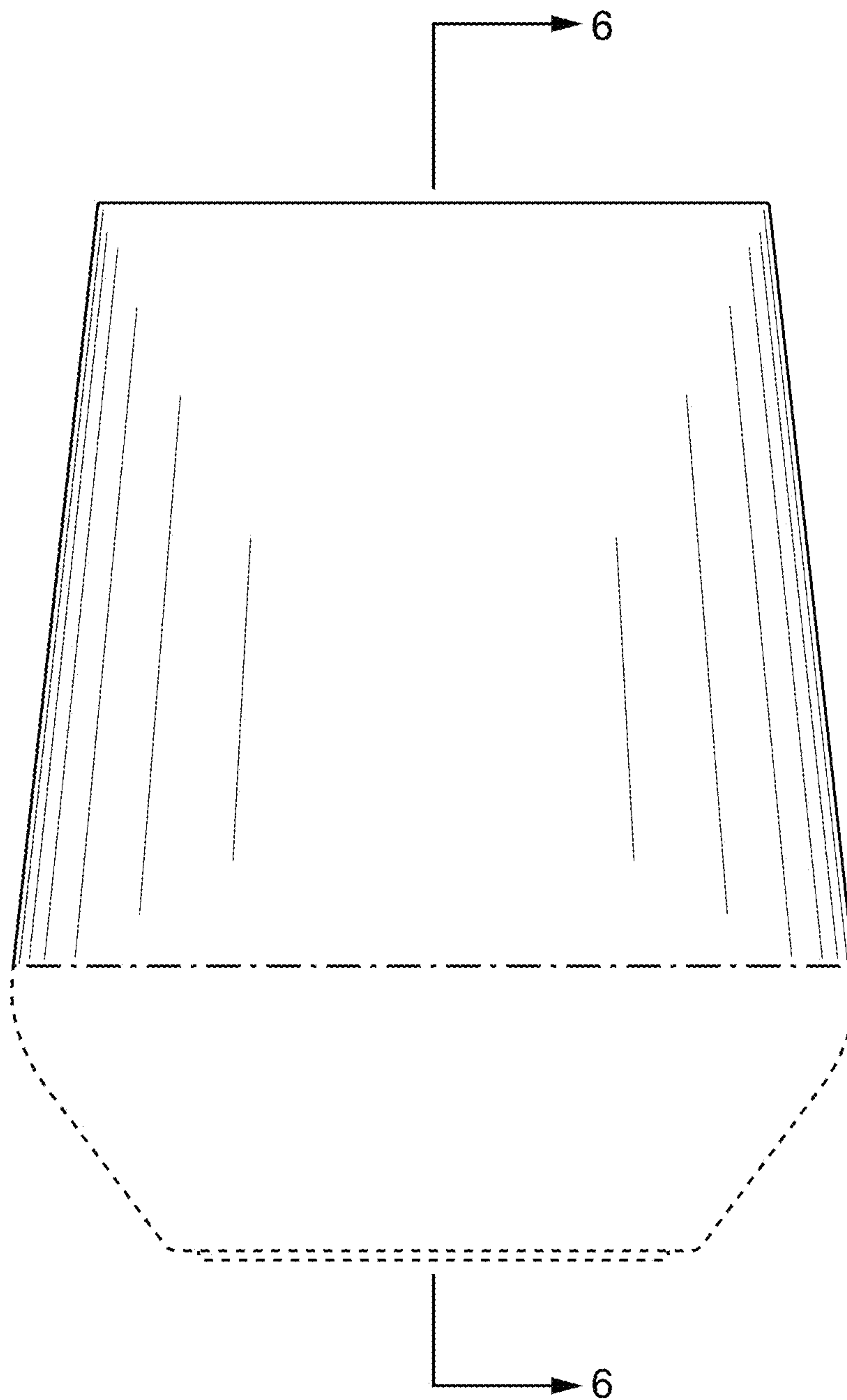

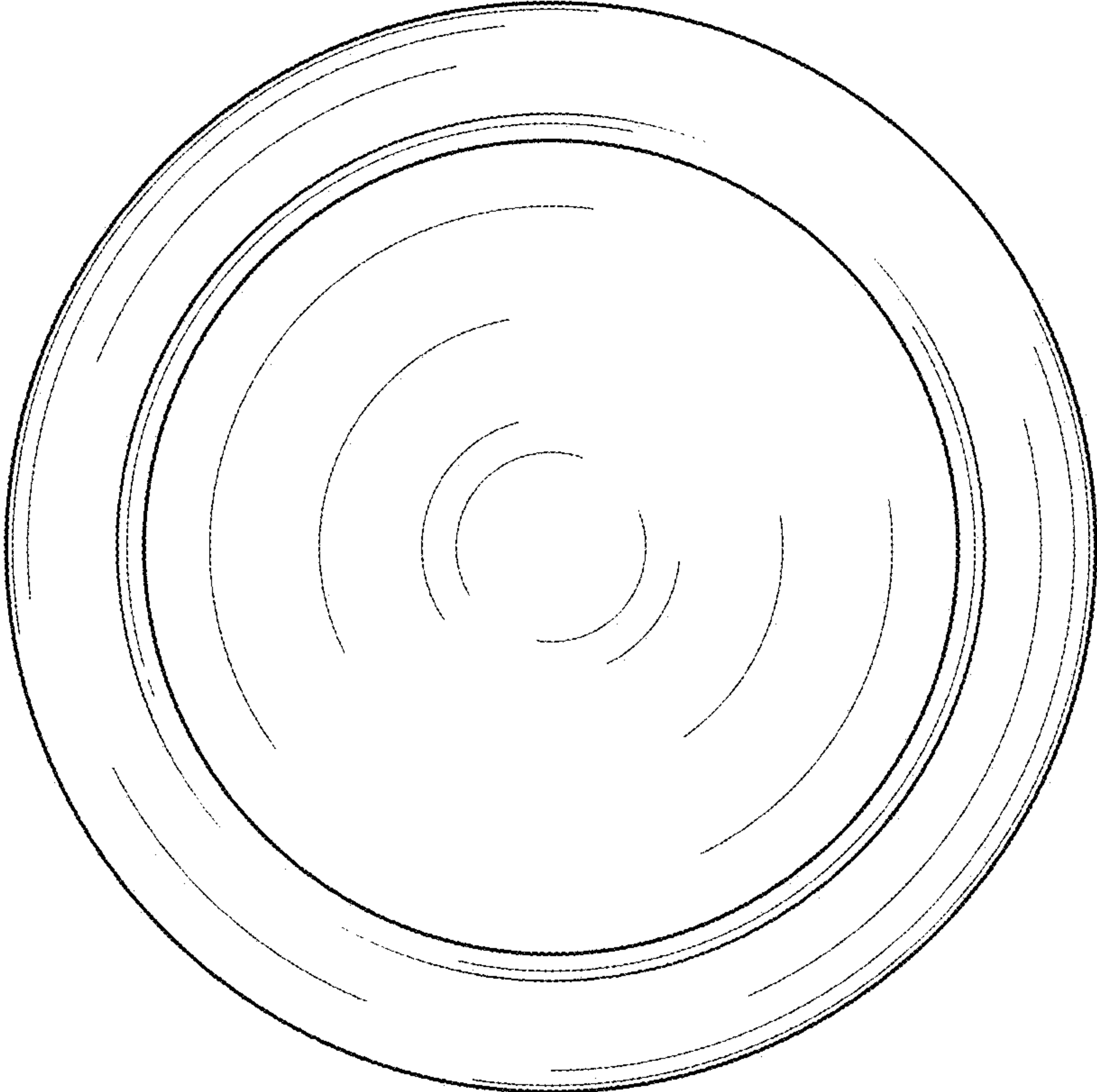

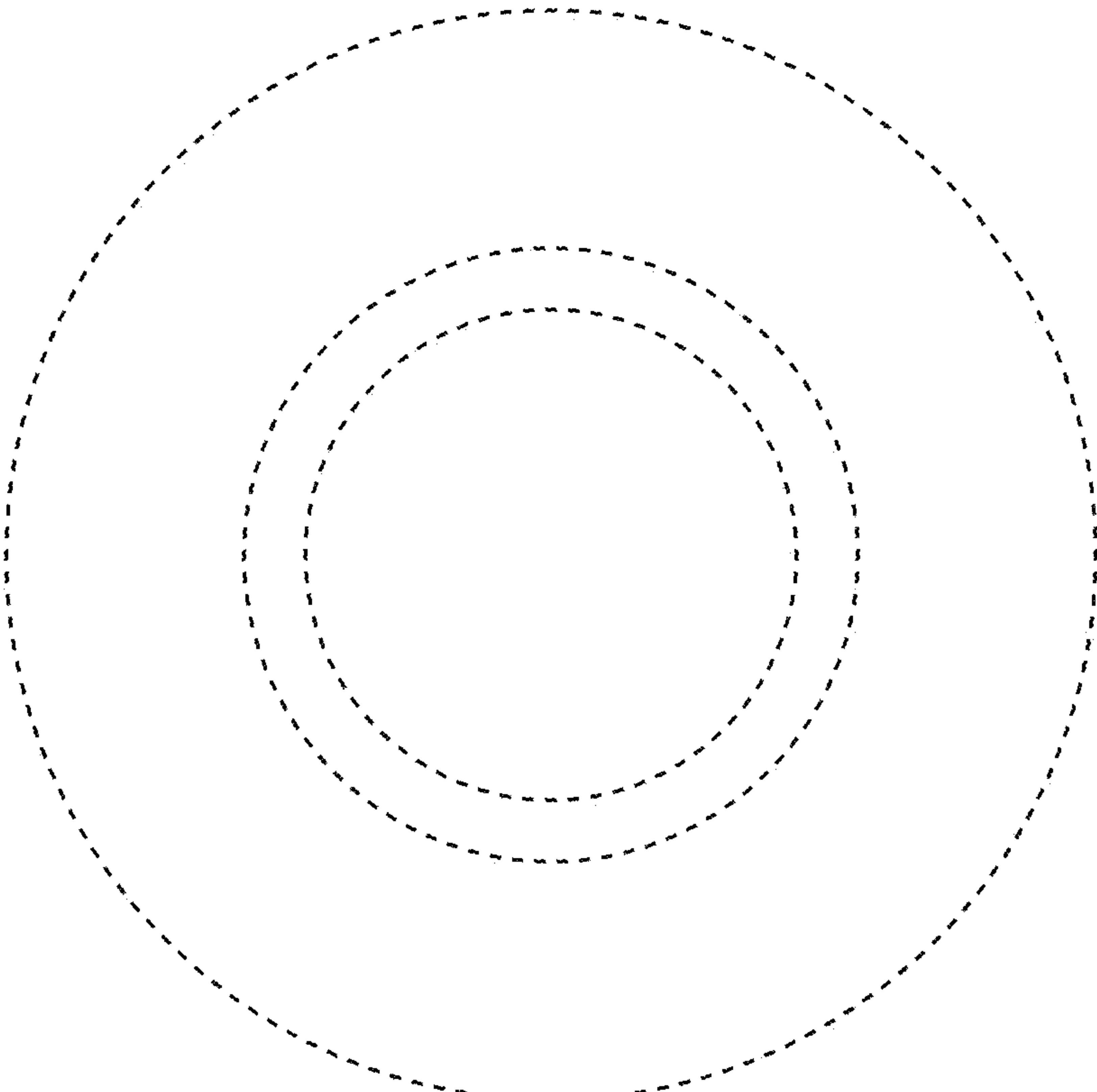

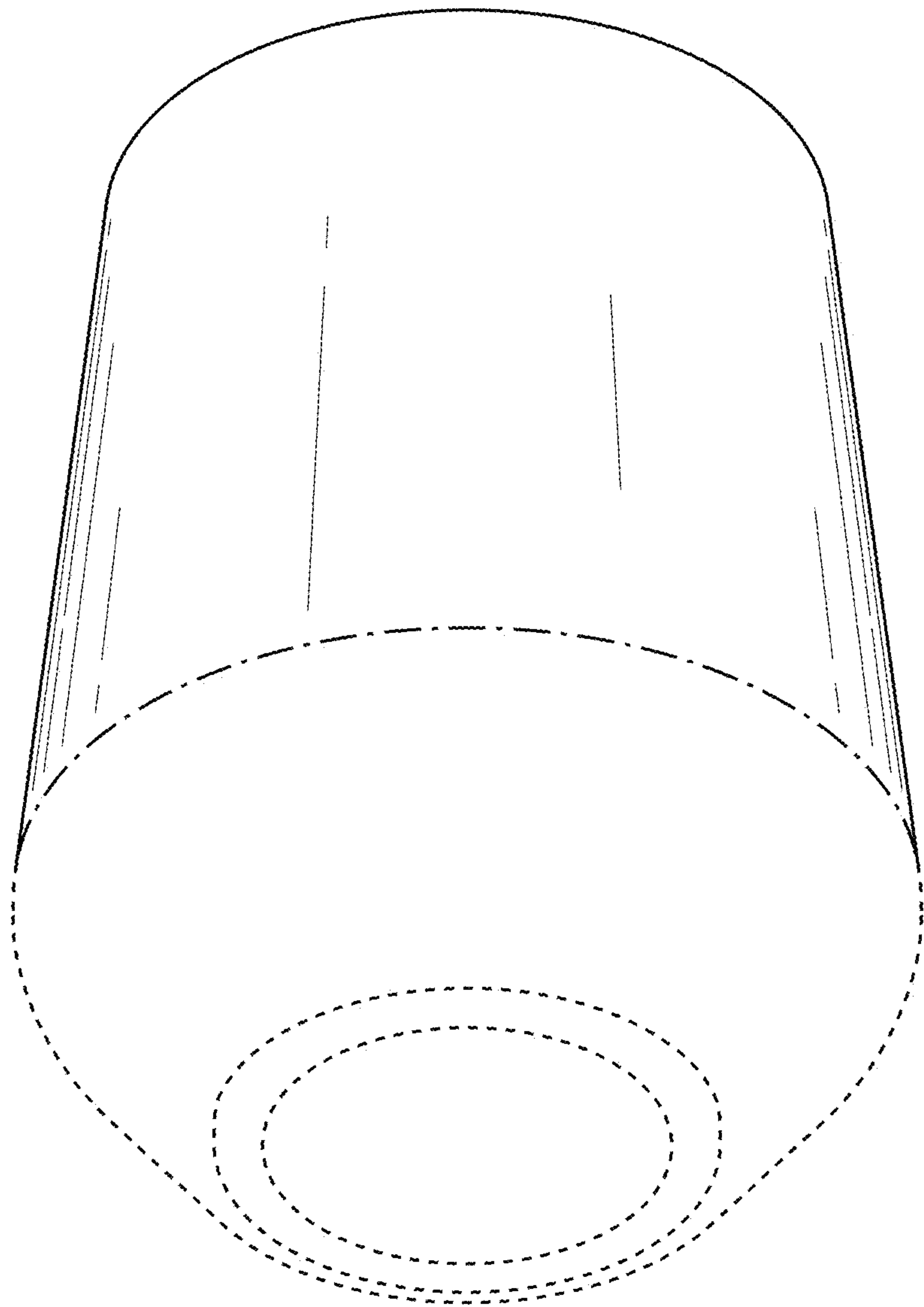

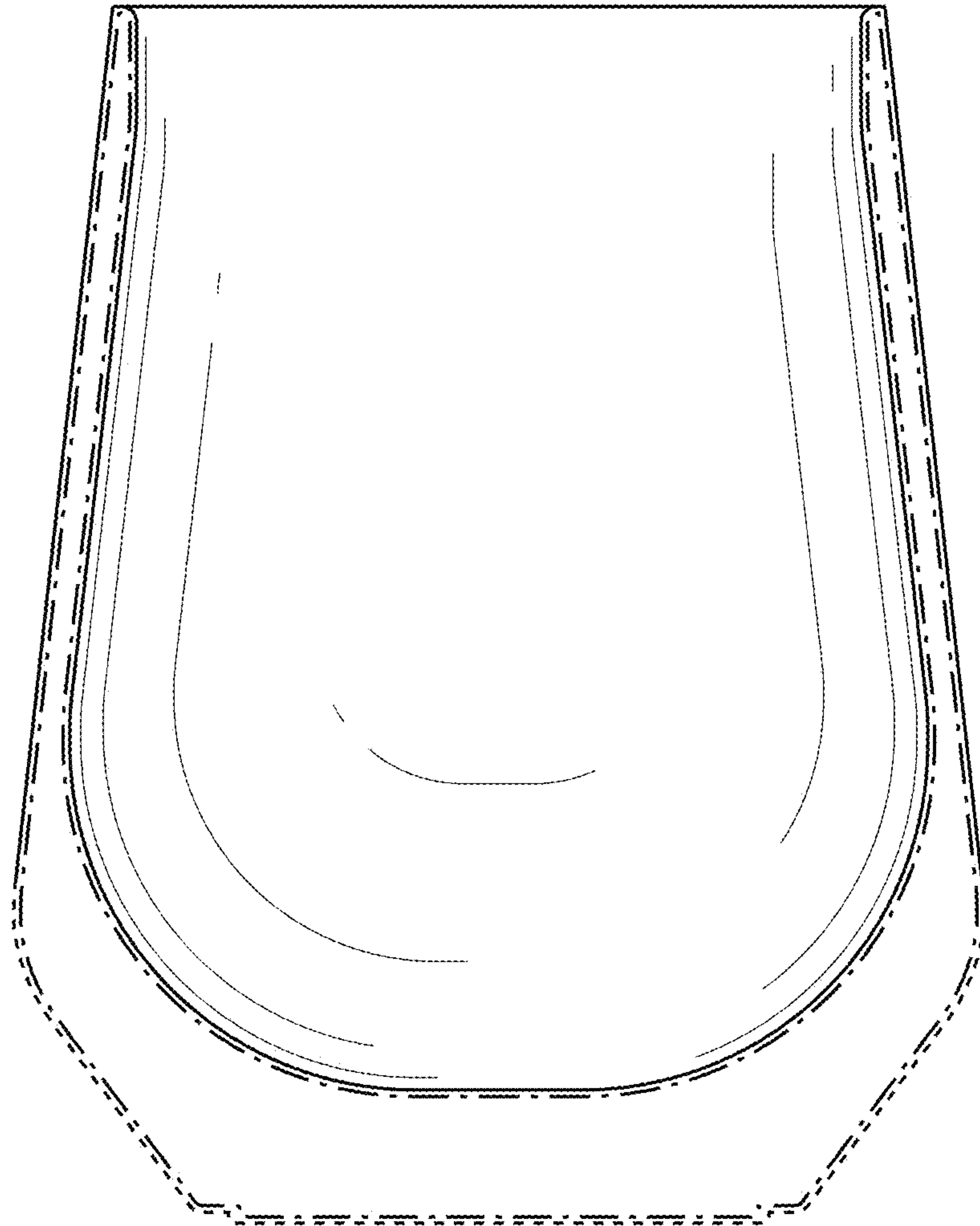
