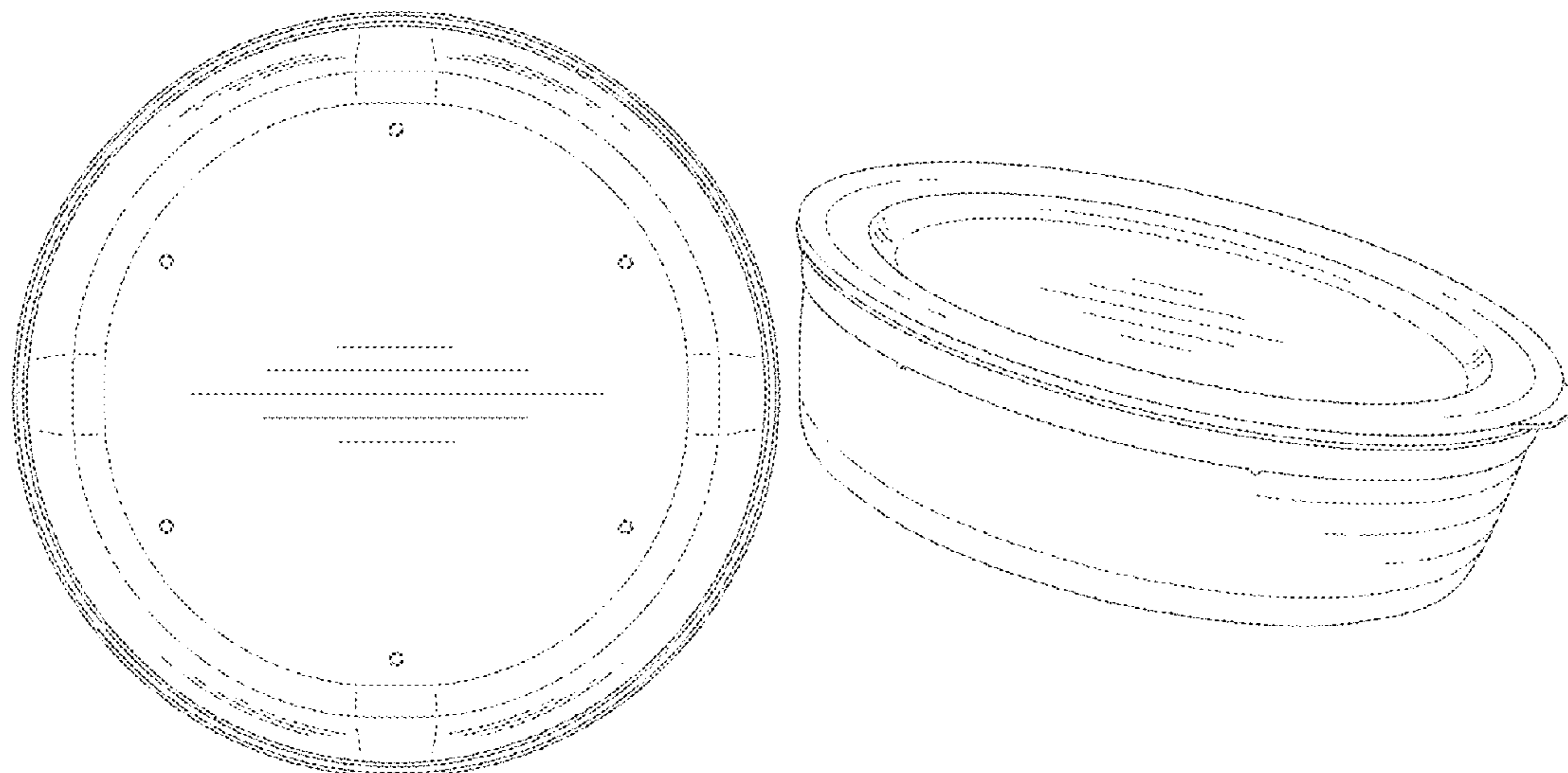
(57) **CLAIM**

DESCRIPTION

FIG. 1.1 is a bottom view of a bowl with lid in a state with no lid on;
FIG. 1.2 is a top view of the bowl with lid in a state with no lid on;
FIG. 1.3 is a side view of the bowl with lid in a state with no lid on;
FIG. 1.4 is an isometric view of the bowl with lid in a state with no lid on; and

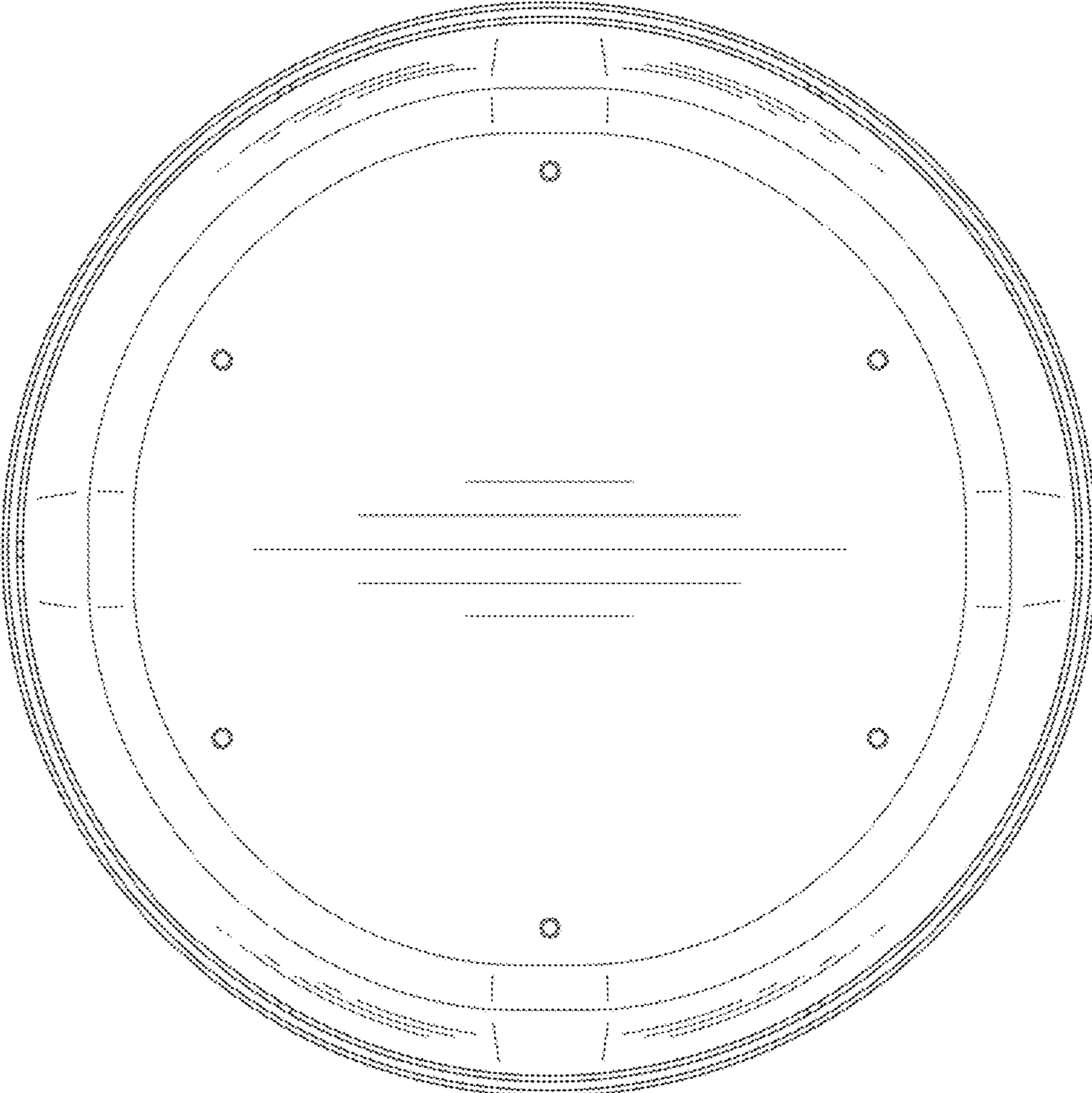

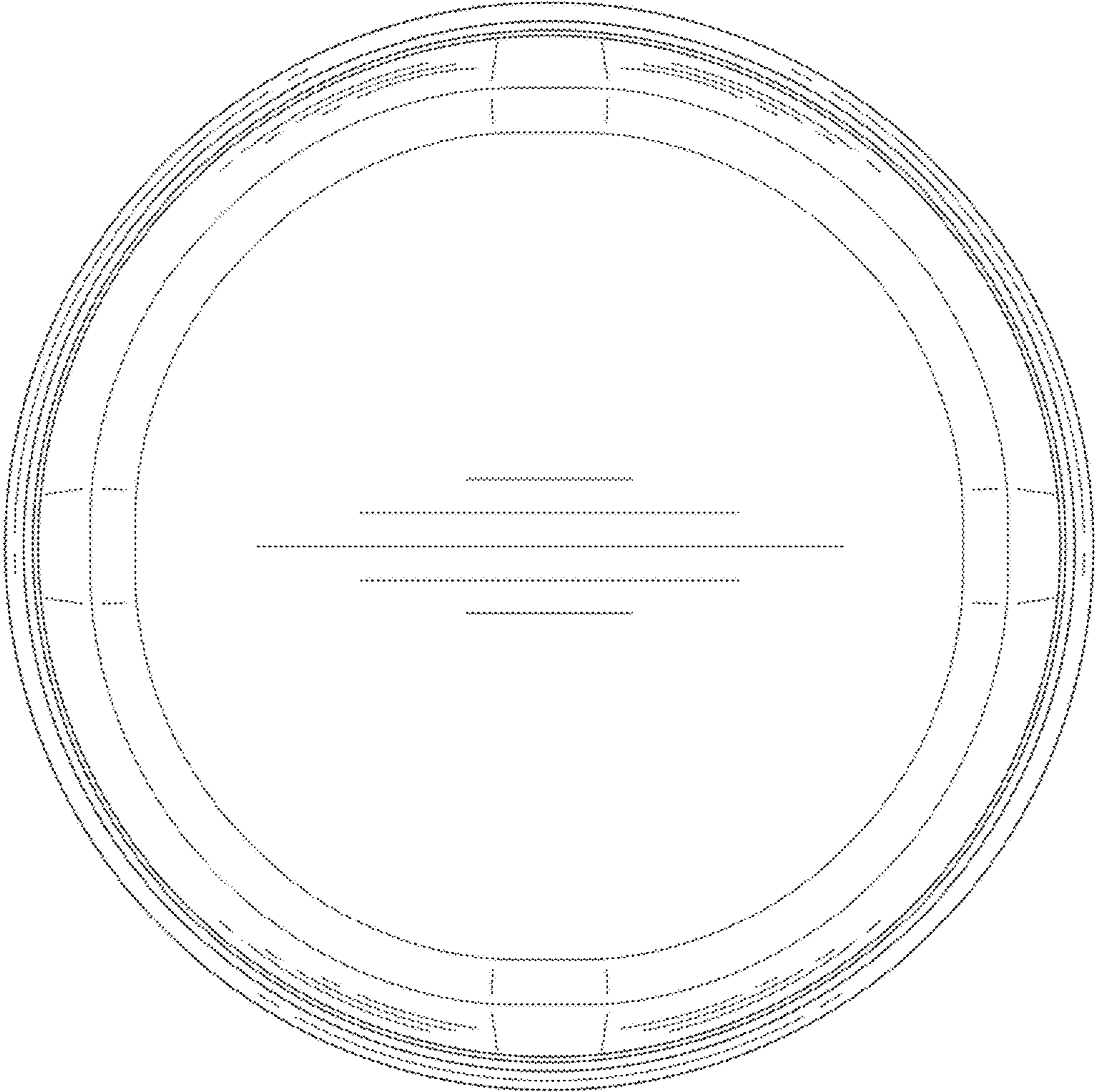

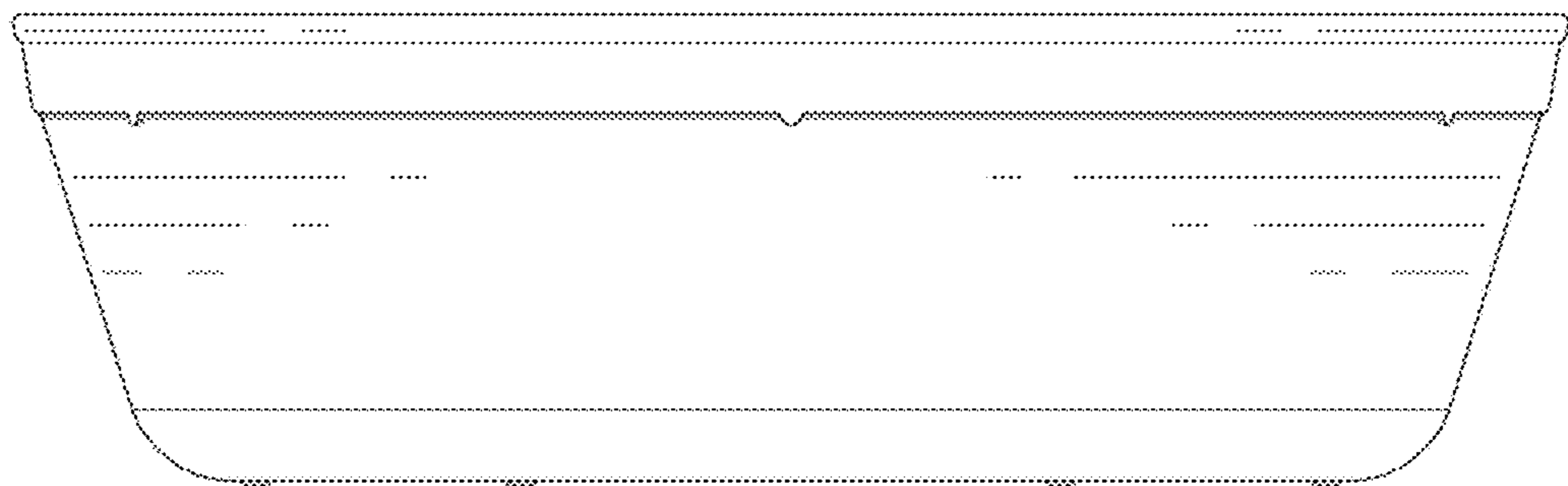

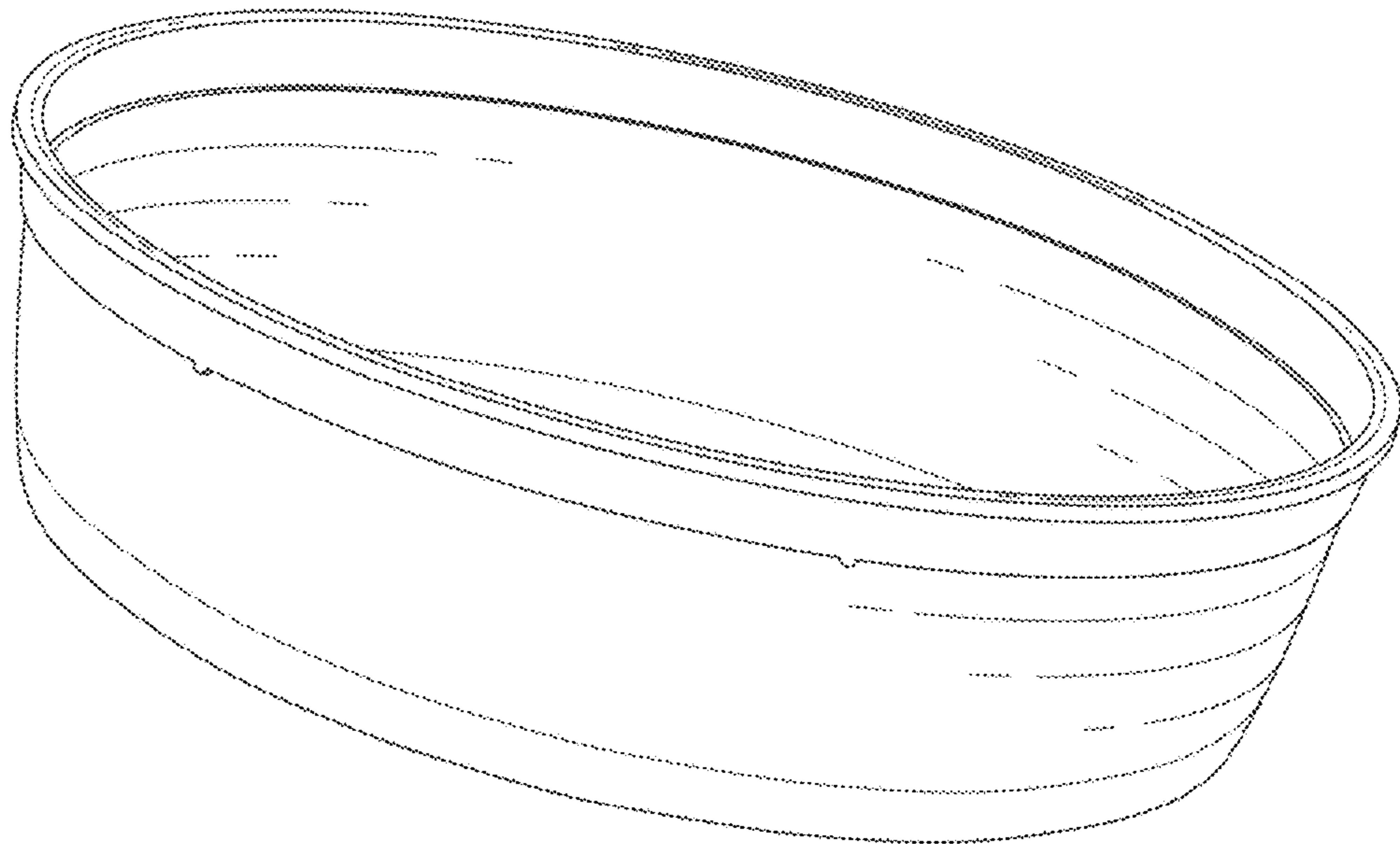
