**DESCRIPTION**

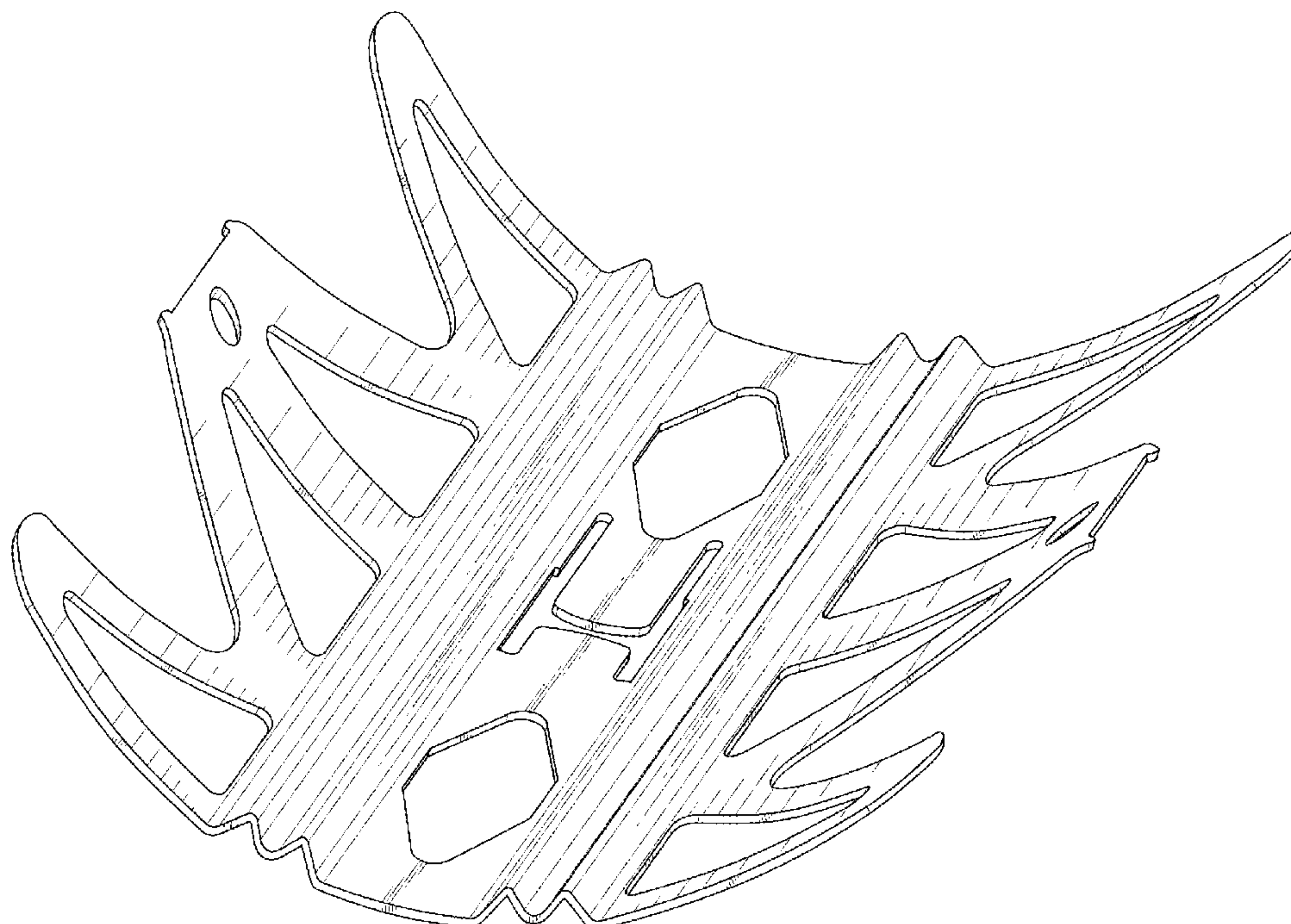
FIG. 1 illustrates a front right-side perspective view of a cable mountable duct saddle;

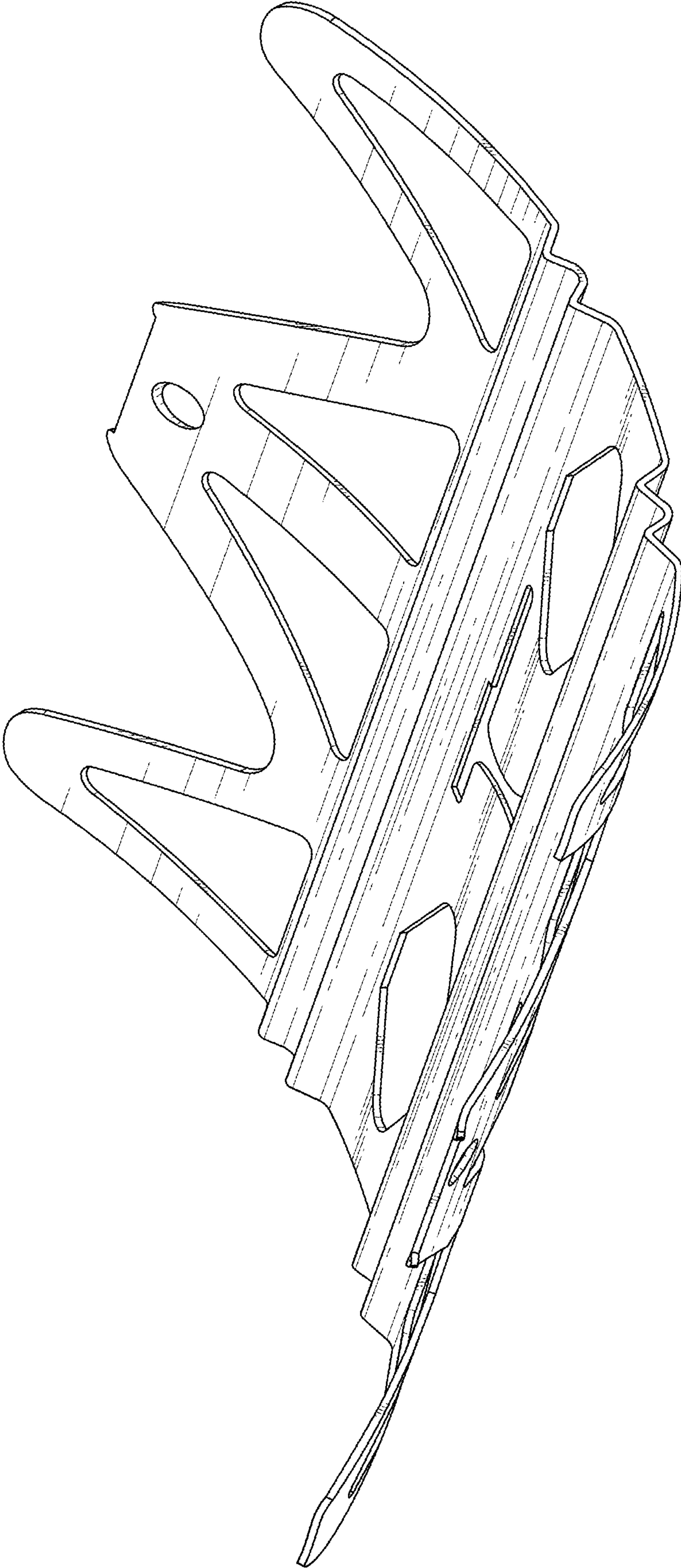

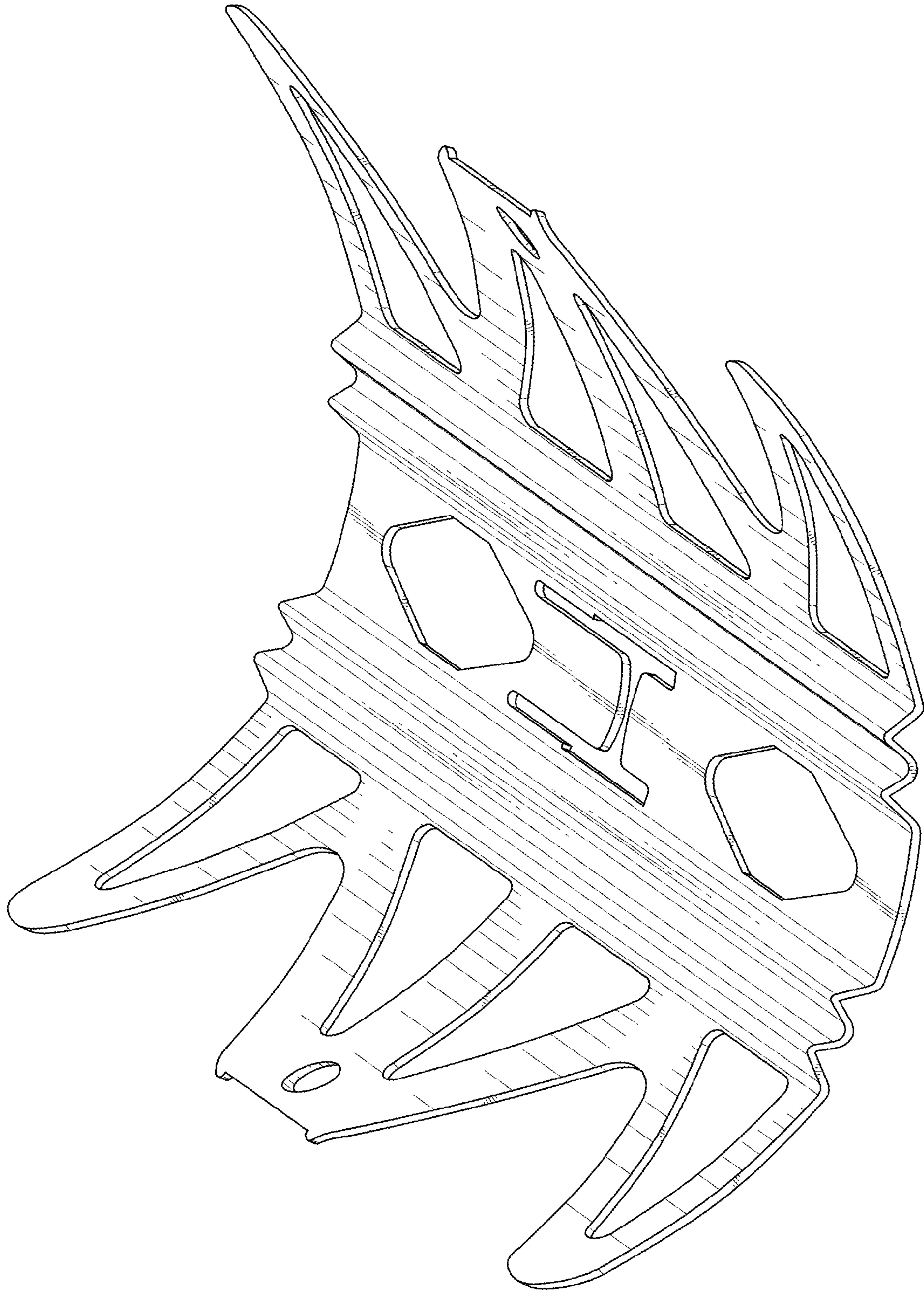

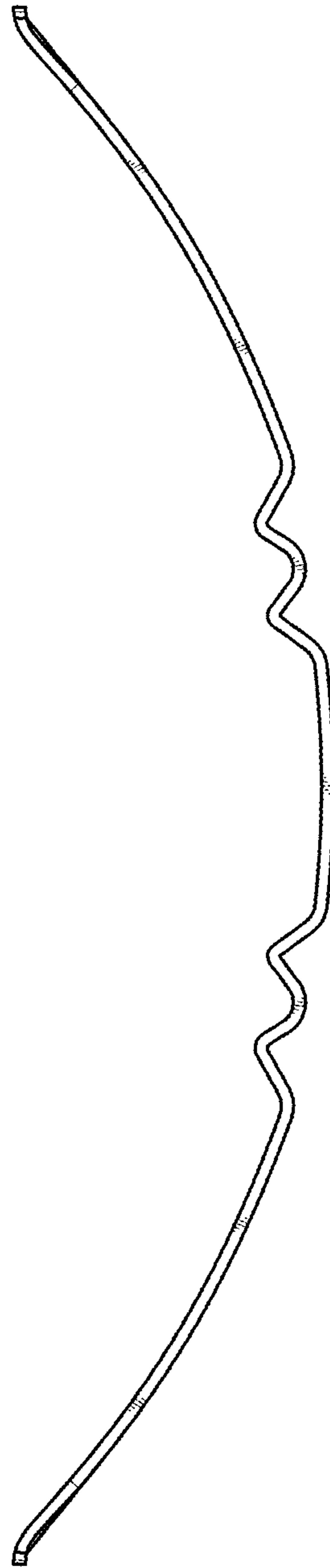

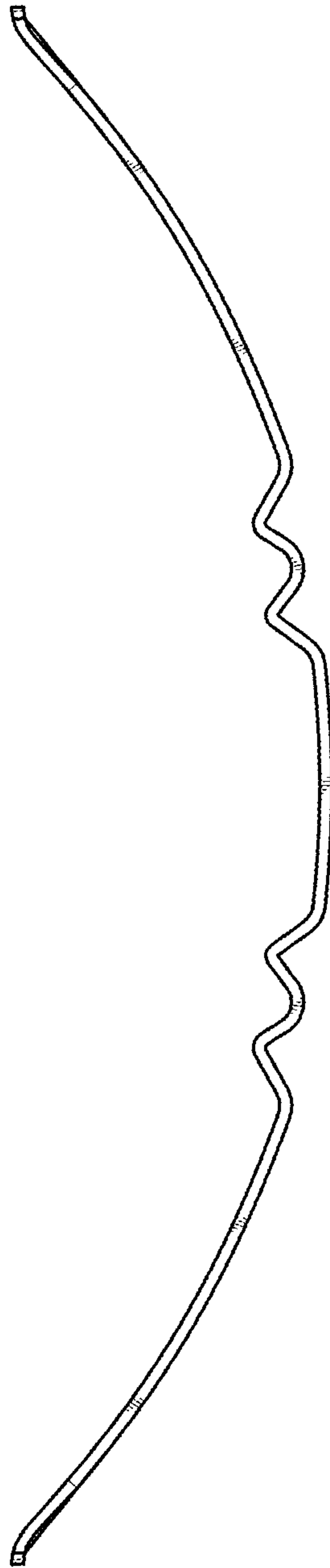

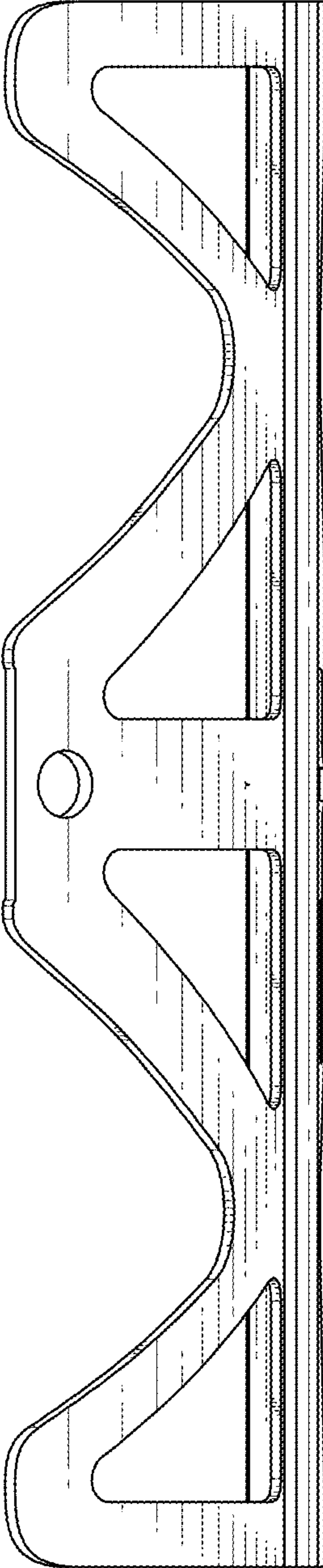

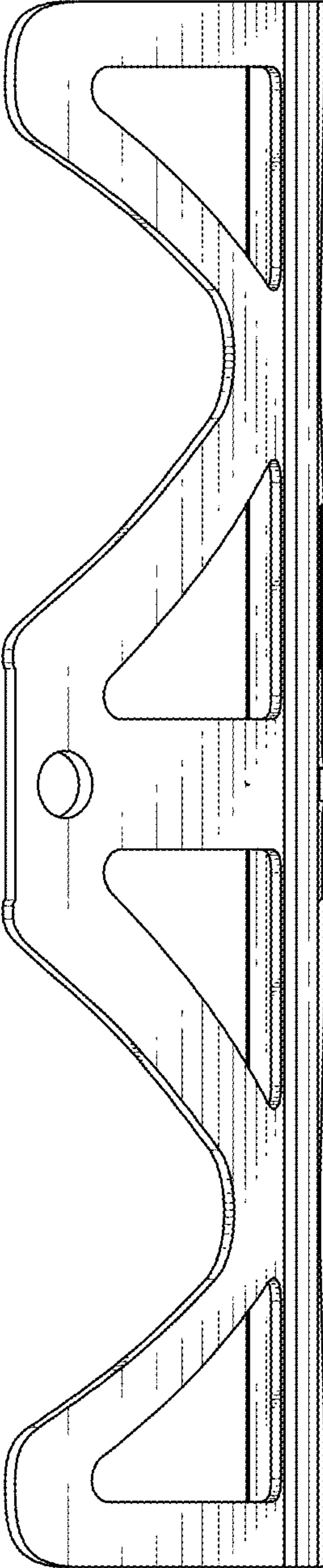

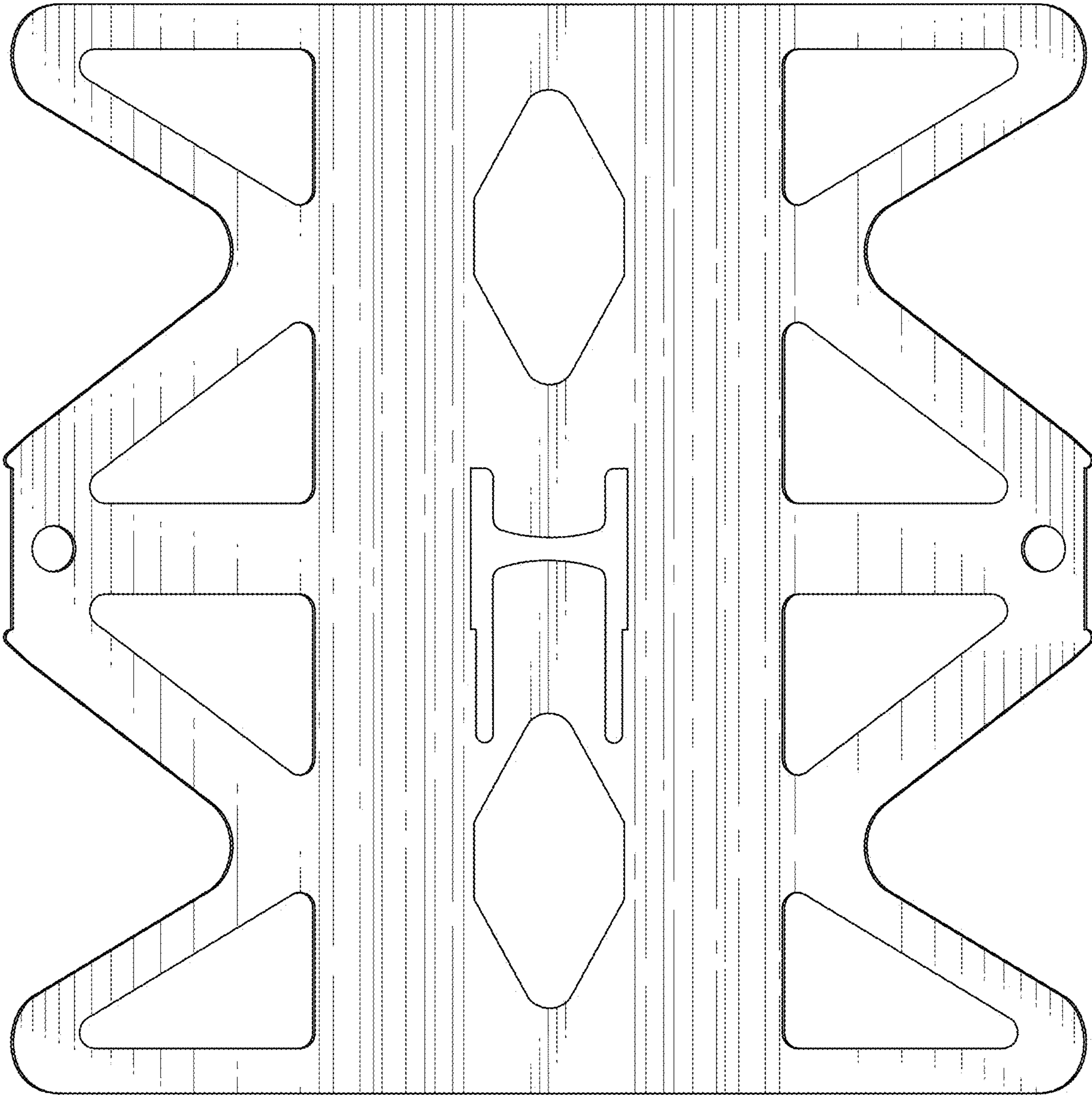

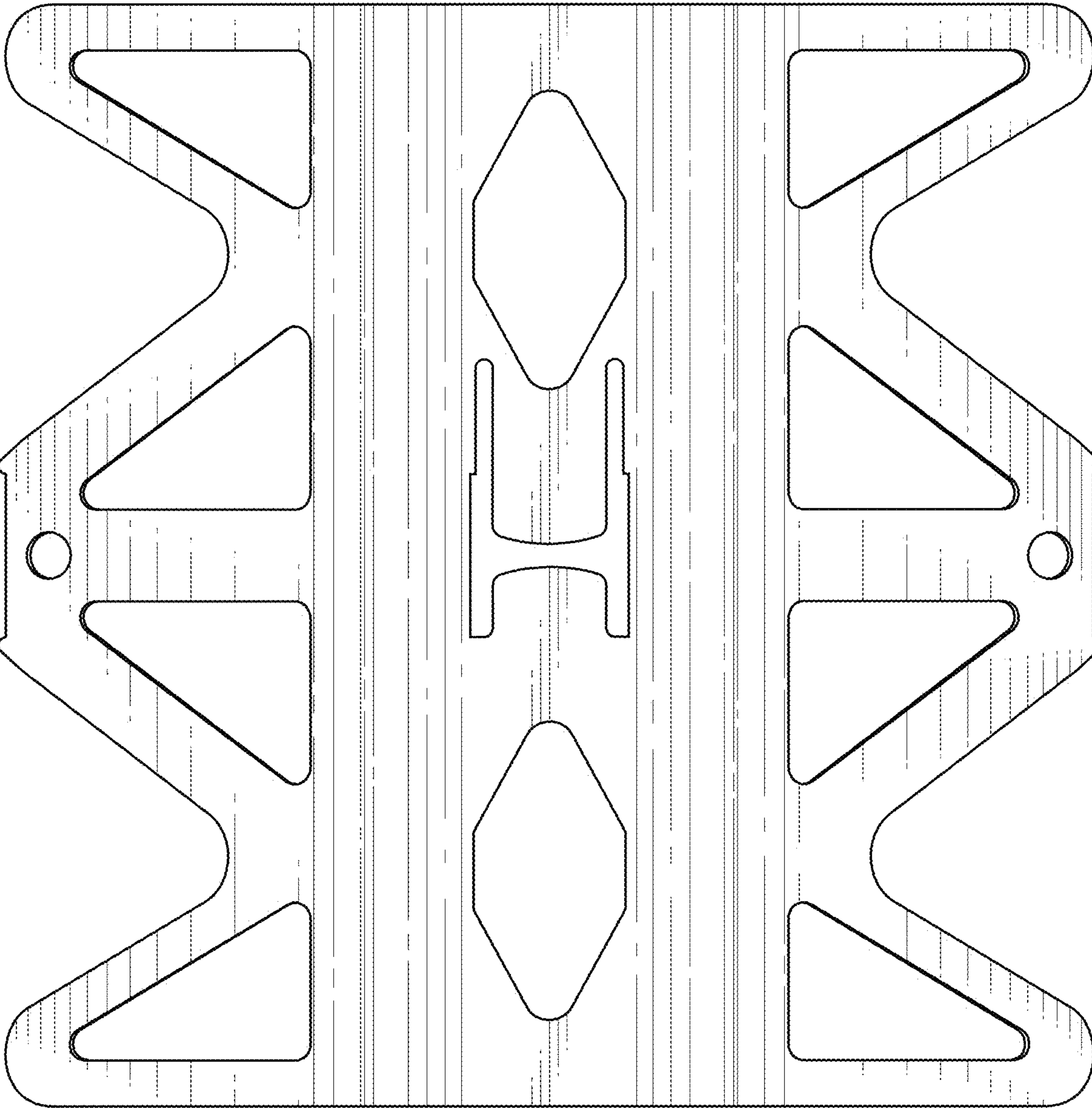

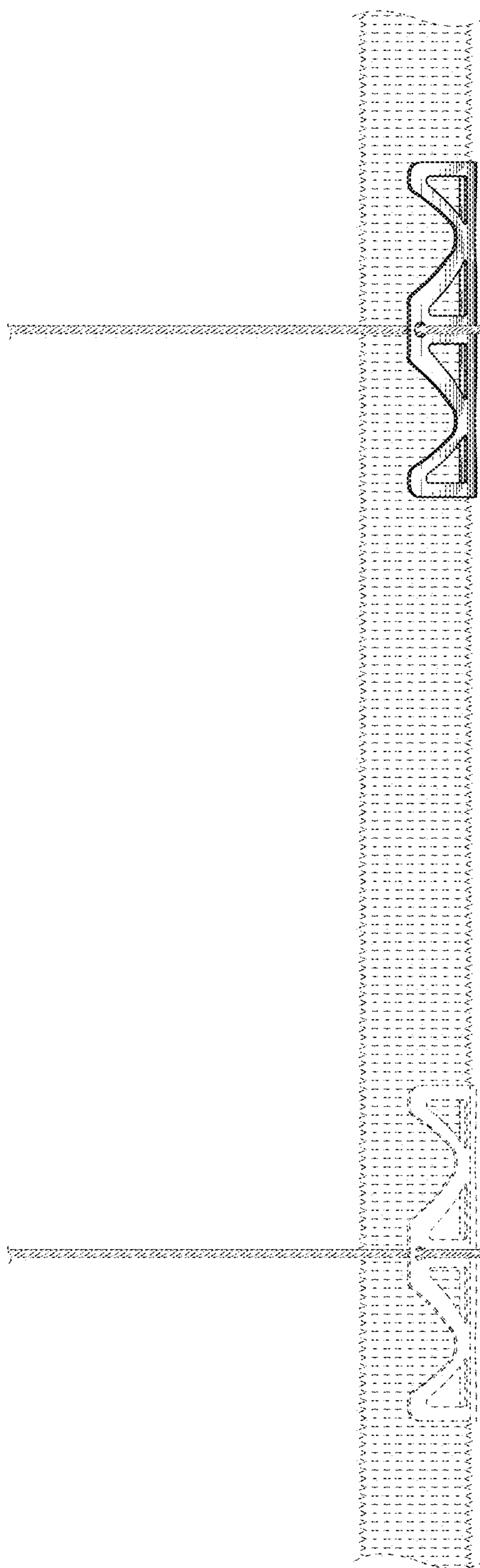

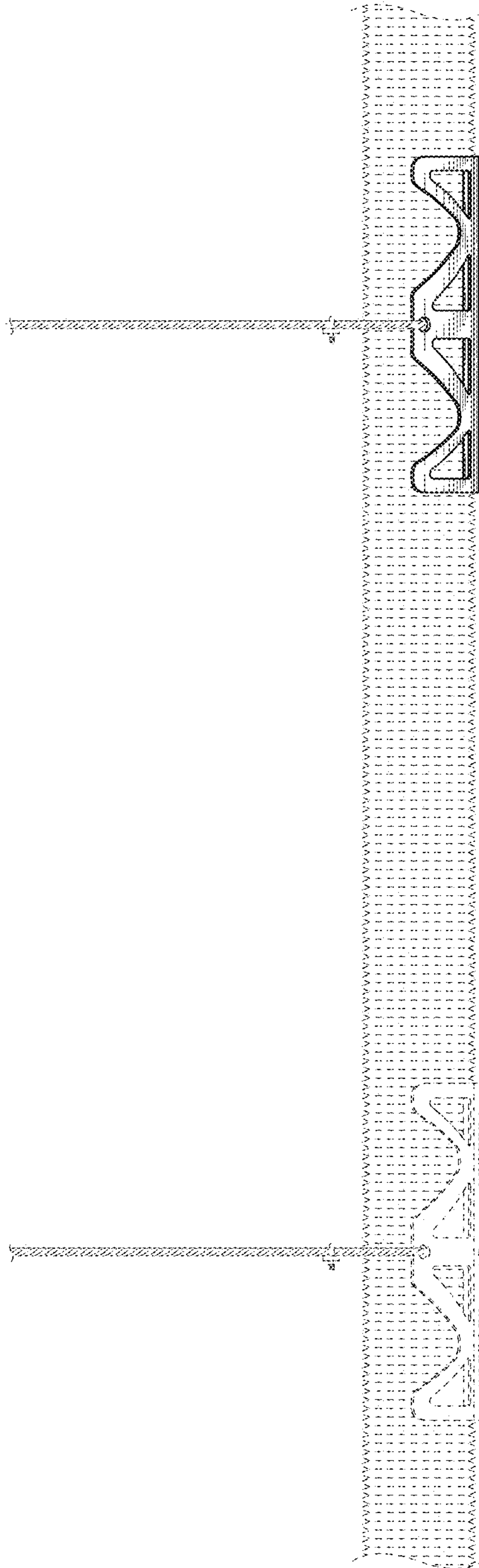
