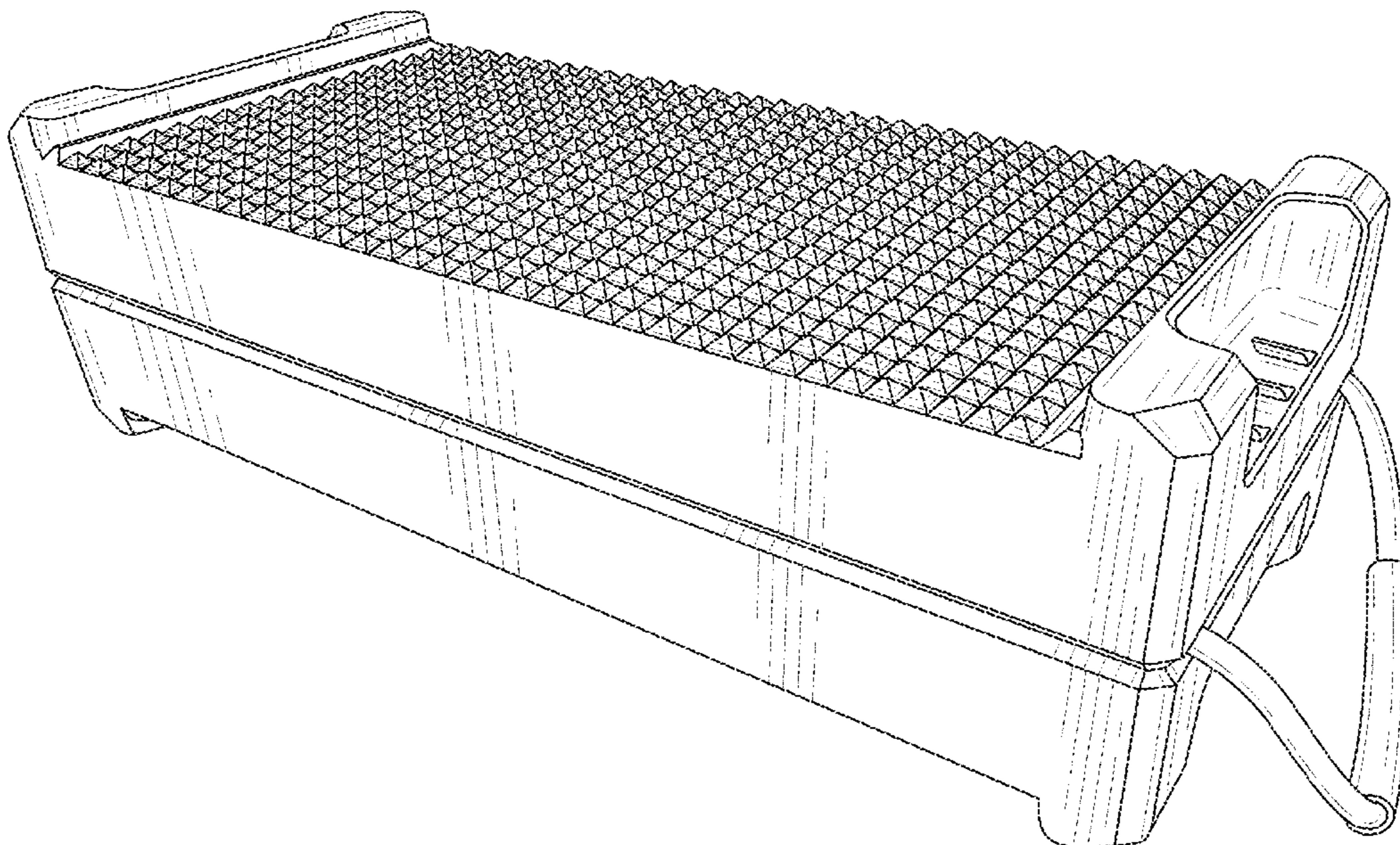
FIG. 1 is a perspective view of the cribbing block of present invention; and

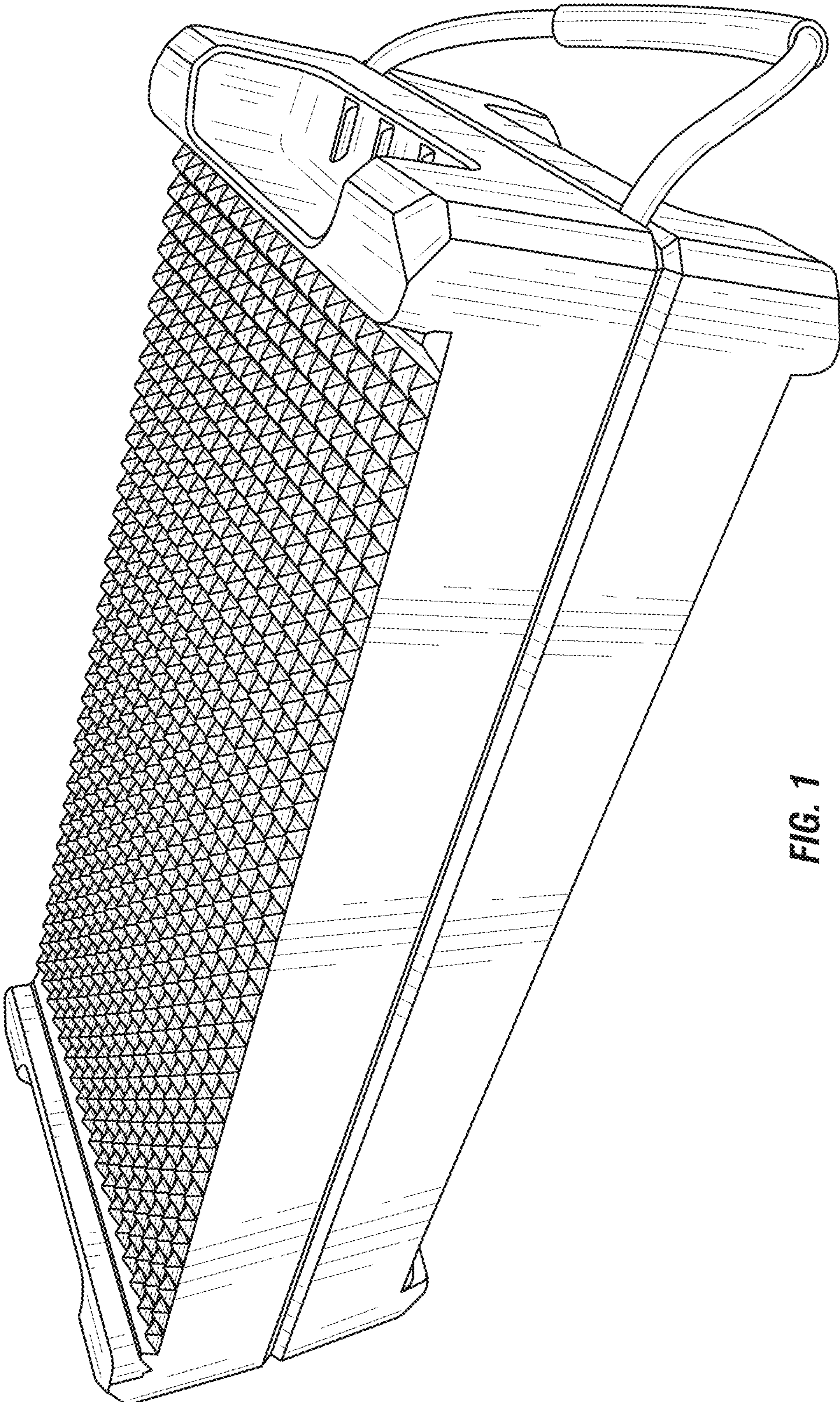

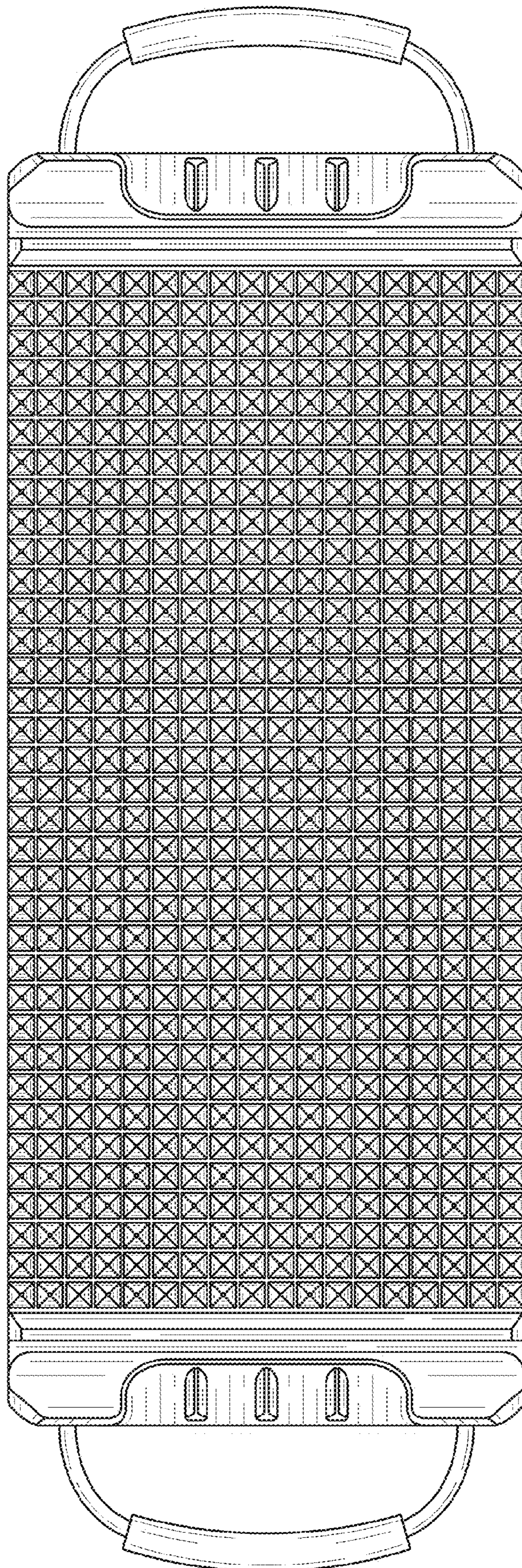

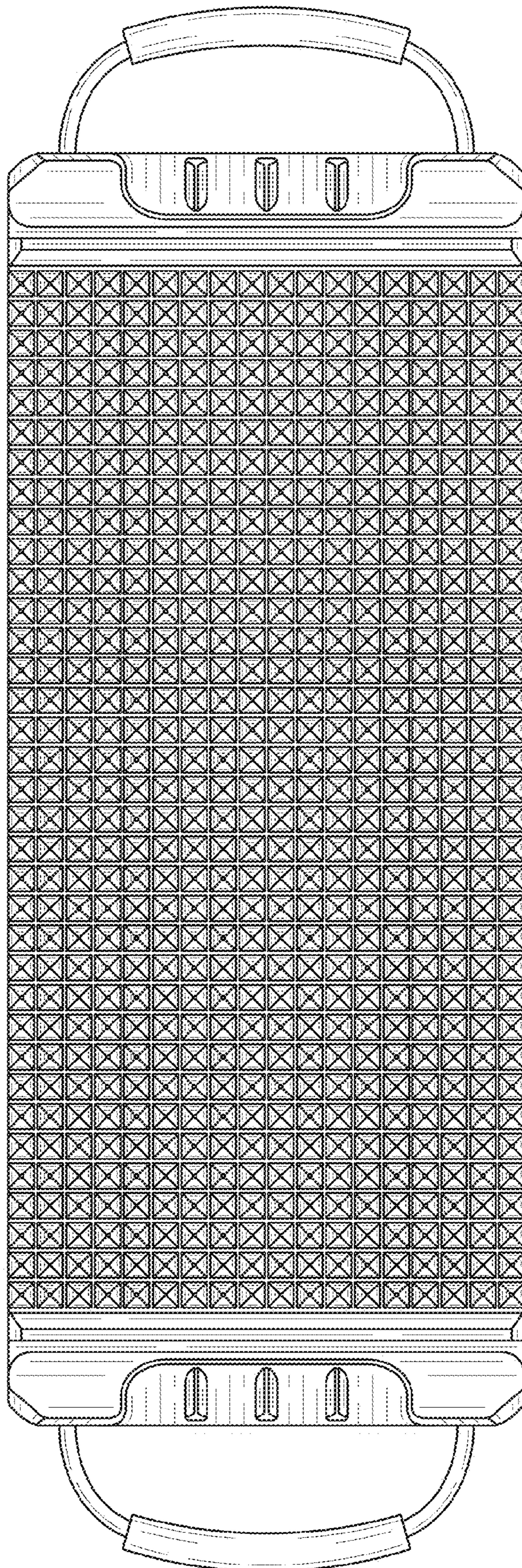

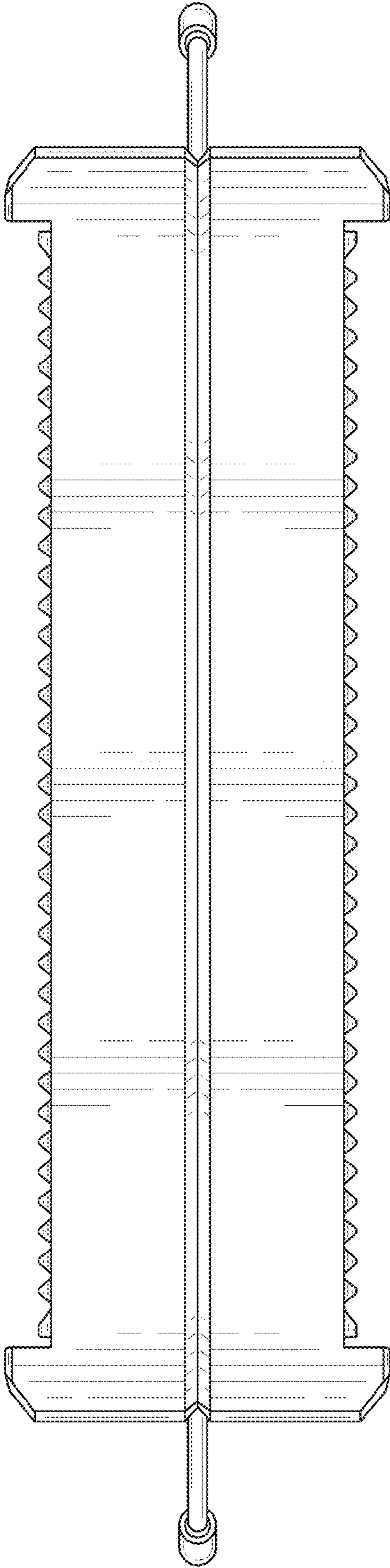

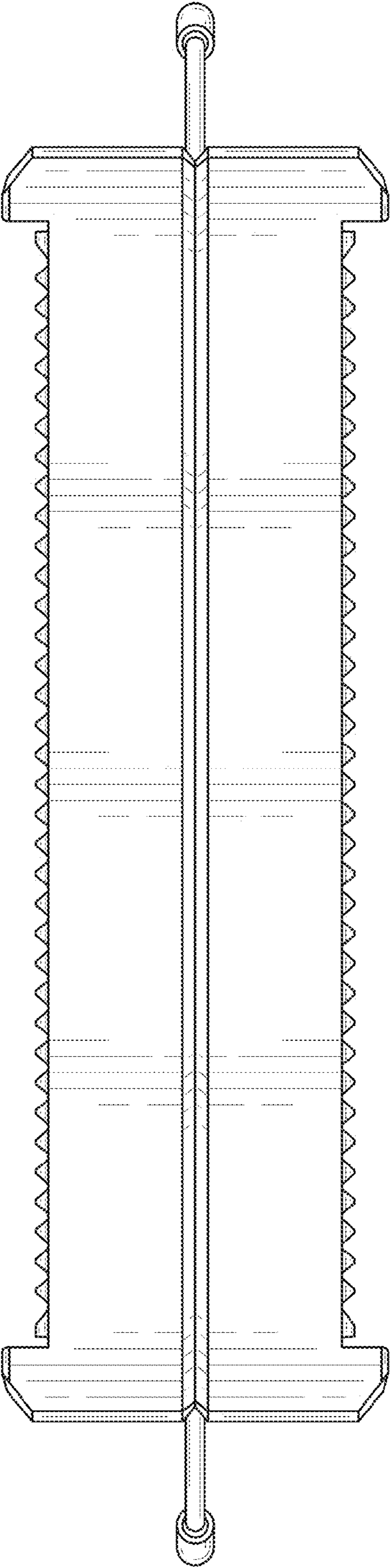

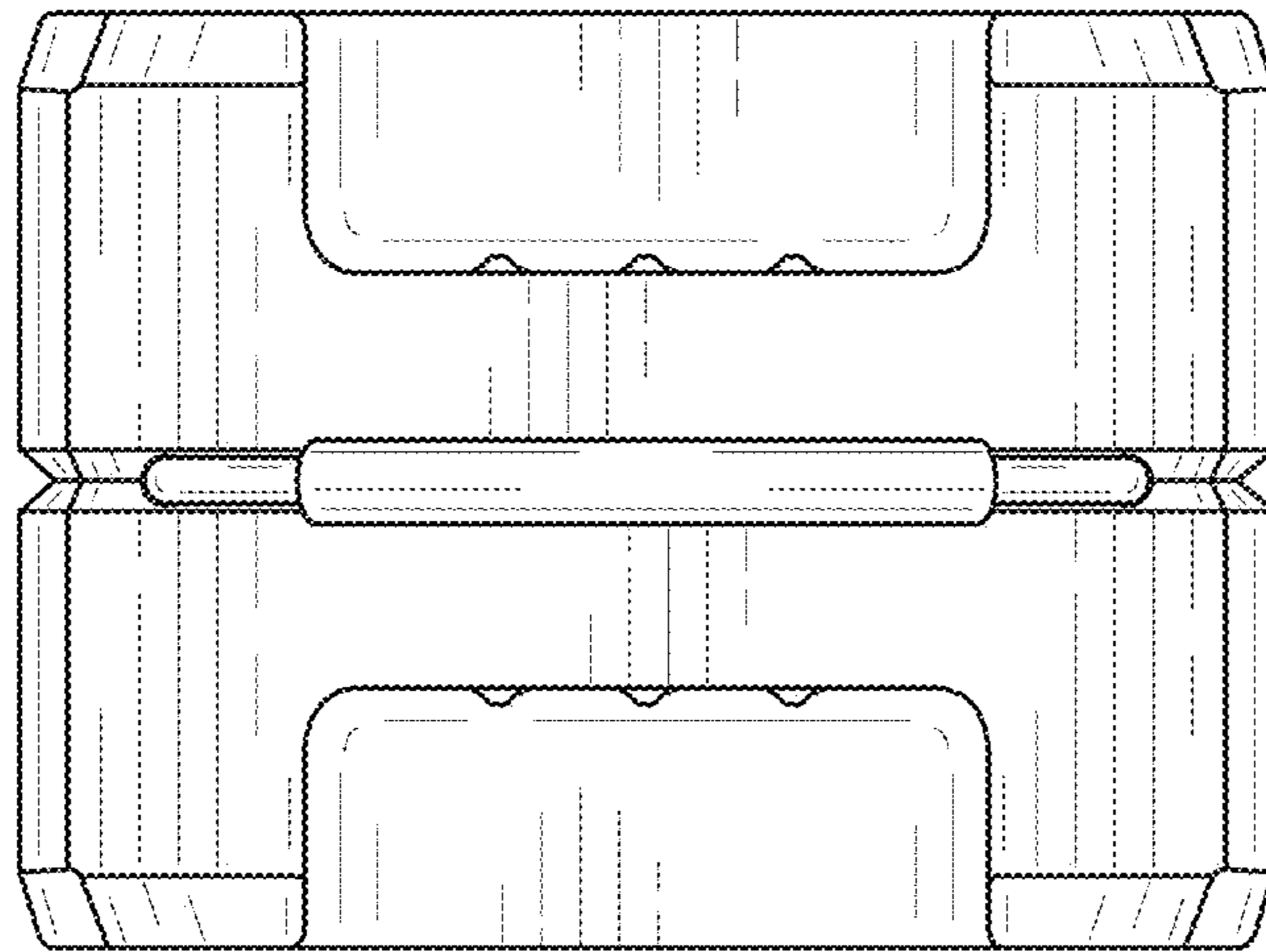

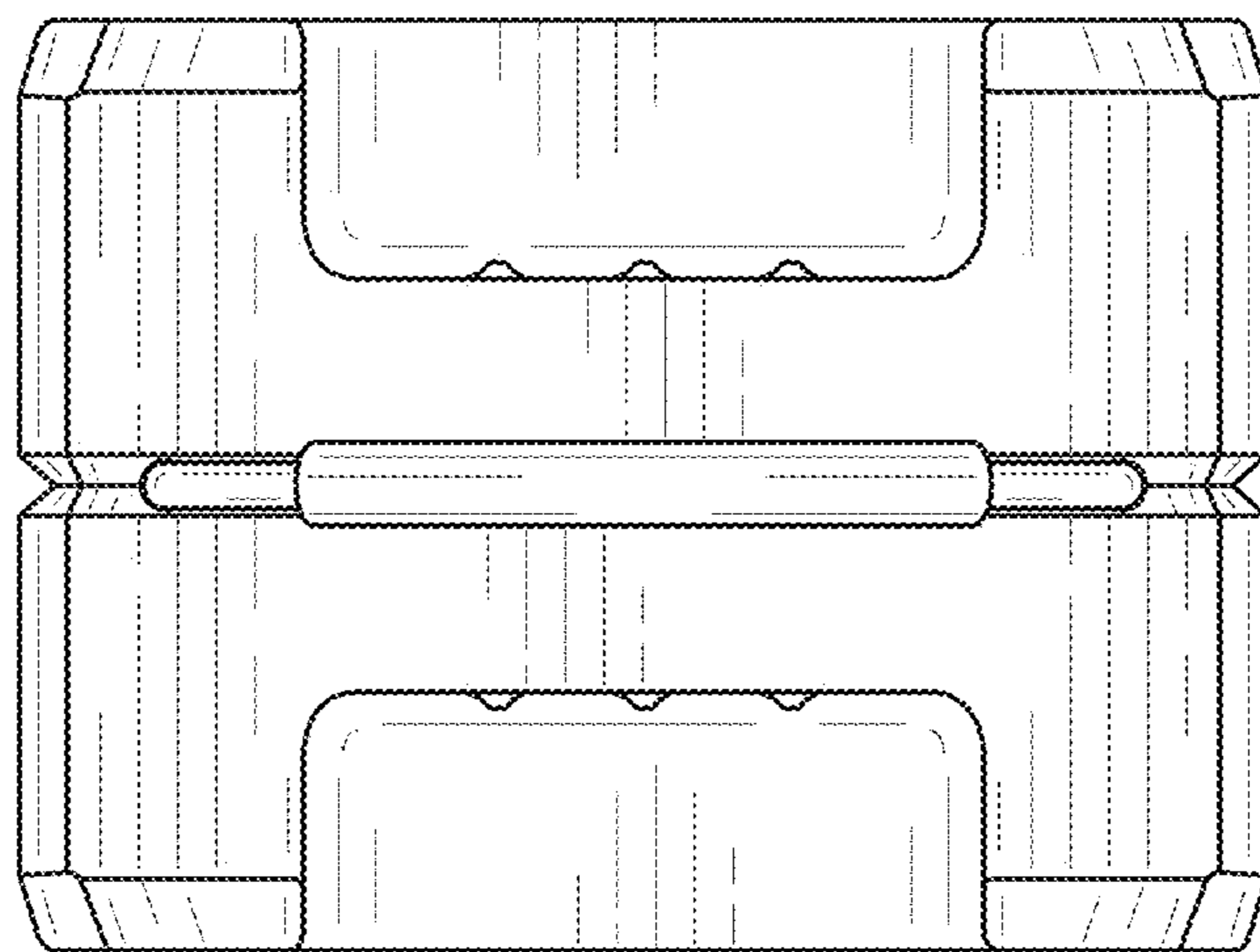
