(57) **CLAIM**

We claim the ornamental design for a packaging container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top perspective view of a packaging container, showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a rear, bottom perspective view of thereof; and, FIG. 9 is an enlarged view of the portion “9” shown in FIG. 8.

The dash-dash broken lines in the drawings show portions of the packaging container which form no part of the claimed design. The dot-dash broken lines depict the bounds of the claimed design and form no part thereof.

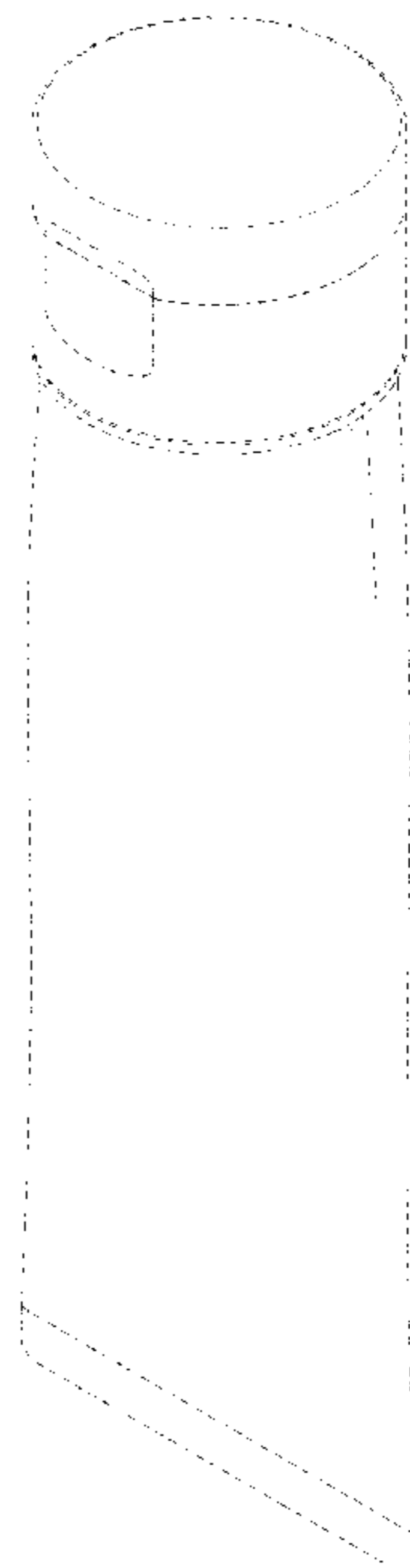

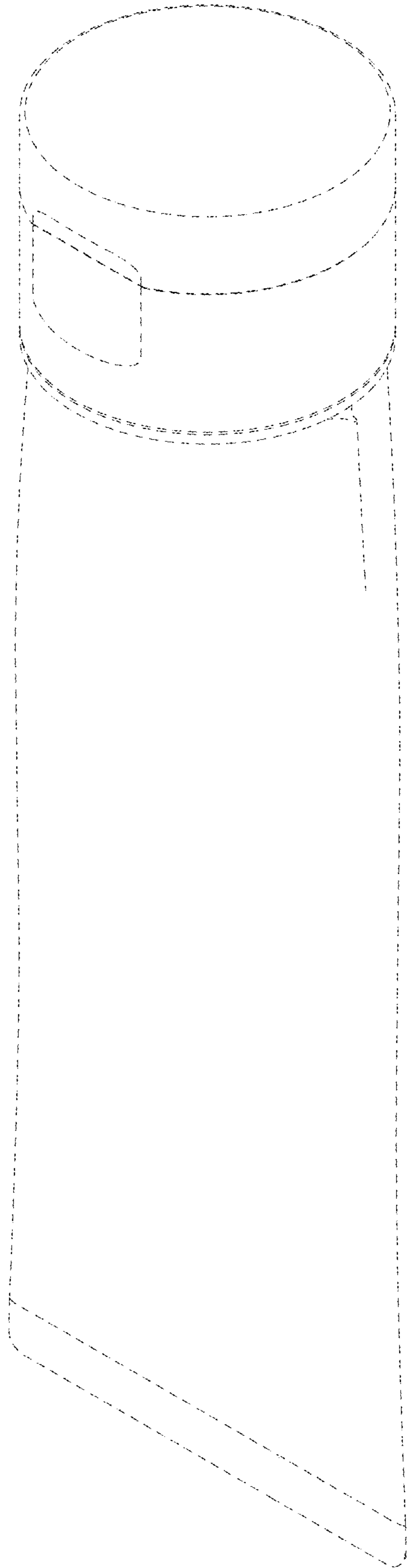

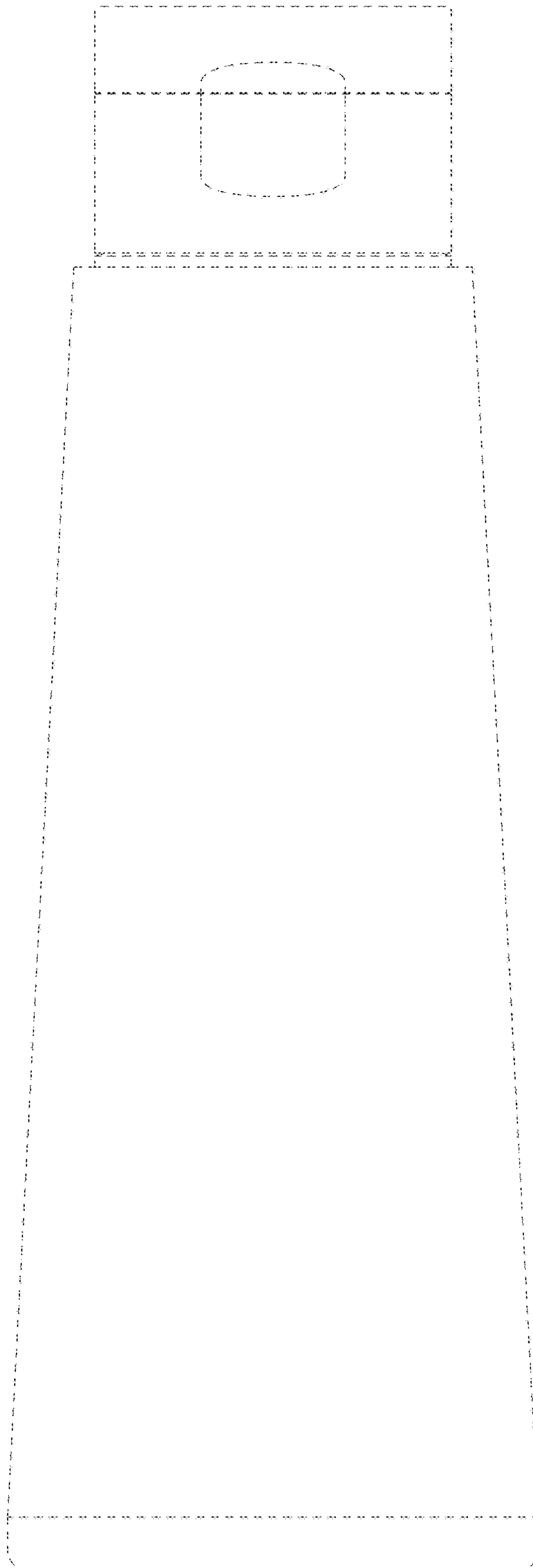

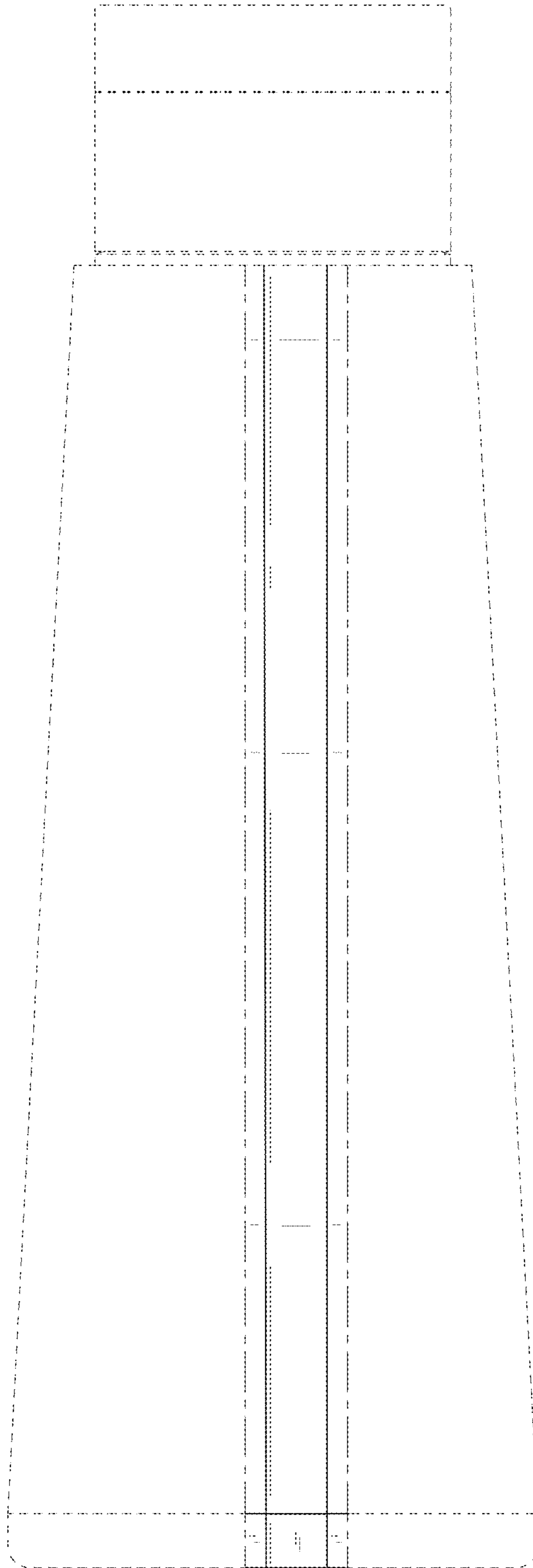

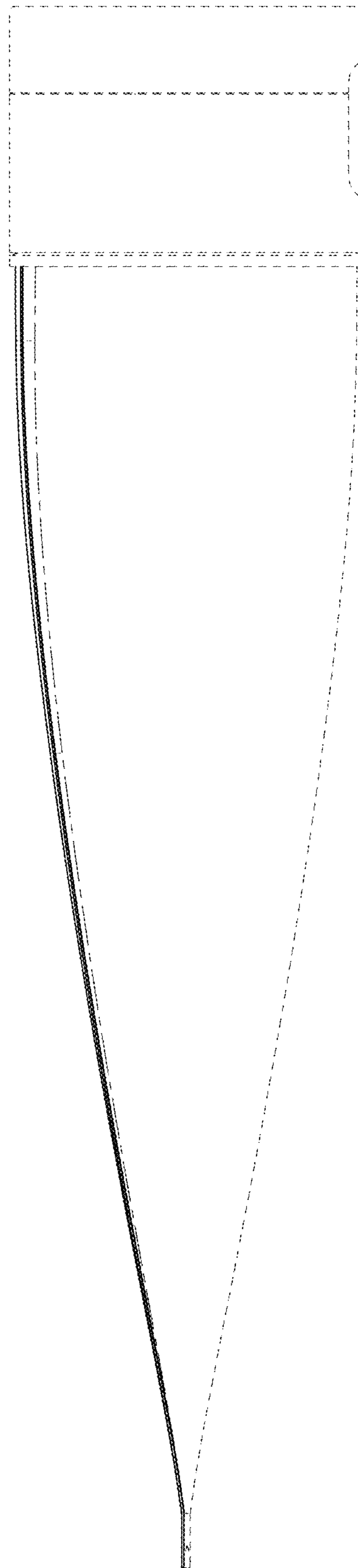

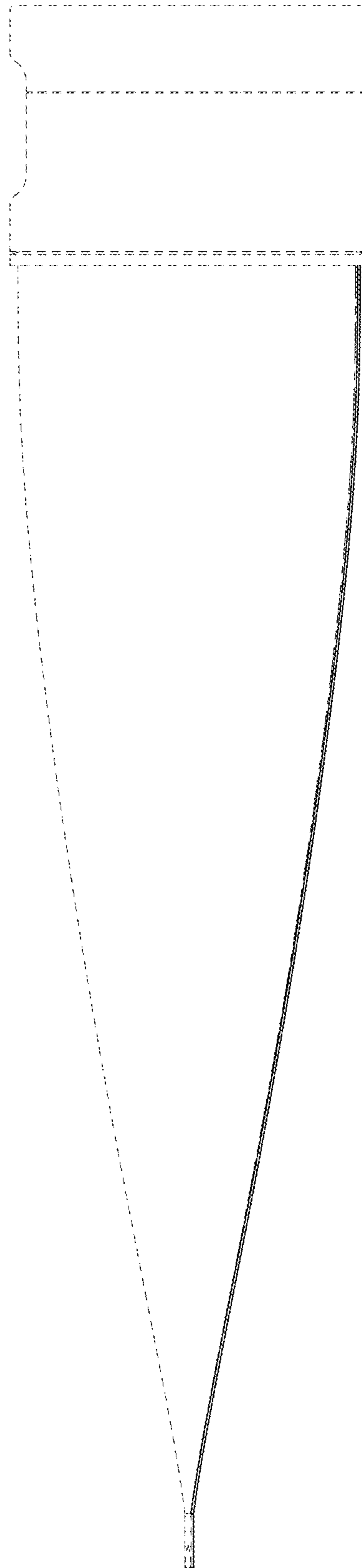

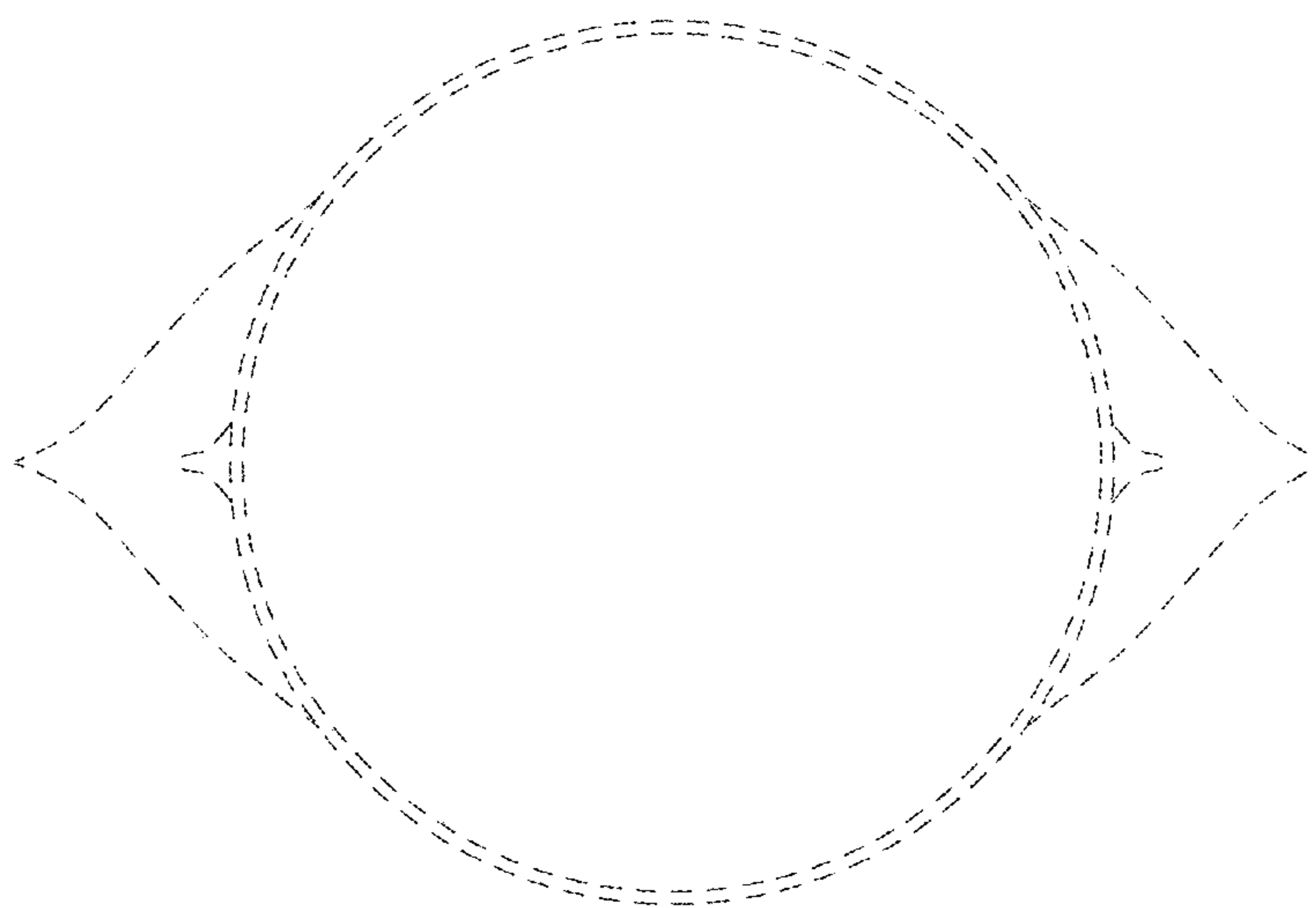

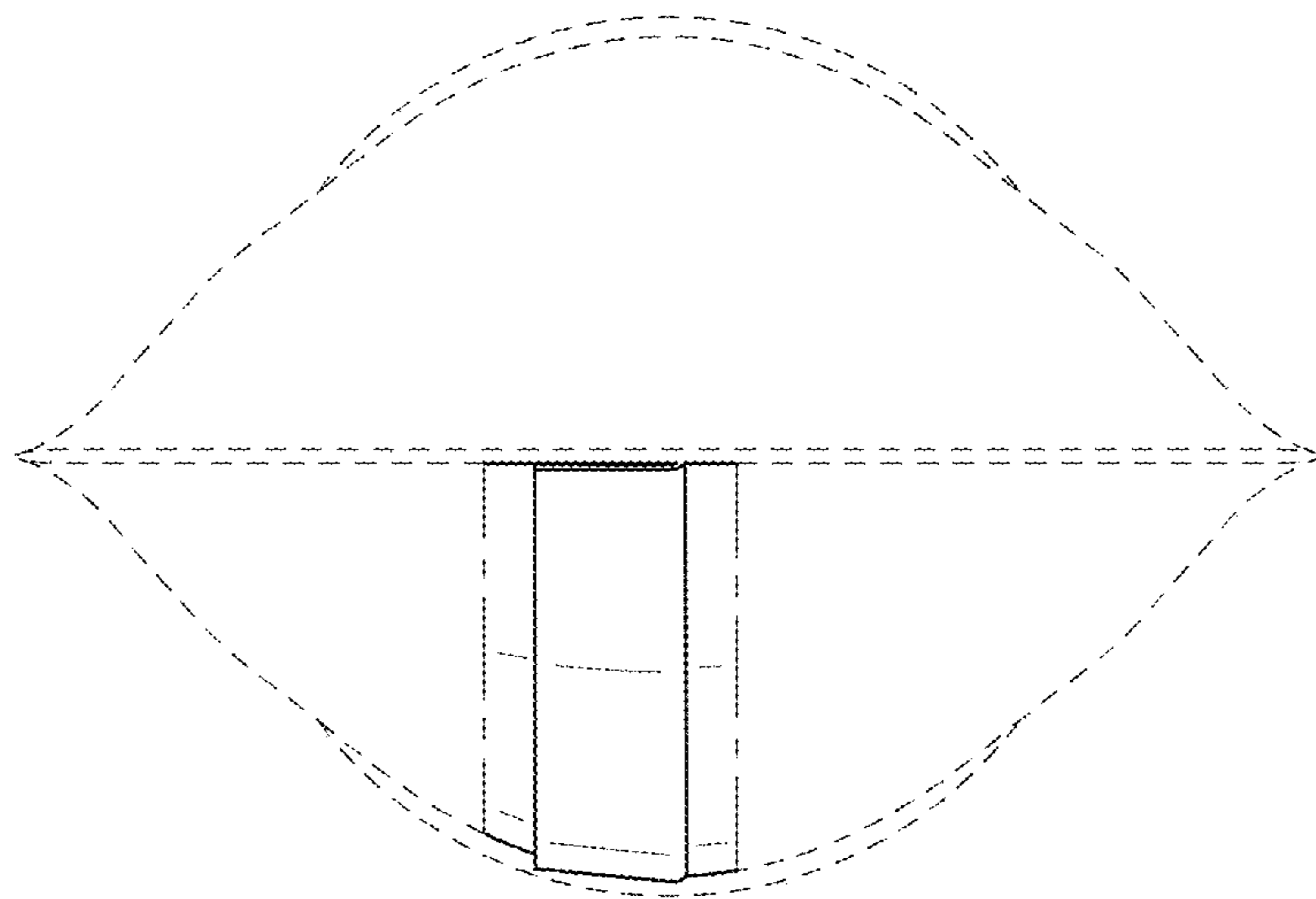

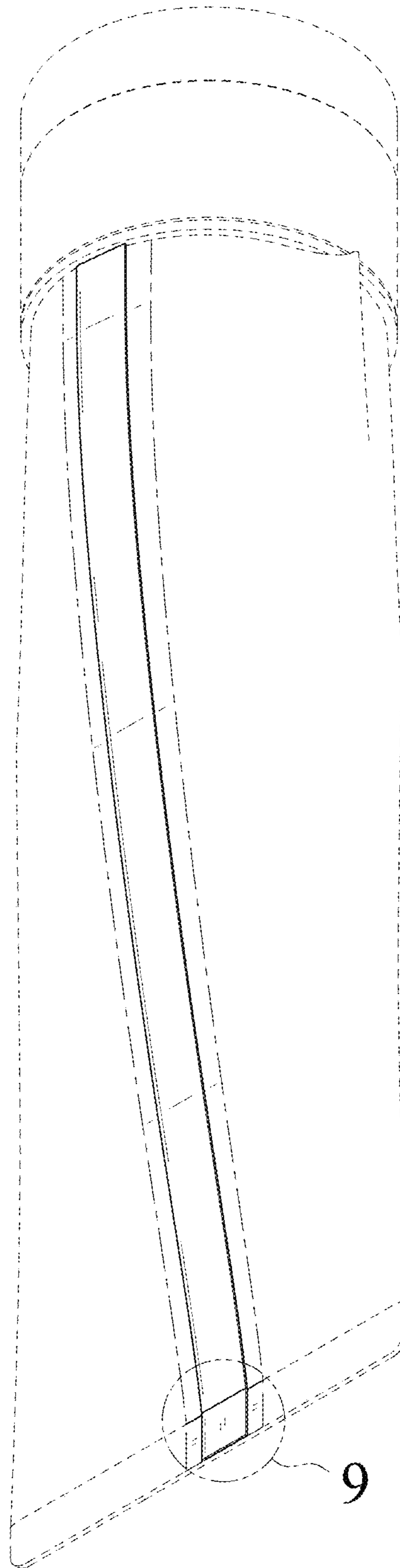
