DESCRIPTION

FIG. 1 is a perspective view of a gnome ornament showing my new design;

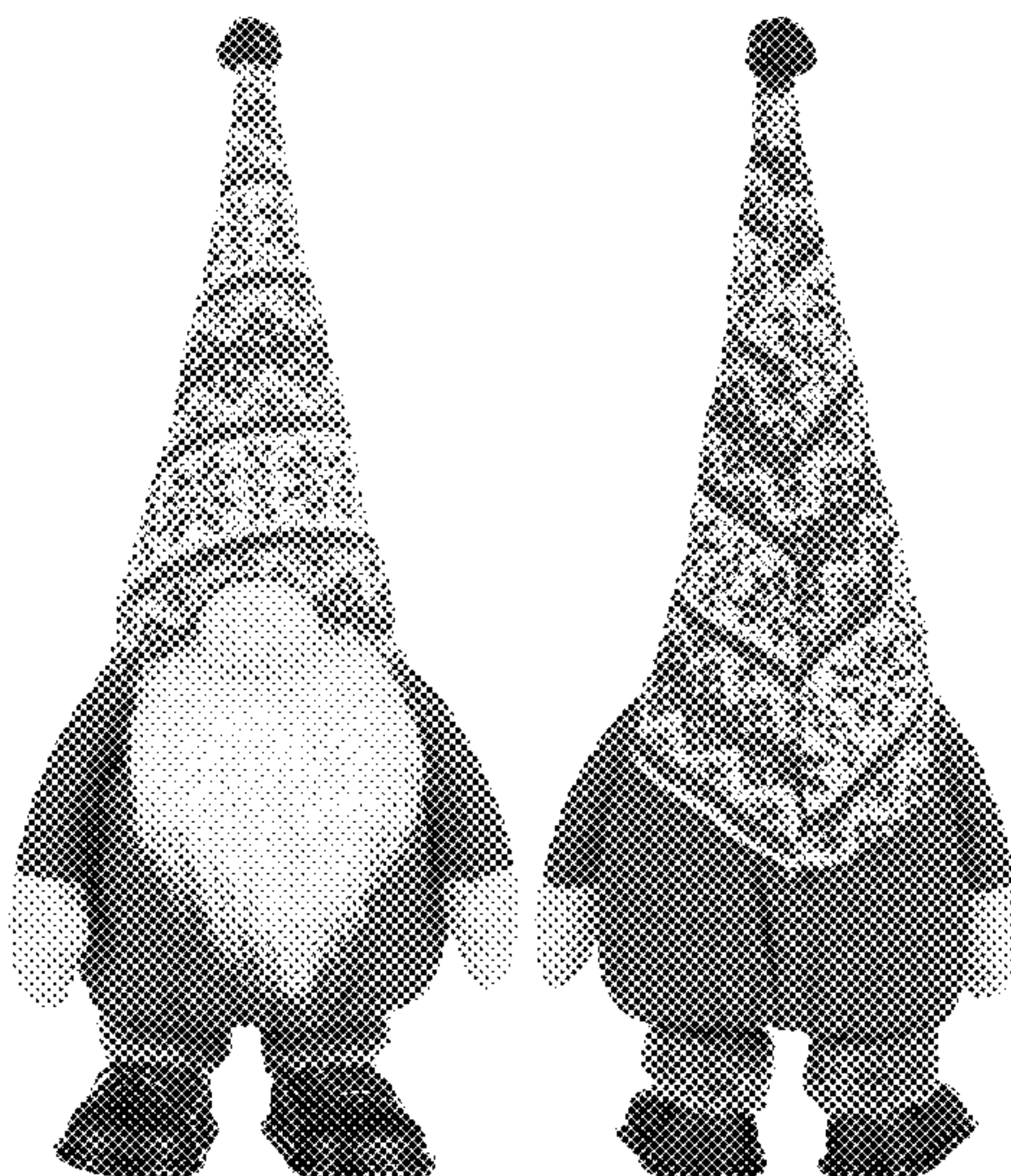

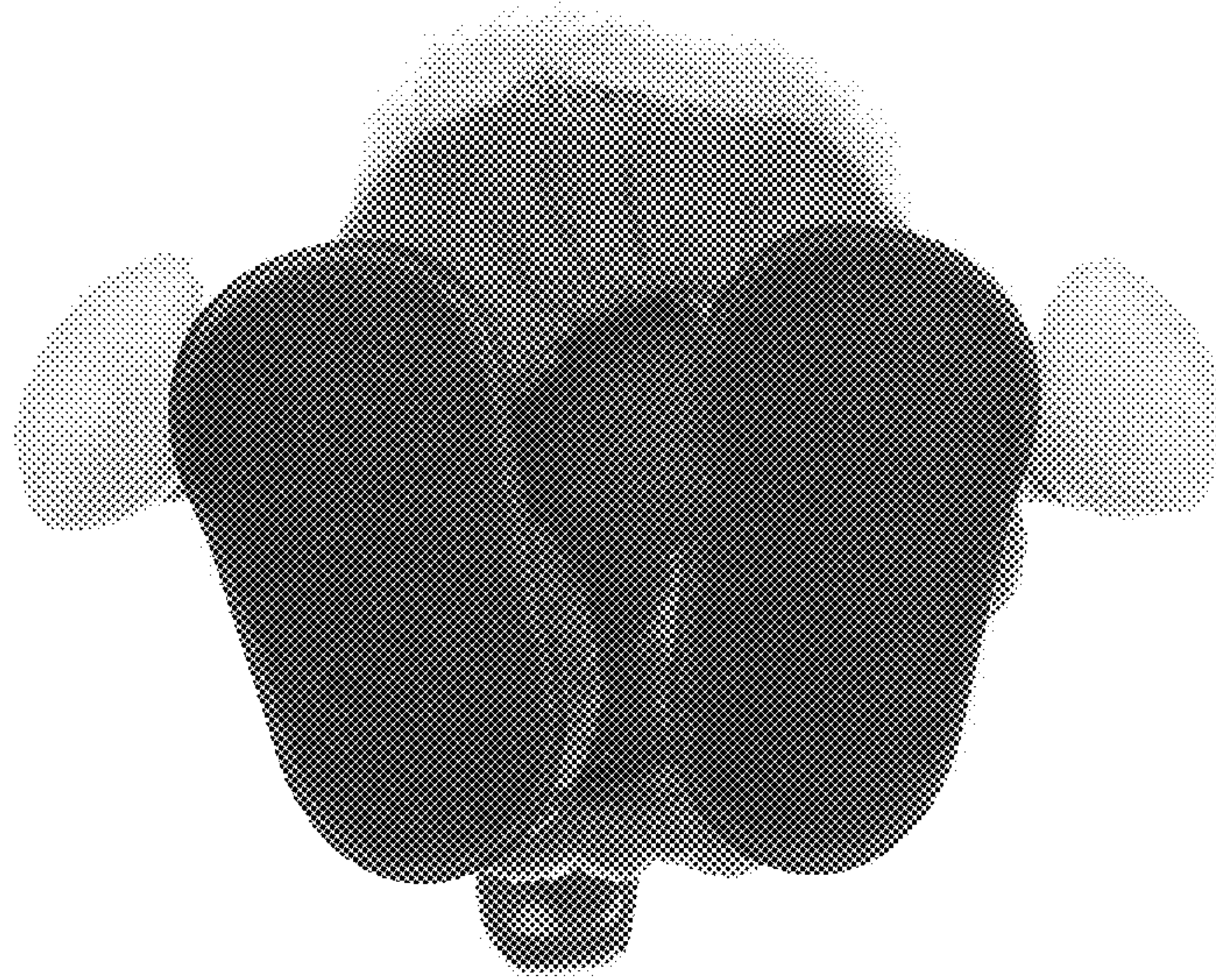
