DESCRIPTION

FIG. 1 is a perspective view of a tire sidewall showing my new design;

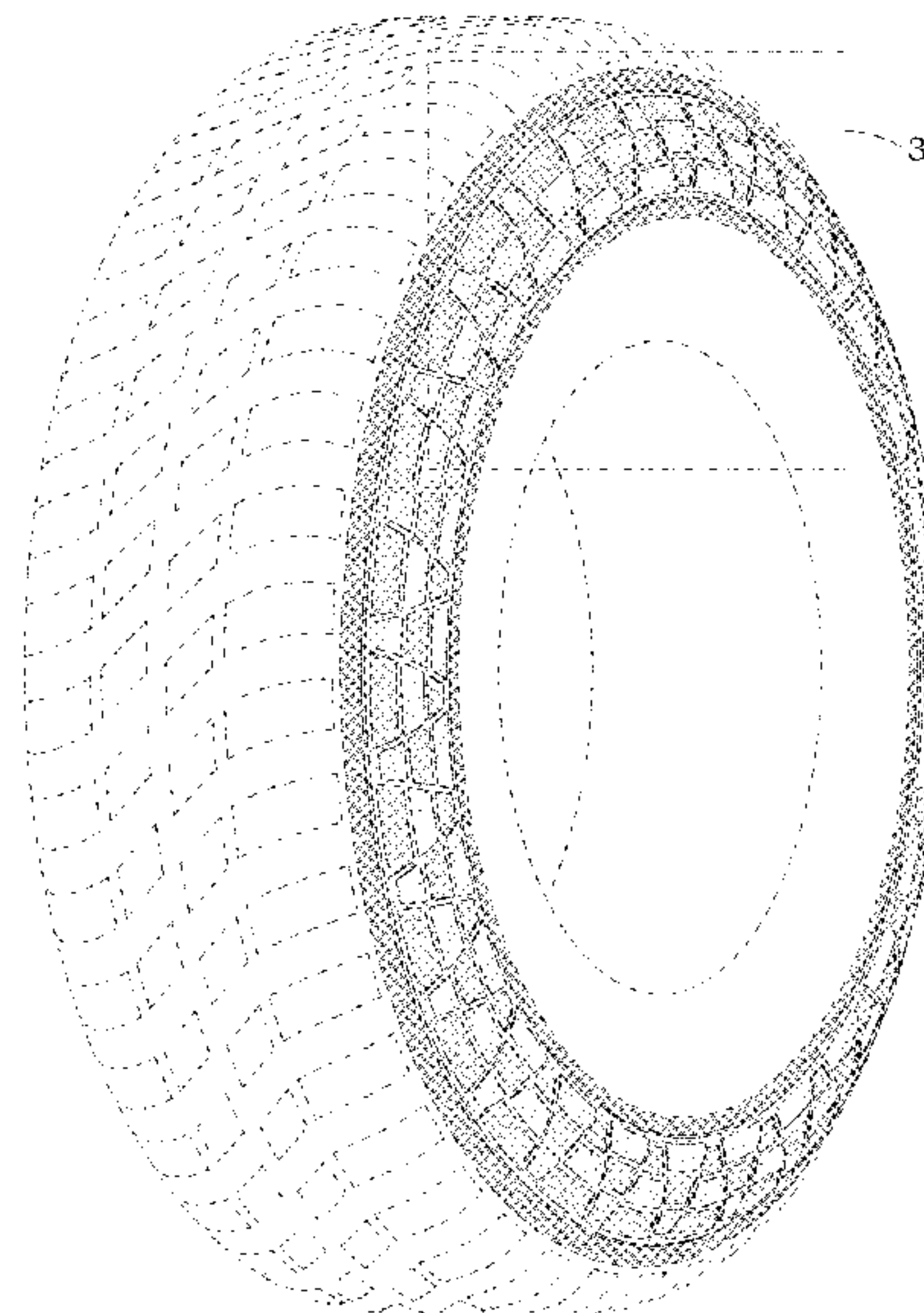
FIG. 2 is a front elevational view thereof; and,

FIG. 3 is an enlarged fragmentary perspective view thereof taken from FIG. 1.

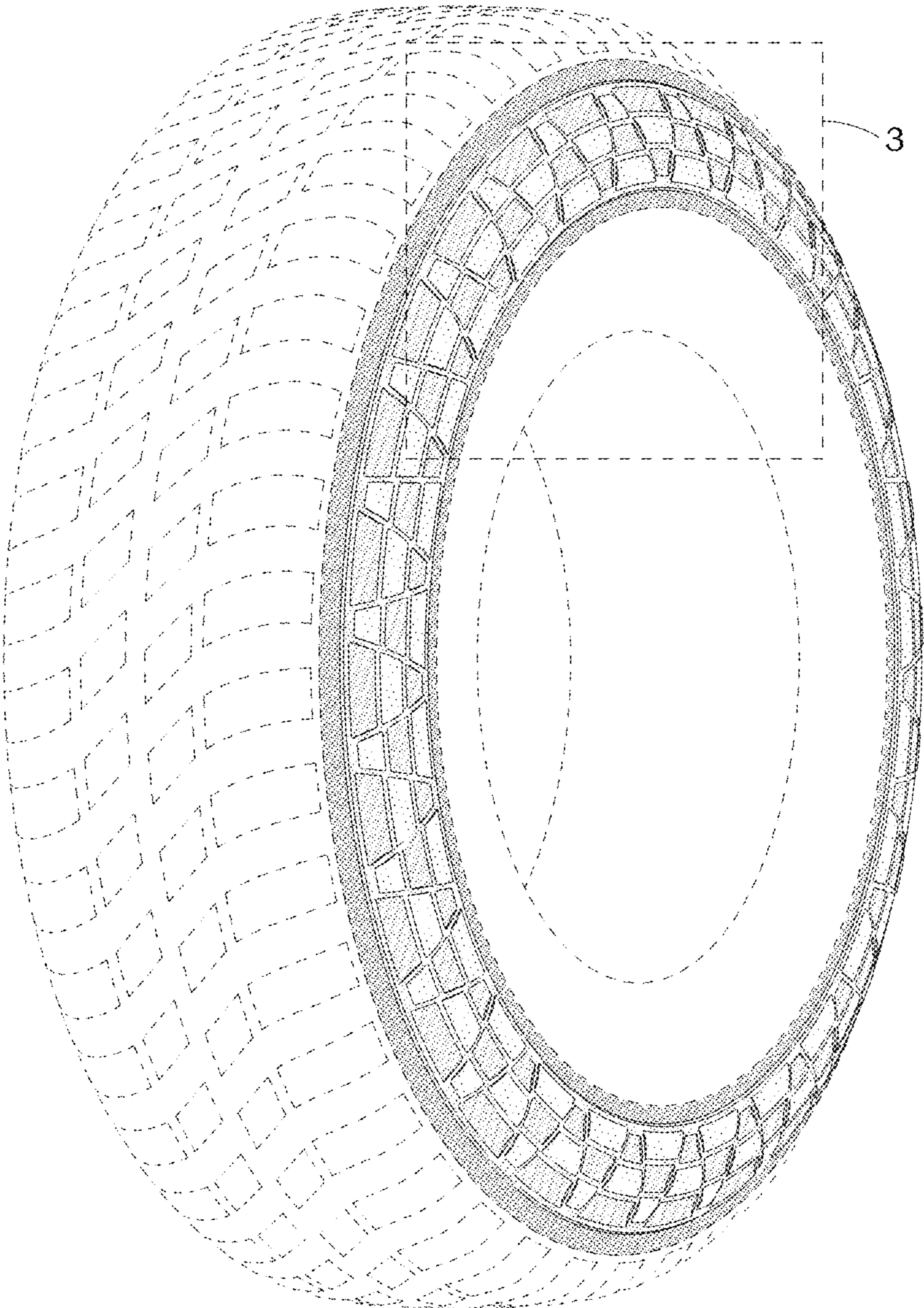

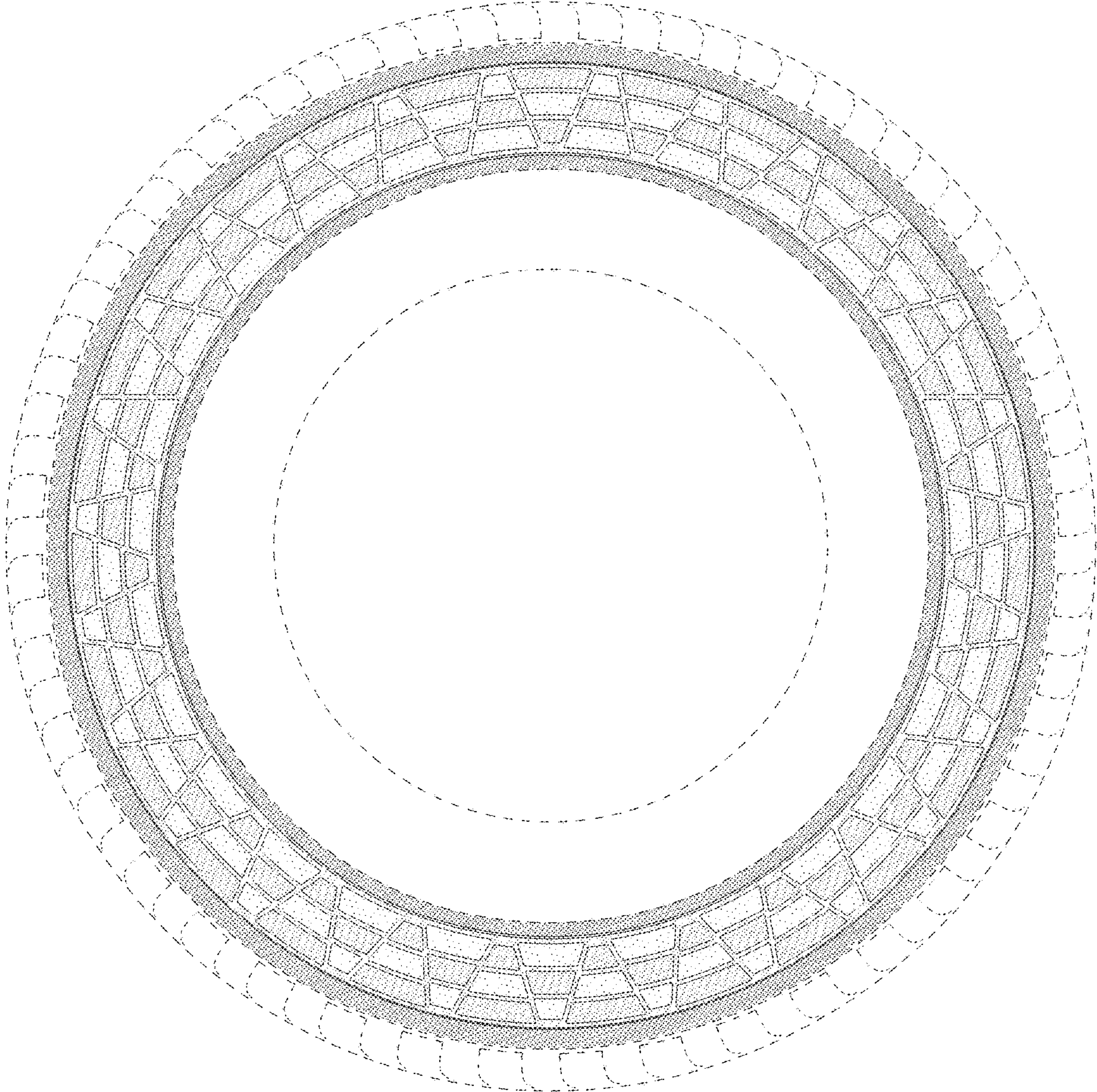

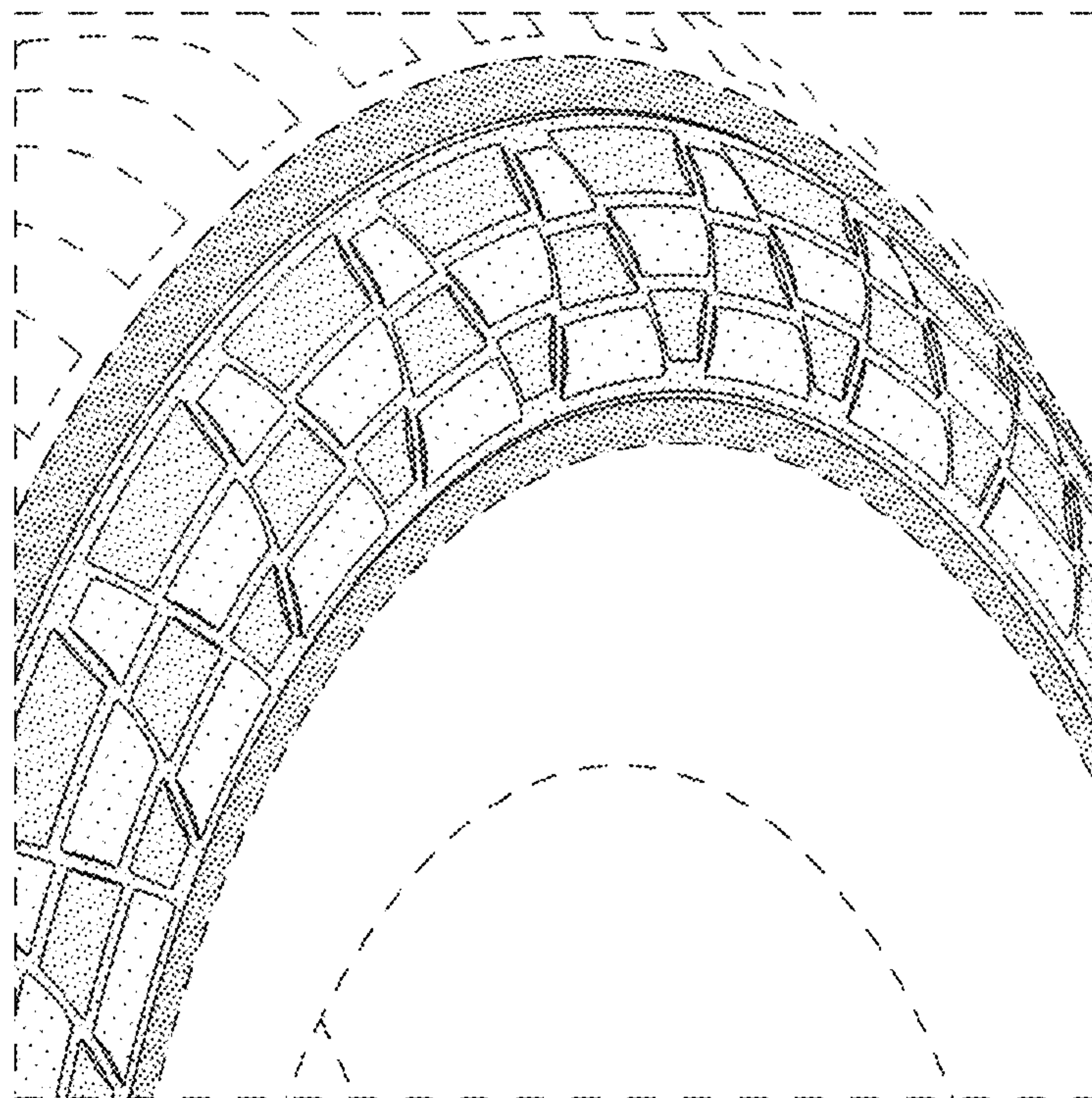
