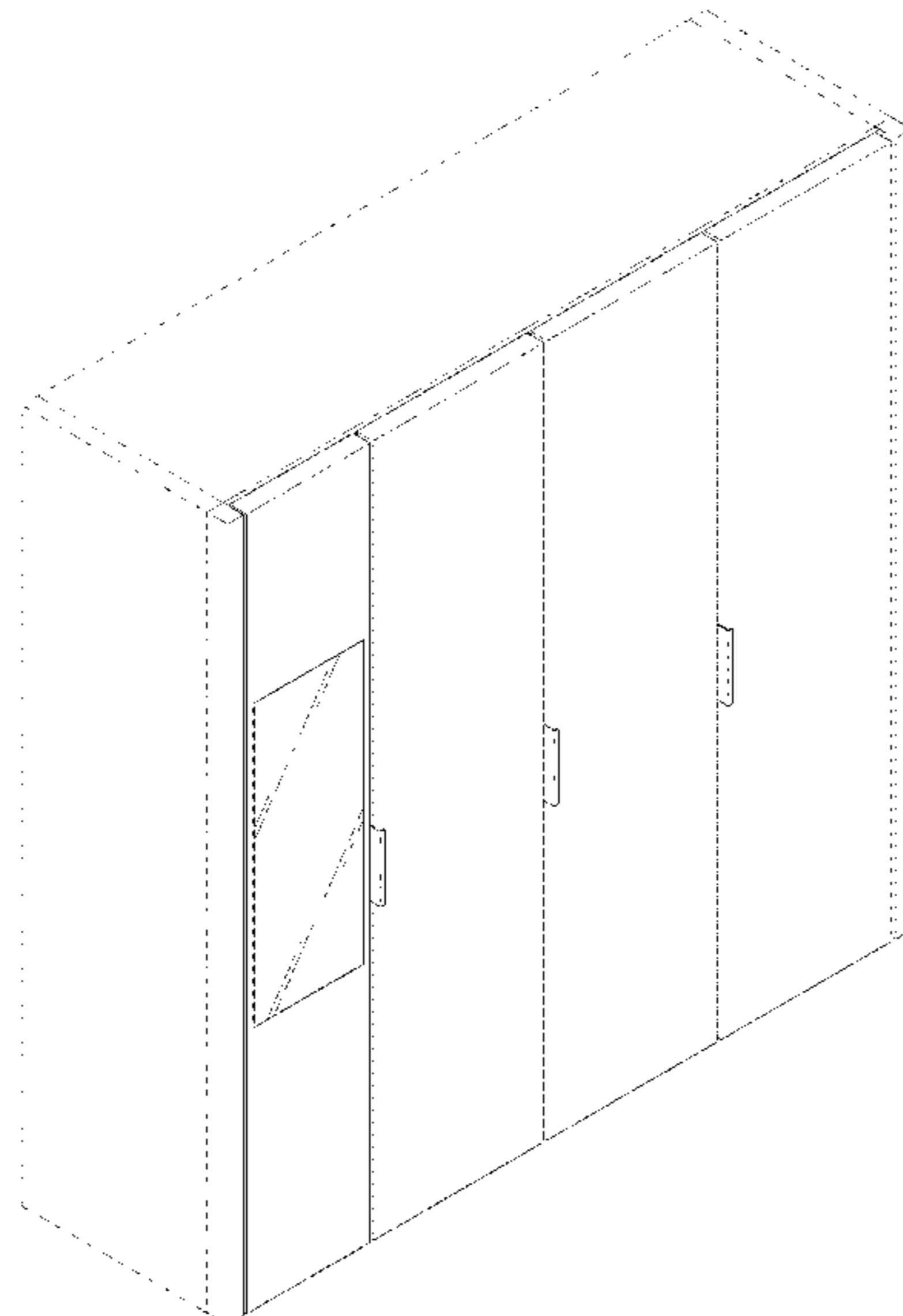
(57) **CLAIM**

The ornamental design for an indoor wall for the built-in home appliances, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the indoor wall for the built-in home appliances showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a top plan view thereof where the bottom plan view is a mirror image.
The broken lines depict portions of the indoor wall for the built-in home appliances that form no part of the claimed design. The dash-dot broken lines define the boundary of the claimed design and form no part thereof.

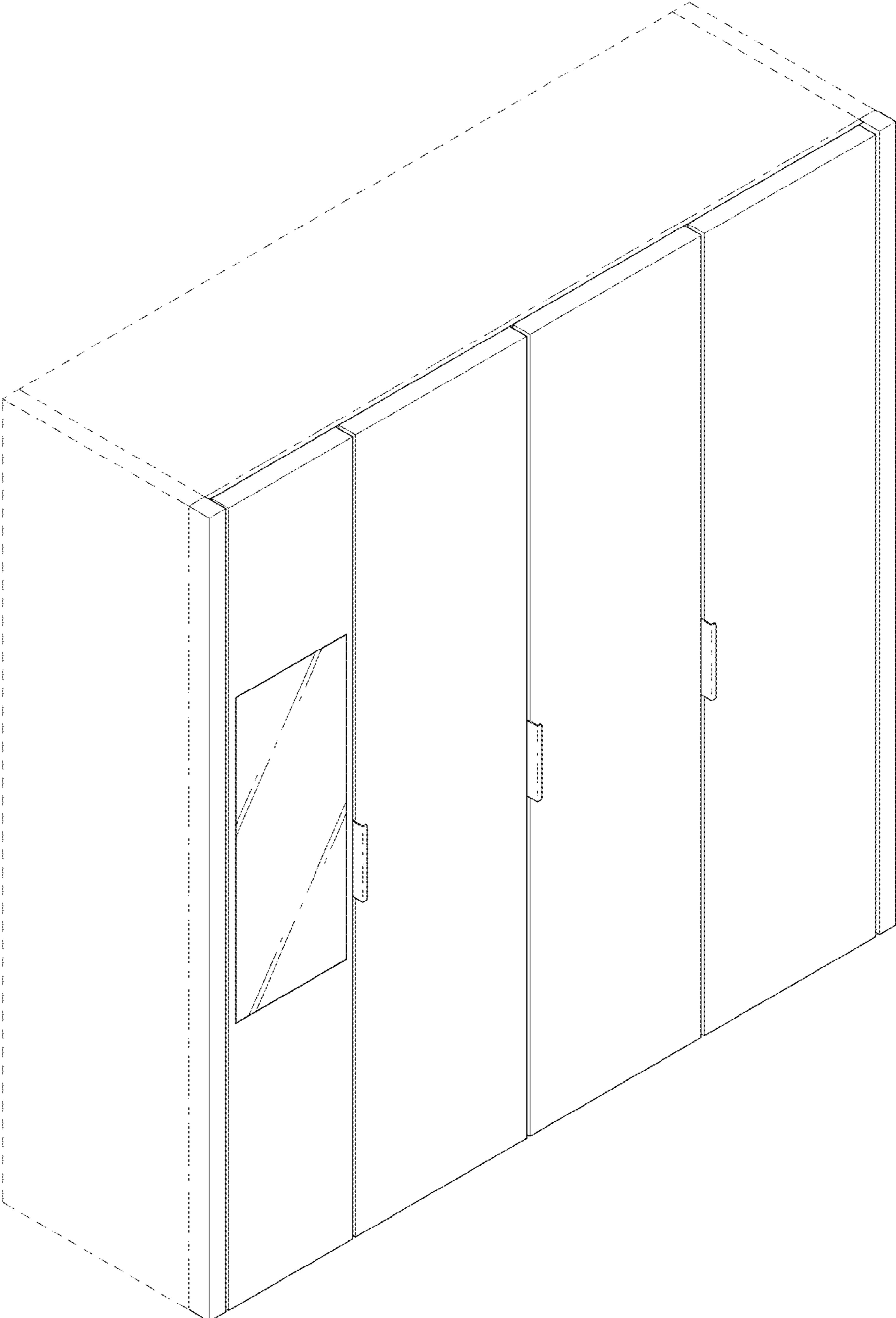

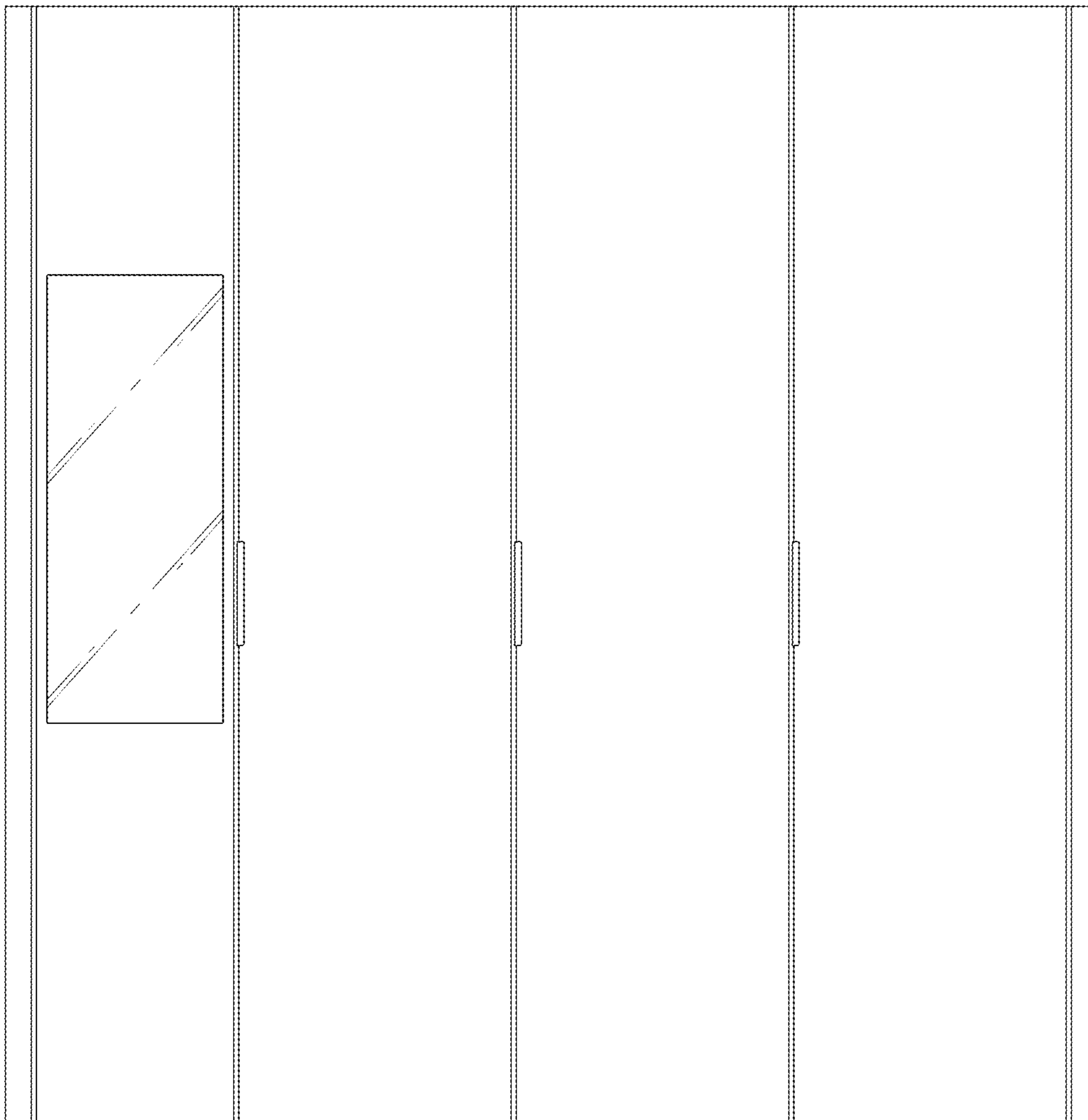

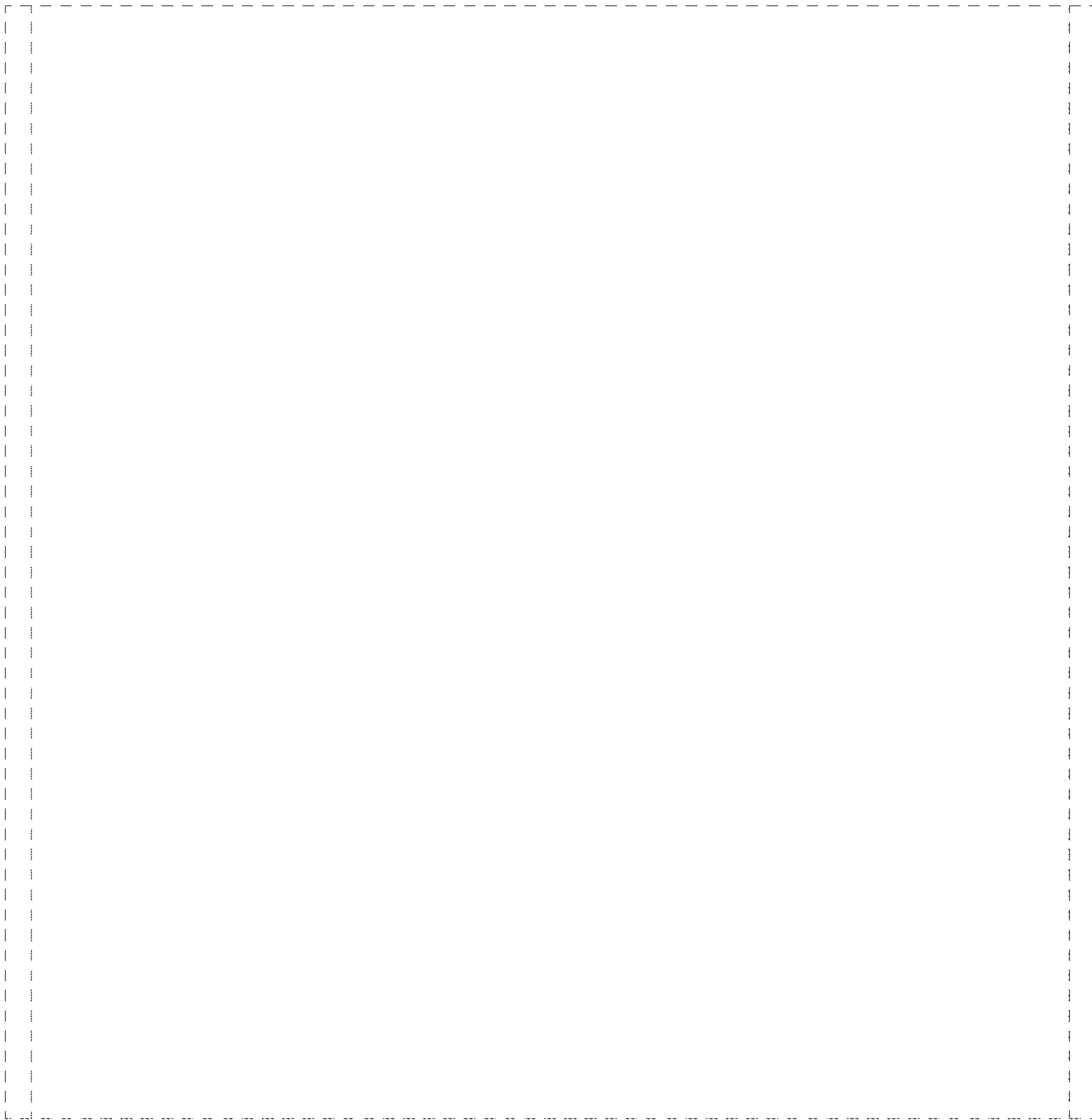

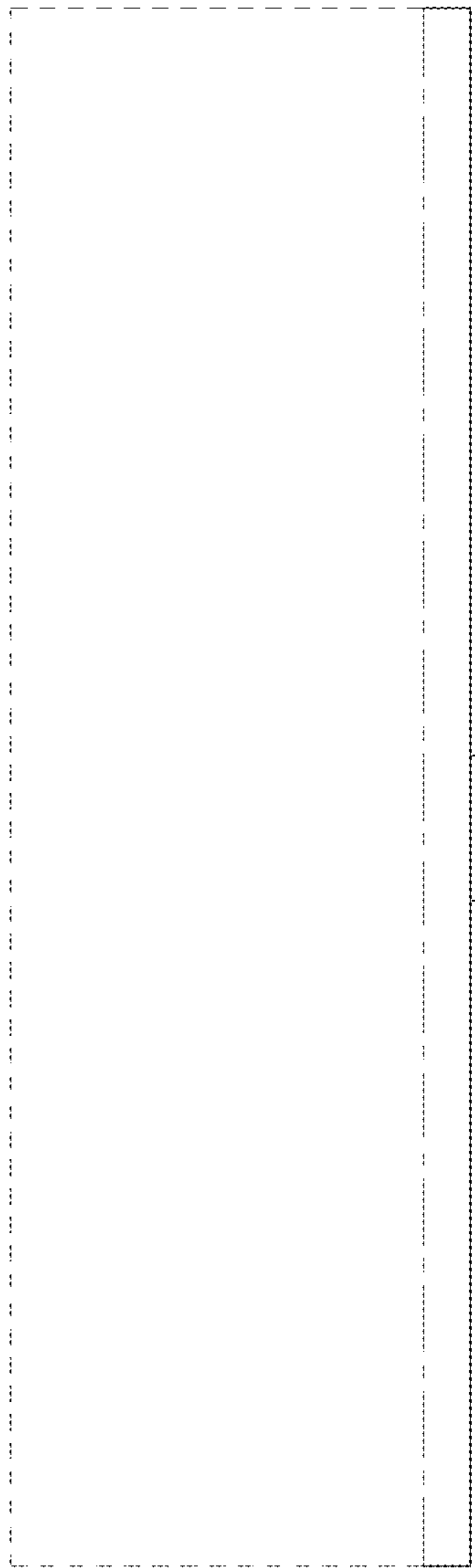

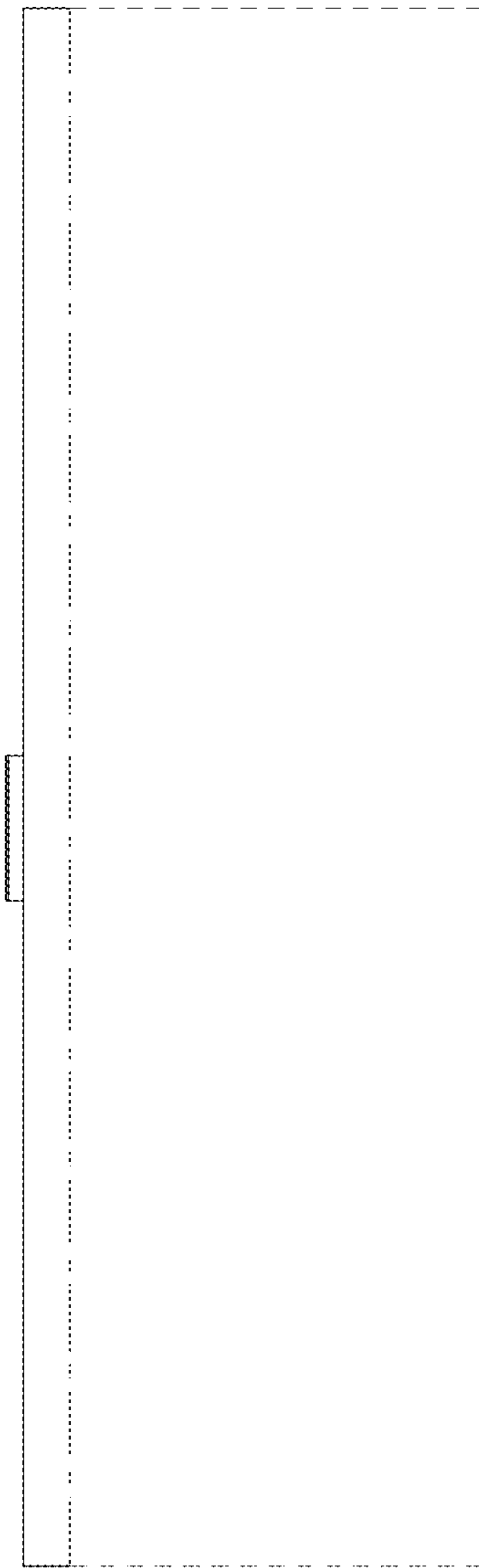
