FIG. 4 is a left-side view of the stenography keyboard;

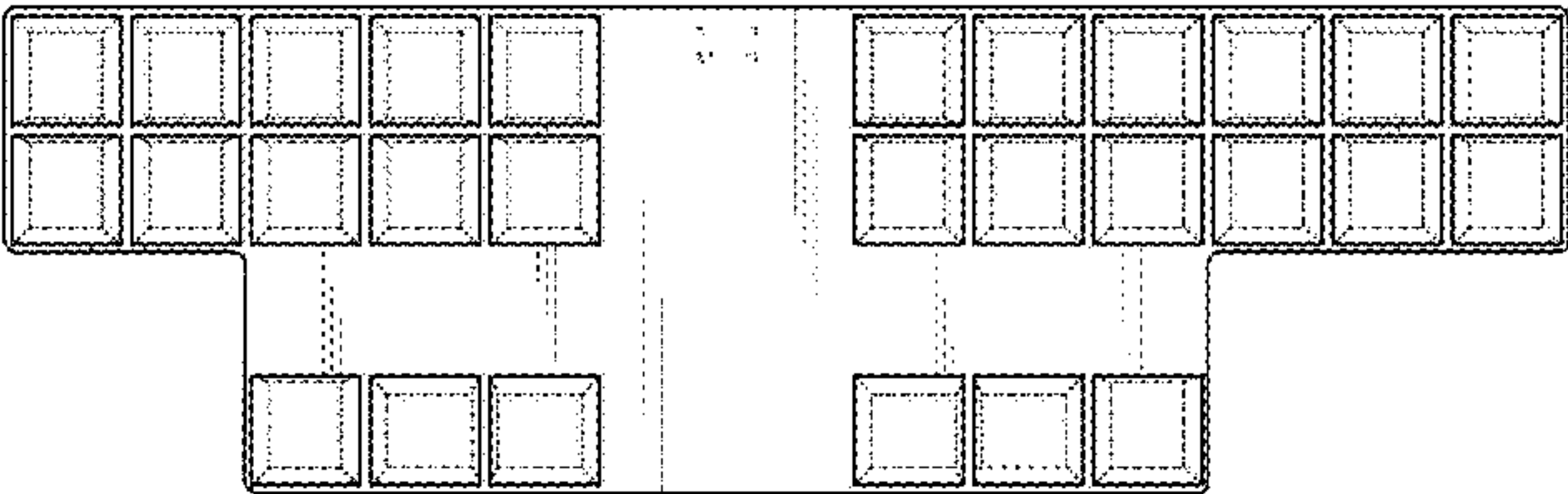
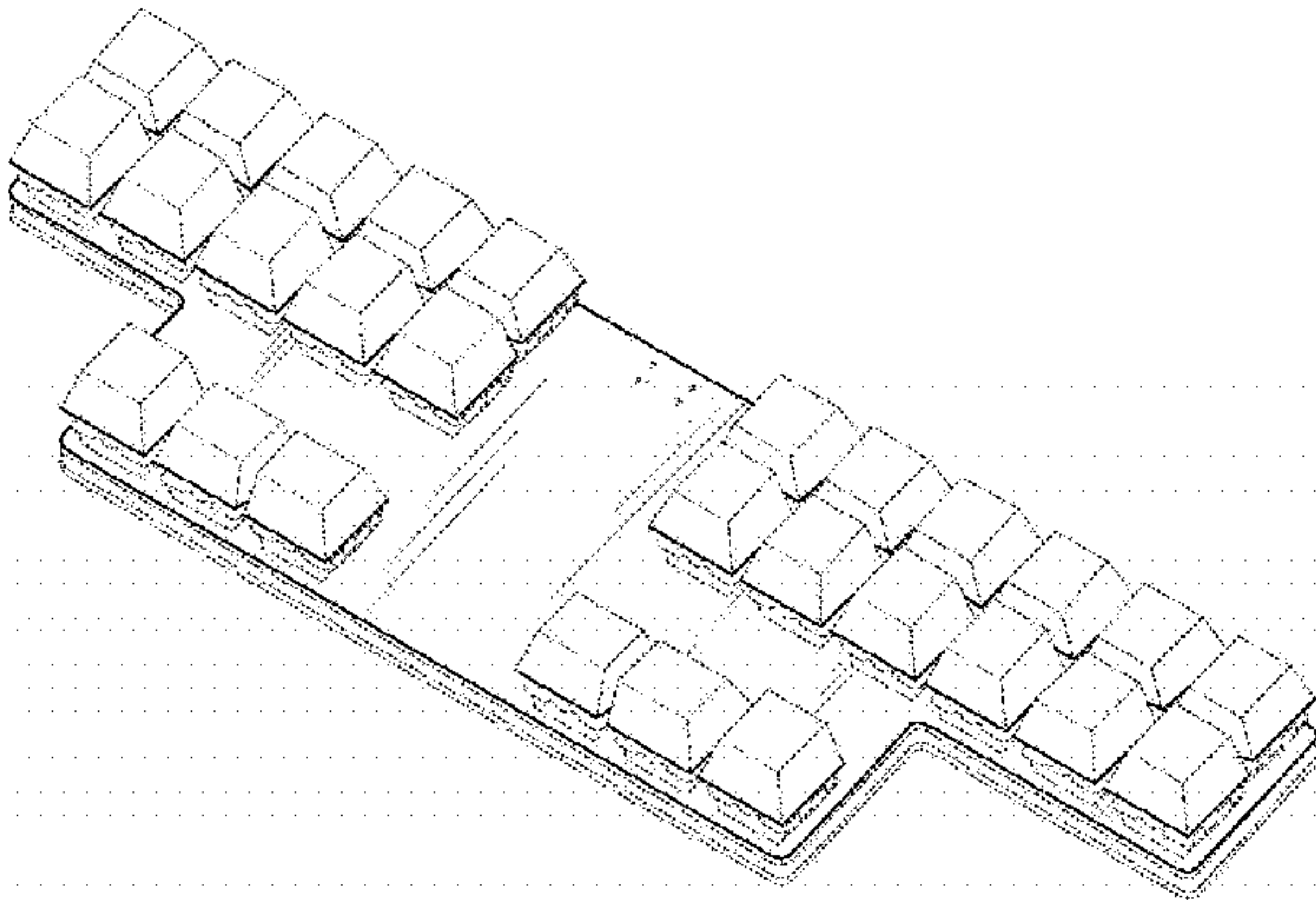
FIG. 5 is a right-side view of the stenography keyboard;

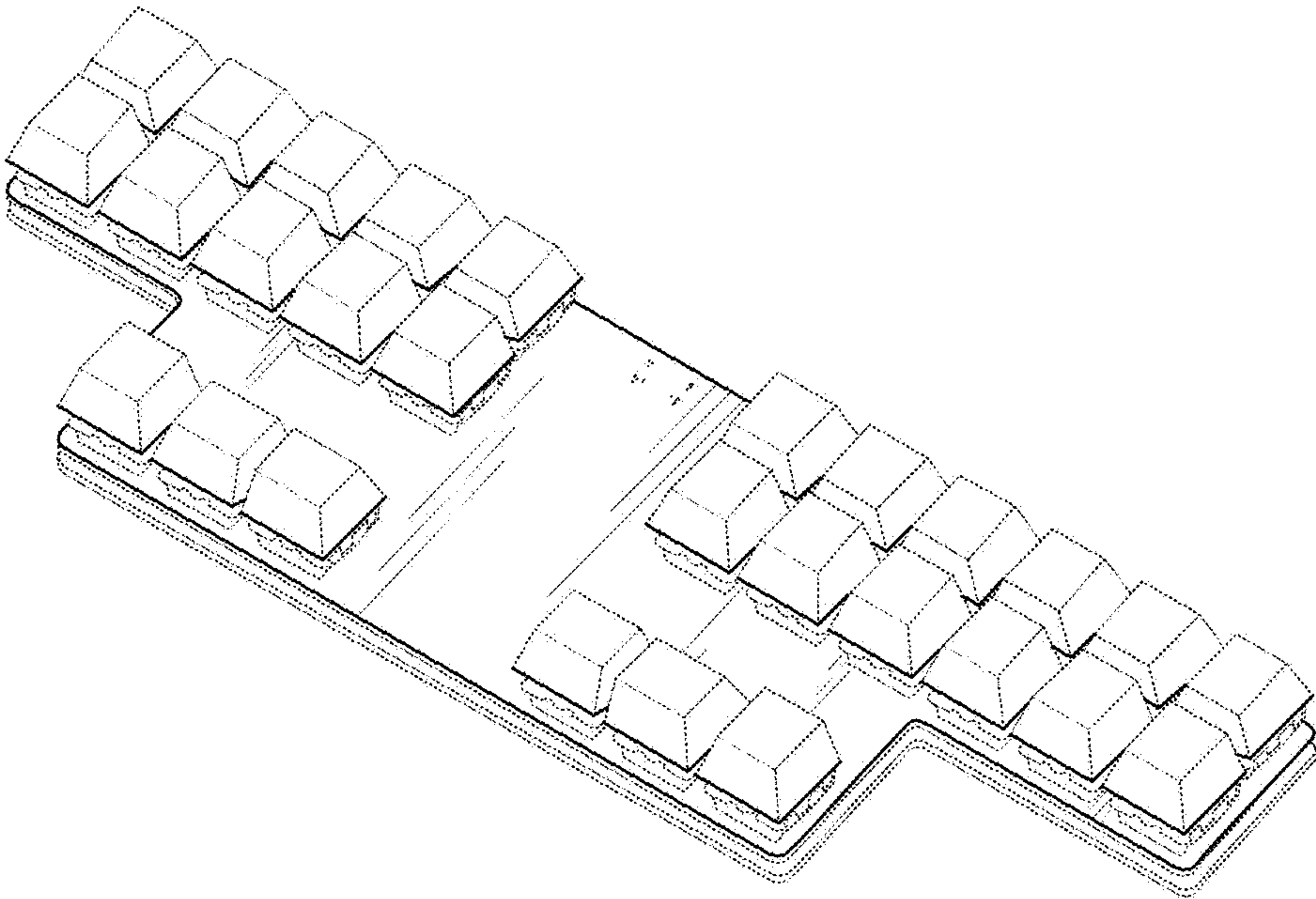

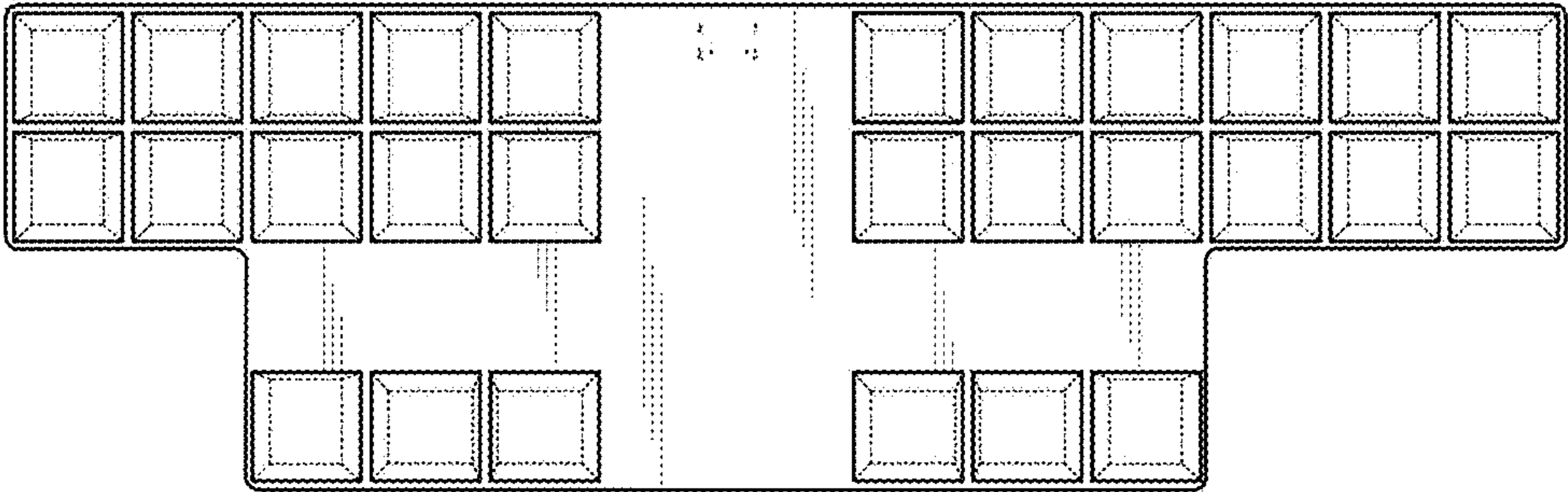

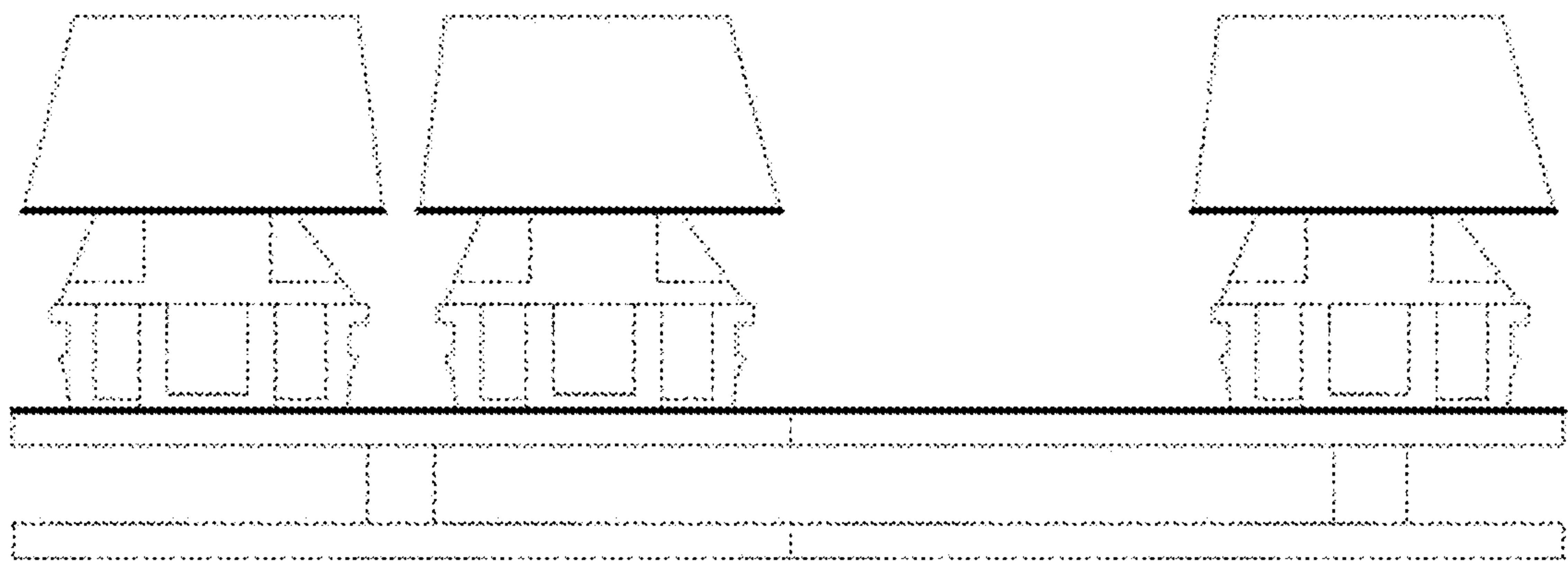

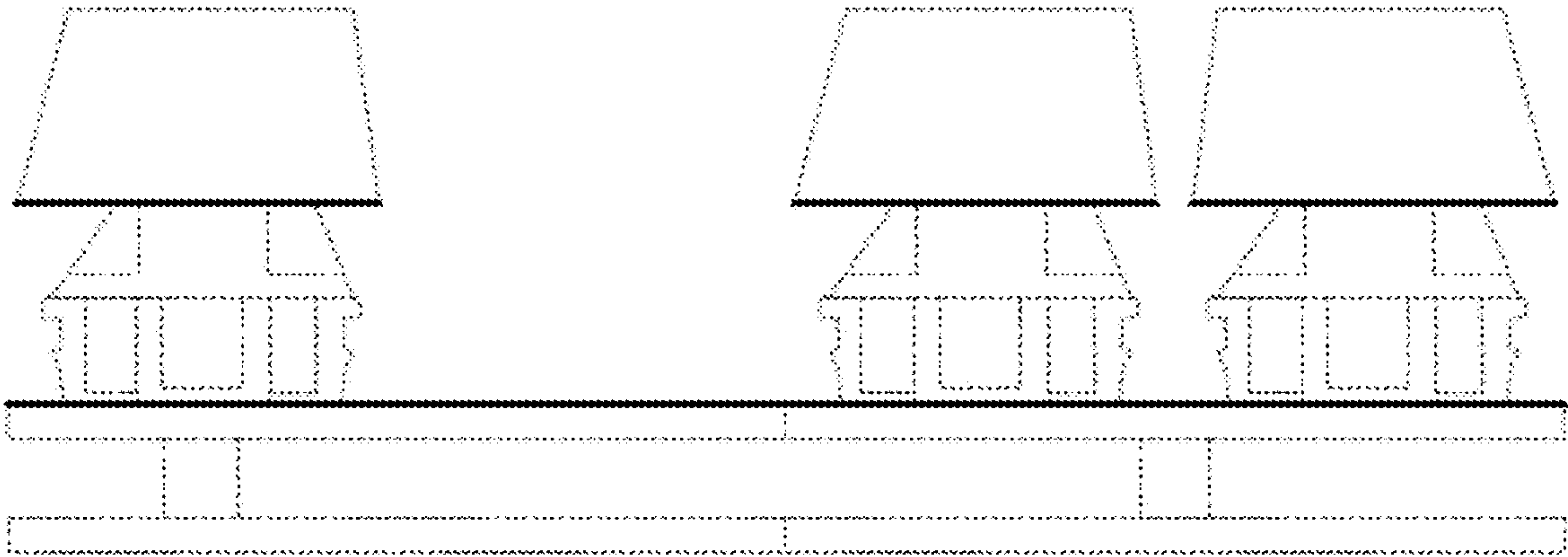

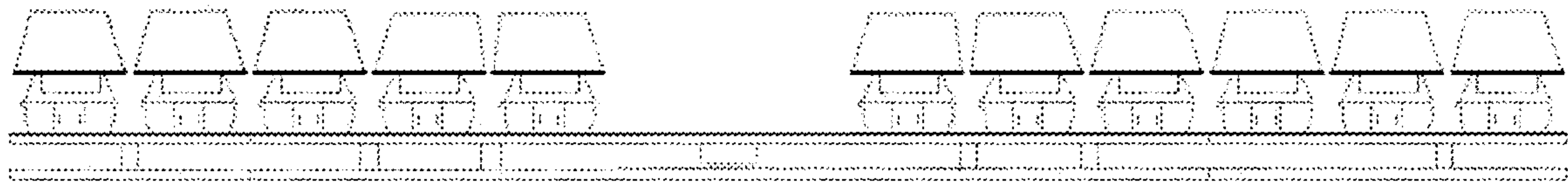
