**DESCRIPTION**

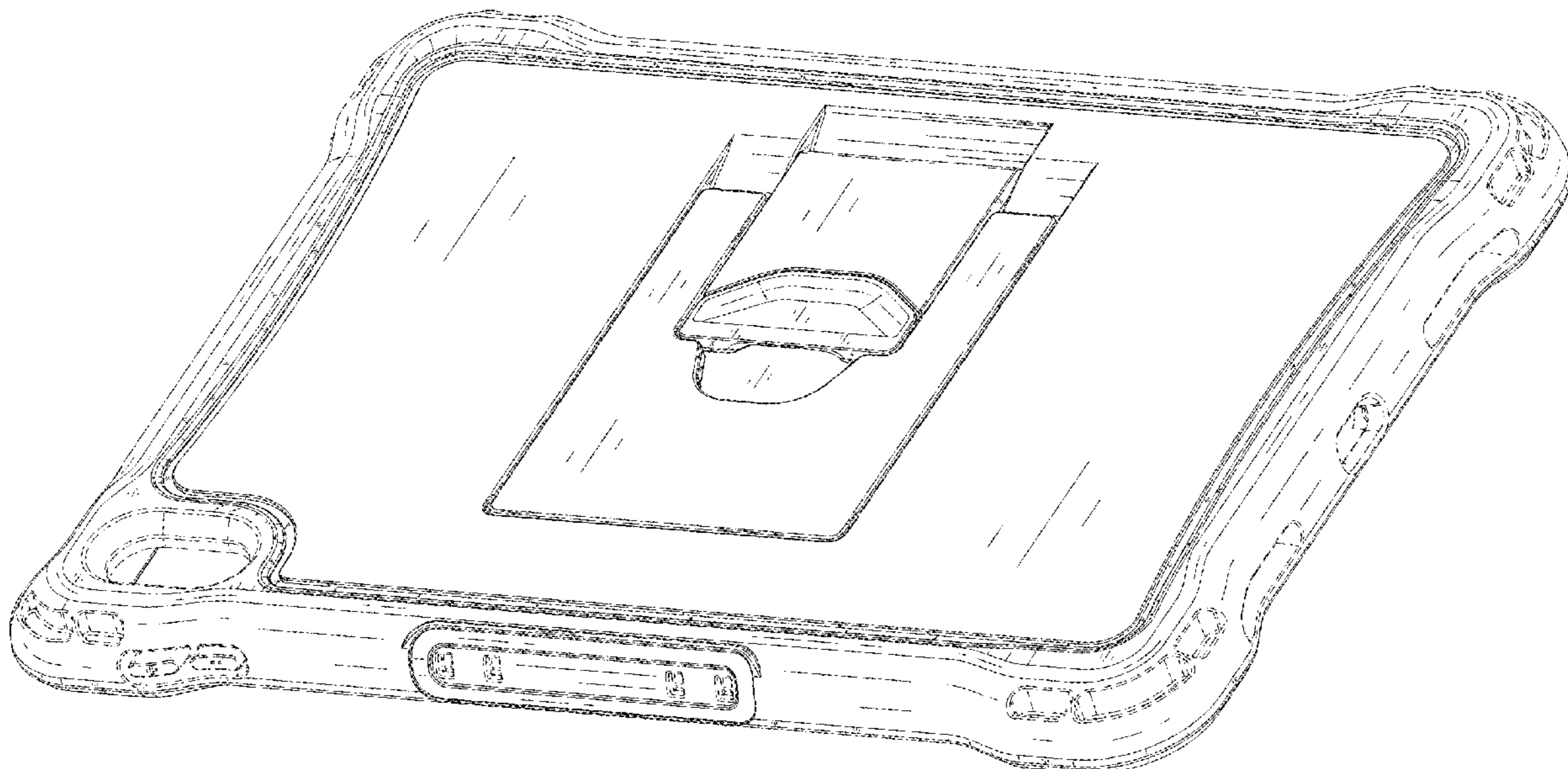

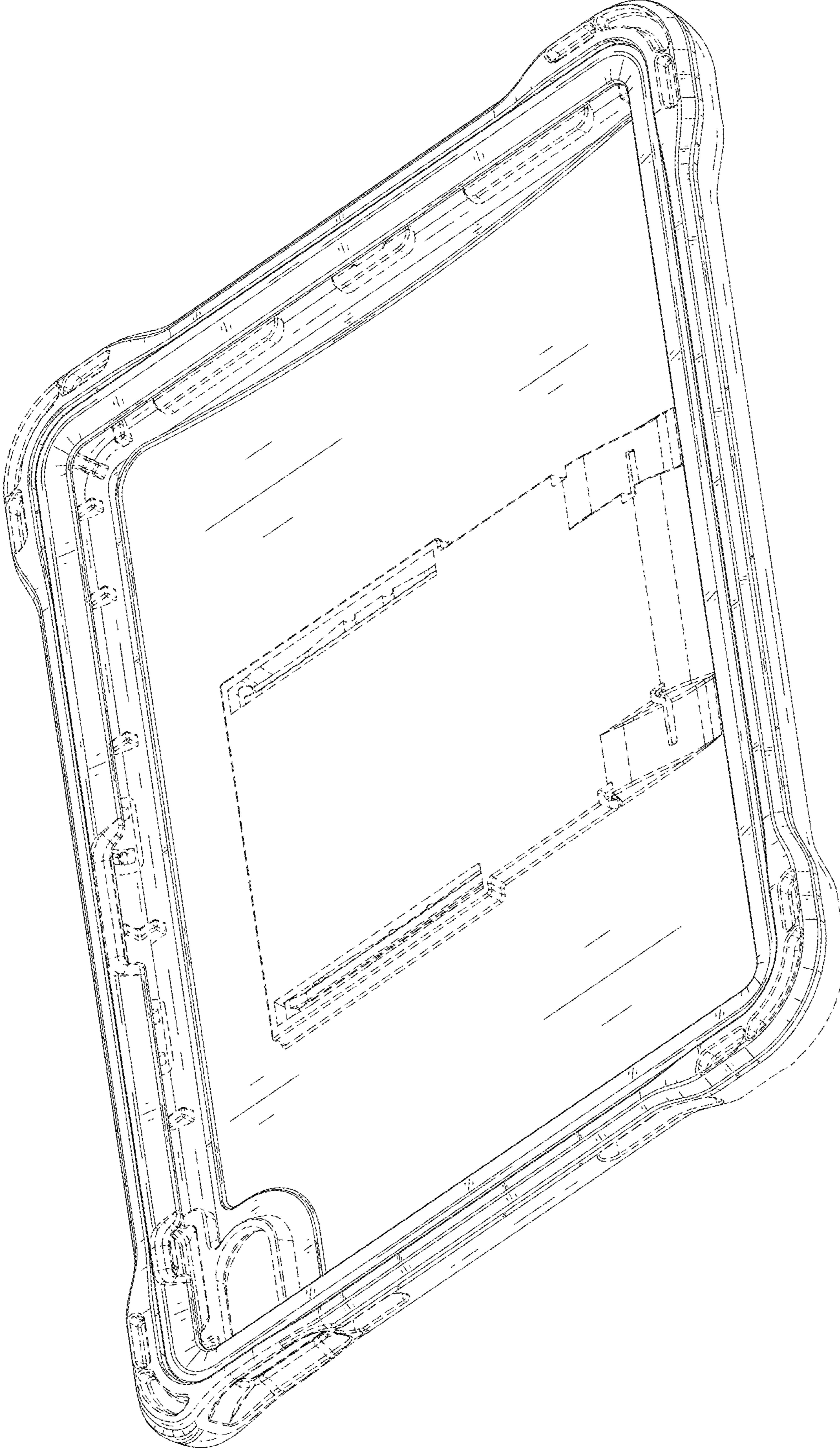

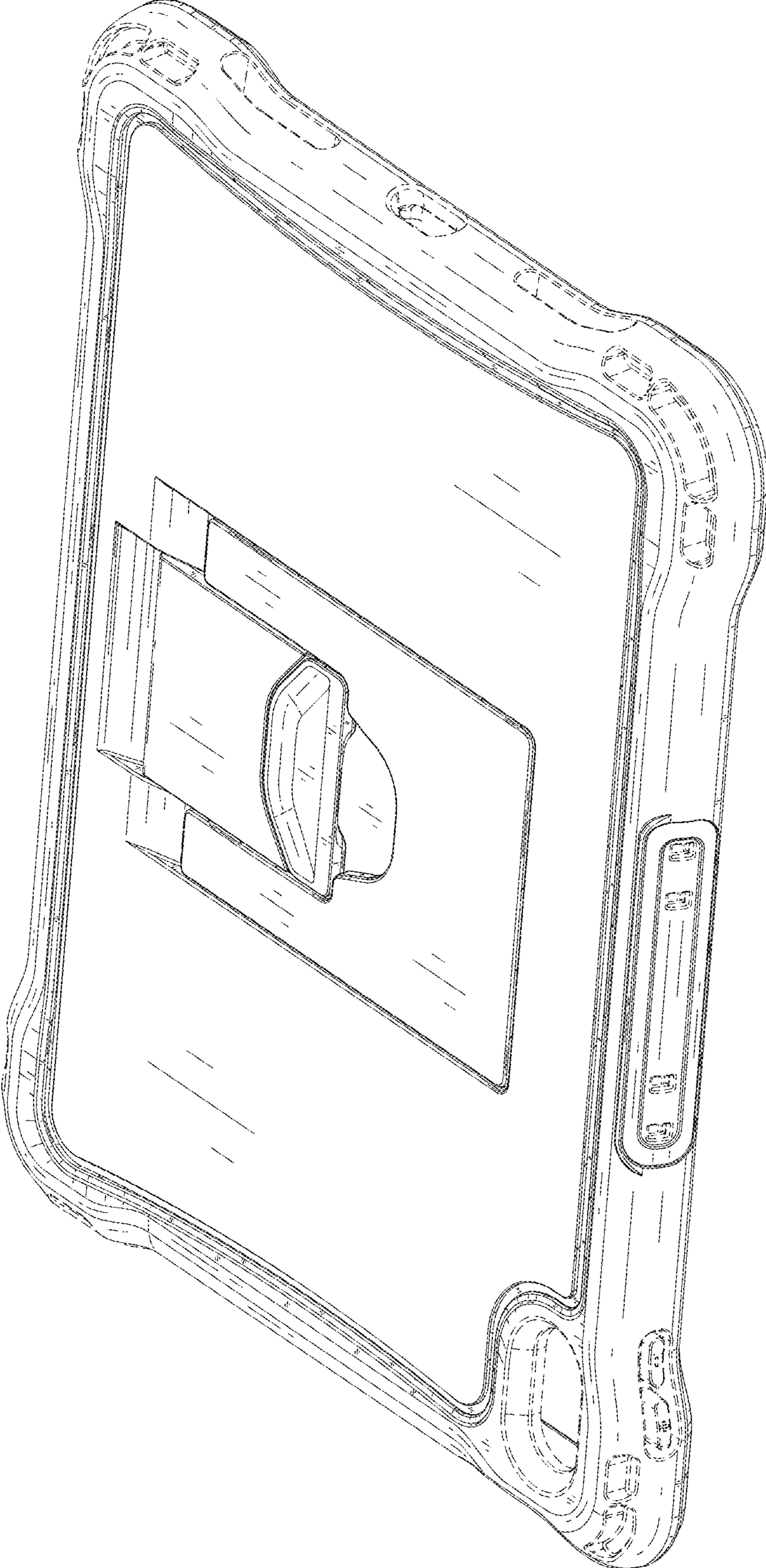

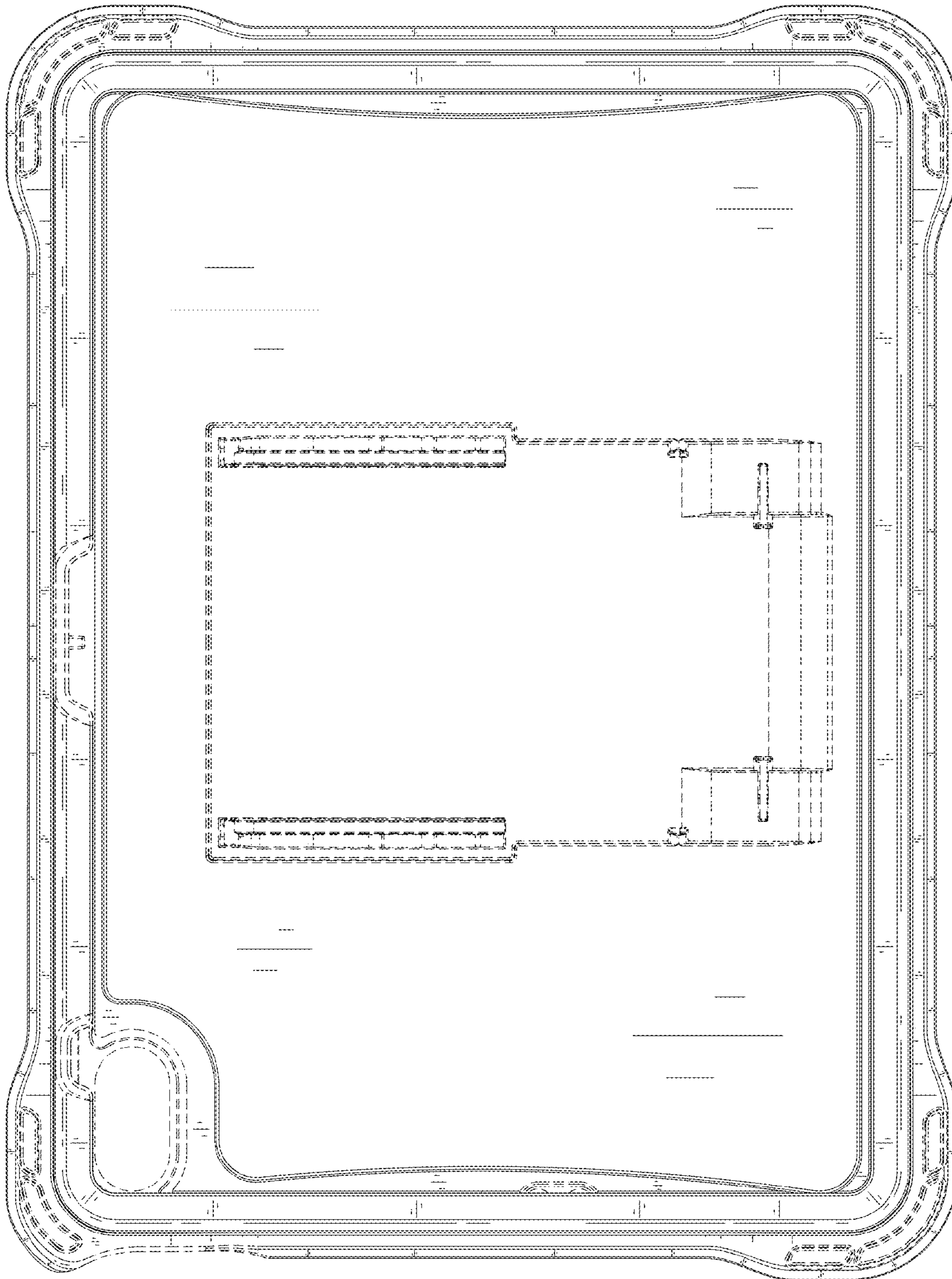

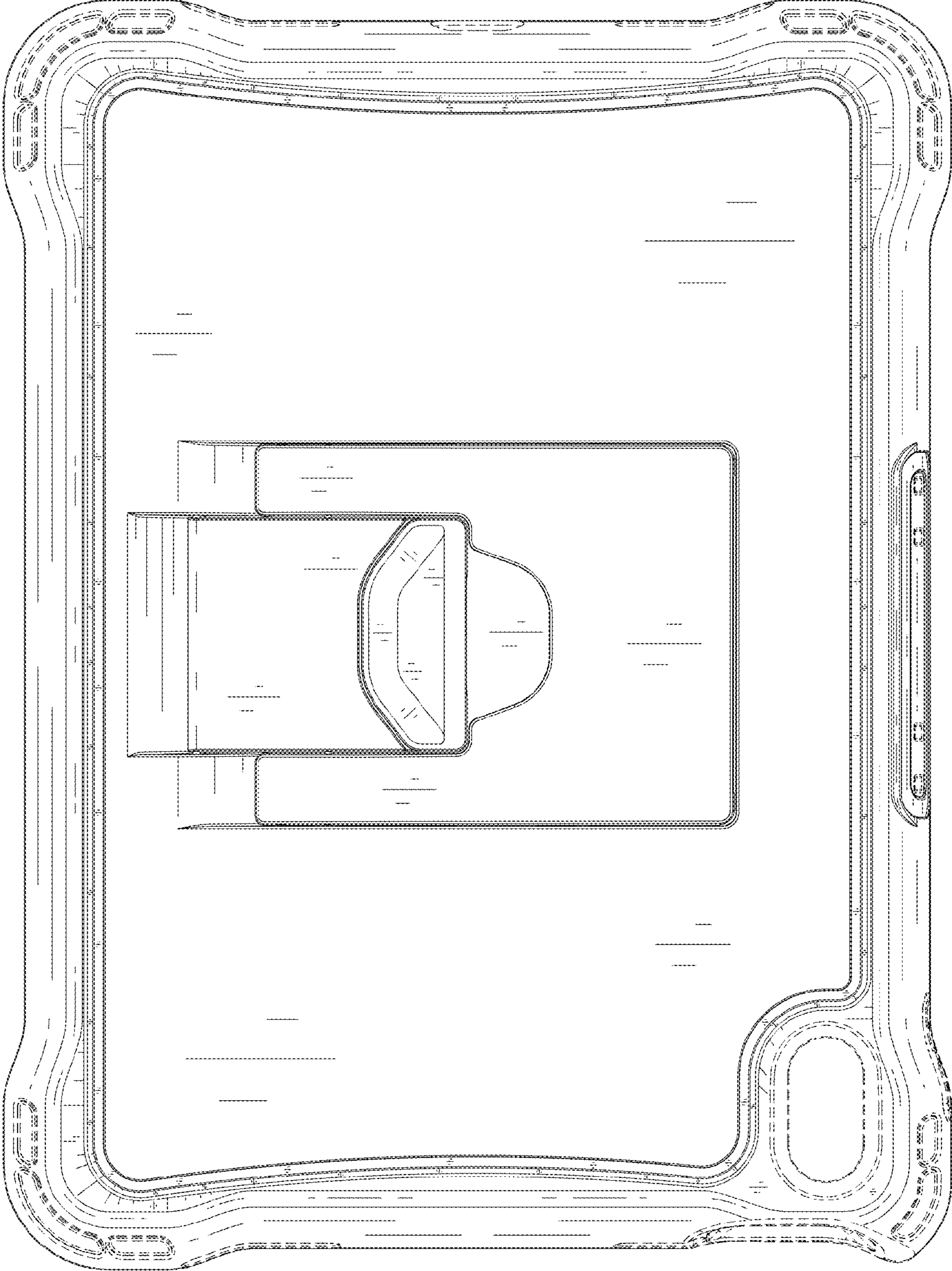

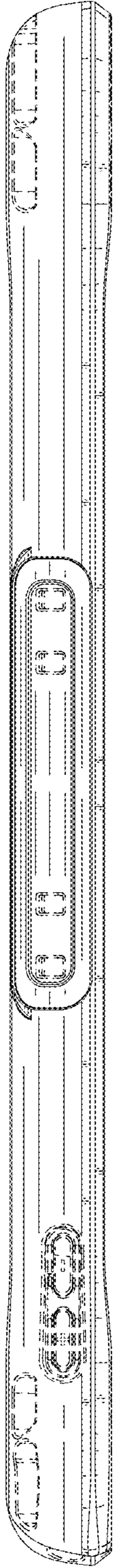

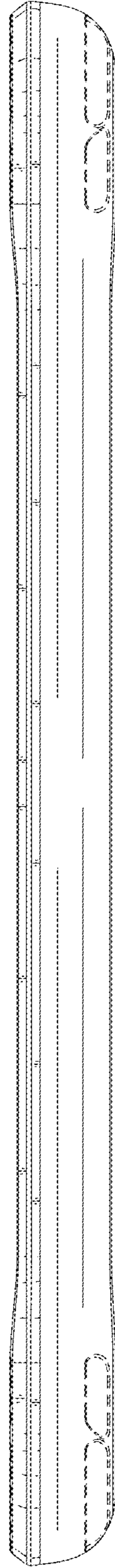
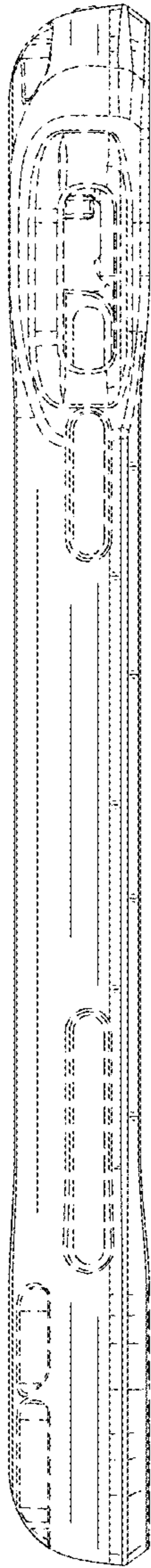
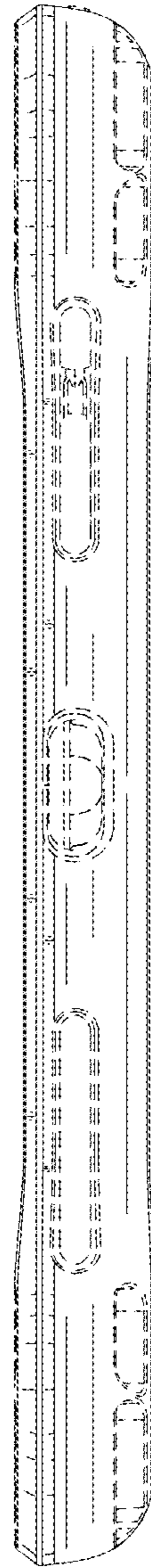
