The ornamental design for a card, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and left side of the card showing my new design;  
FIG. 2 is a front elevation view thereof;

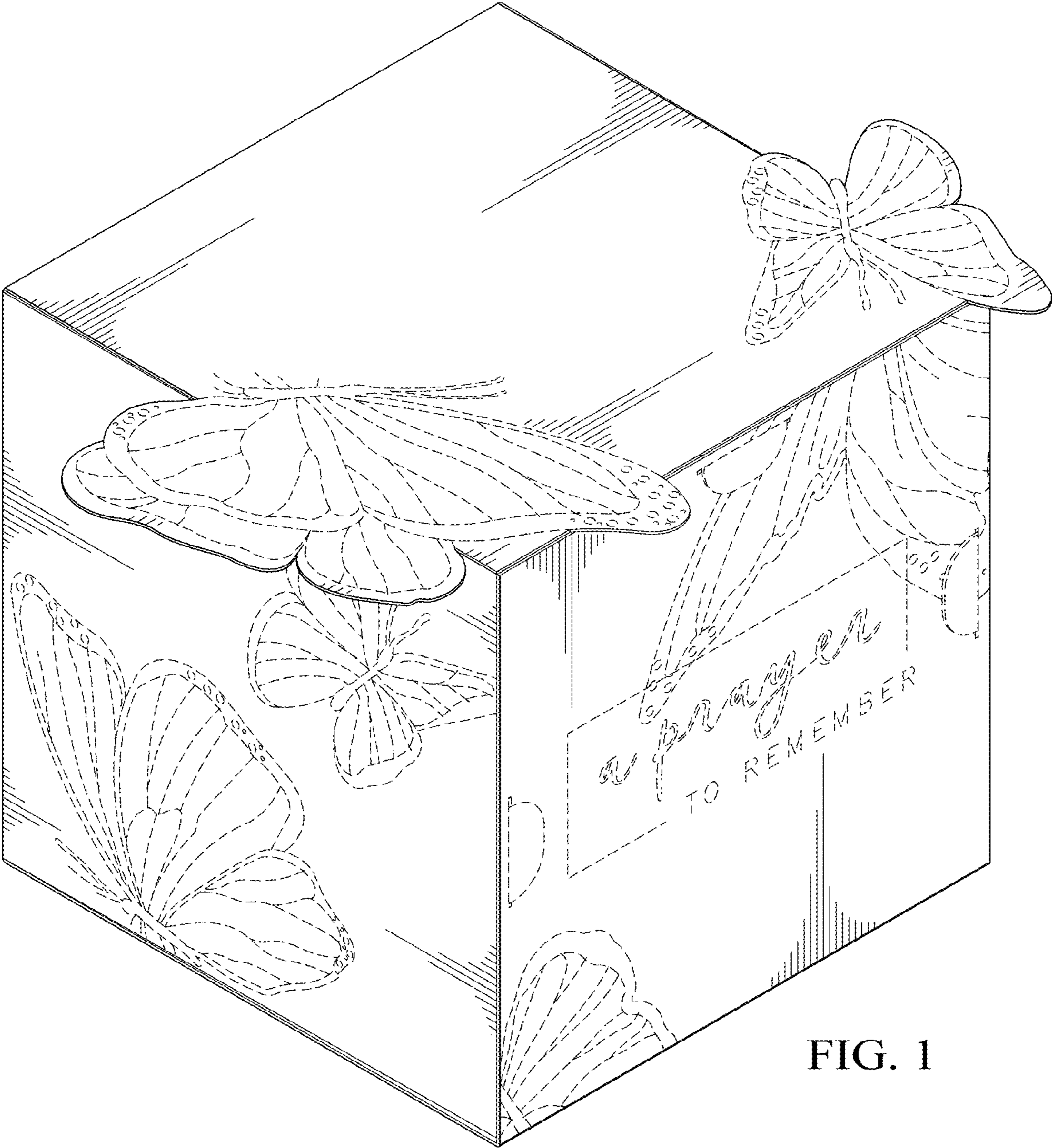

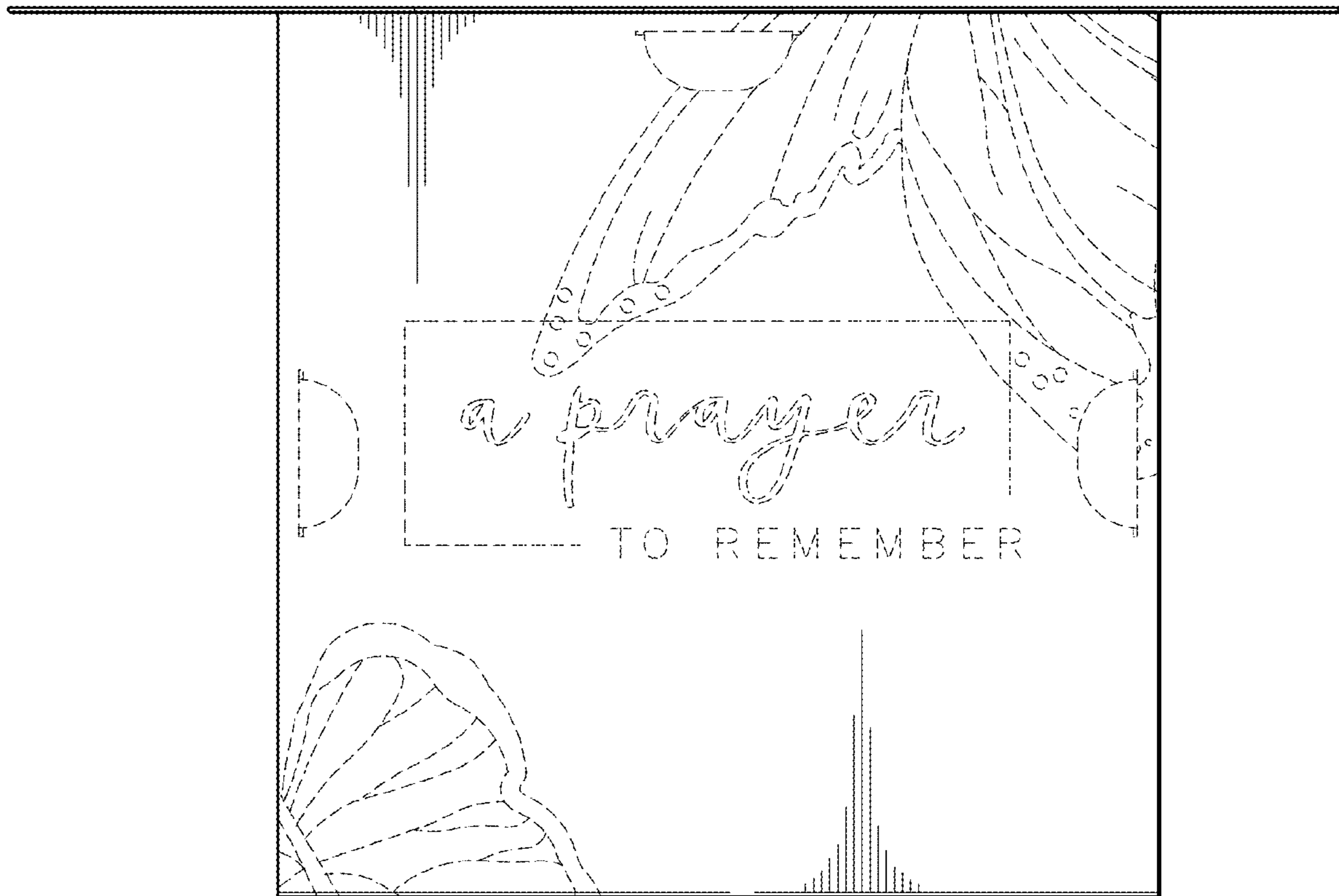

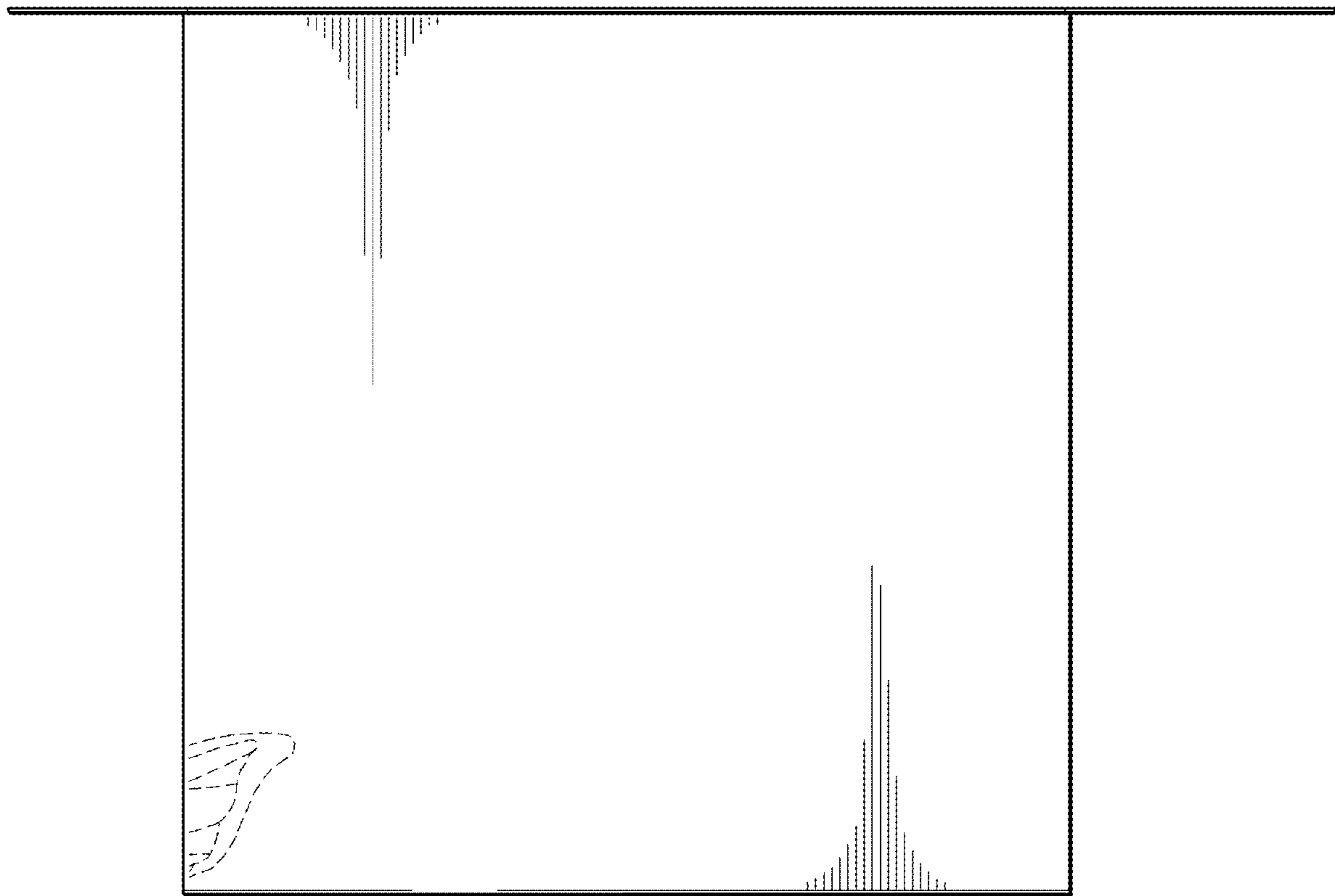

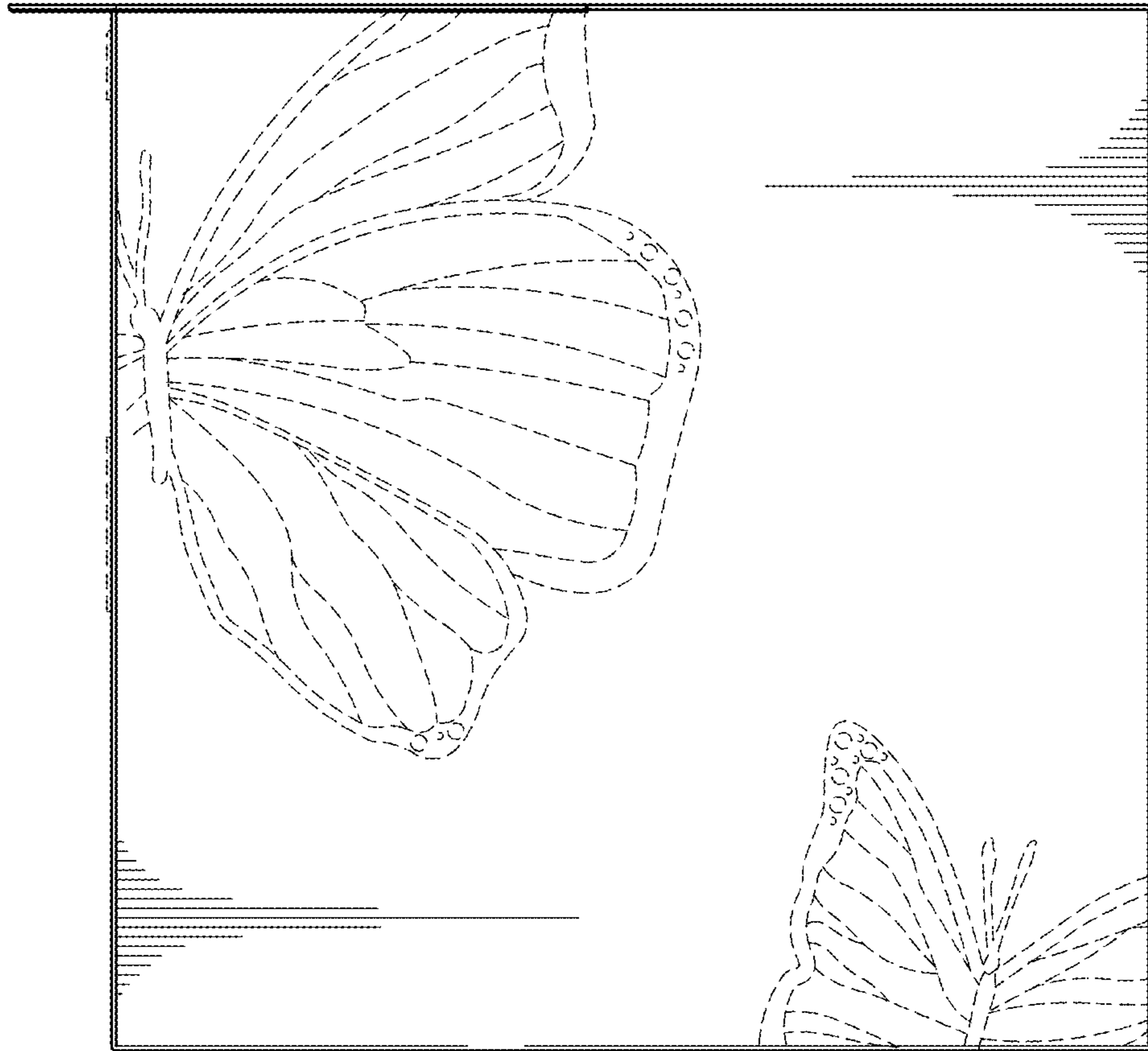

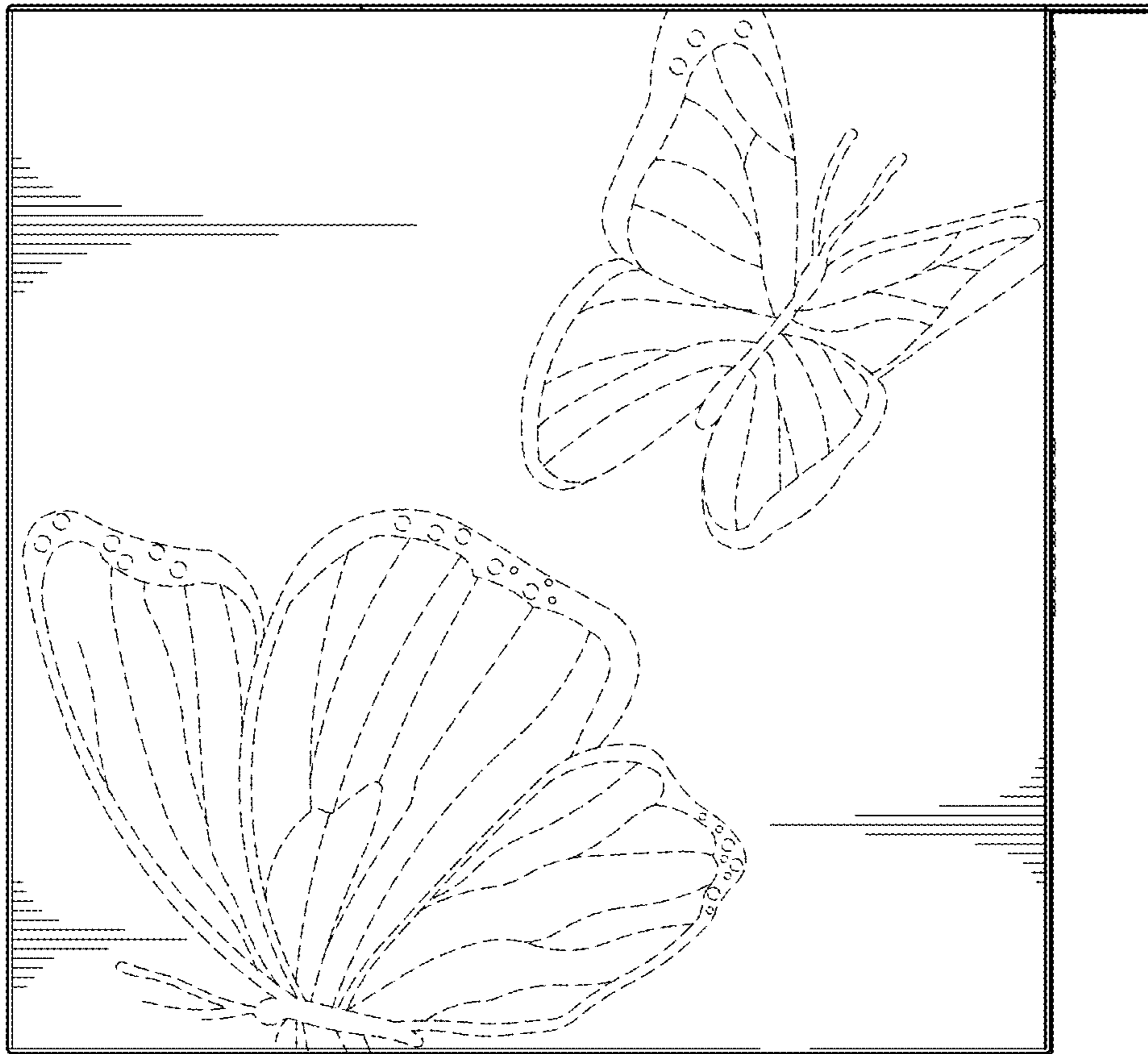

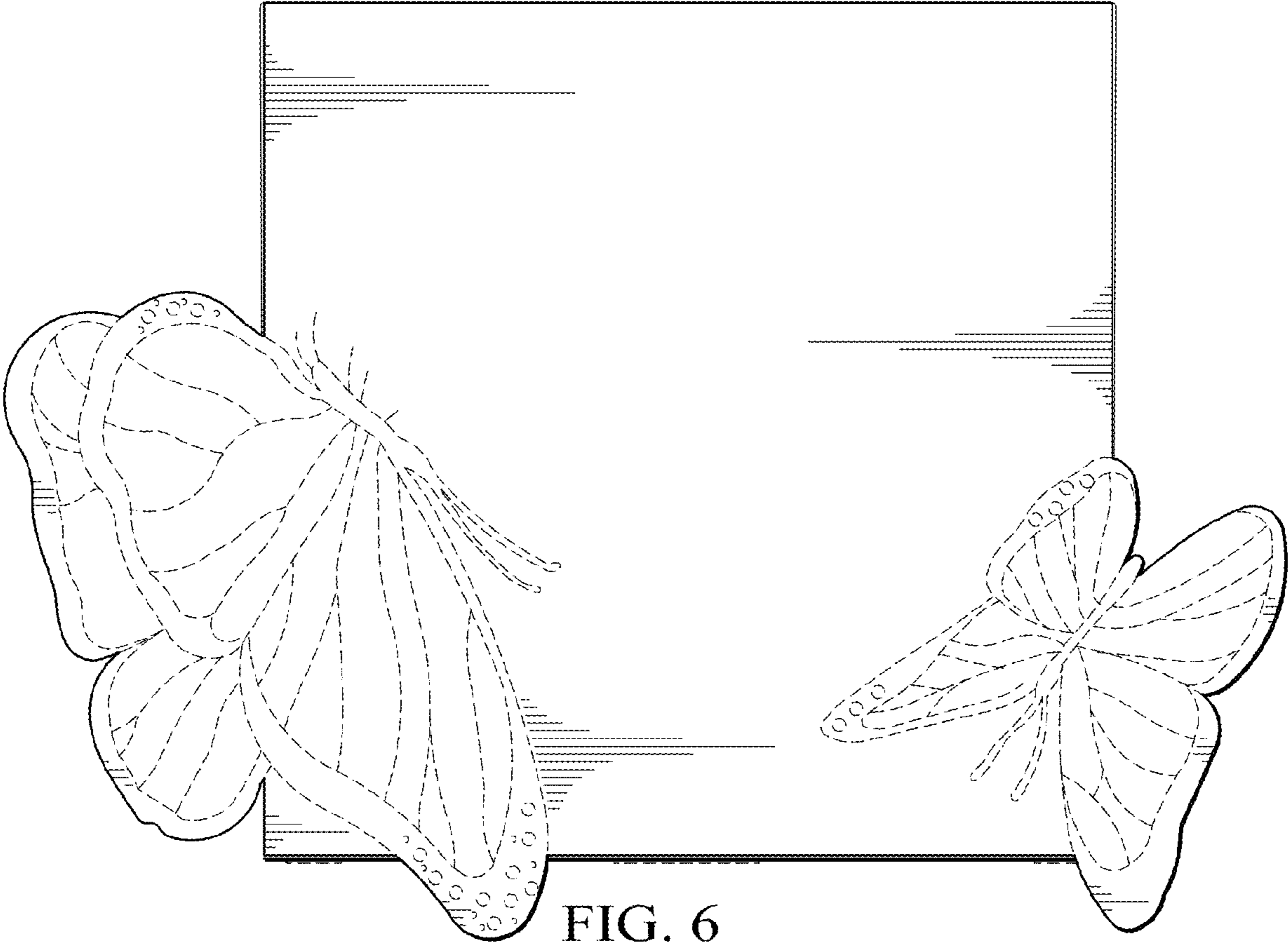

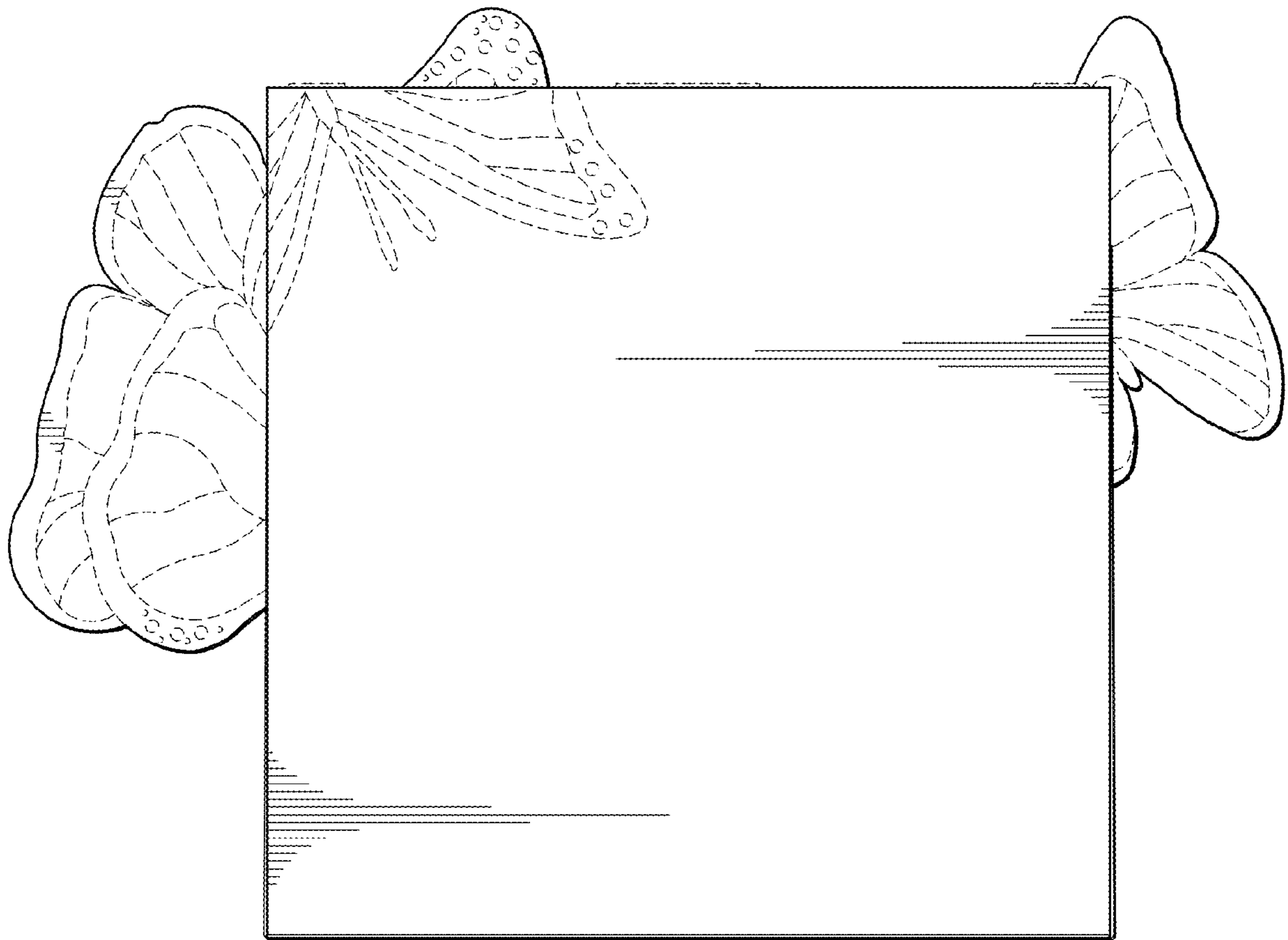

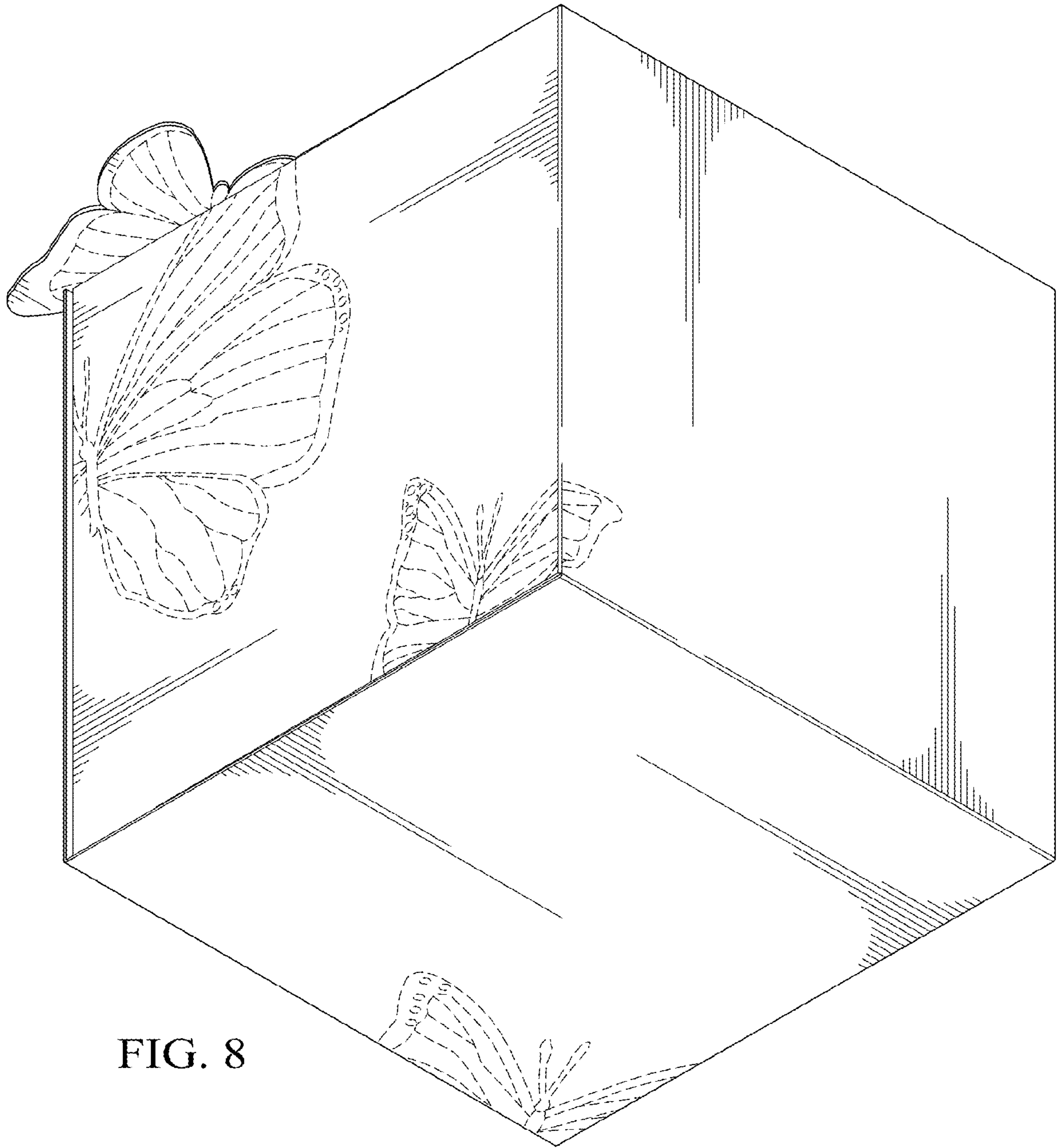

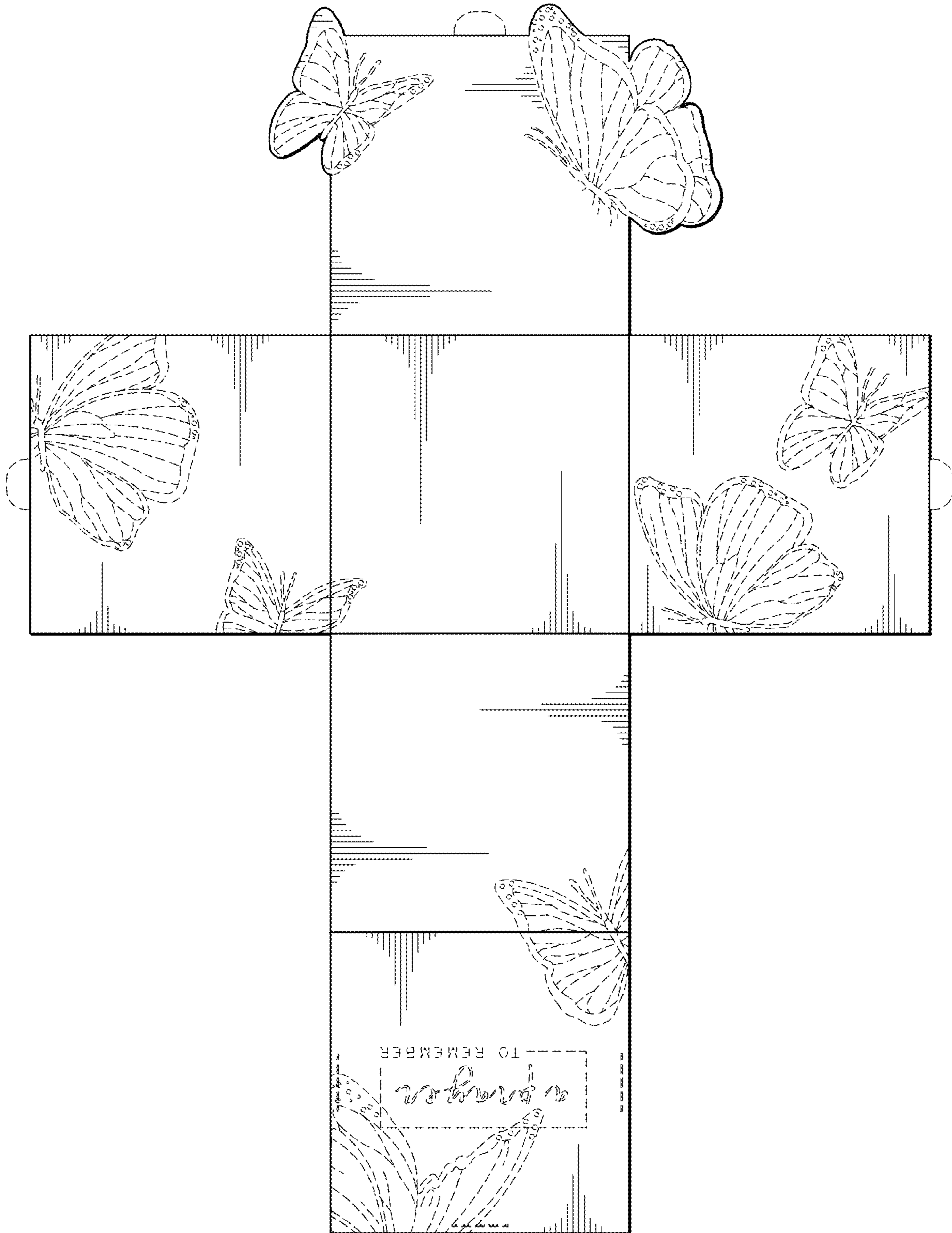

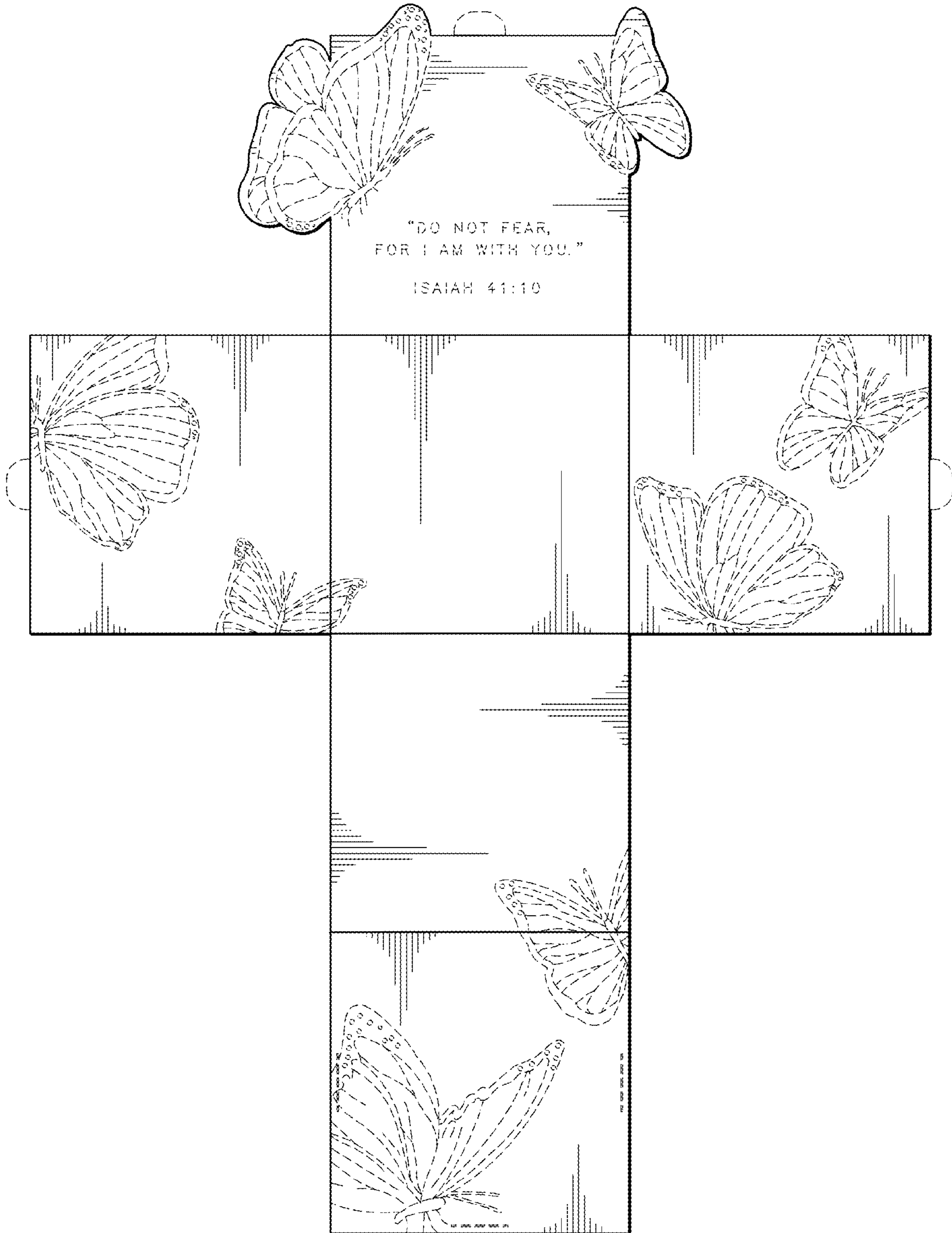
