The ornamental design for a puzzle, as shown and described.

DESCRIPTION

FIG. 25 shows a top plan view thereof.

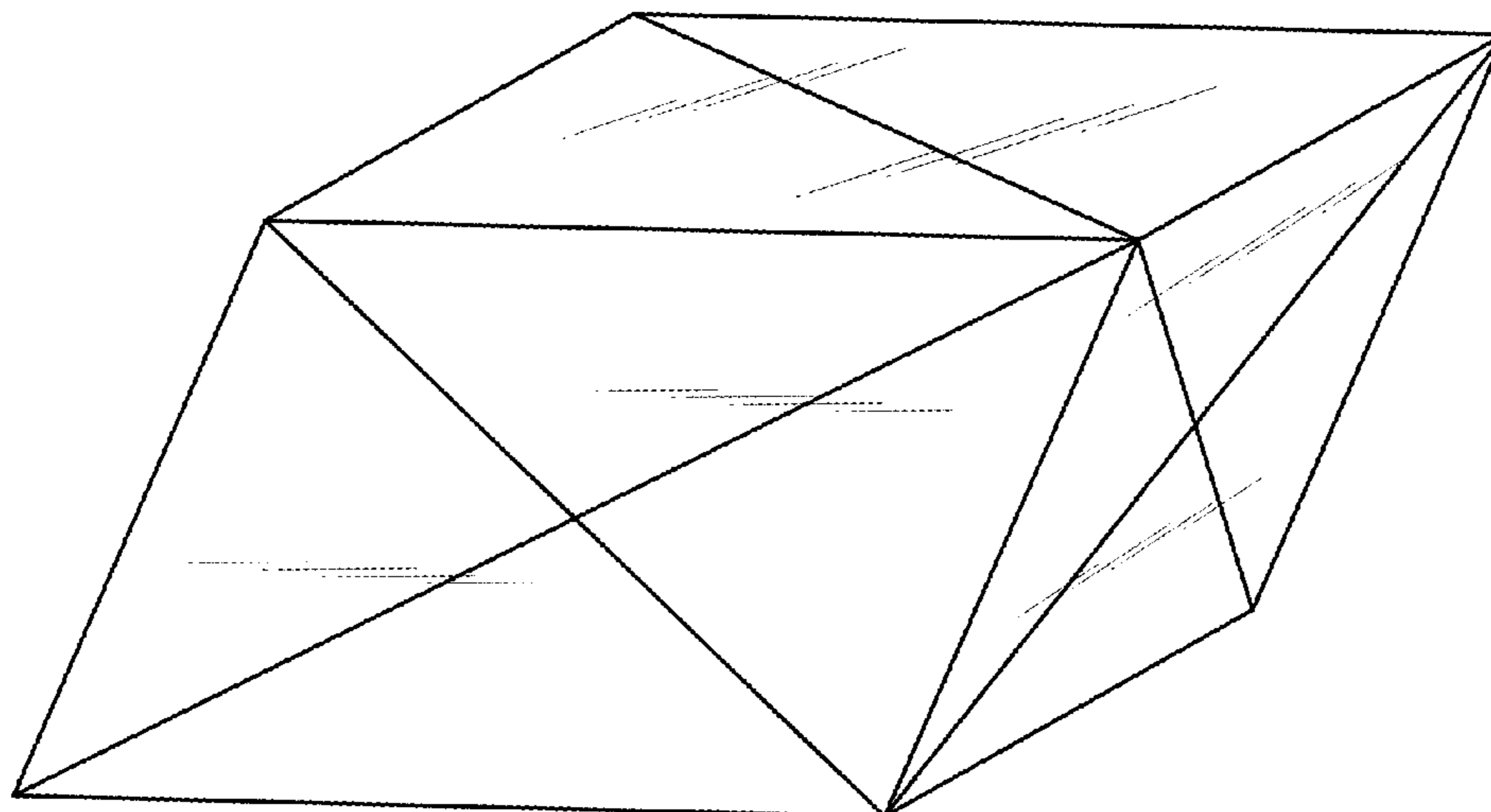
FIG. 26 shows a bottom plan view thereof.

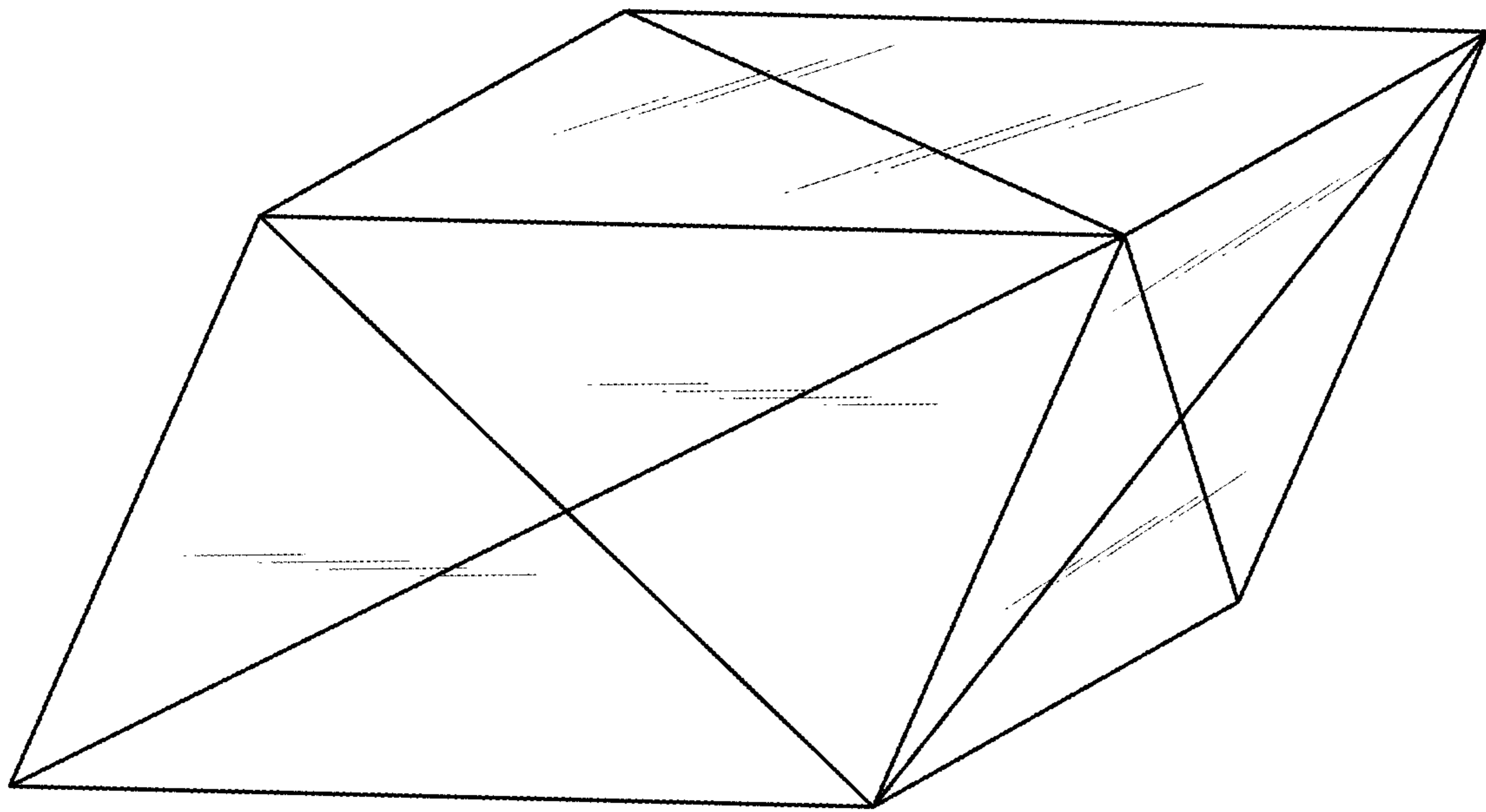

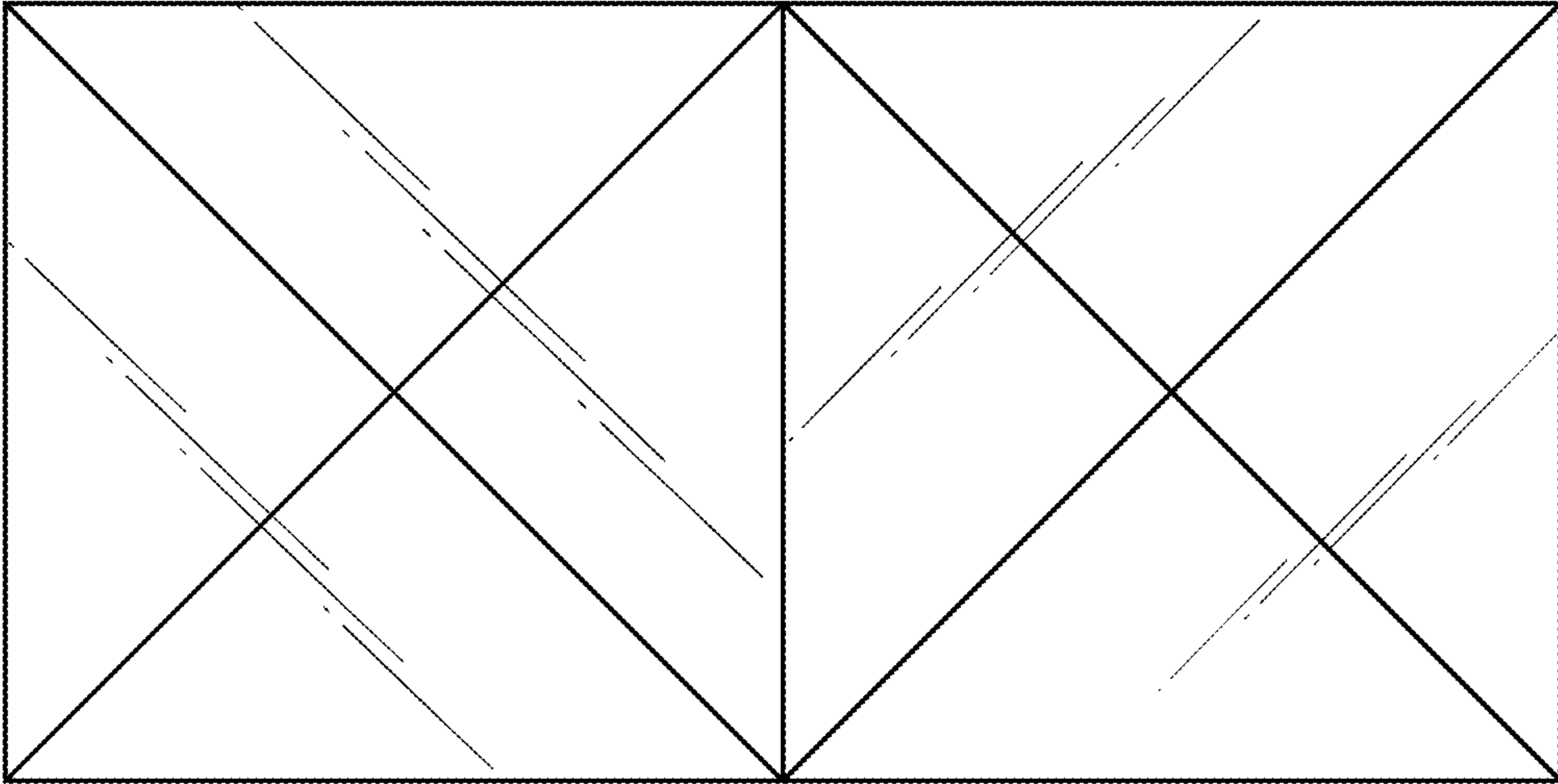

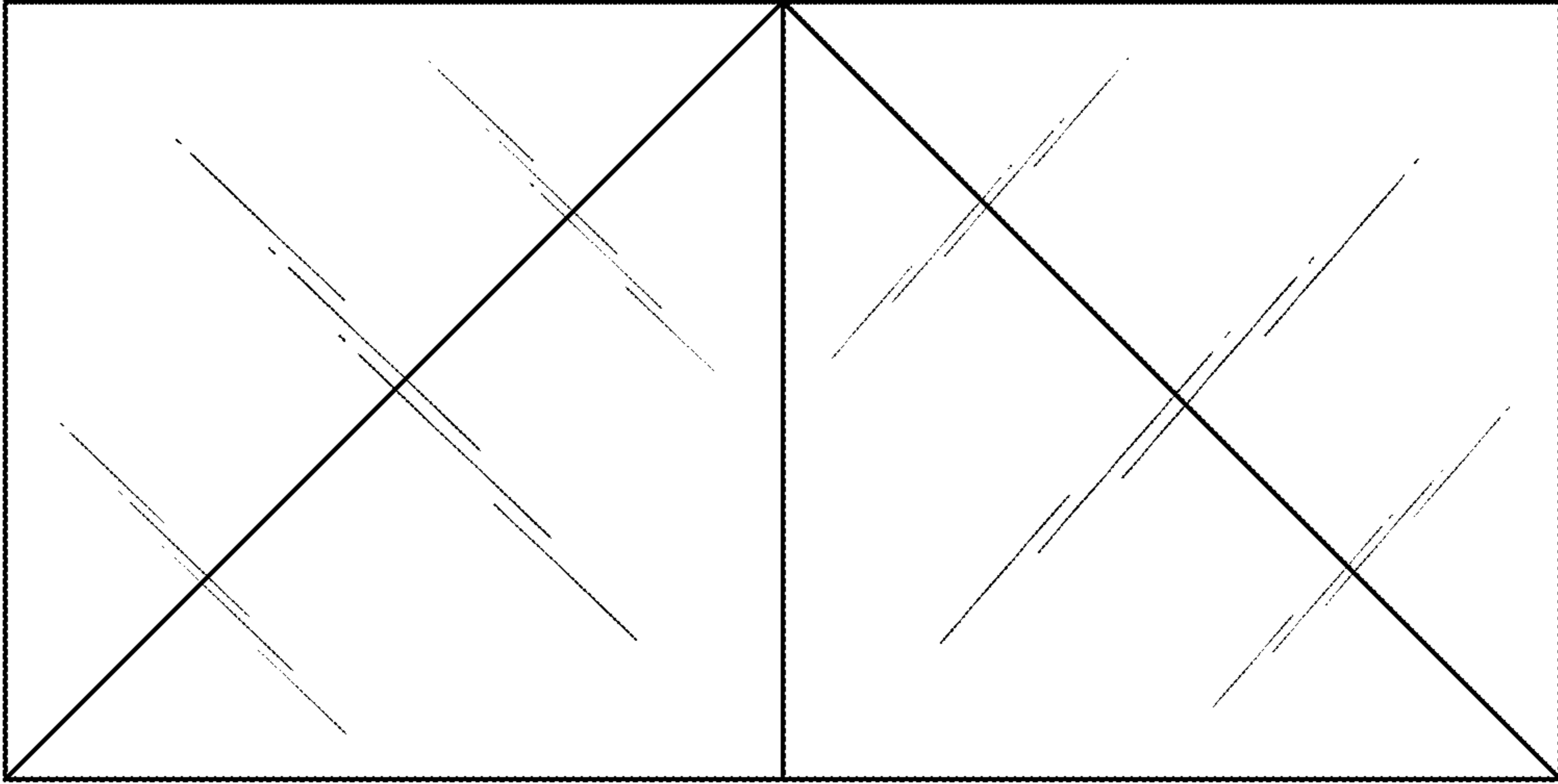

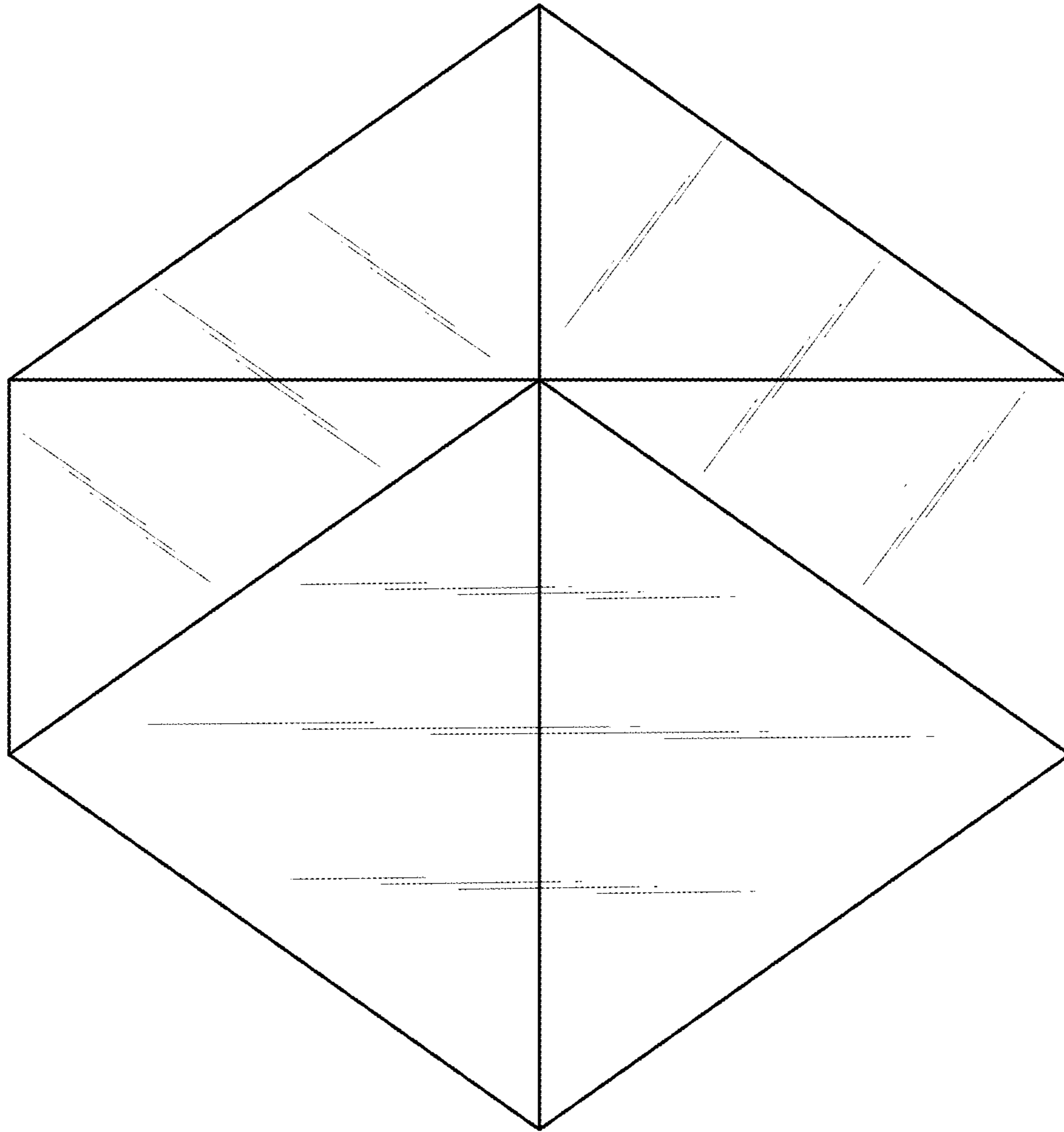

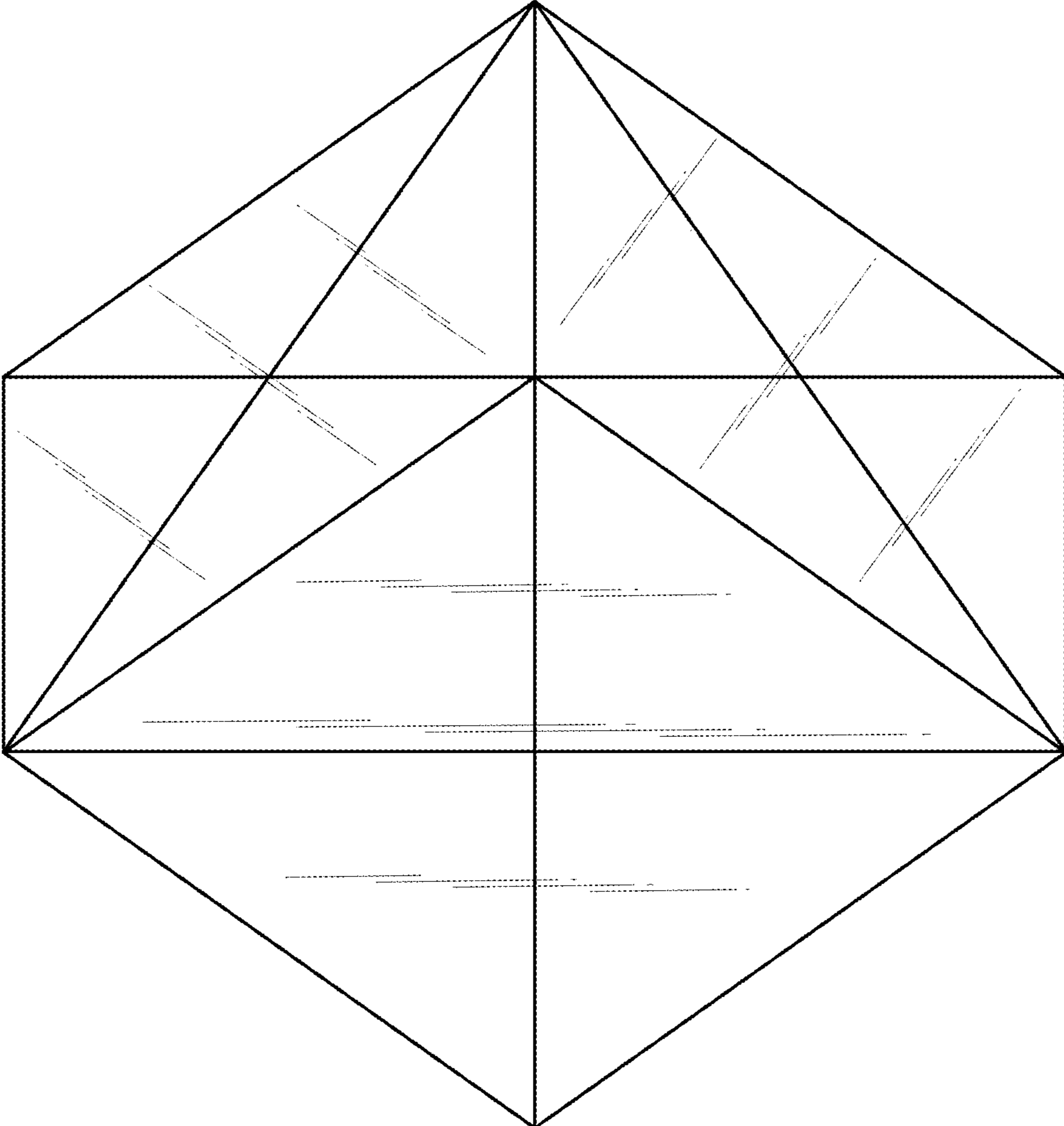

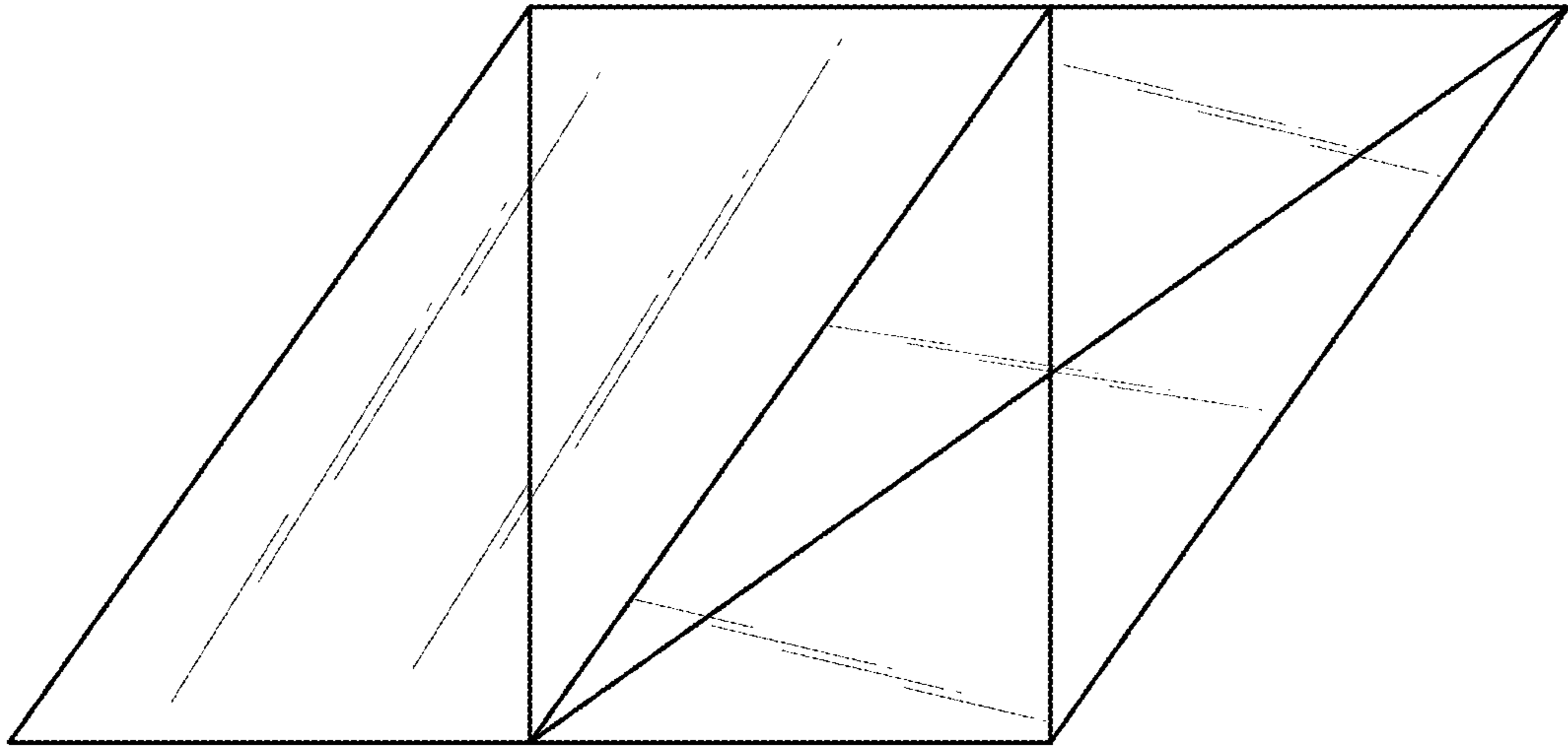

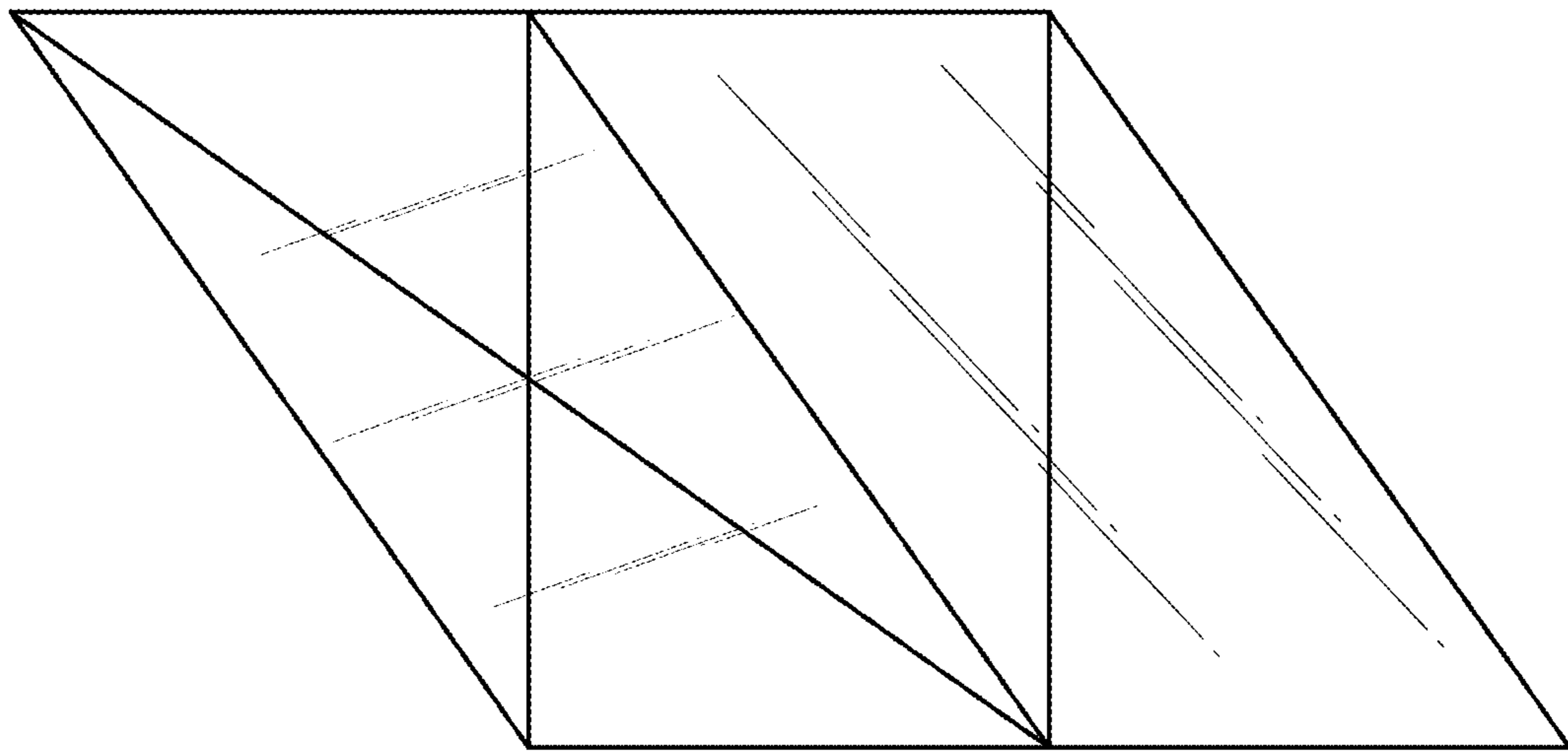

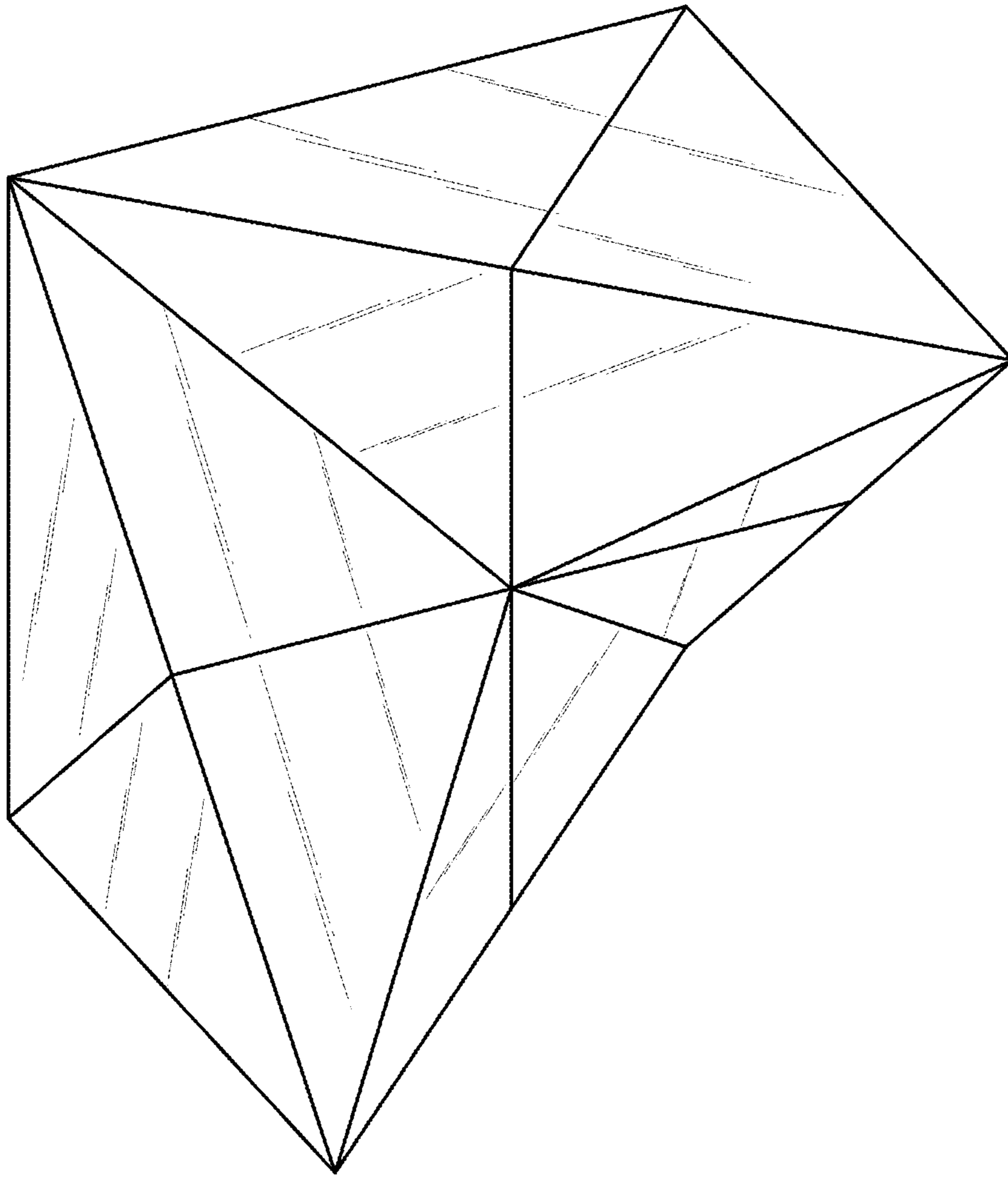

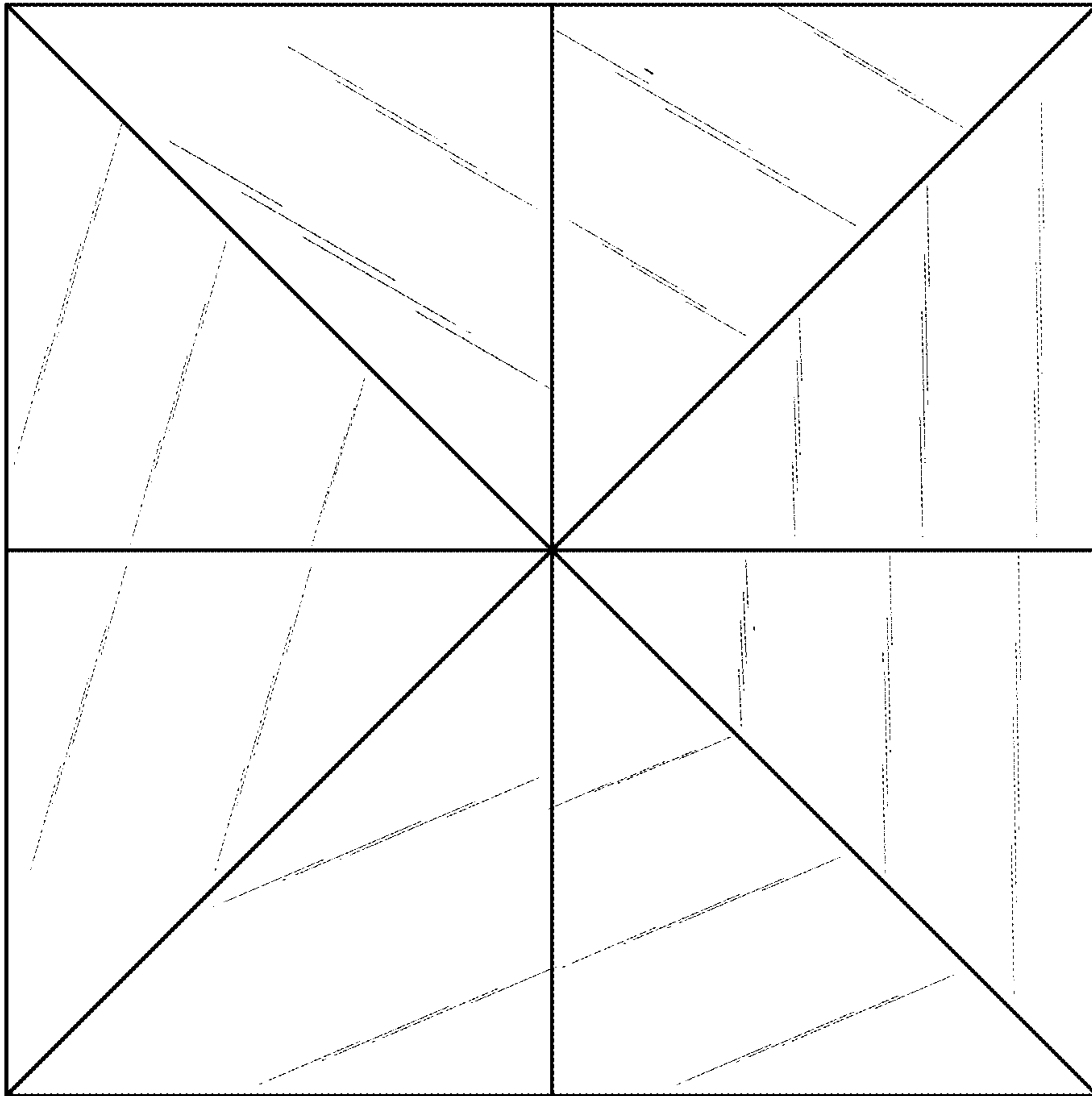

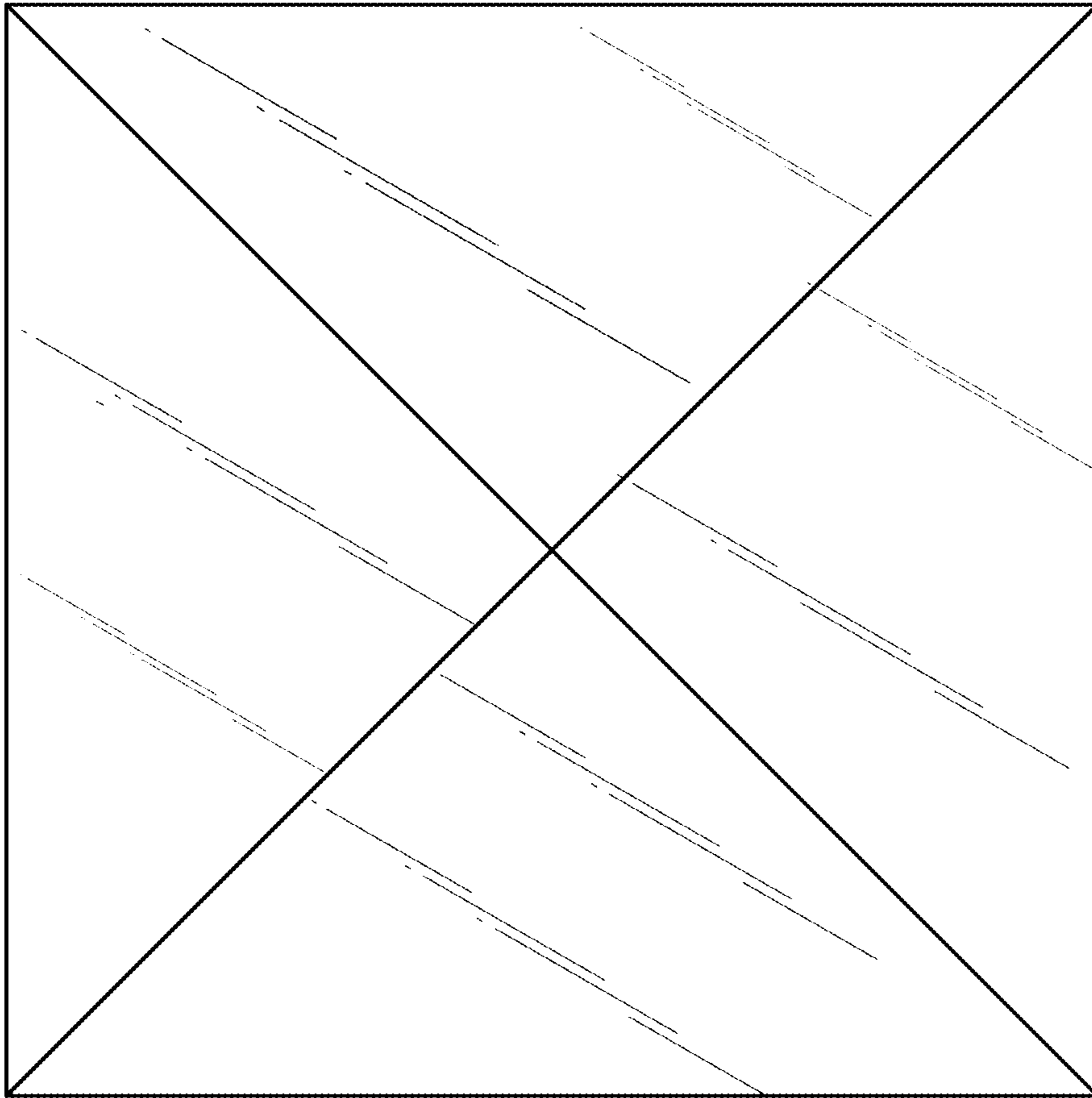

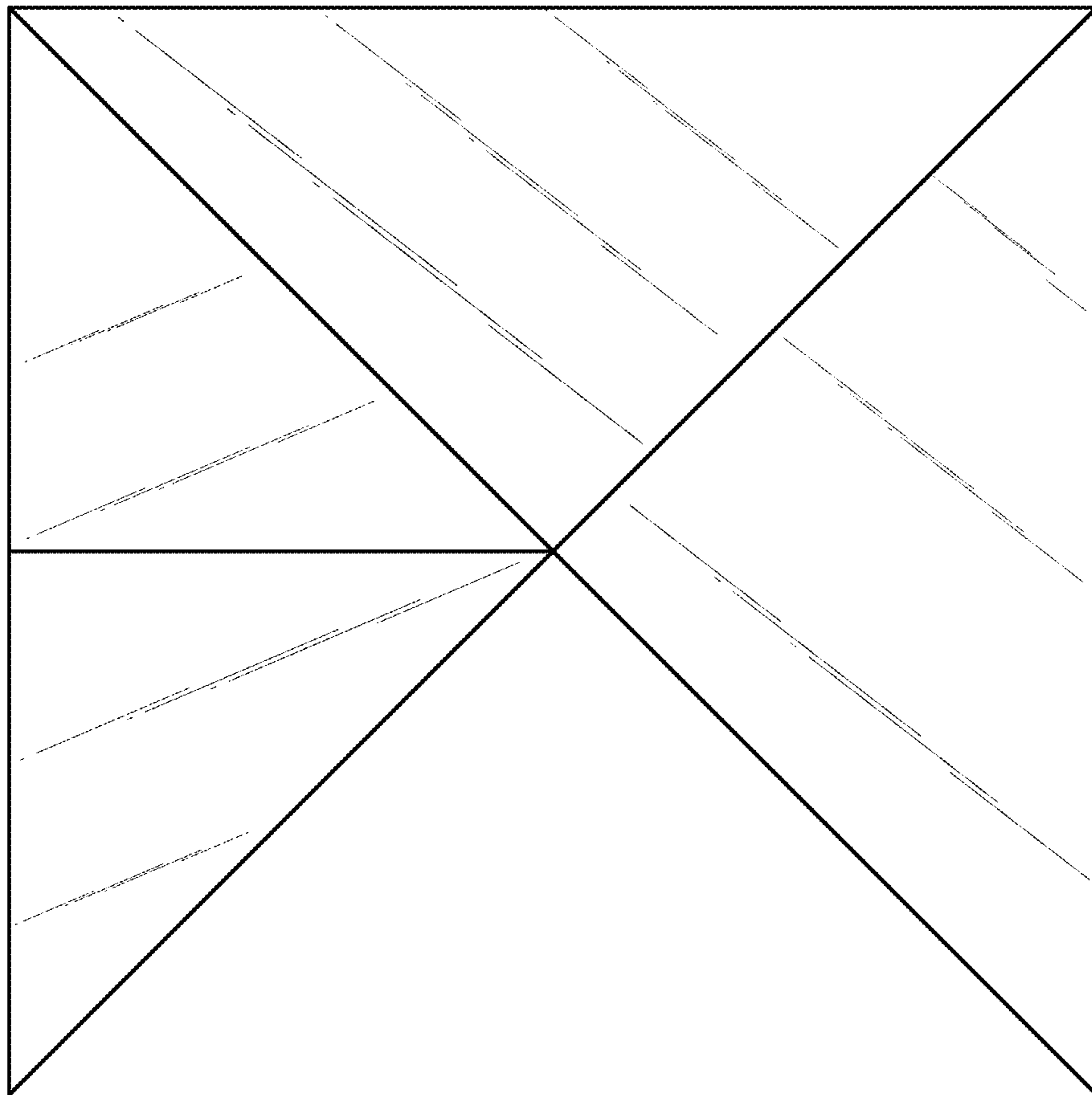

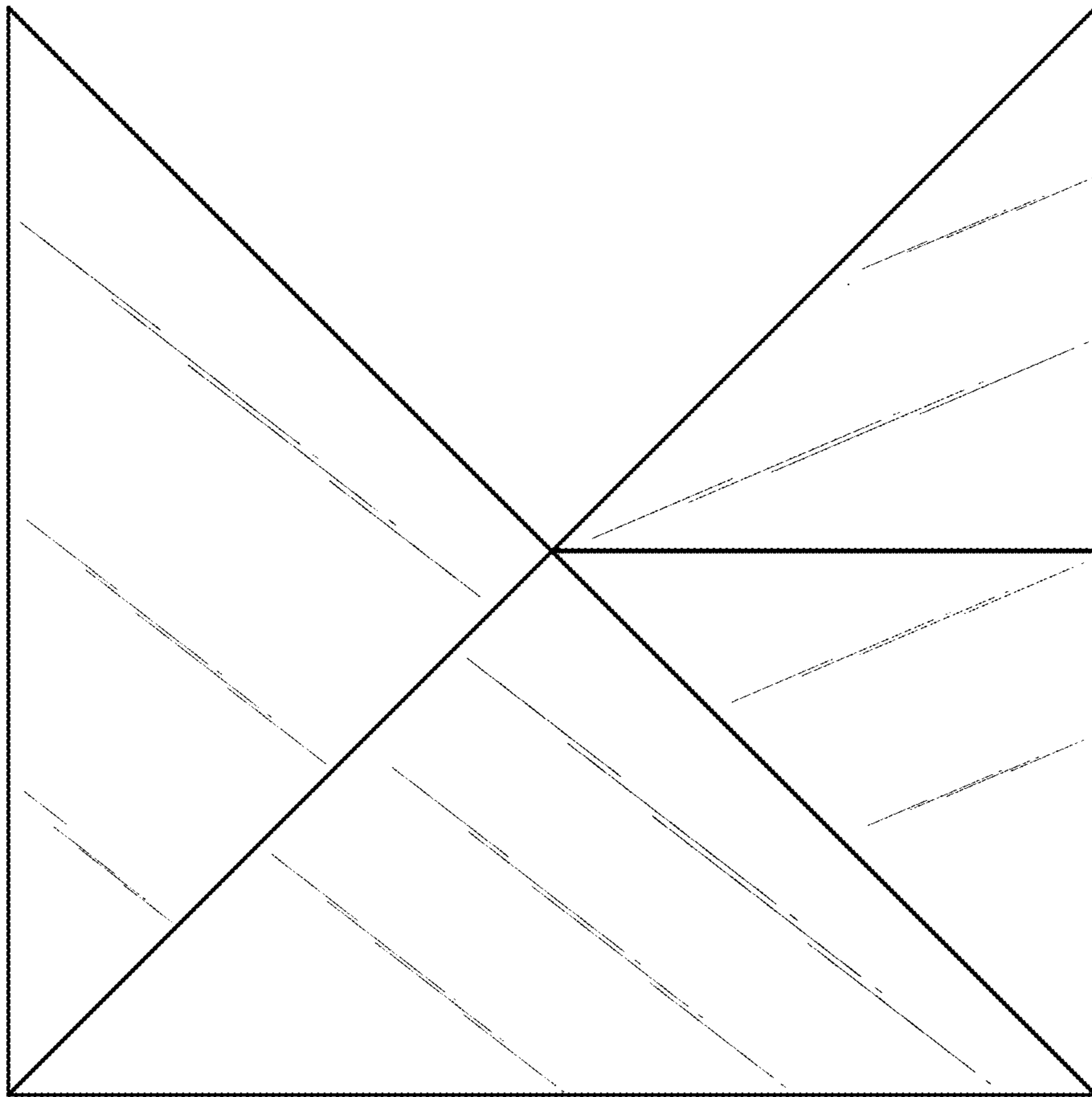

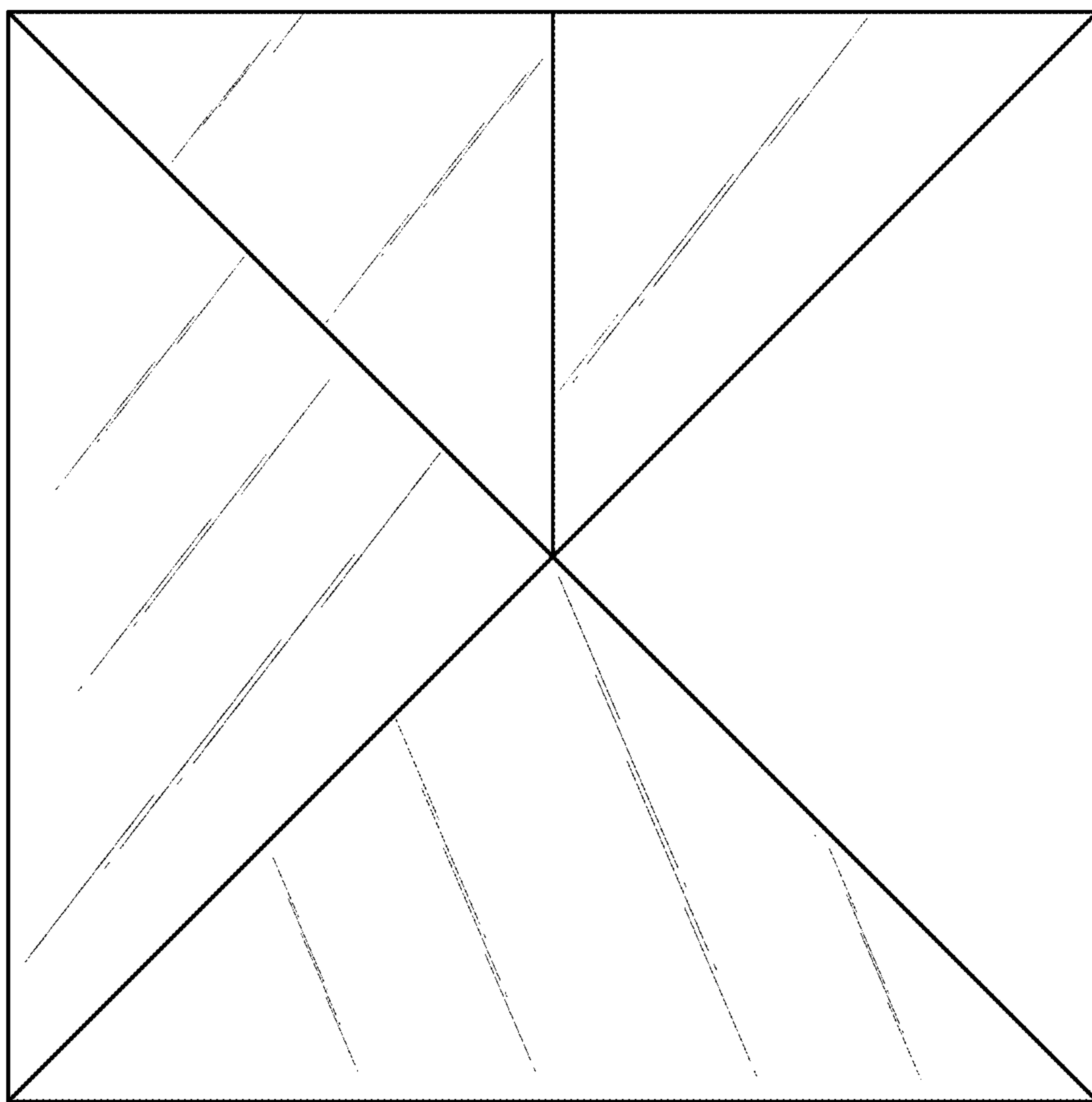

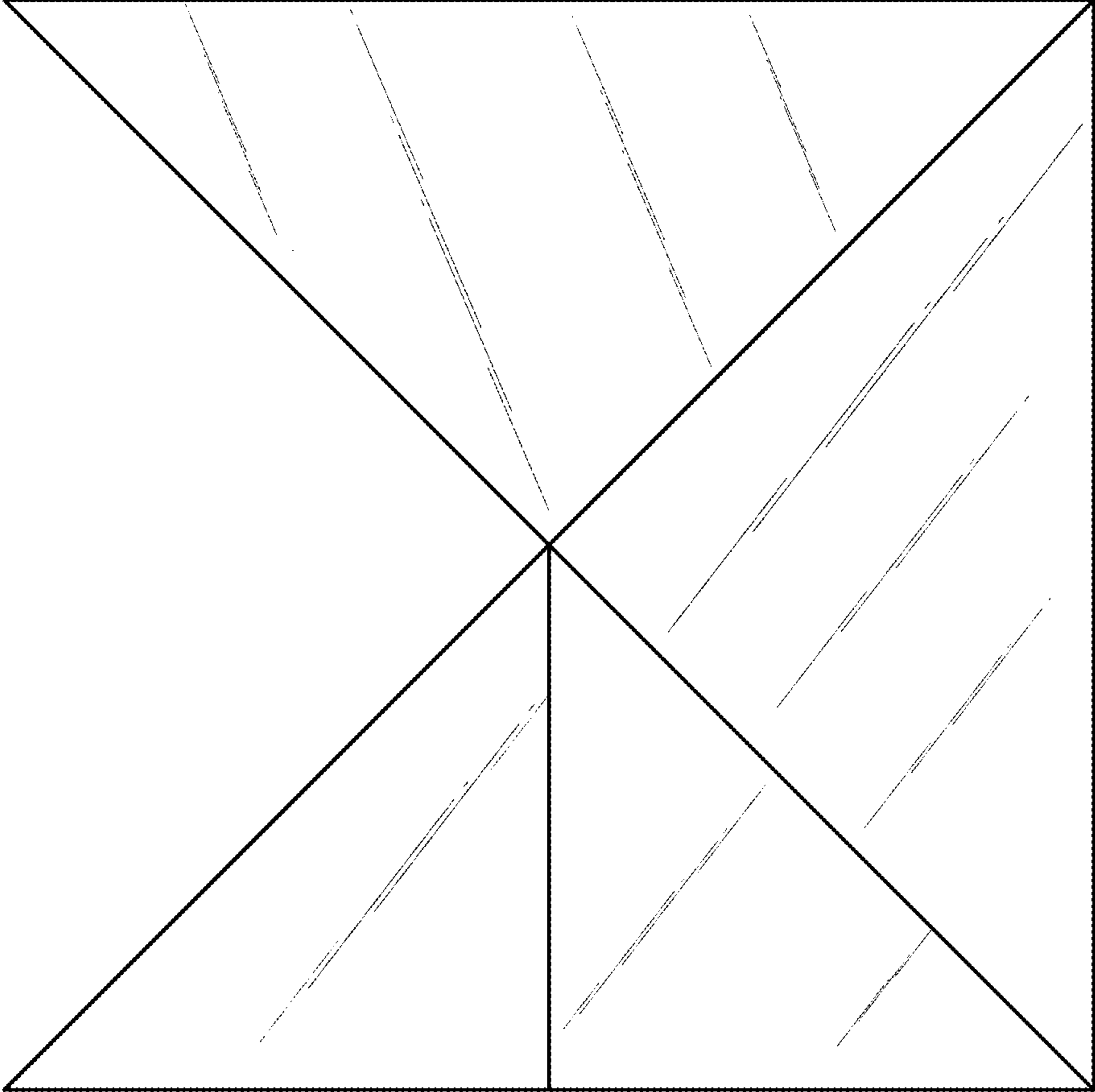

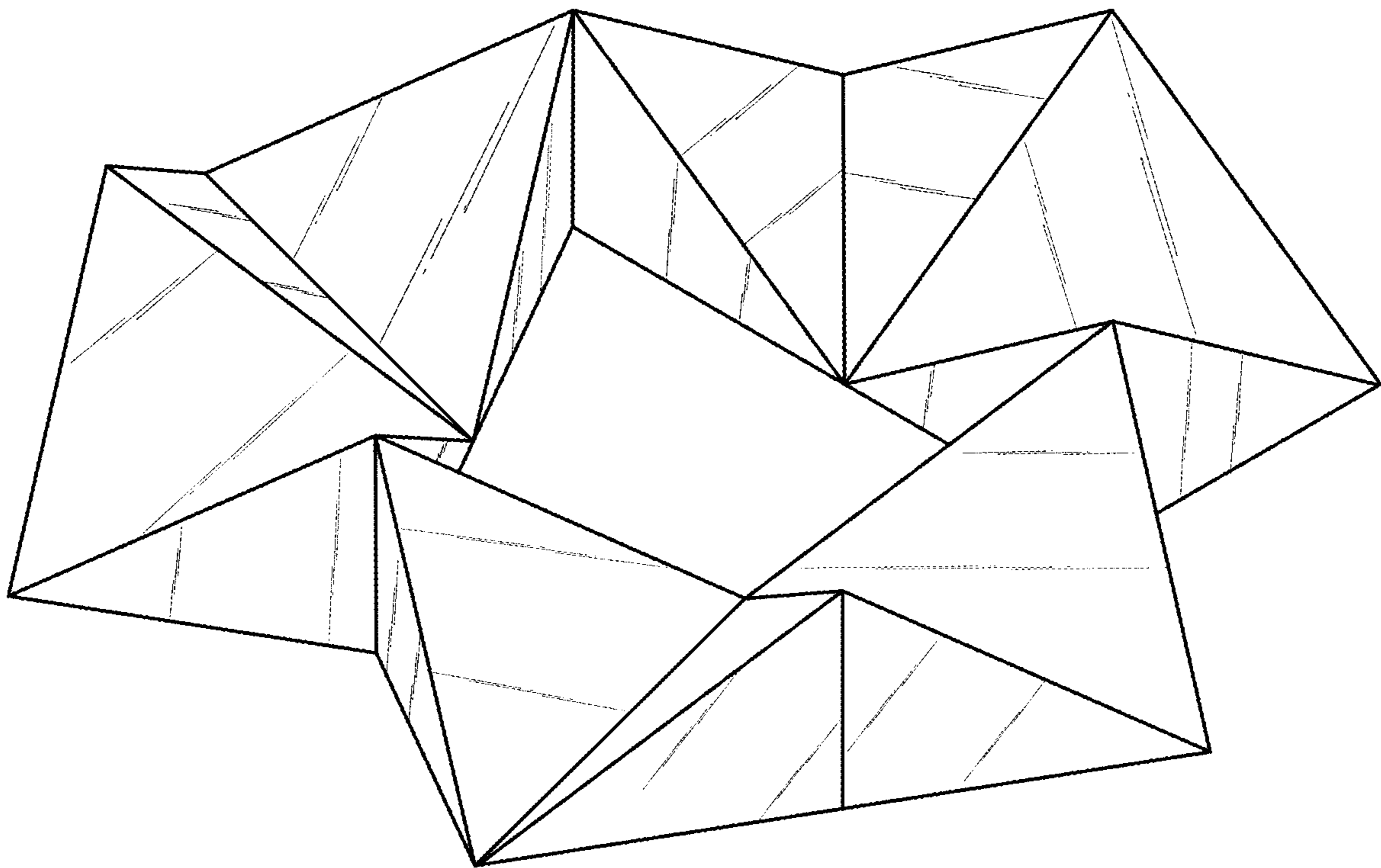

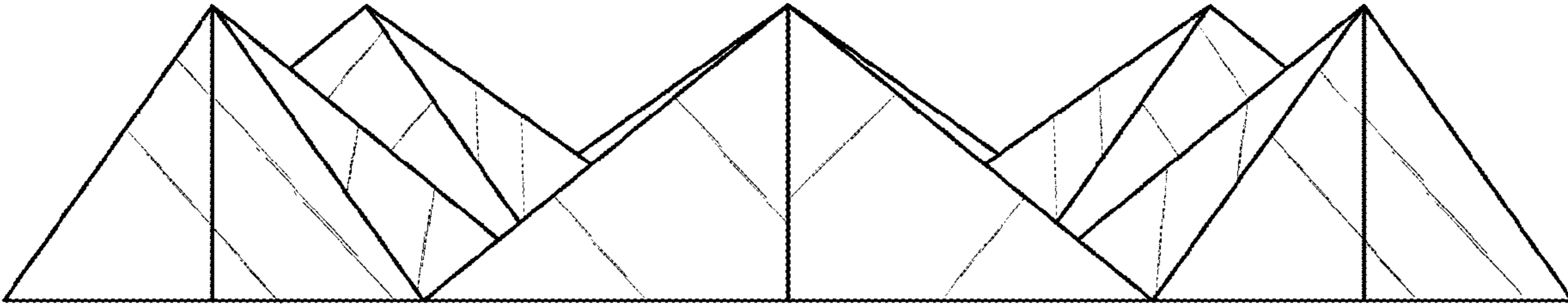

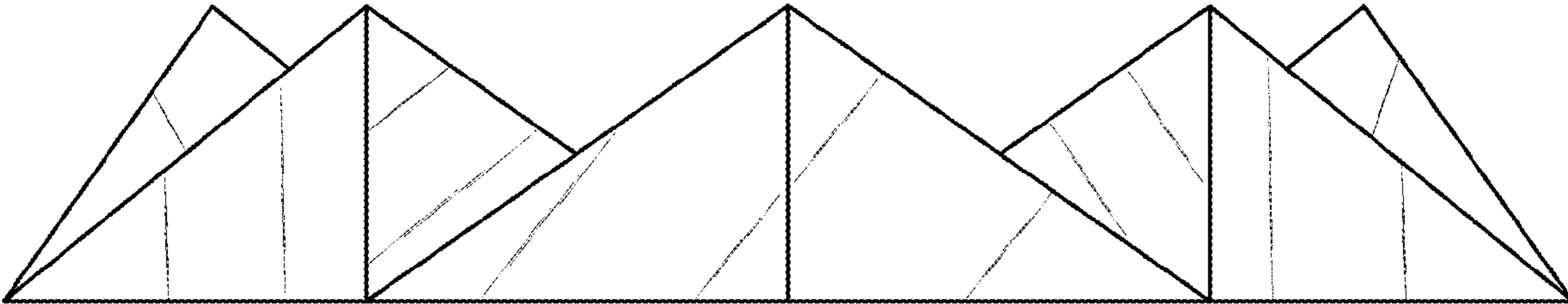

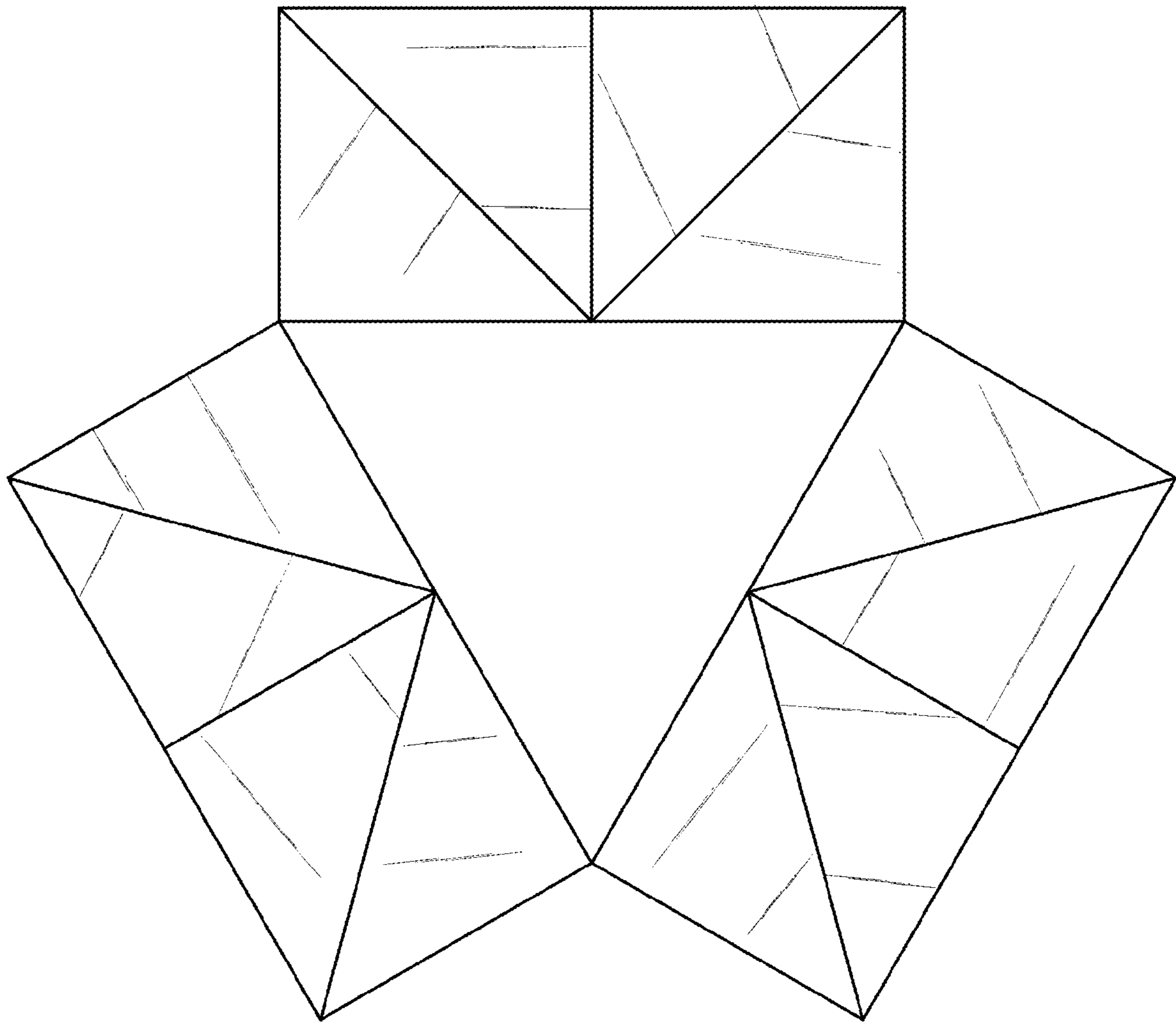

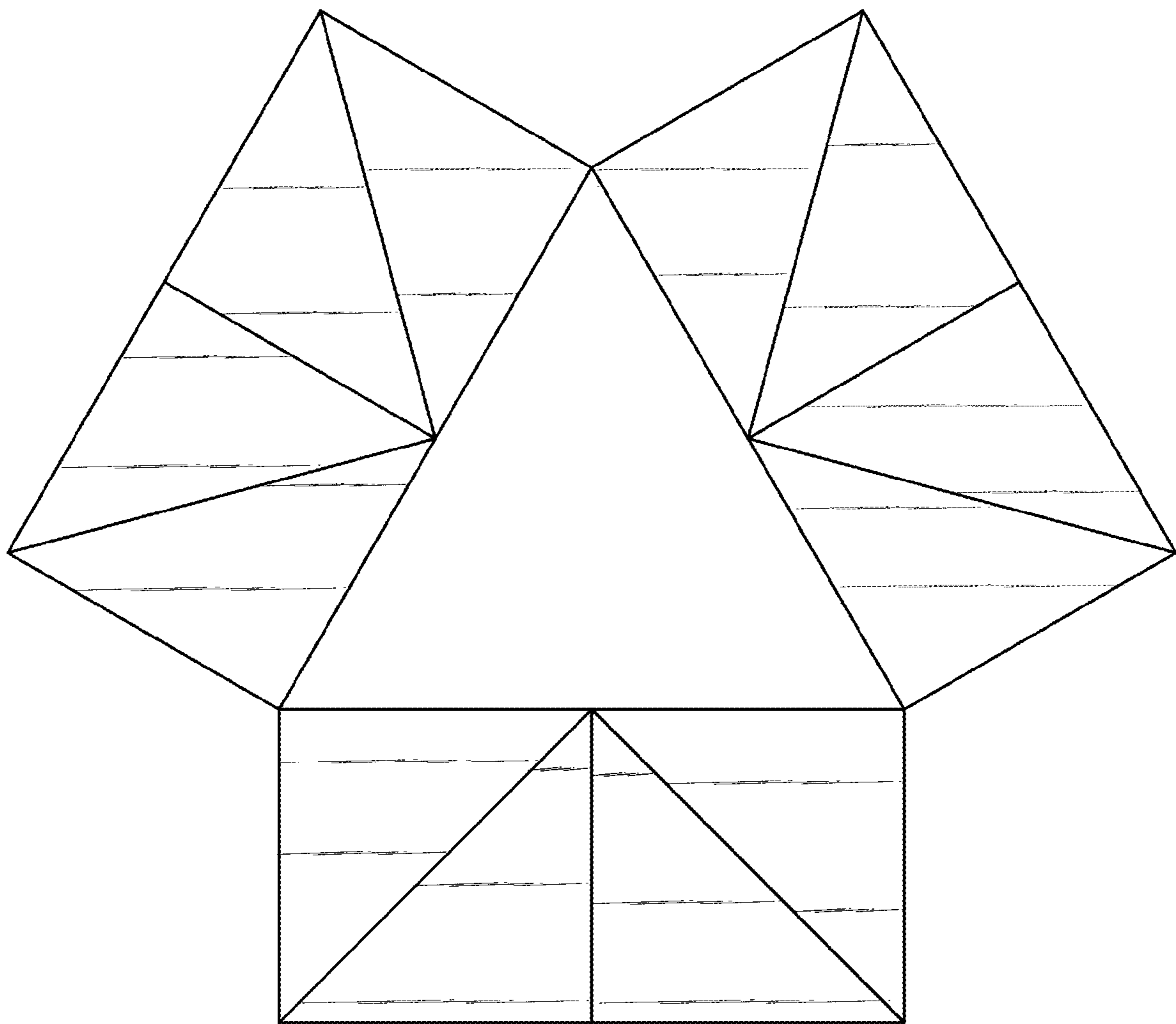

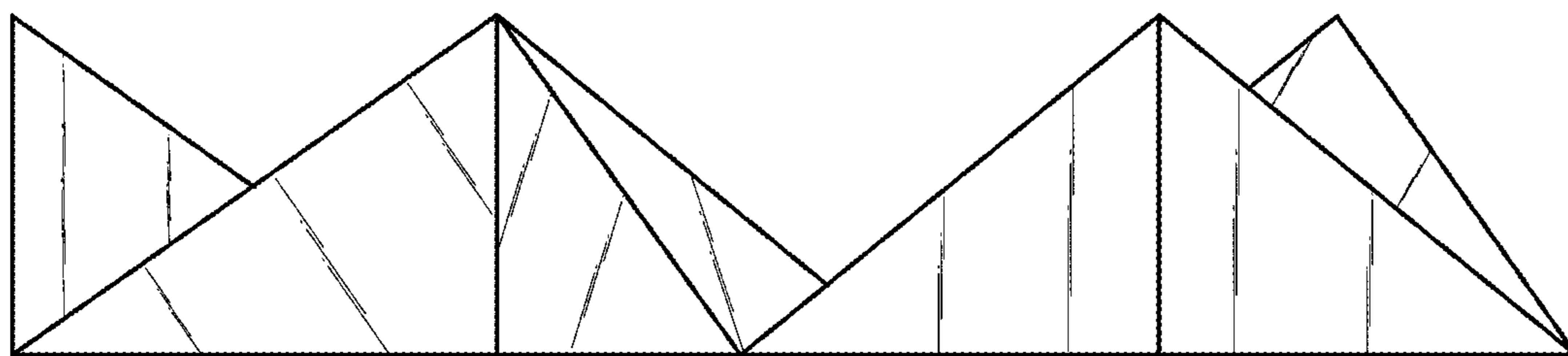

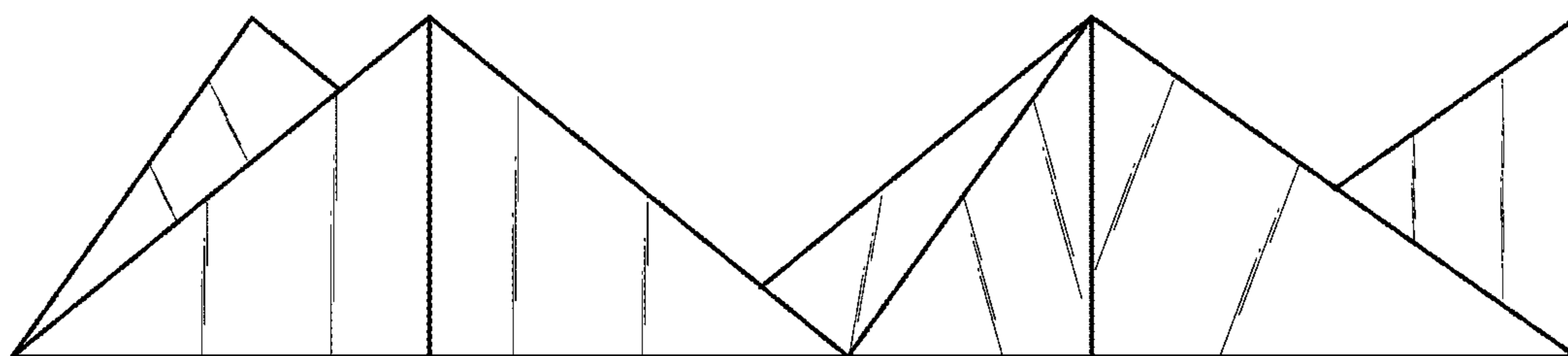

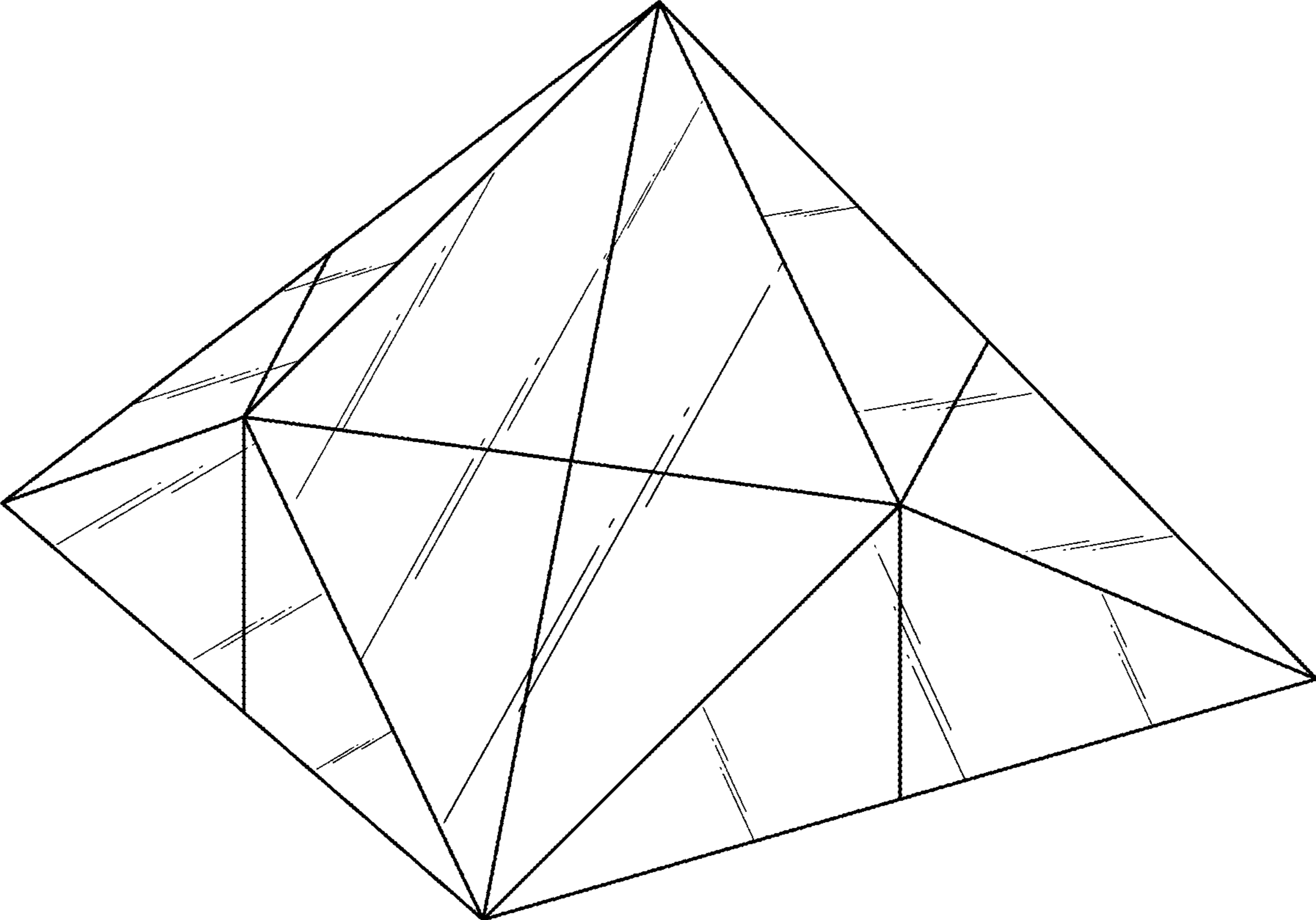

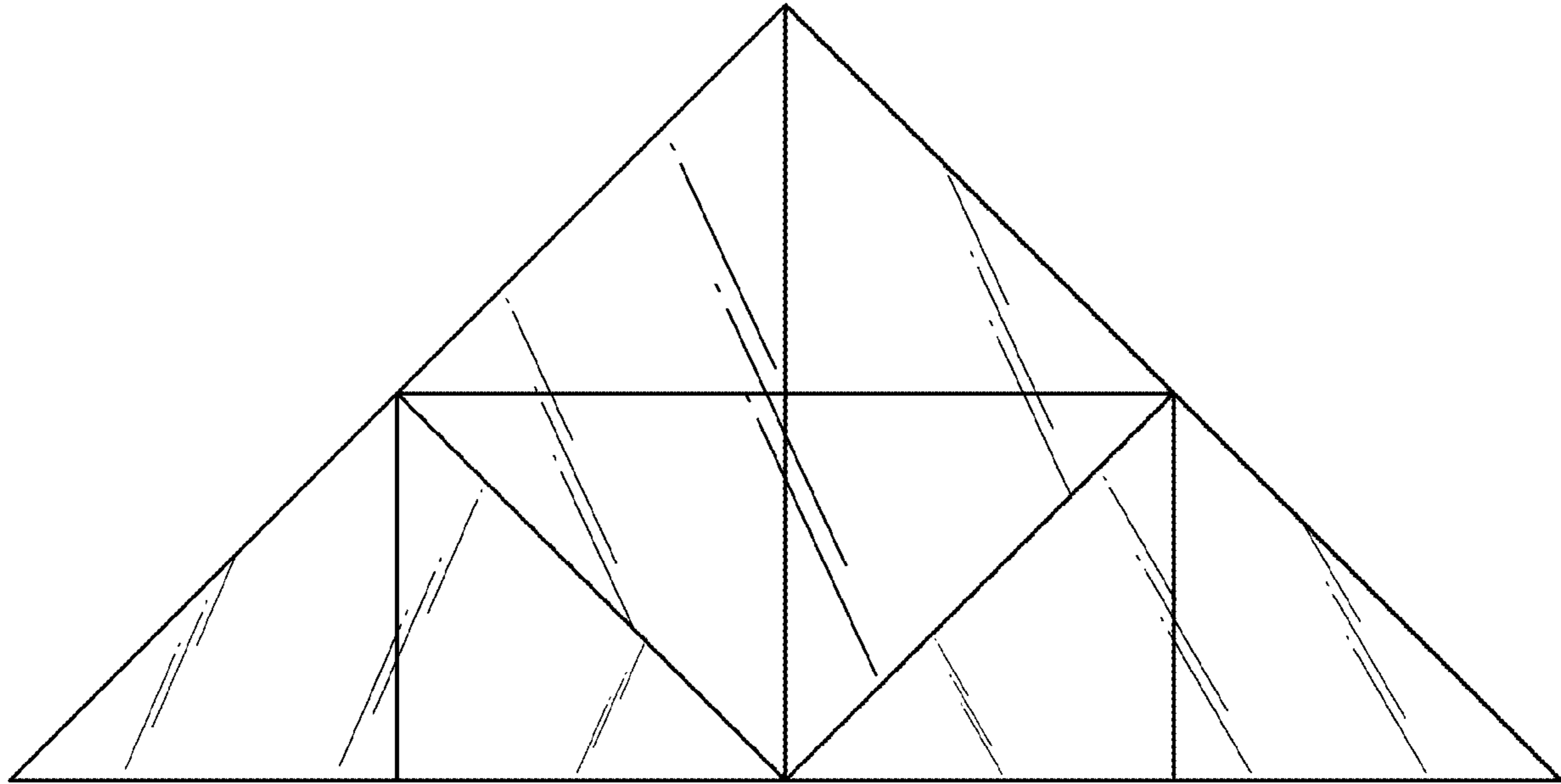

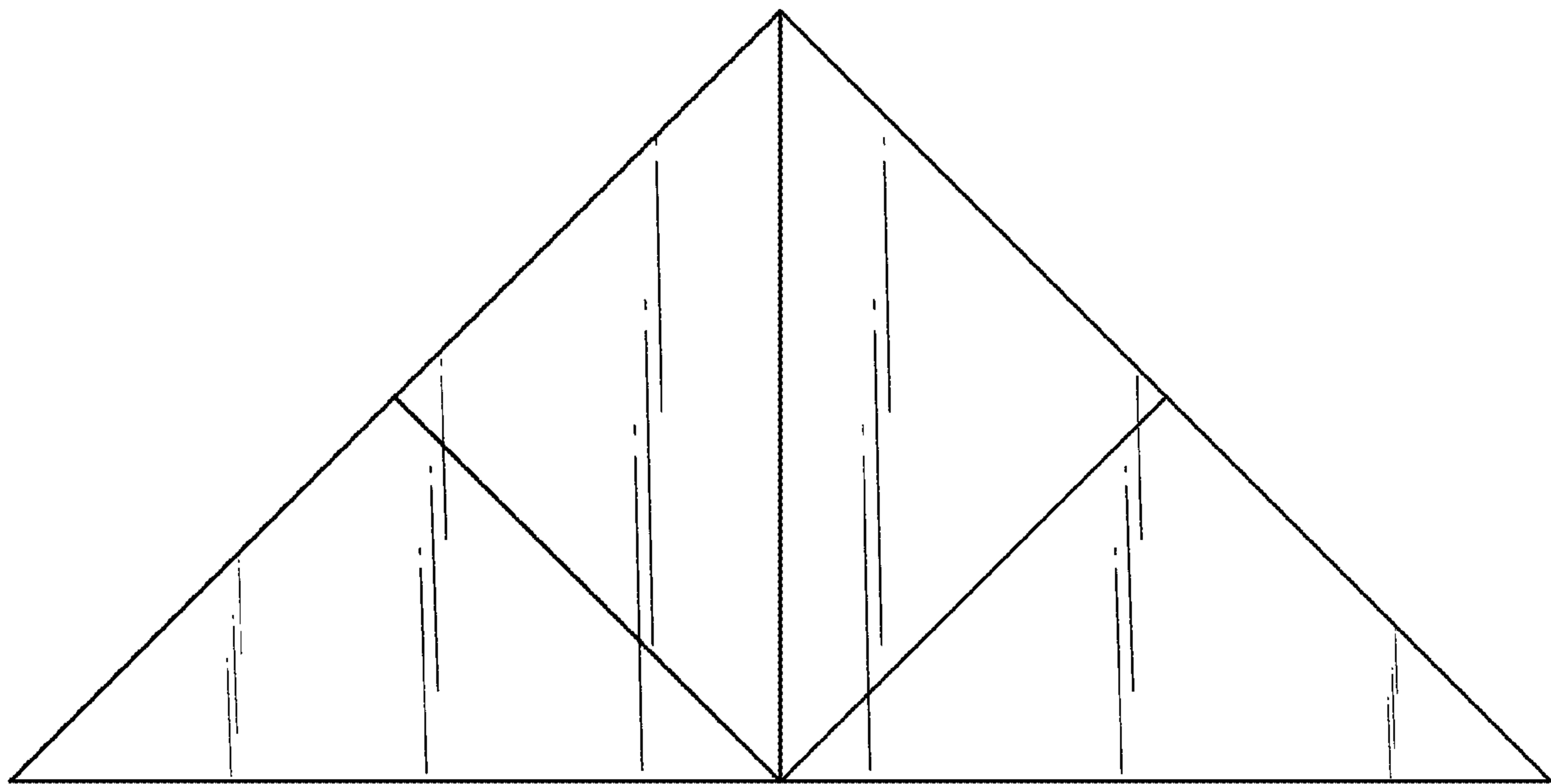

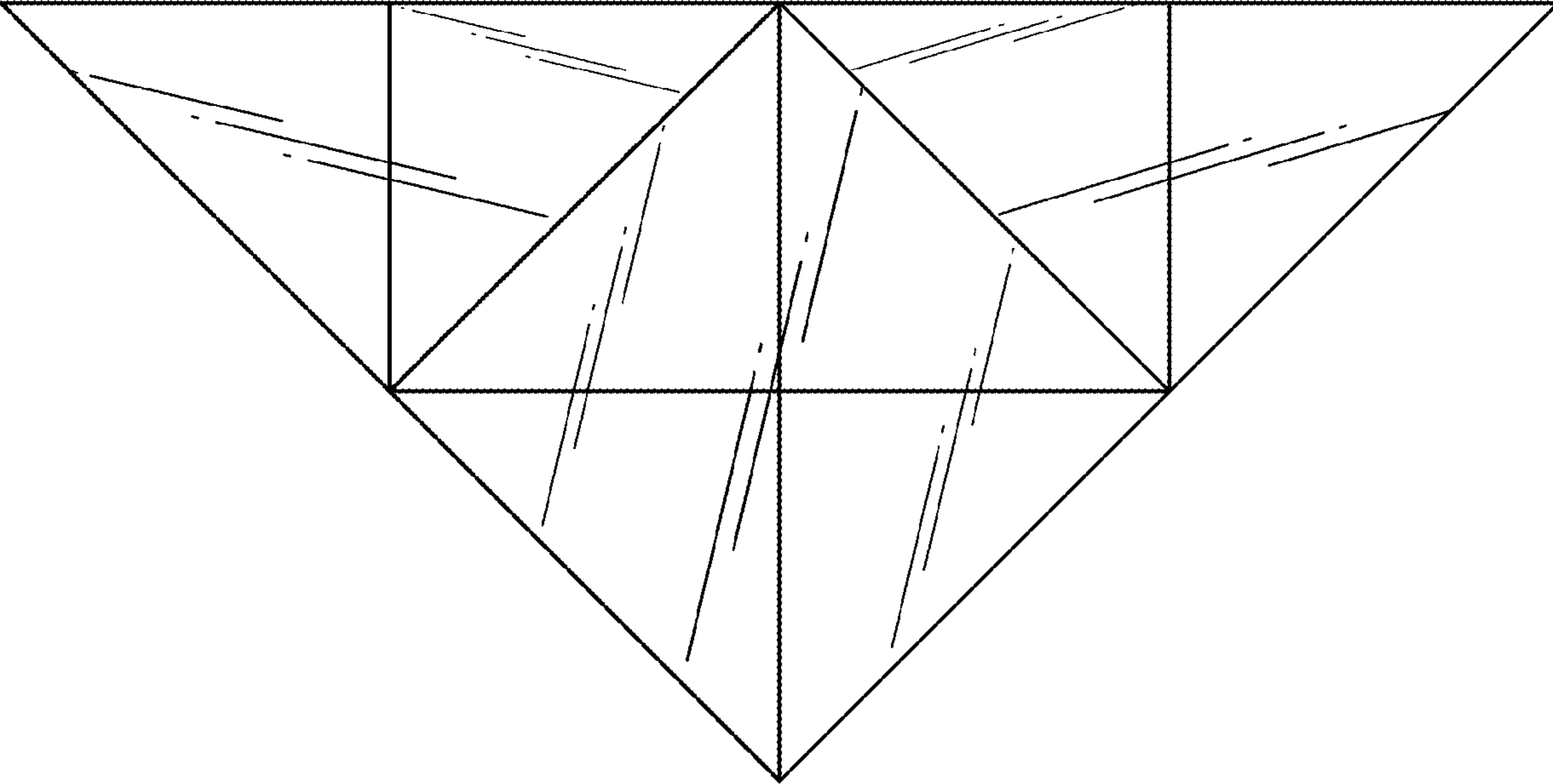

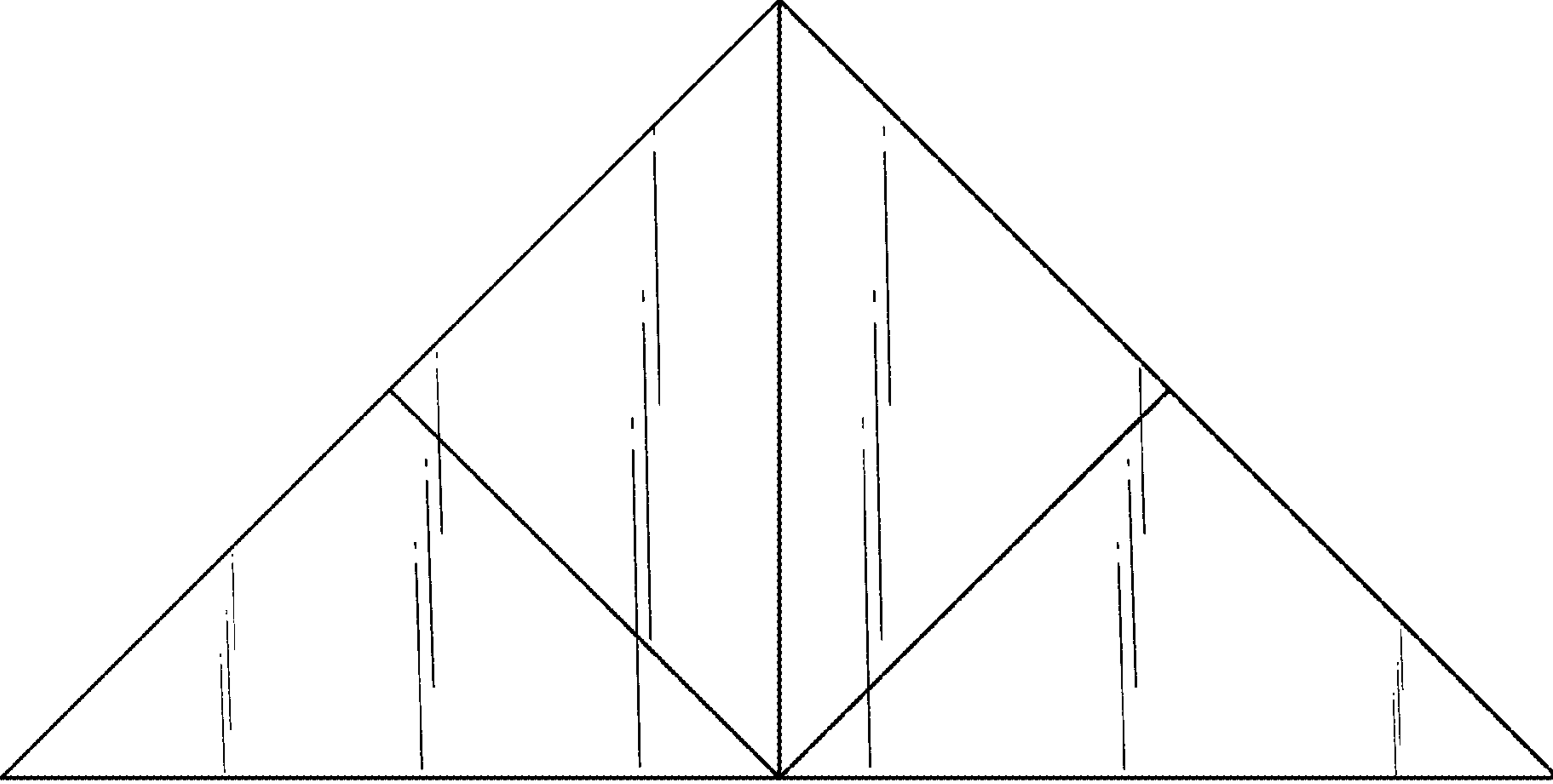

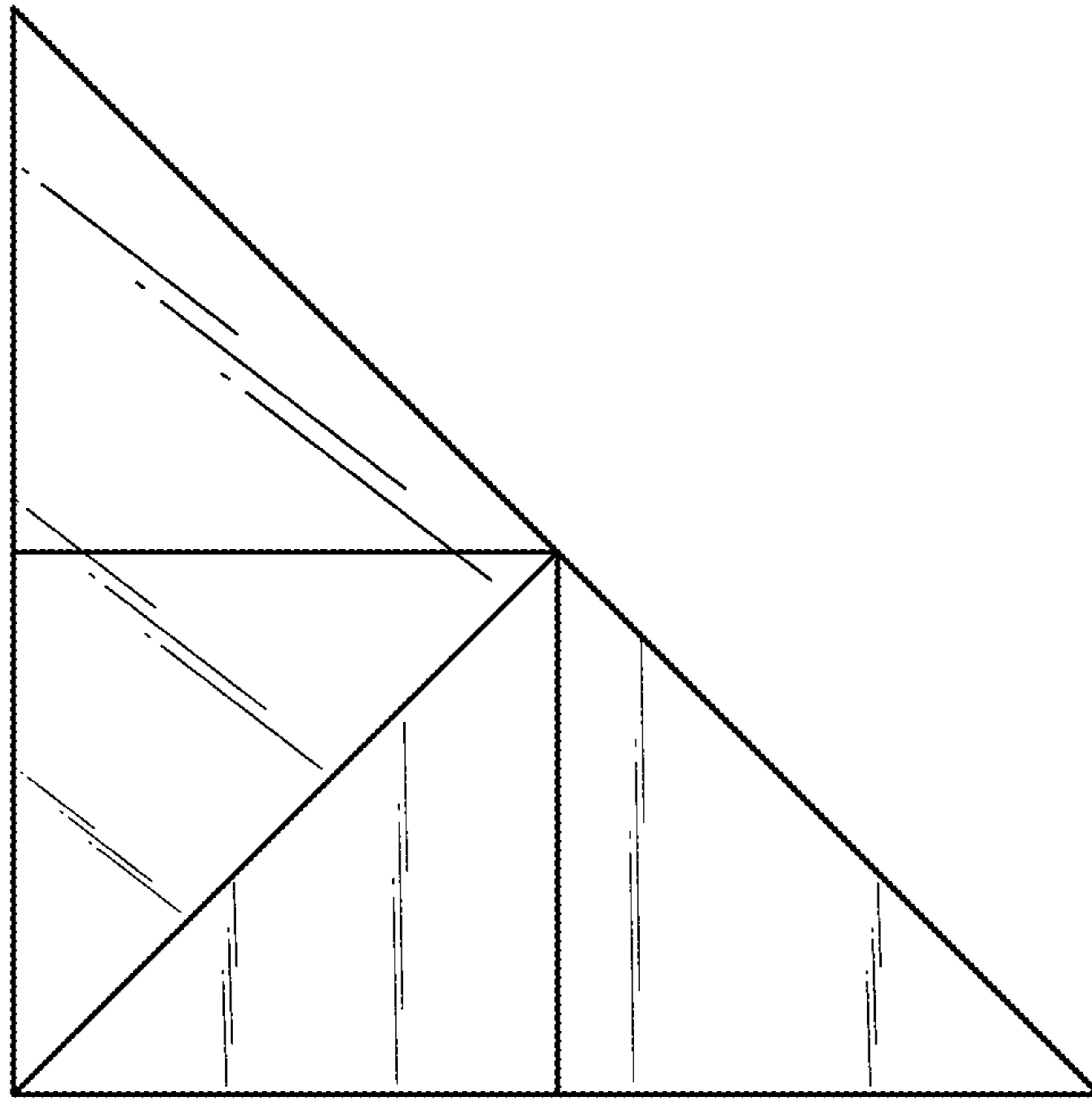

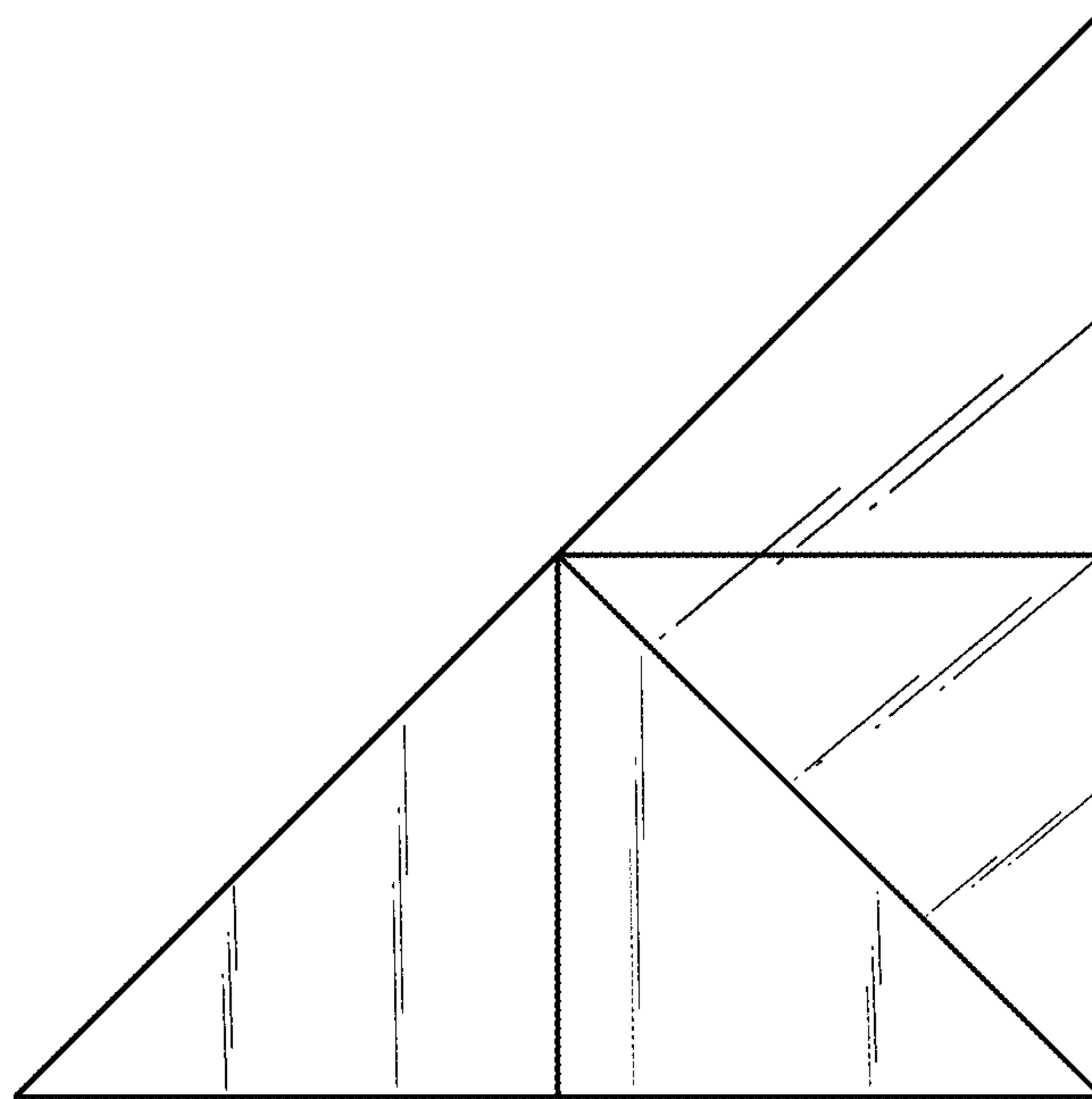
