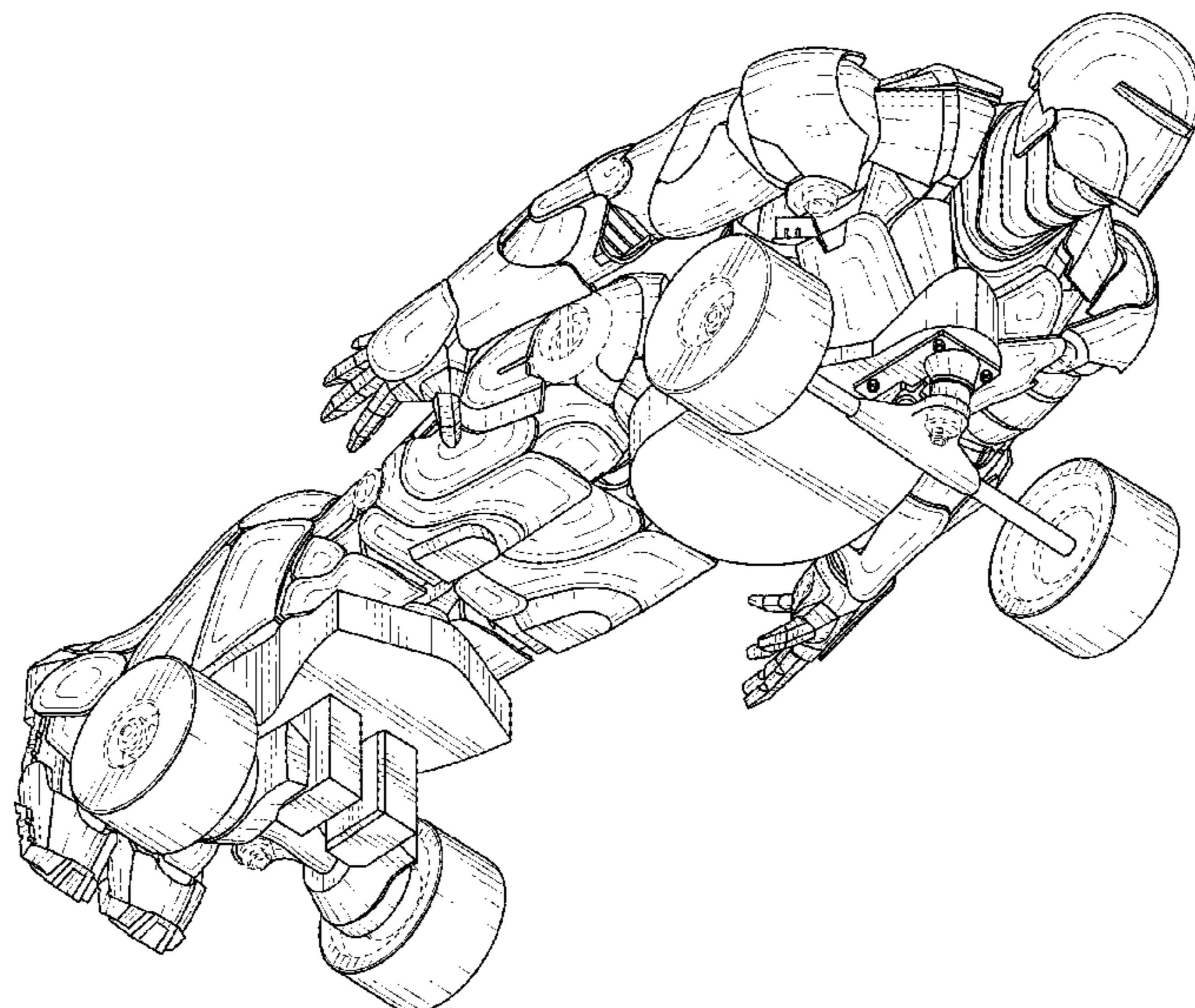
(57) **CLAIM**

The ornamental design for an action figure racer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-left perspective view of an action figure racer showing our new design;  
 FIG. 2 is a bottom-front-right perspective view thereof;  
 FIG. 3 is a top-rear-right perspective view thereof;  
 FIG. 4 is a bottom-rear-left perspective view thereof;  
 FIG. 5 is a front elevational view thereof;

 FIG. 7 is a top plan view thereof;  
 FIG. 8 is a bottom plan view thereof;  
 FIG. 9 is a right elevational view thereof; and,  
 FIG. 10 is a left elevational view thereof.

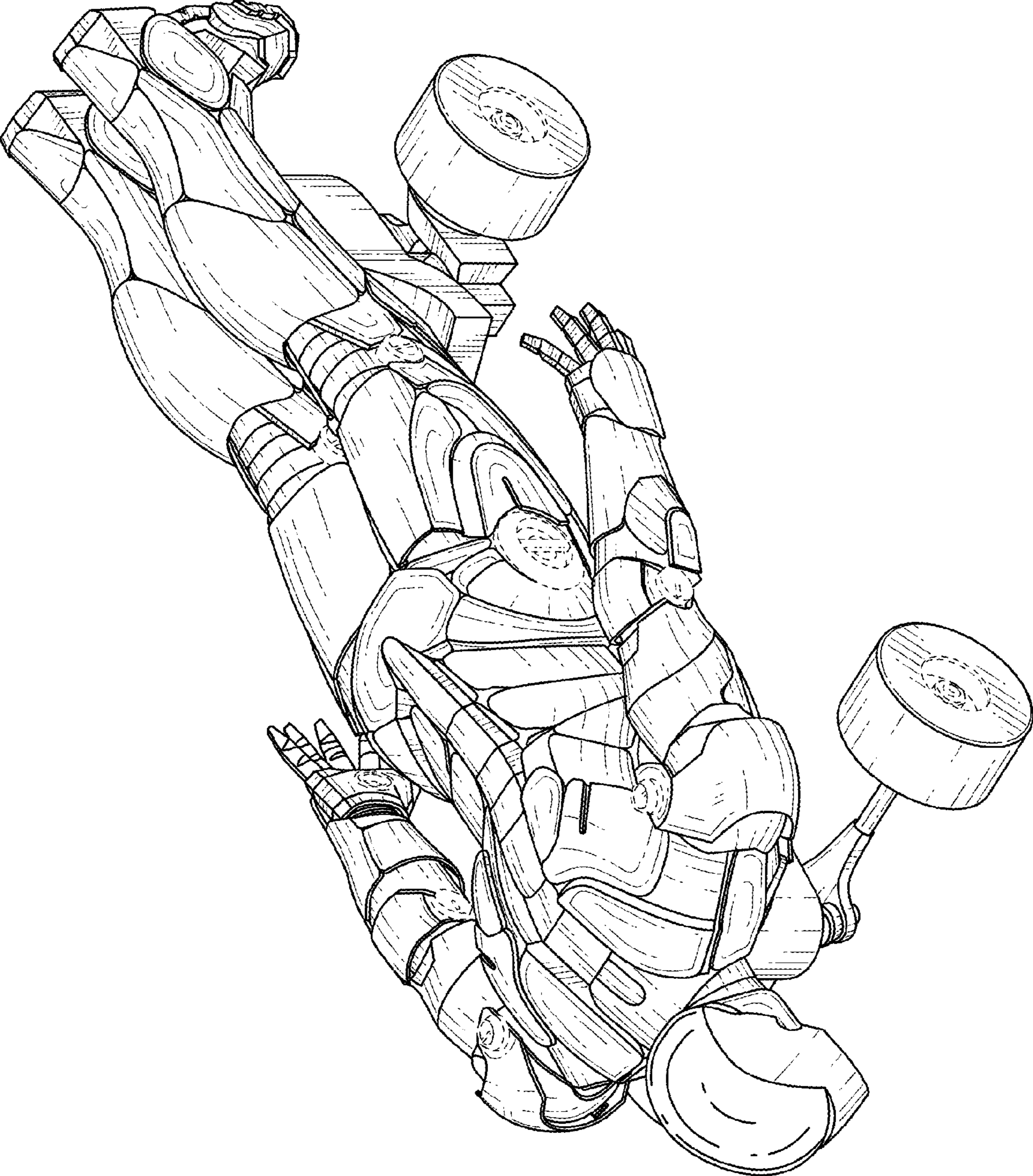

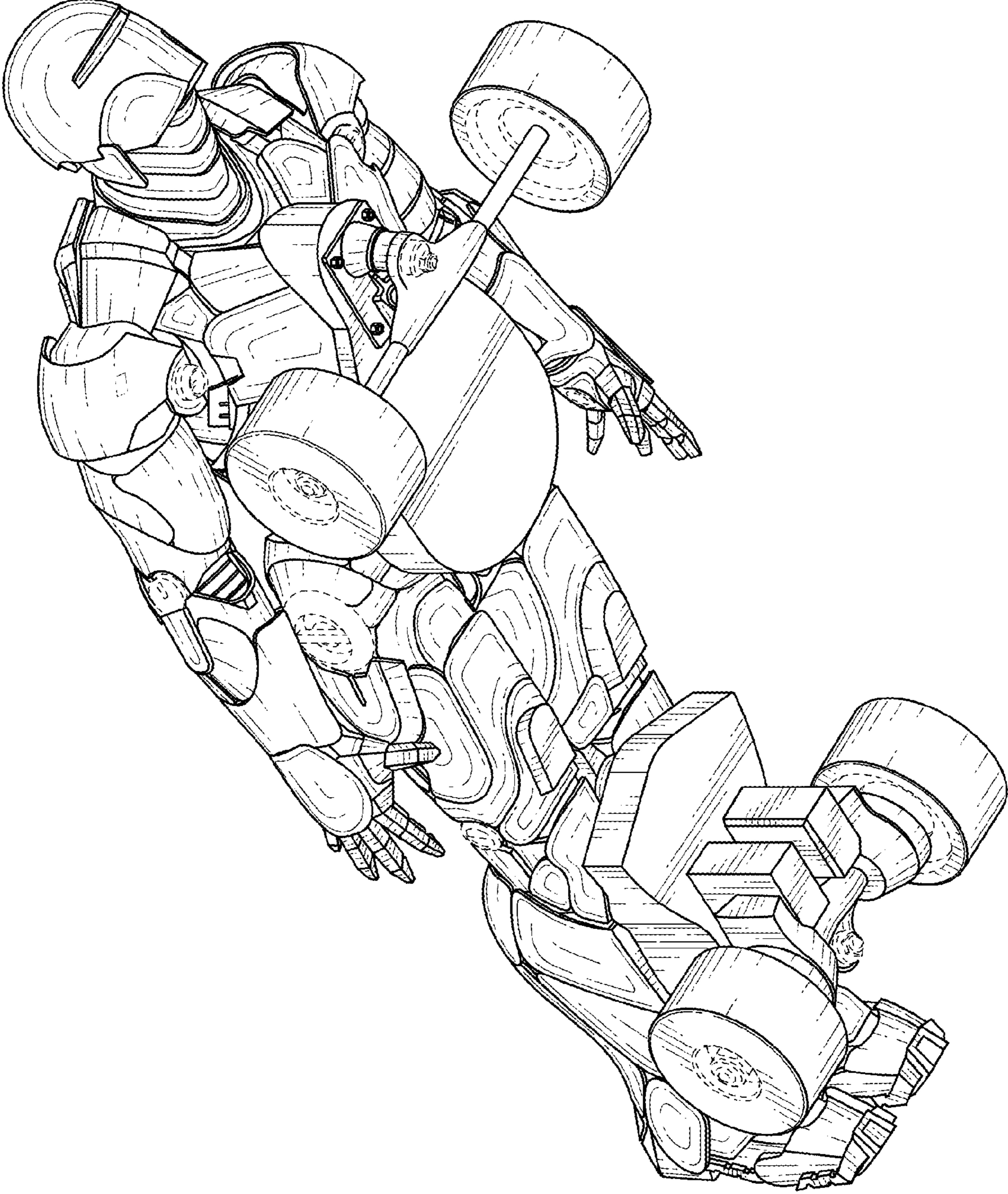

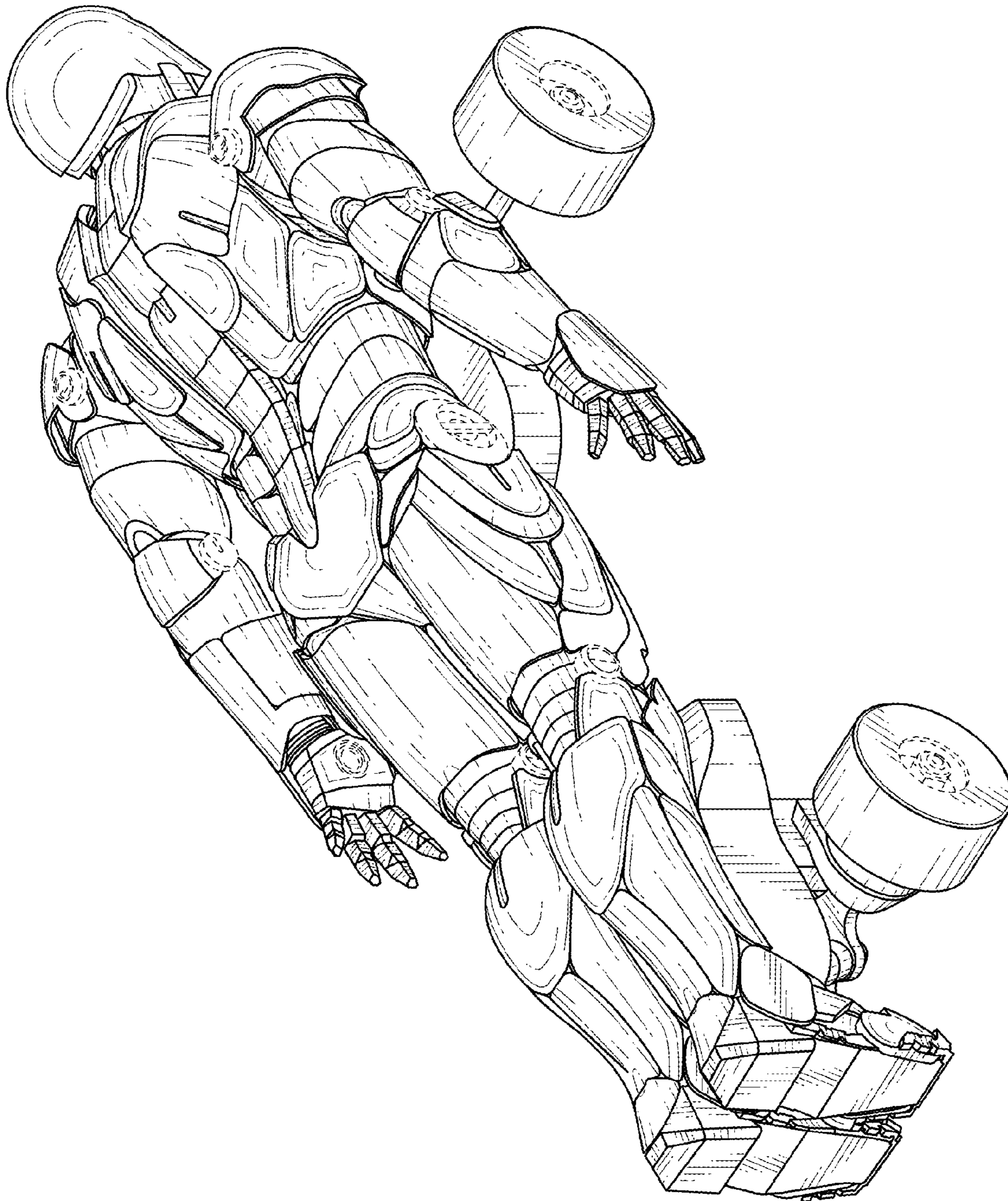

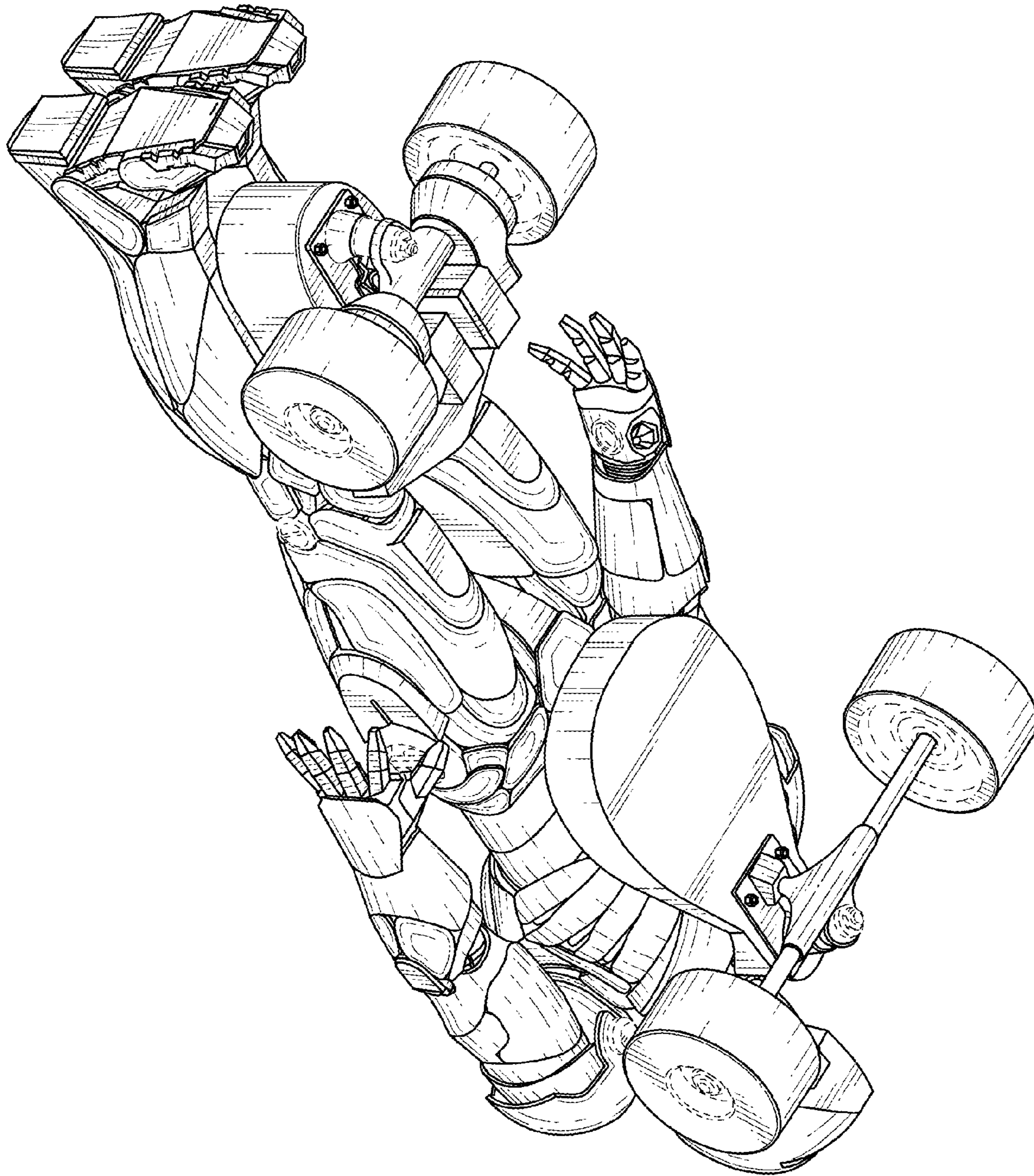

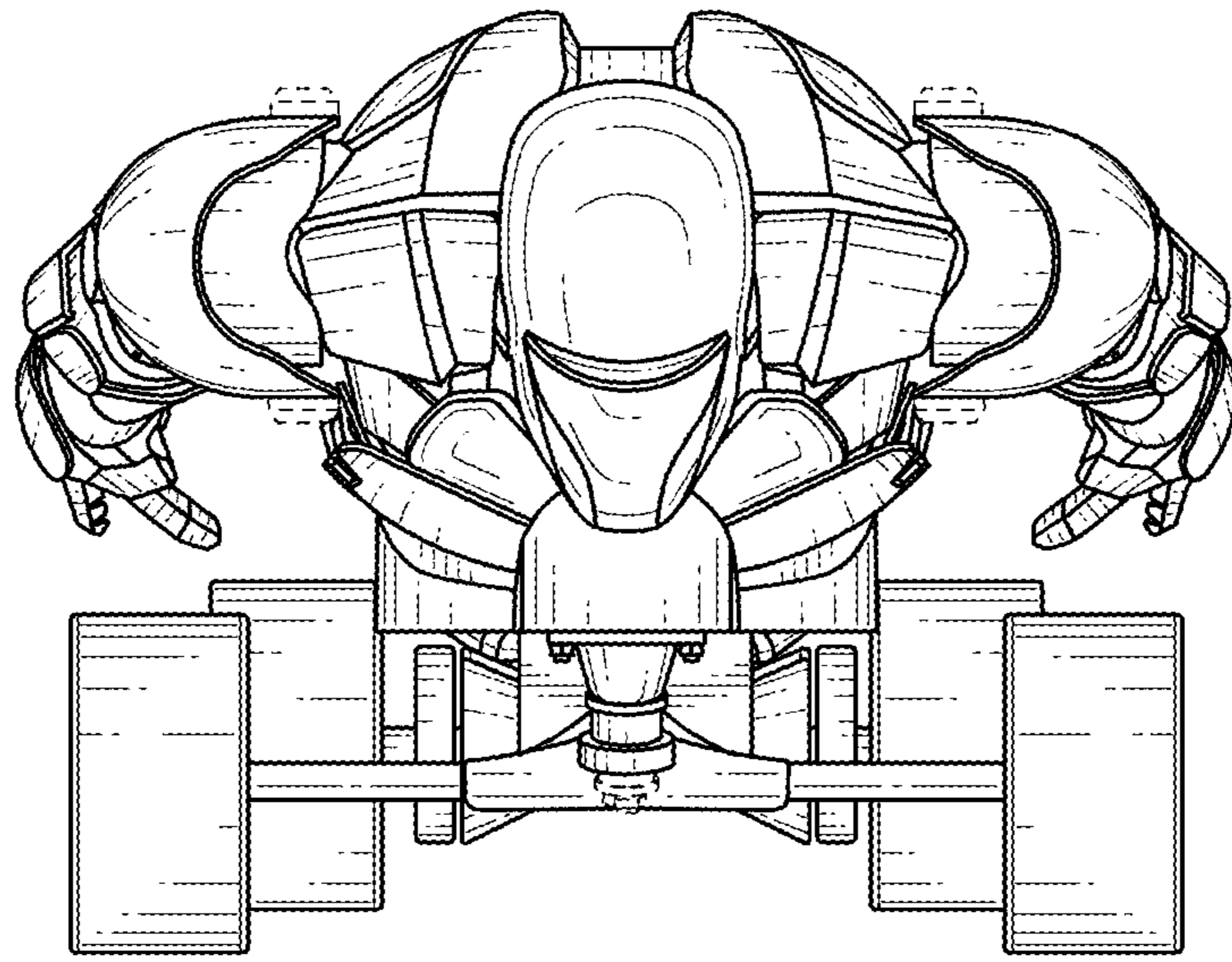

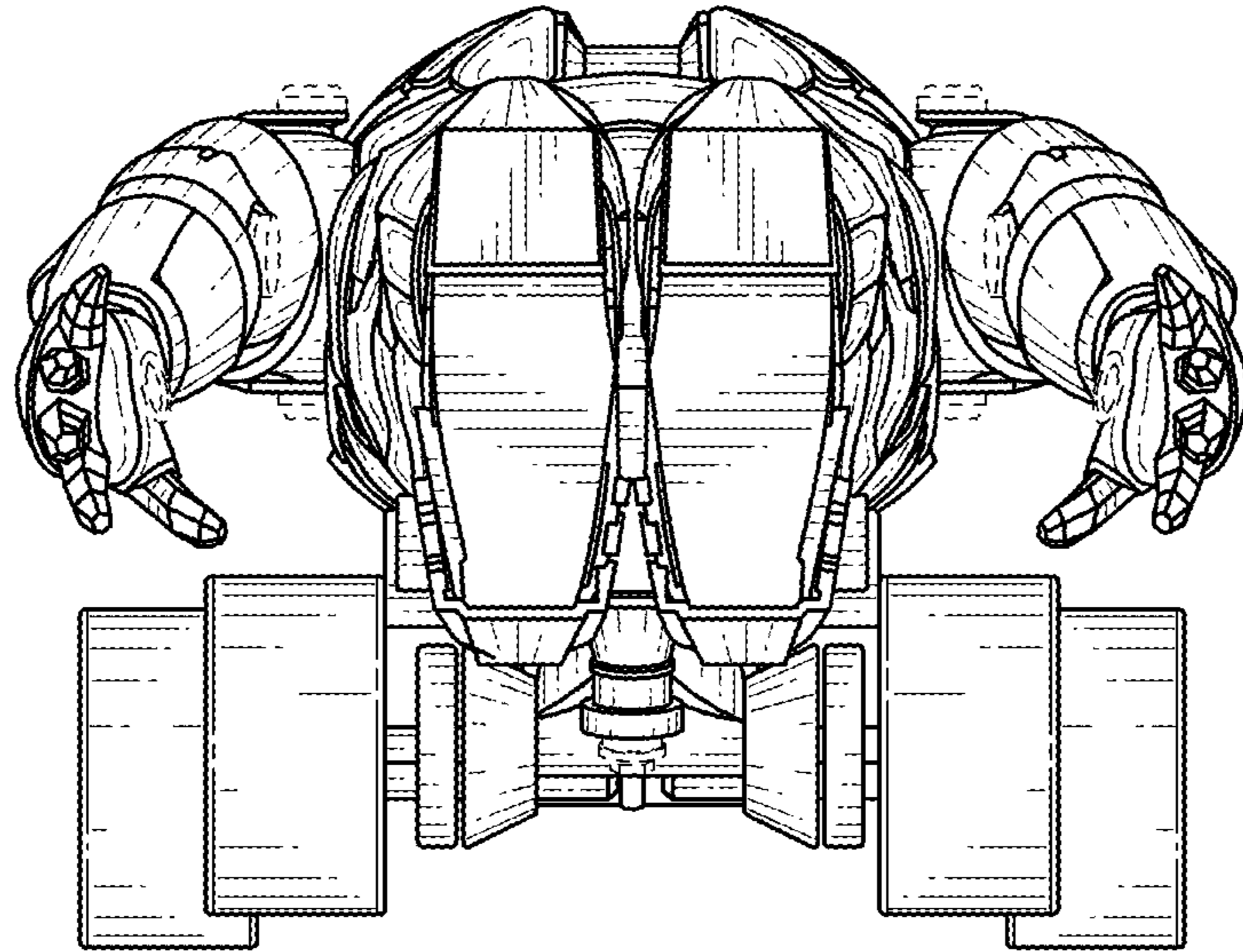

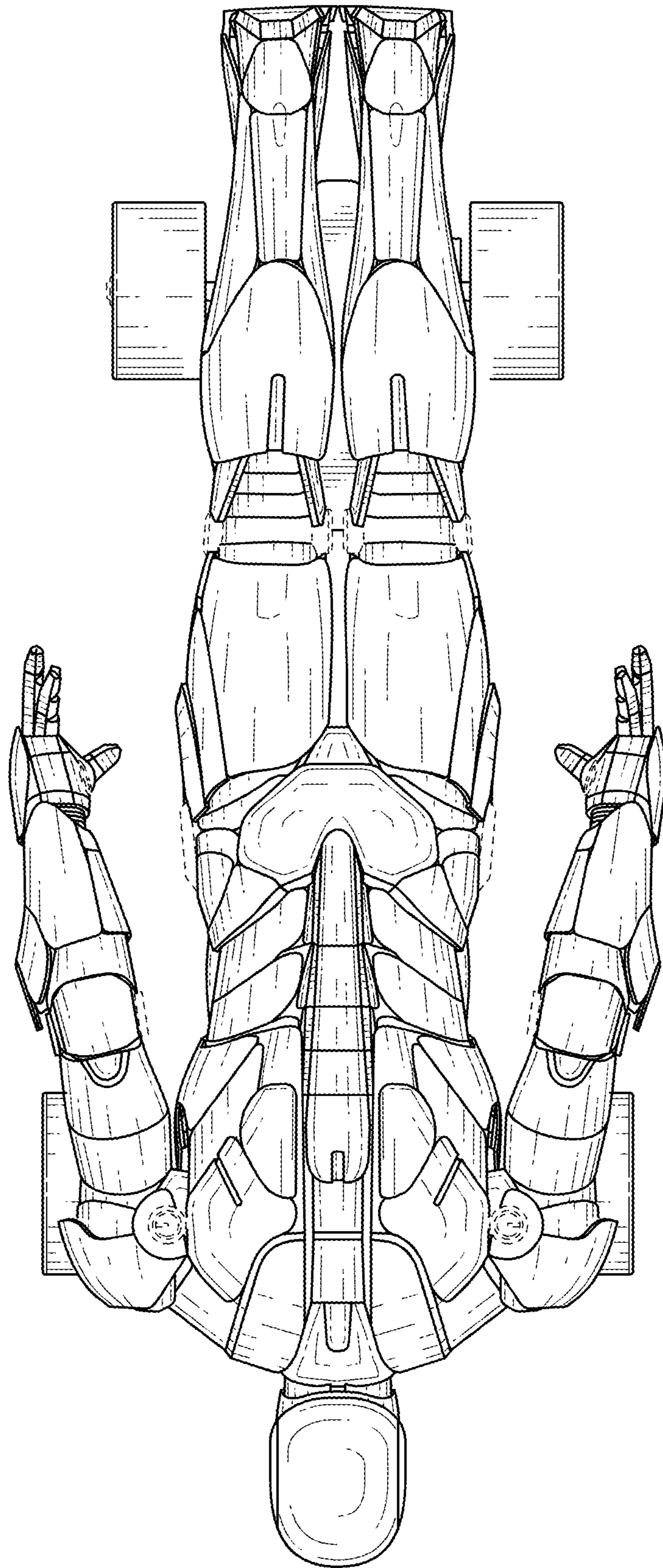

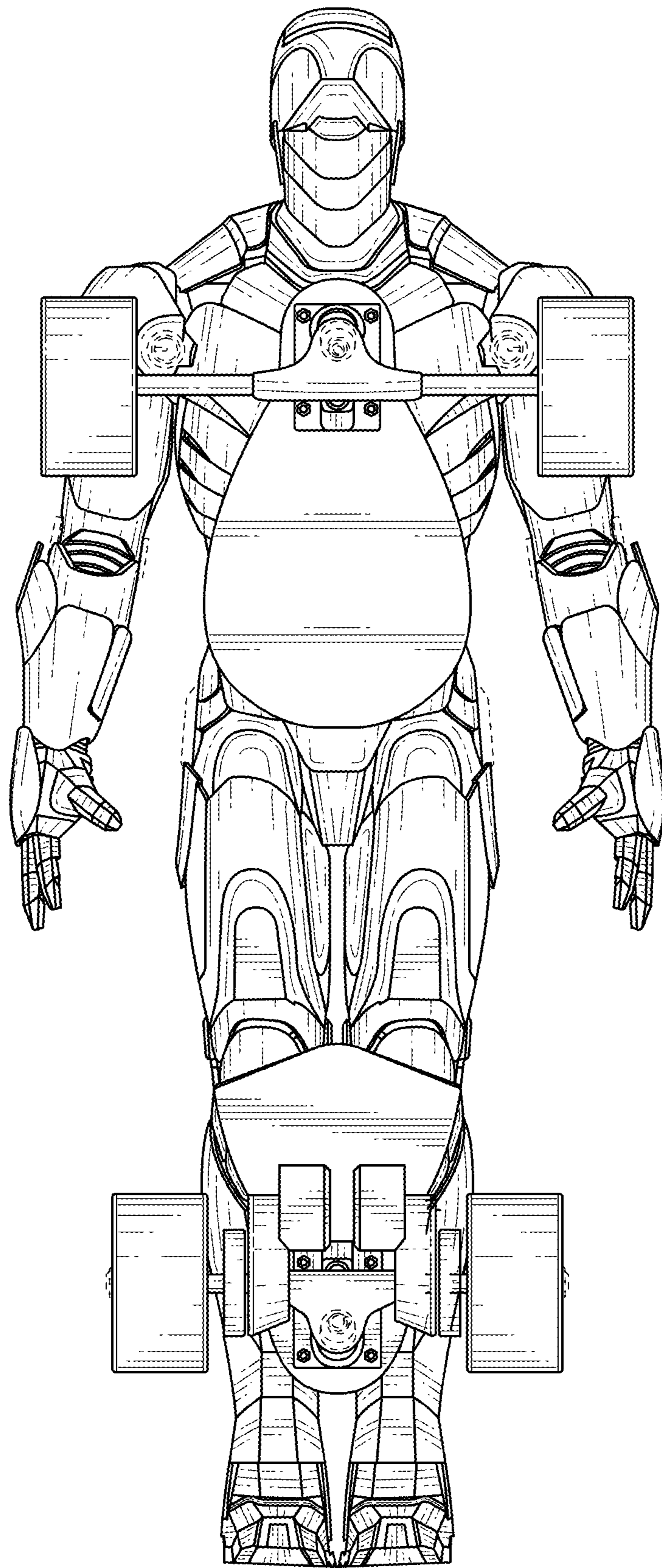

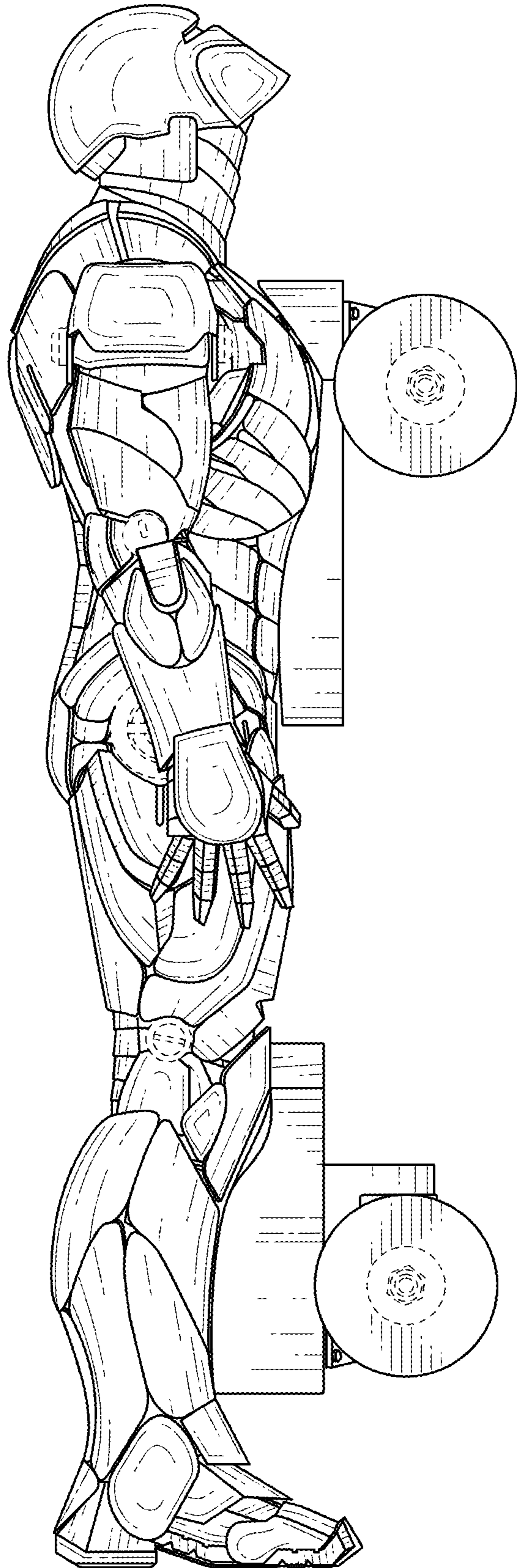

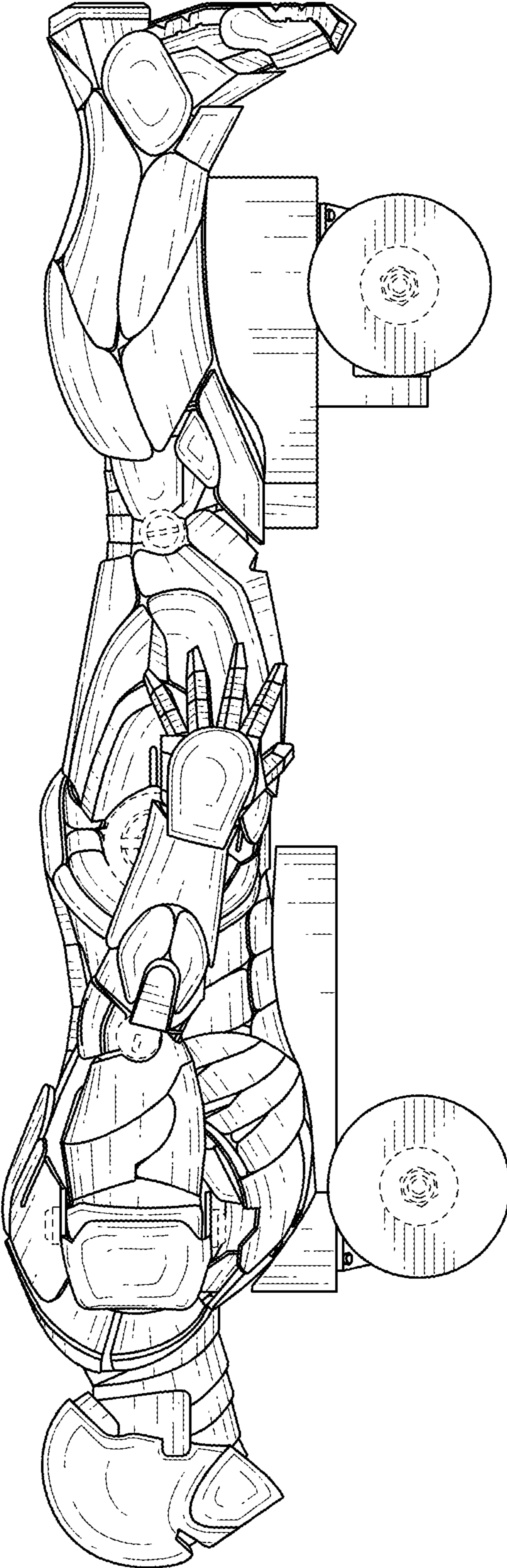
