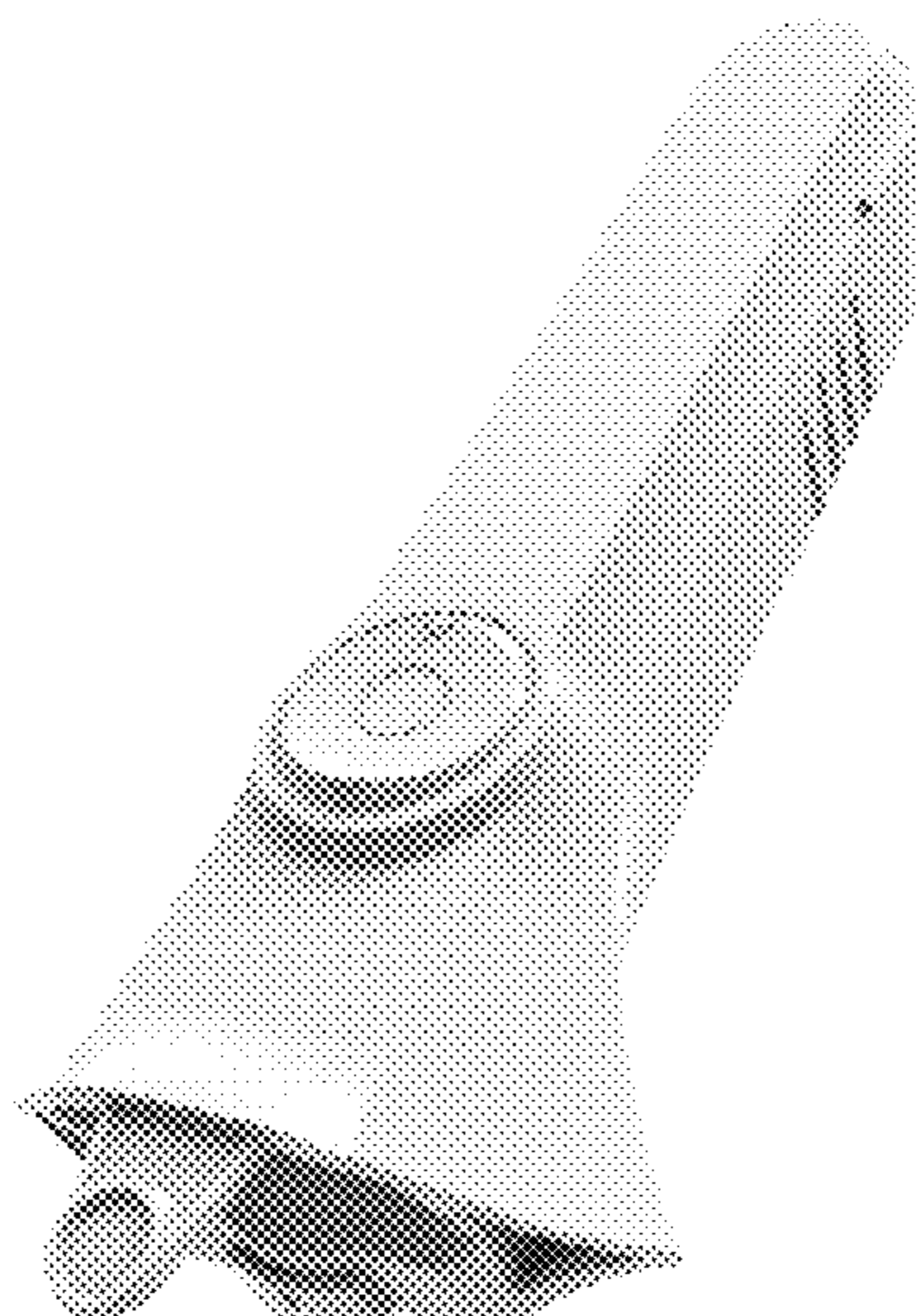
FIG. 1 is a bottom perspective view of the snorkel mask communication tube showing my new design;

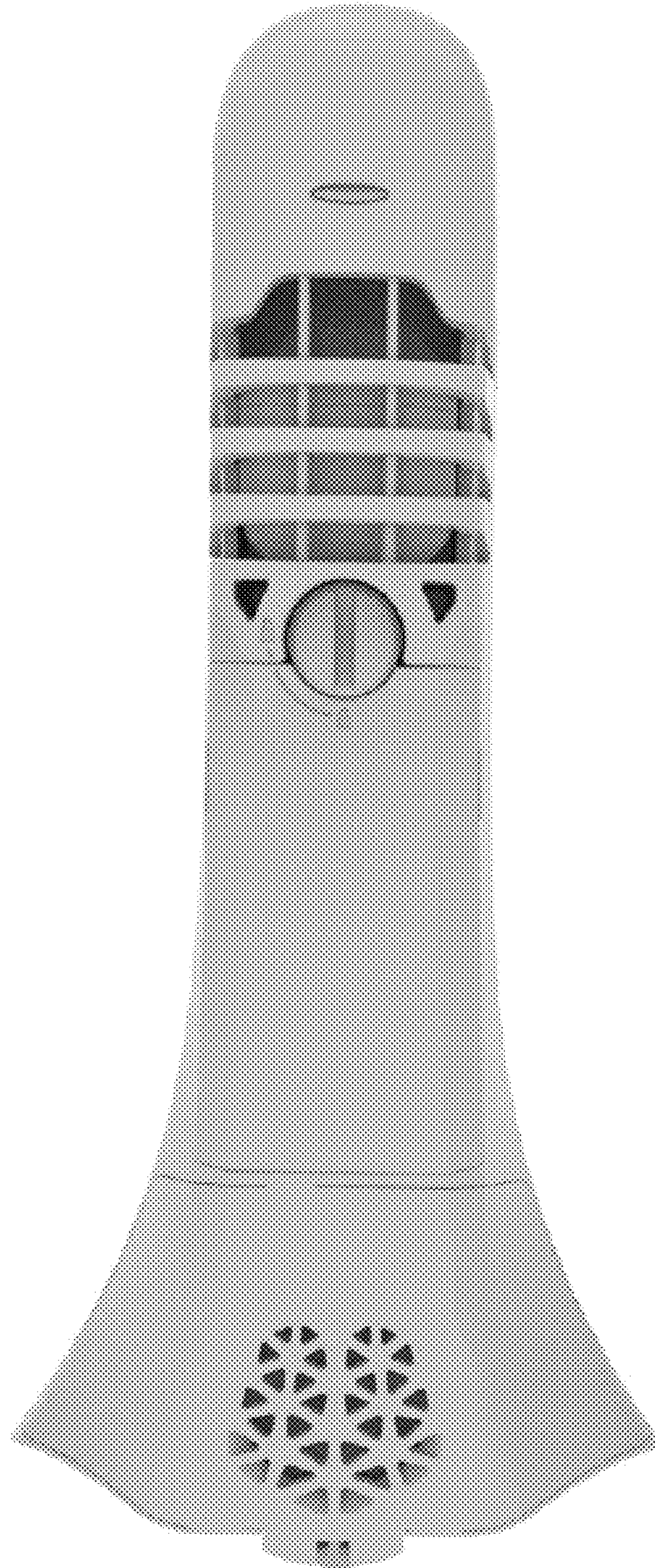

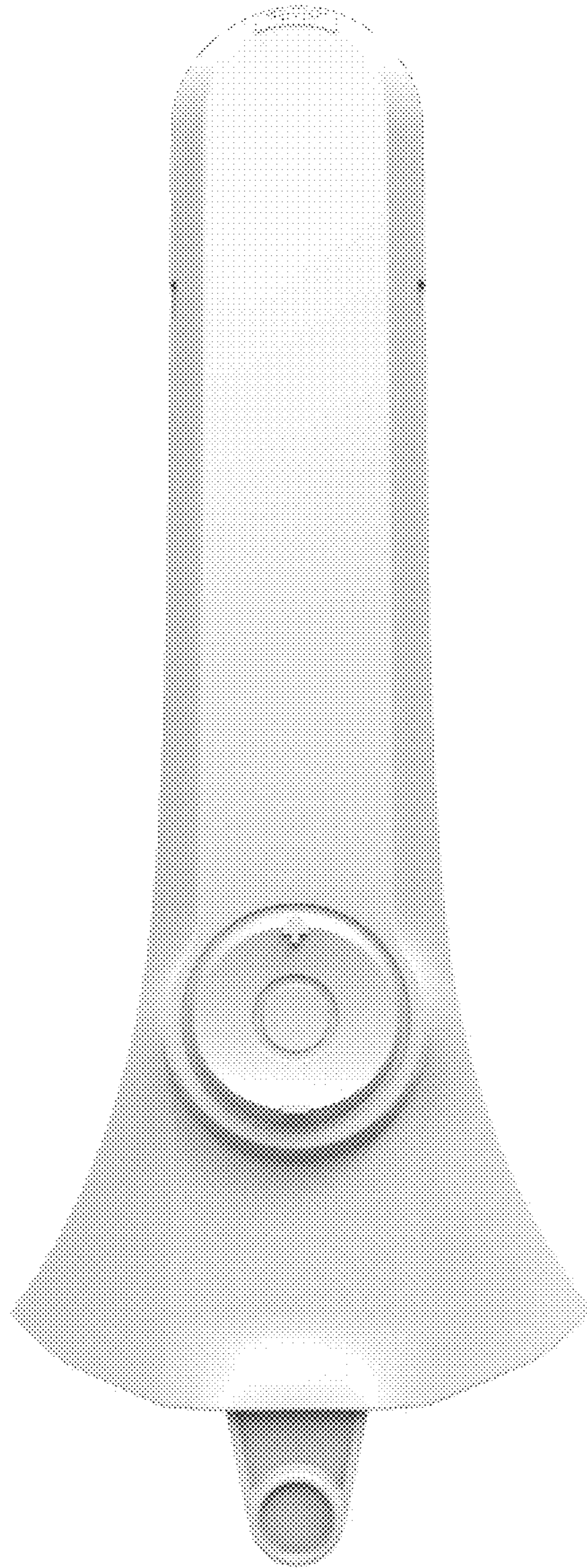
