The broken lines in the drawings illustrate portion of the syringe device and form no part of the claimed design.

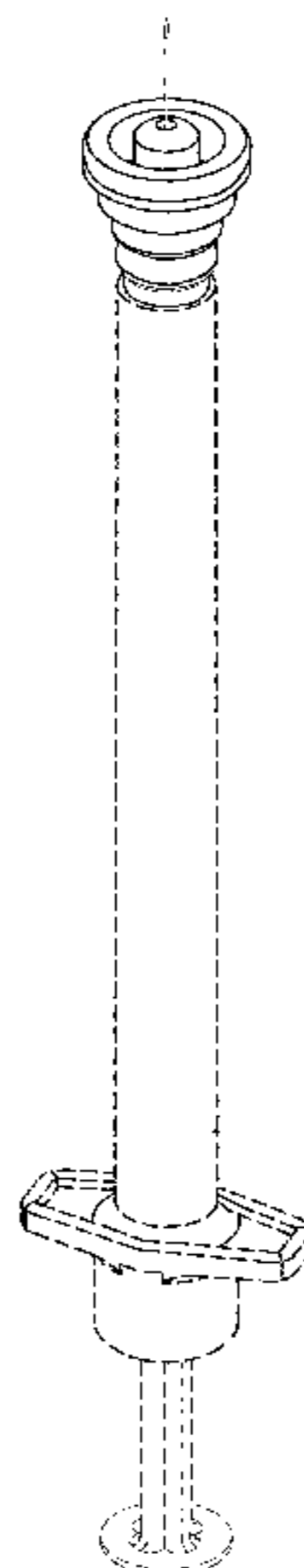

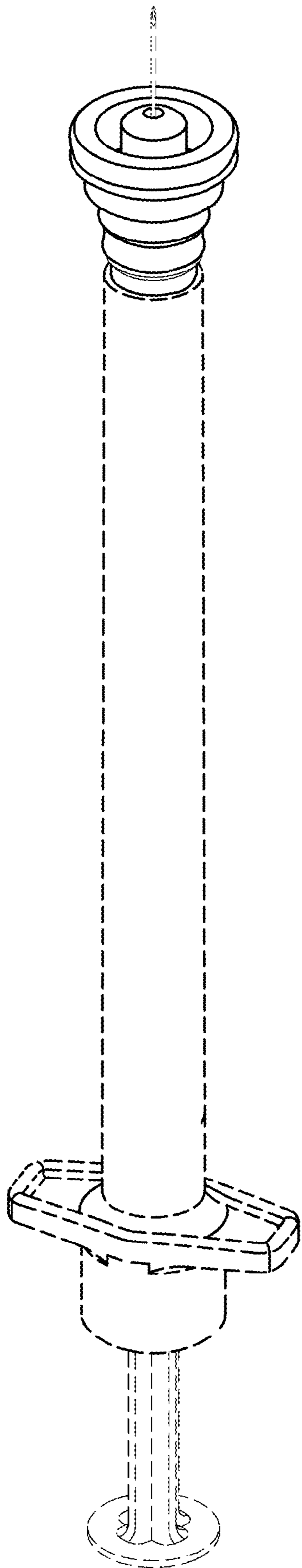

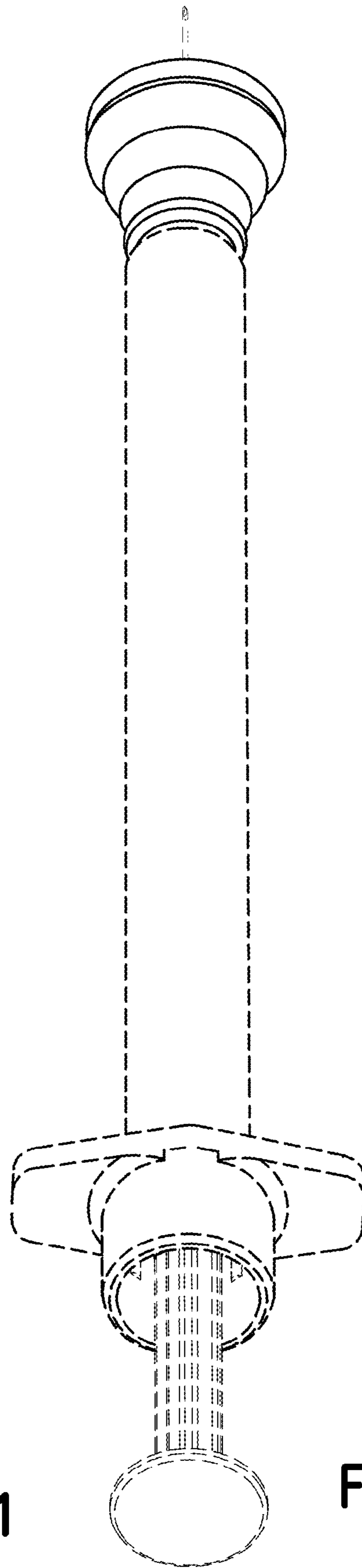

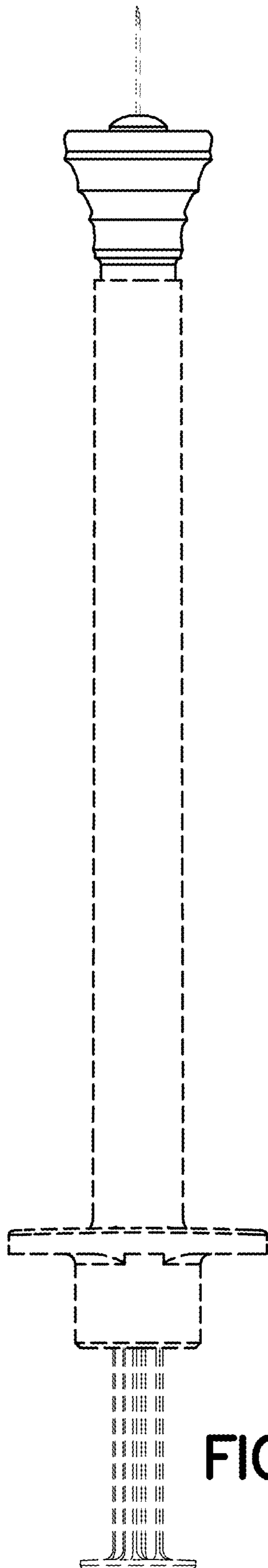

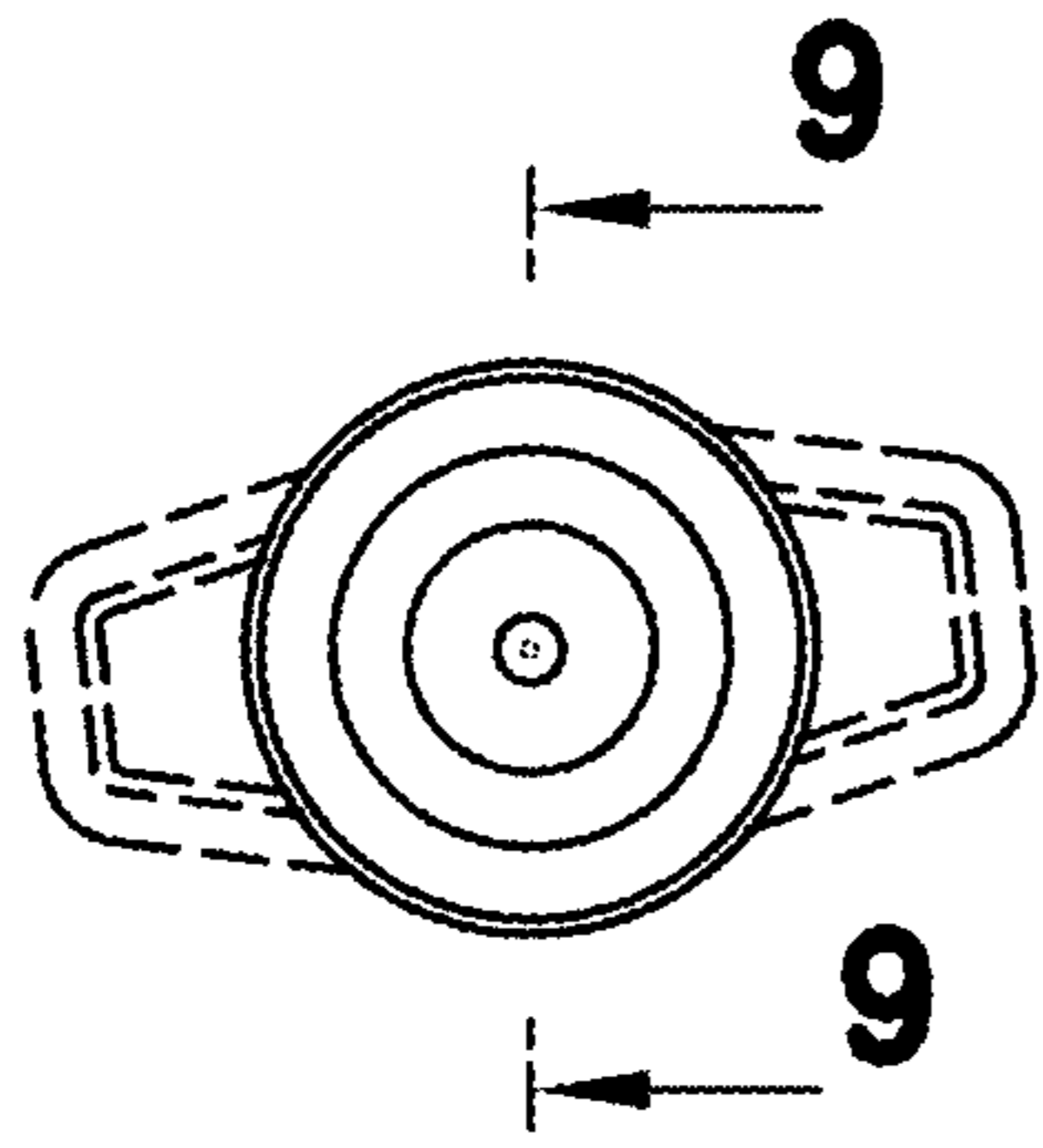

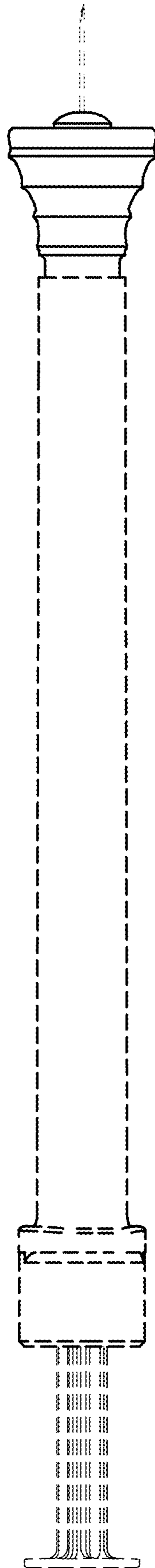

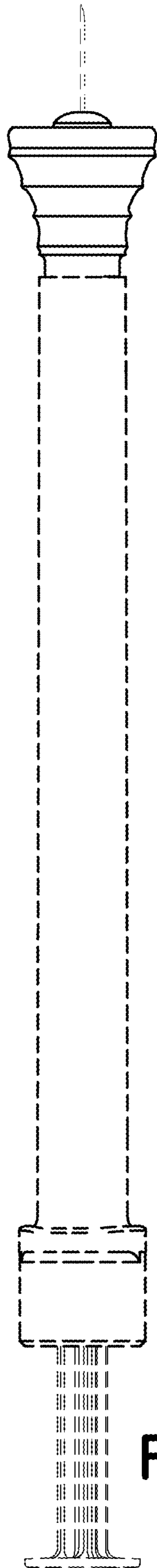

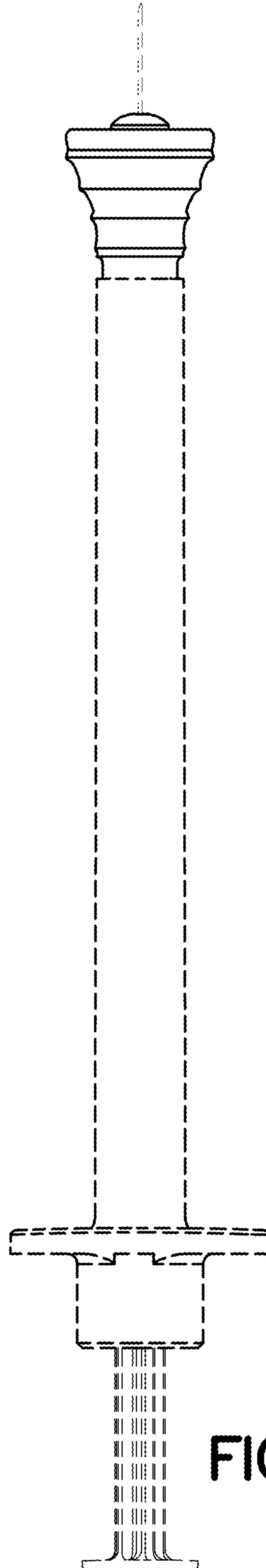

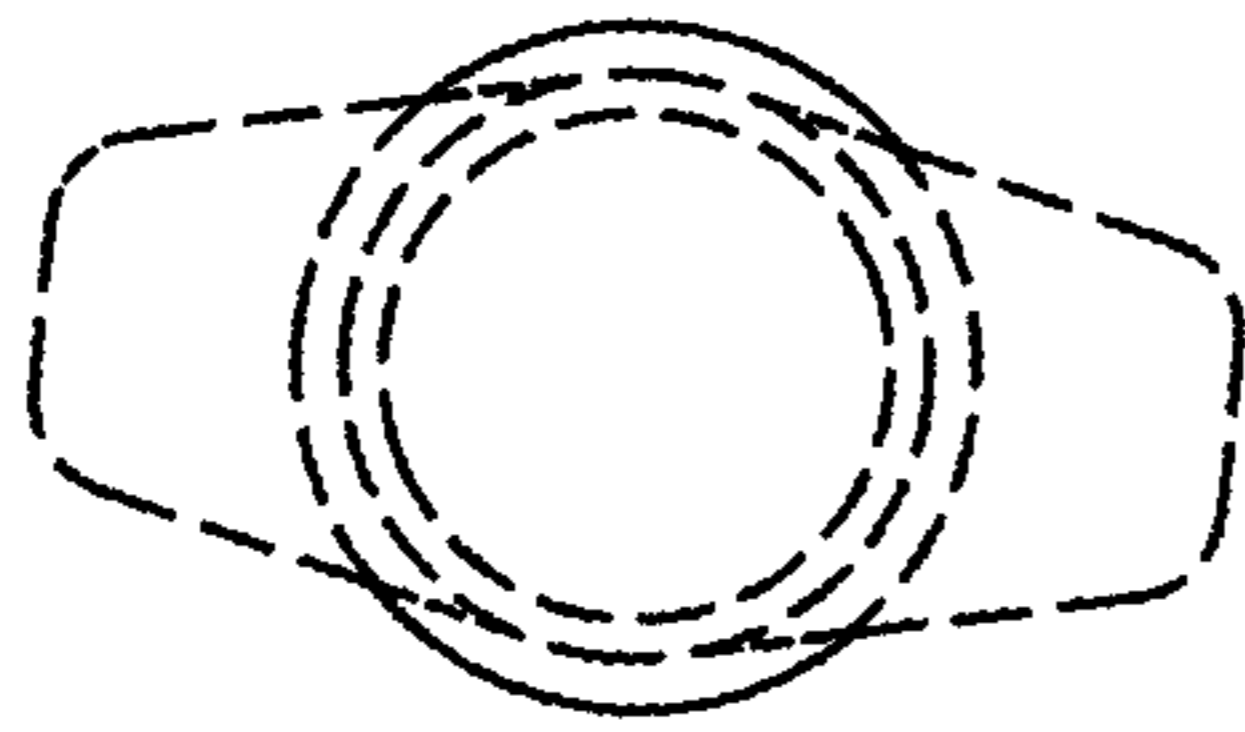

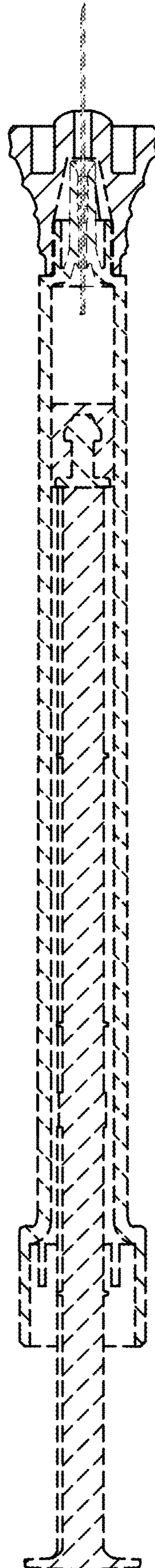
