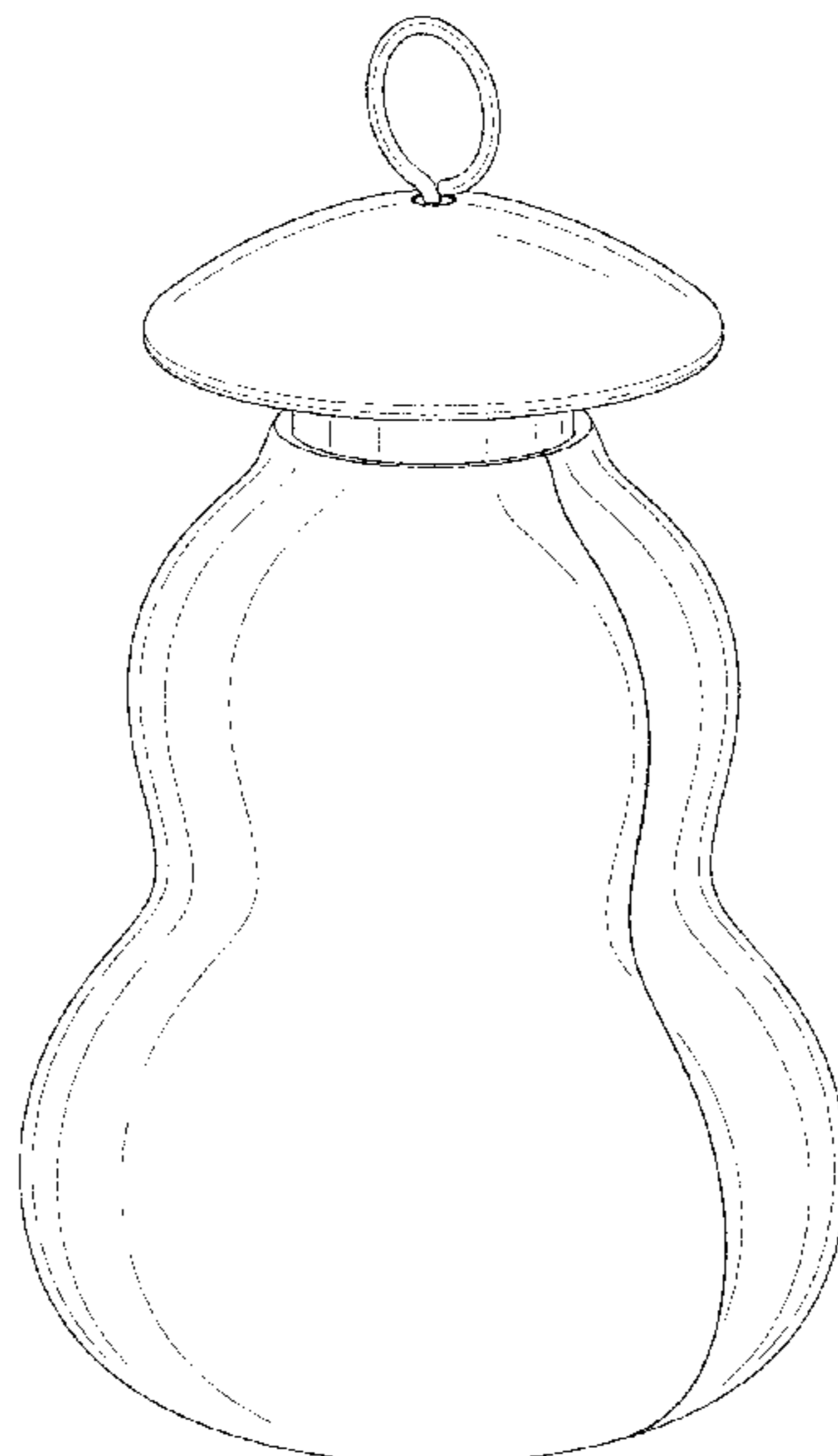
(57) **CLAIM**

The ornamental design for a lamp, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a lamp showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a front, right side, top perspective view thereof with the top portion of the lamp shown in an upwardly extended position; and,
FIG. 9 is a front, right side, top perspective view thereof with the top portion of the lamp shown in a full downward position.

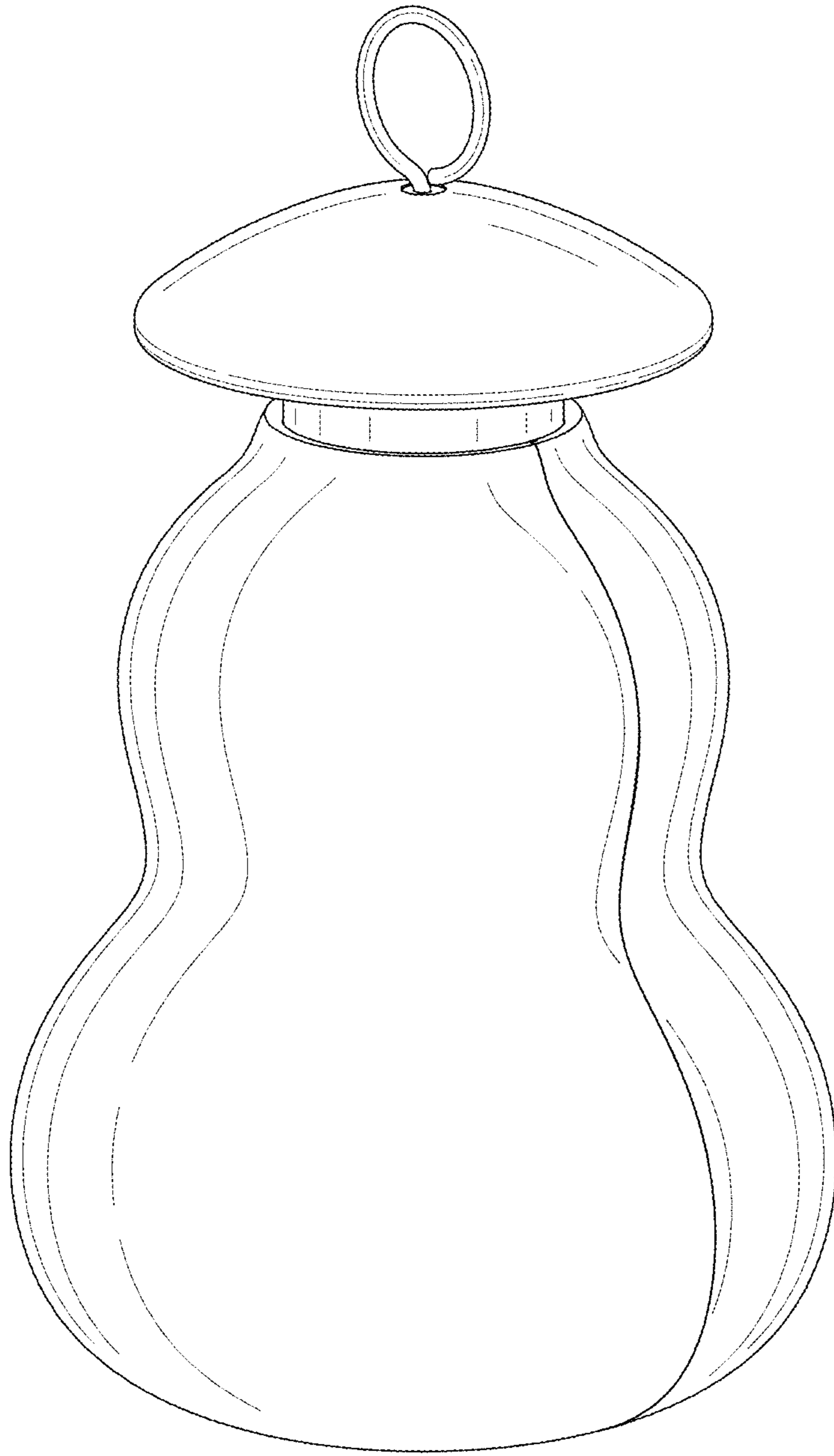

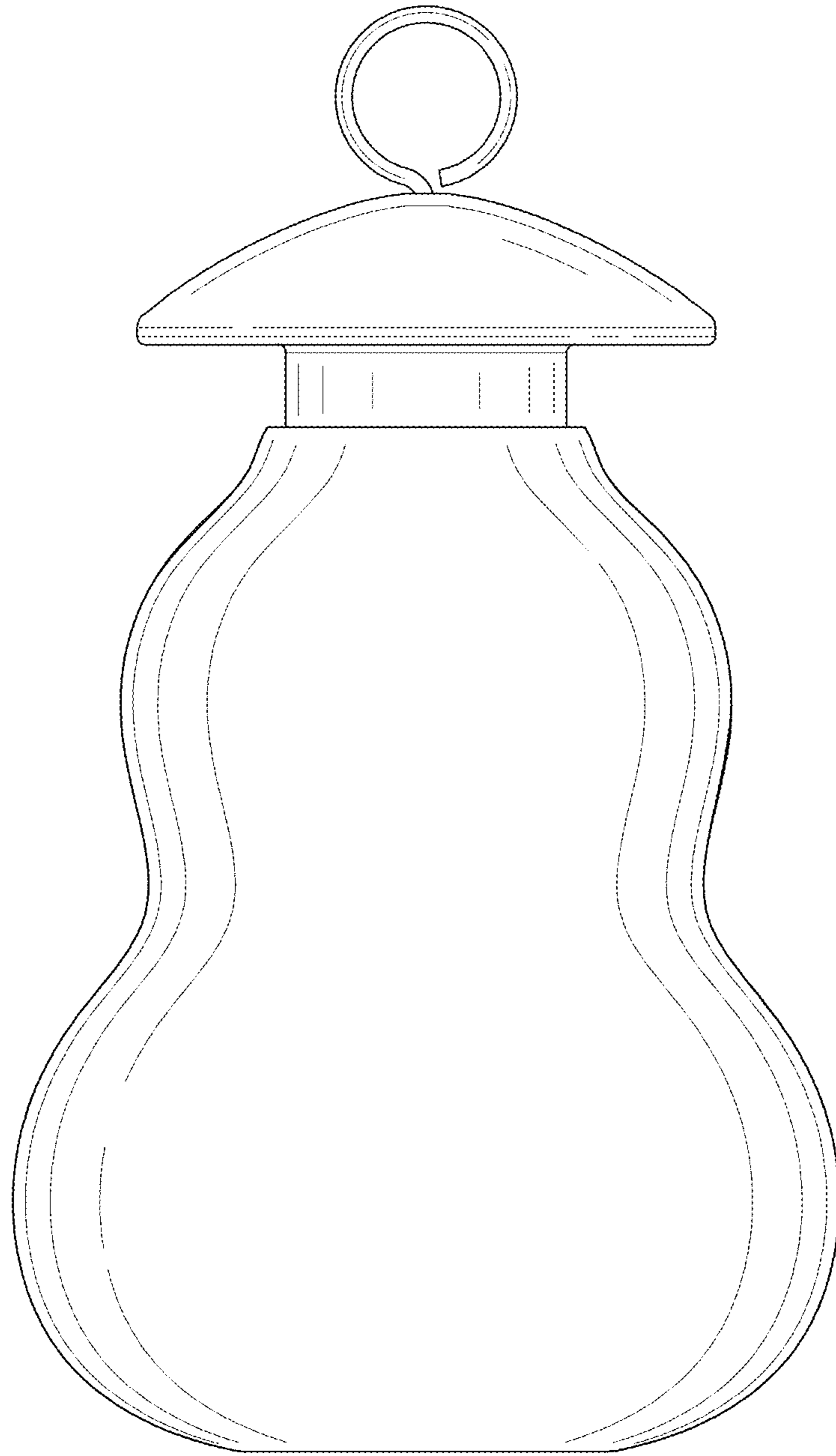

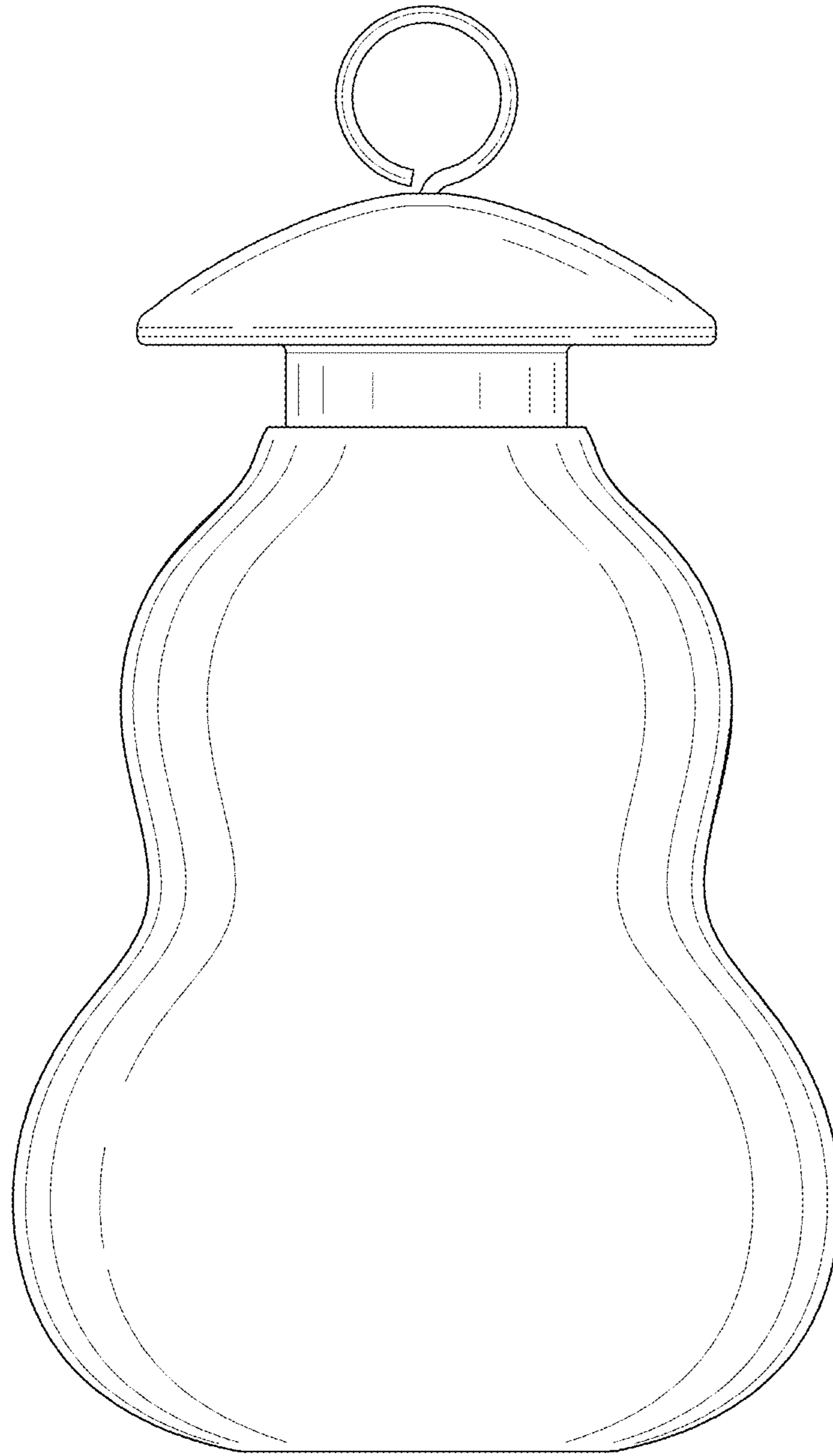

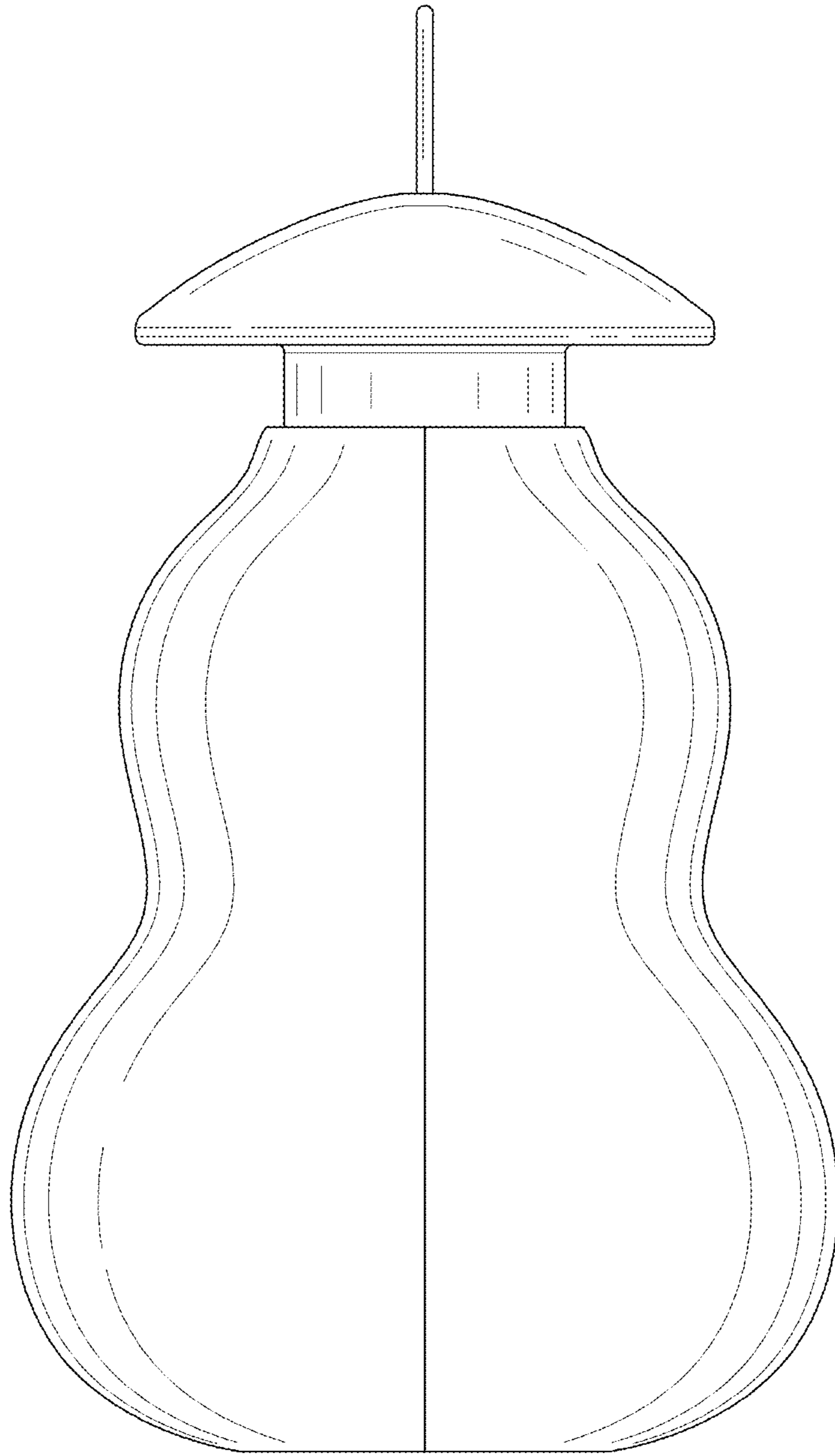

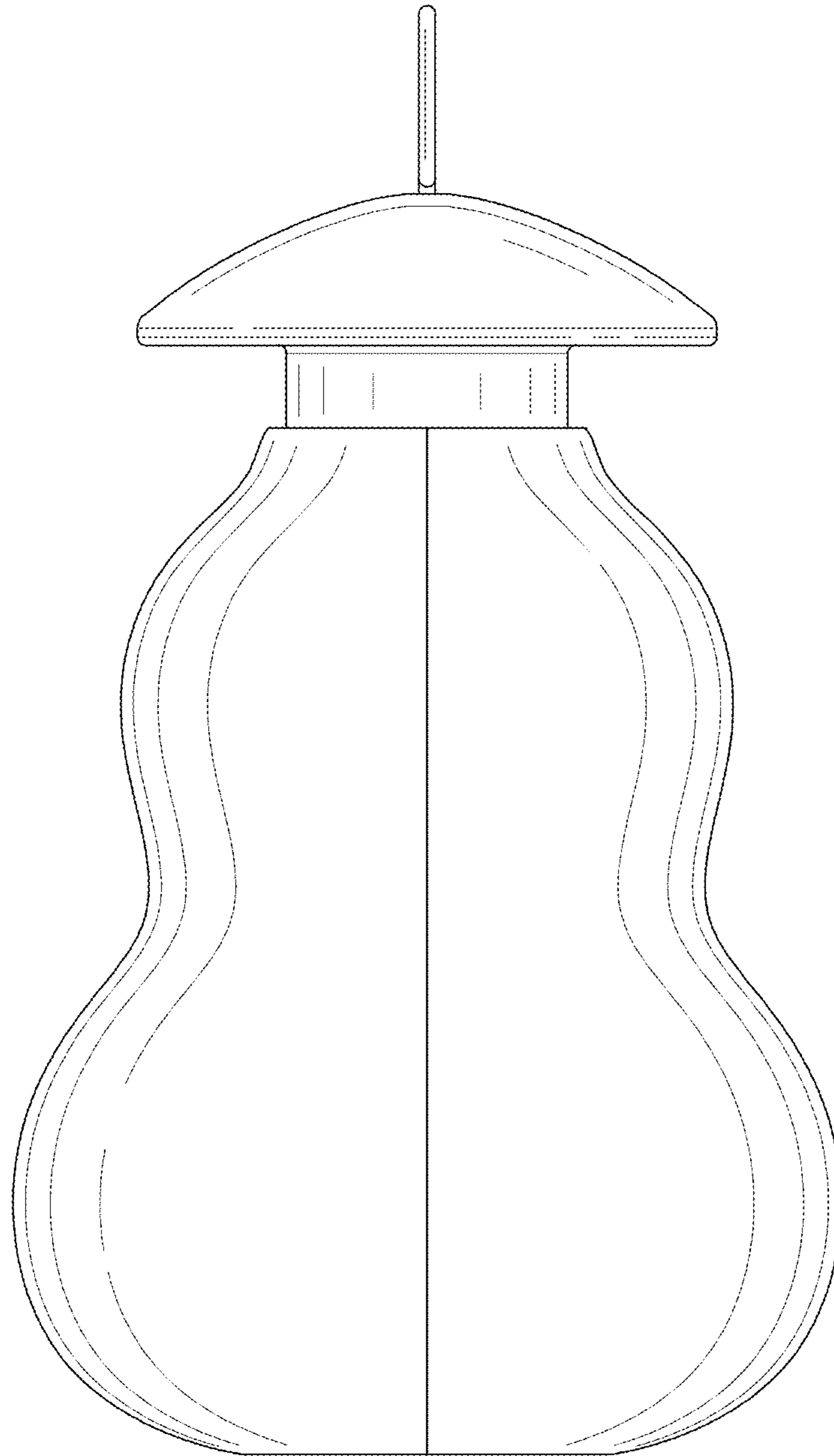

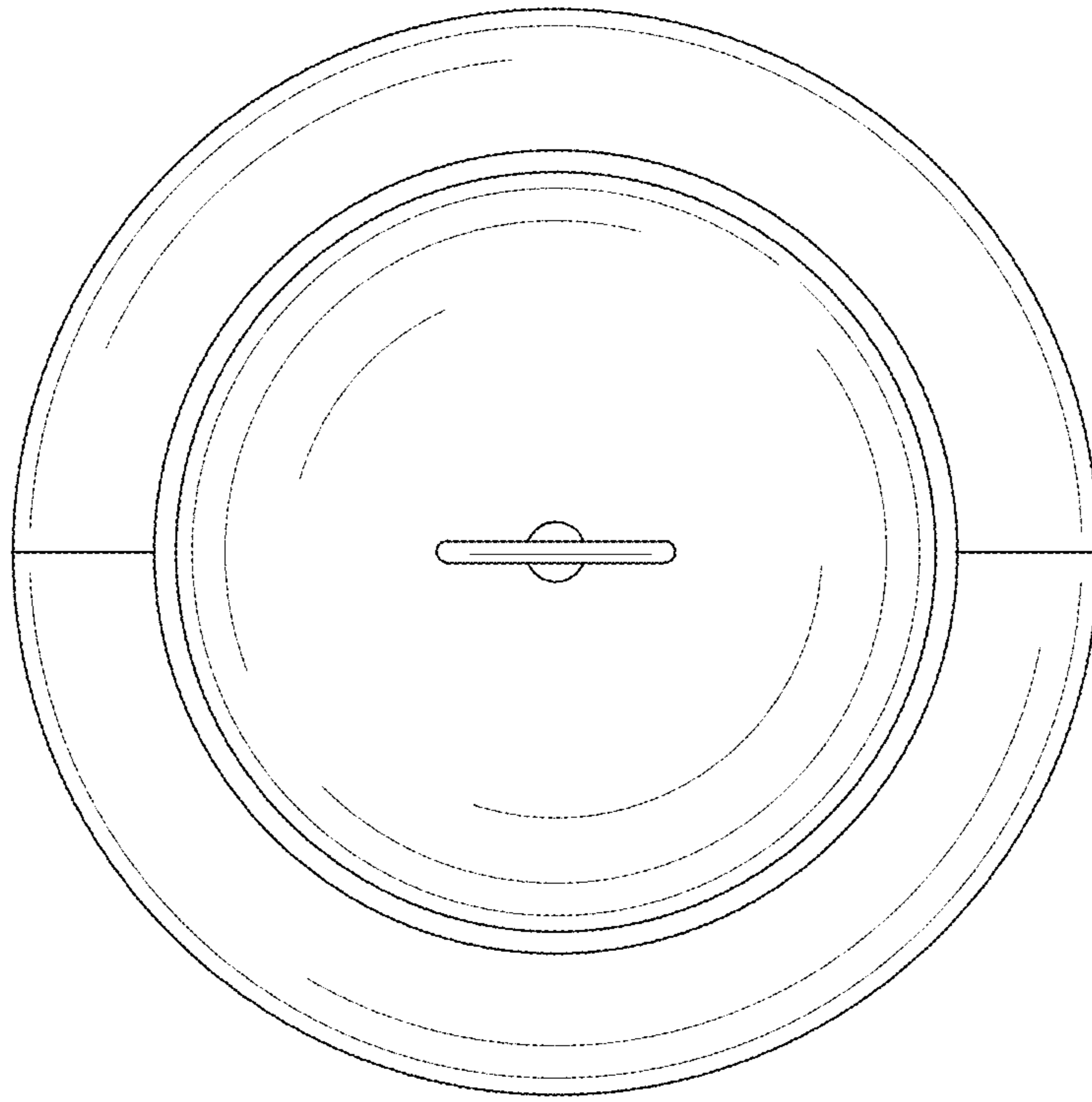

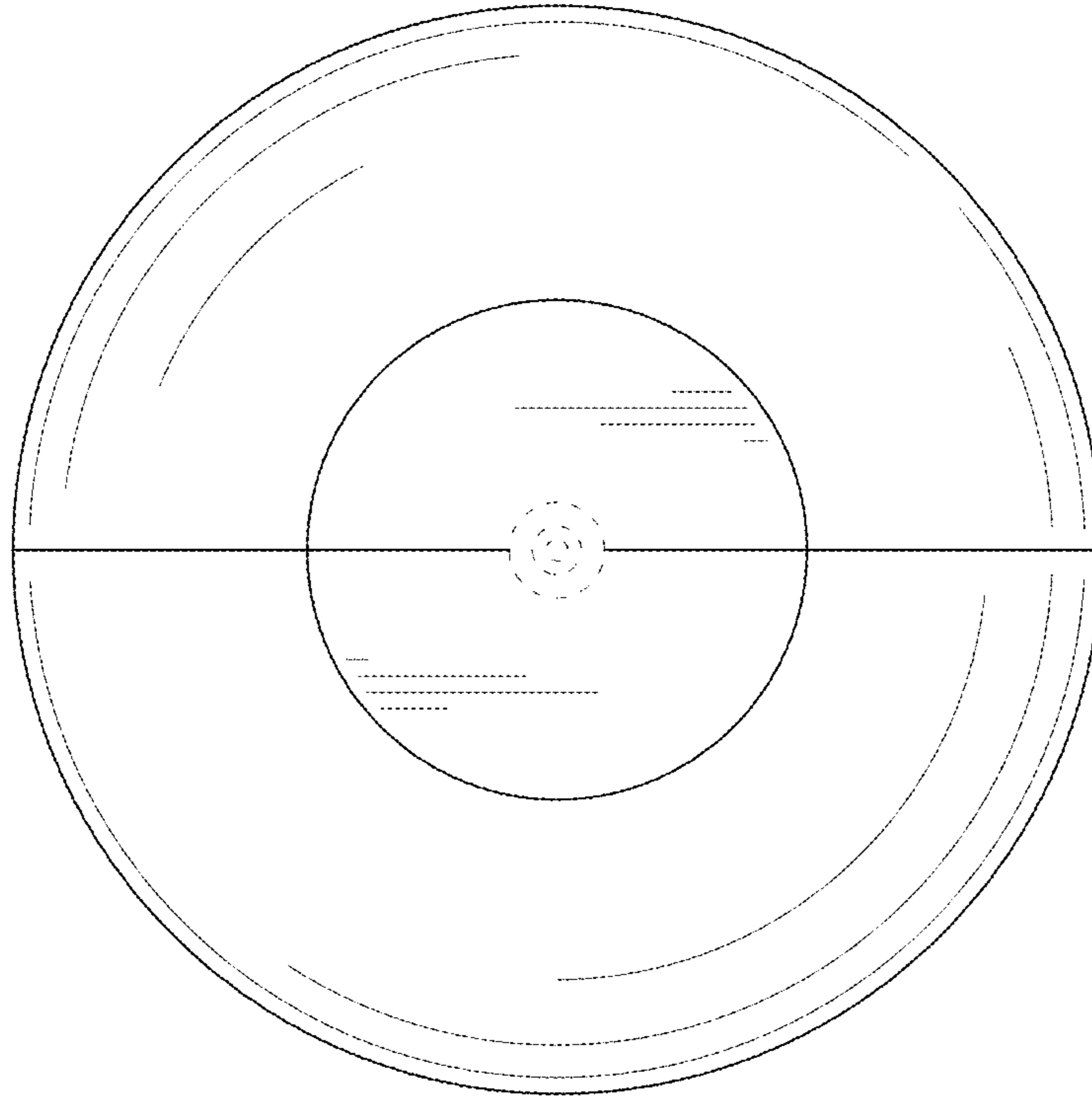

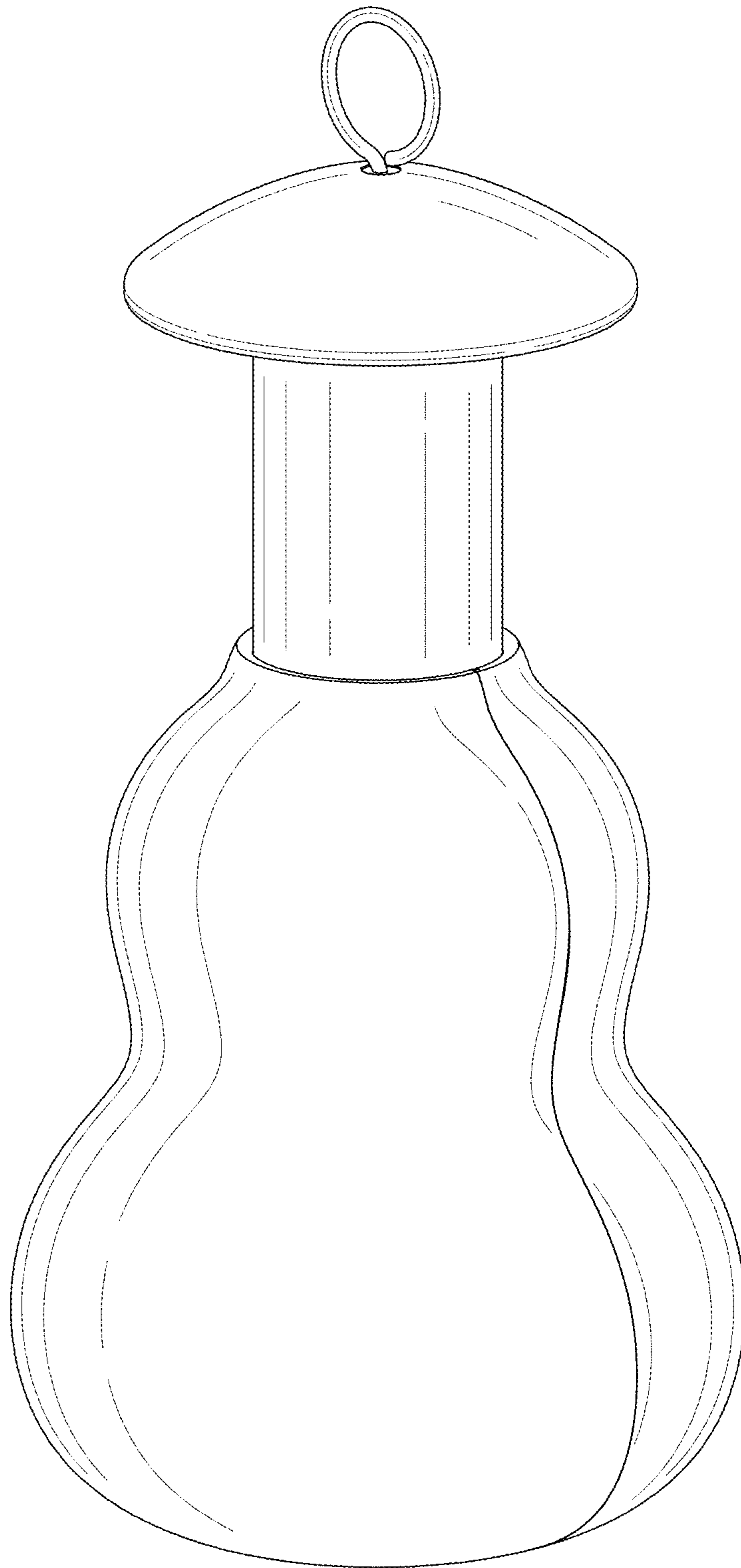

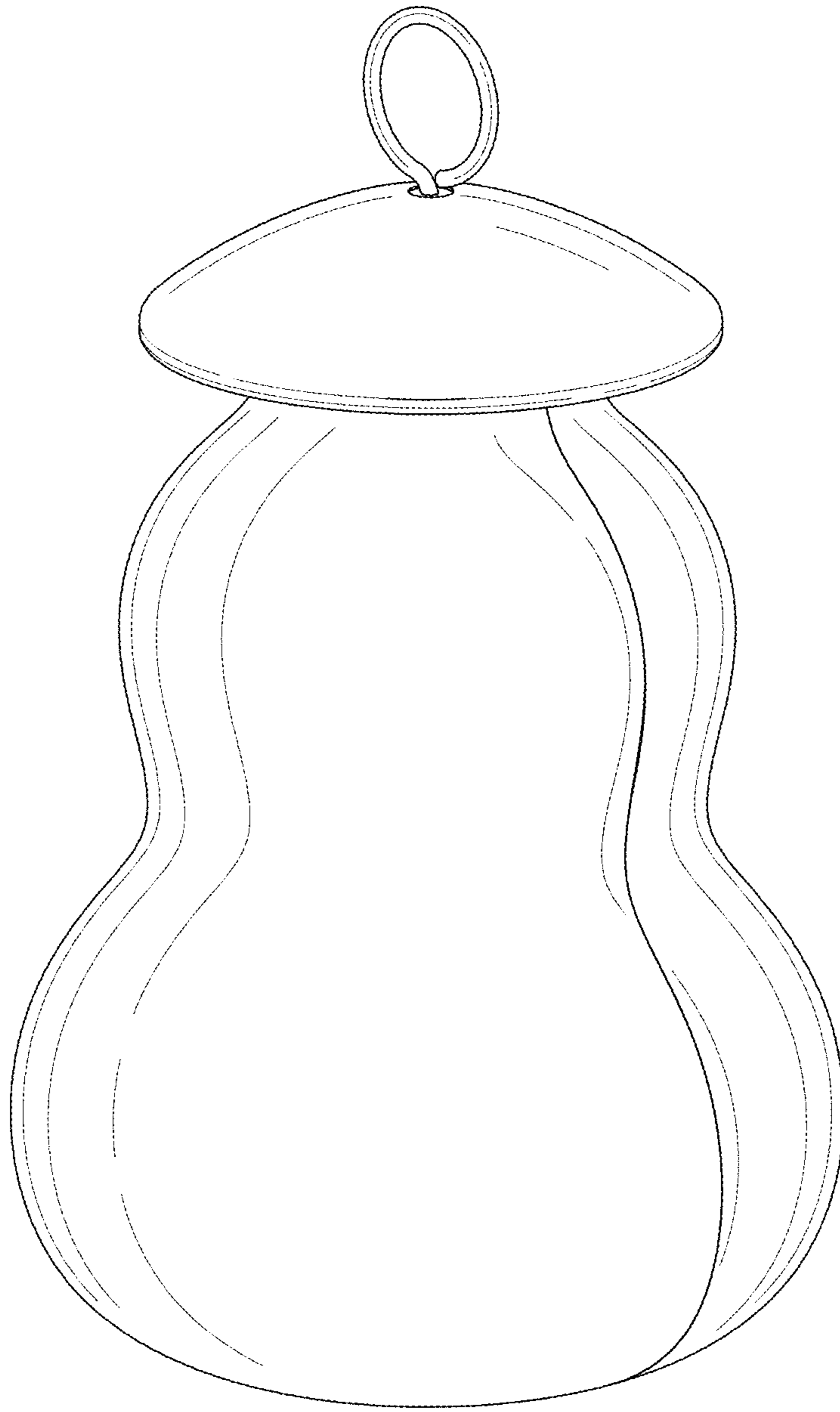
