DESCRIPTION

FIG. 1 is a rear, right side and top perspective view of a hair straightener, showing my new design;

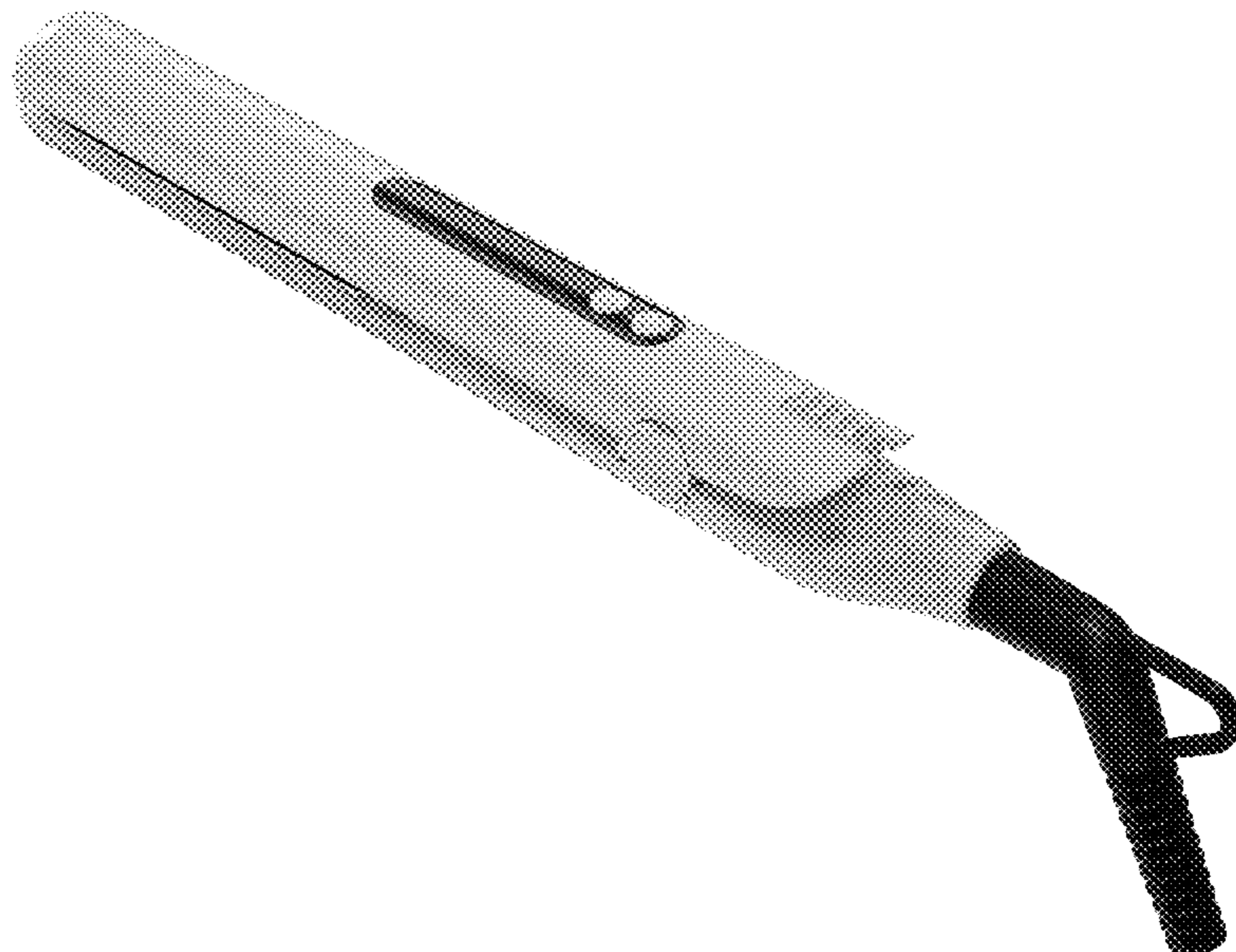

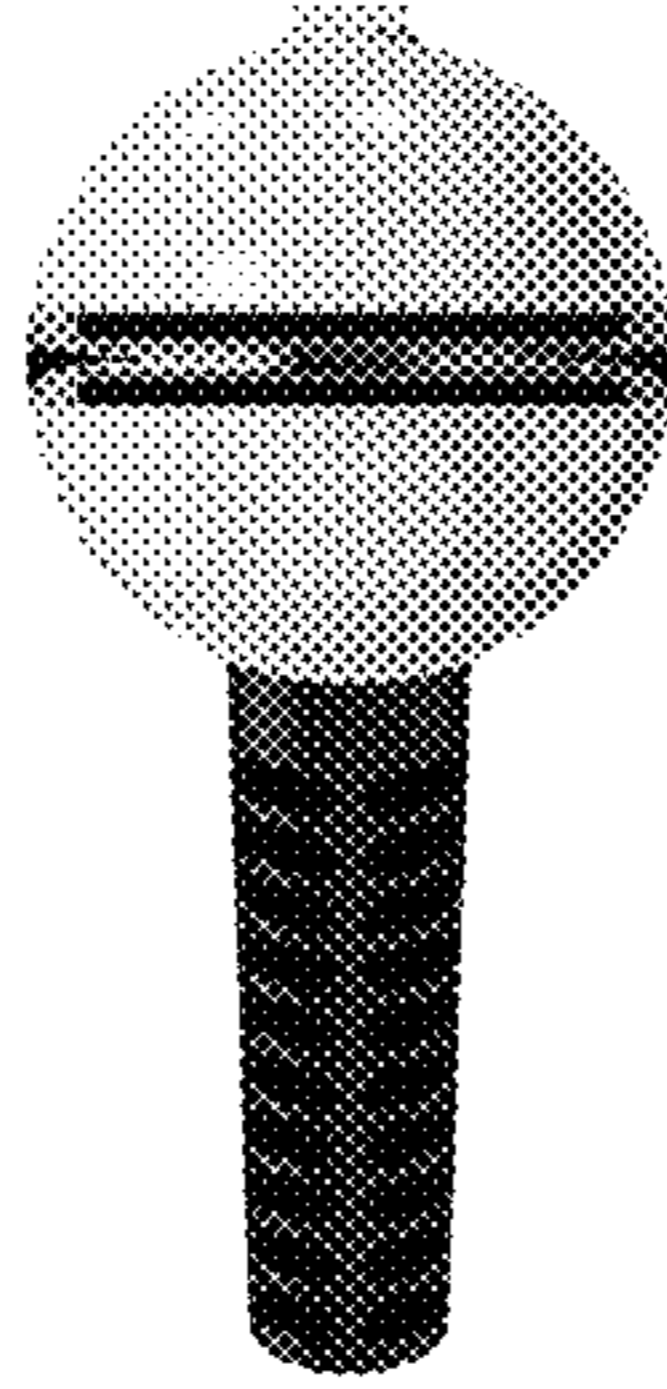

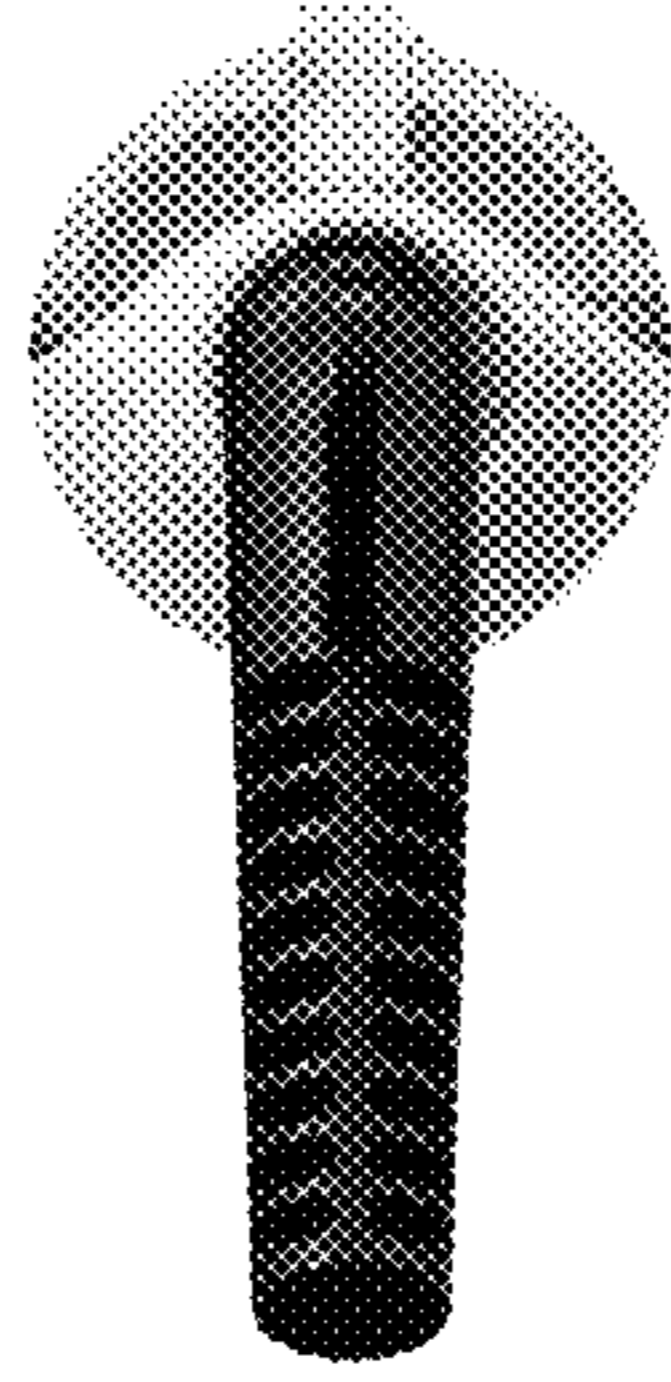

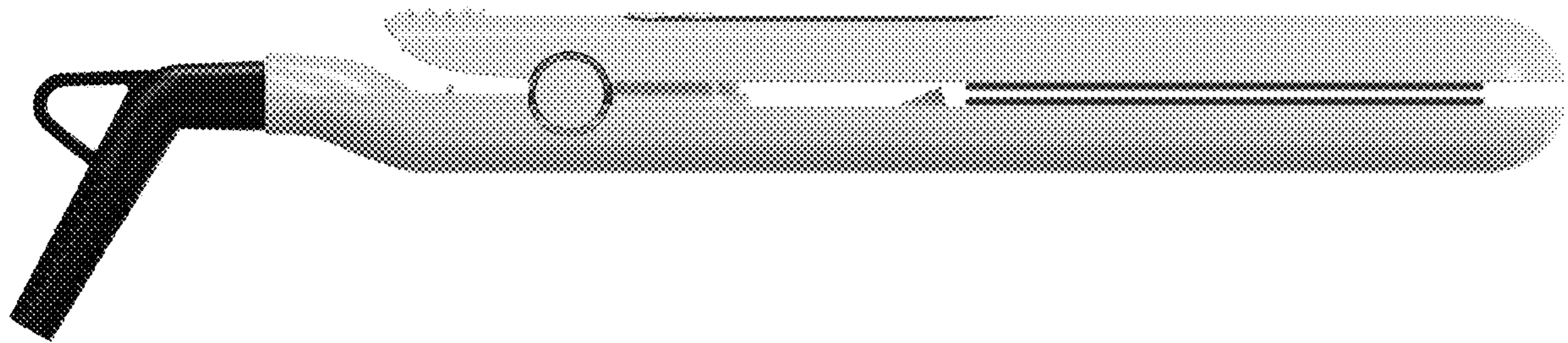

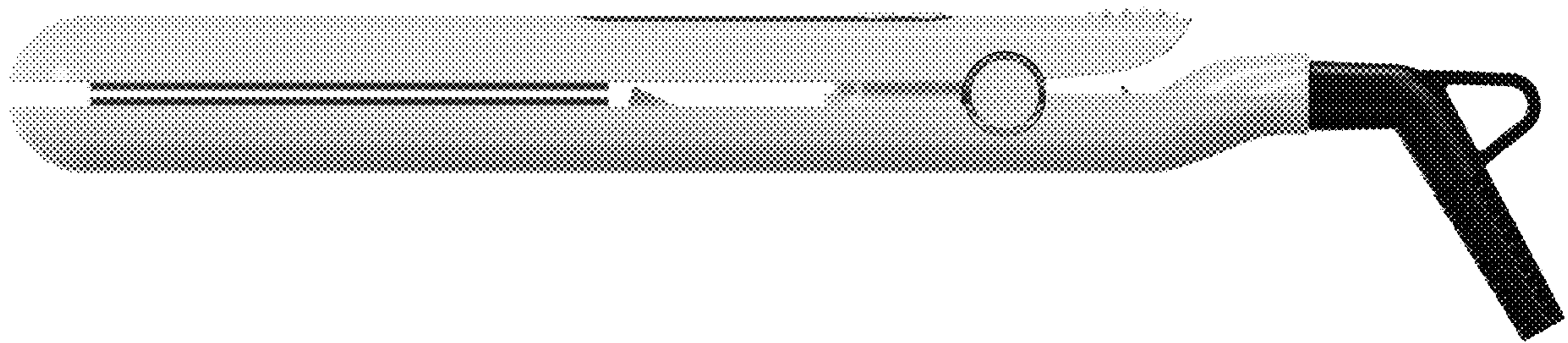

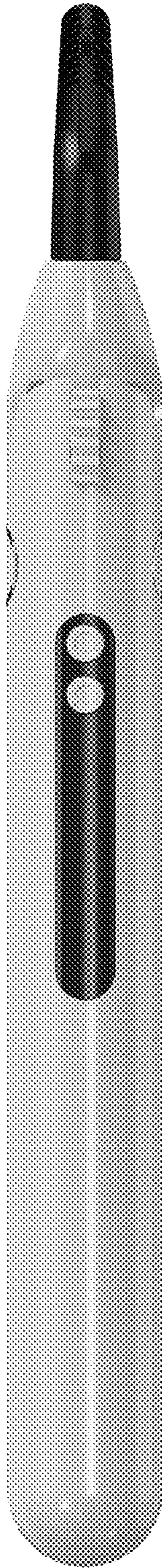

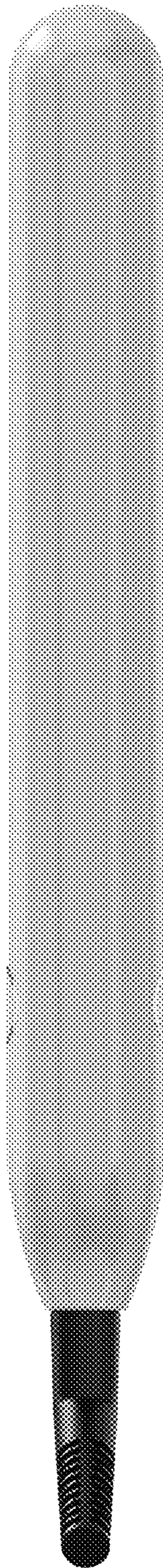

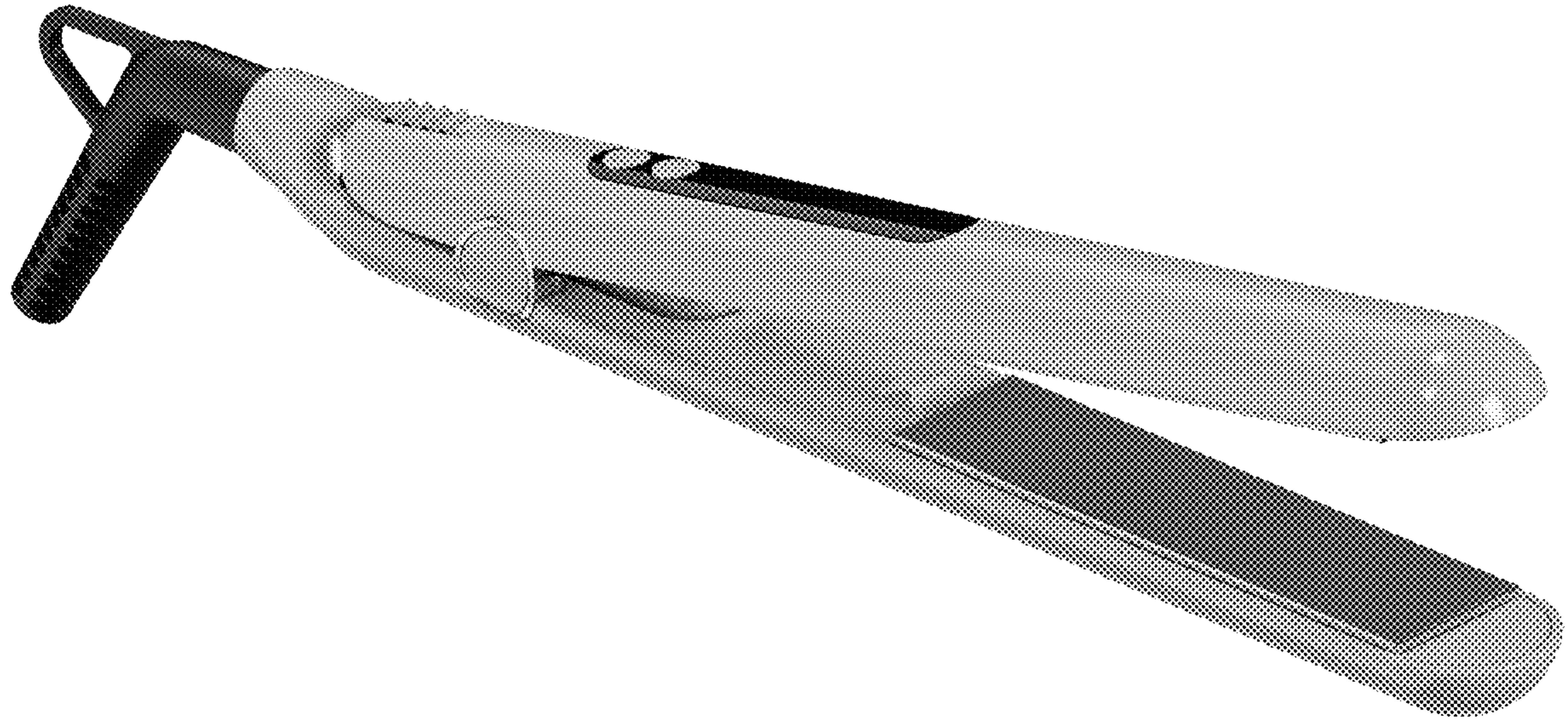

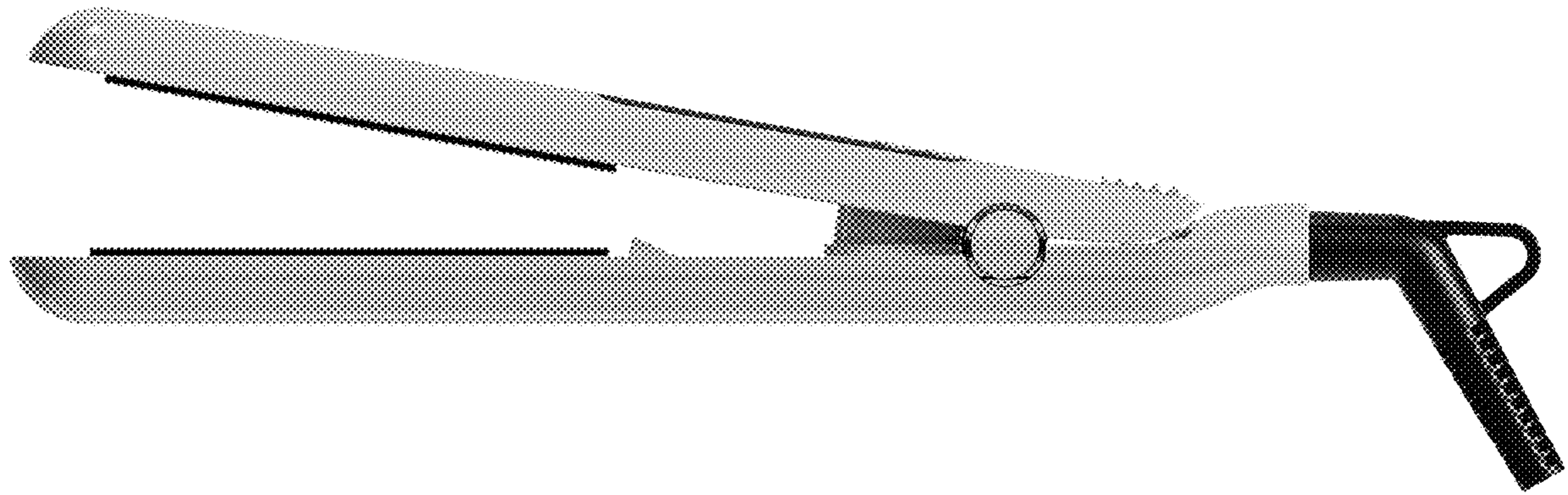
