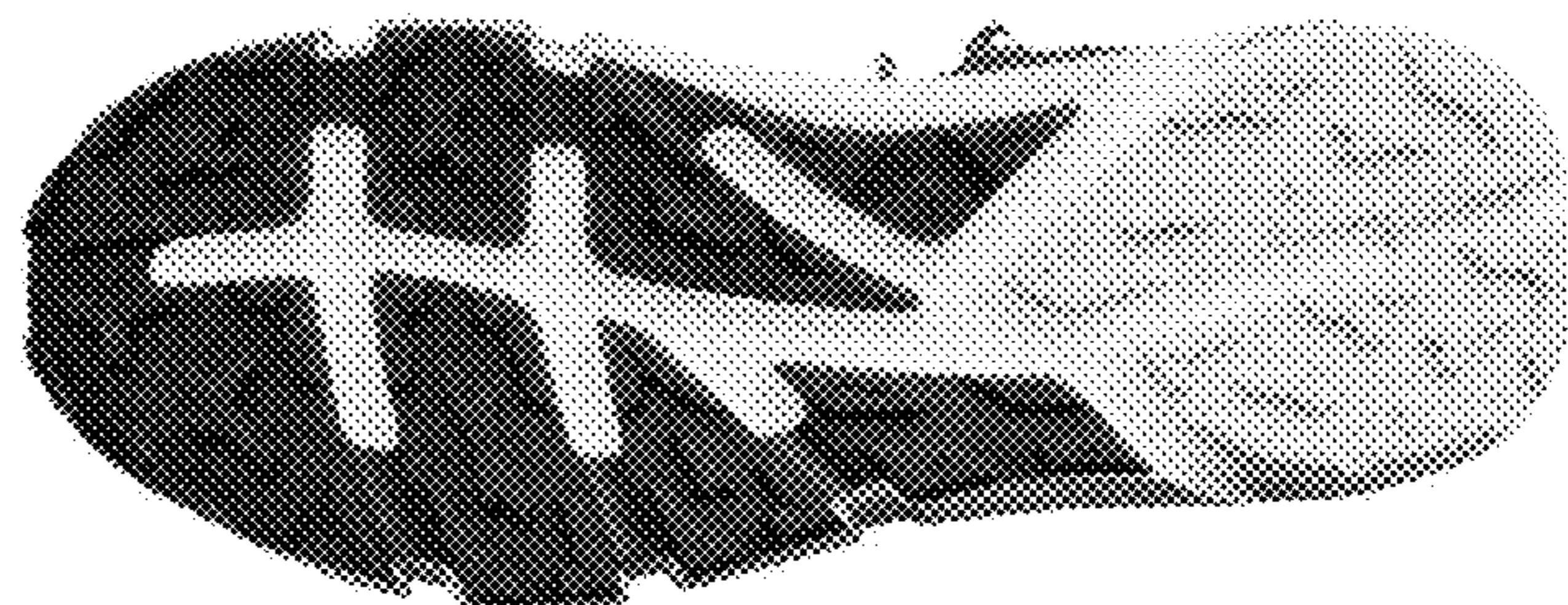
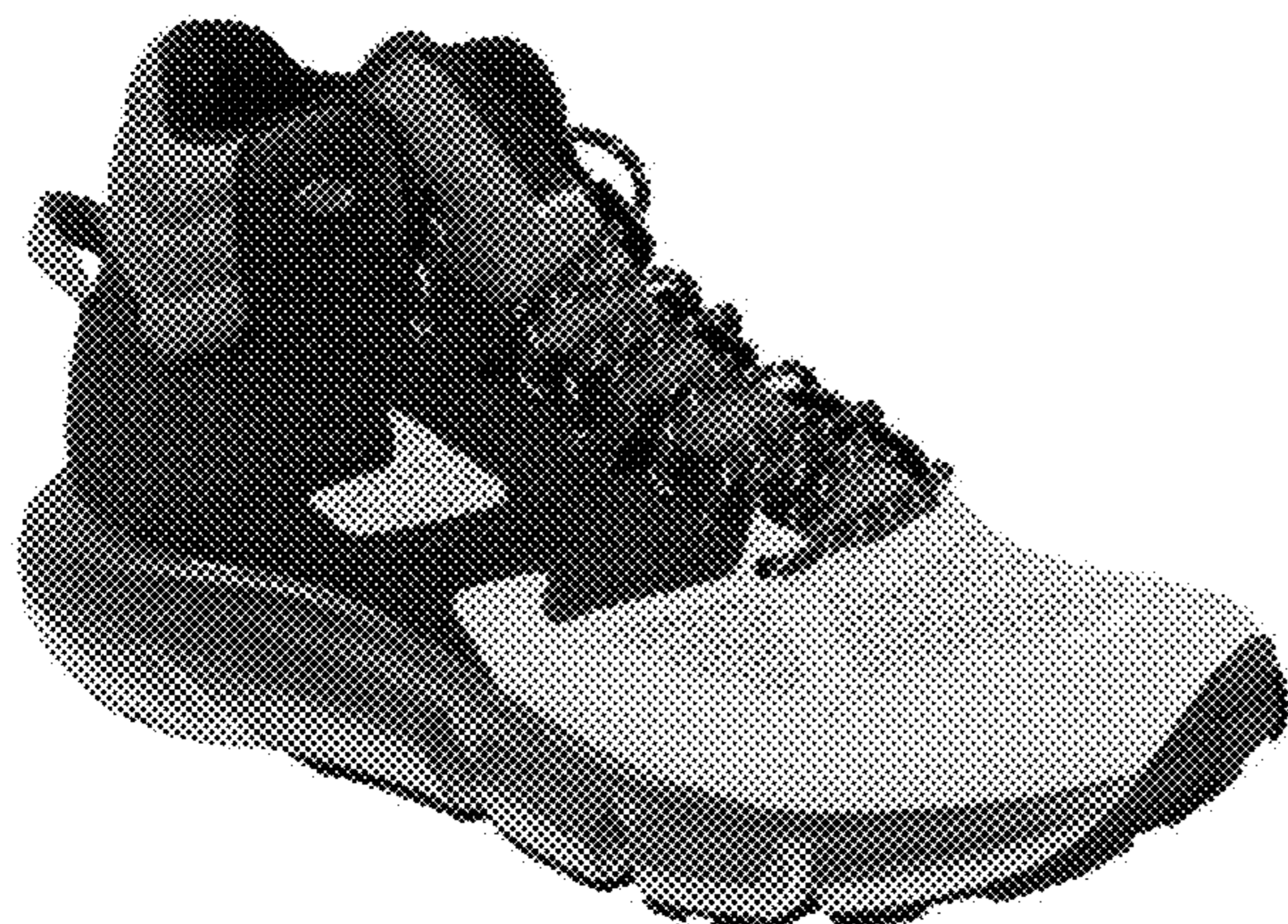
The ornamental design for a footwear article, as shown and described.

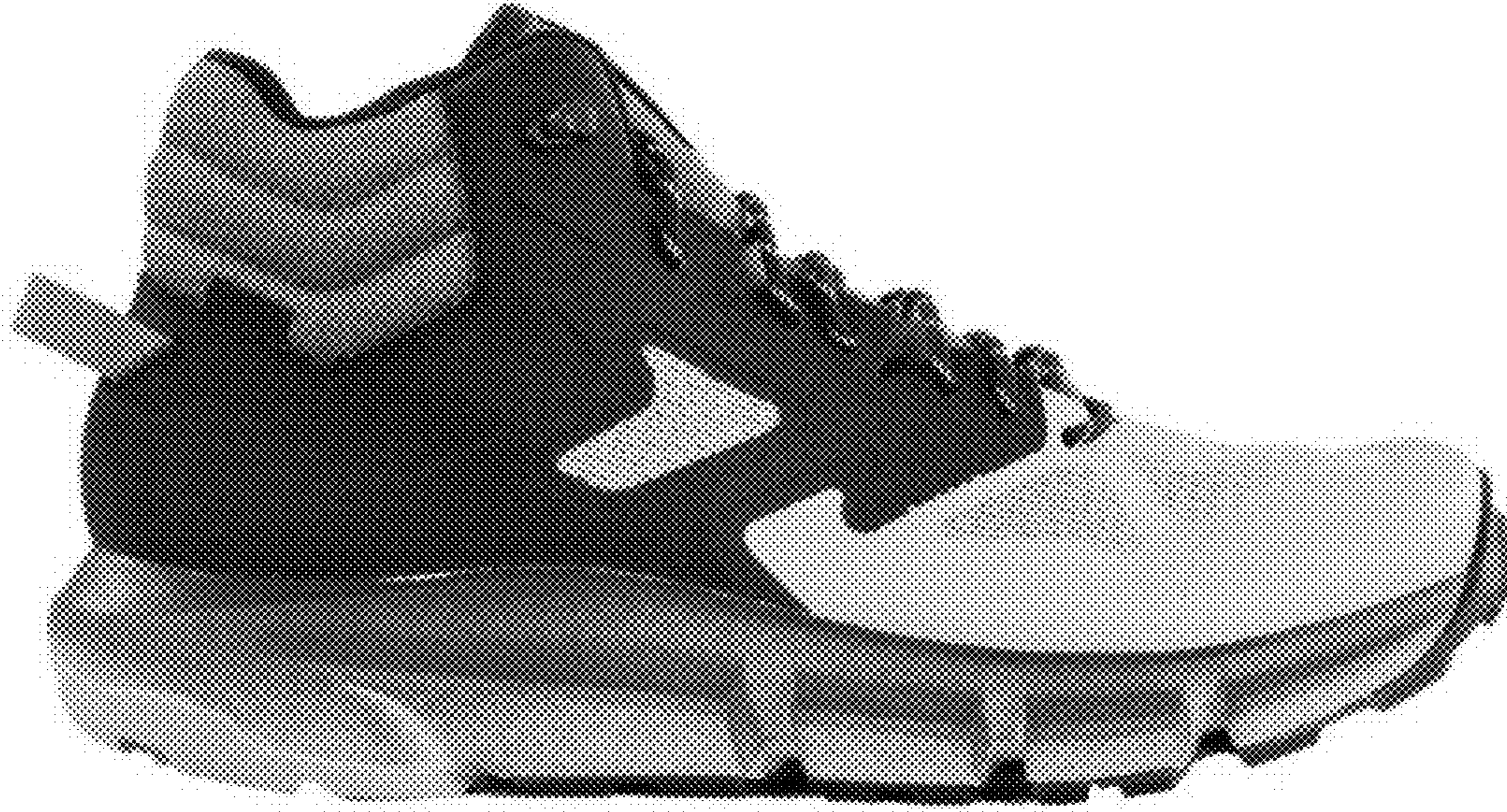

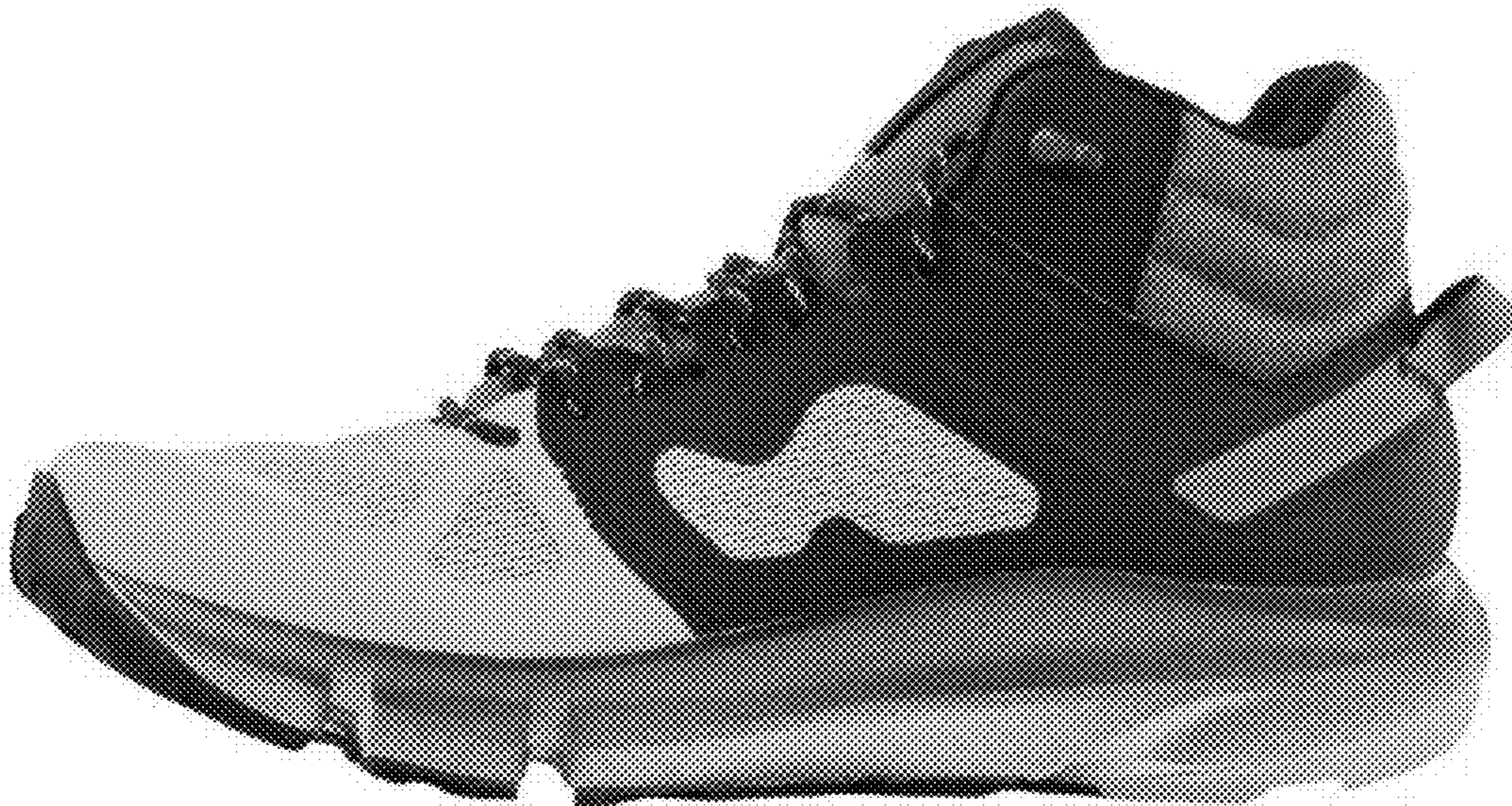

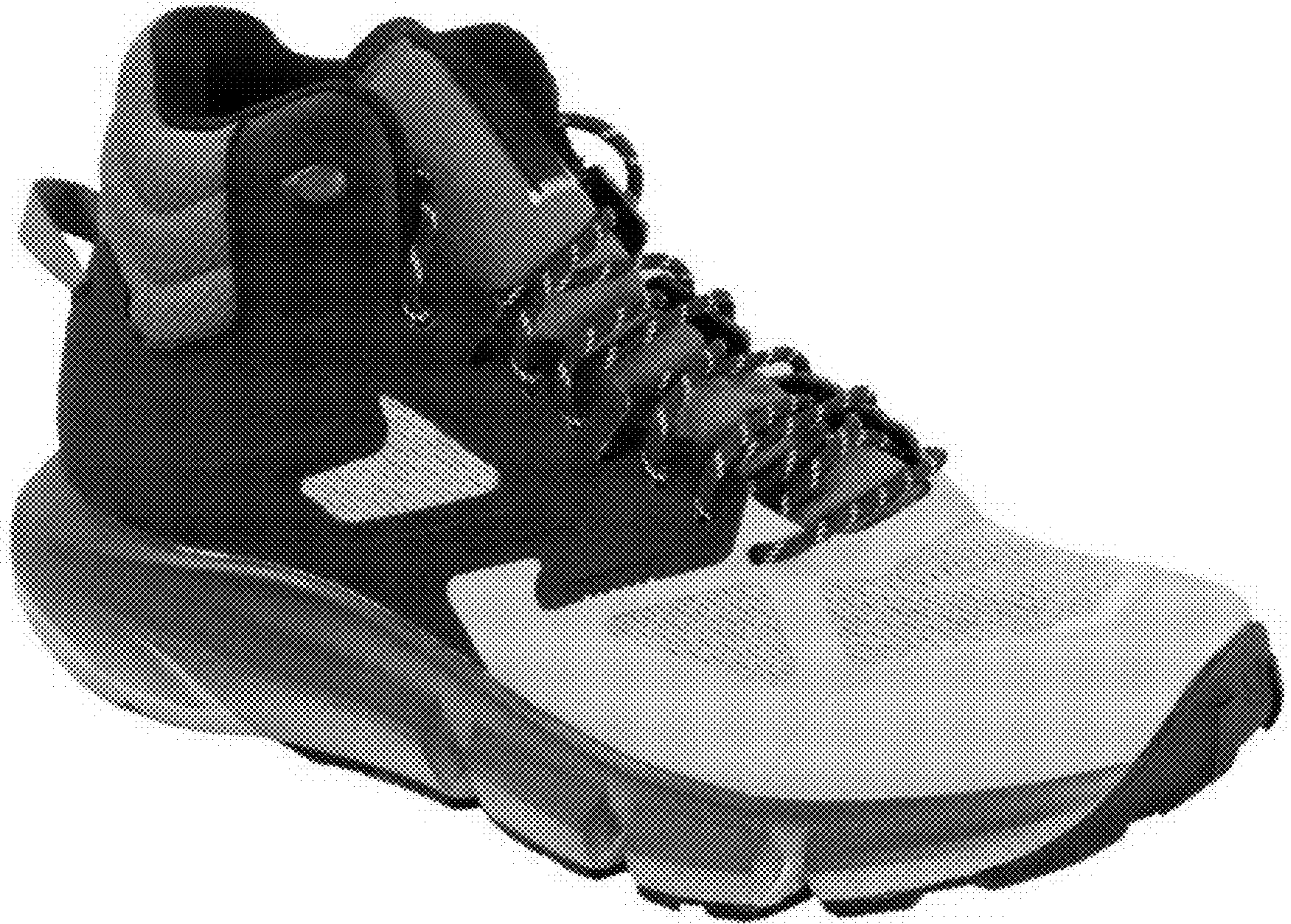

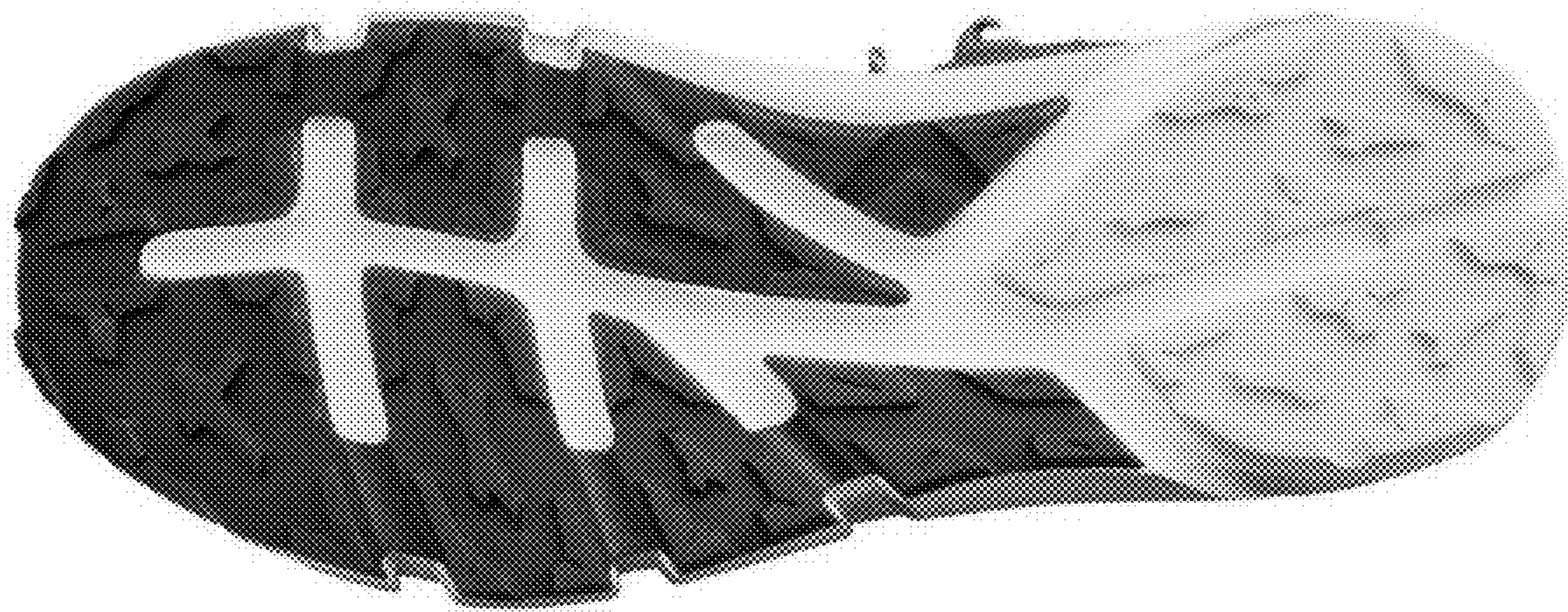
