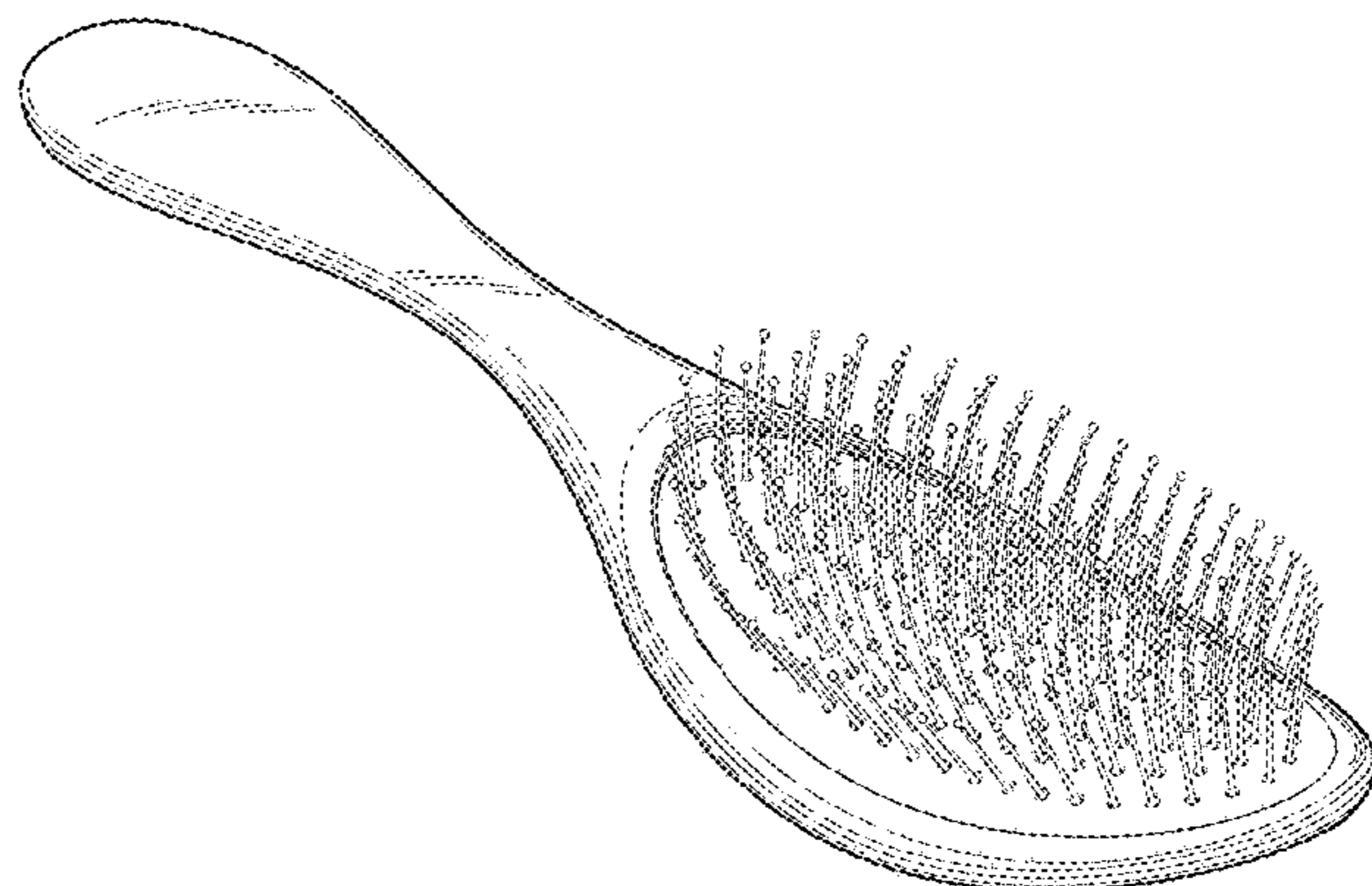
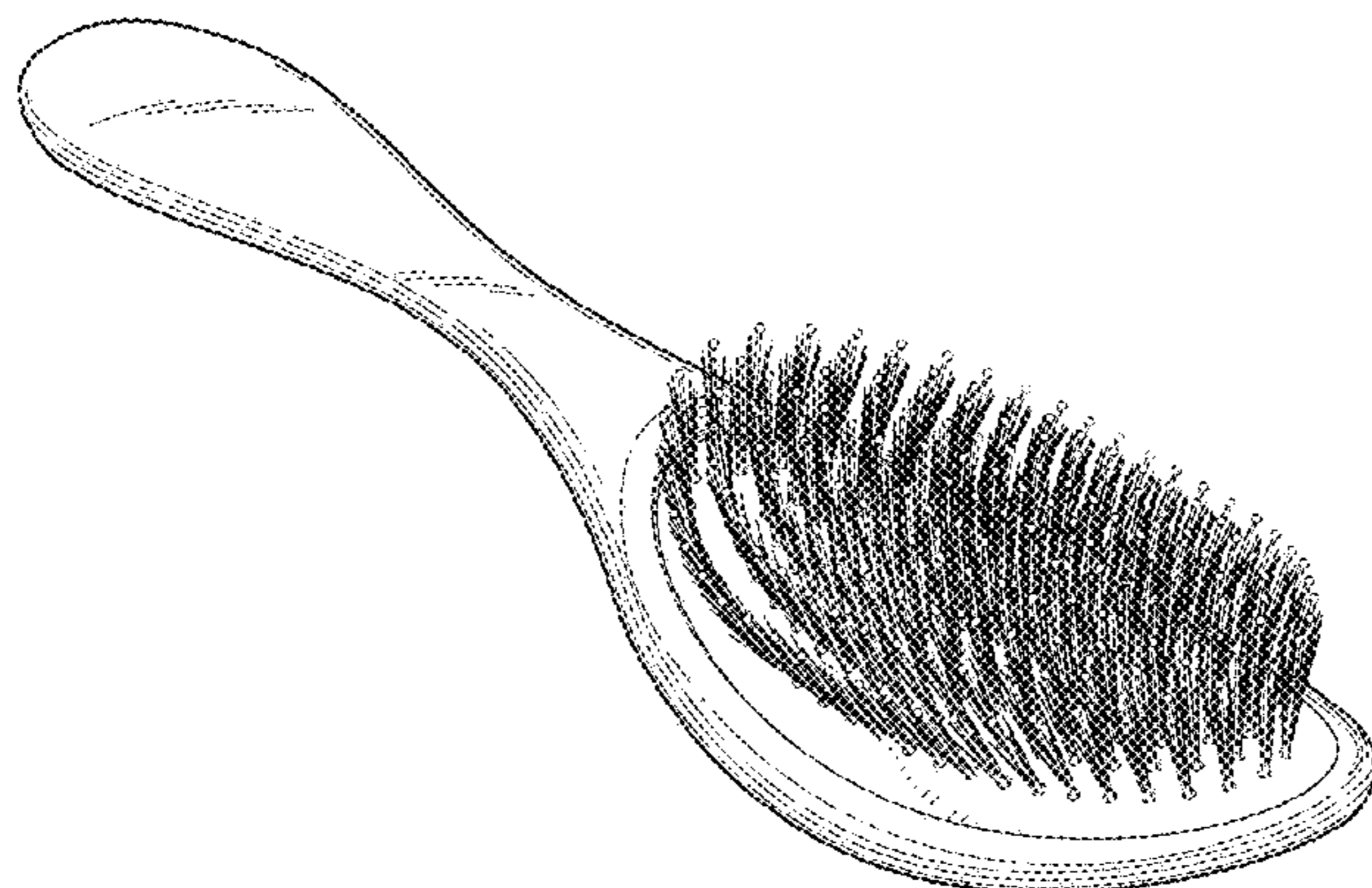
(57) **CLAIM**

The ornamental design for a contour brush, as shown.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a contour brush showing my new design.
 FIG. 2 is a bottom perspective view thereof.
 FIG. 3 is a top plan view thereof.
 FIG. 4 is a right side elevation view thereof. The left side elevation view is the mirror image of the right side elevation view.

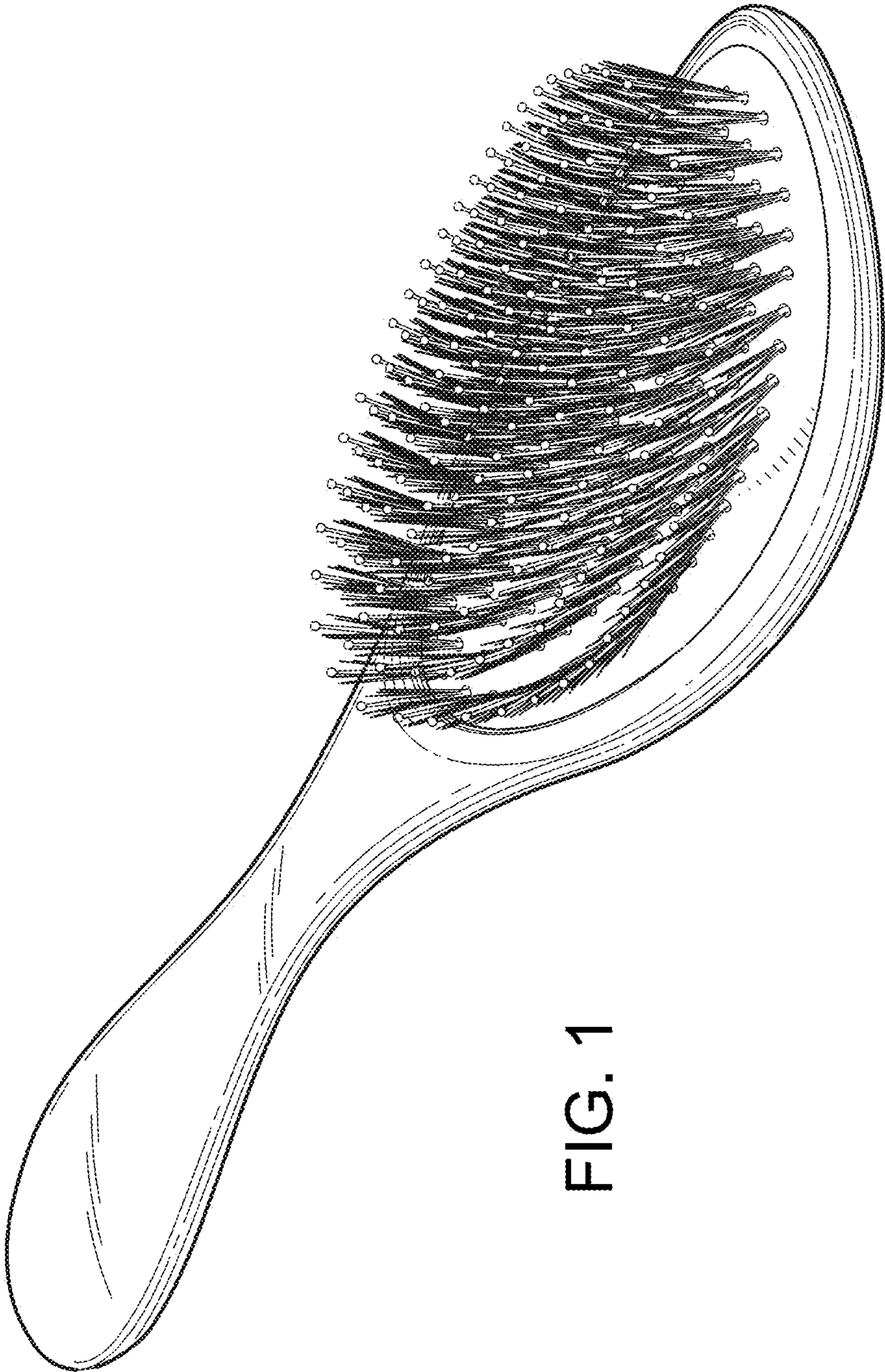

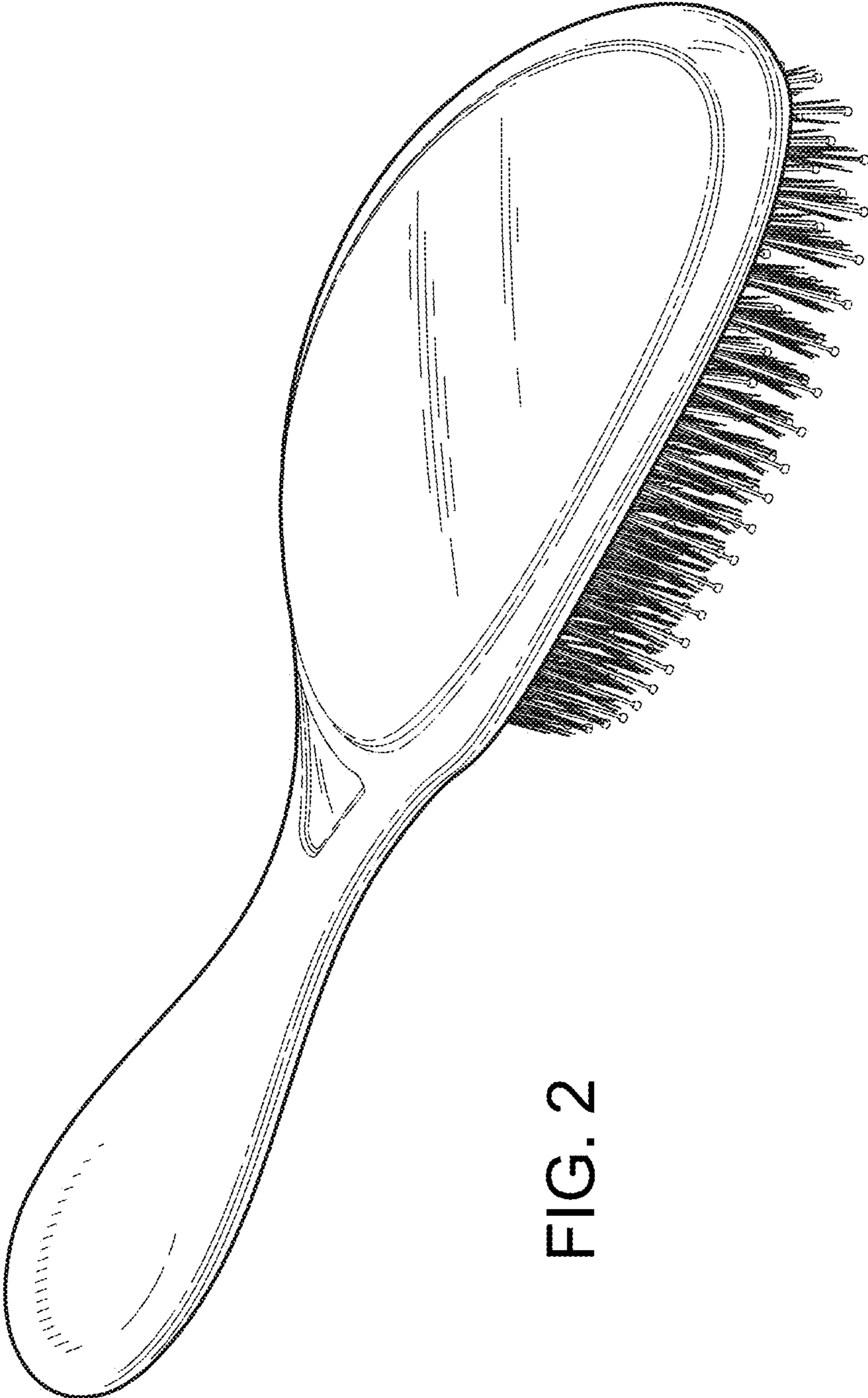

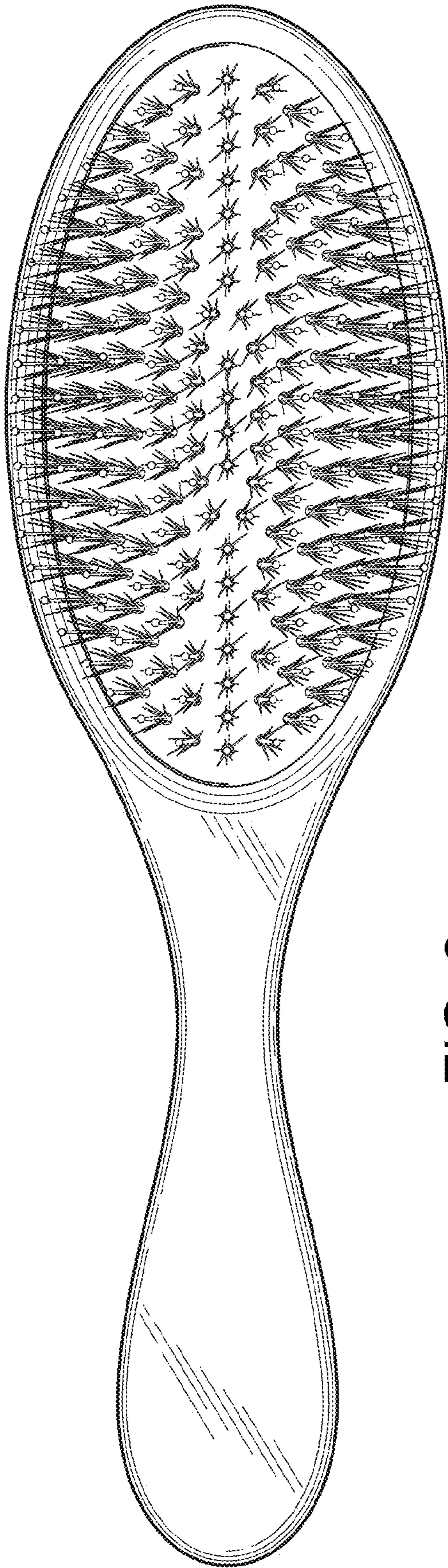

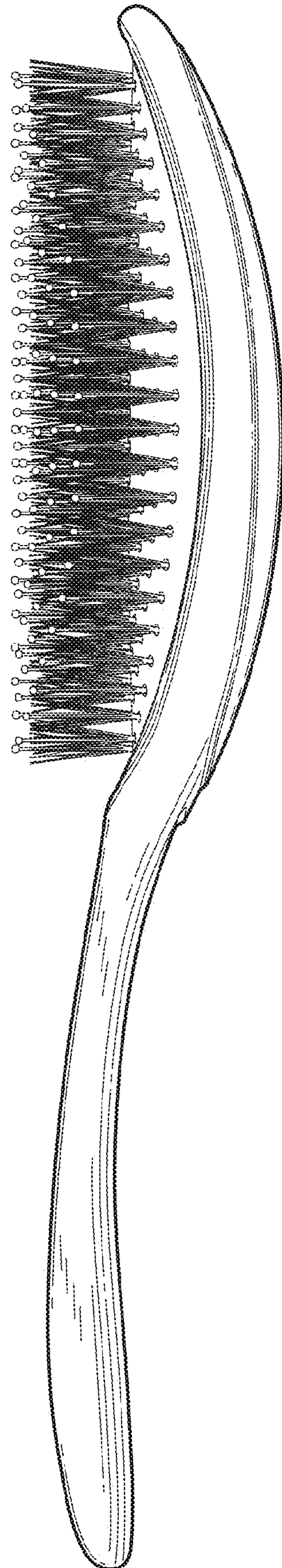

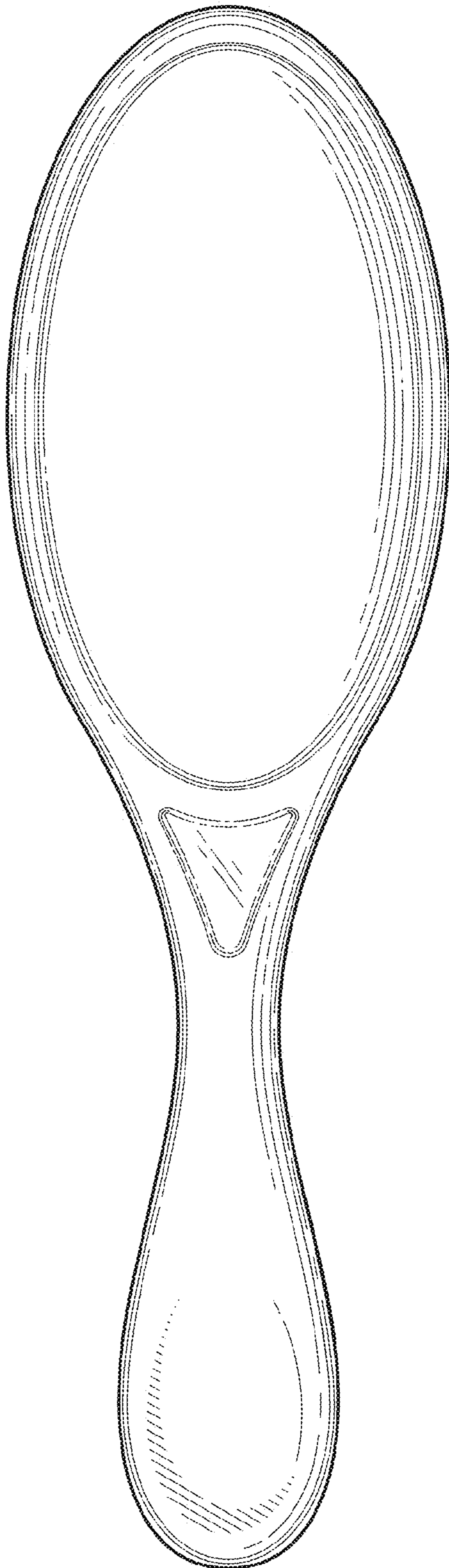

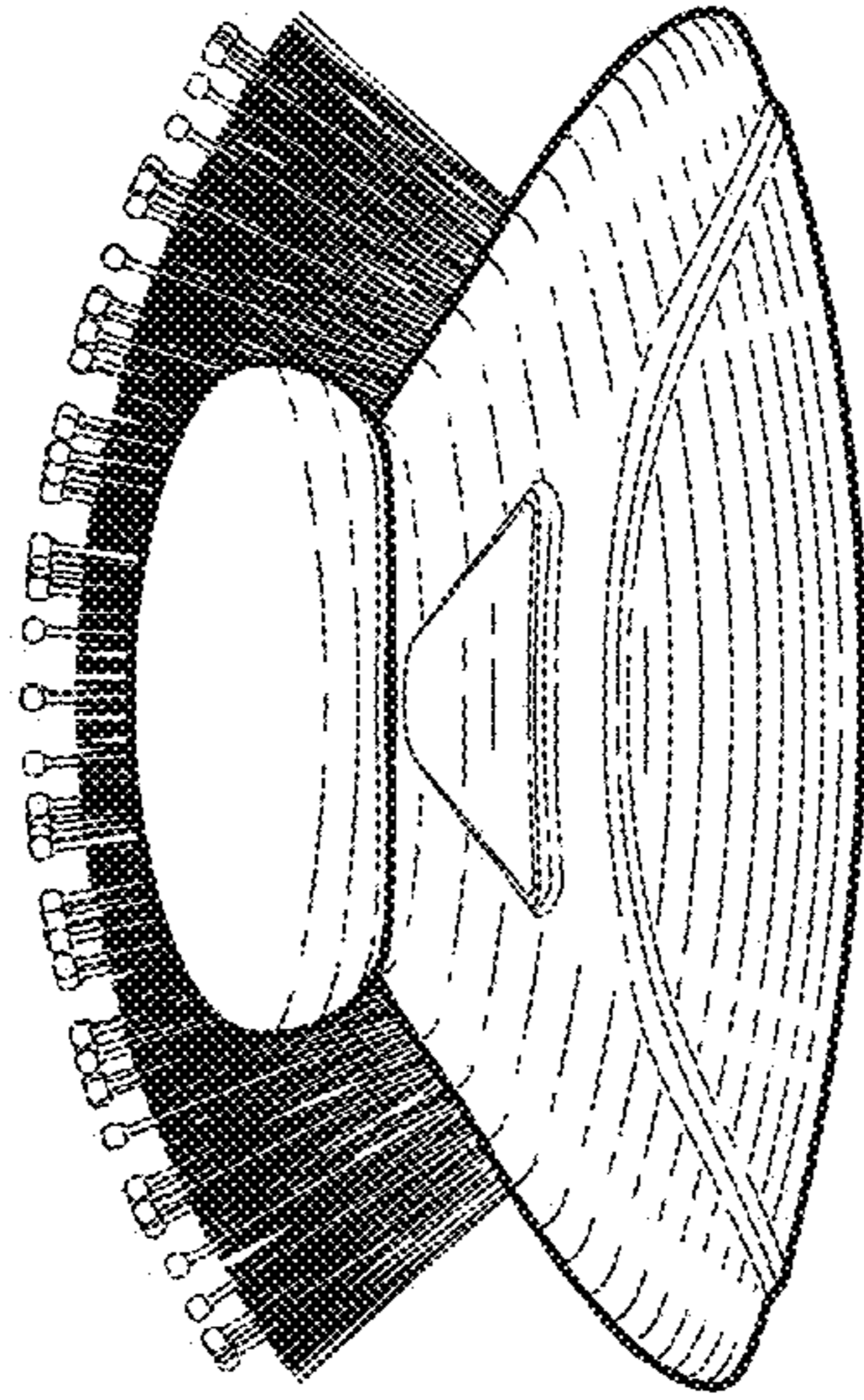

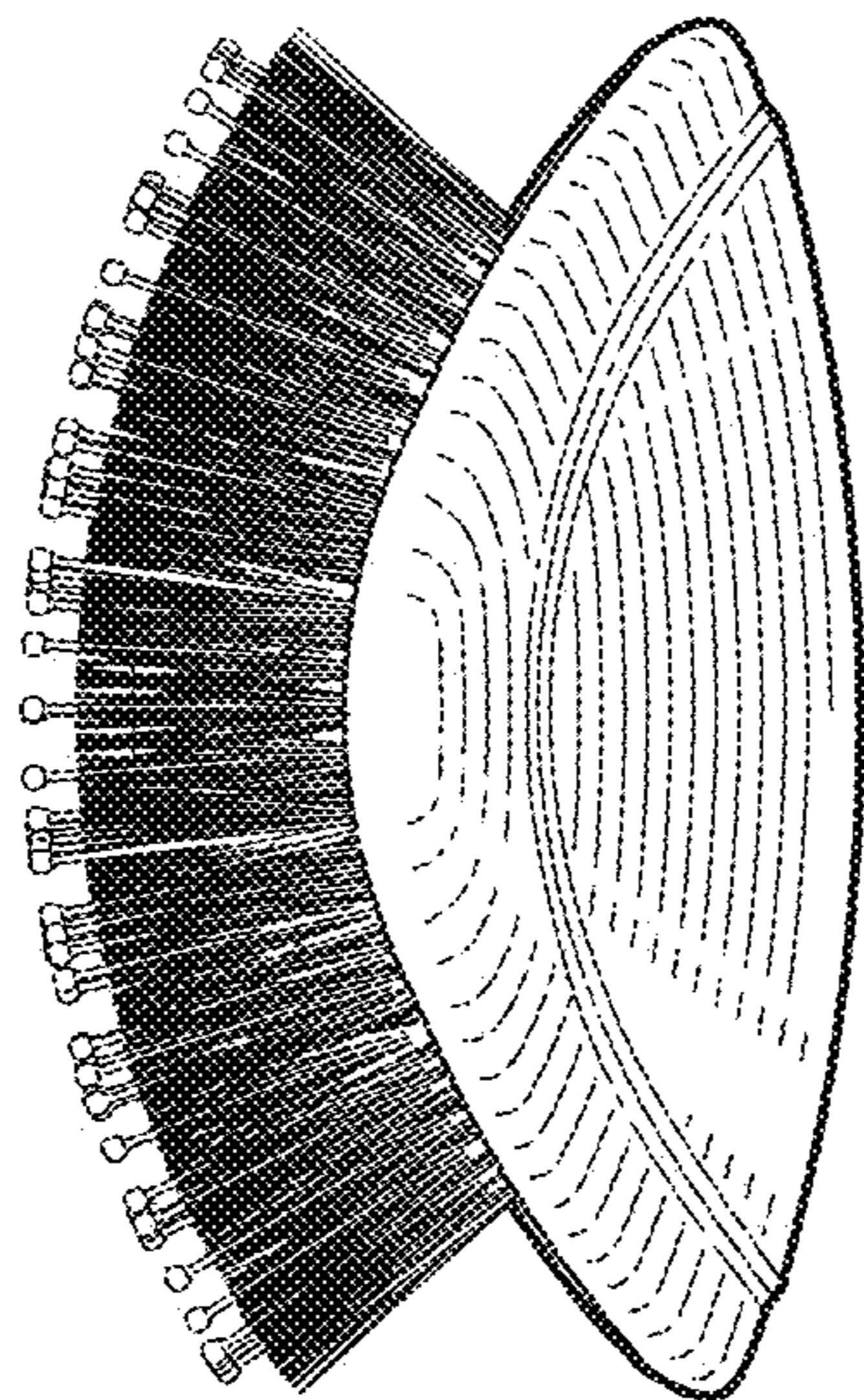

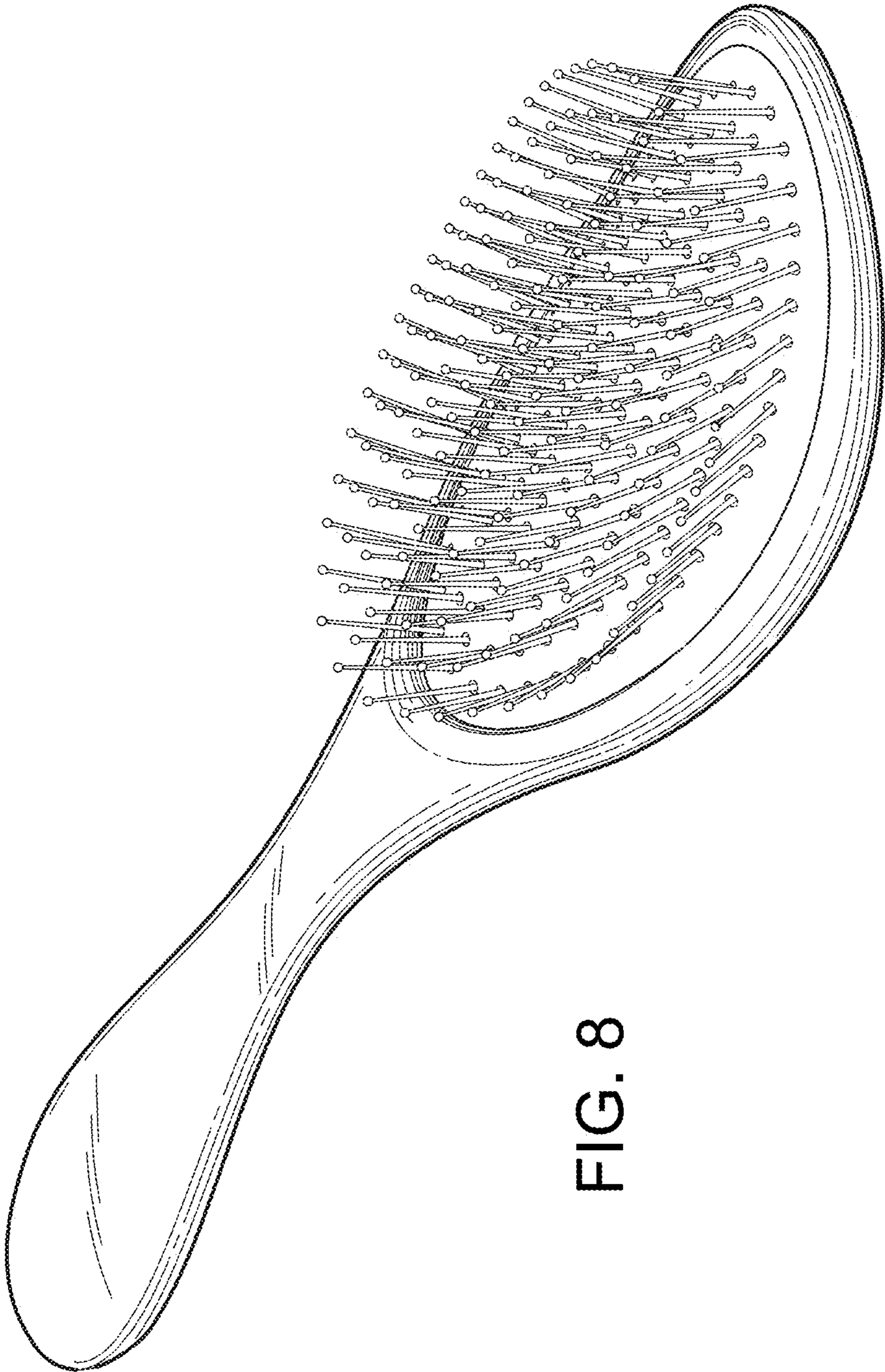

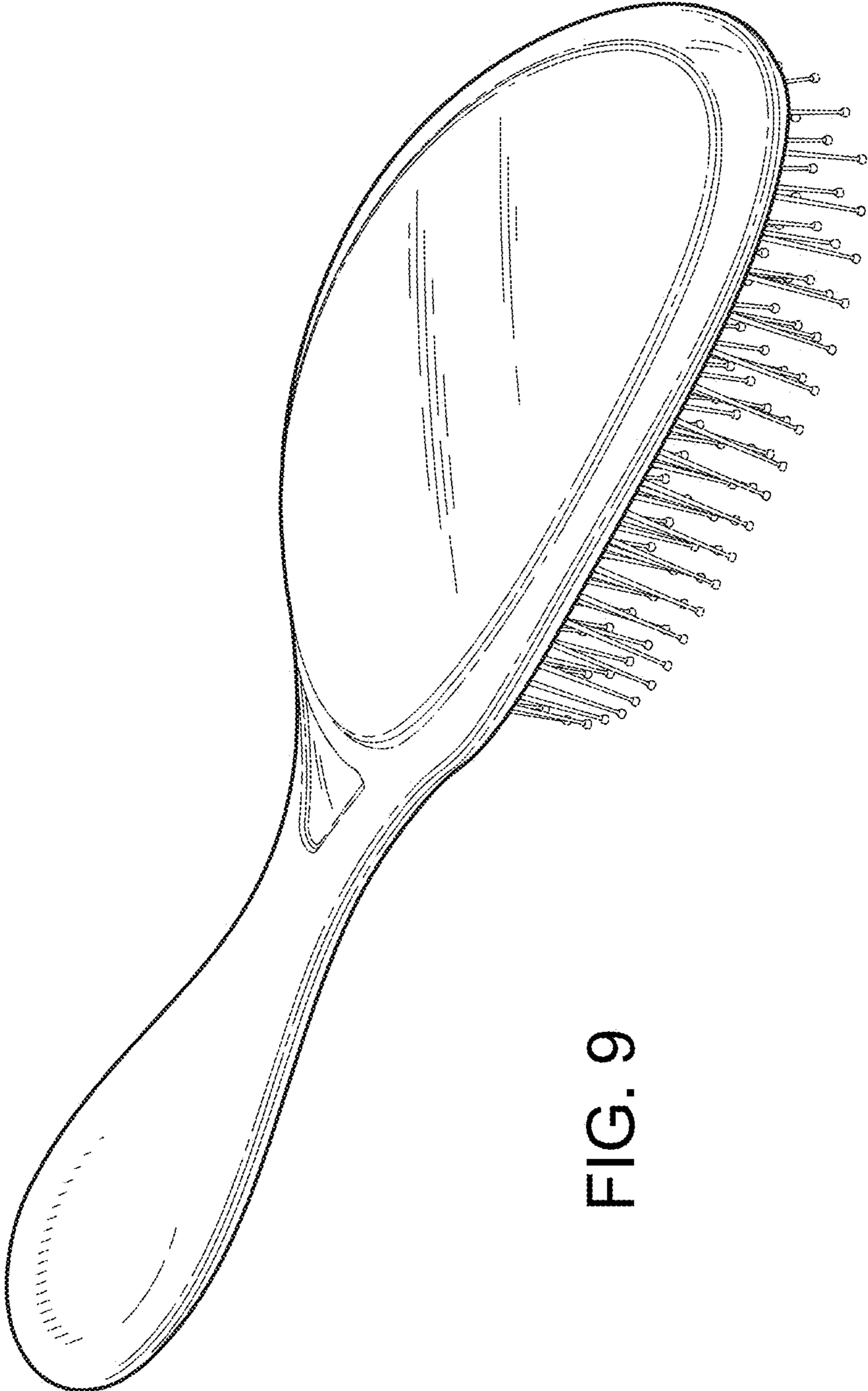

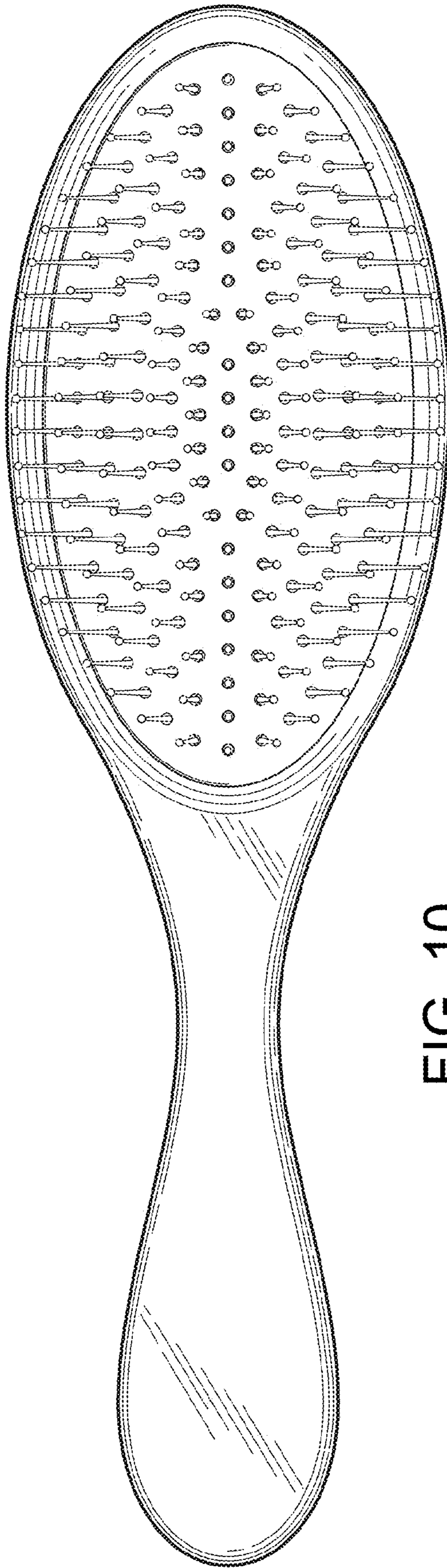

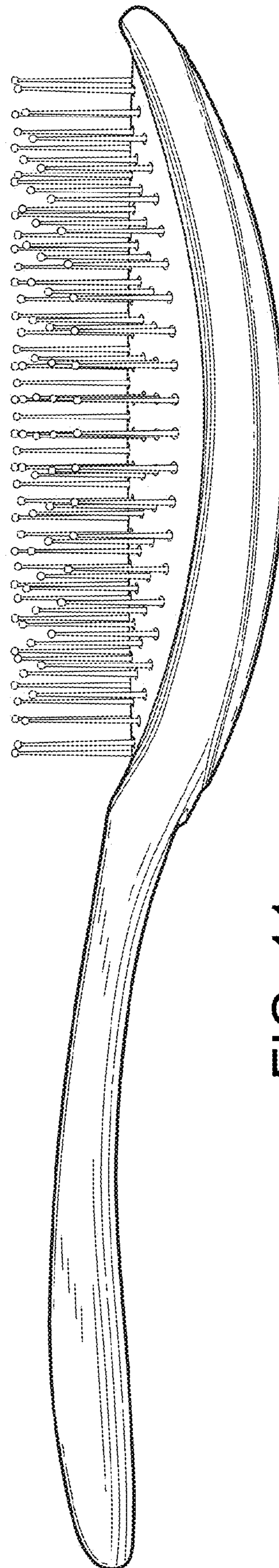

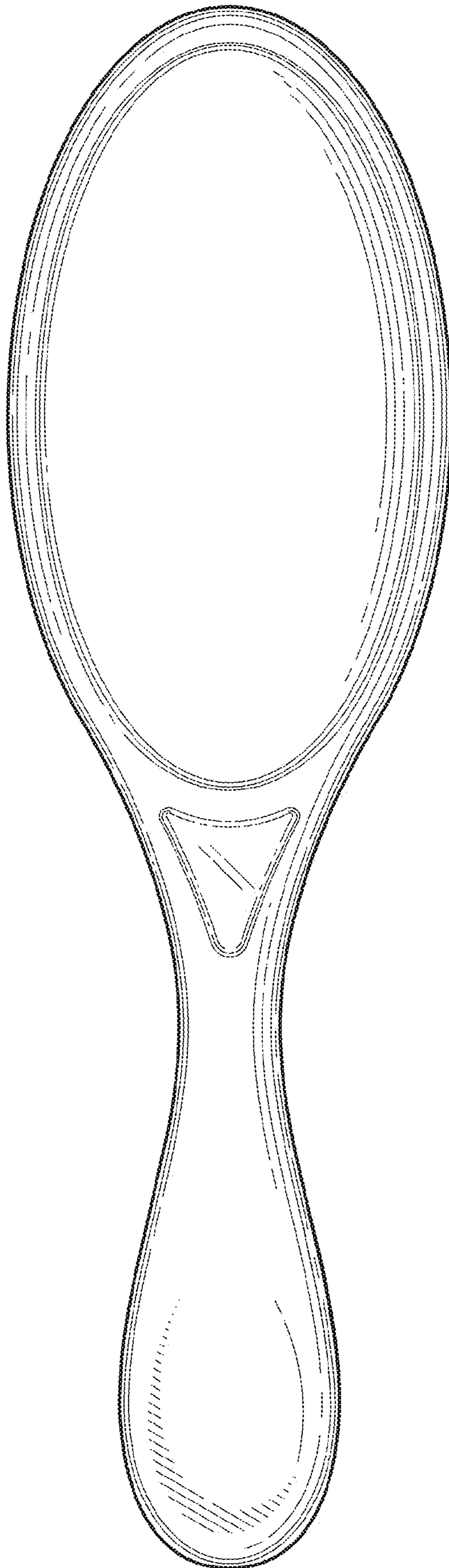

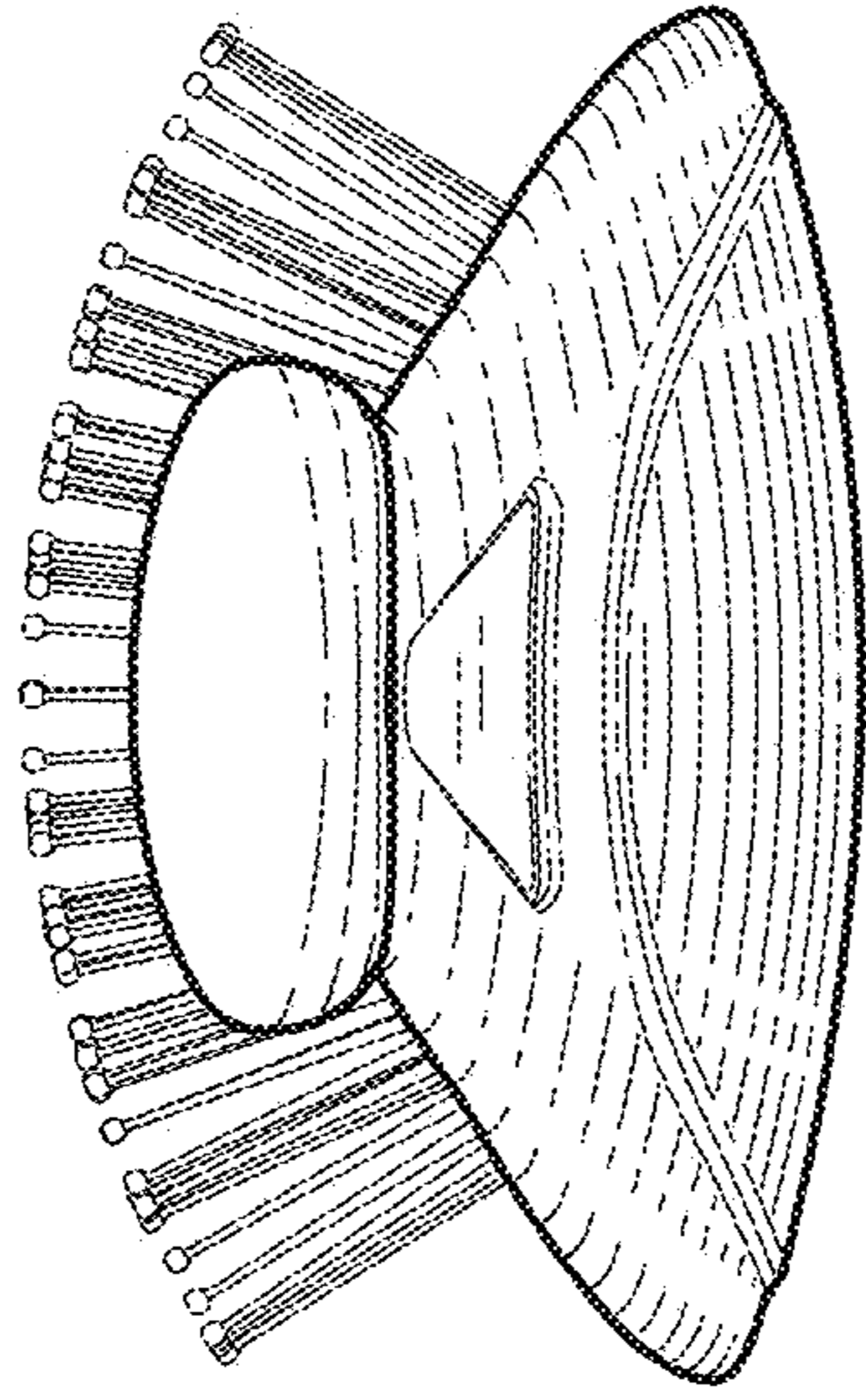

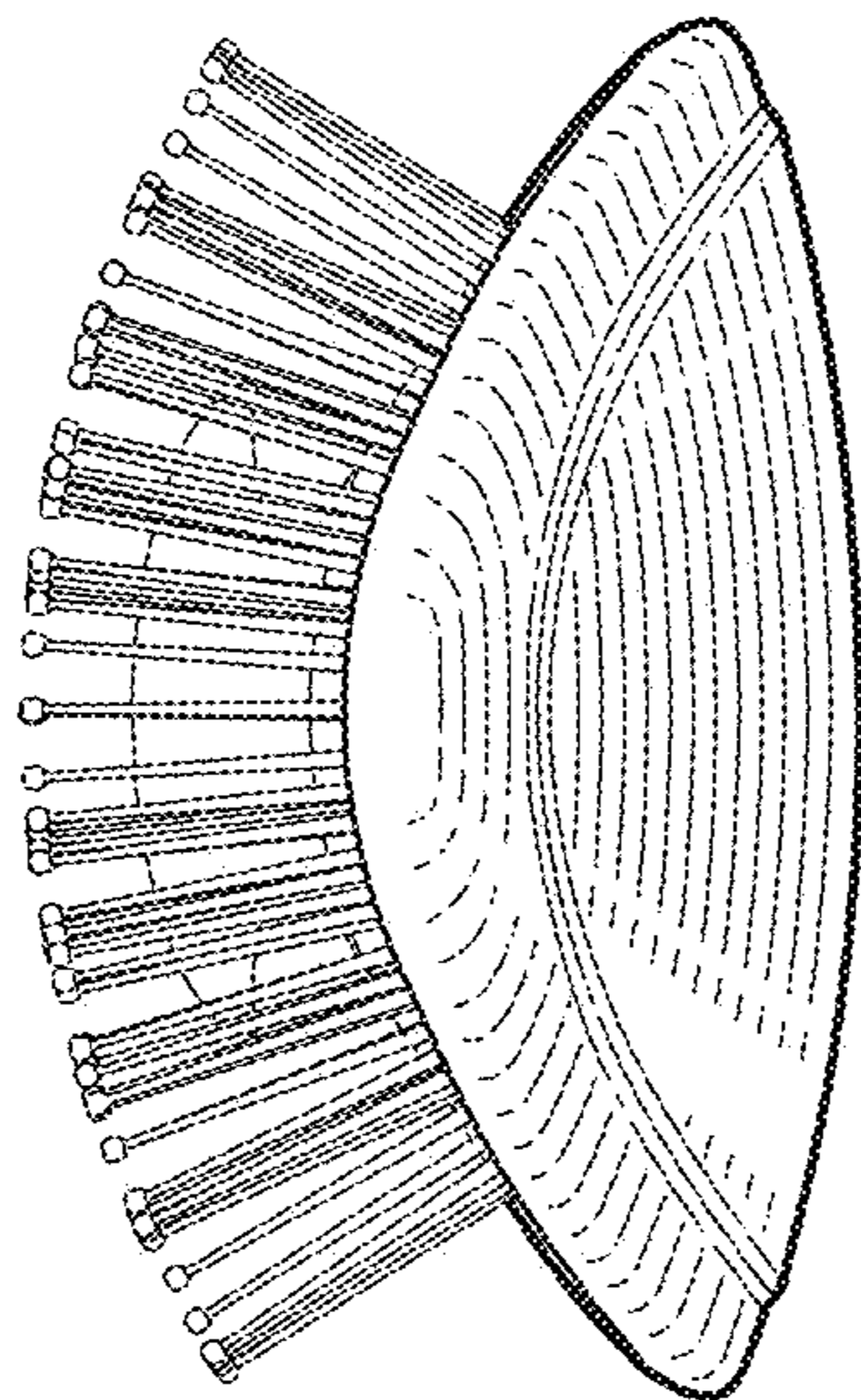
