(57) **CLAIM**

The ornamental design for a chaise, as shown and described.

**DESCRIPTION**

FIG. 1 is a right perspective view of a chaise showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a right side elevation view thereof, the left side elevation view being a mirror image;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof; and,

FIG. 6 is a right side elevation view thereof showing the chaise in a reclined position.

The broken lines represent portions of the chaise that form no part of the claimed design.

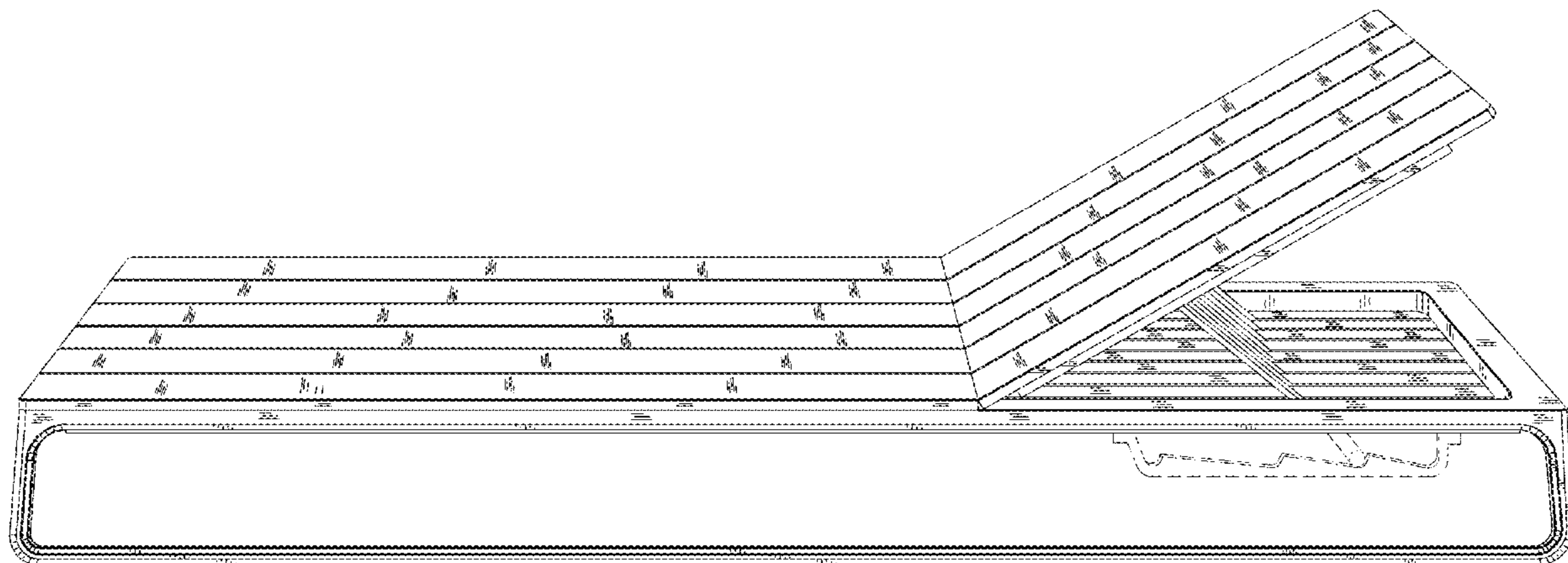

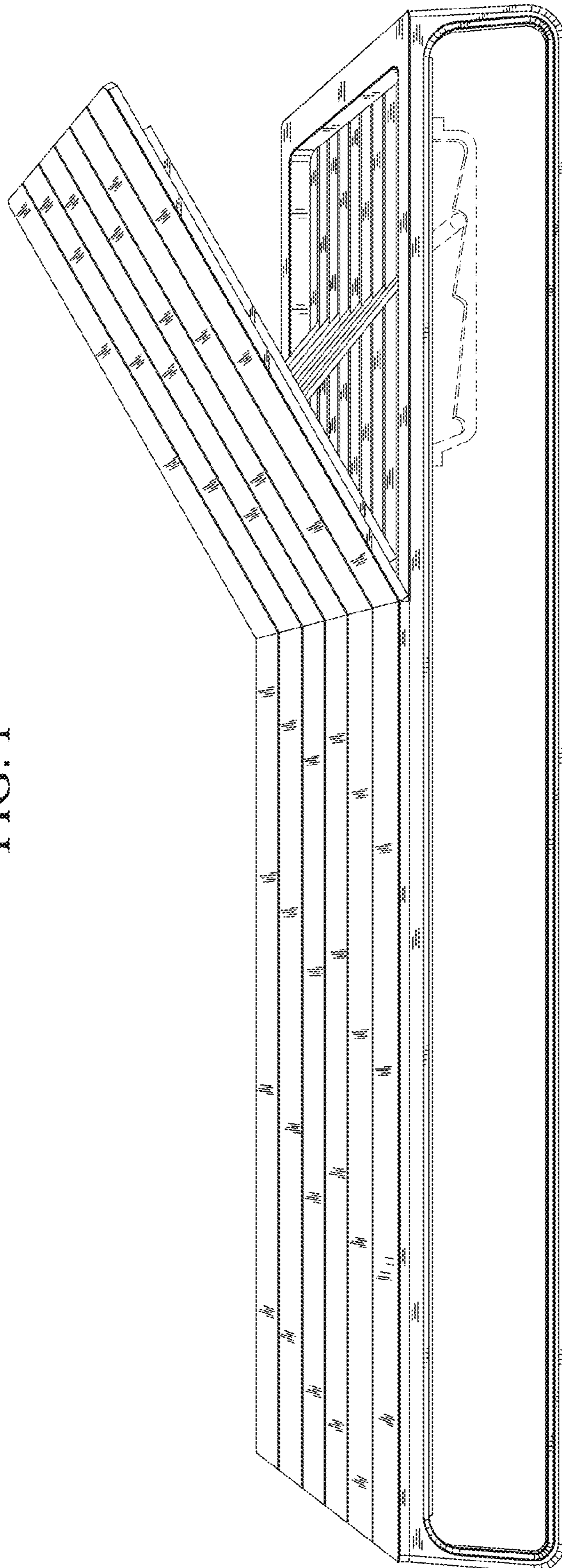

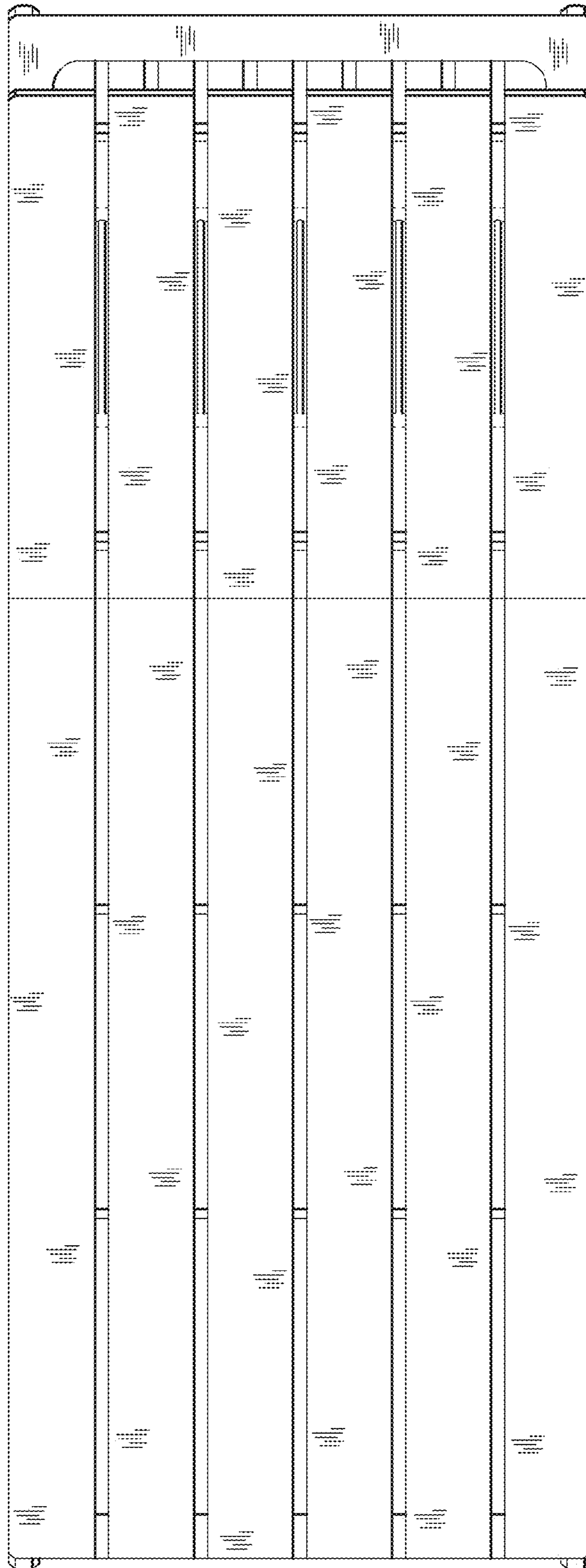

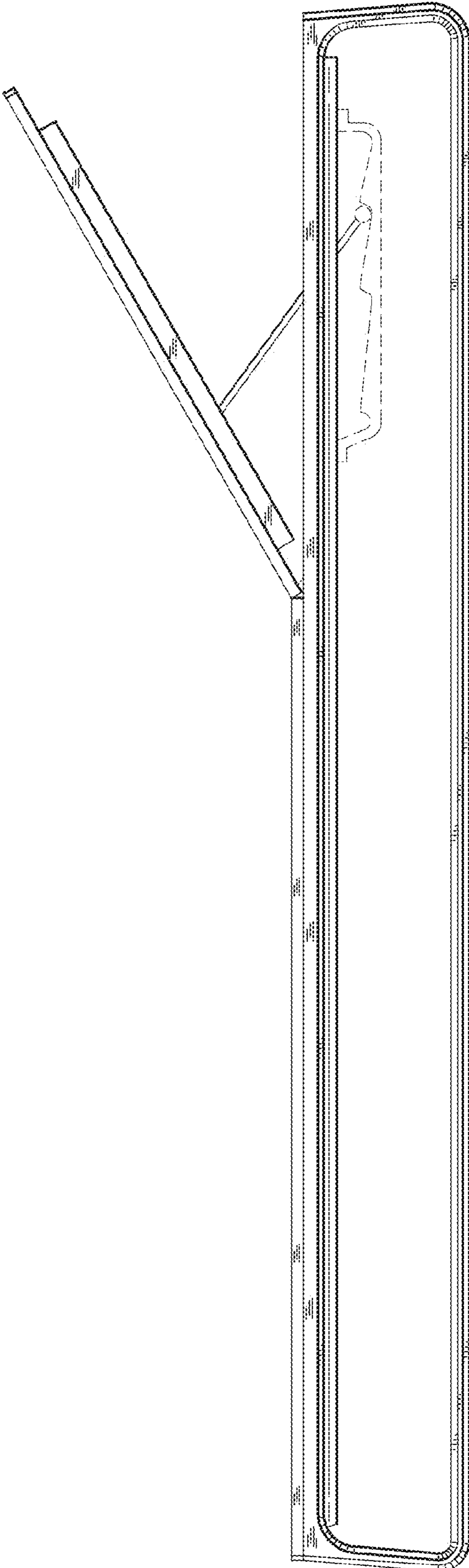

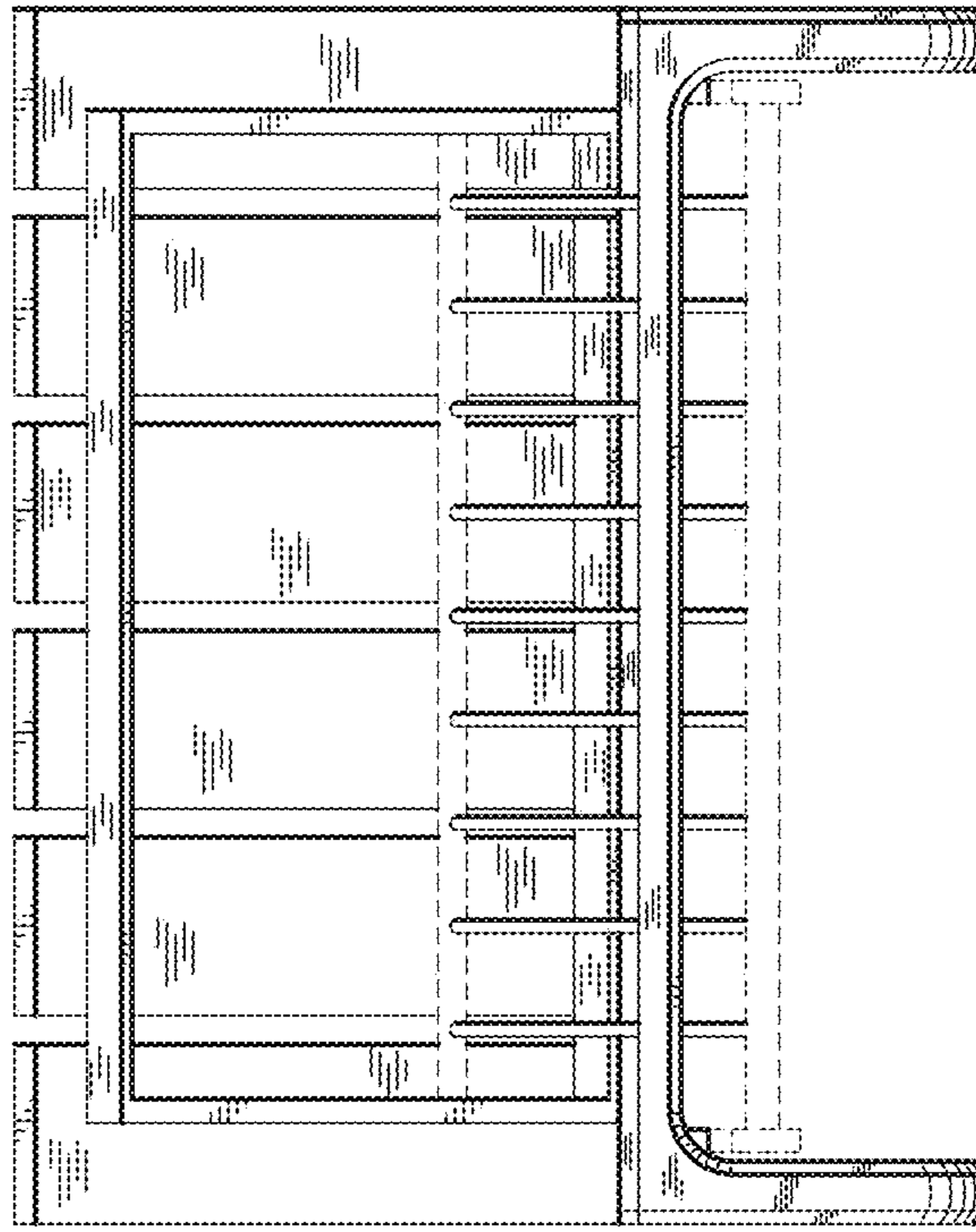

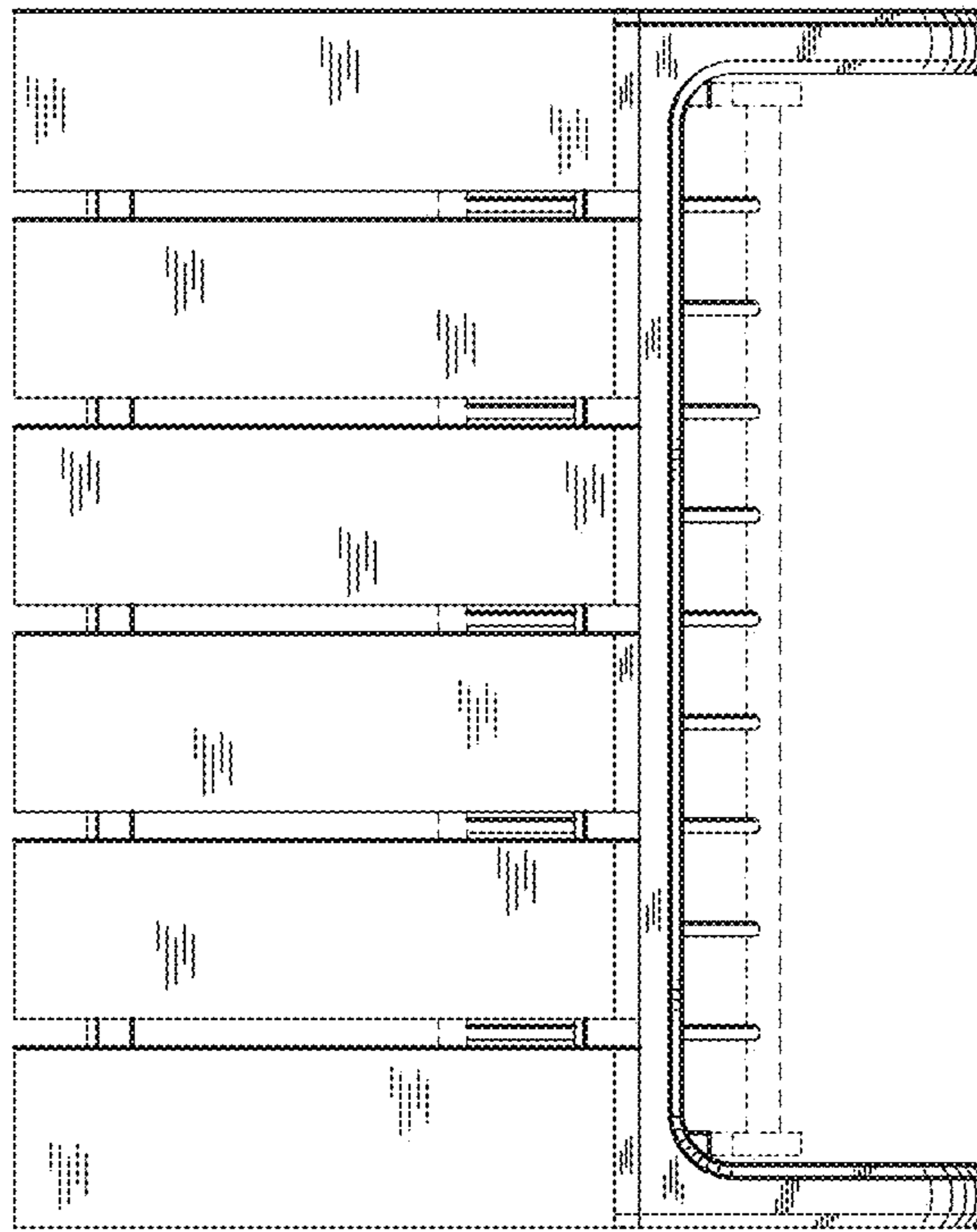
