FIG. 2 is an exploded perspective view thereof viewed from in front of, above, and the left side;

FIG. 3 is an exploded perspective view of thereof viewed from in front of, above, and the right side;

FIG. 4 is a left side elevation view thereof,

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a rear elevation view thereof;

FIG. 8 is a top plan view thereof; and,

FIG. 9 is a bottom plan view thereof.

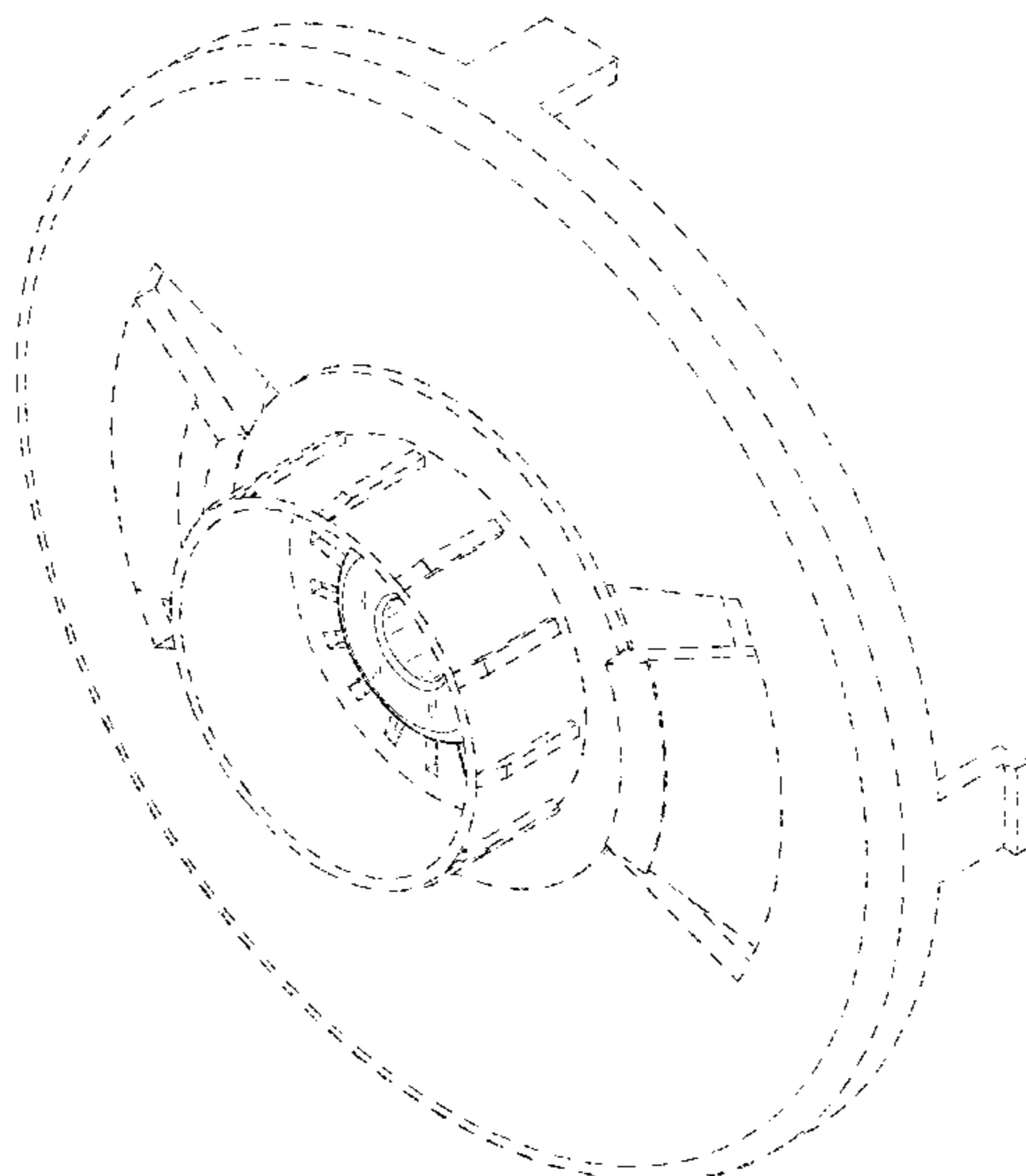

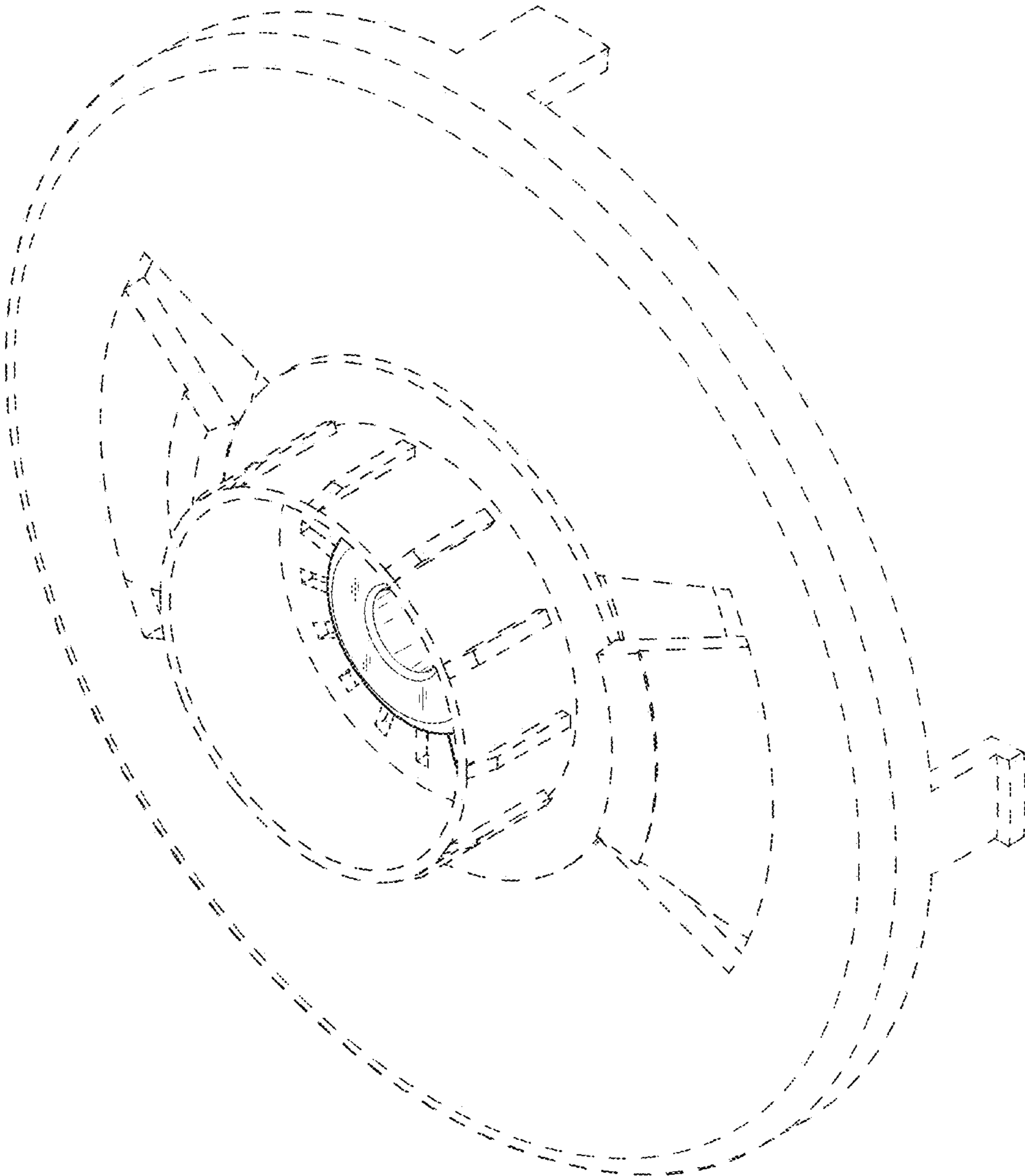

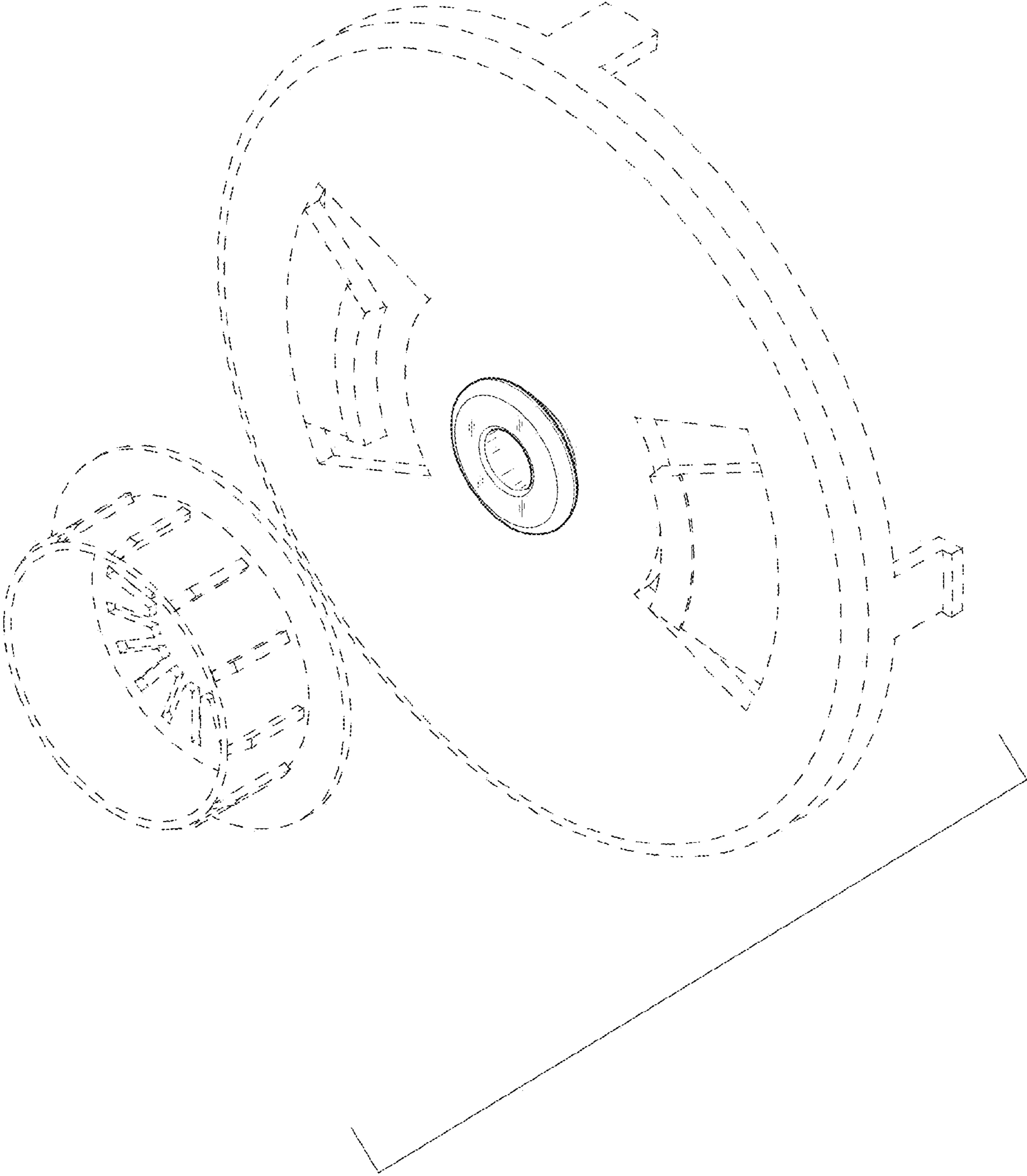

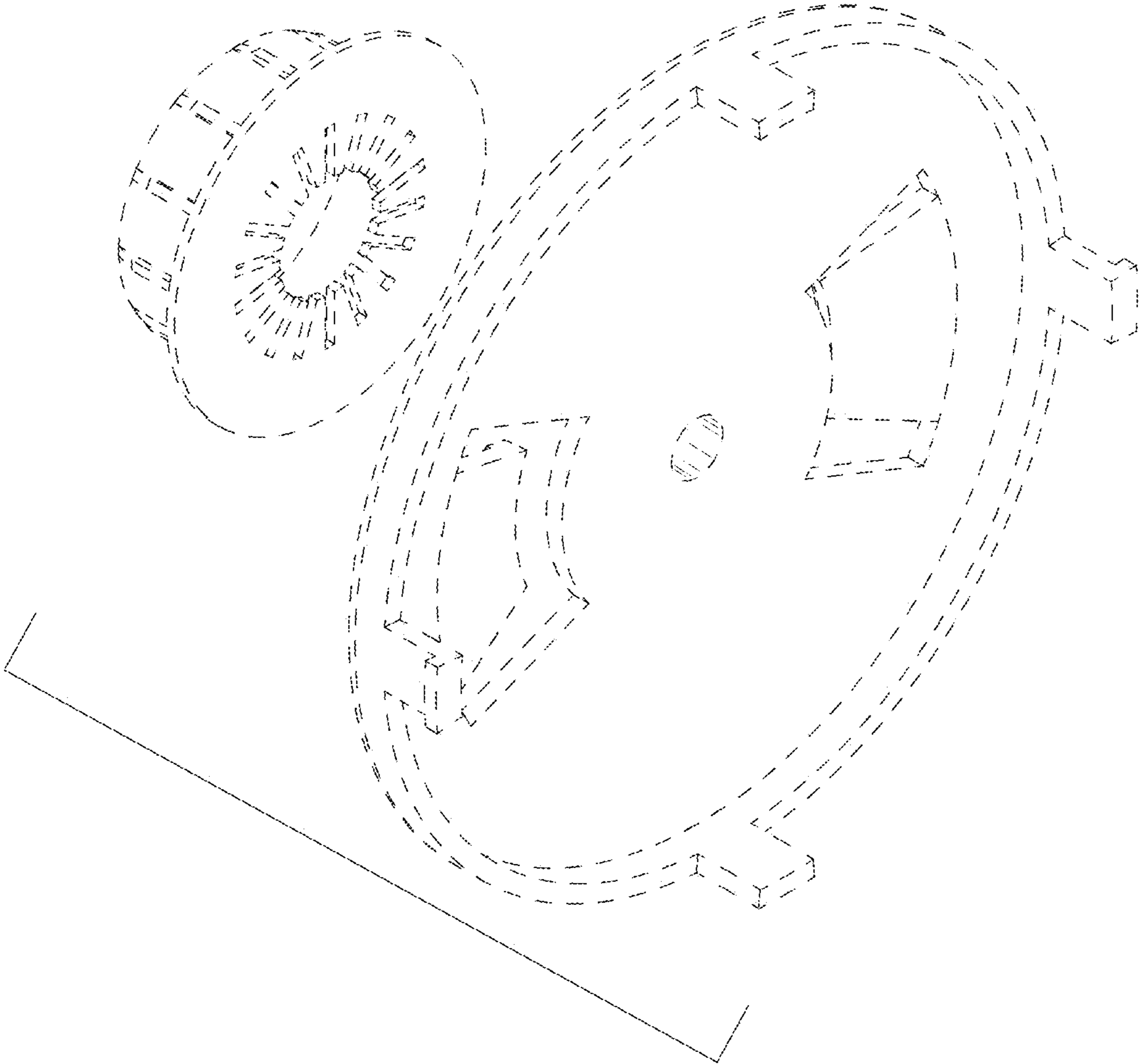

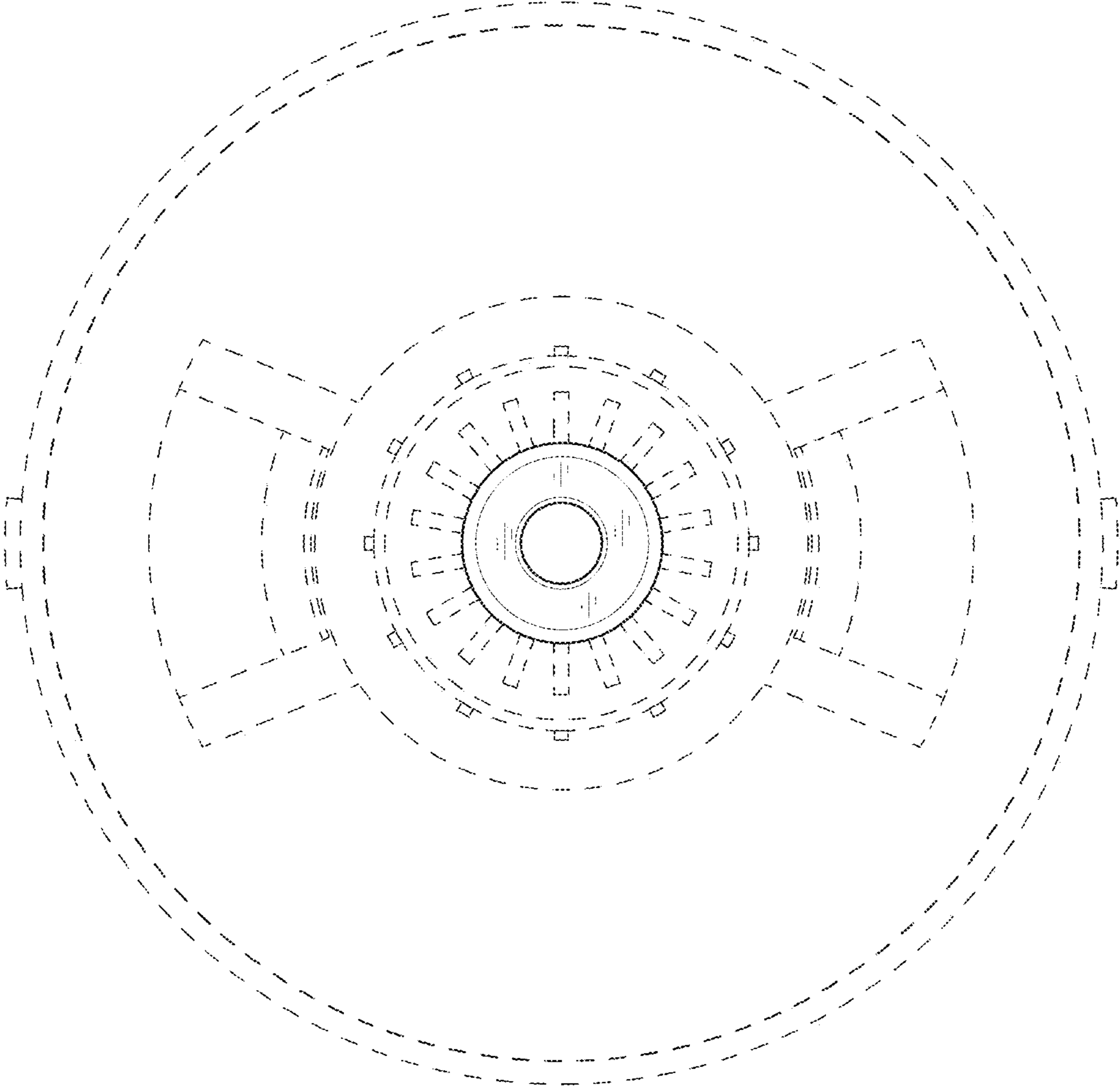

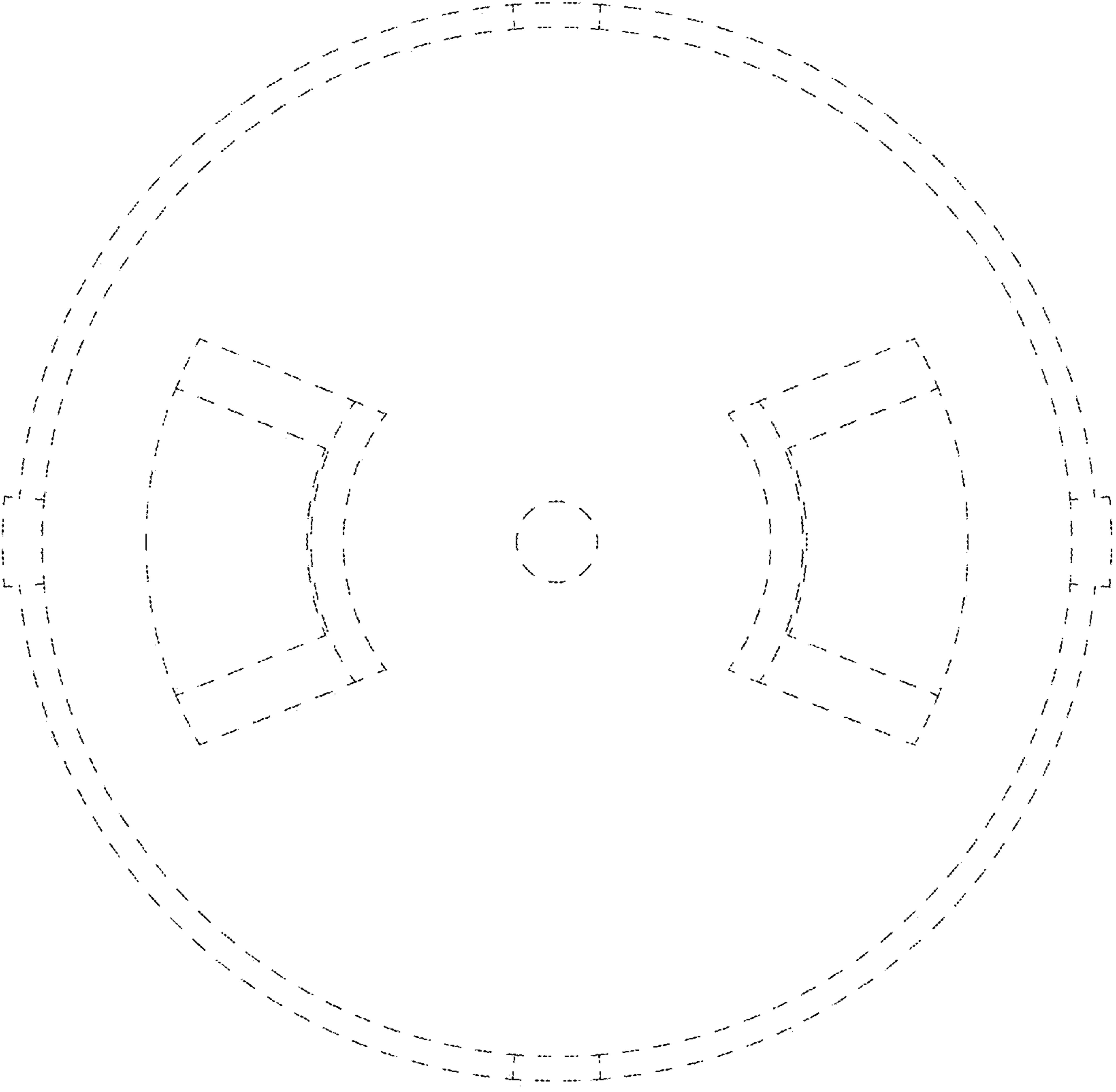

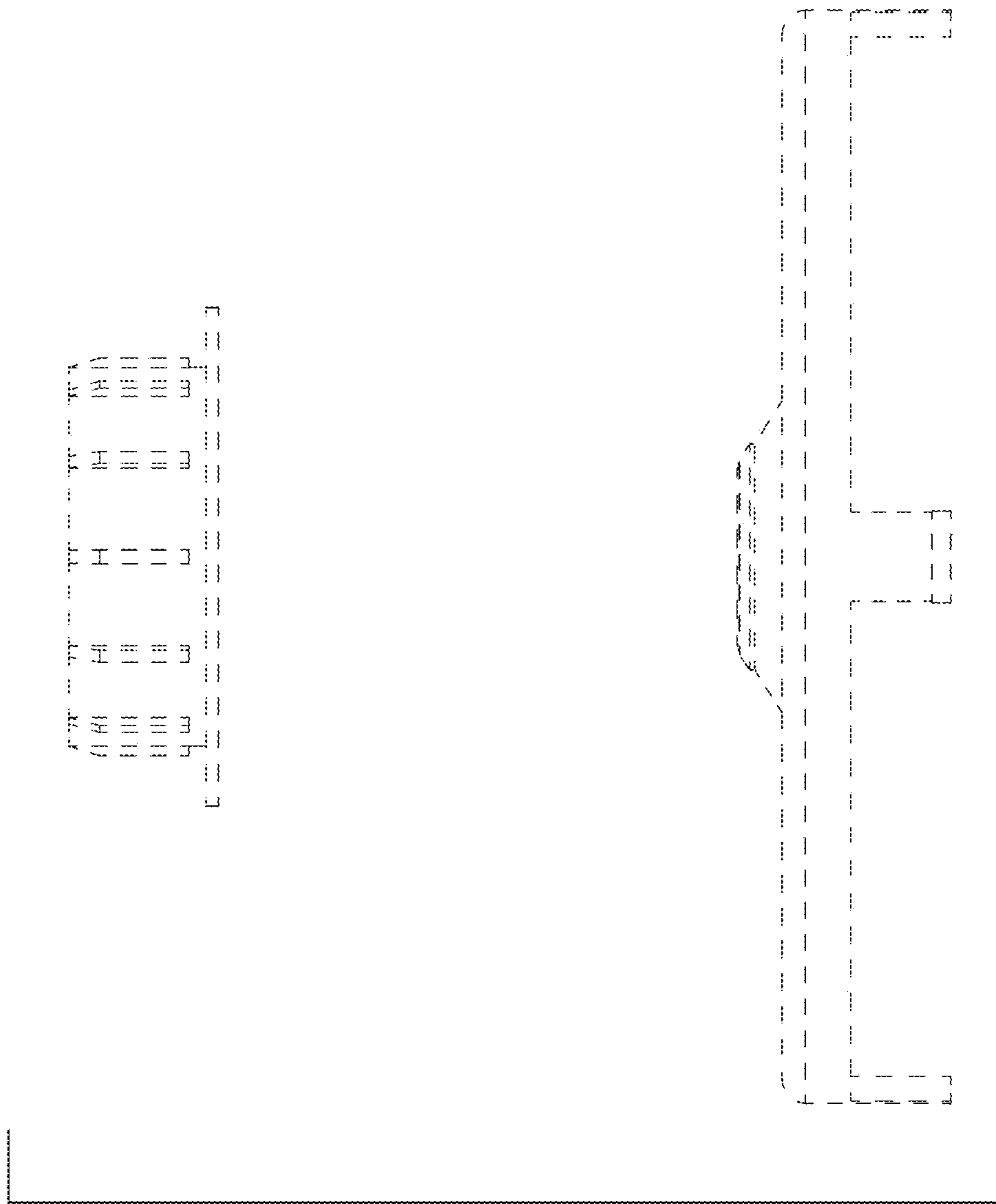

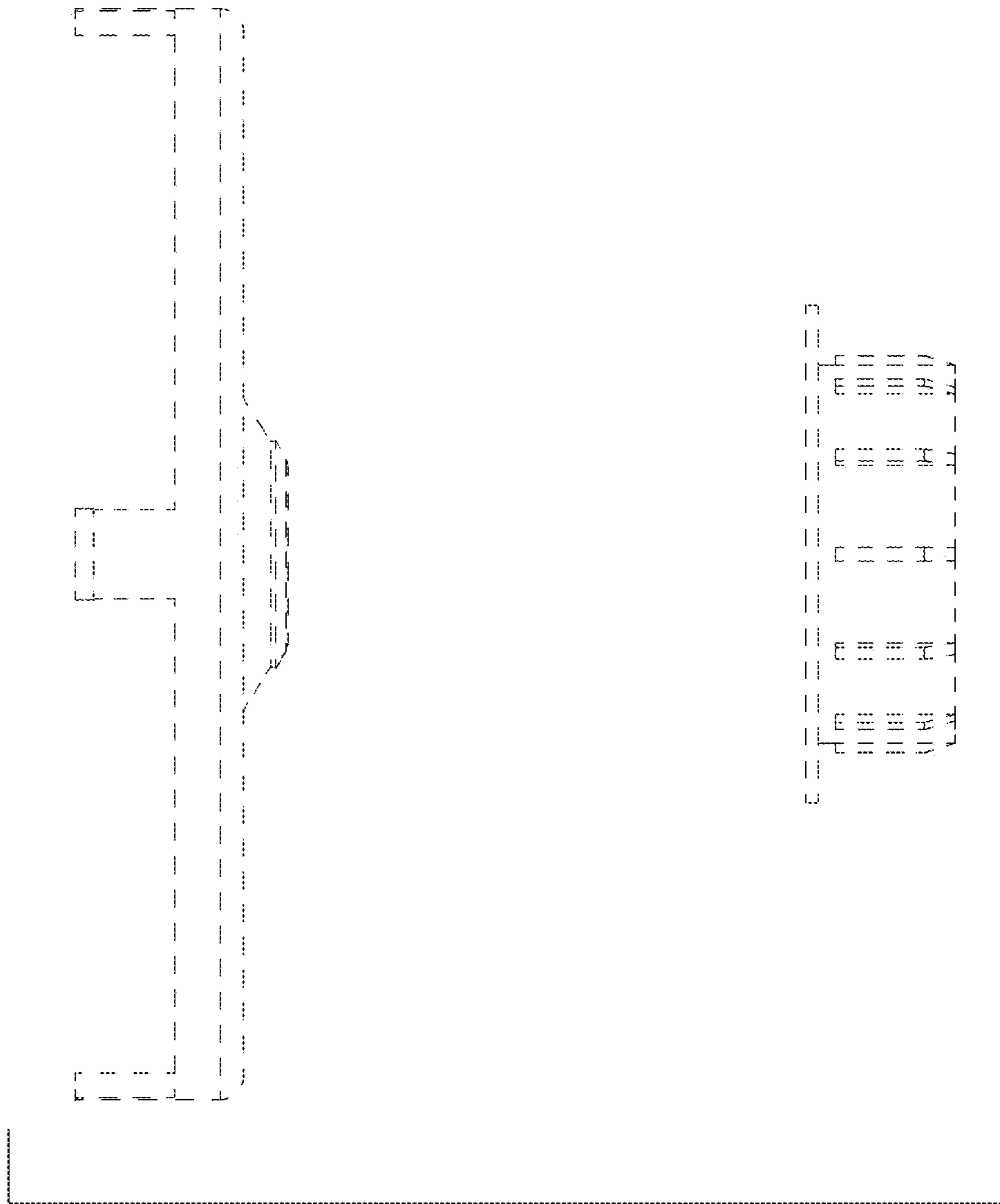

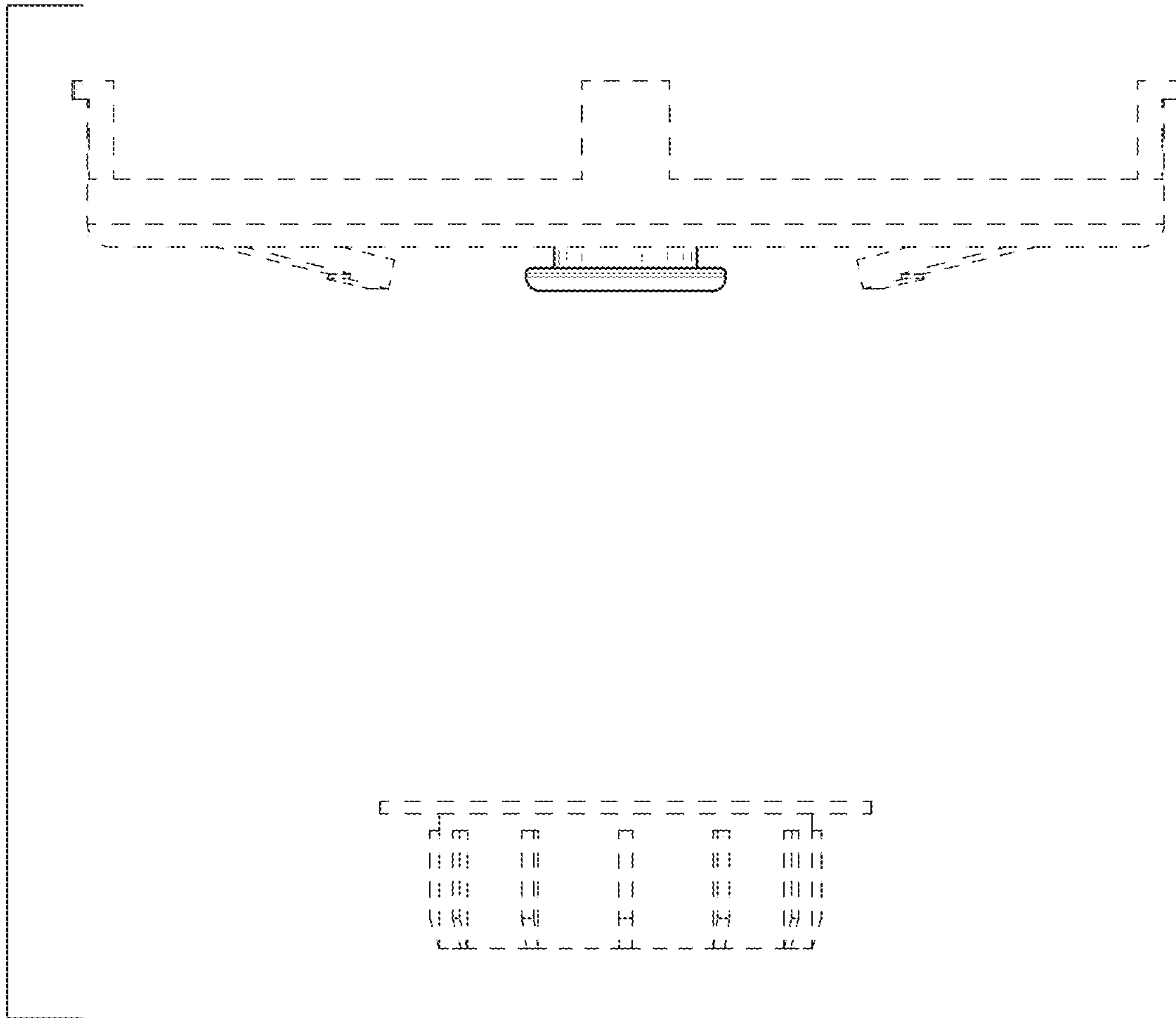

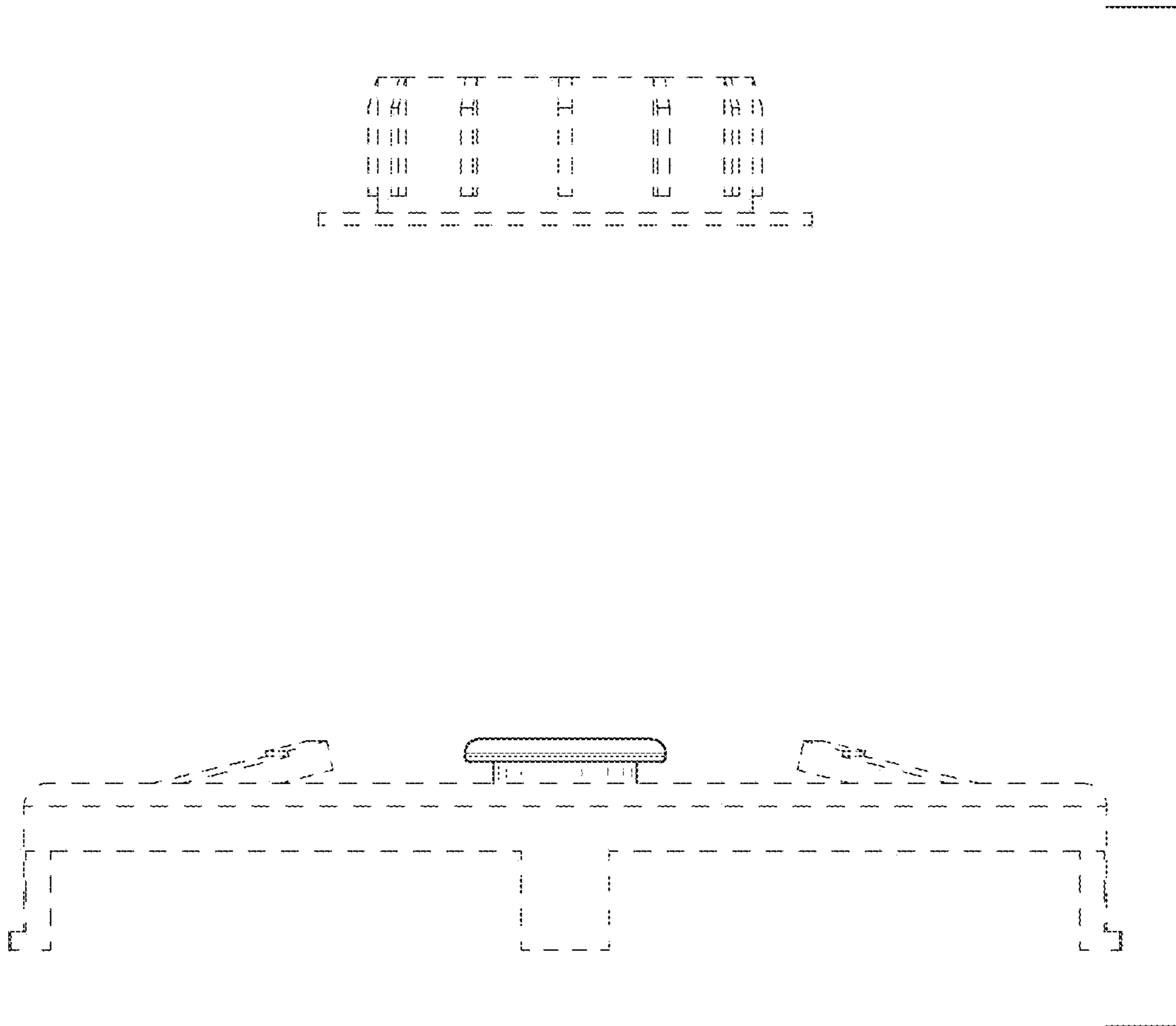
