The ornamental design for a food container, as shown.

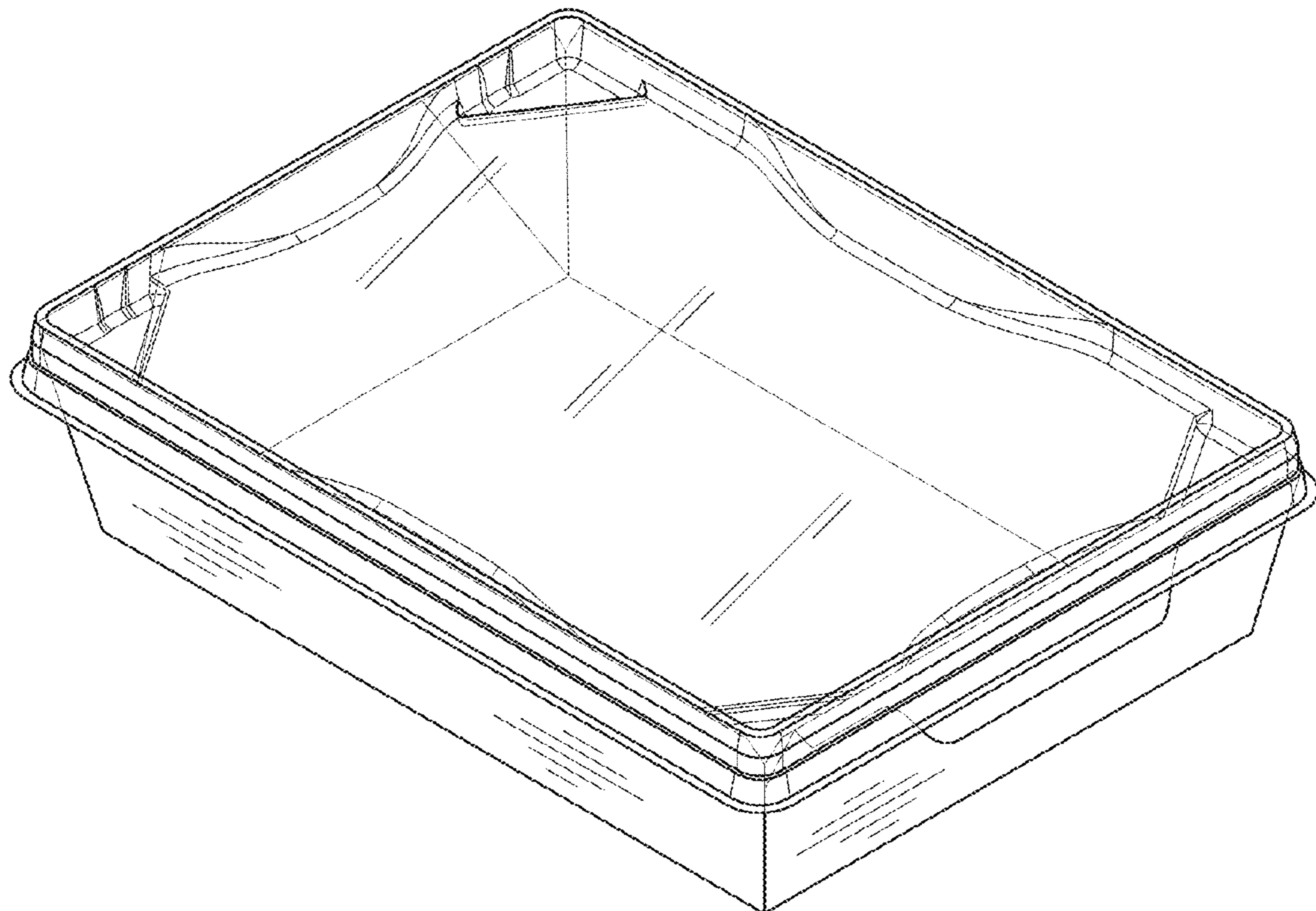
DESCRIPTION

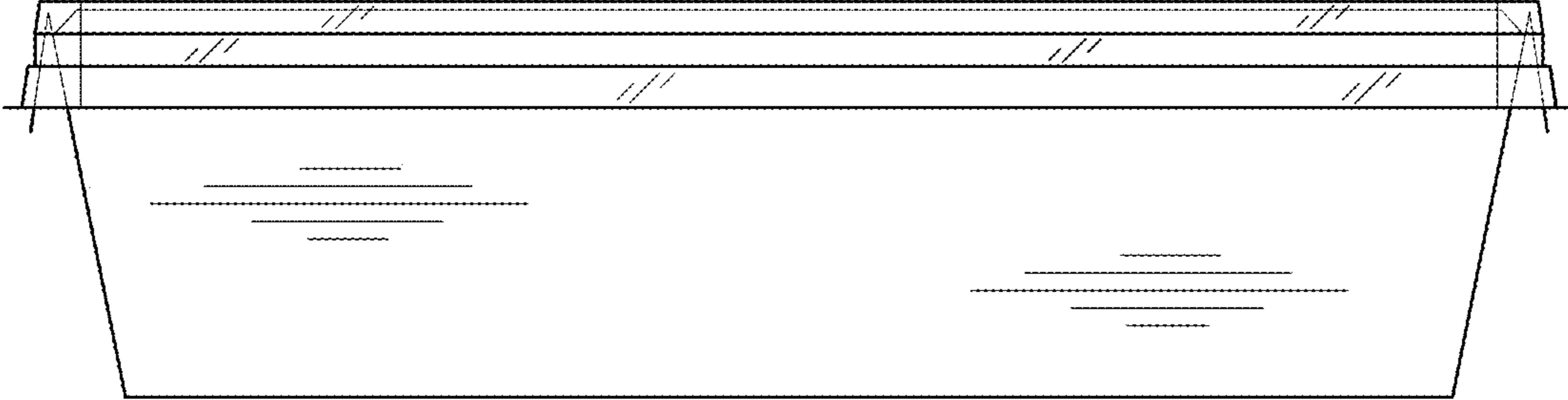

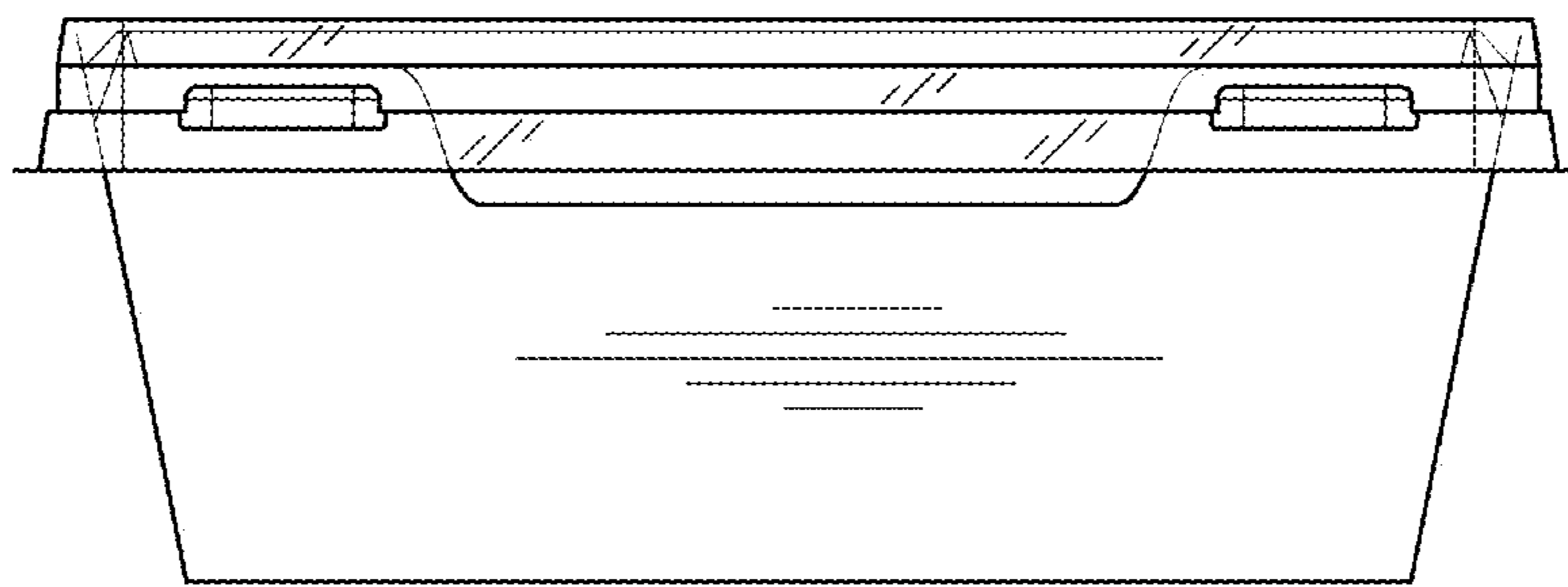

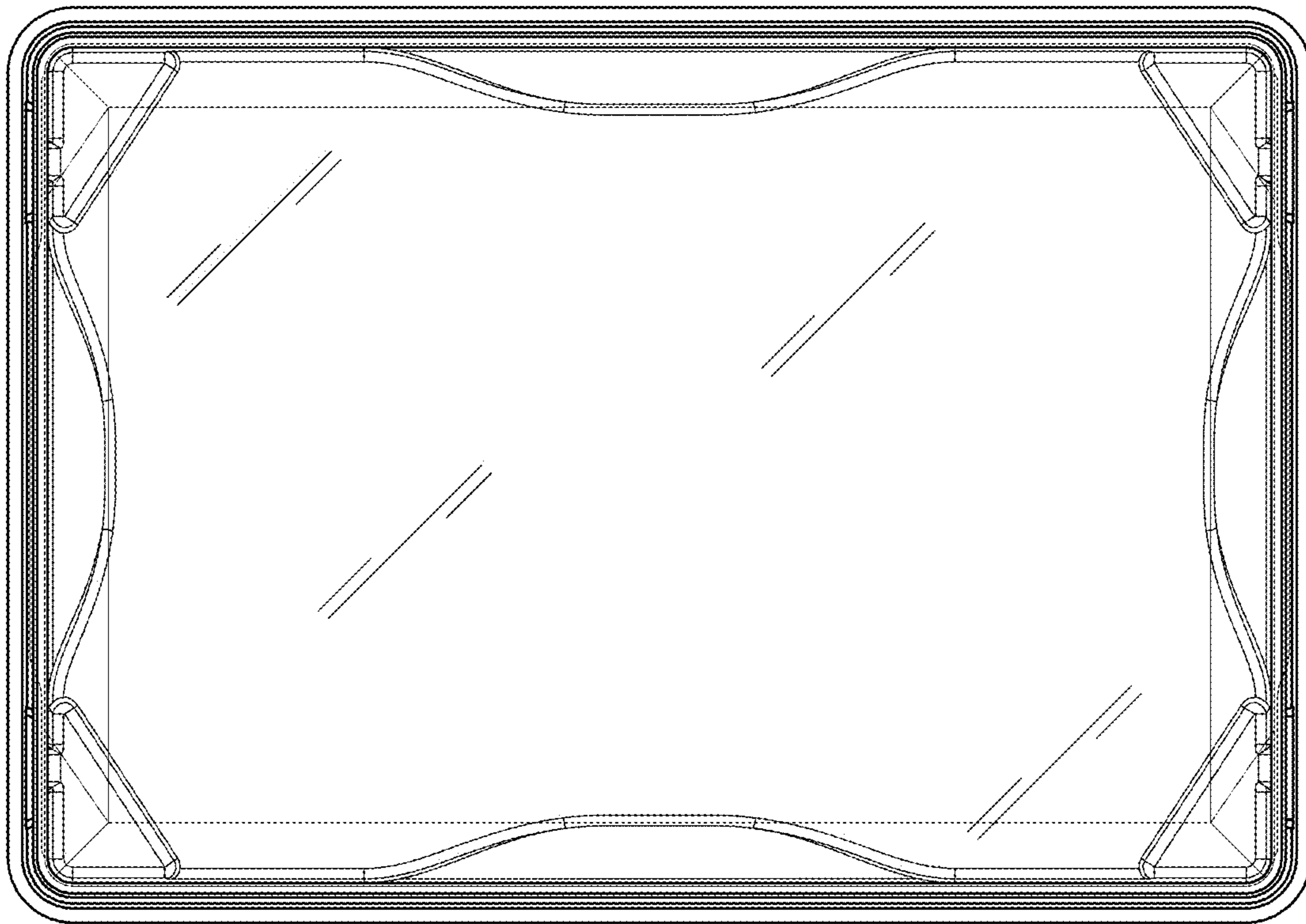

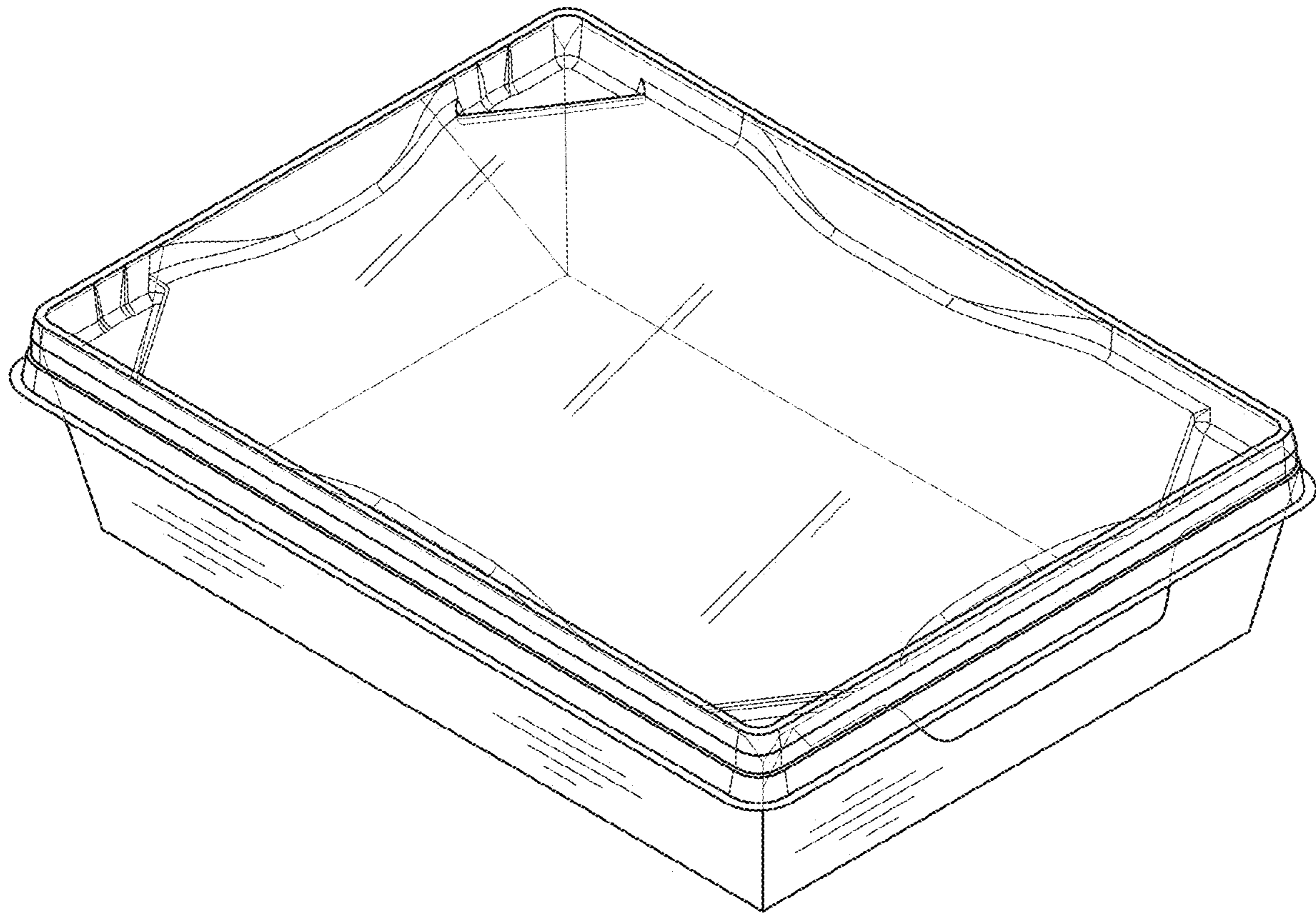
