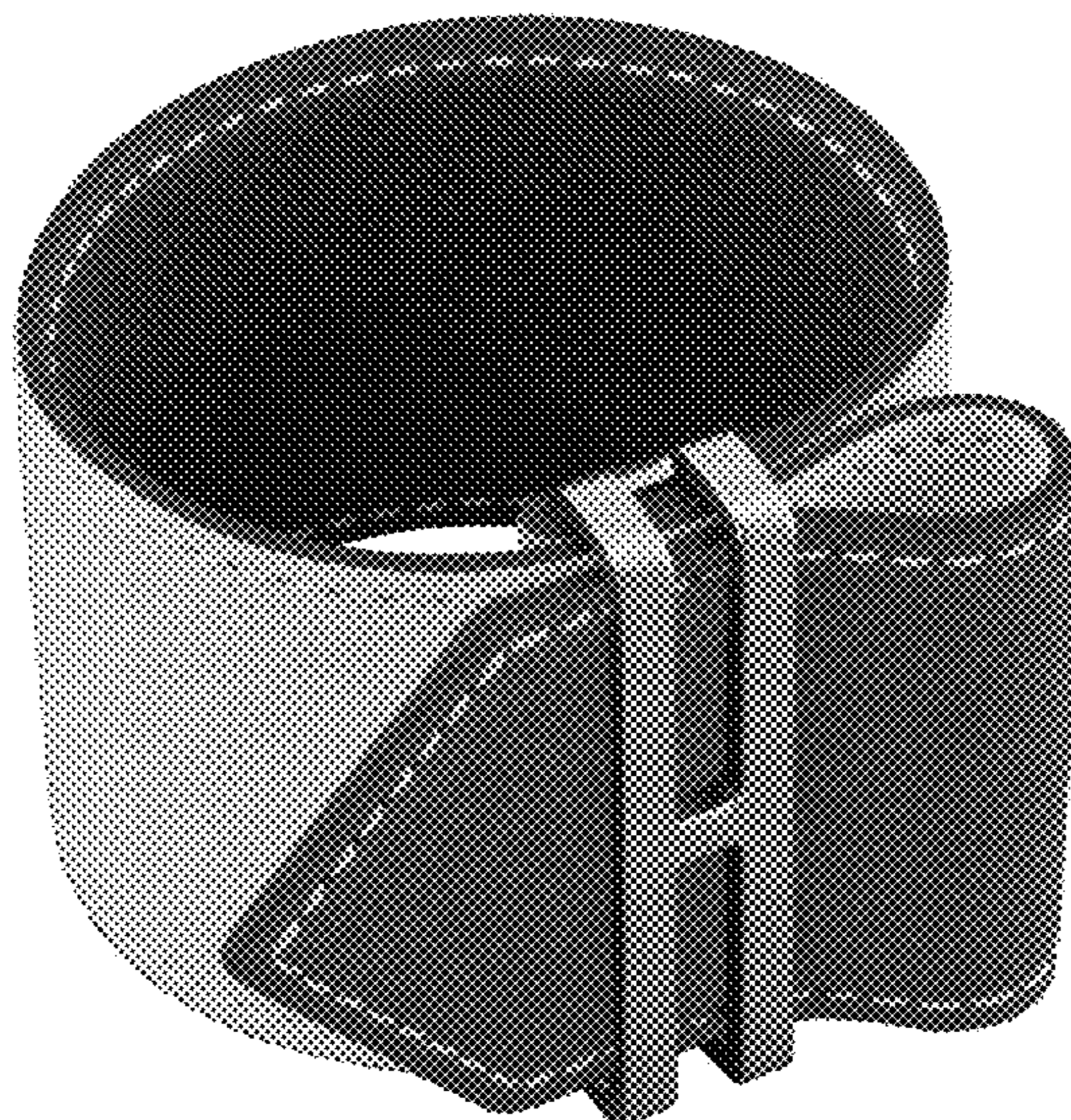
The ornamental design for a bracelet, as shown and described.

1. Bracelet
- 1.1 : Perspective
- 1.2 : Front
- 1.3 : Back
- 1.4 : Right
- 1.5 : Left
- 1.6 : Top
- 1.7 : Bottom
- 1.8 : Open bracelet perspective
- 1.9 : Open bracelet perspective

The bracelet comprises a flexible band, with a buckle connected to one end, which, on the front, has an H-shaped pattern and which on the inside defines a passage where the other end of the band, folded on itself, is held.

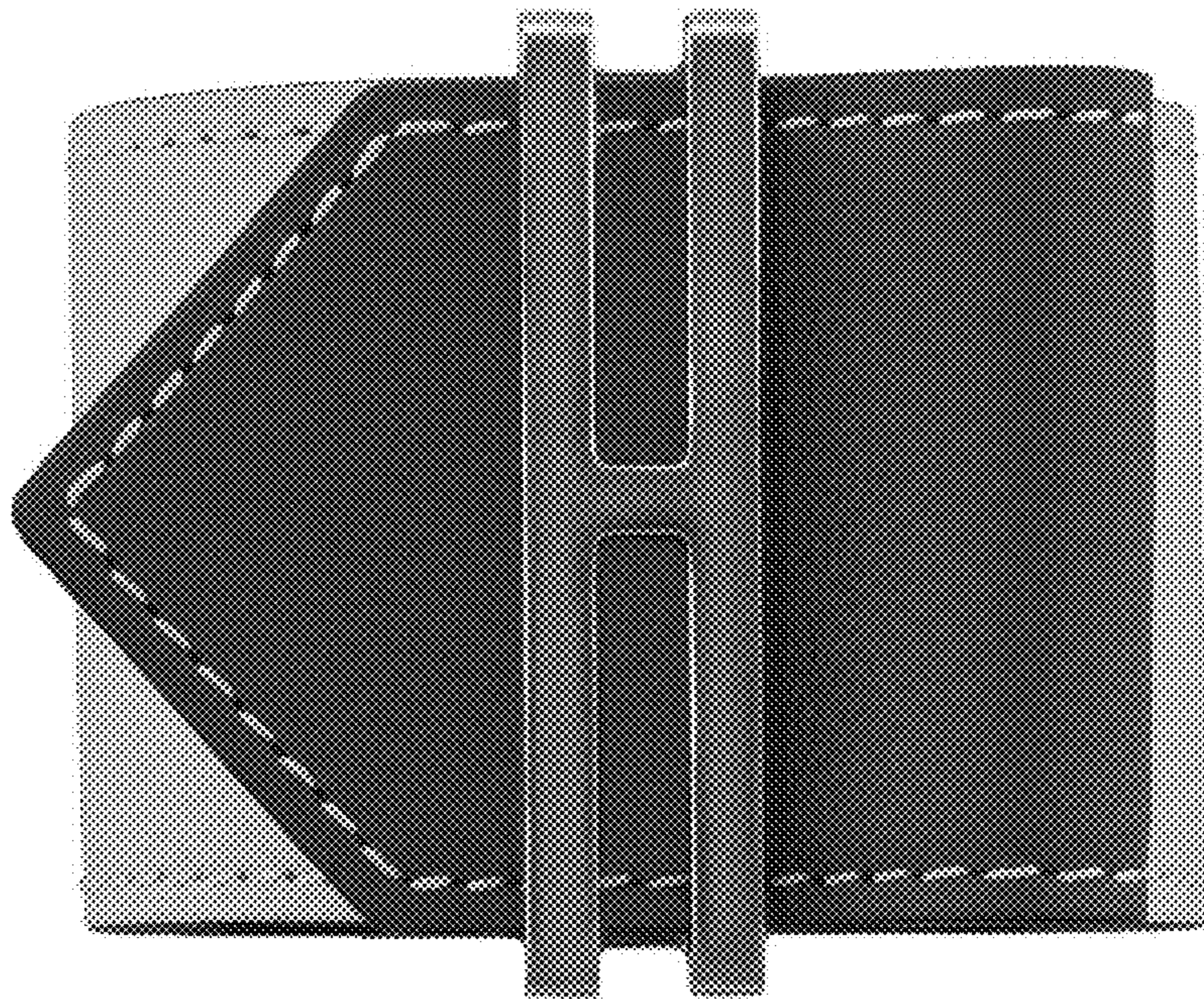

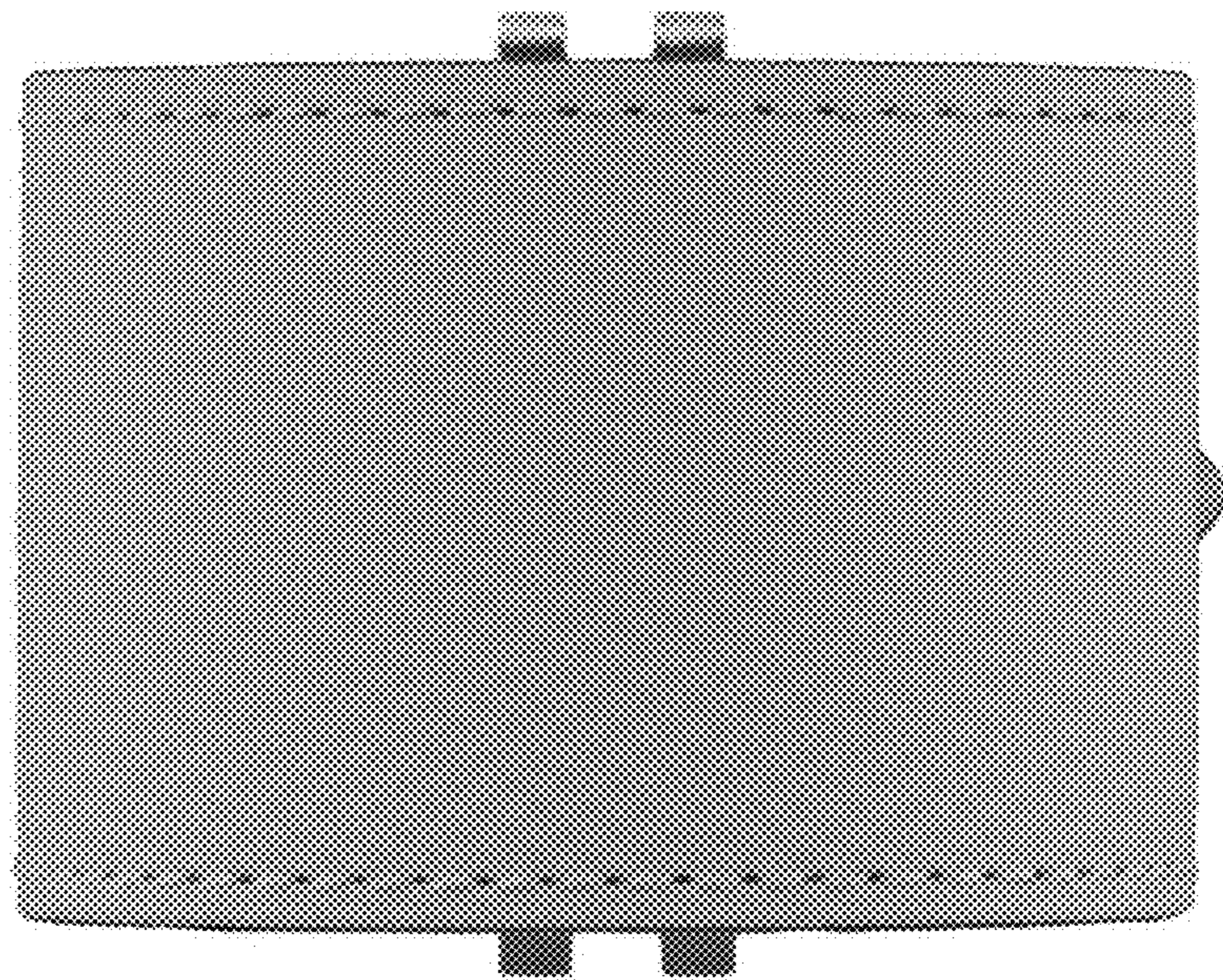

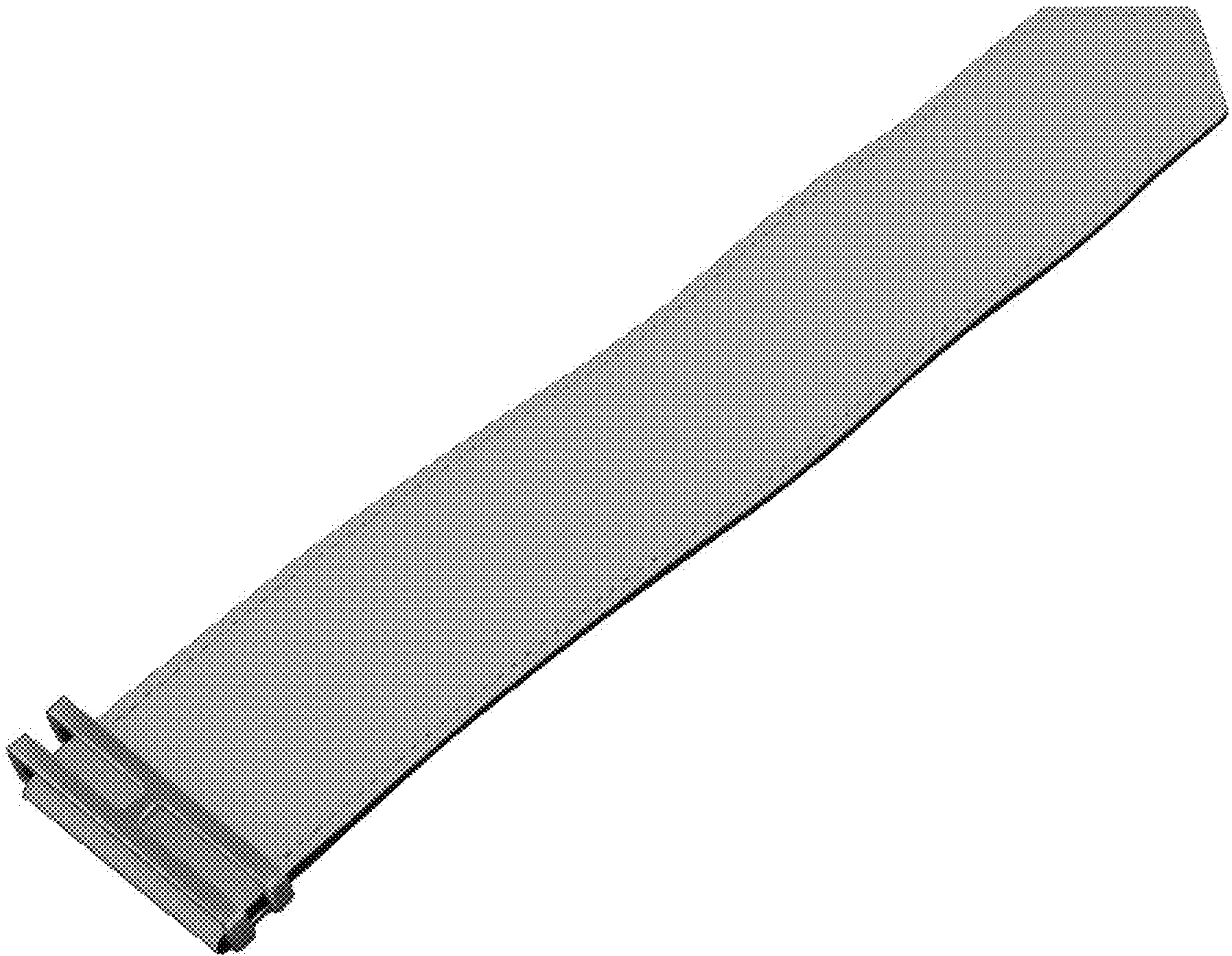
