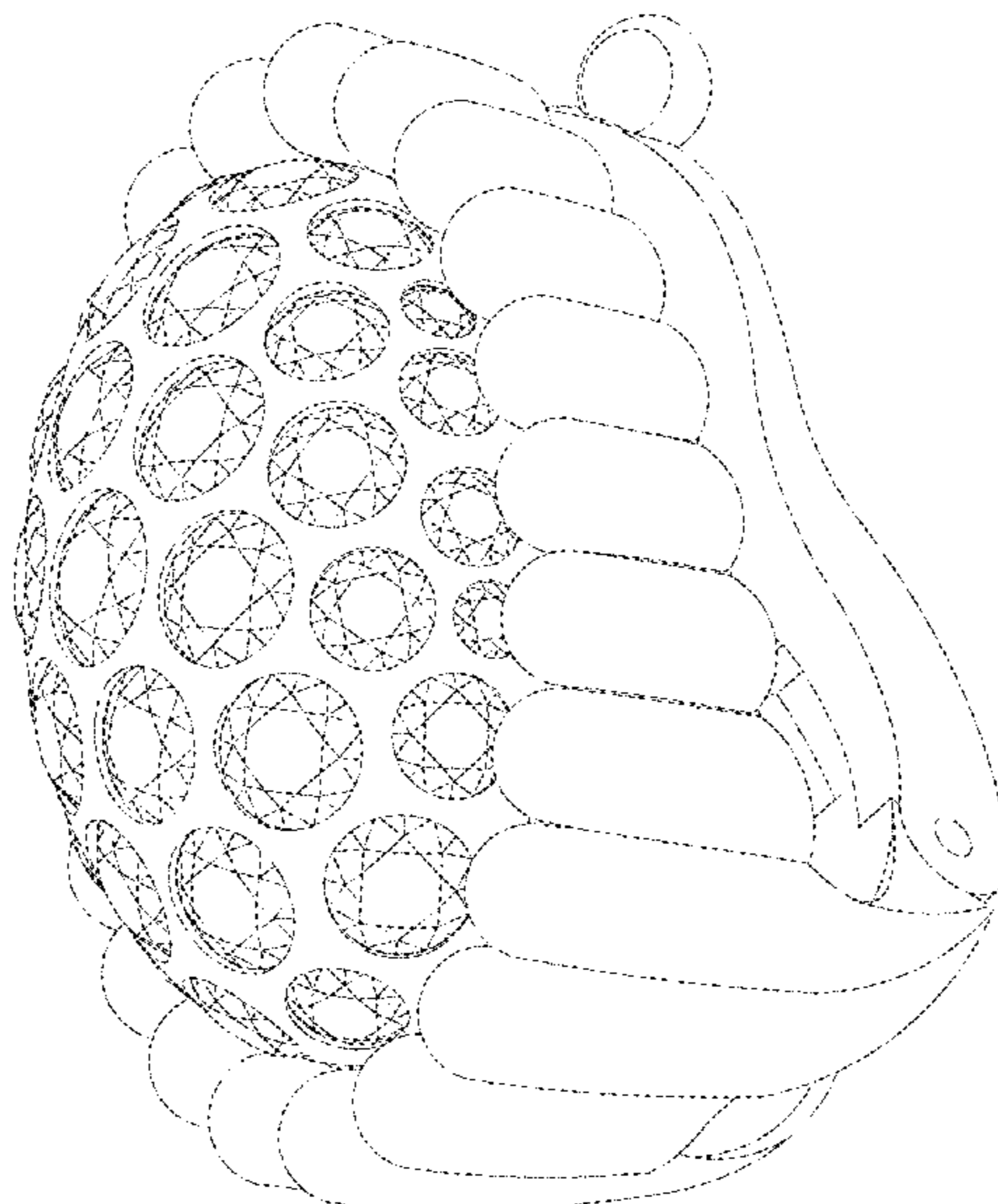

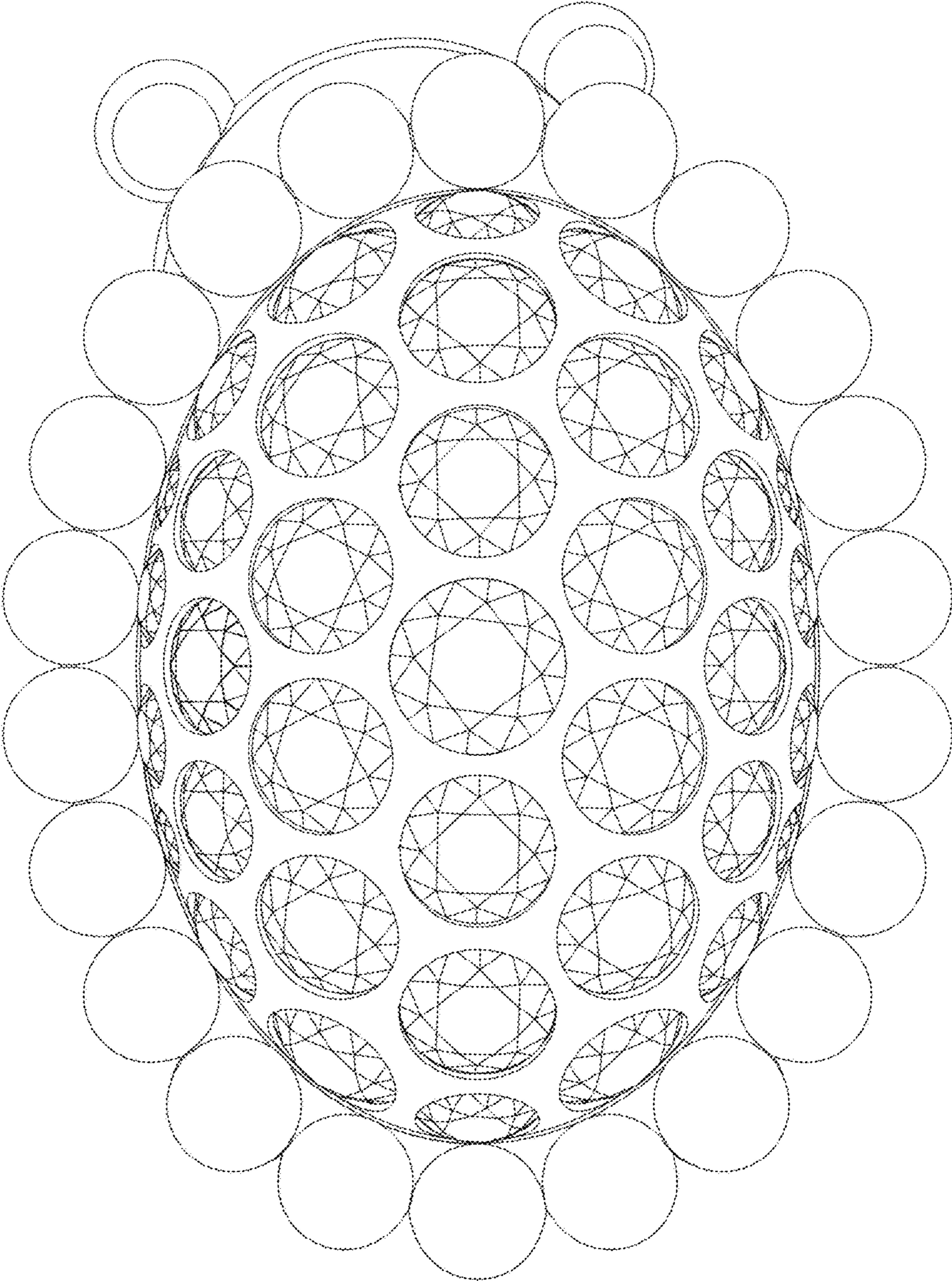

Earring arranged in golden beads staggered rows with an central oval motif paved with grain-set diamonds.

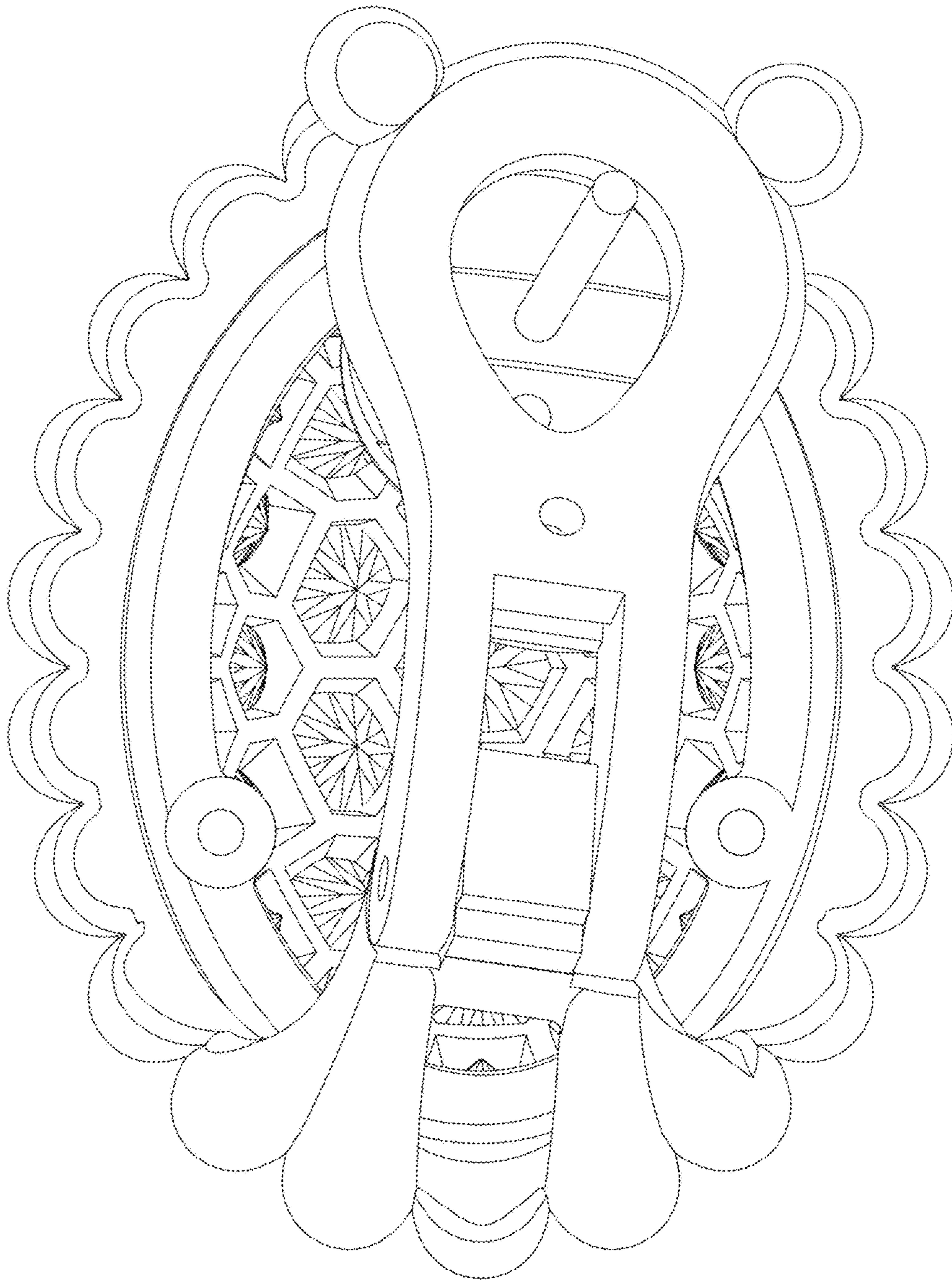

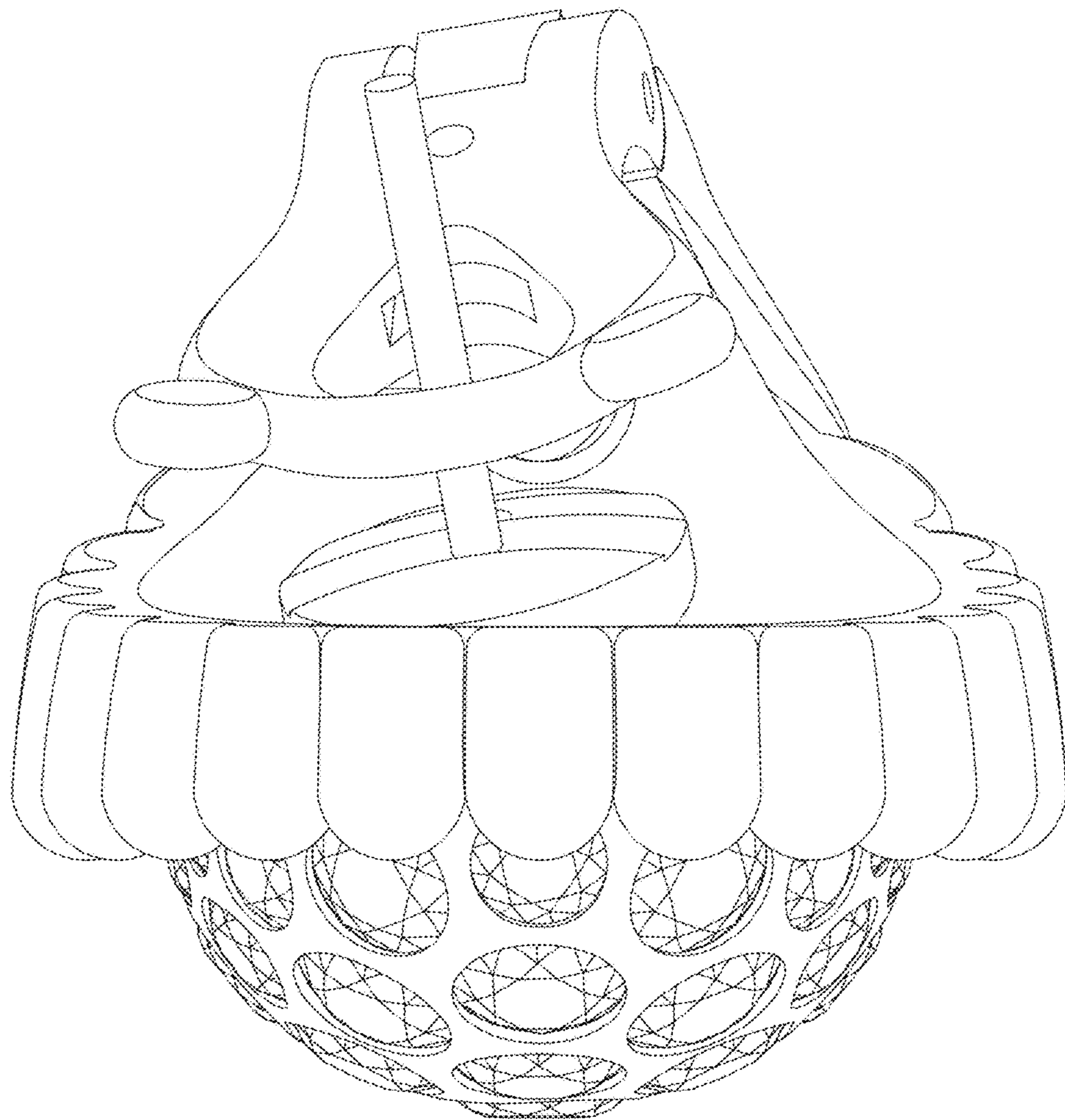

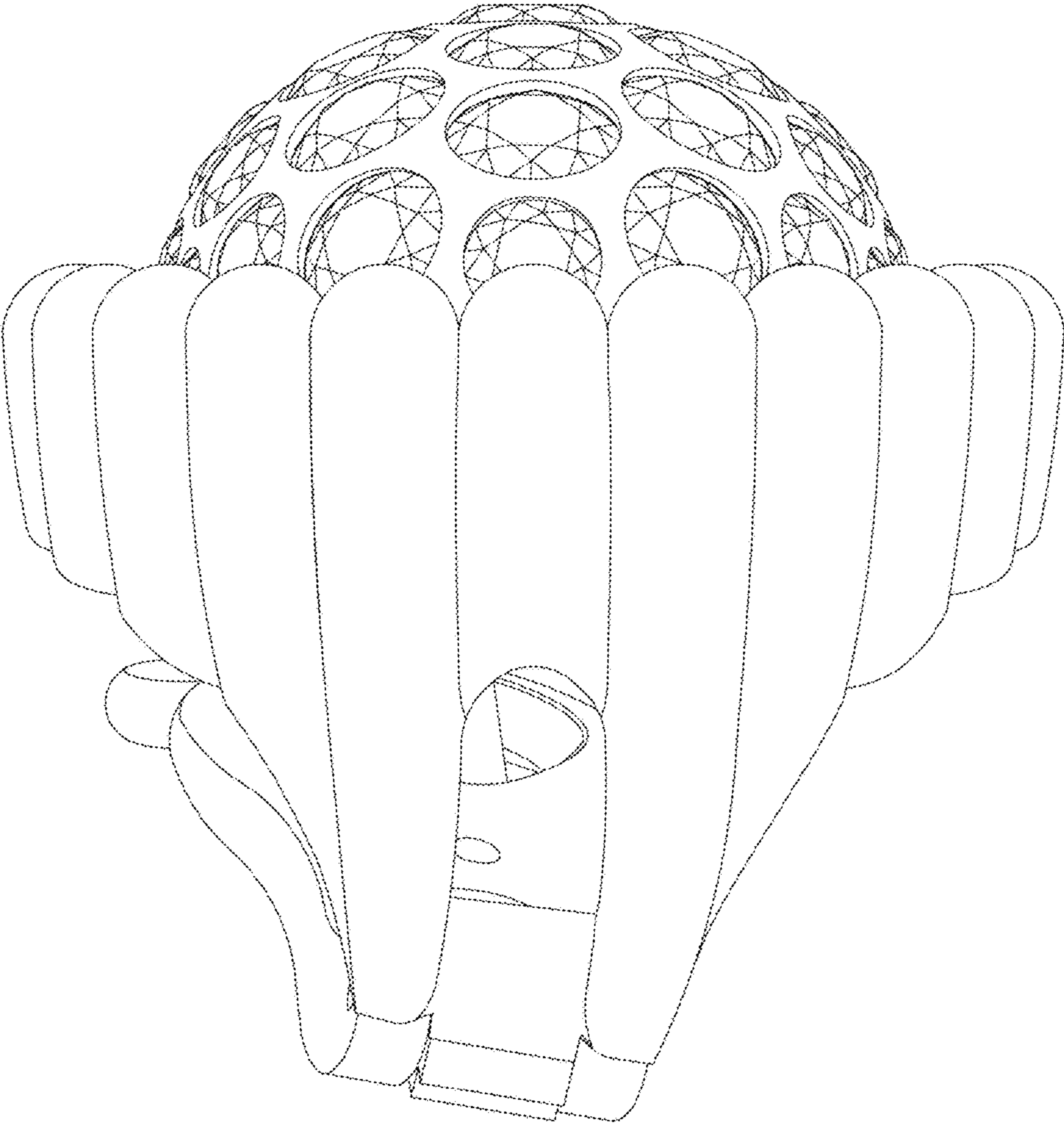

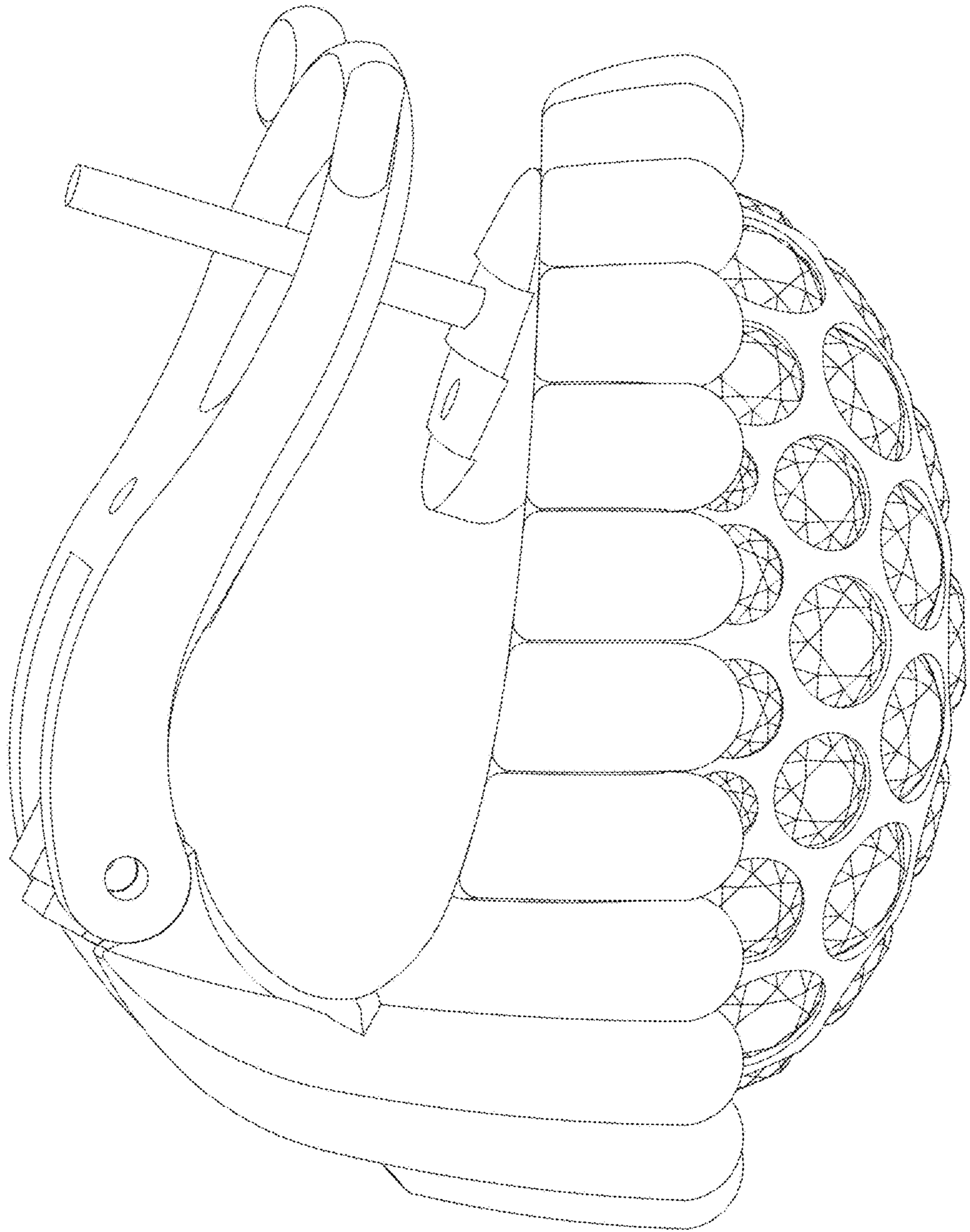

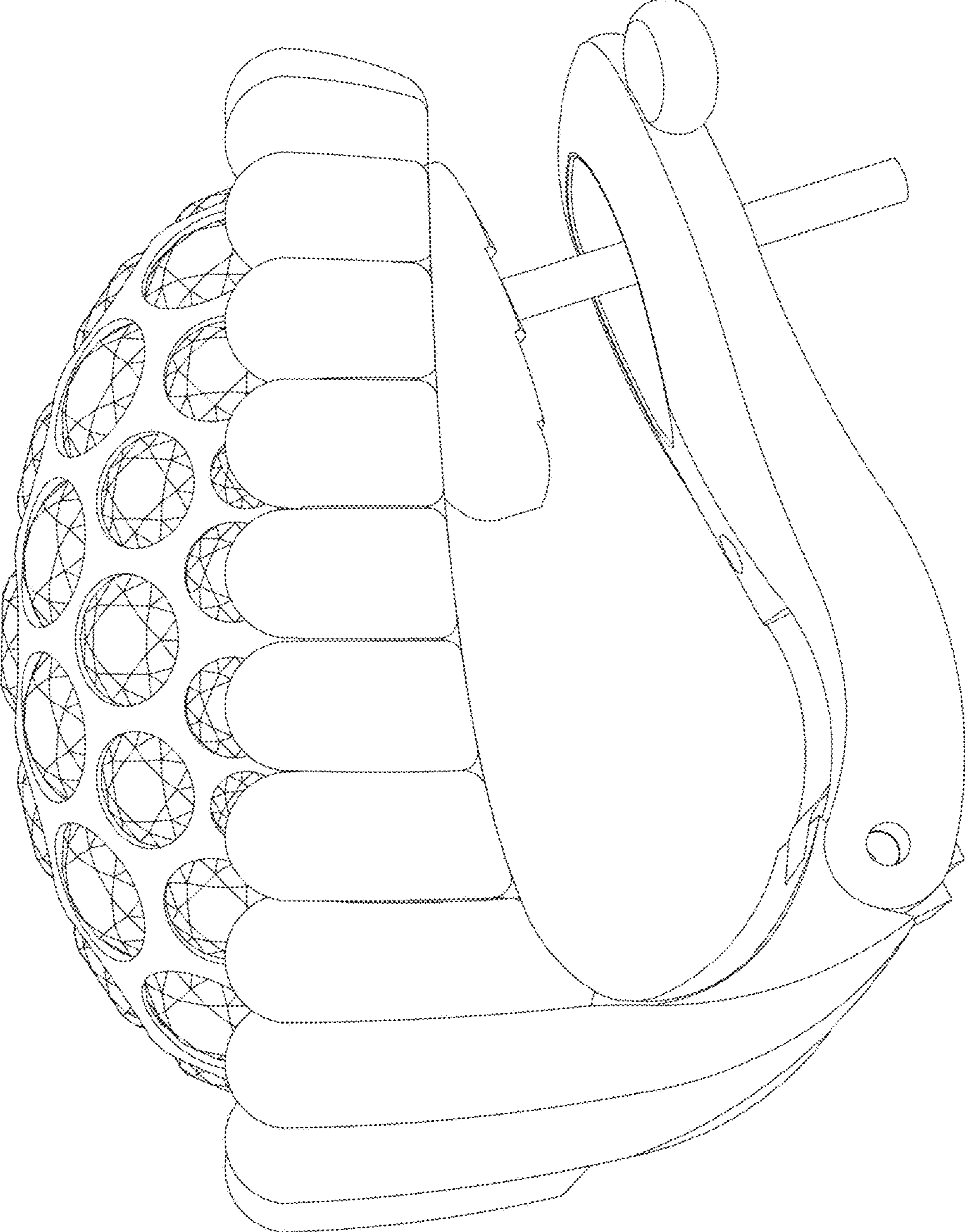

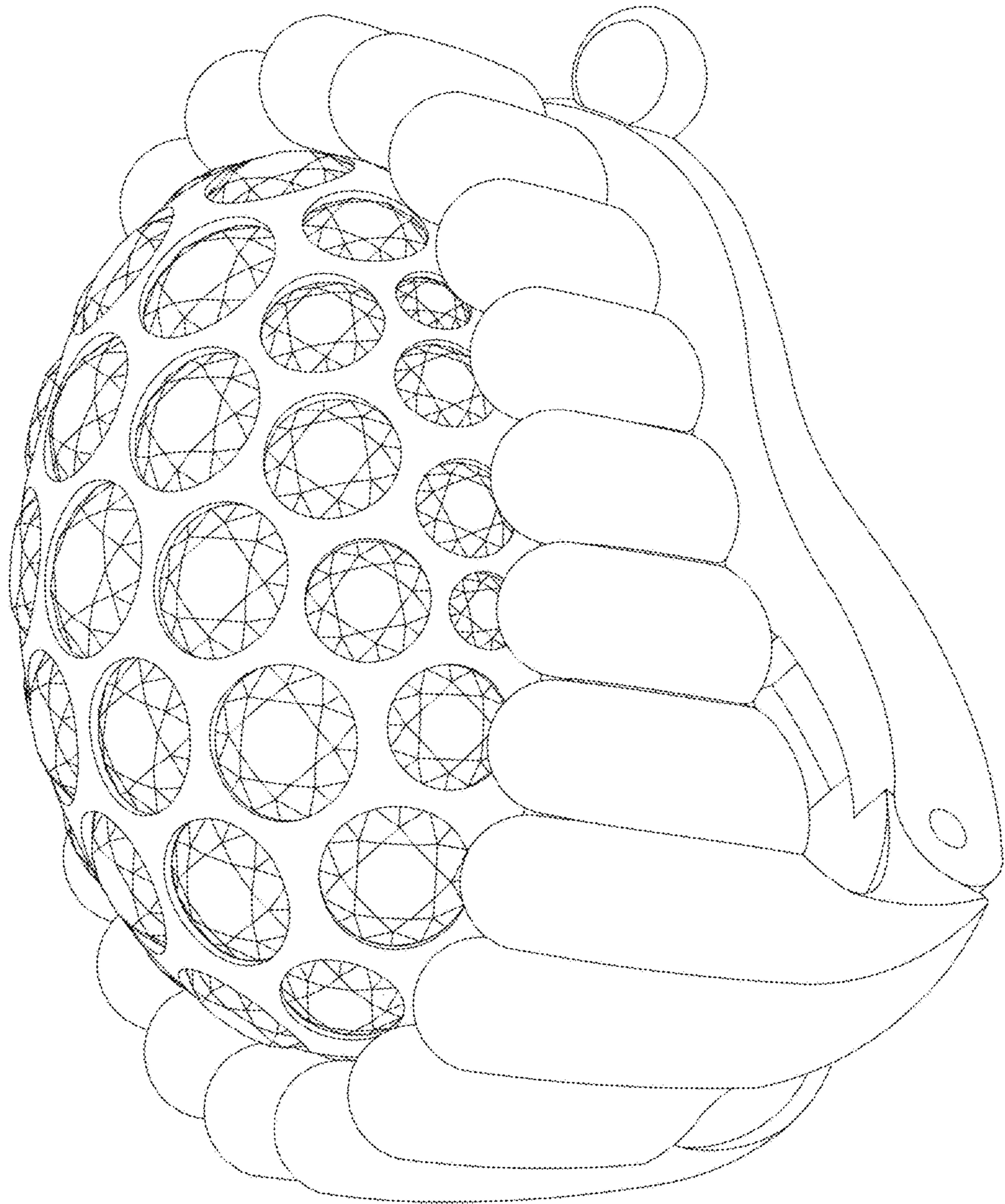
