The ornamental design for a rear bumper for a vehicle, as shown and described.

DESCRIPTION

FIG. 5 is a right side view thereof;

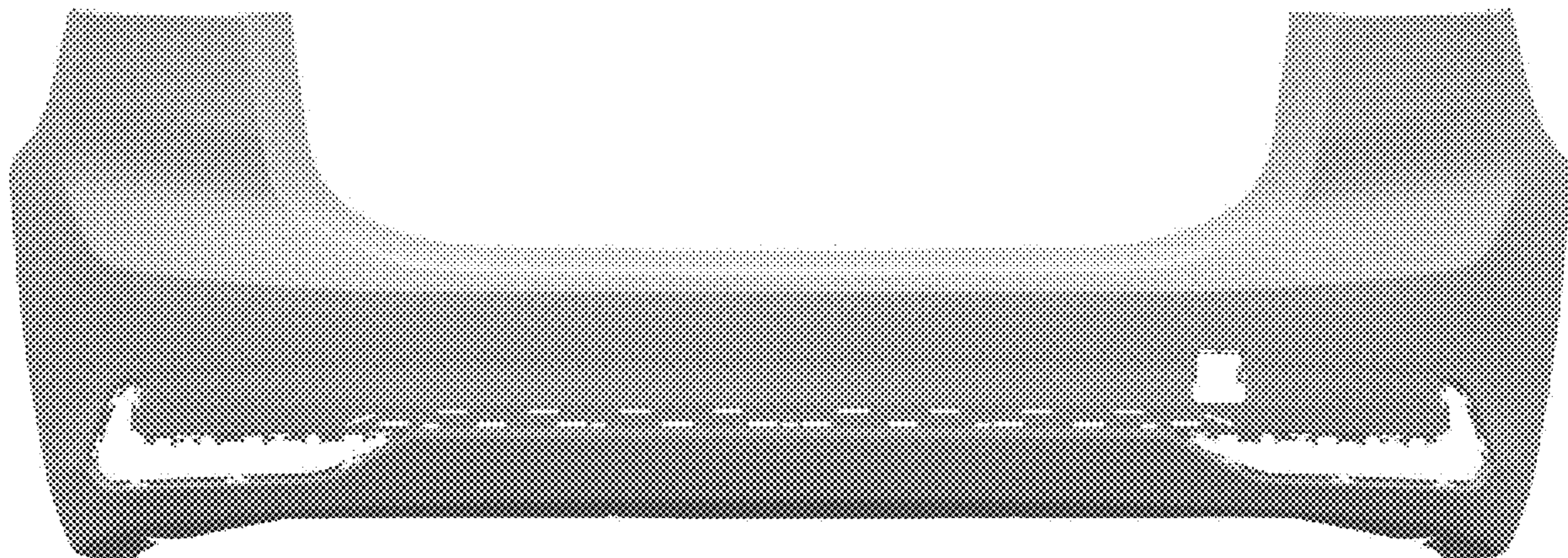
FIG. 6 is a top view thereof;

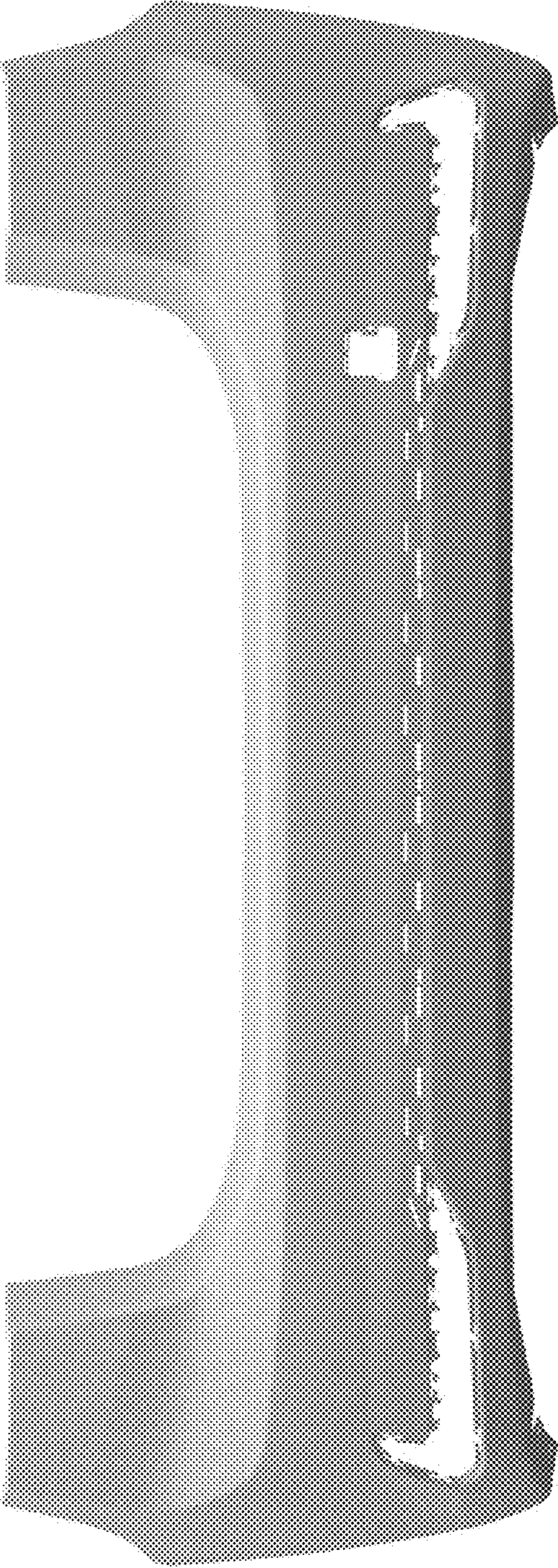

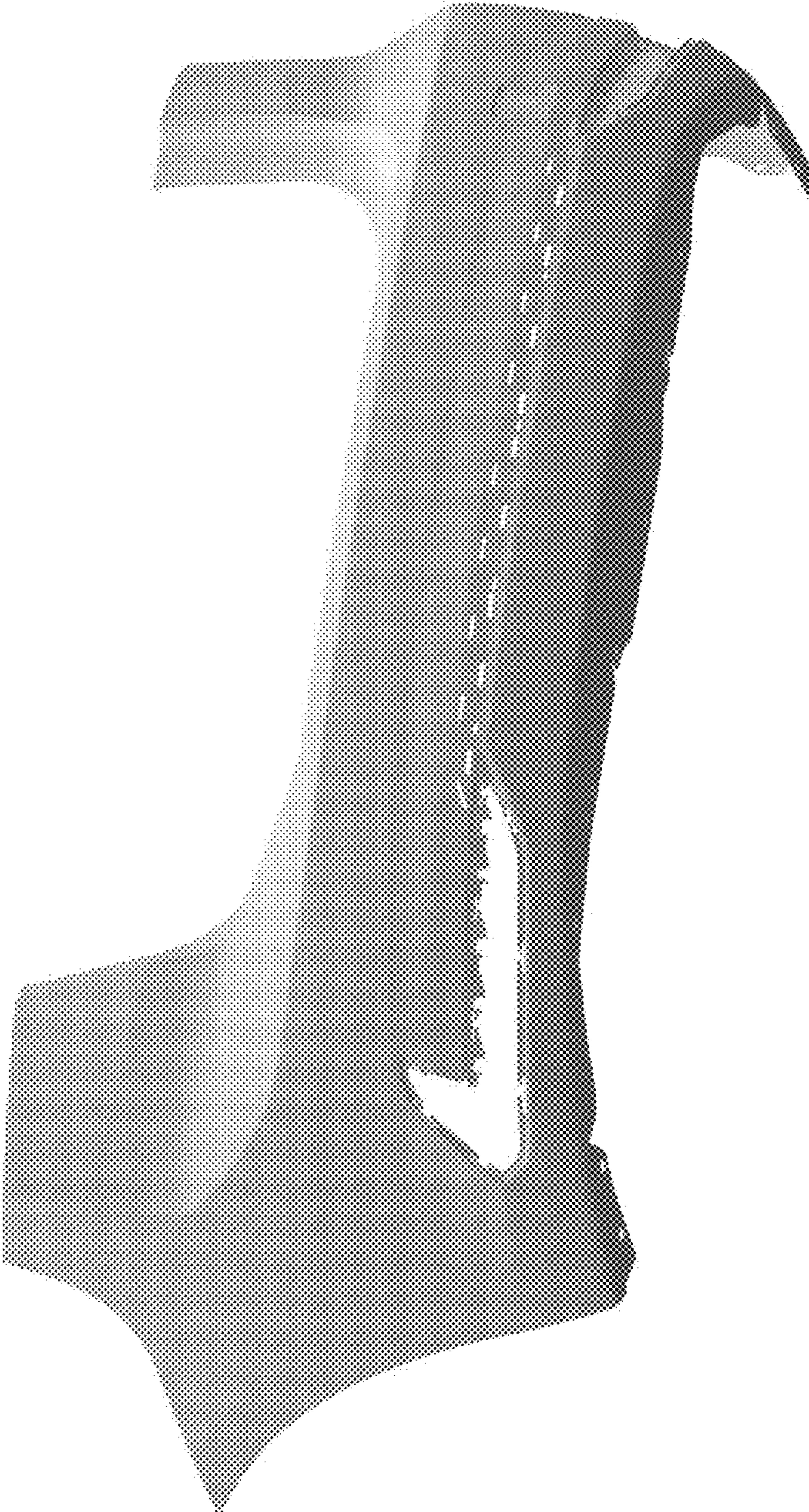

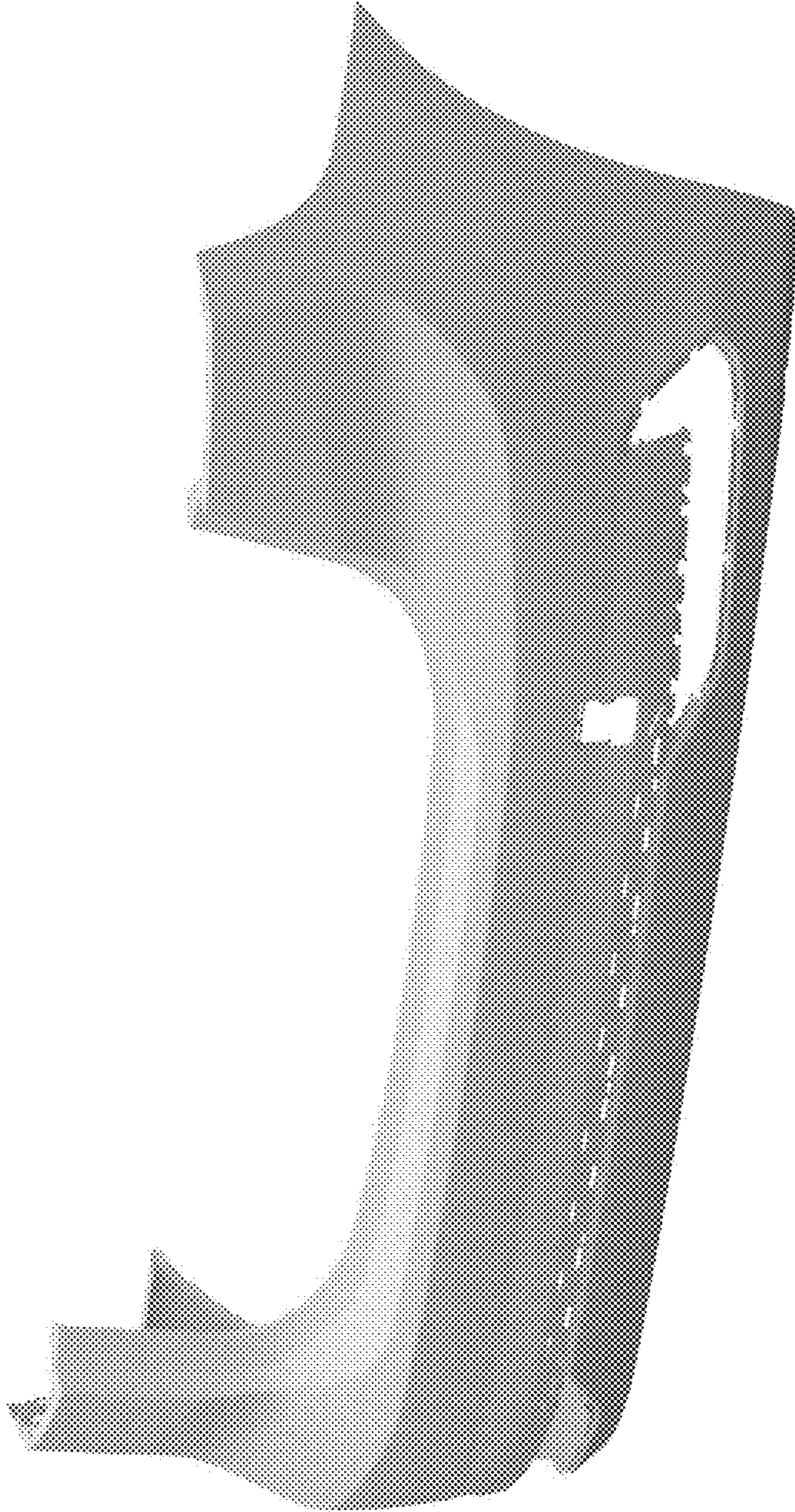

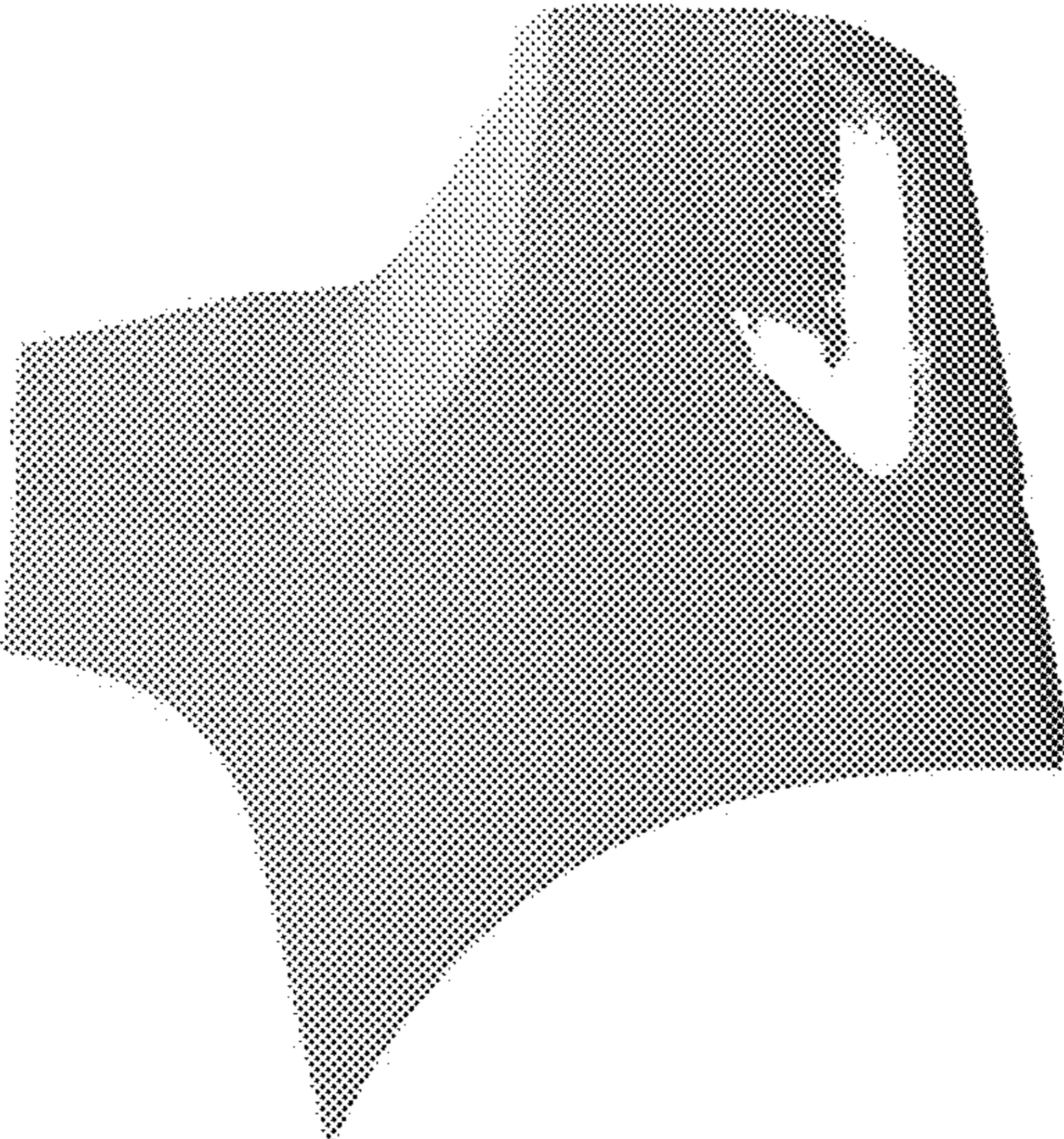

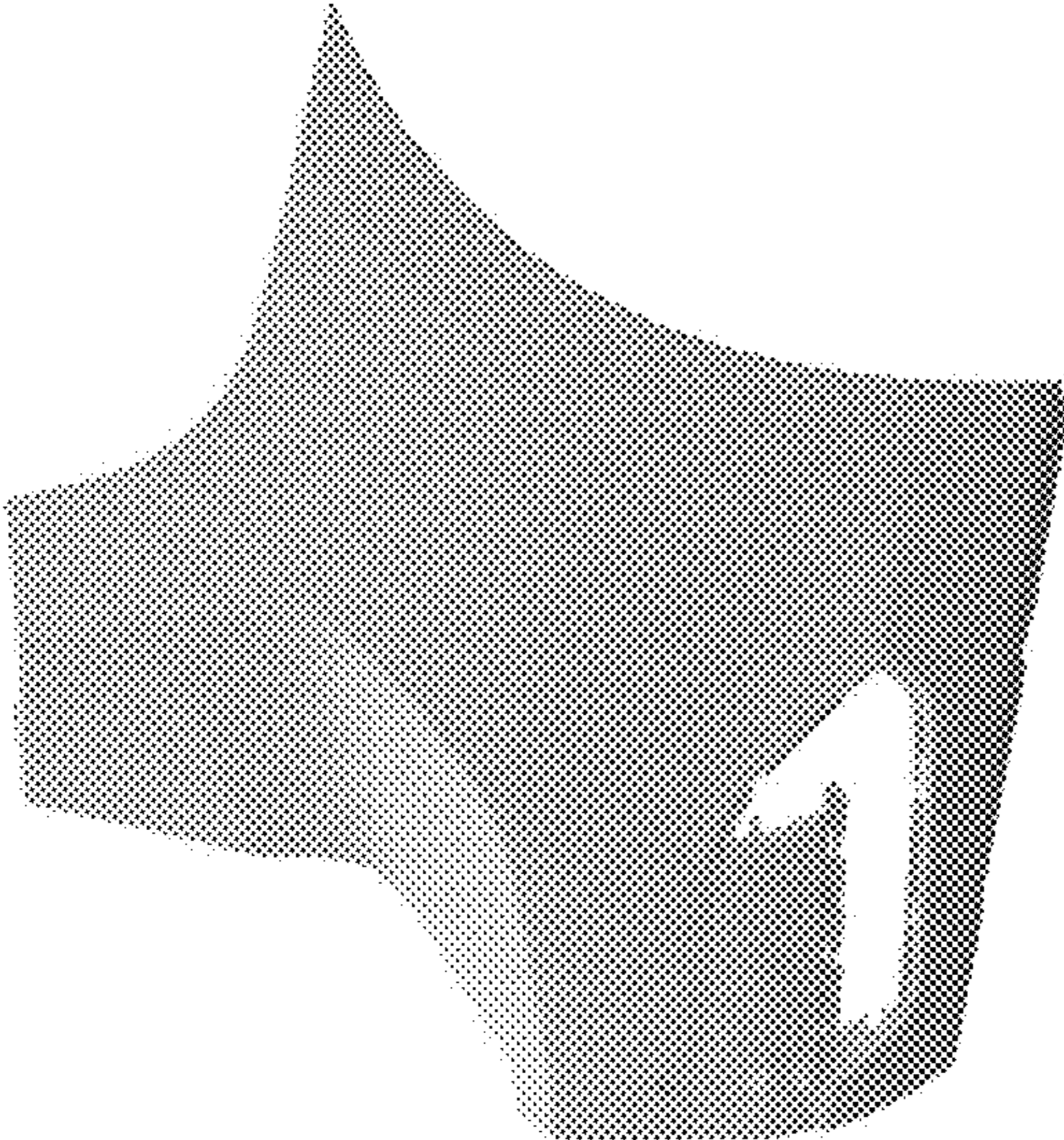

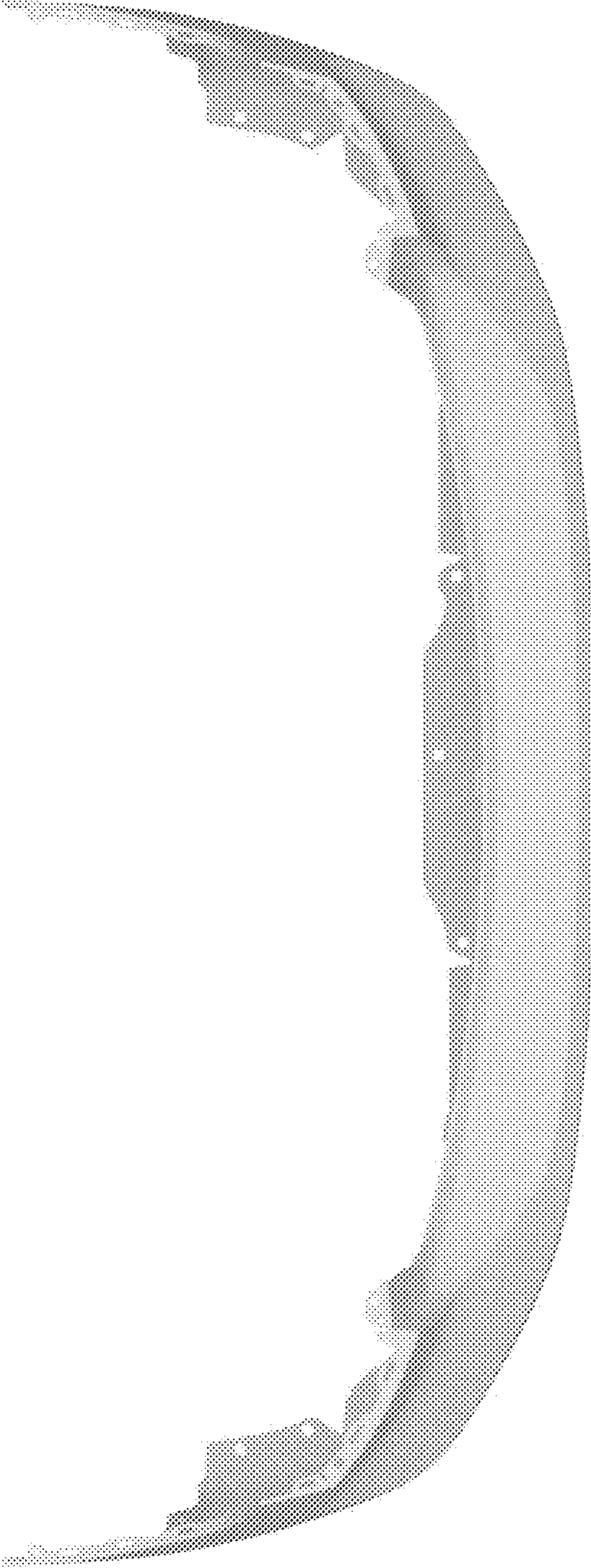

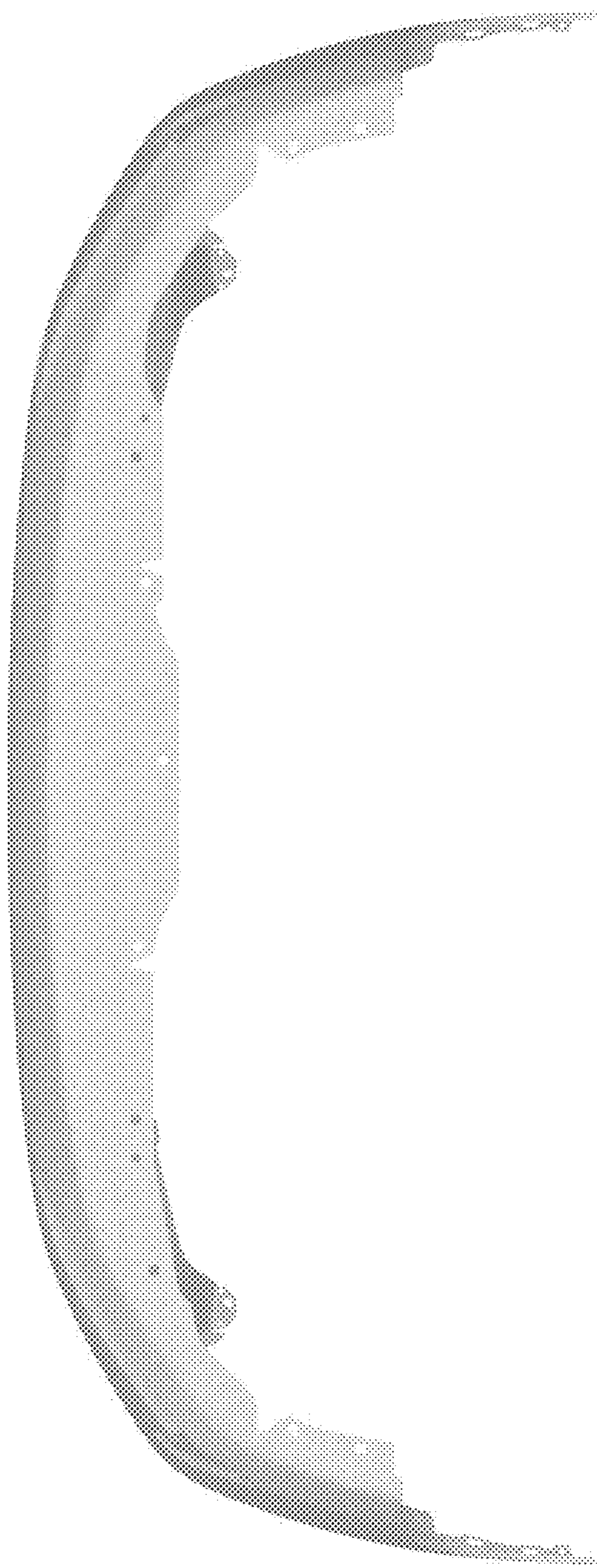

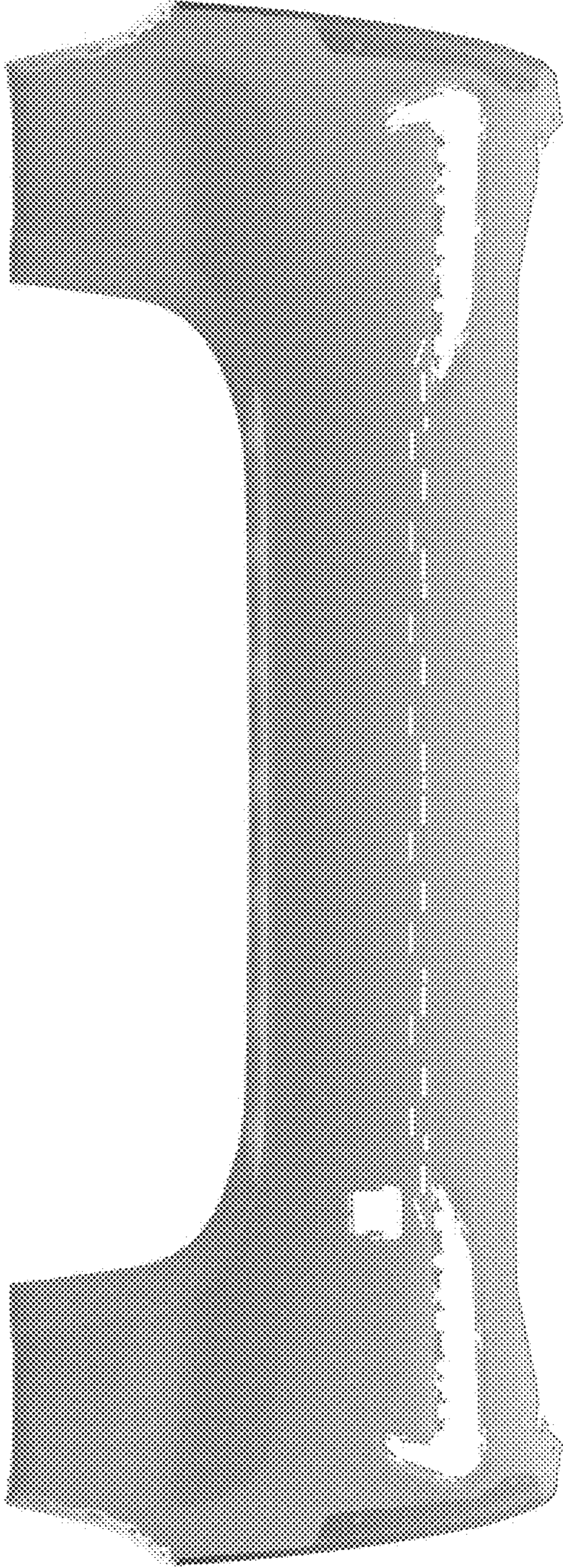
