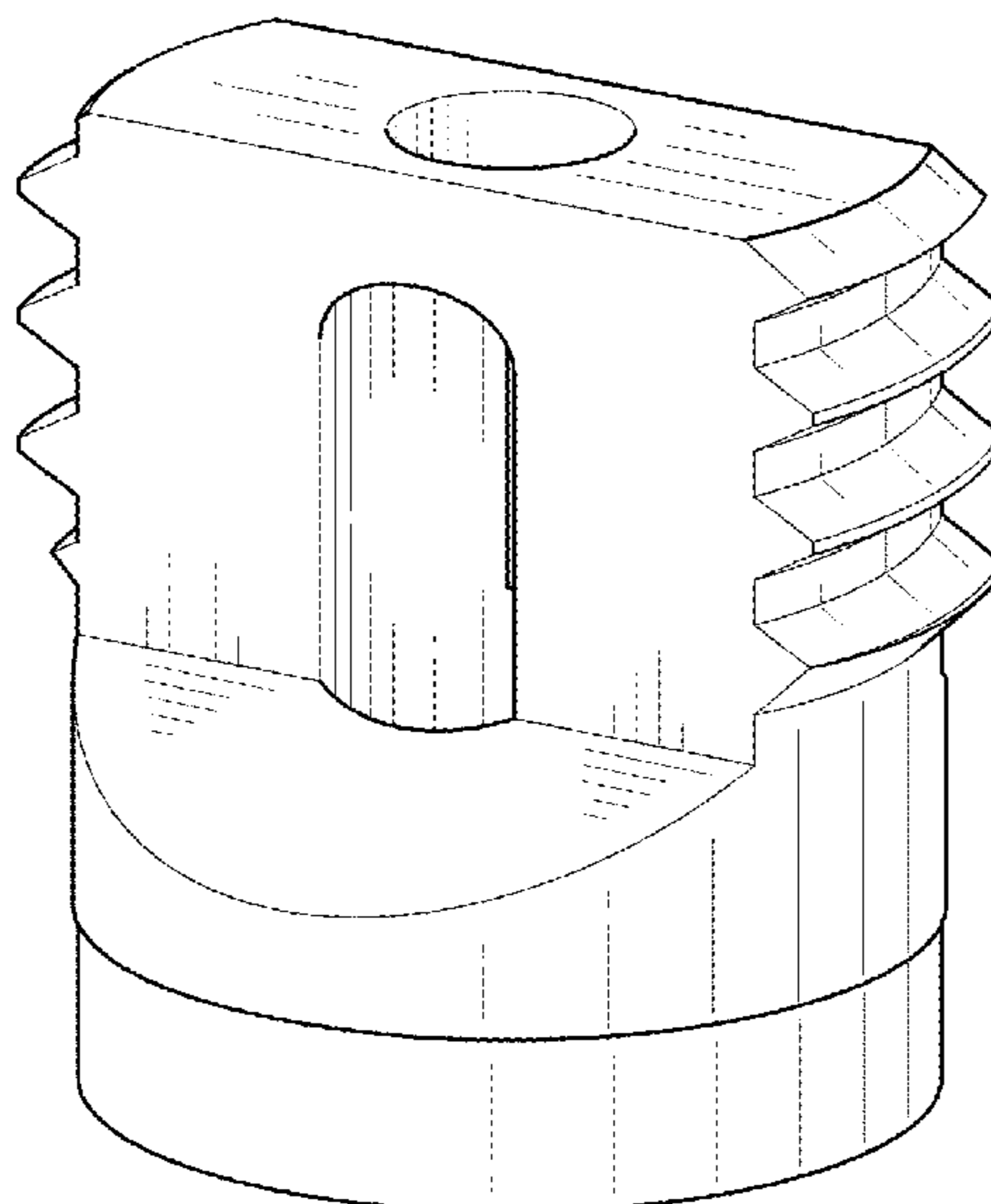
(57) **CLAIM**

The ornamental design for a valve component for vehicle tyres, as shown and described.

DESCRIPTION

FIG. 1 is a front, right-side, top perspective view of a valve component for vehicle tyres, showing the new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left-side elevational view thereof; FIG. 5 is a right-side elevational view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a front, right-side, top perspective view showing the valve component in a closed state of use; FIG. 9 is a front elevational view showing the valve component in a closed state of use; and, FIG. 10 is a front elevational view showing the valve component in an open state of use. The broken lines depict environment and form no part of the claimed design.

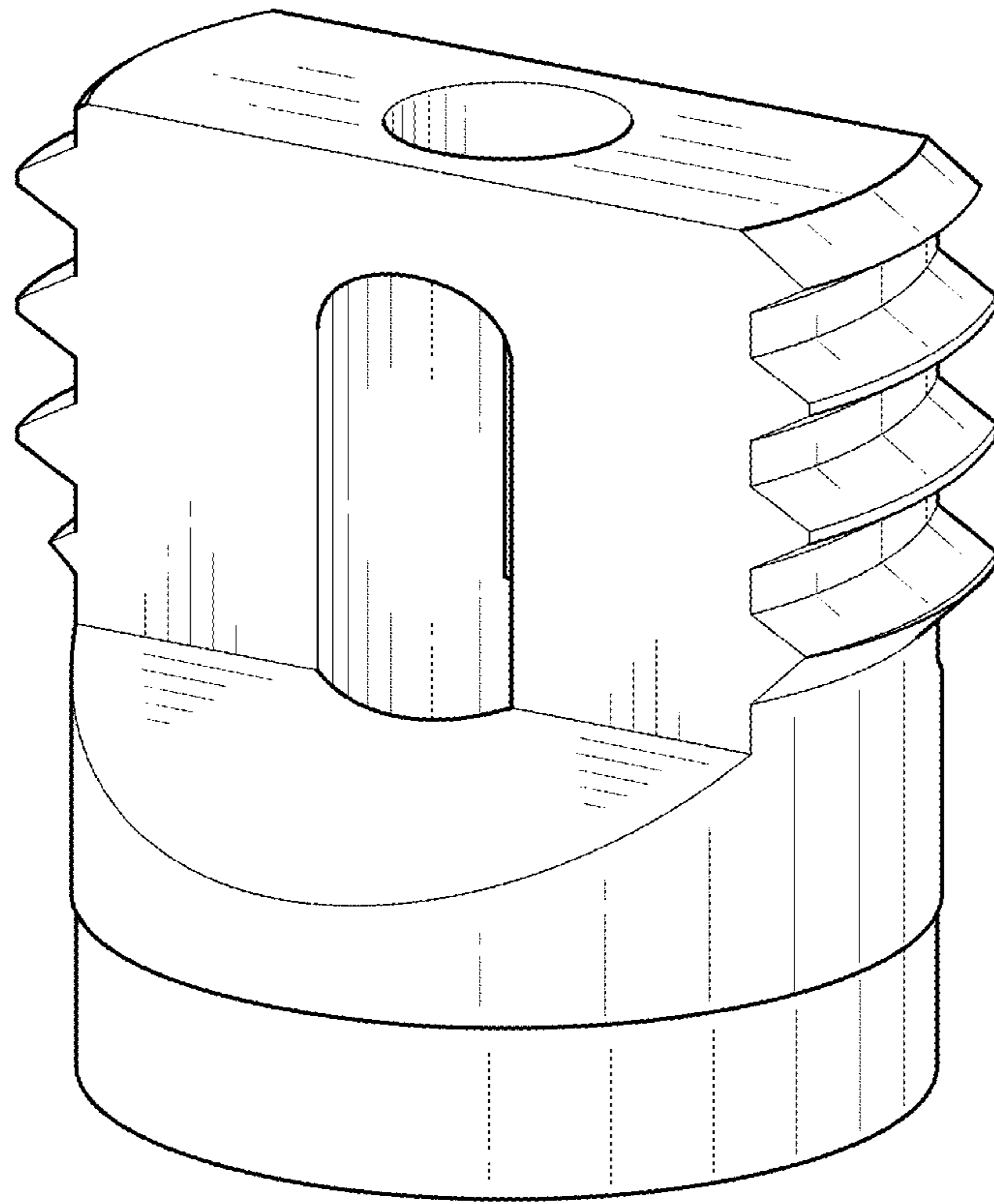

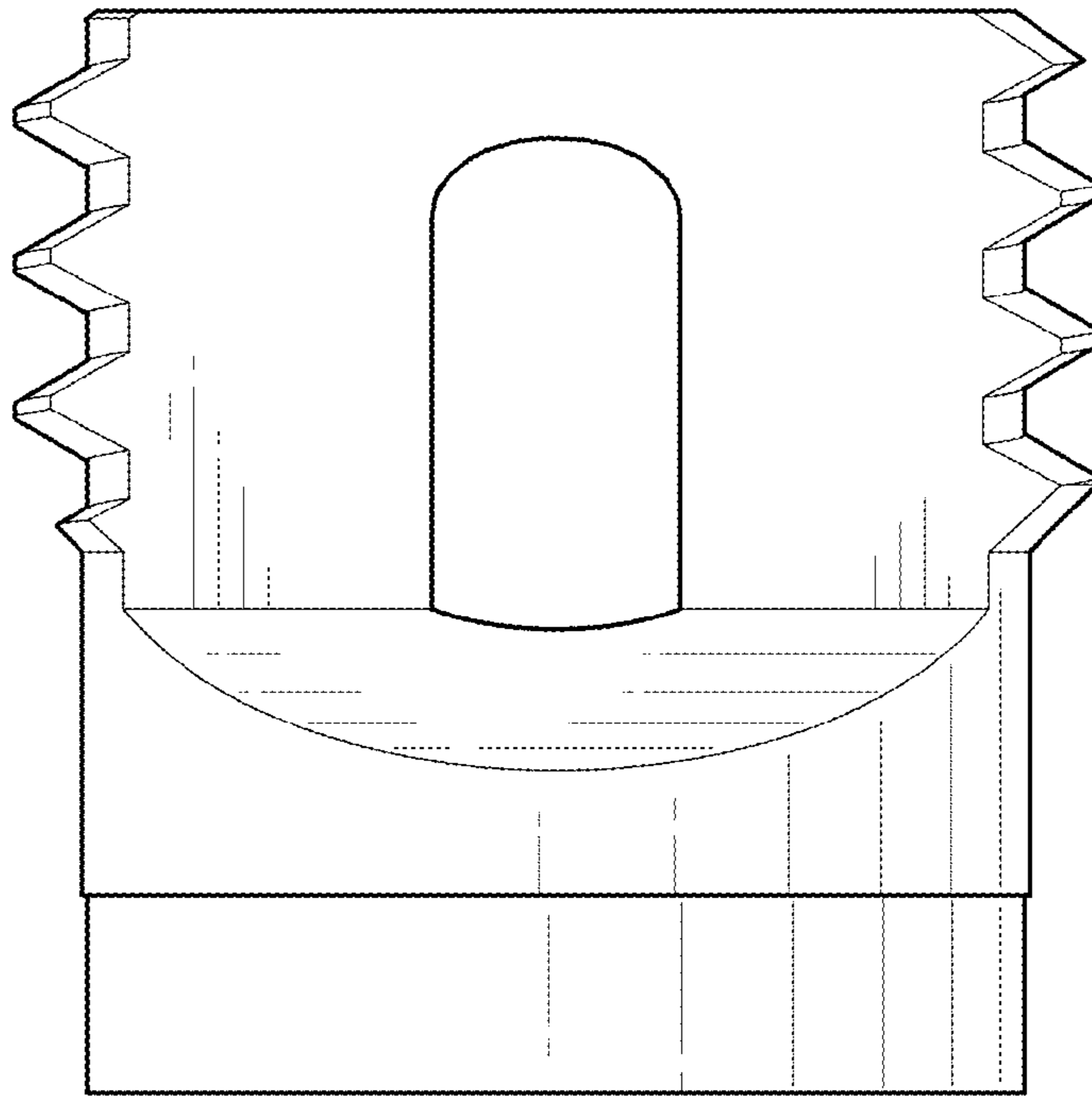

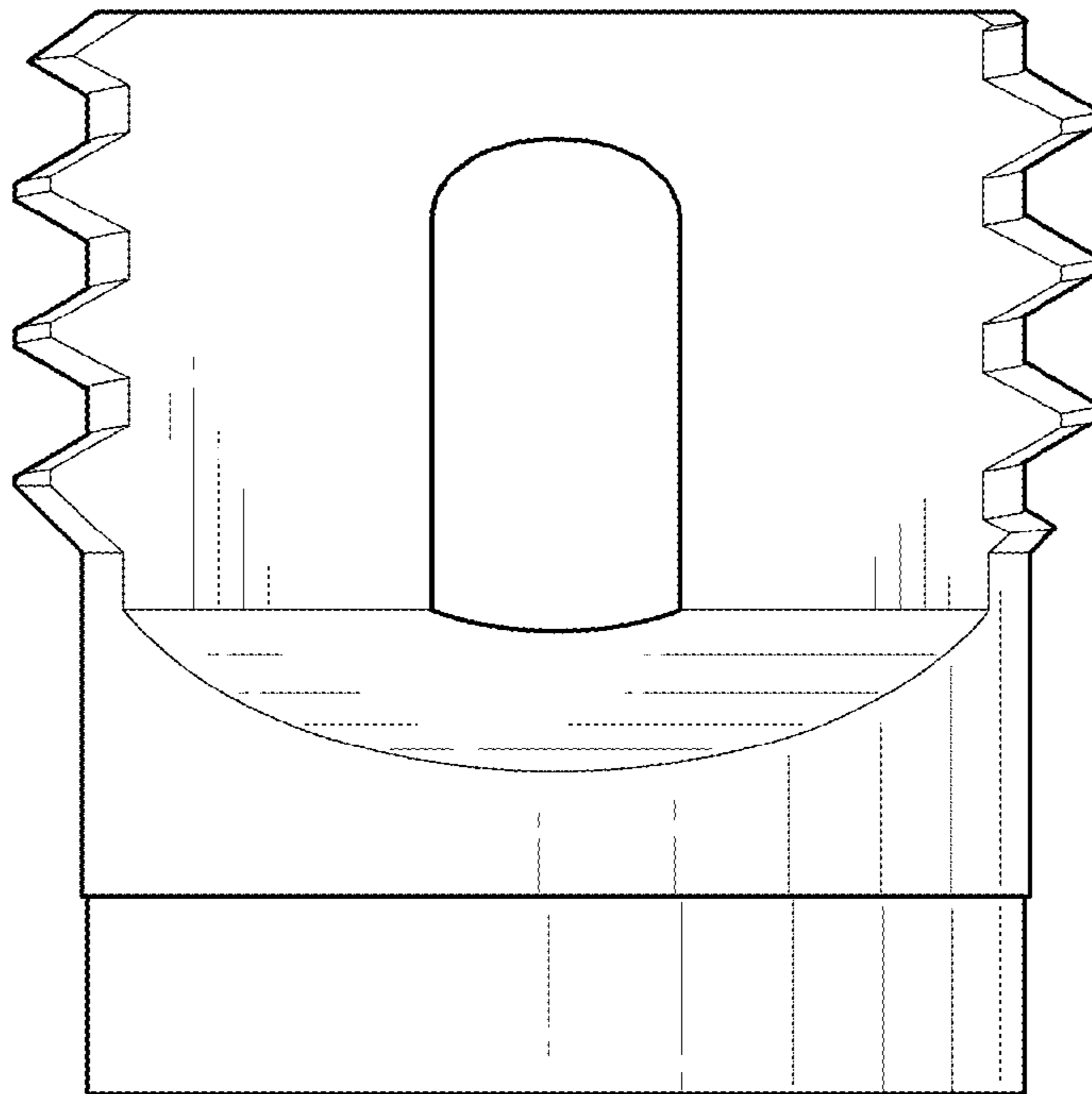

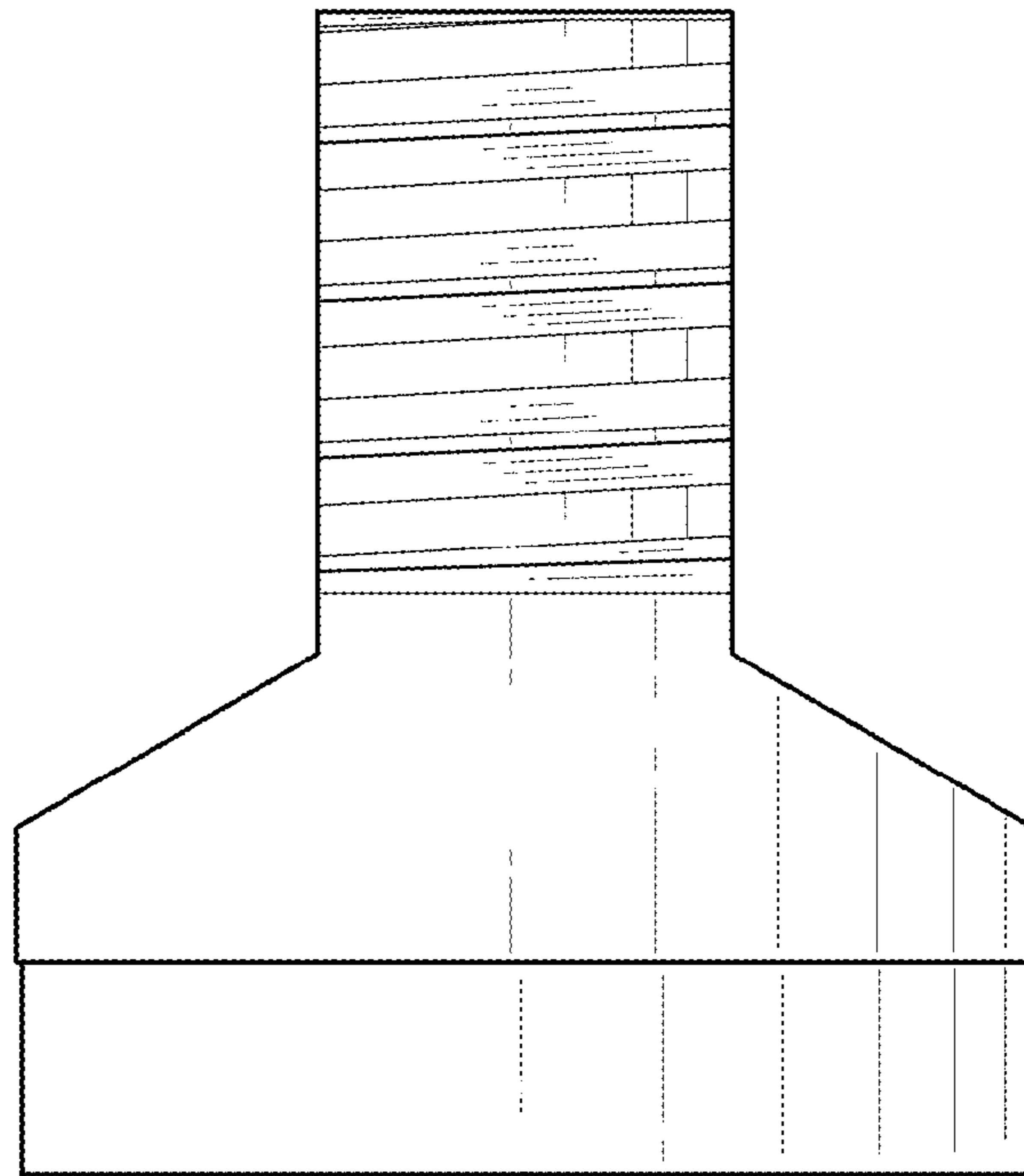

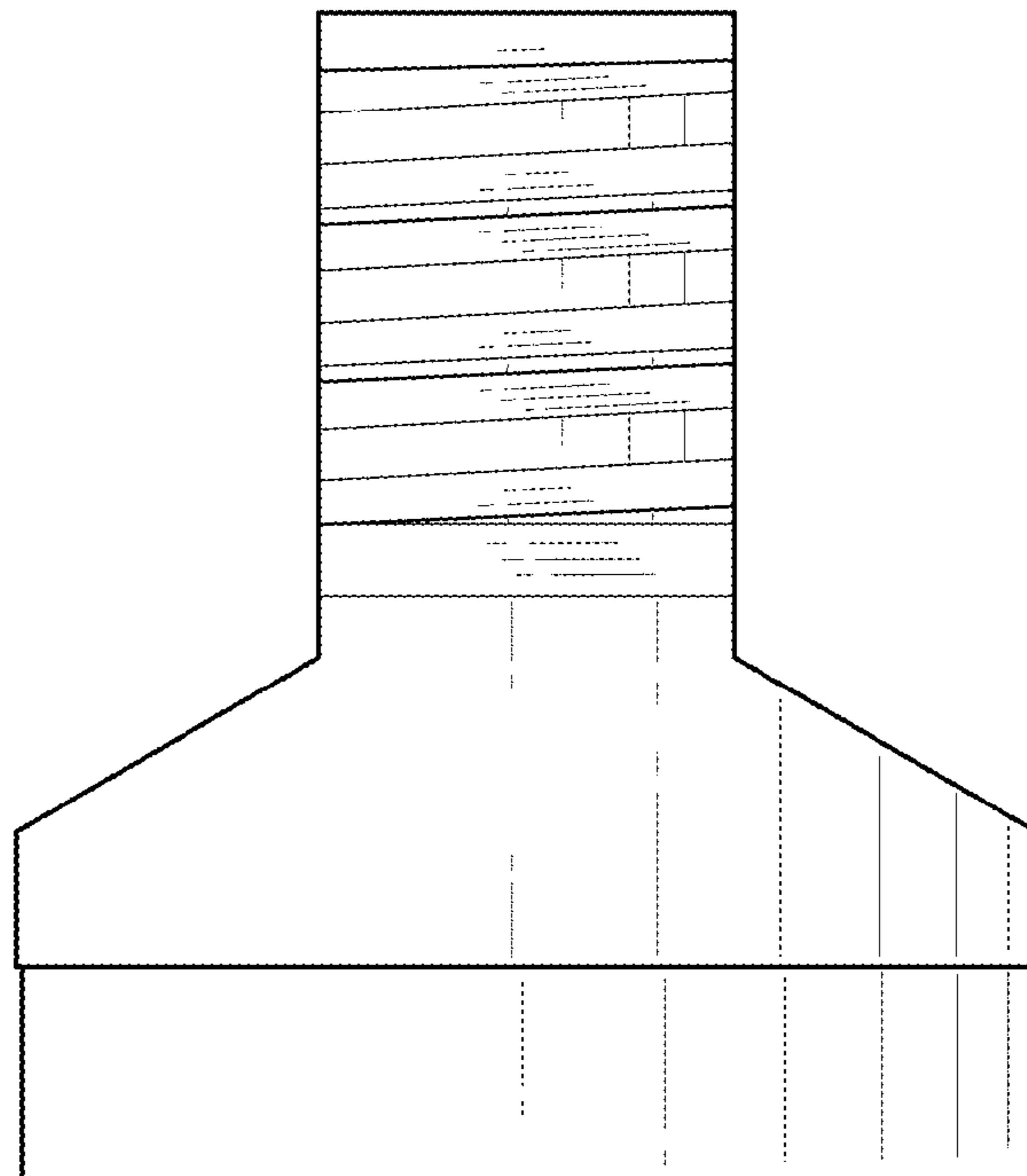

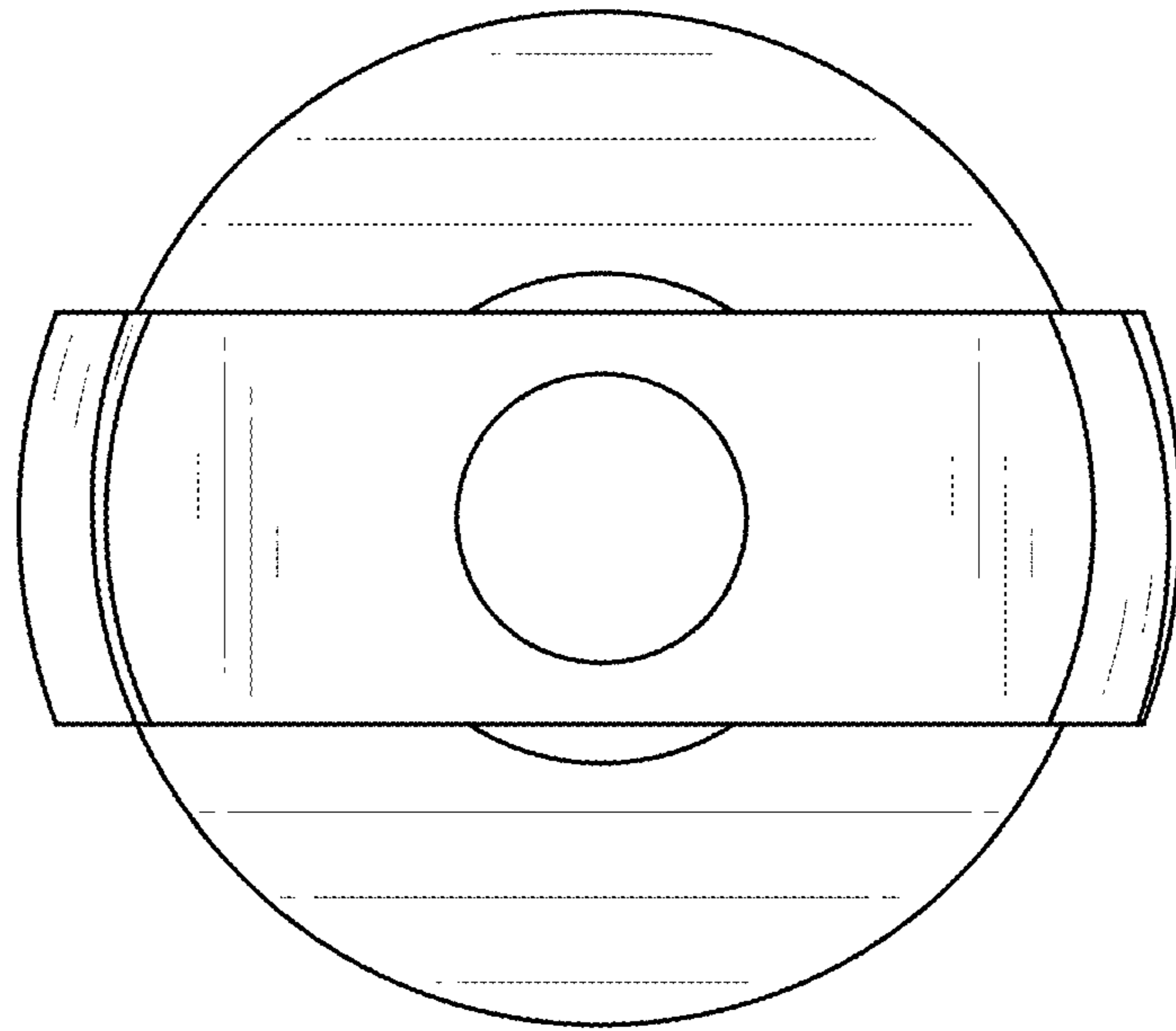

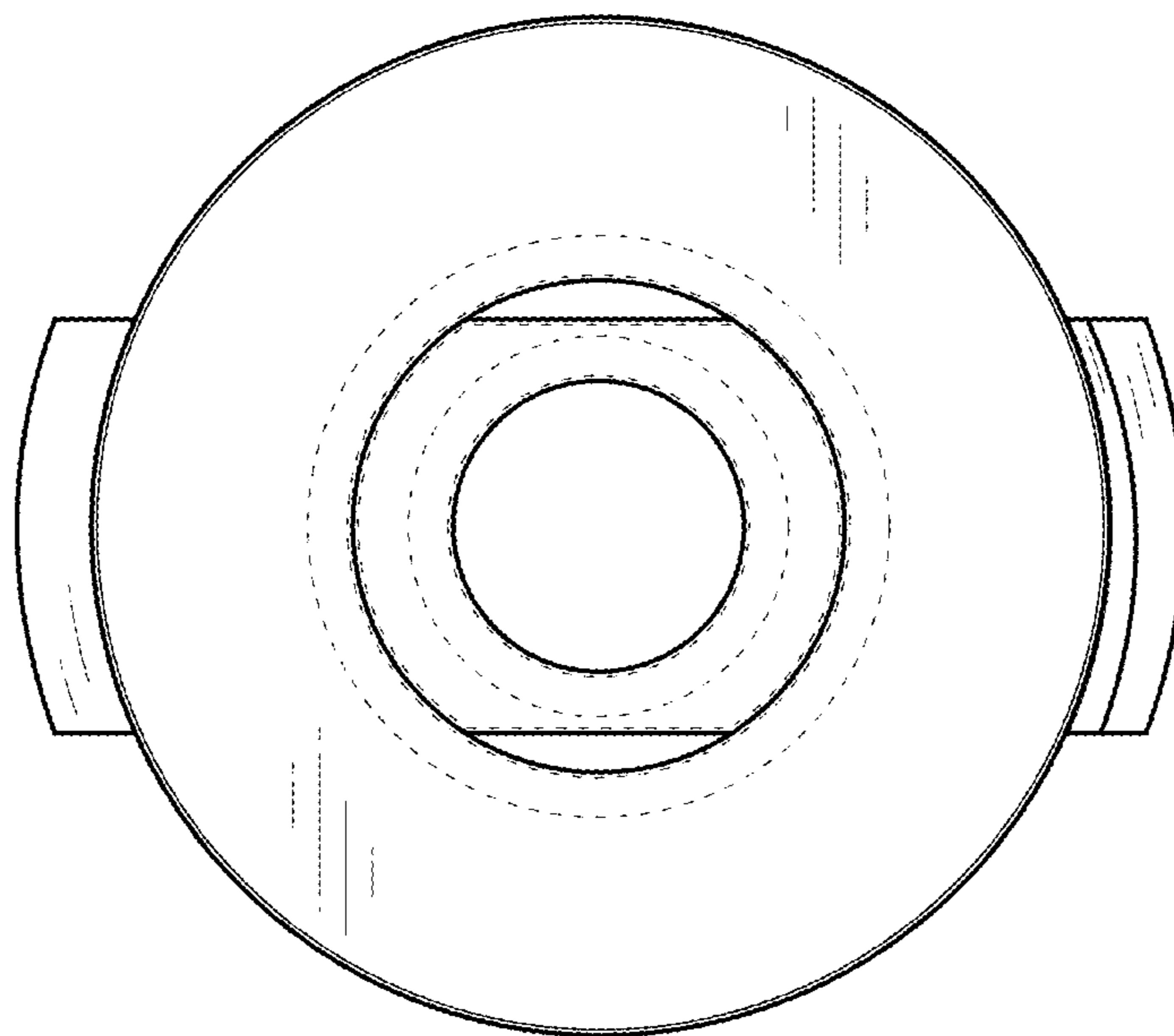

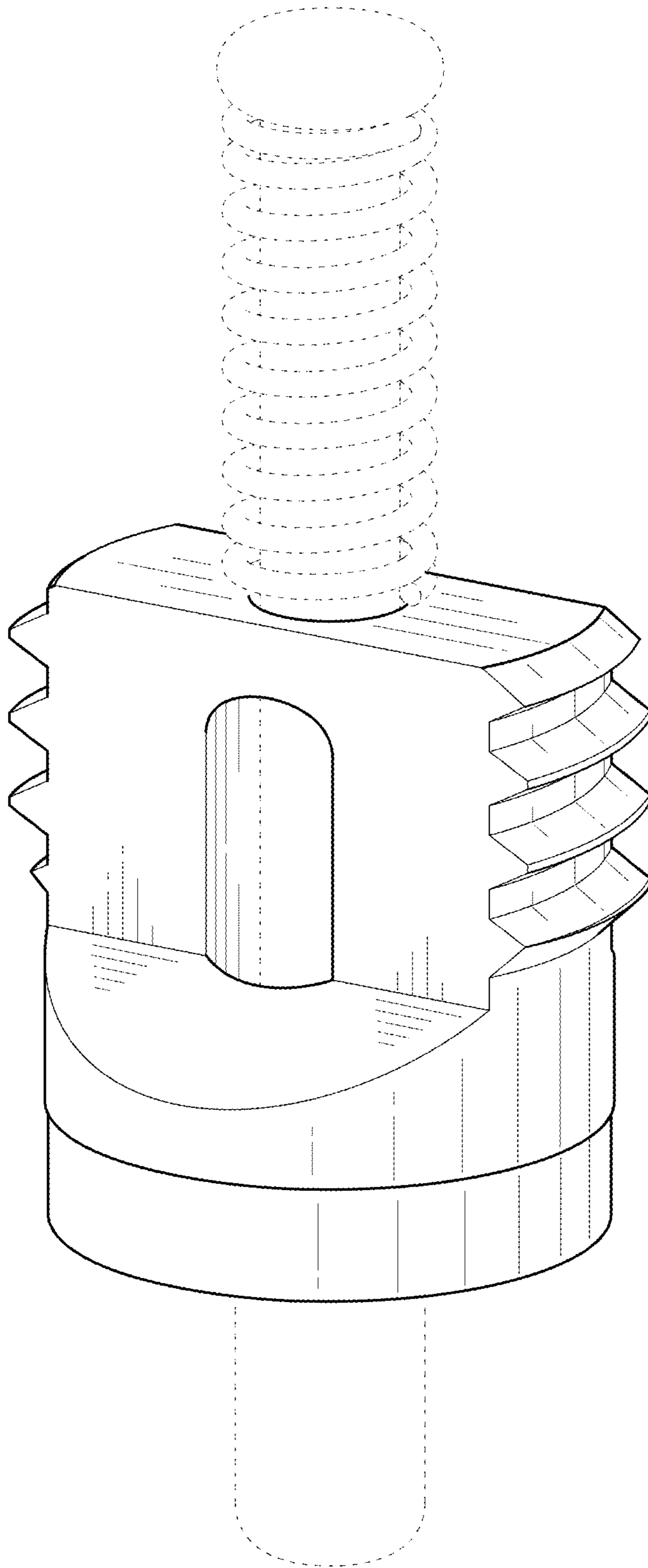

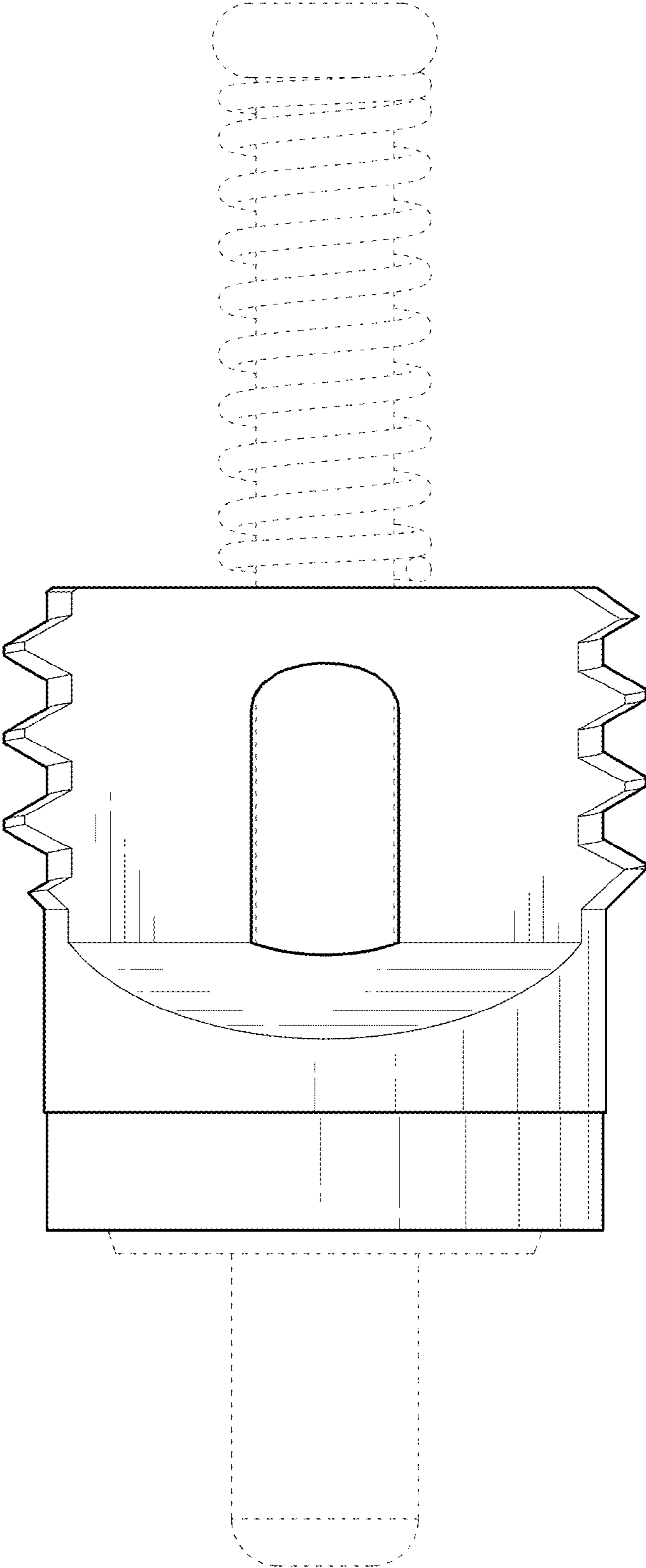

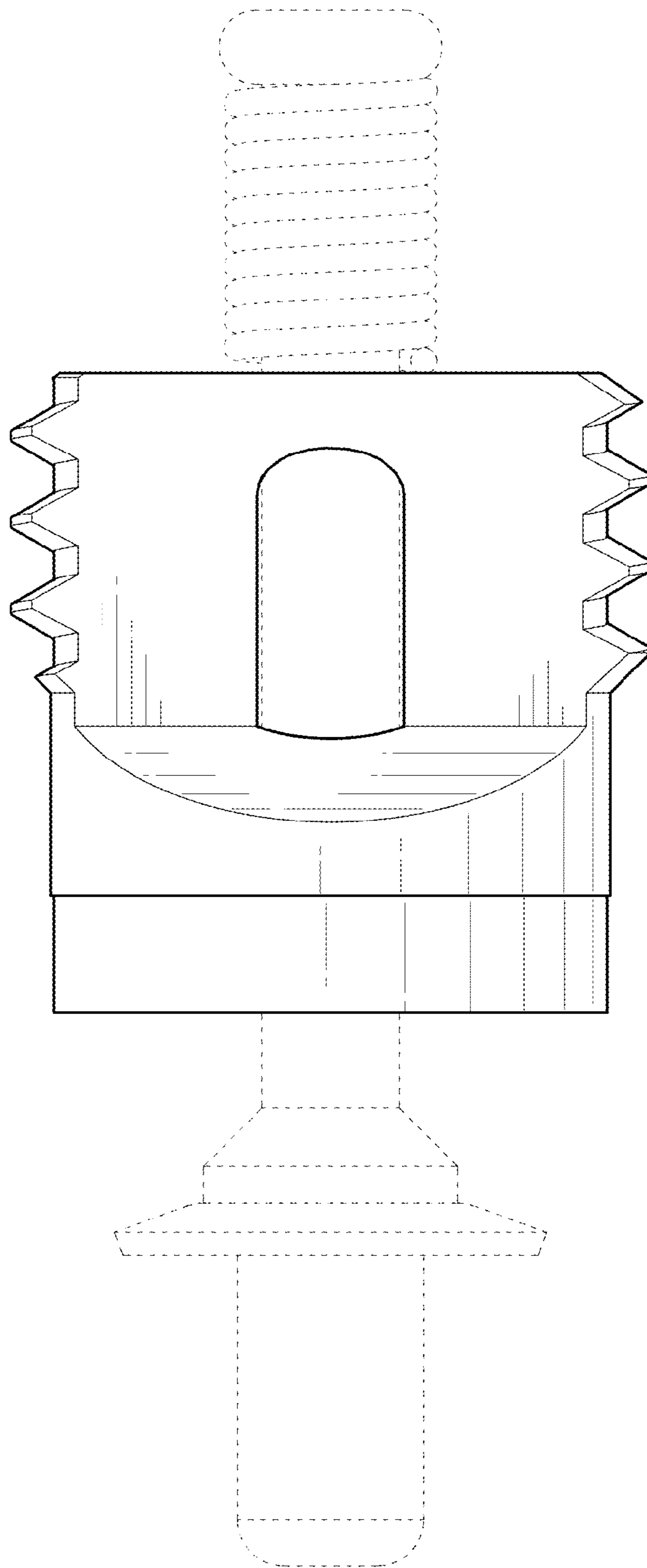
