(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image of the claimed design;

FIG. 2 is a second image thereof;

FIG. 3 is a third image thereof;

FIG. 4 is a fourth image thereof;

FIG. 5 is a front view of another embodiment of a display screen or portion thereof with animated graphical user interface showing a first image of the claimed design;

FIG. 6 is a second image thereof;

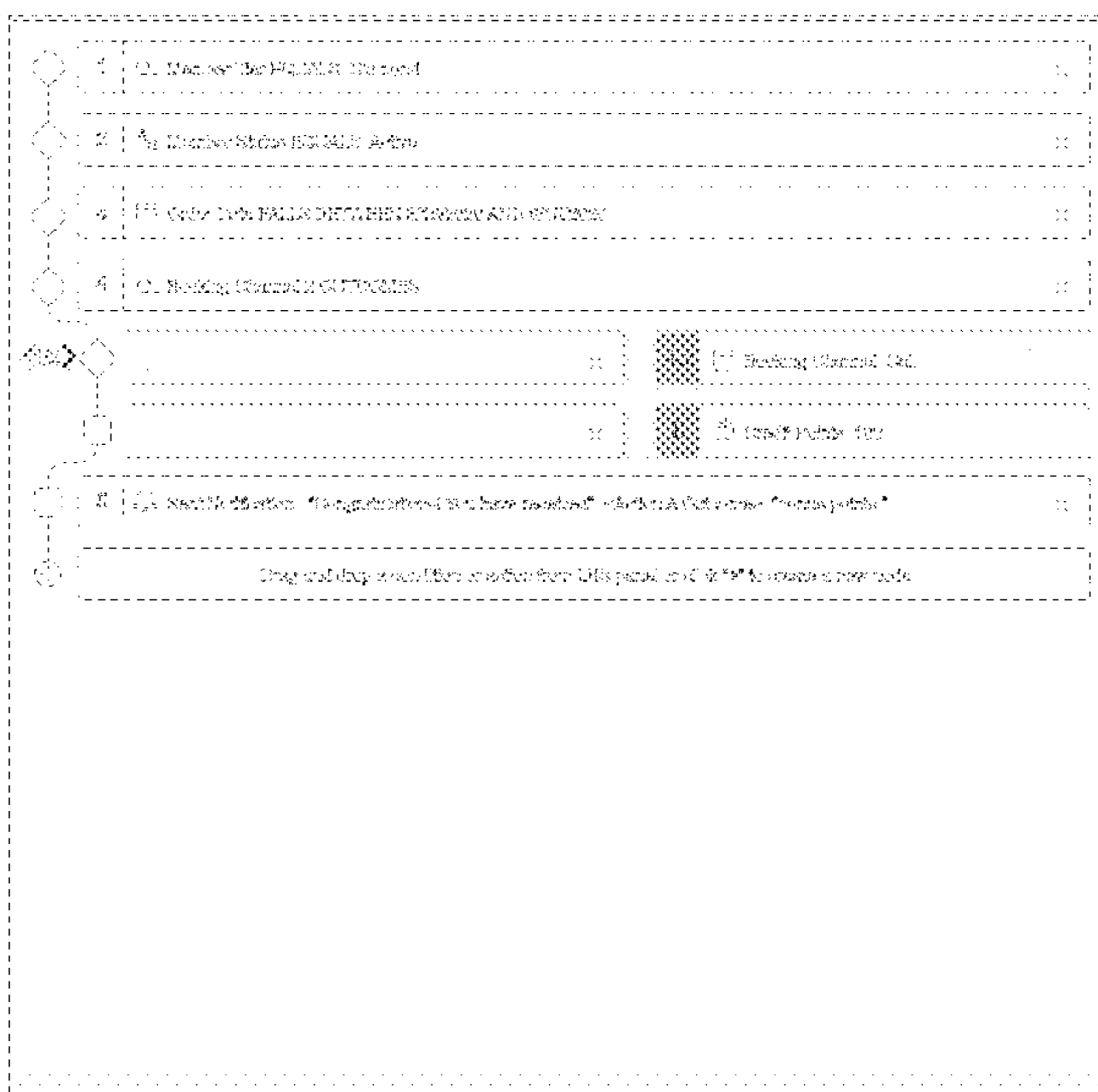
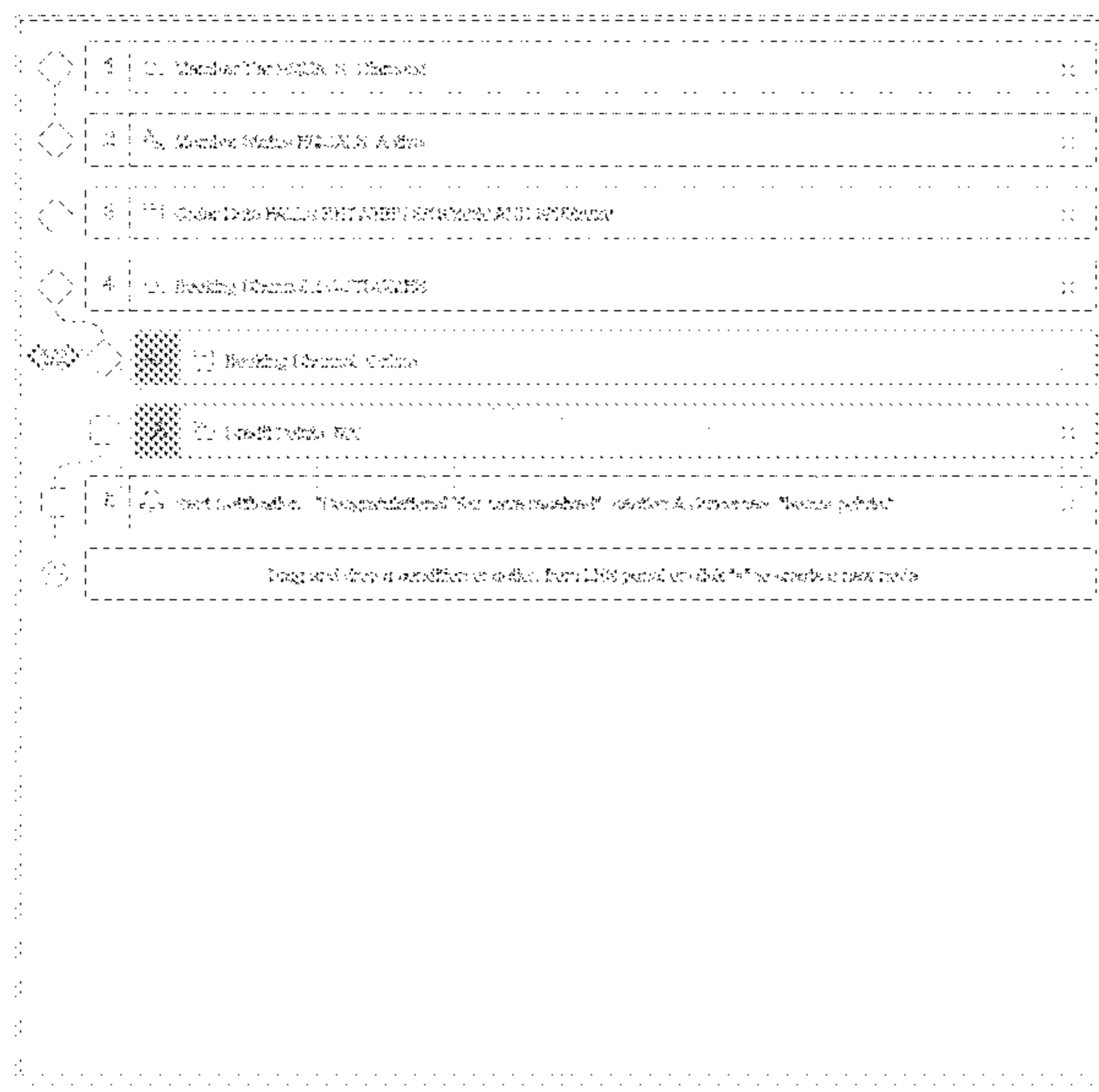
FIG. 7 is a third image thereof; and,

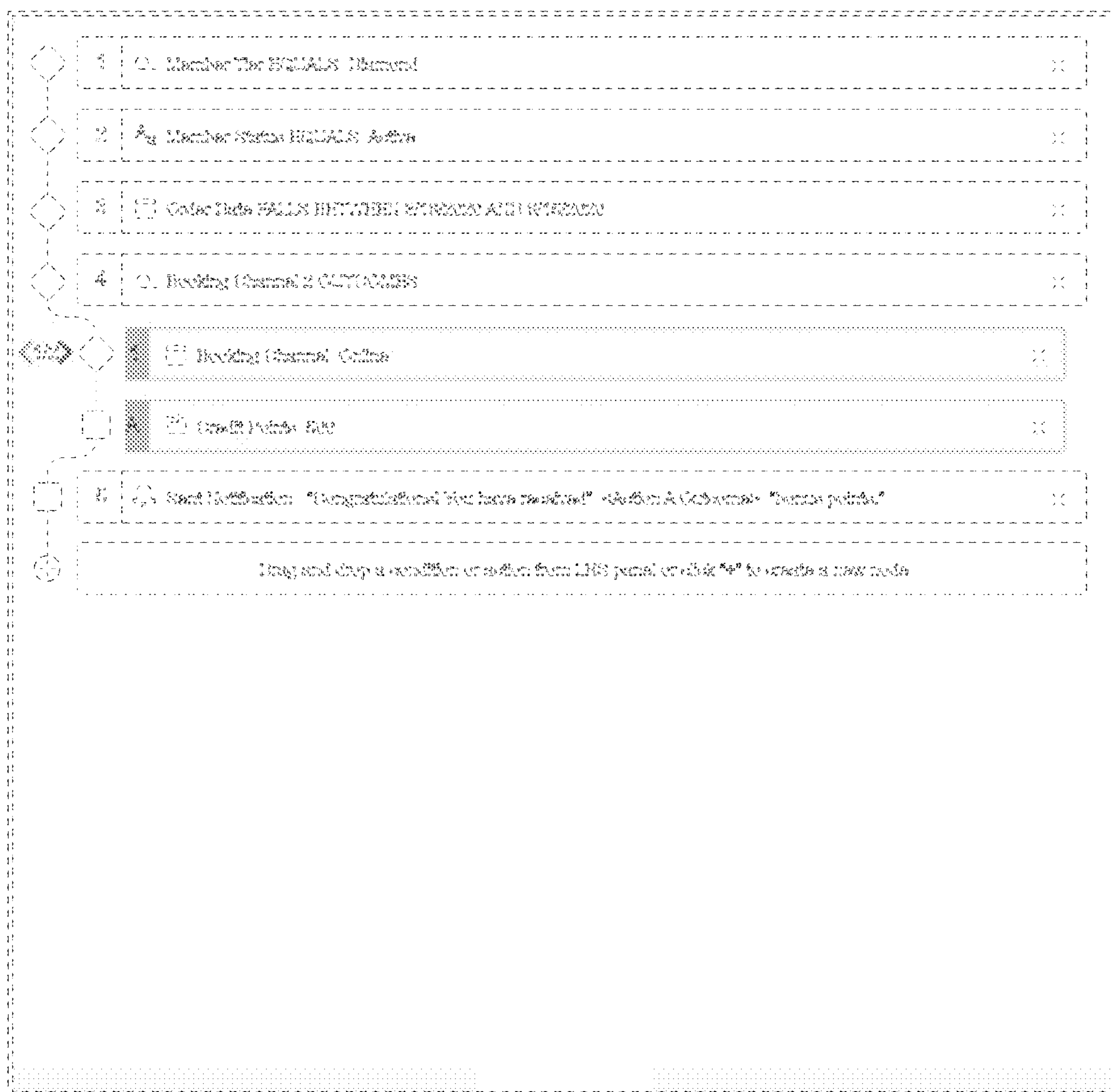

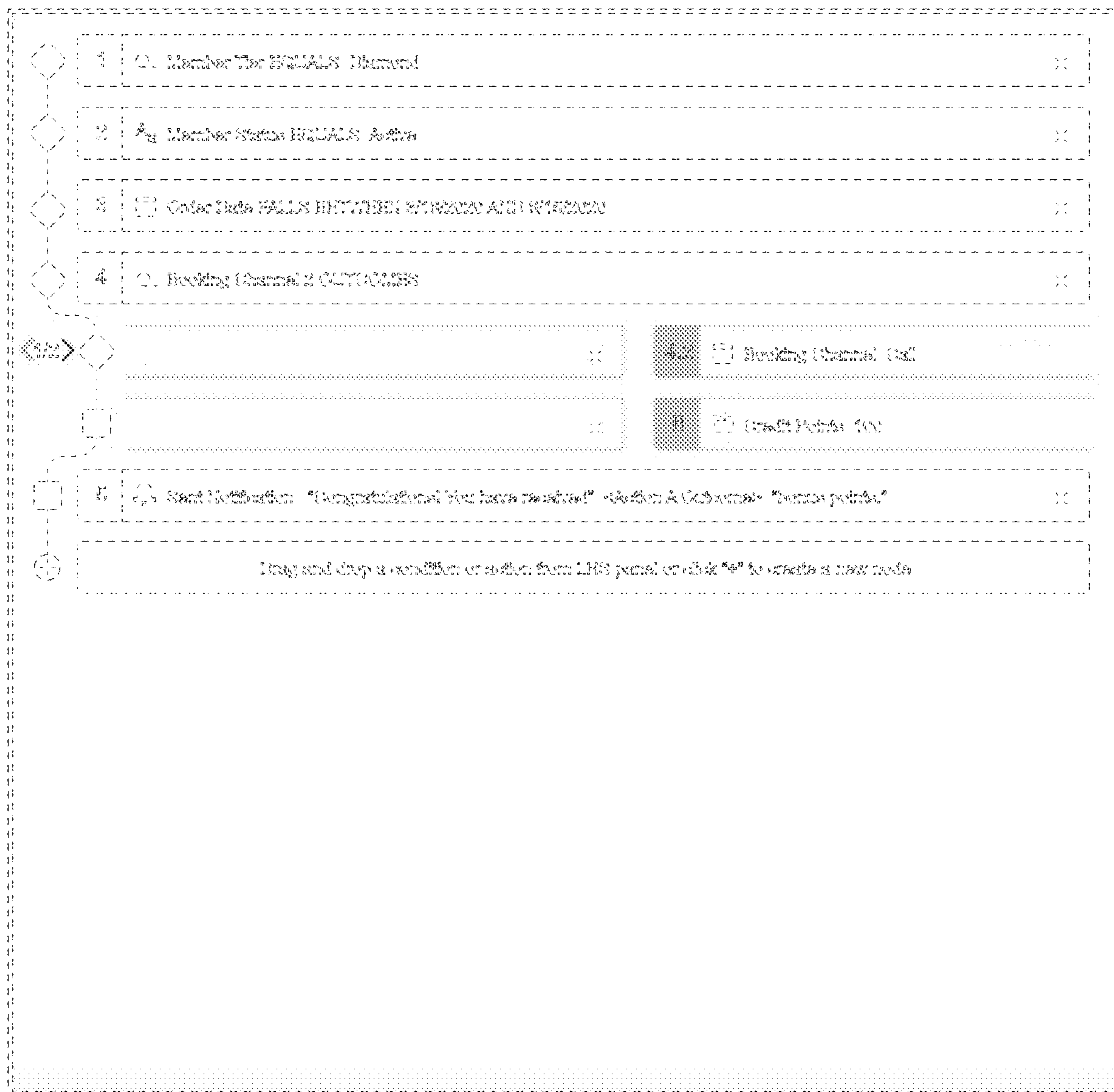

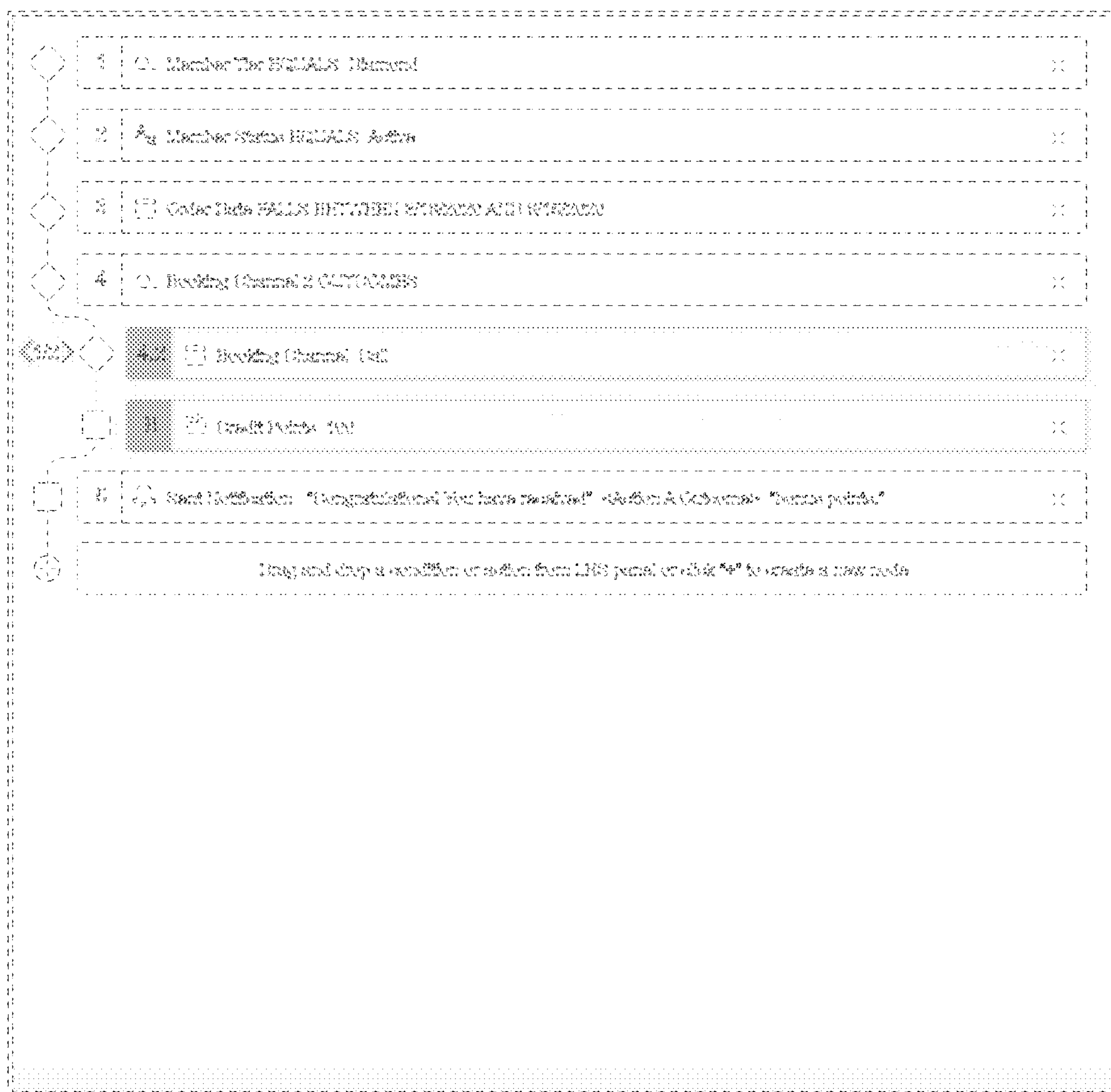

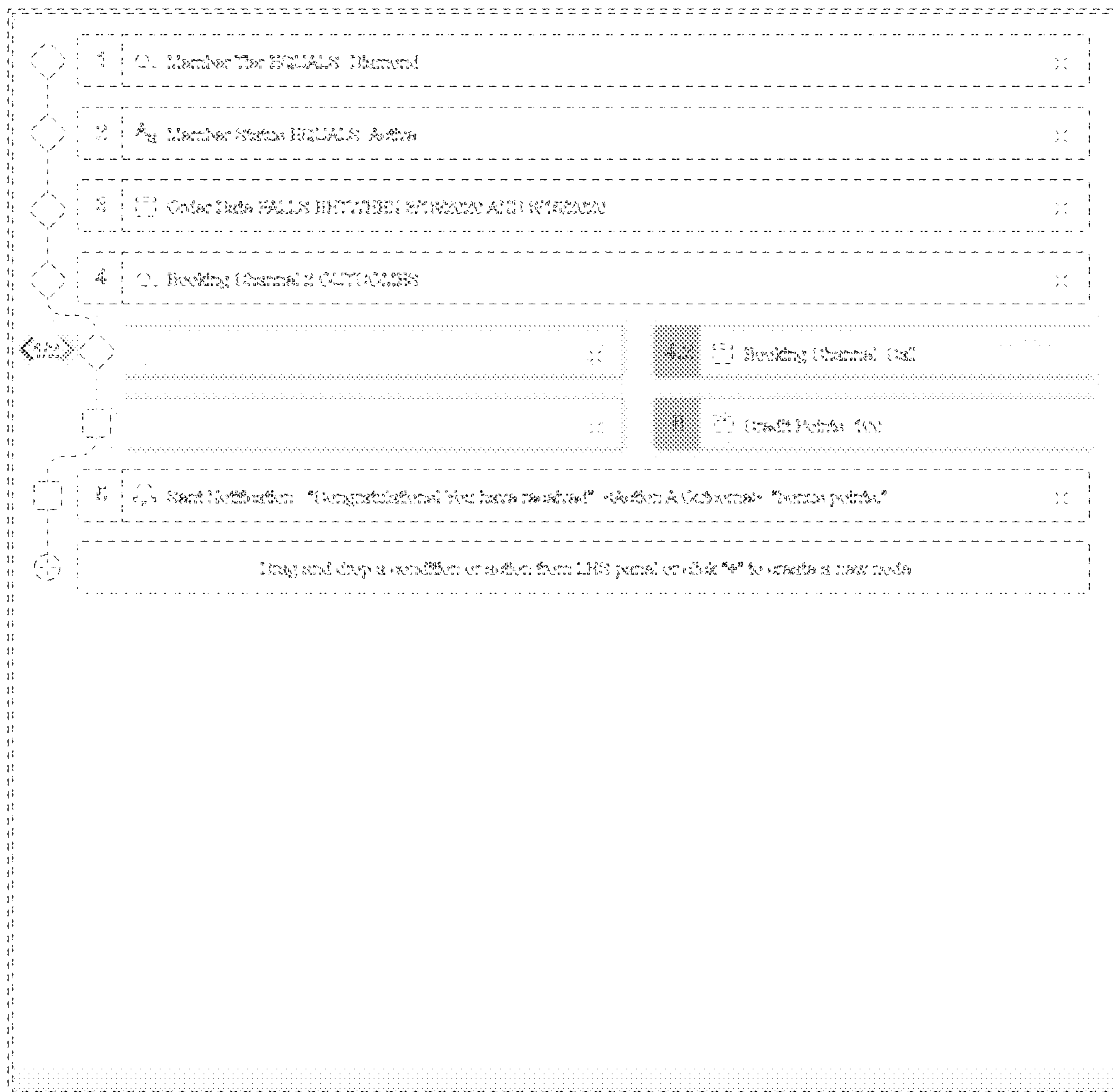

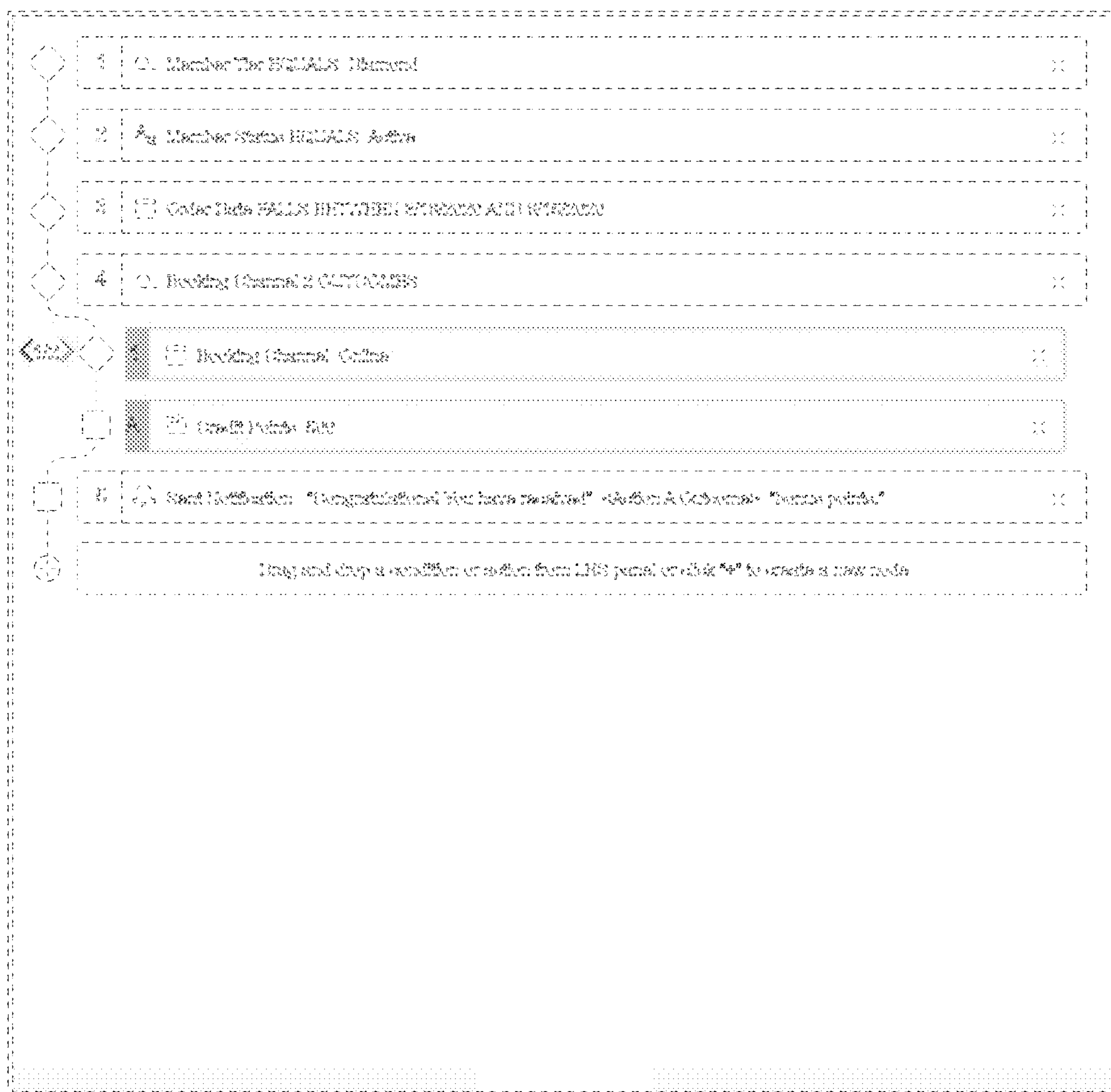
