(57) **CLAIM**

The ornamental design for a tape guide part for spot welding machine, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tape guide part for spot welding machine according to my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a perspective view of the tape guide part for spot welding machine according to my new design that is assembled in a welding machine for use.
The broken lines seen in FIG. 8 are for the purpose of showing environmental structure, and form no part of the claimed design.

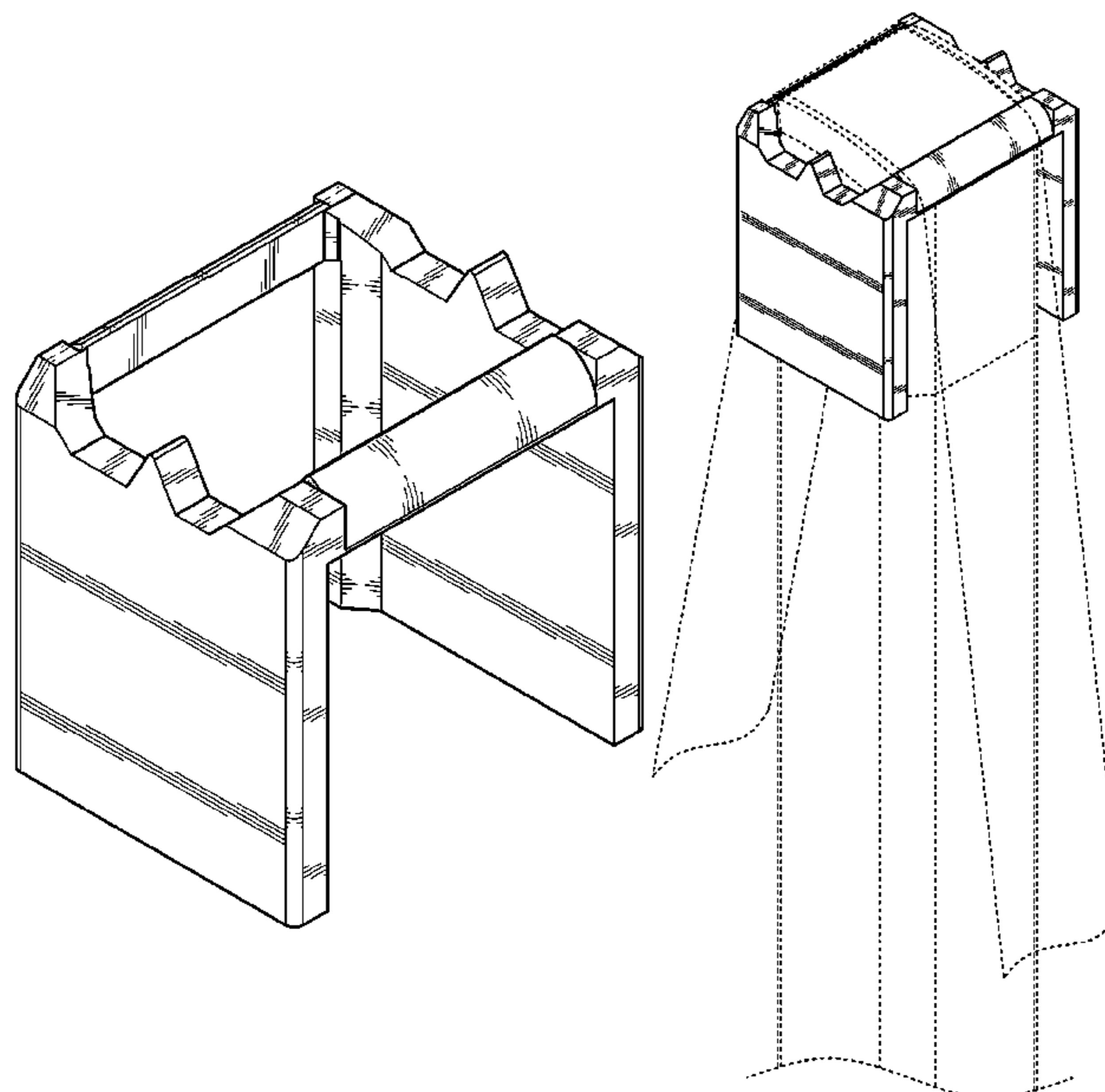

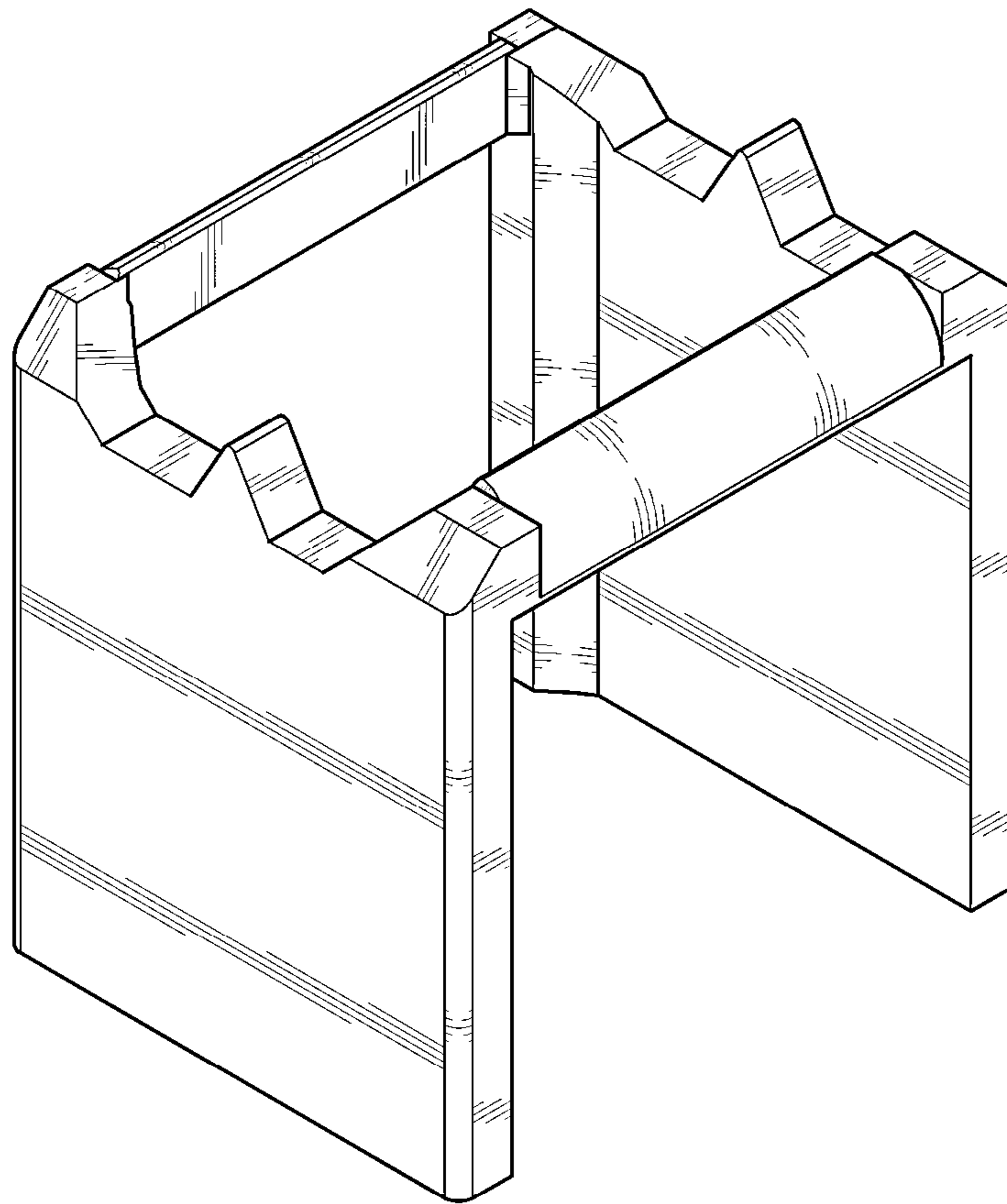

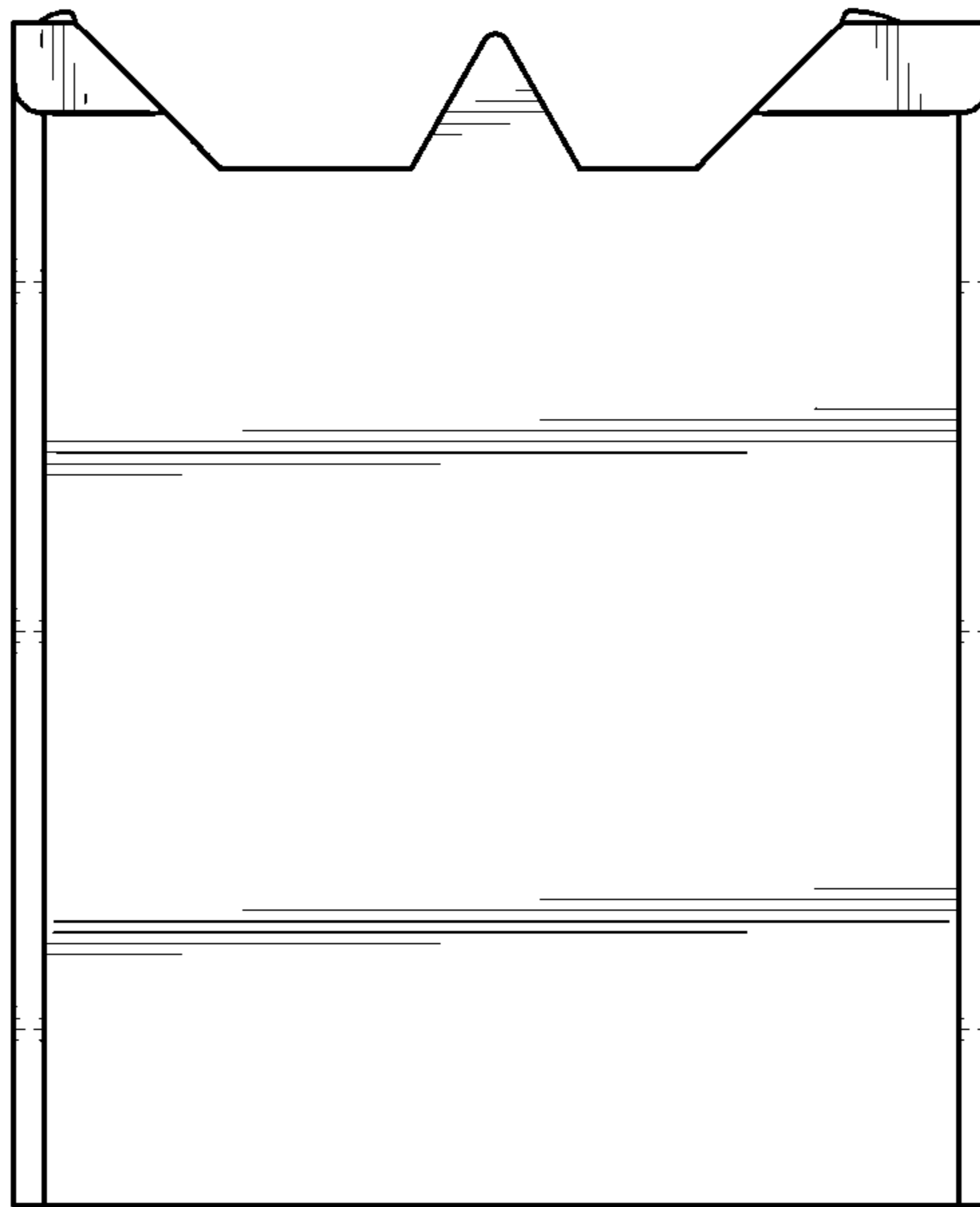

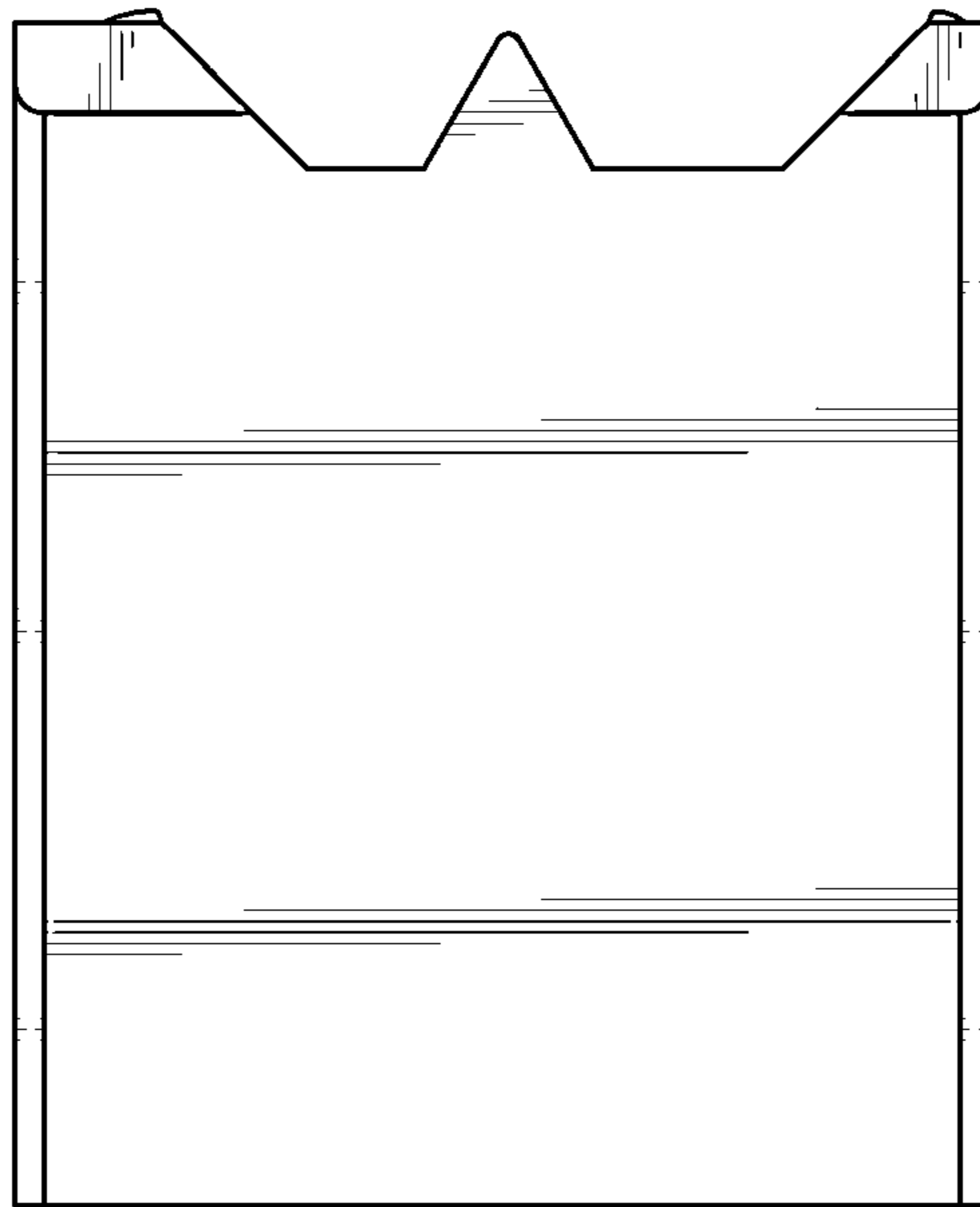

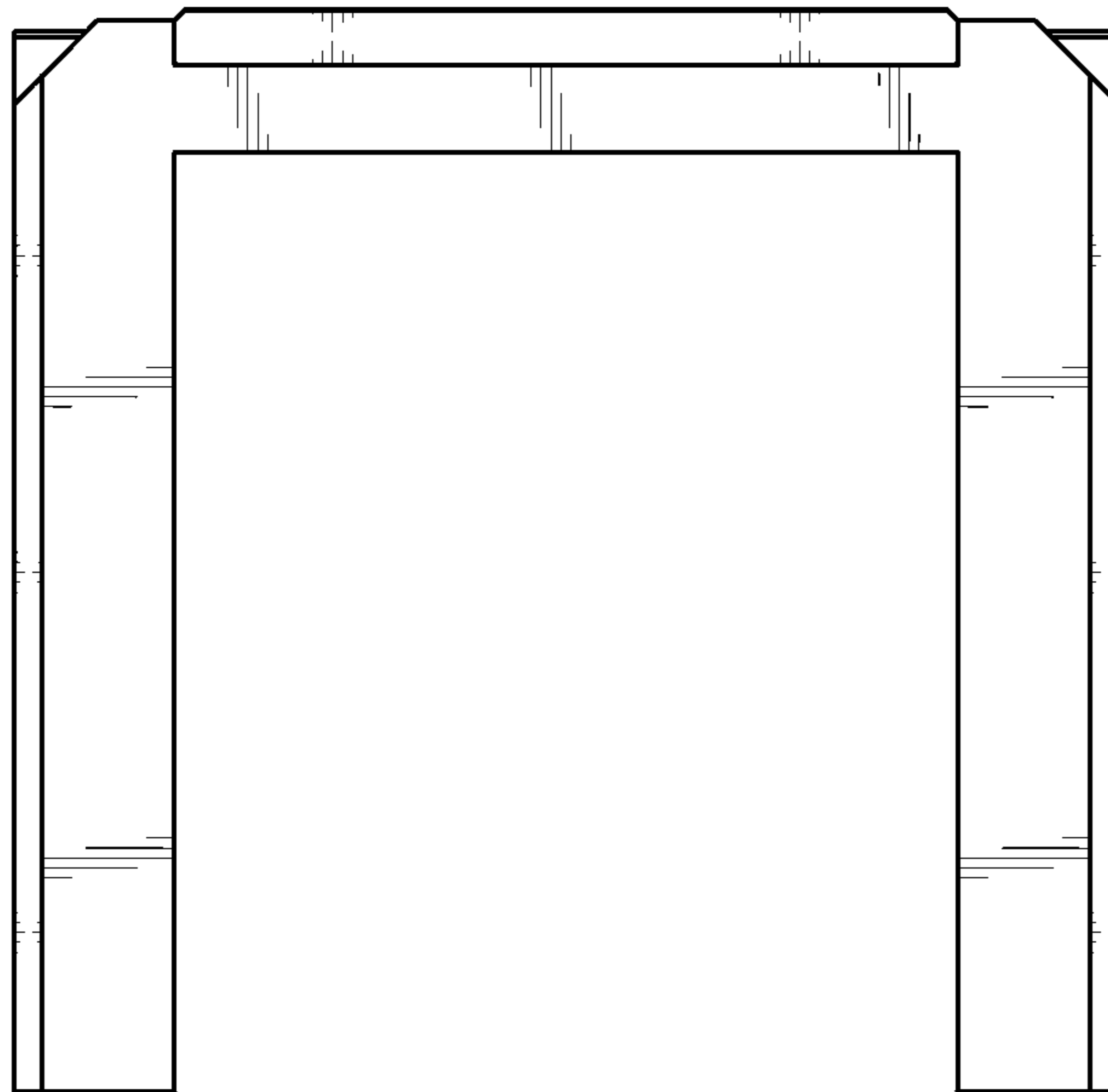

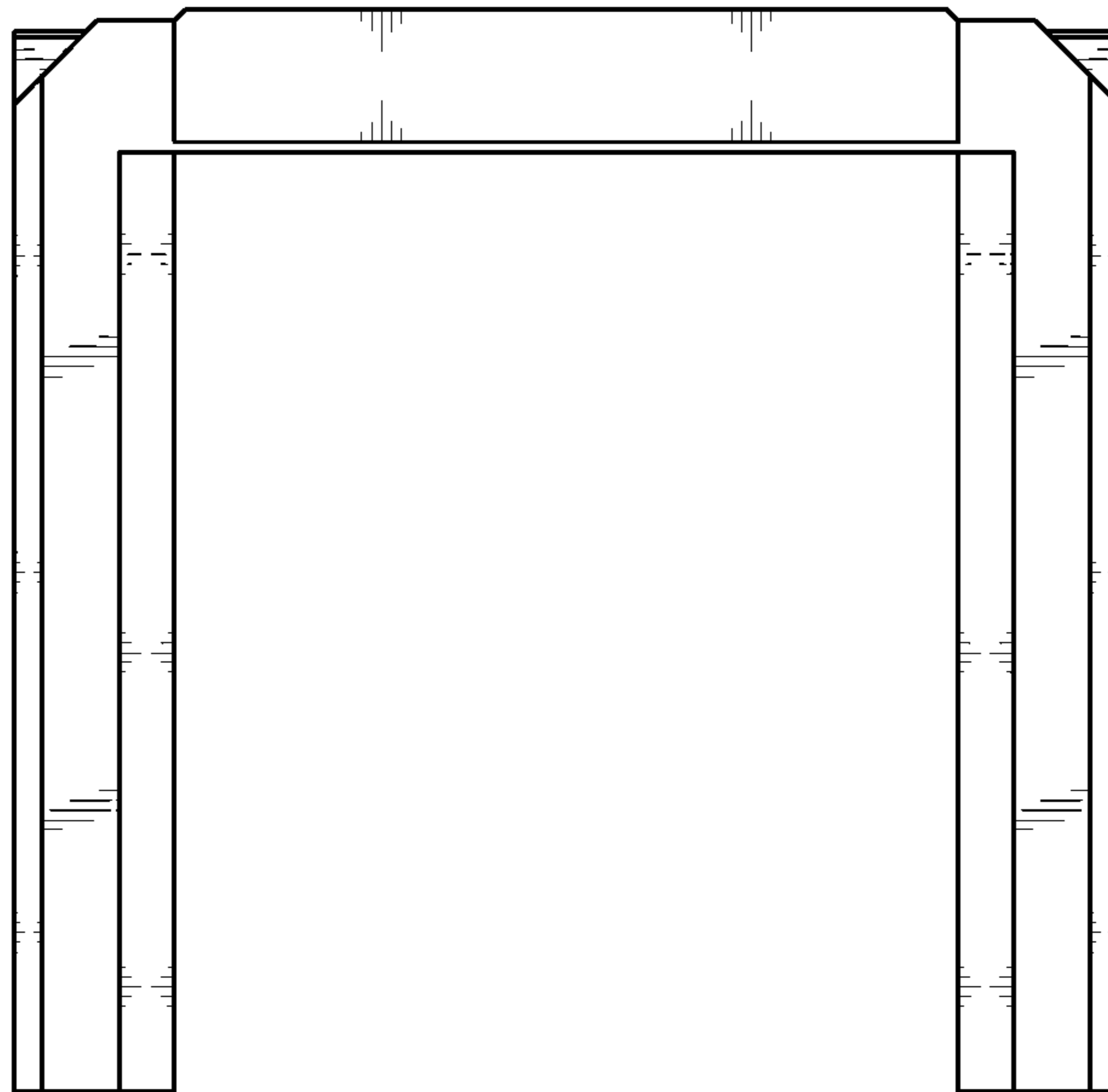

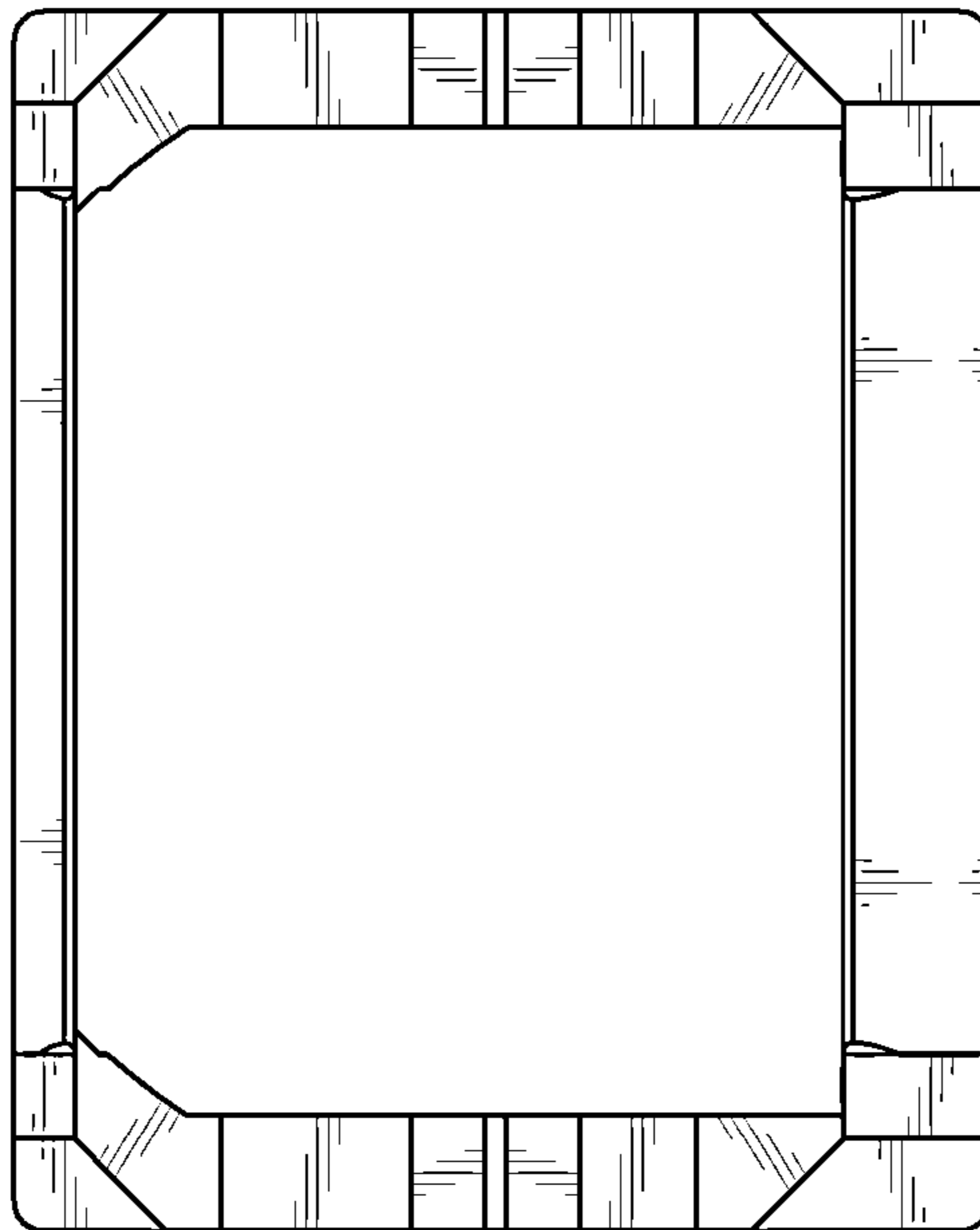

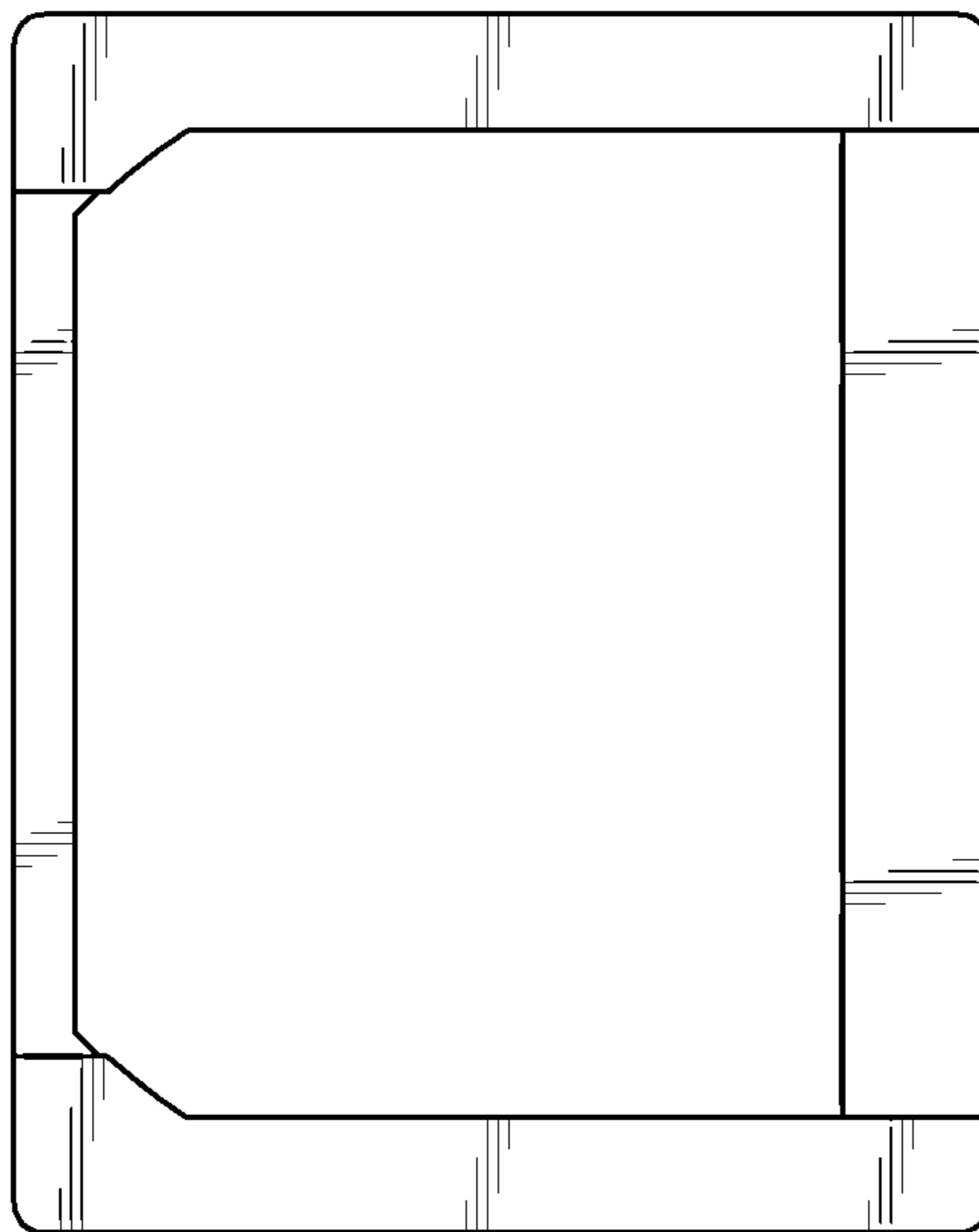
