DESCRIPTION

FIG. 1 is a front, right, upper perspective view of a camera of the present invention showing front, right and top sides of the camera;

FIG. 2 is a front, left, lower perspective view showing front, left and bottom sides of the camera;

FIG. 3 is a rear, left, lower perspective view showing rear, left and bottom sides of the camera;

FIG. 4 is a front elevation view of the front side of the camera;

FIG. 5 is a left elevation view of the left side of the camera;

FIG. 6 is a right elevation view of the right side of the camera; and,

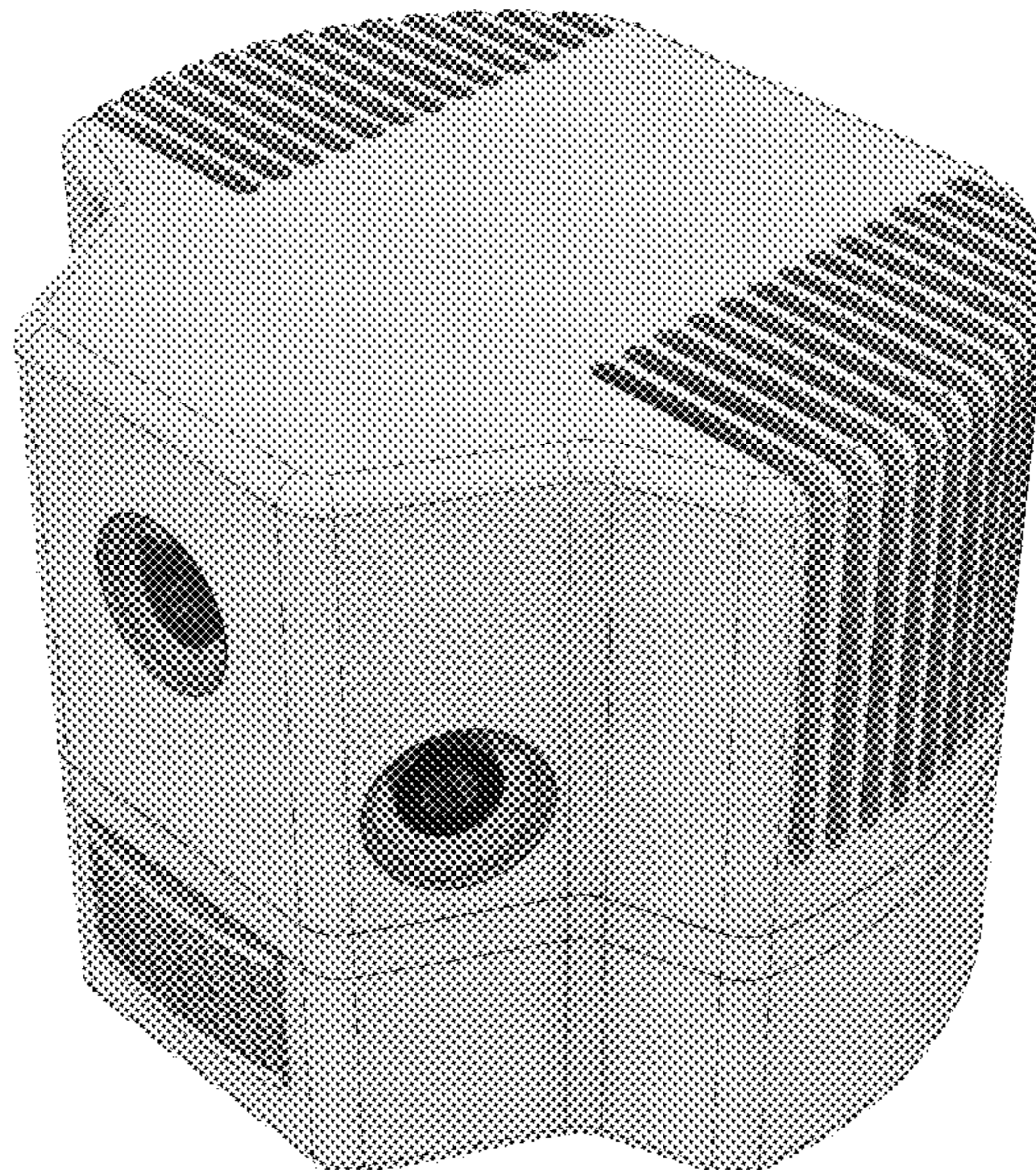
FIG. 7 is a top plan view of a top side of the camera.

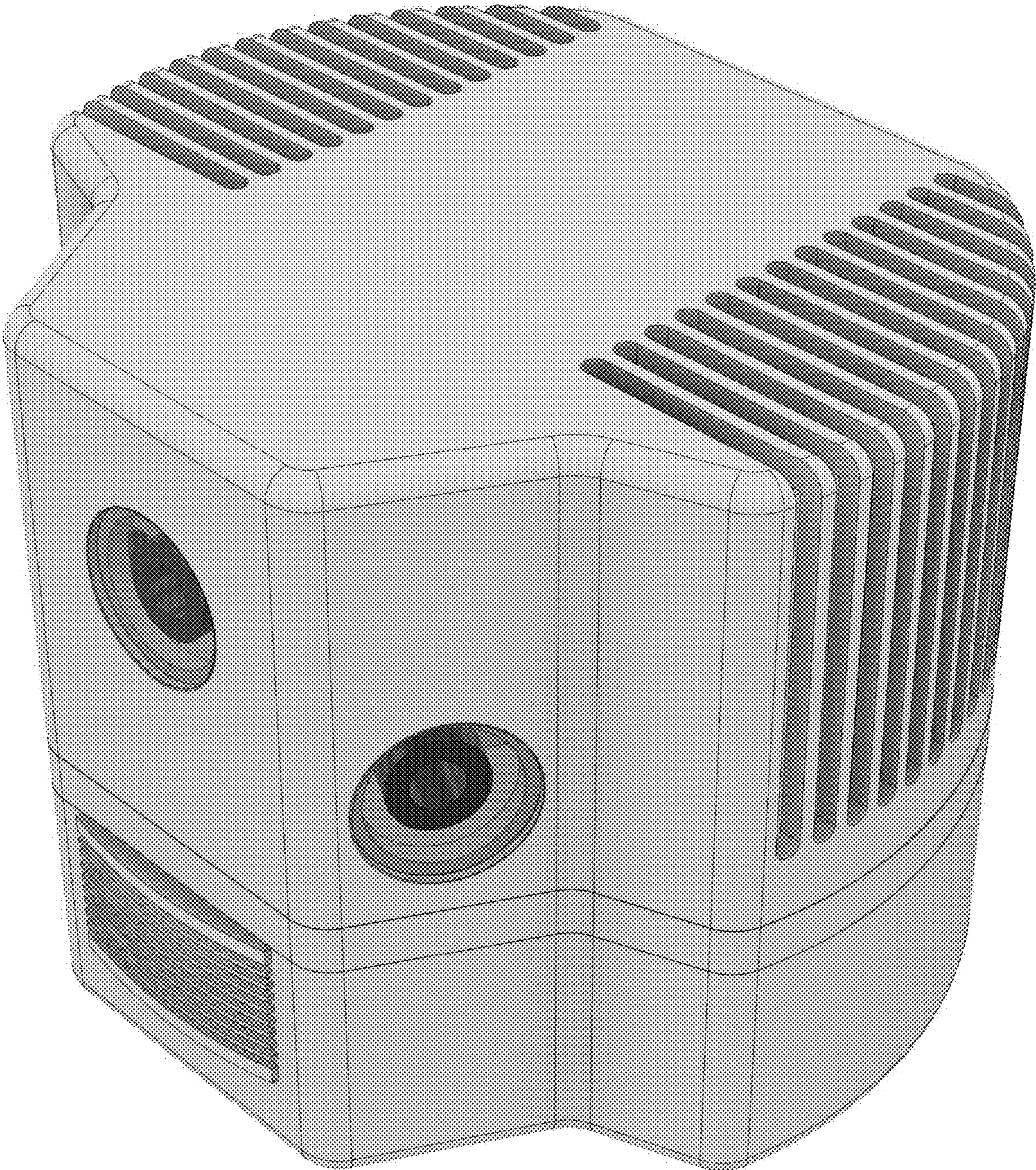

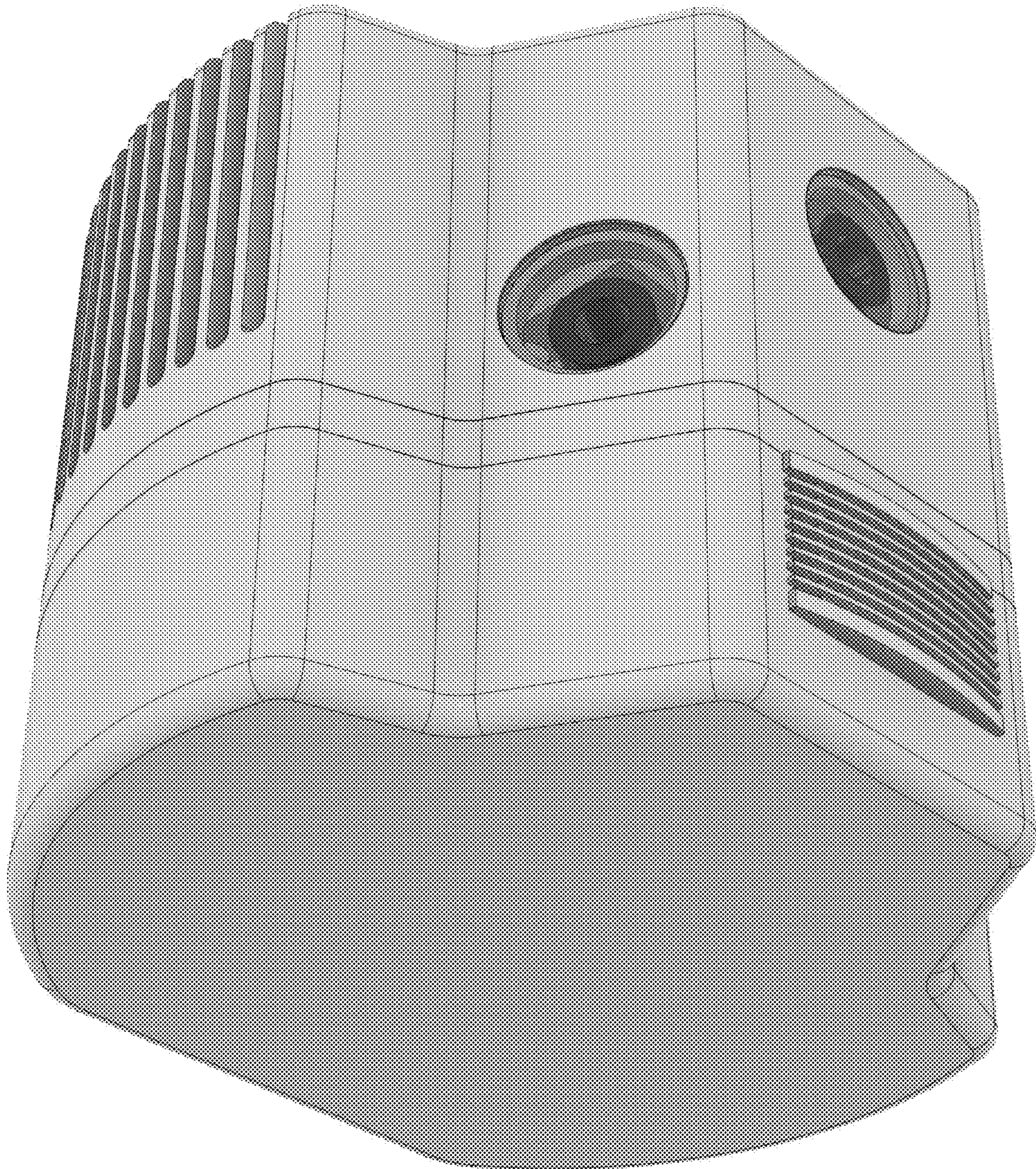

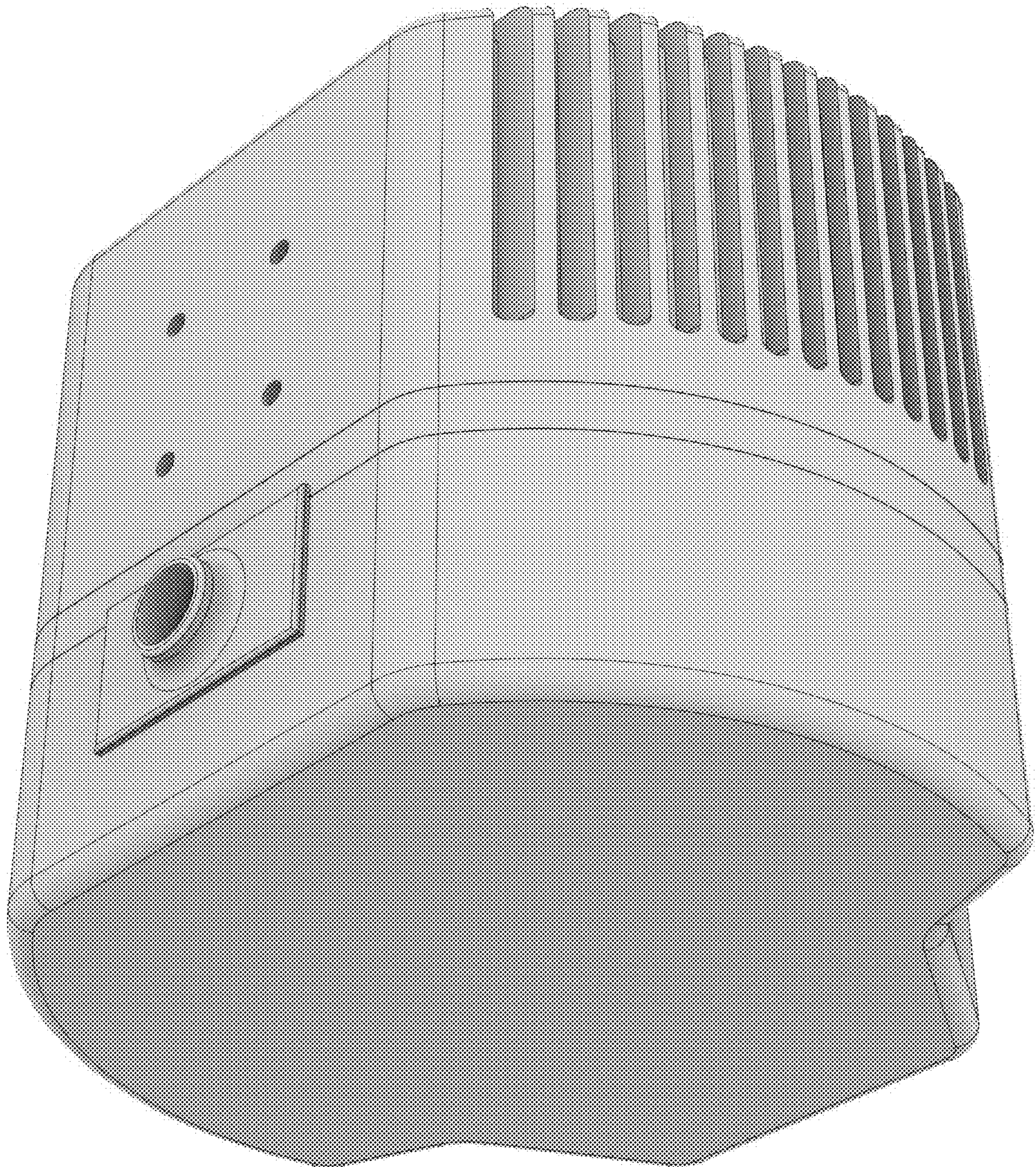

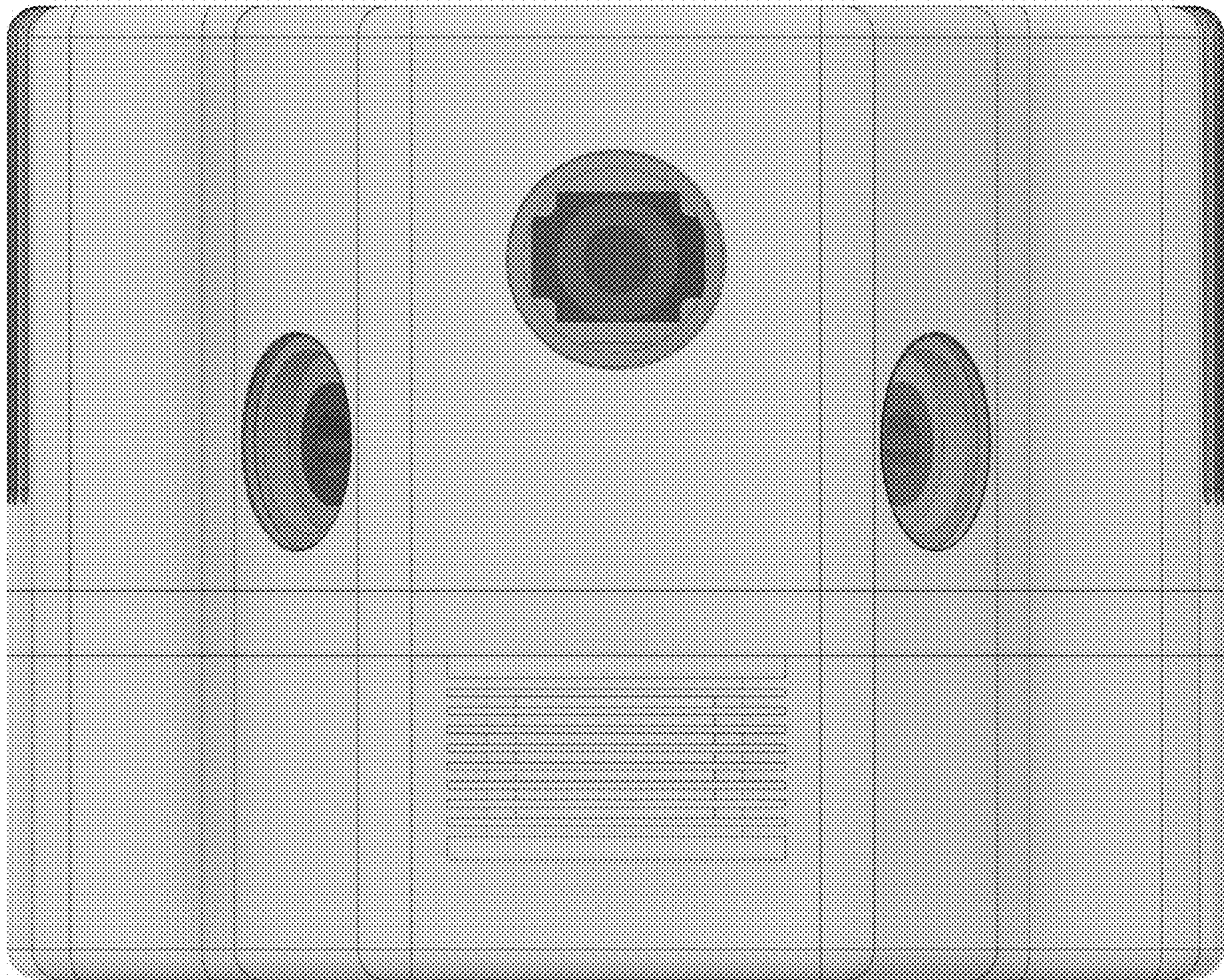

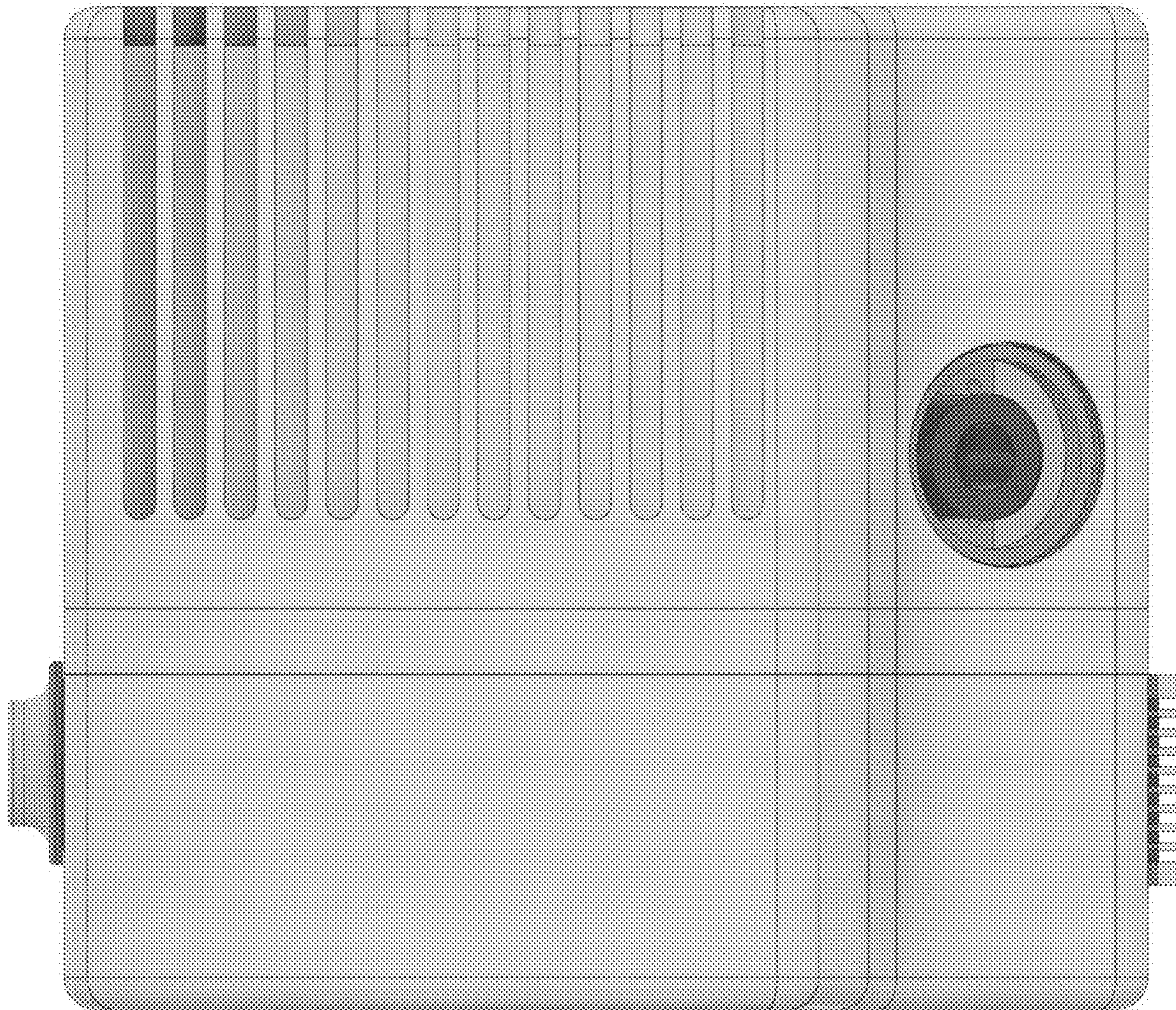

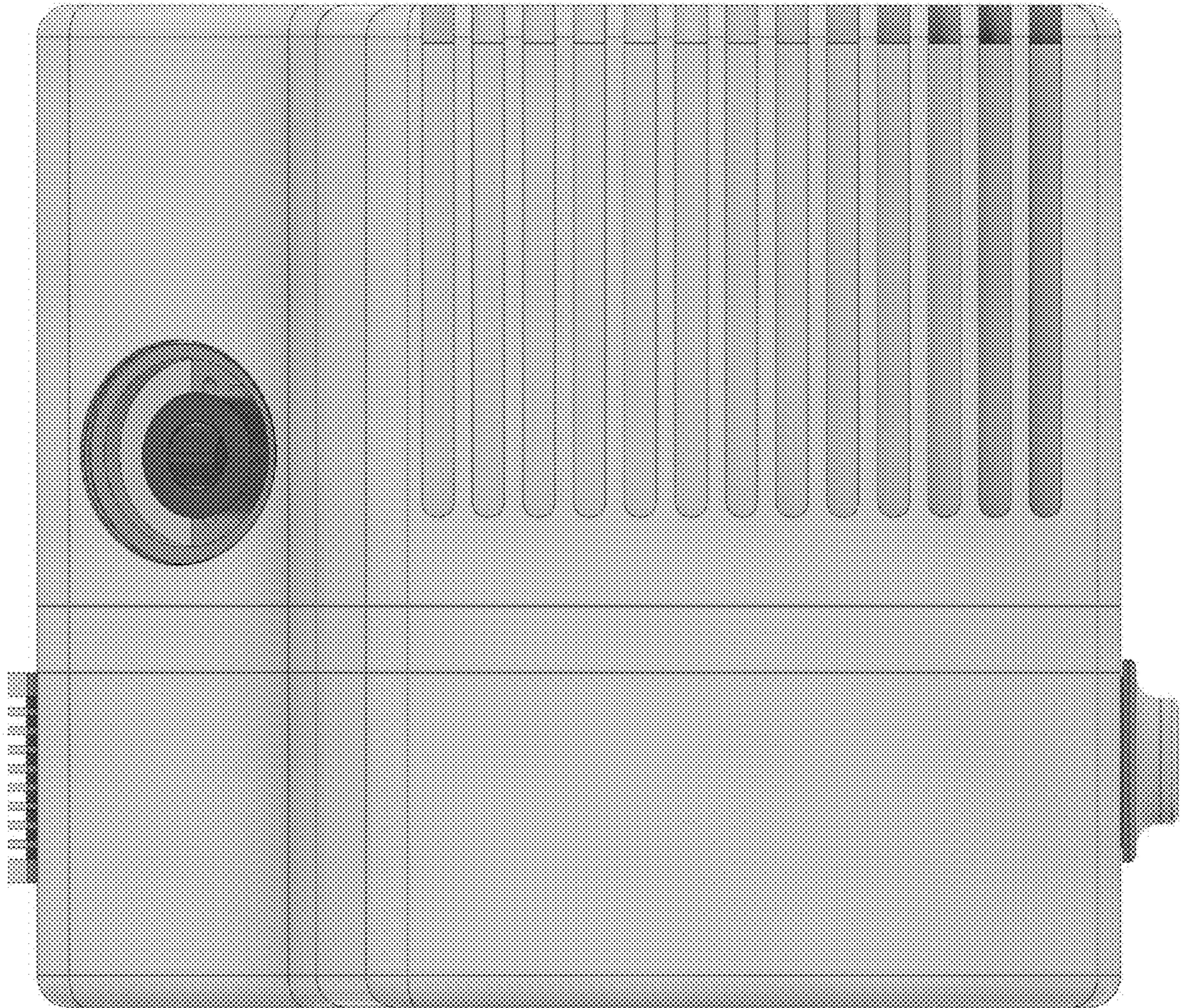

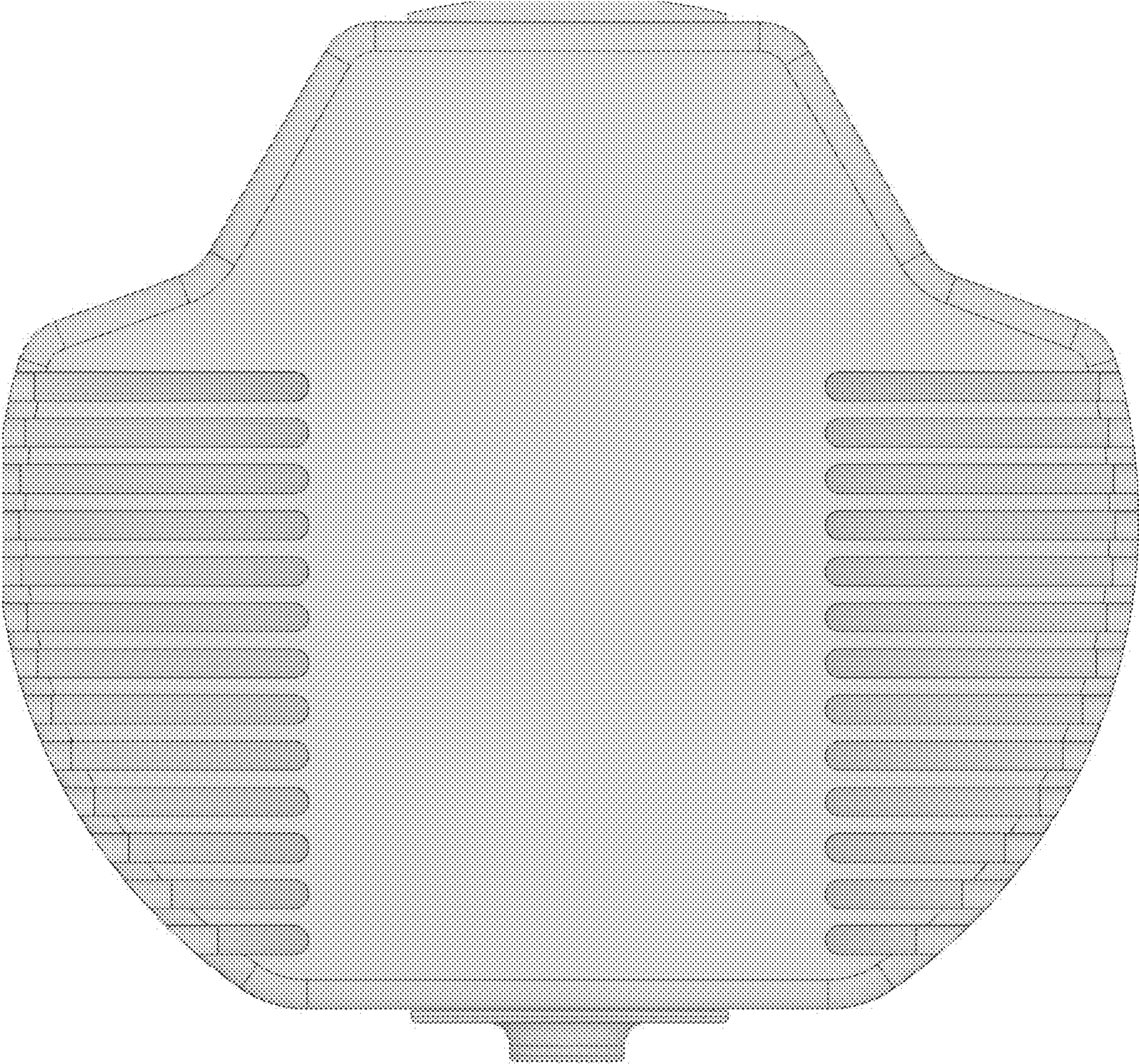
