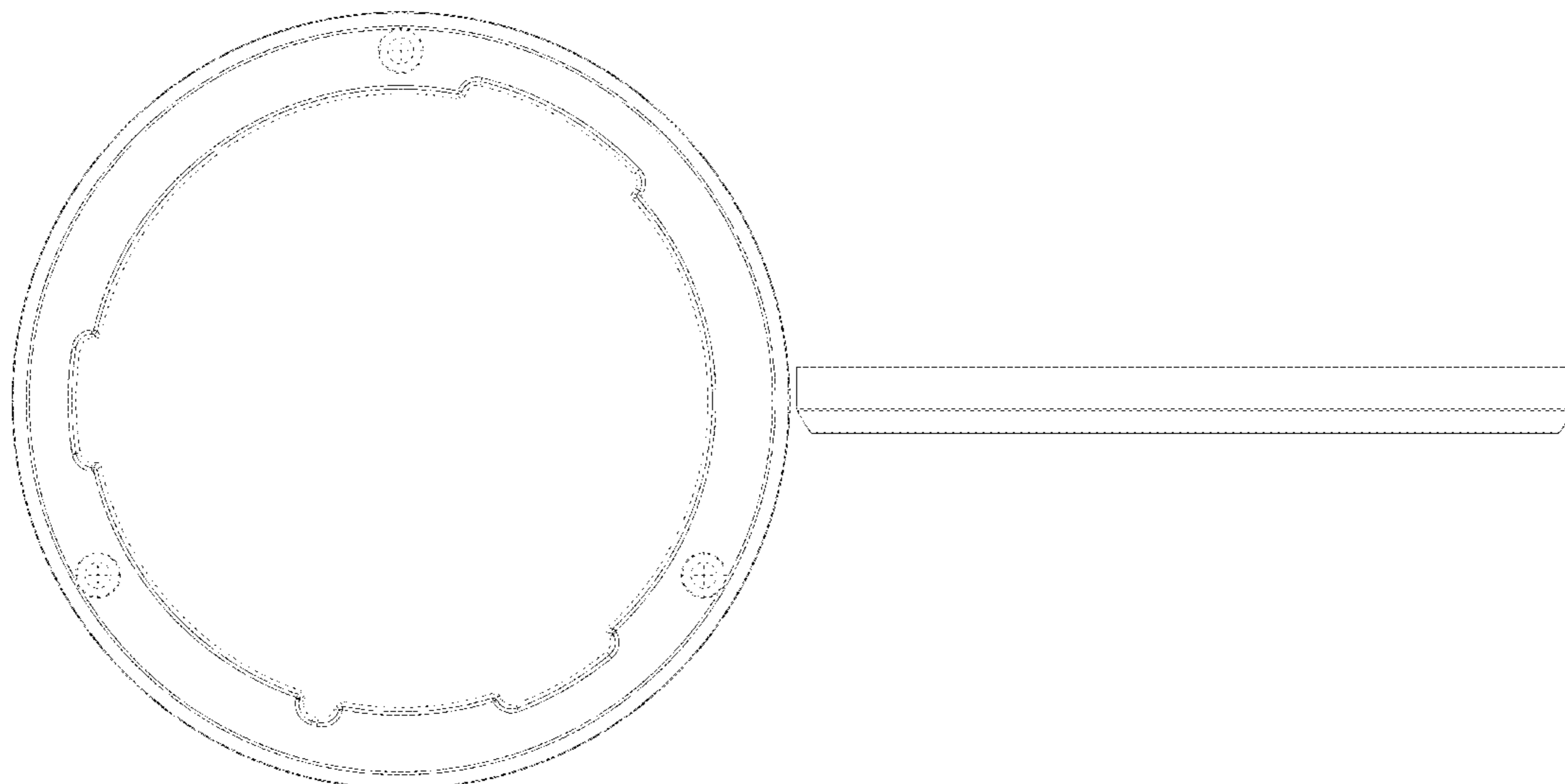
(57) **CLAIM**

We claim the ornamental design for a headlight, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper front view of a headlight according to our new design;  
FIG. 2 is a top view thereof with the bottom view thereof being a mirror image of FIG. 2; and,  
FIG. 3 is a left-side view thereof with the right-side view thereof being a mirror image of FIG. 3.  
The broken lines illustrate portions of the headlight that form no part of the claimed design.

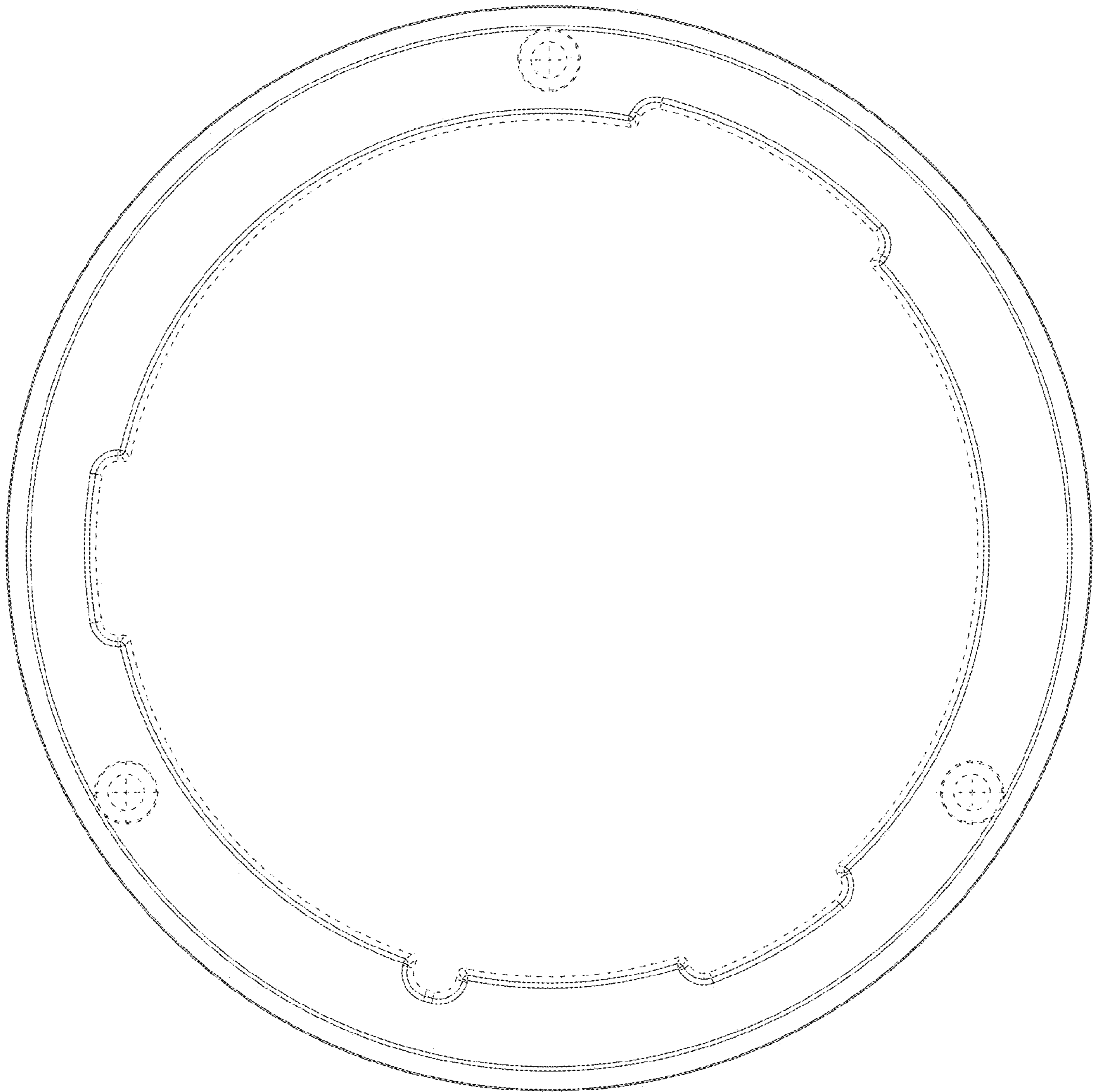

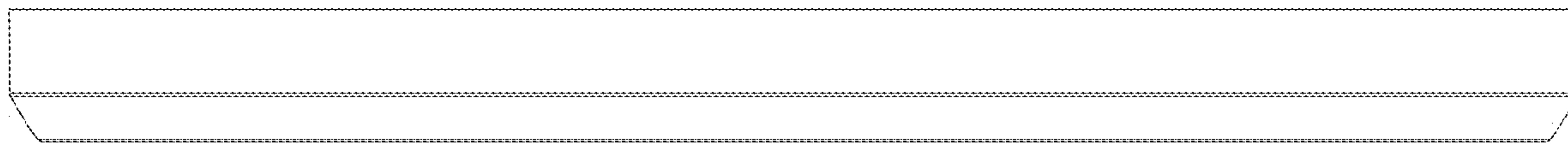

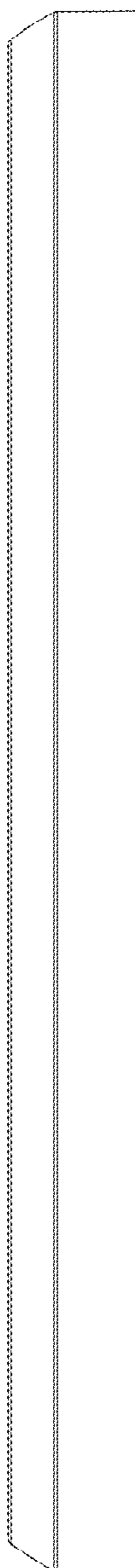
