FIG. 7 is a rear side view thereof.

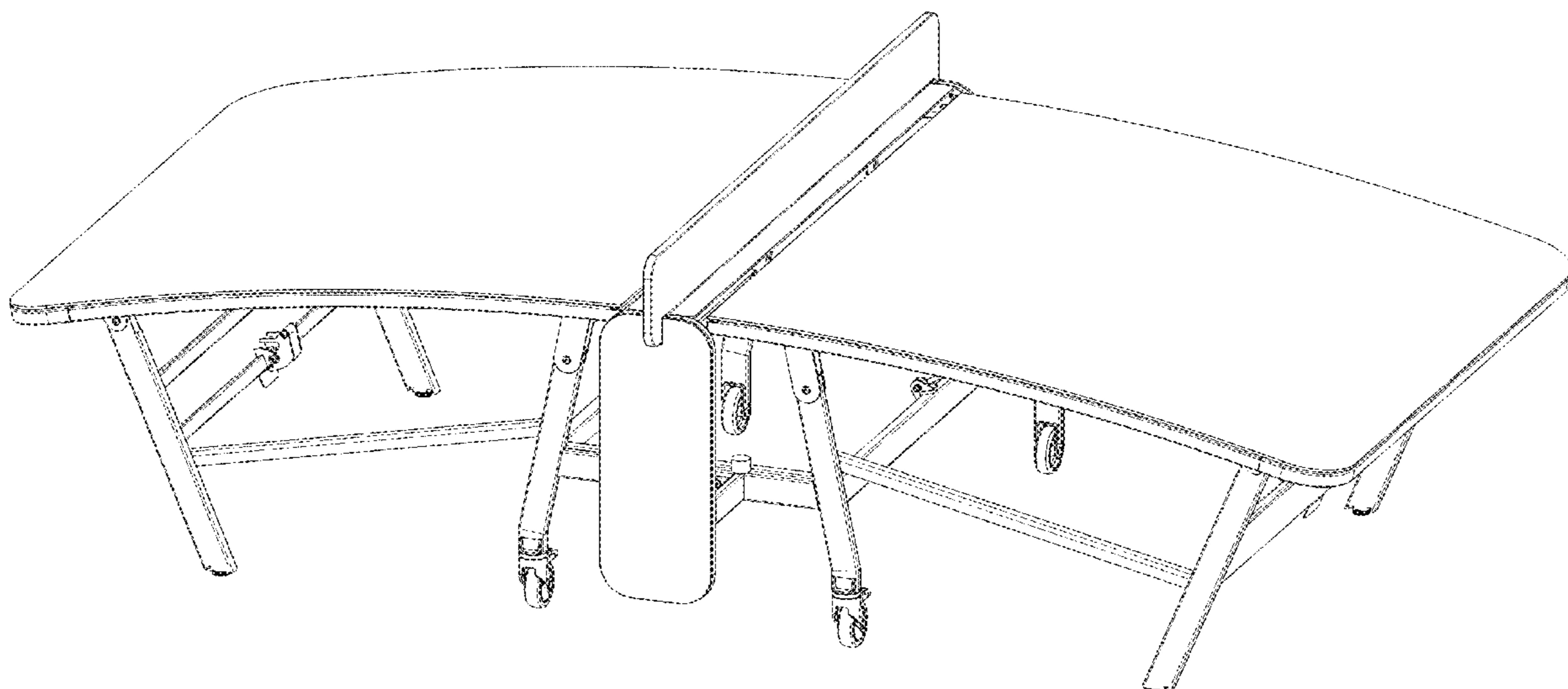

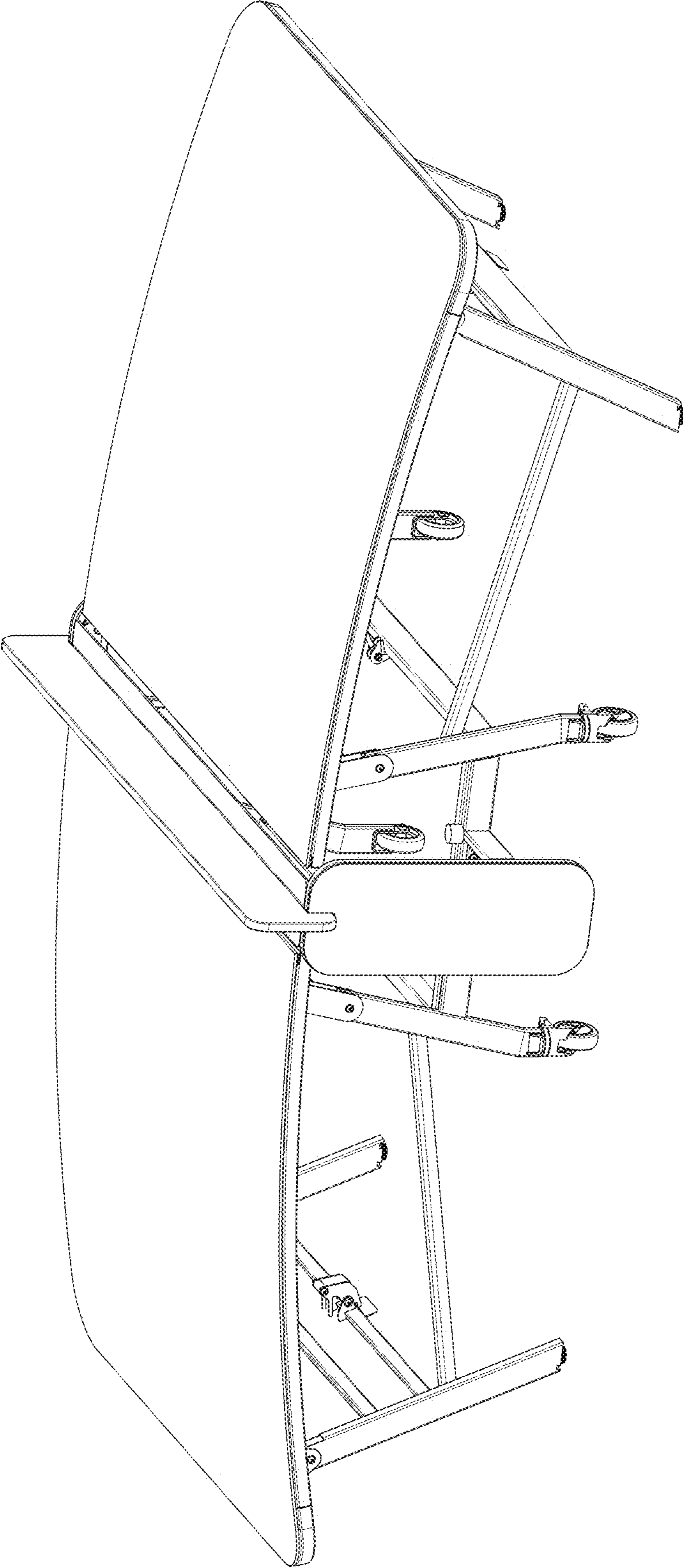

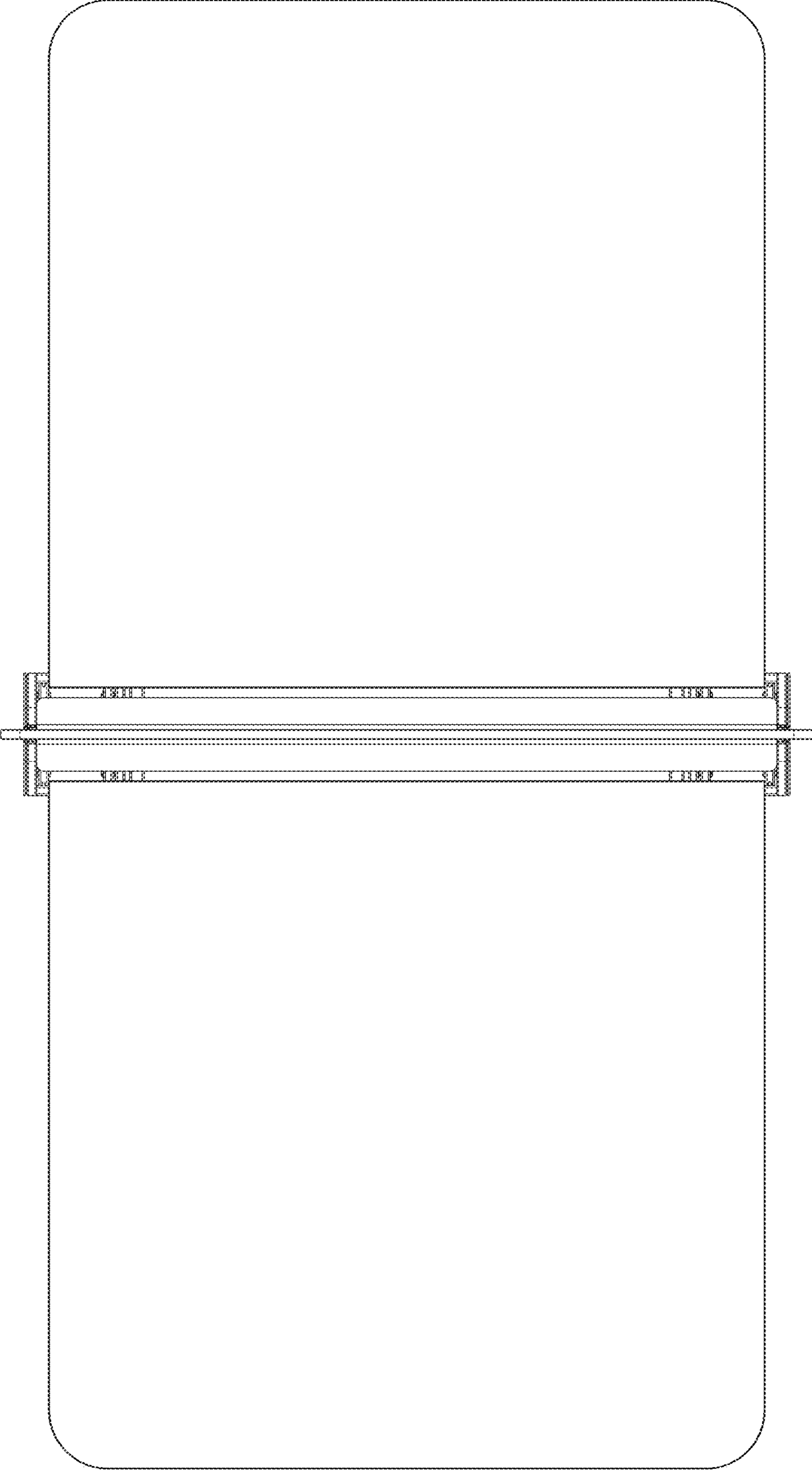

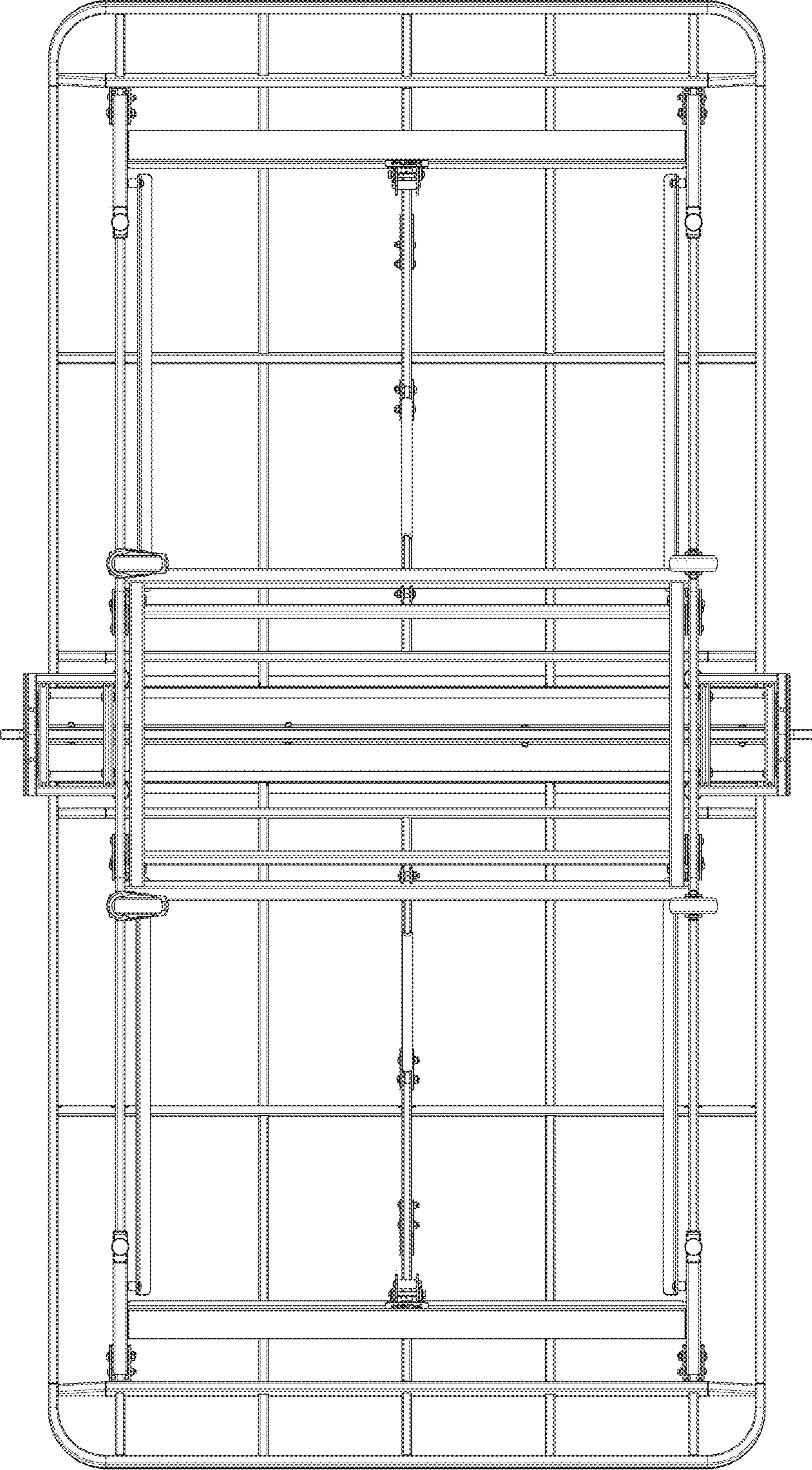

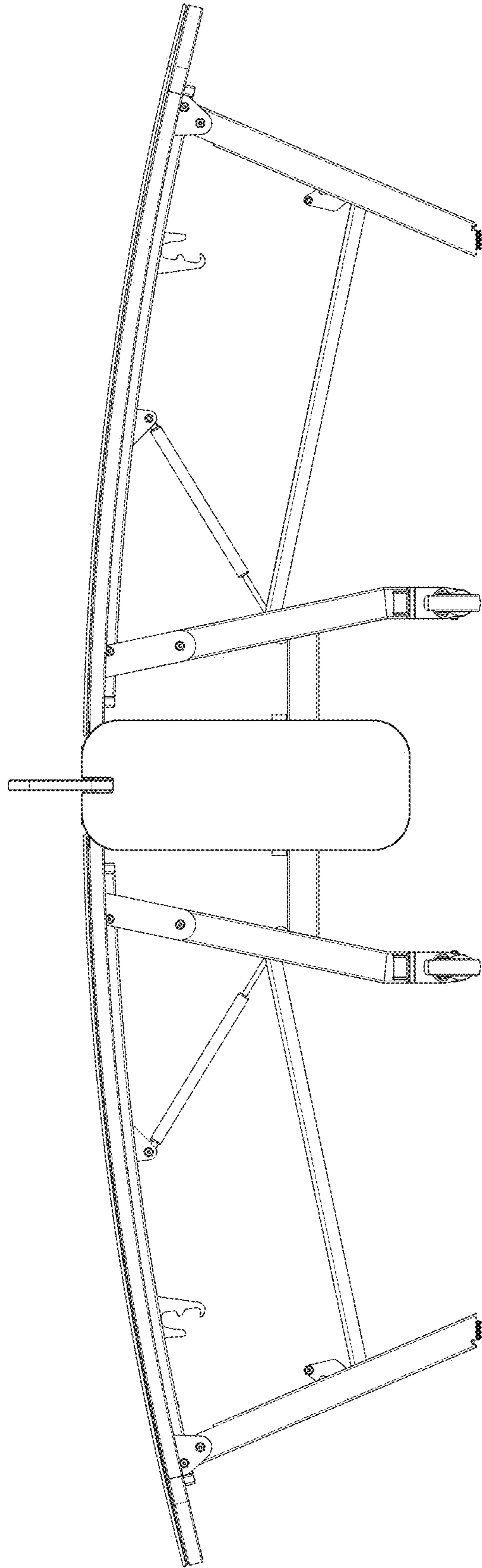

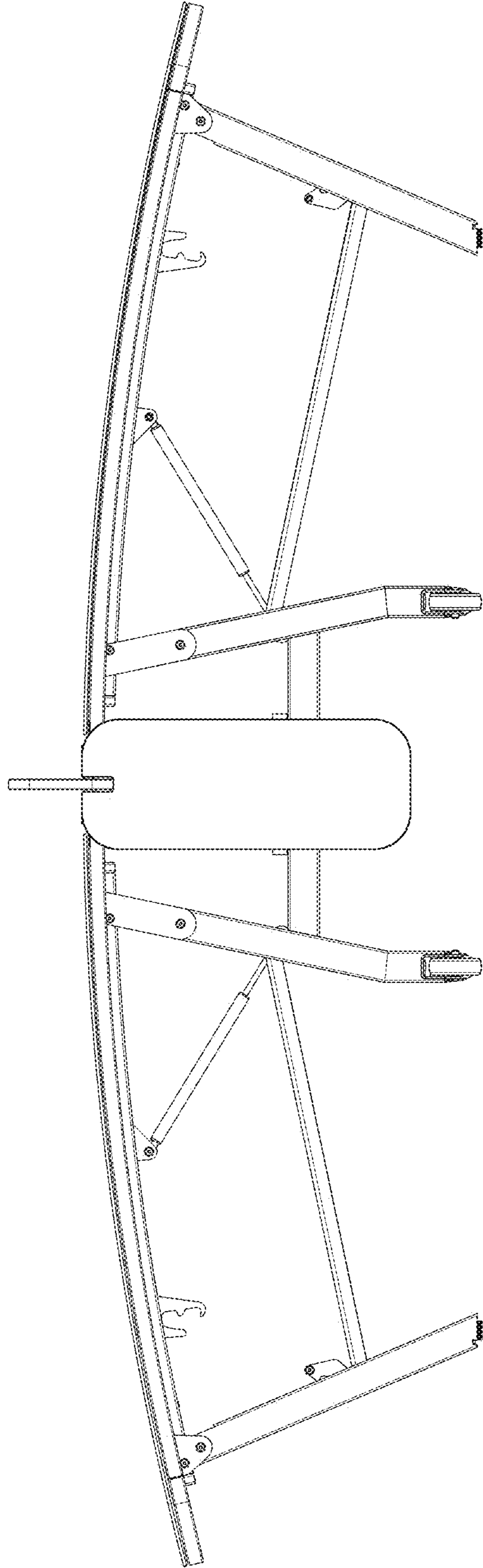

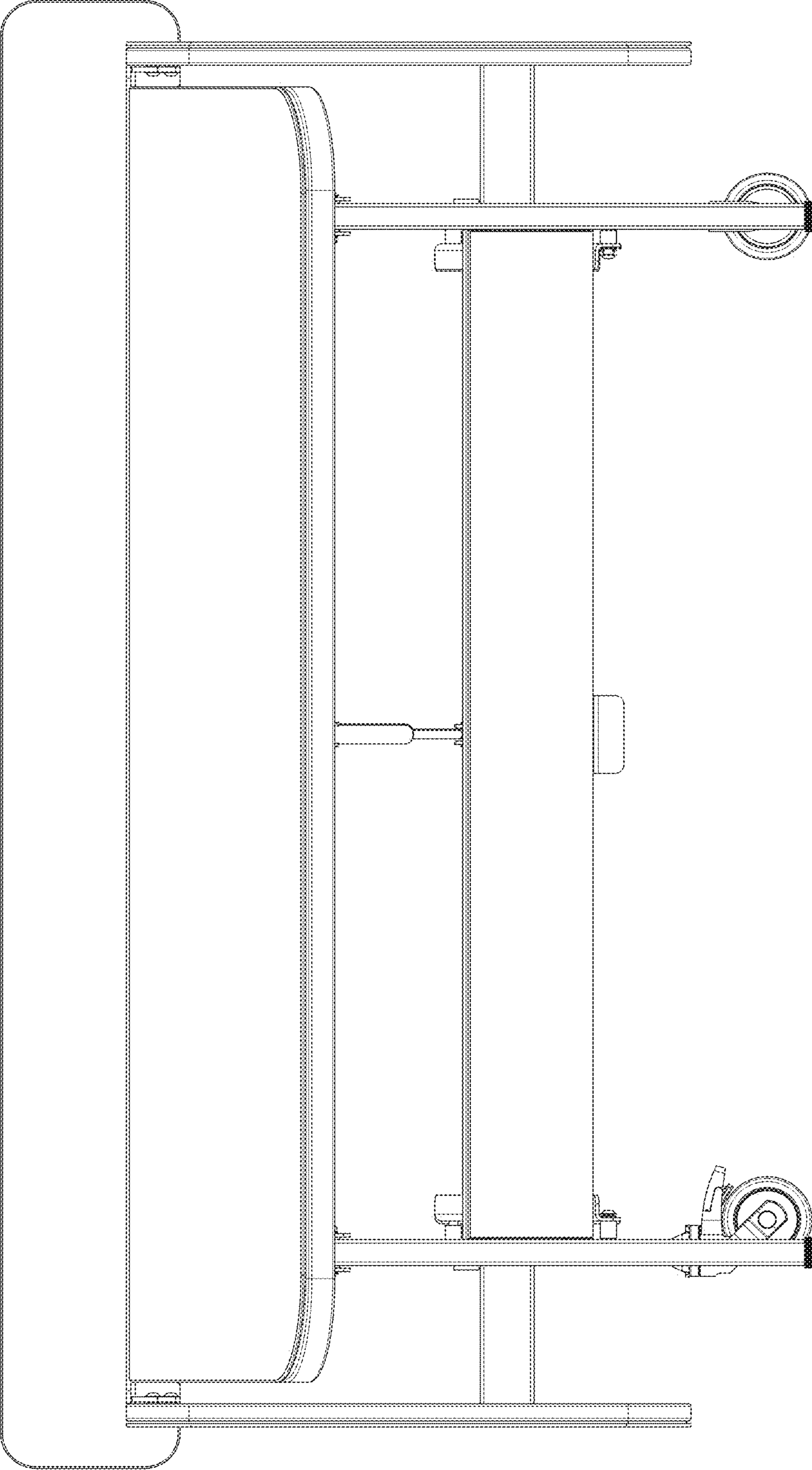

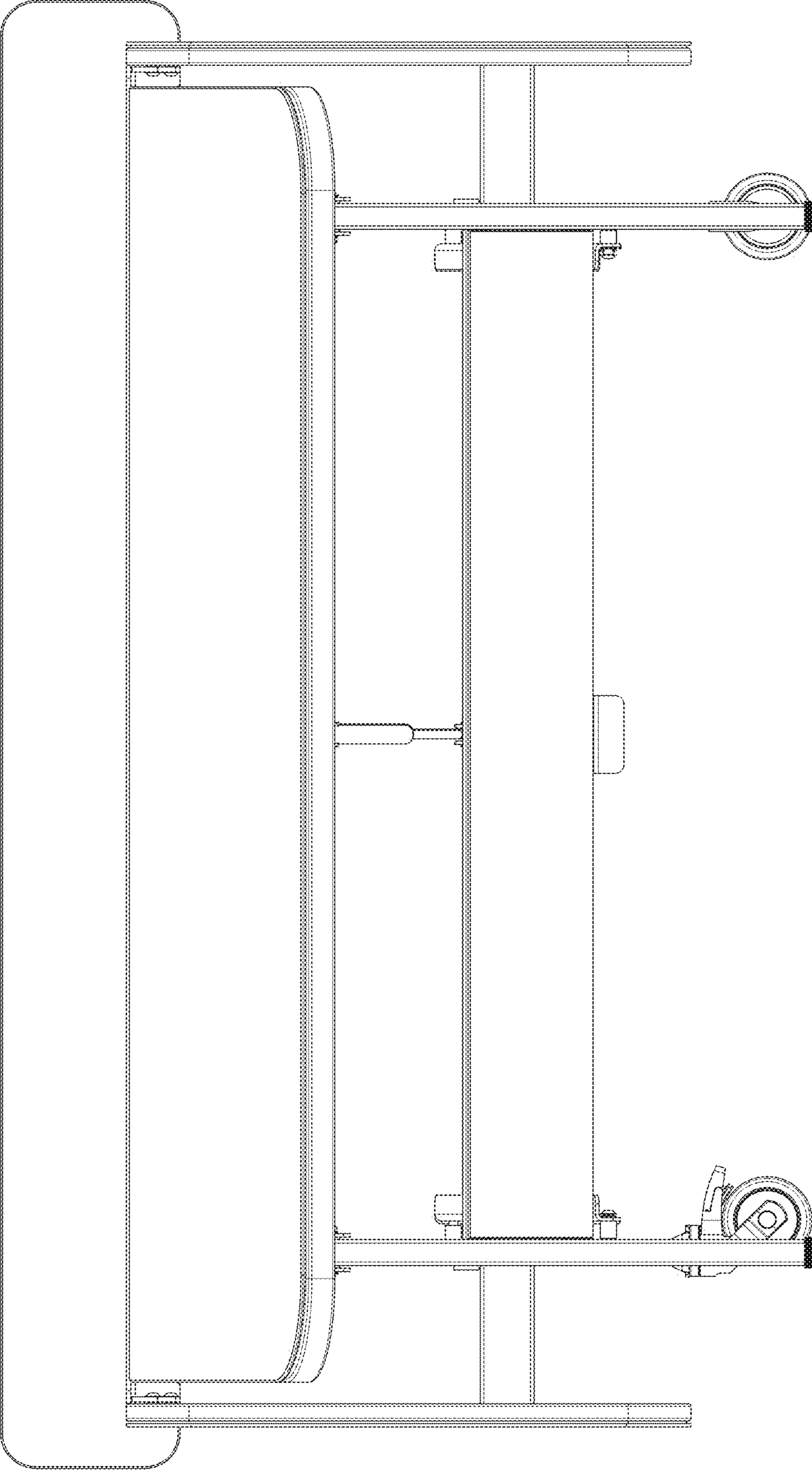
