**DESCRIPTION**

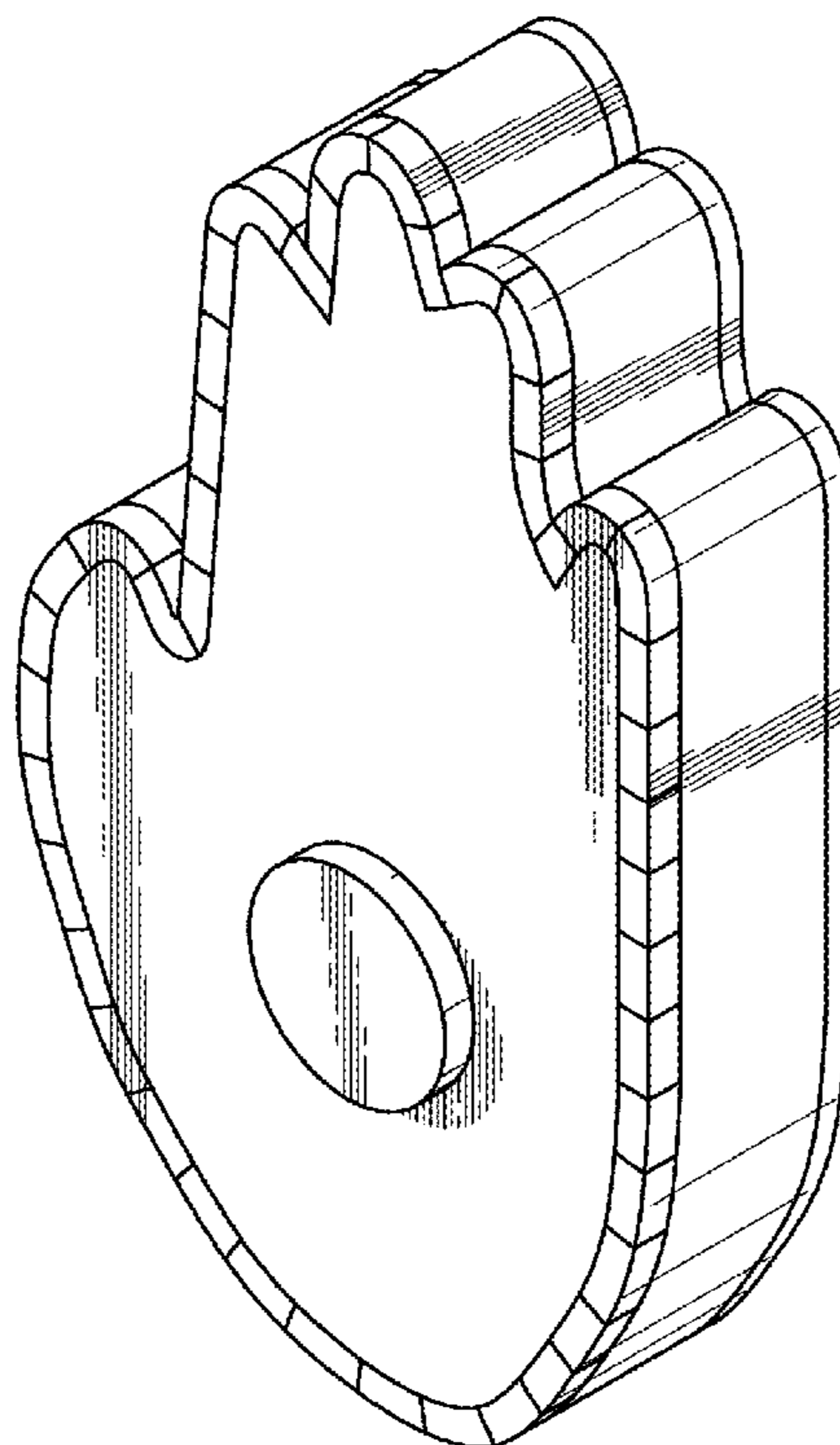
FIG. 1 is a perspective view of an applause hand in accordance with the present design;

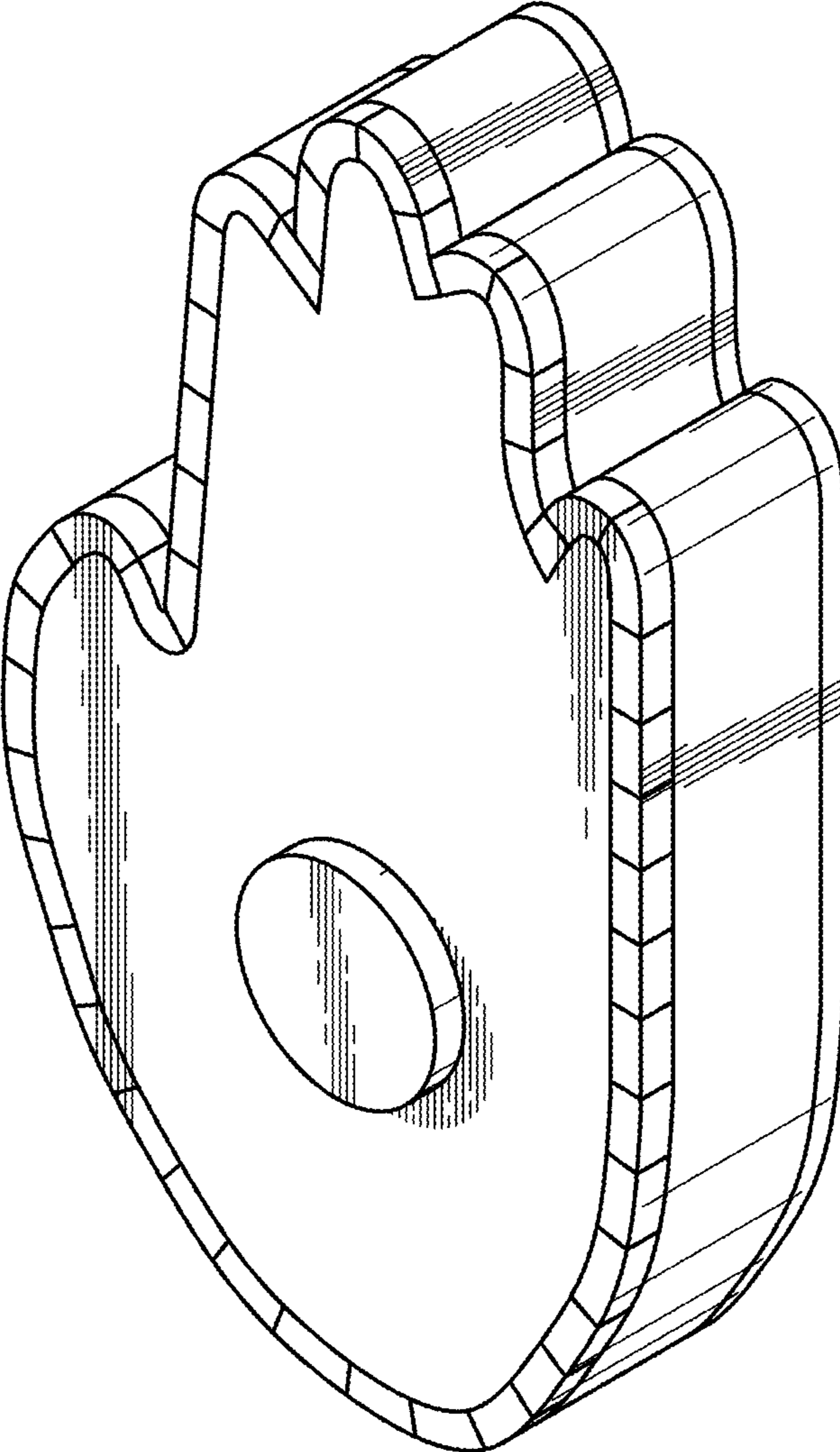
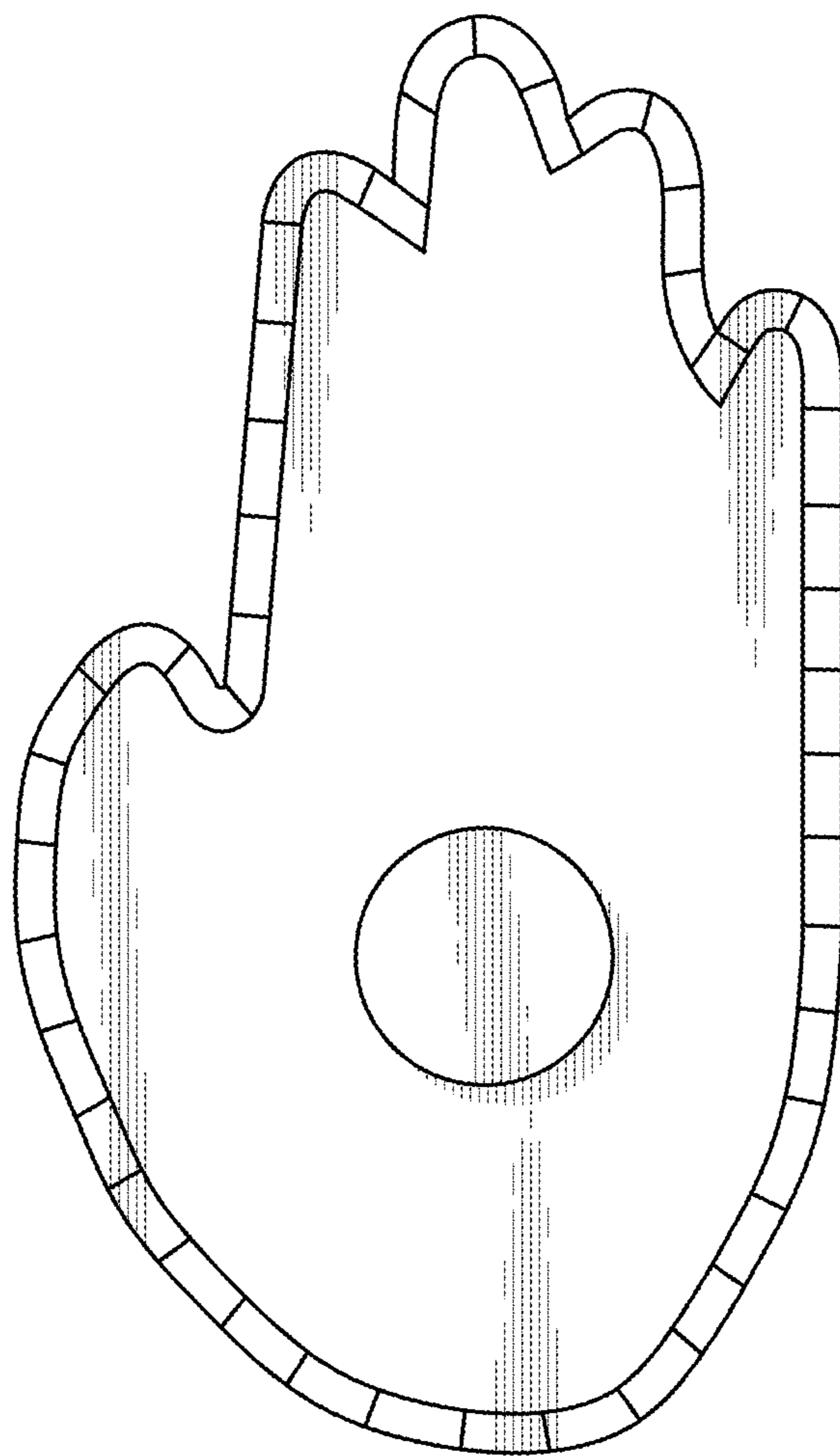
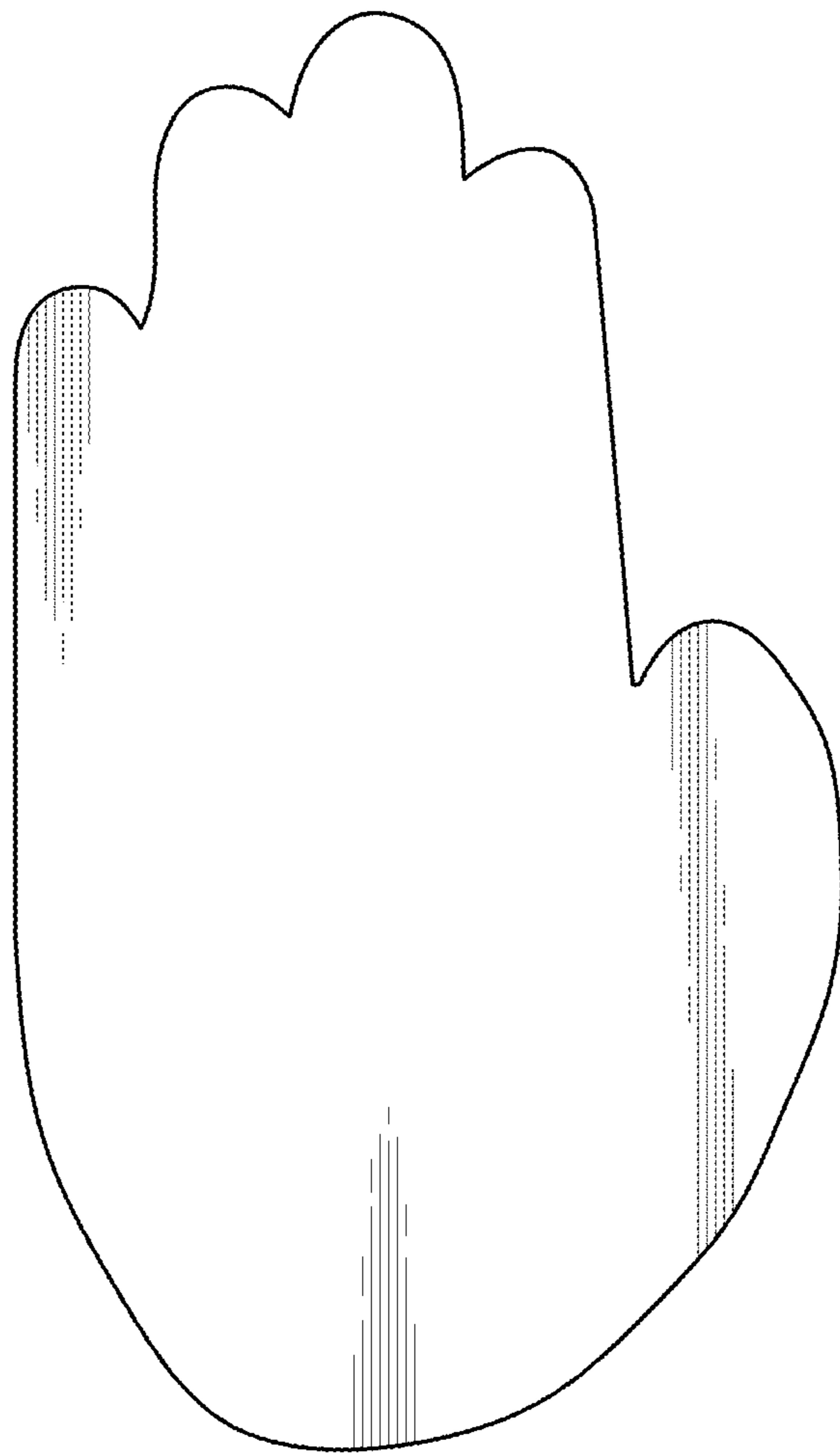


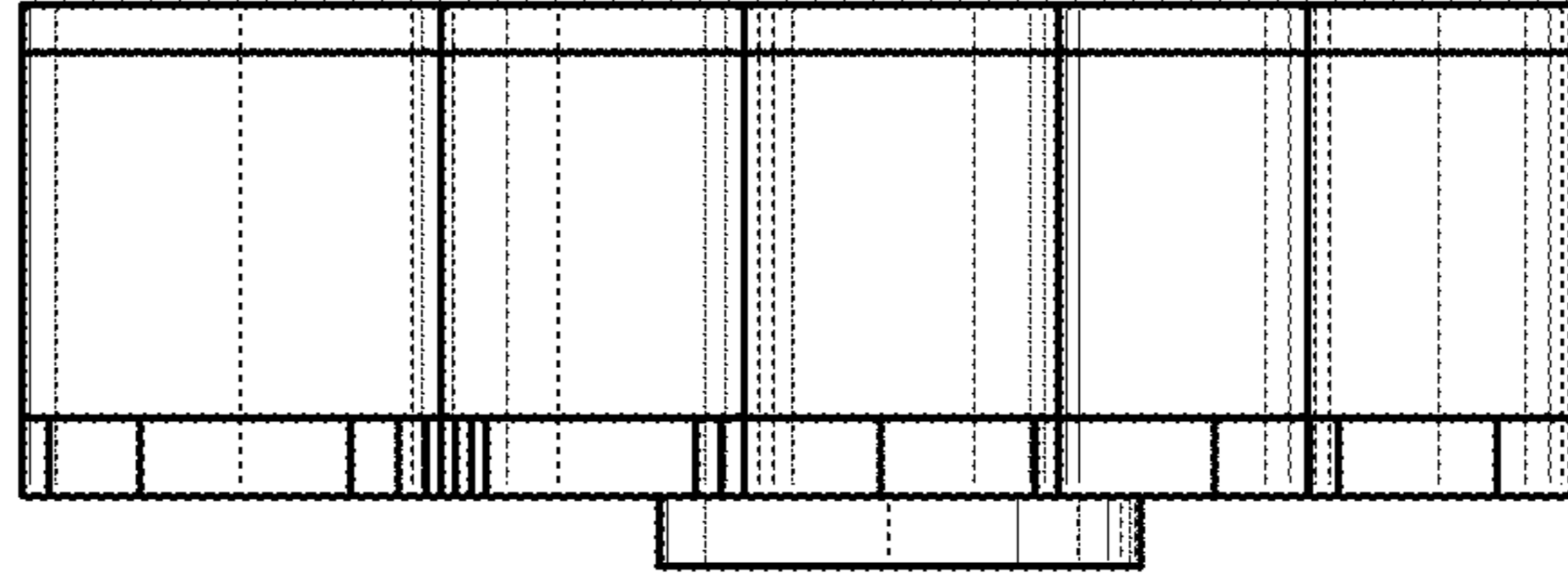

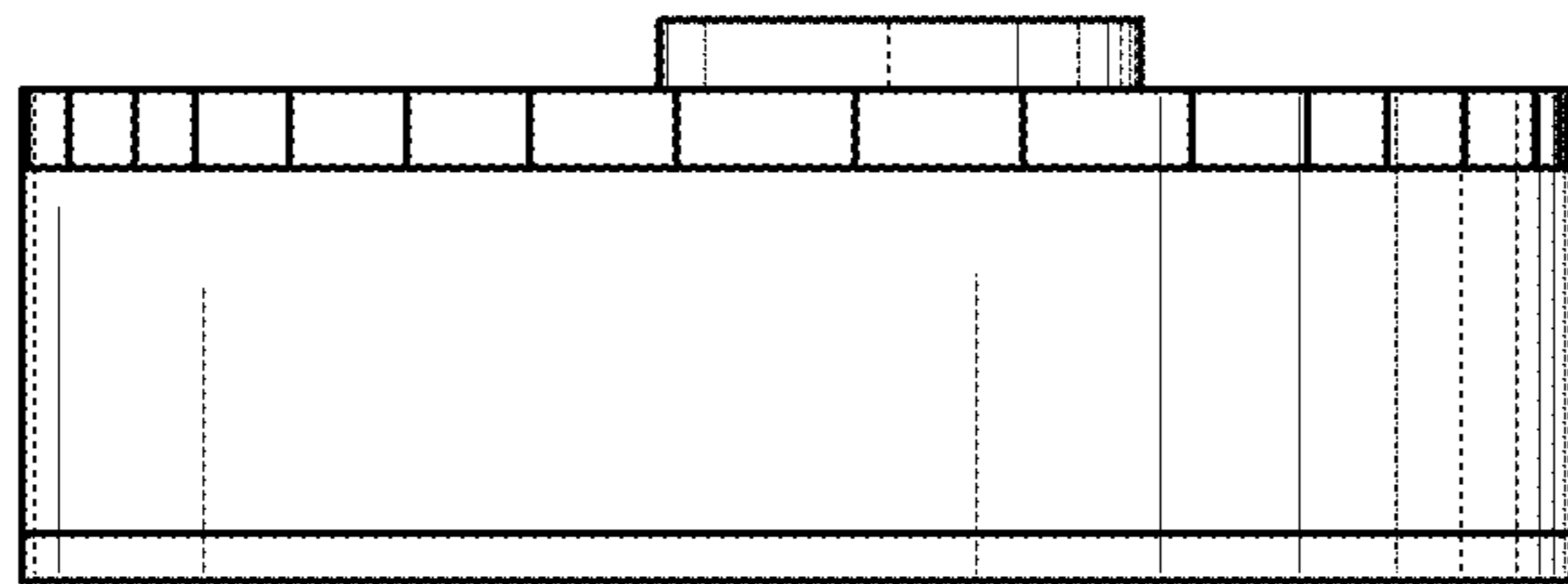

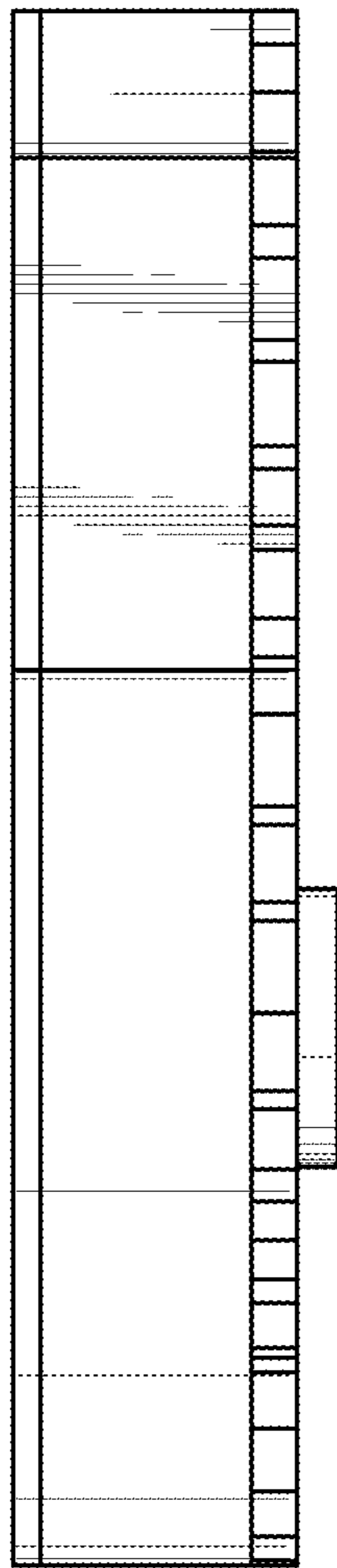

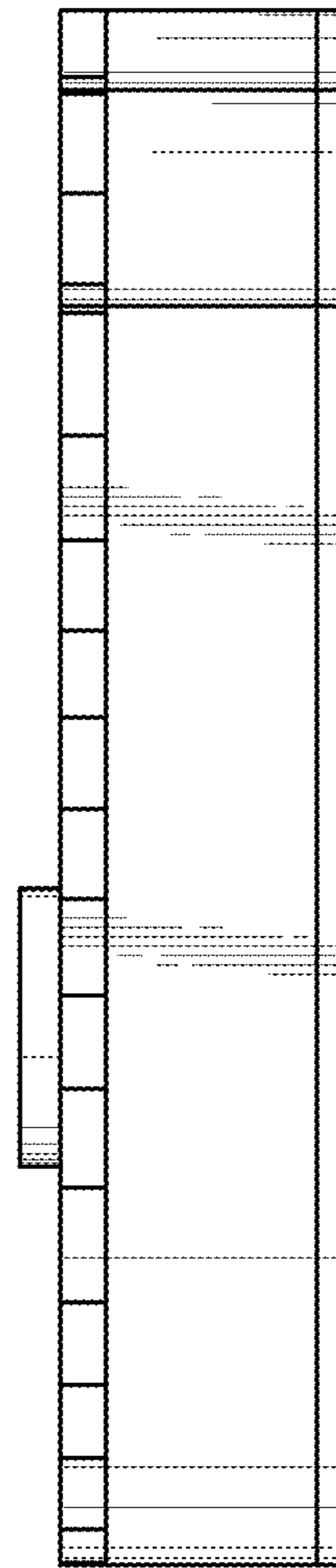
