FIG. 5 is a right side view of FIG. 1.

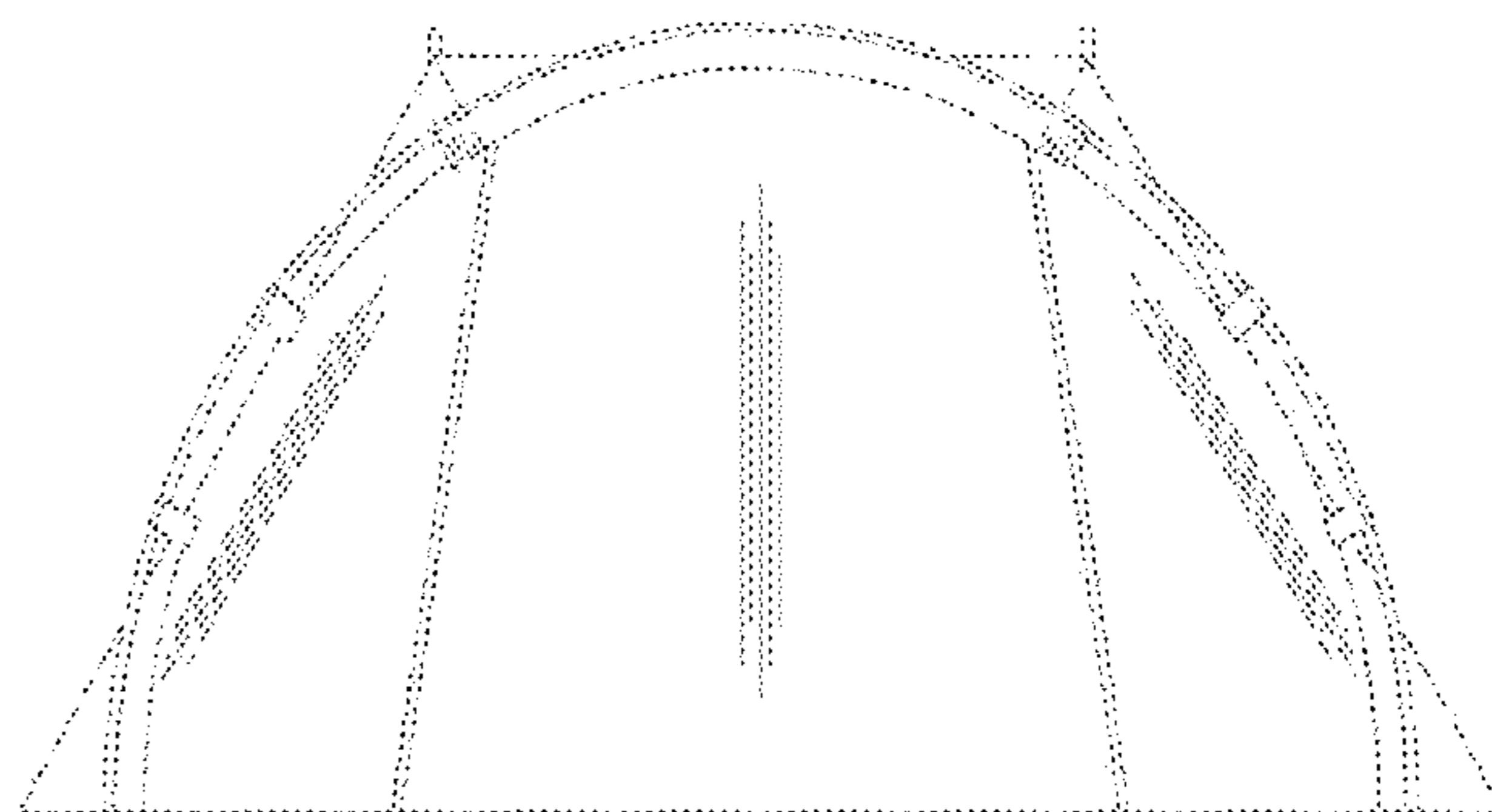
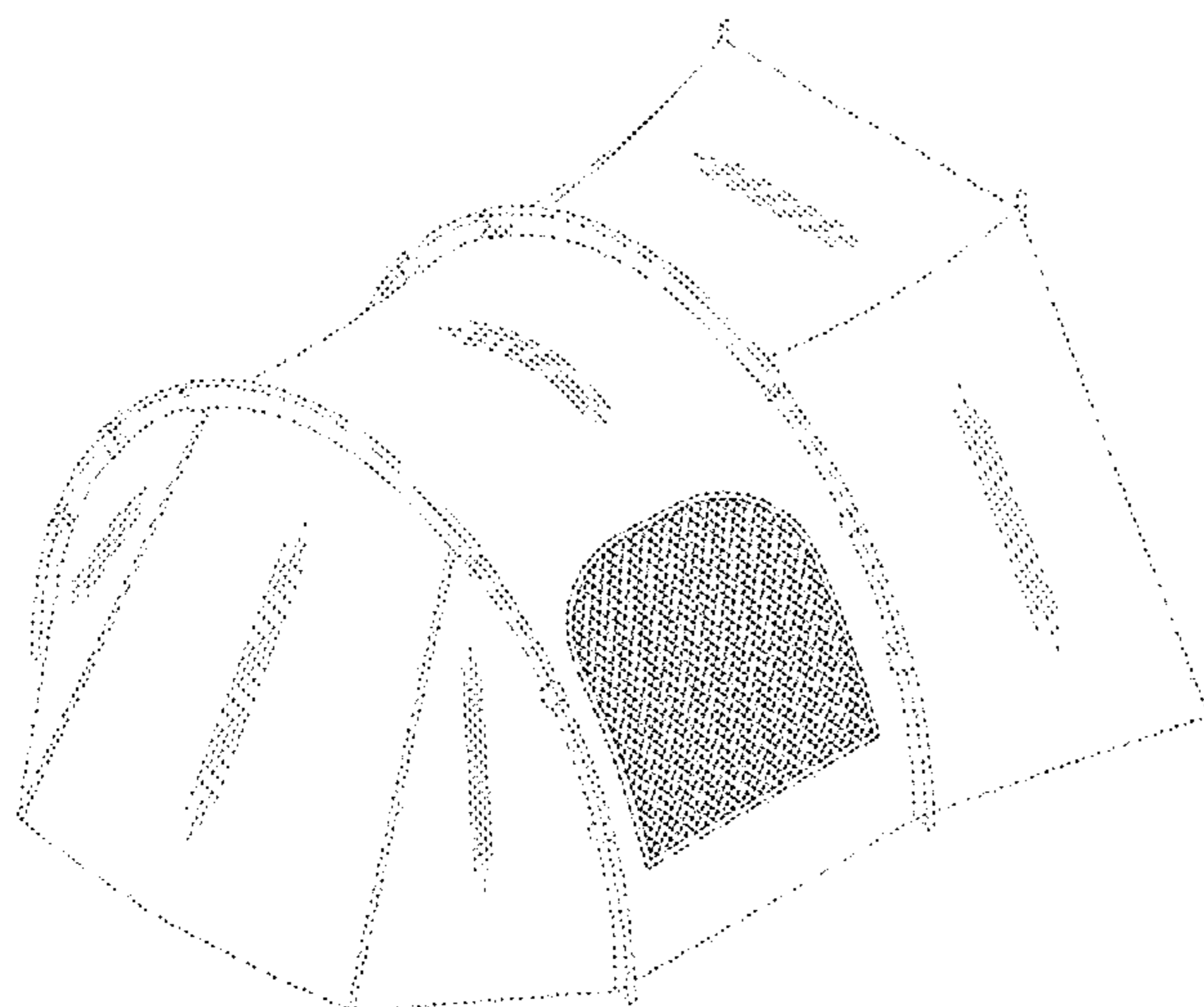
FIG. 6 is a top plan view of FIG. 1.

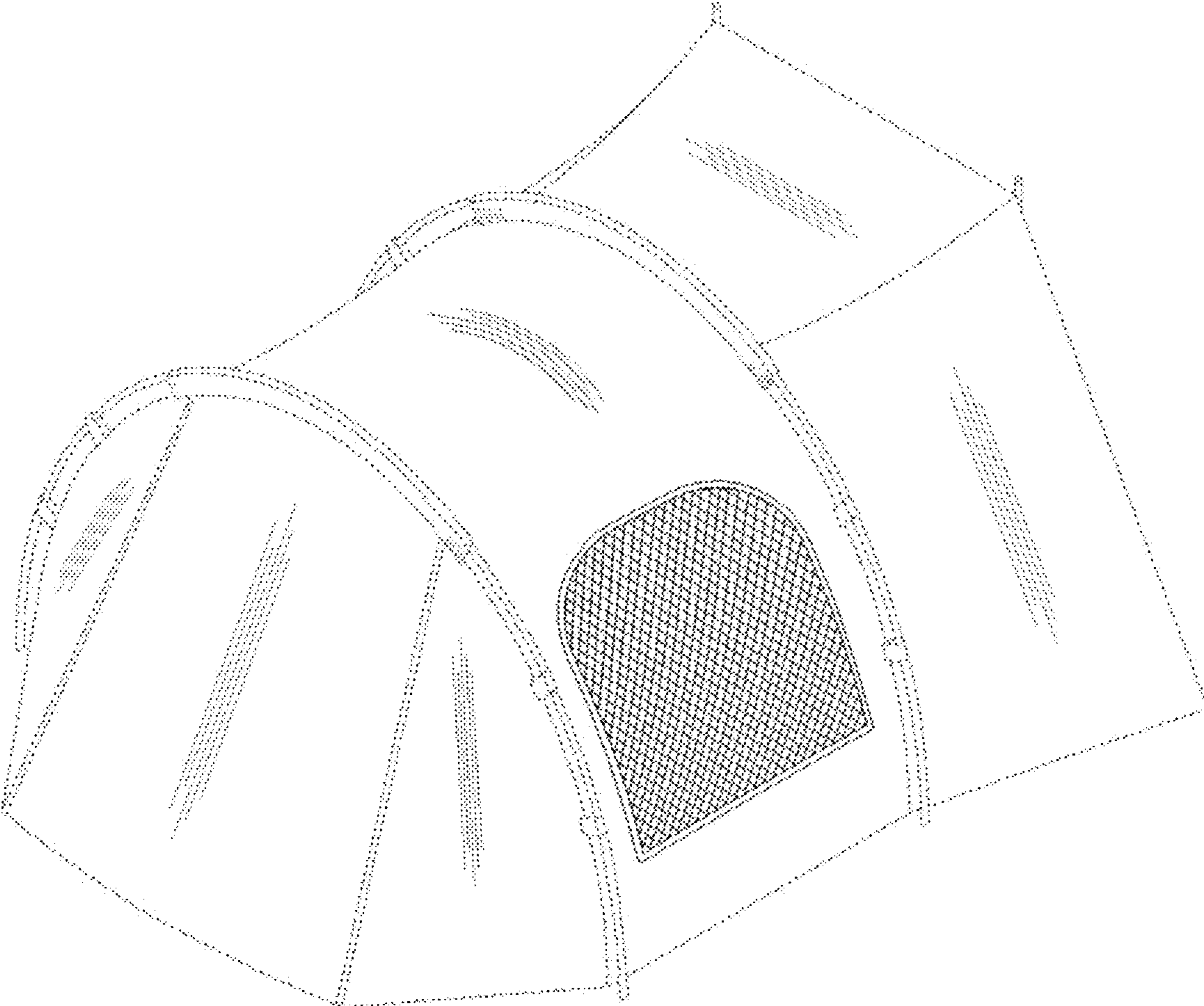

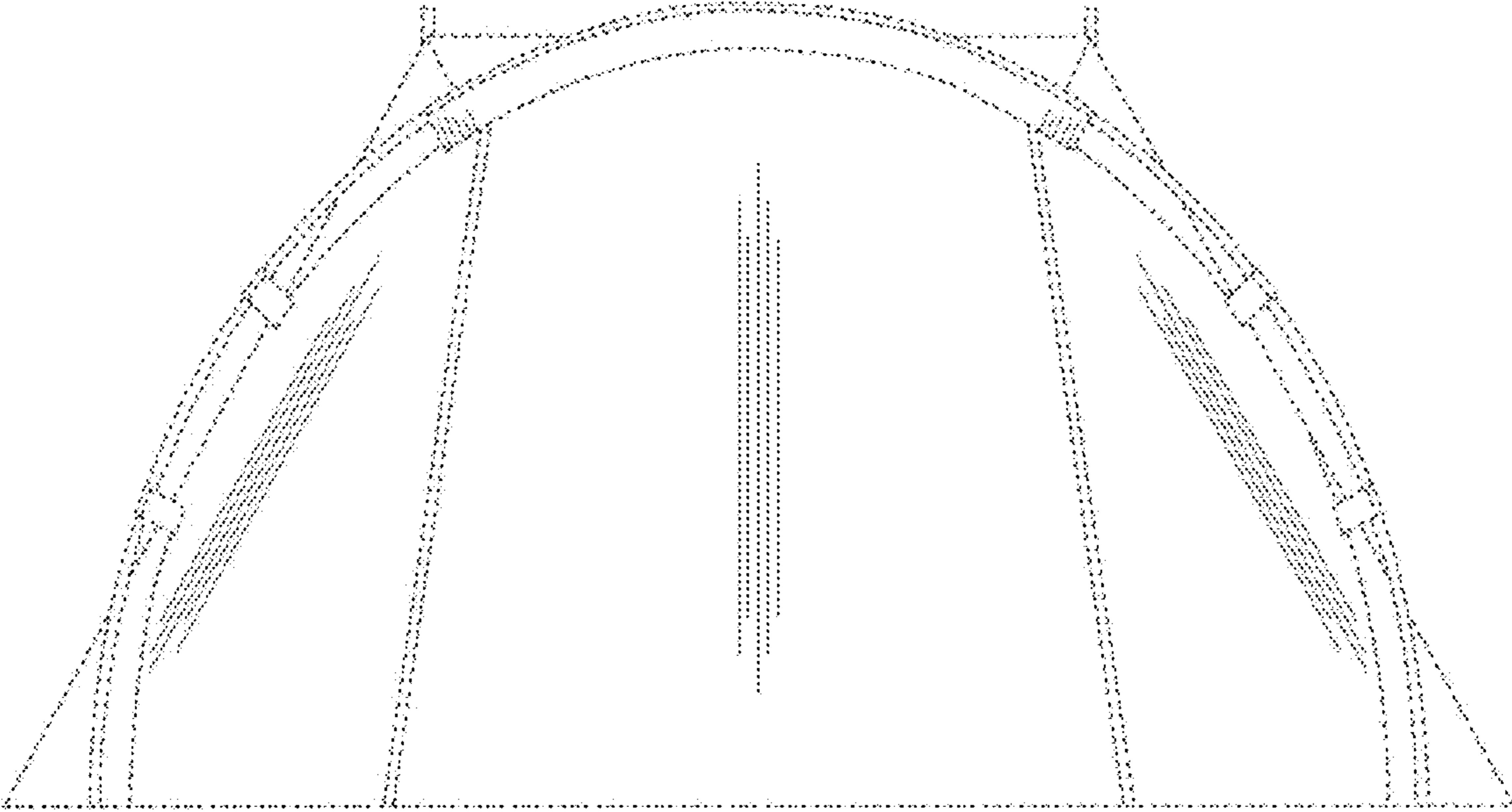

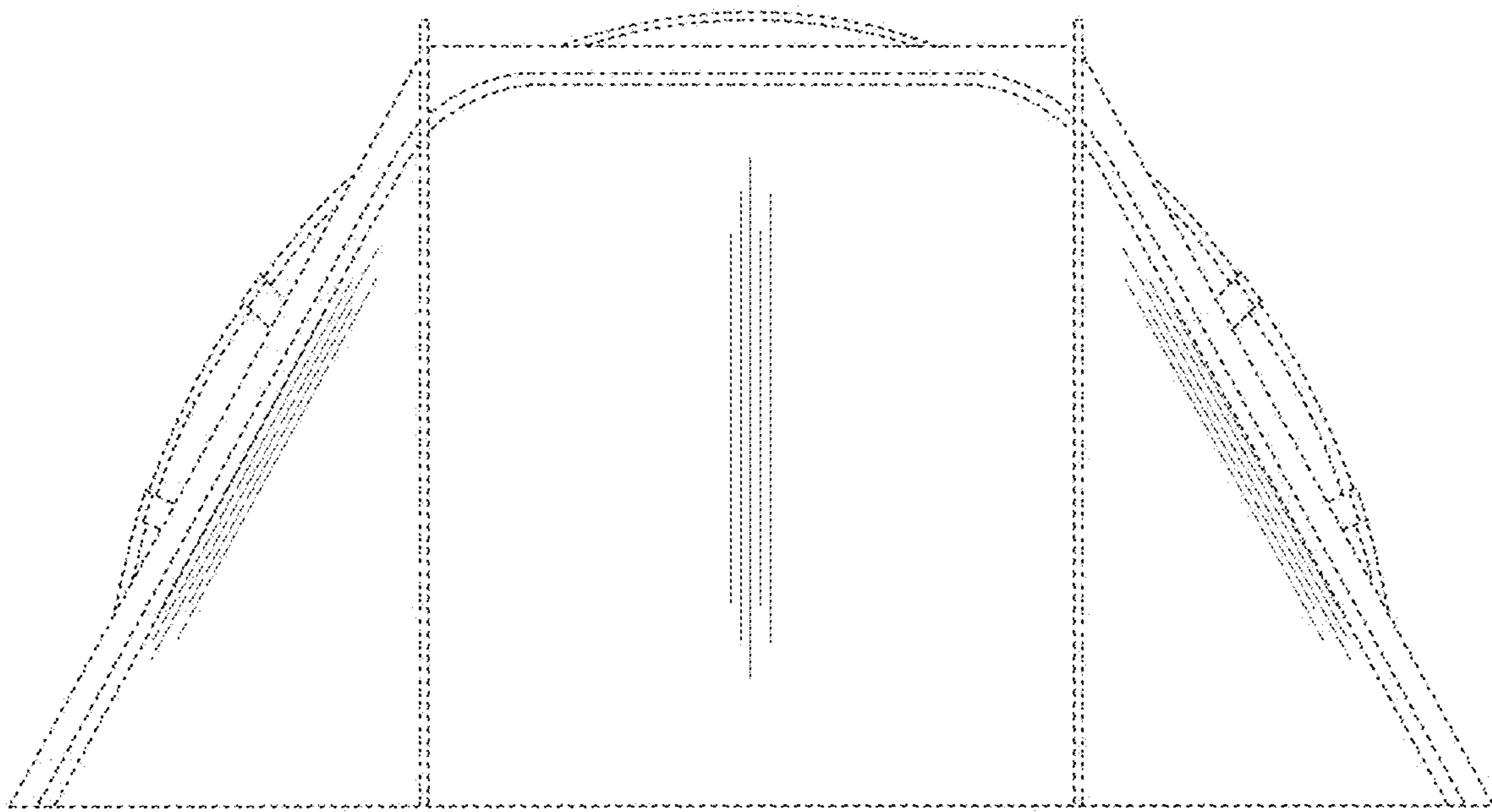

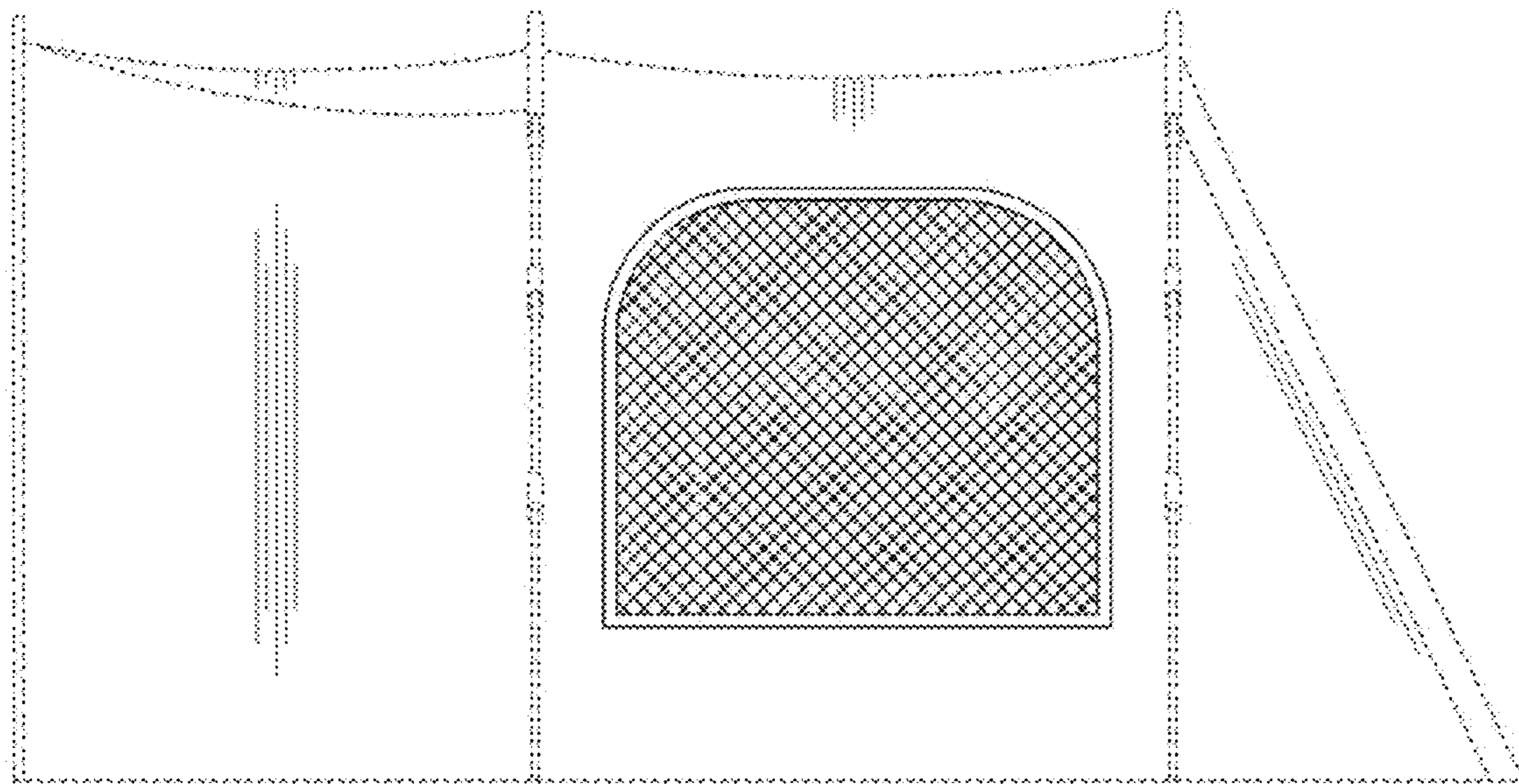

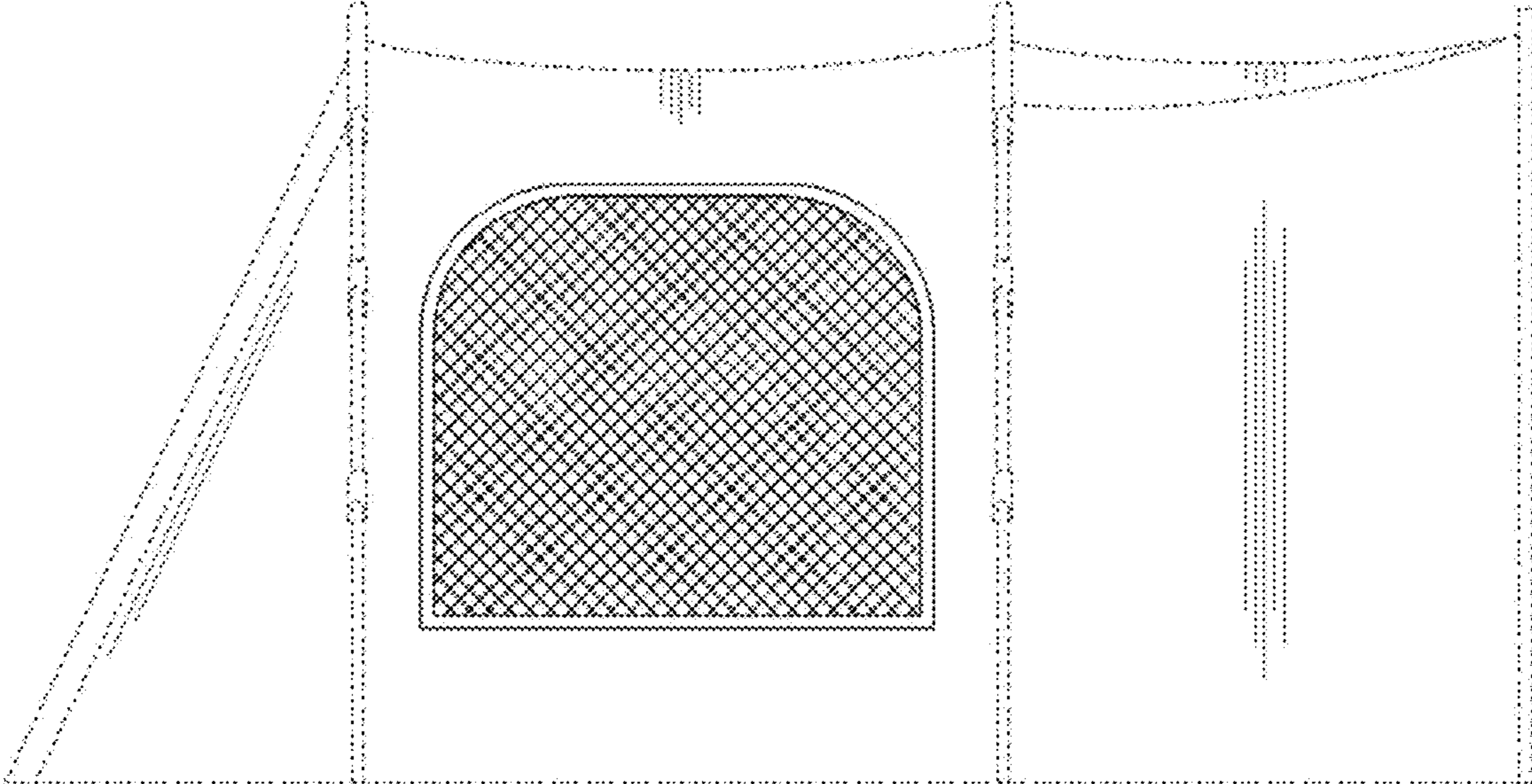

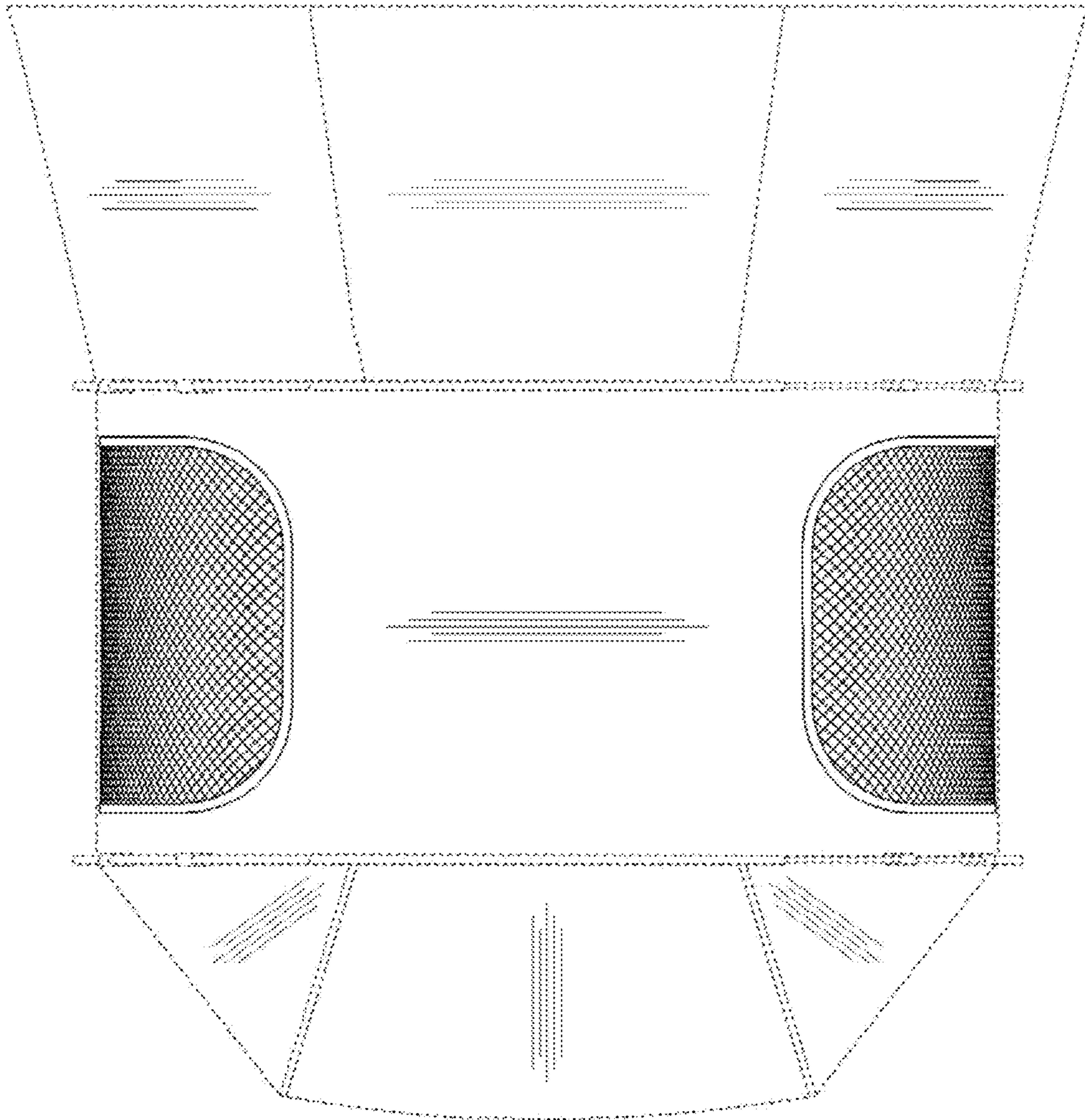

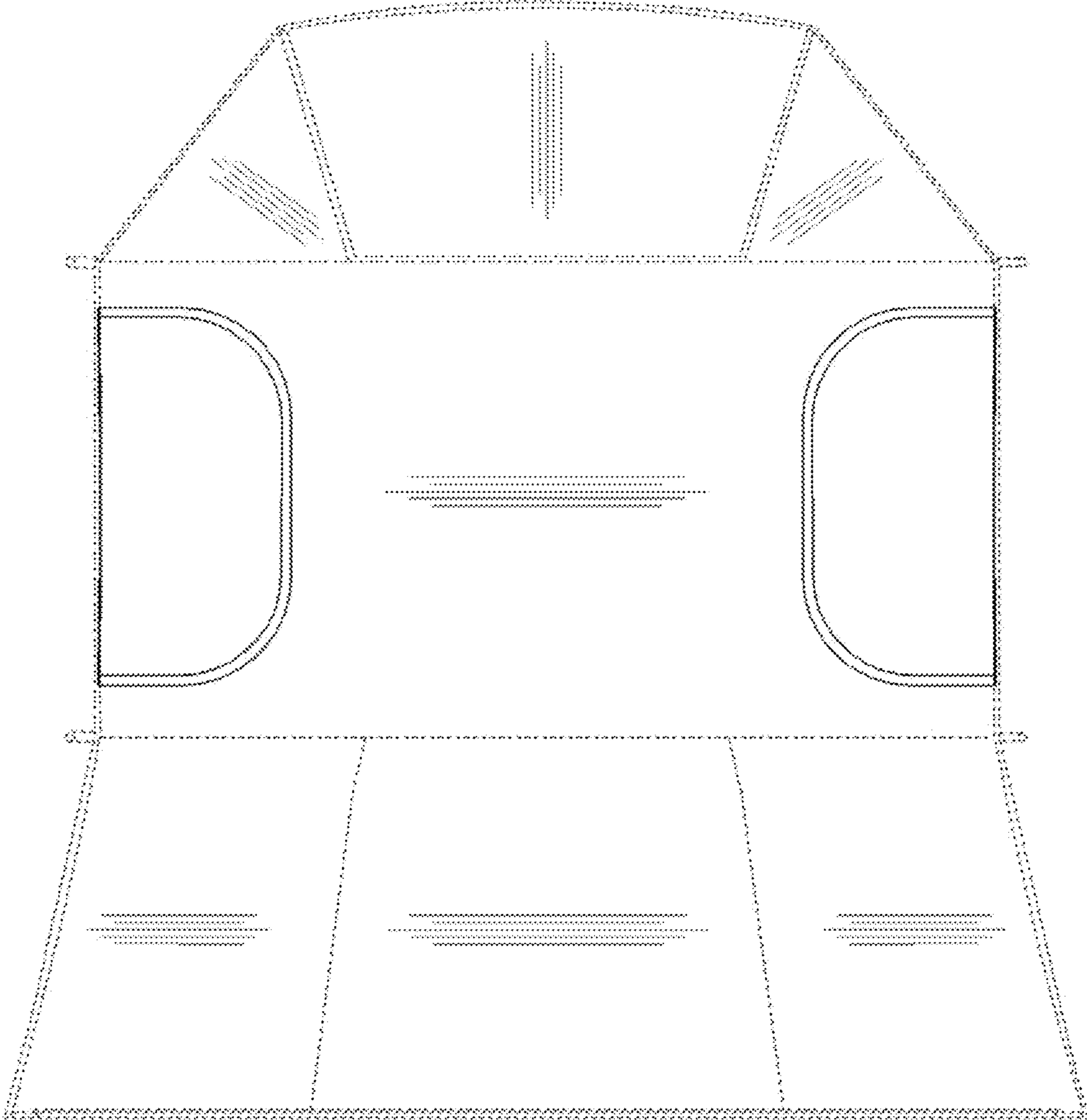

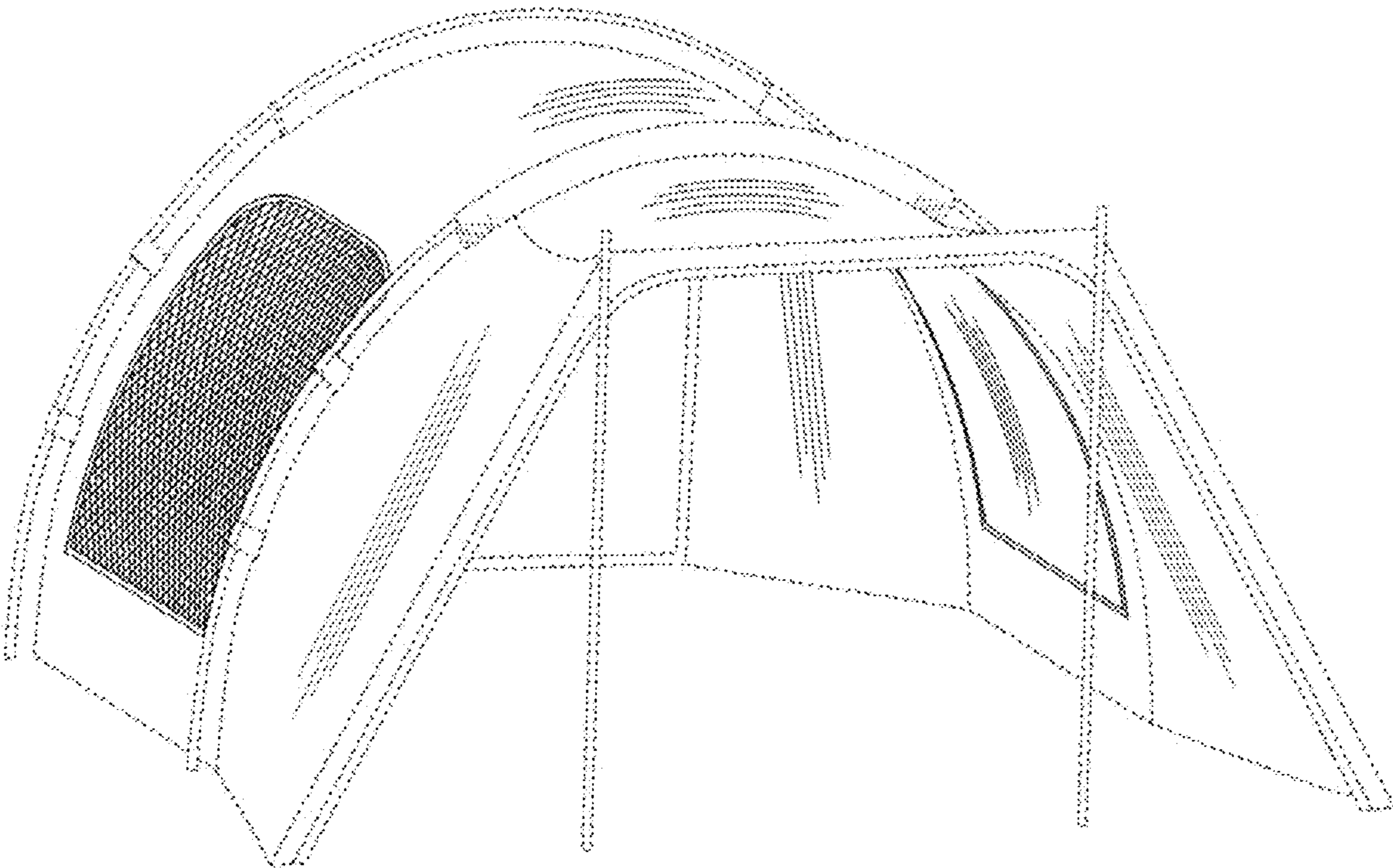
