**DESCRIPTION**

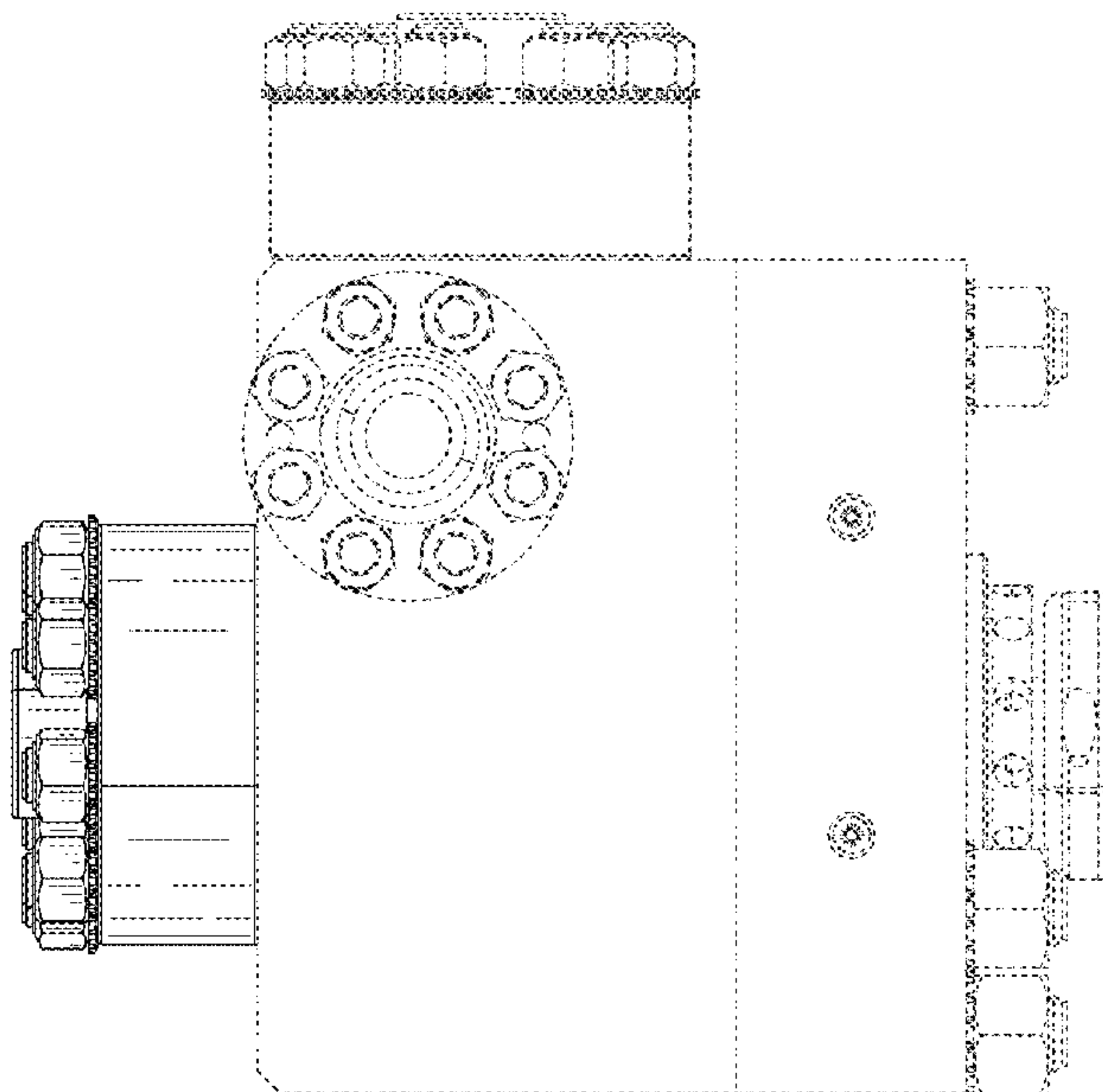
FIG. 1 is a right side plan view of a fluid end of our new design;

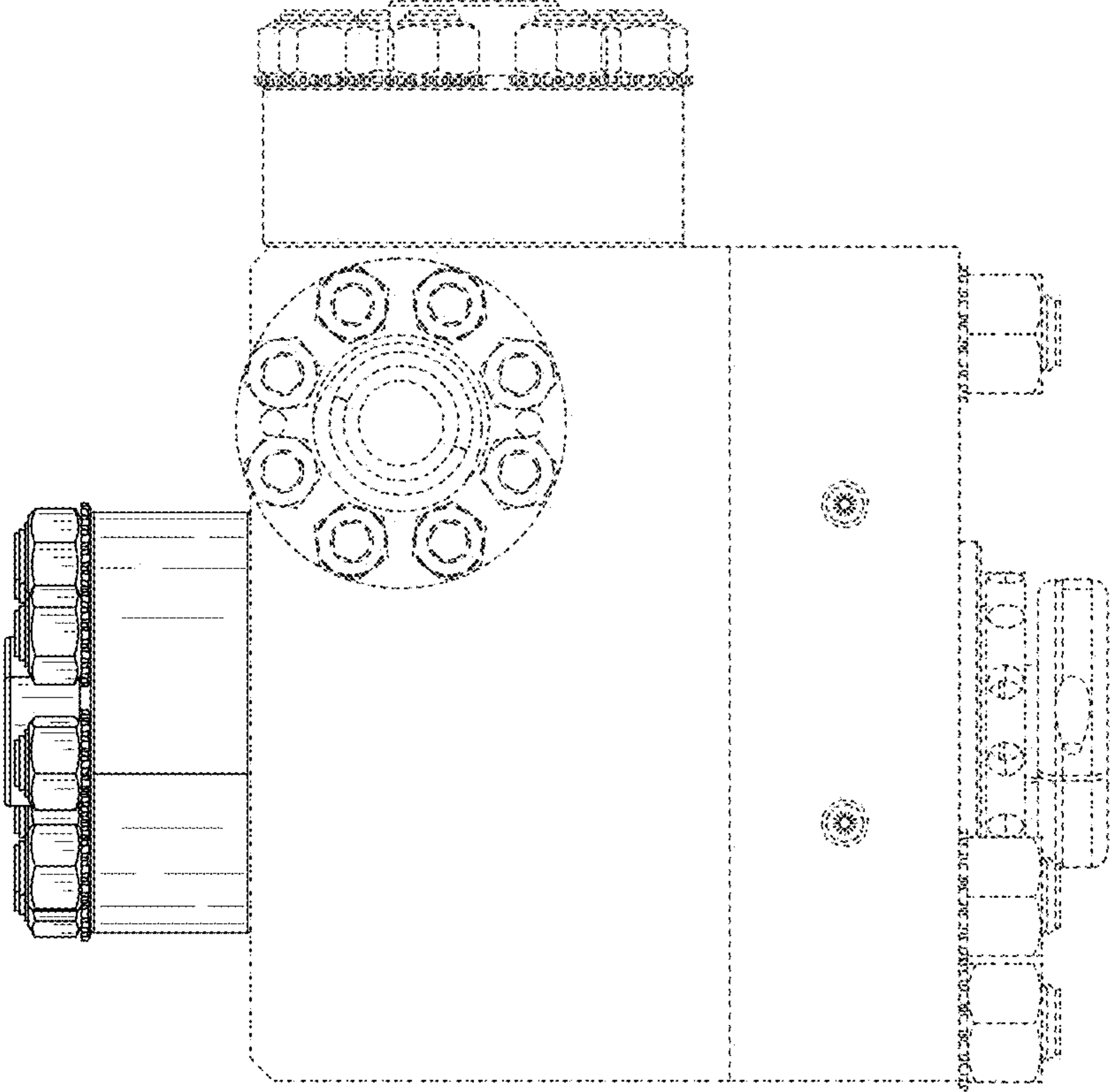

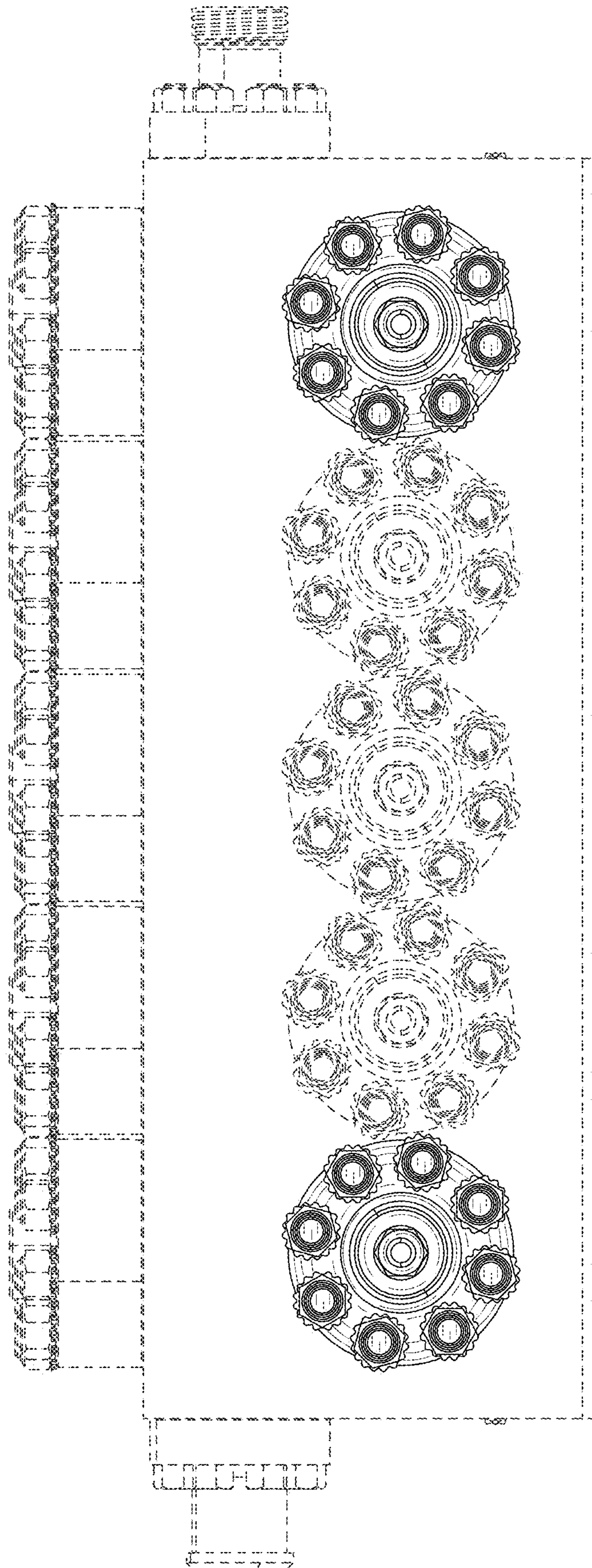

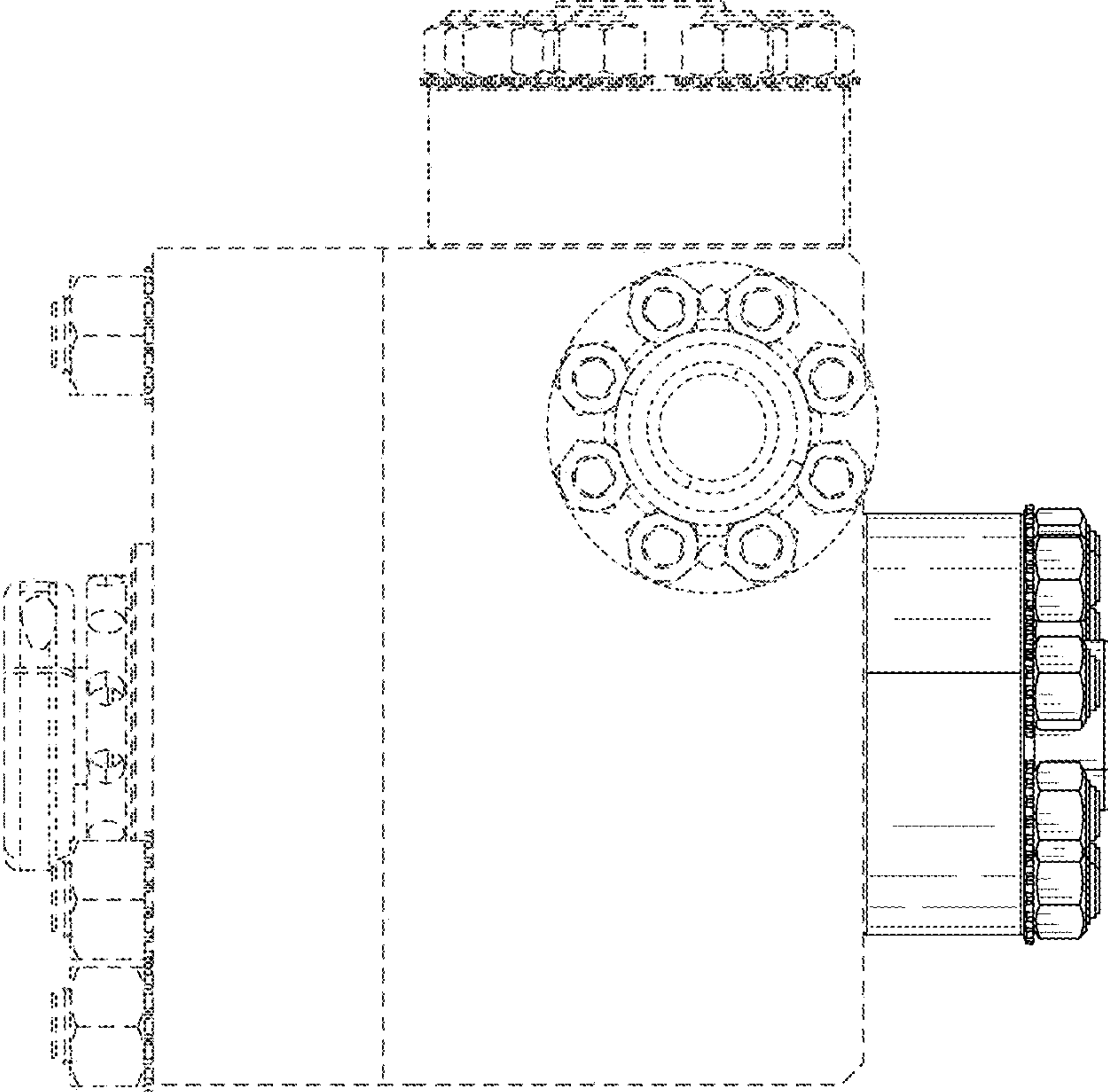

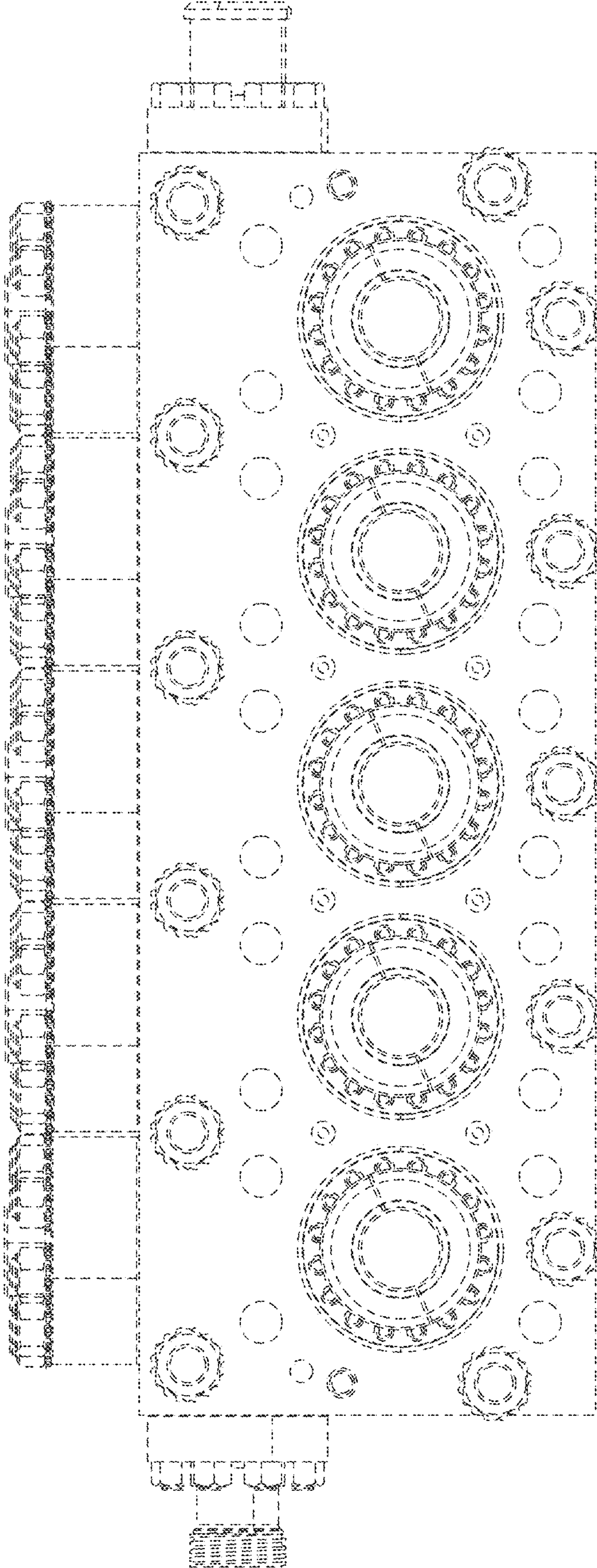

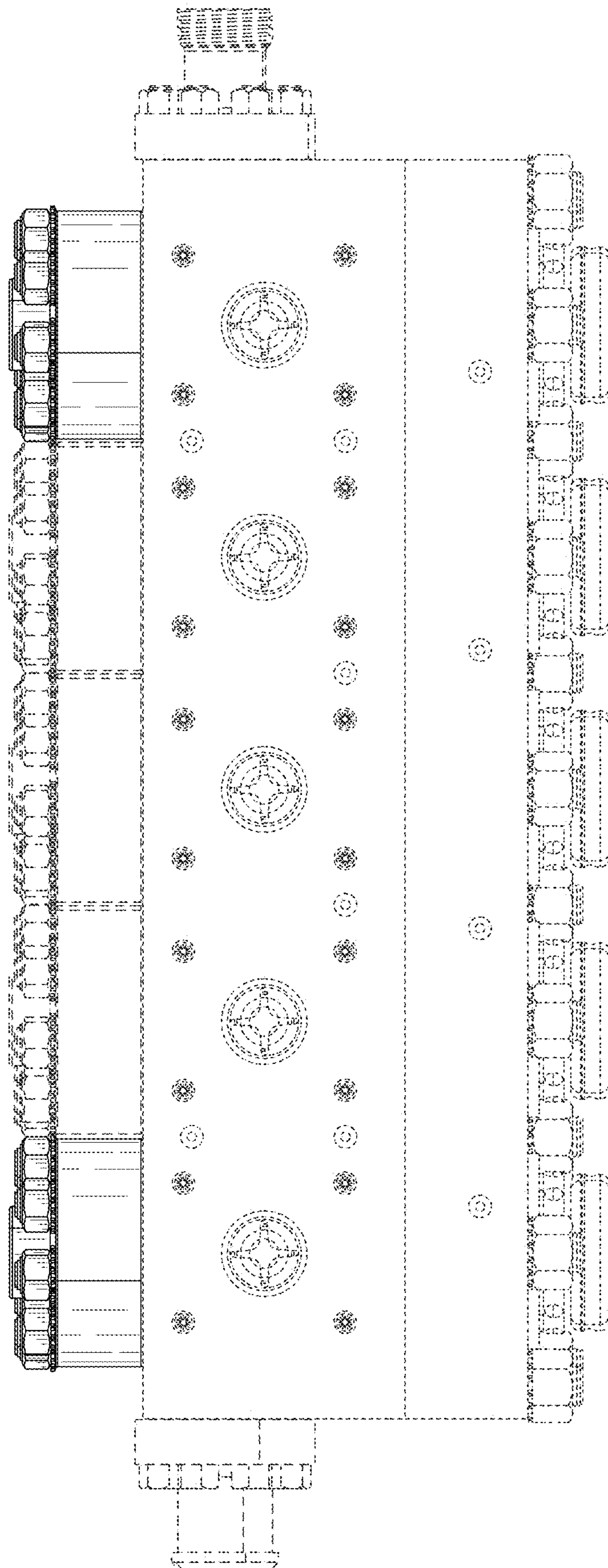

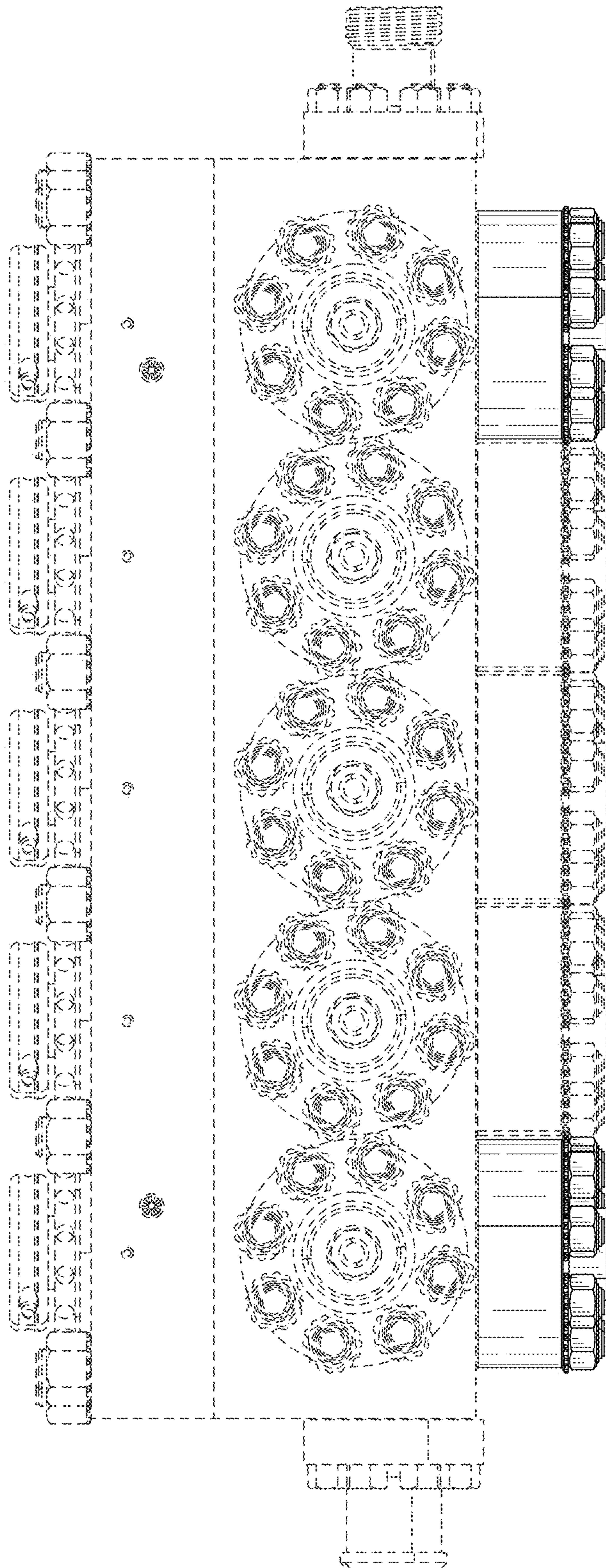

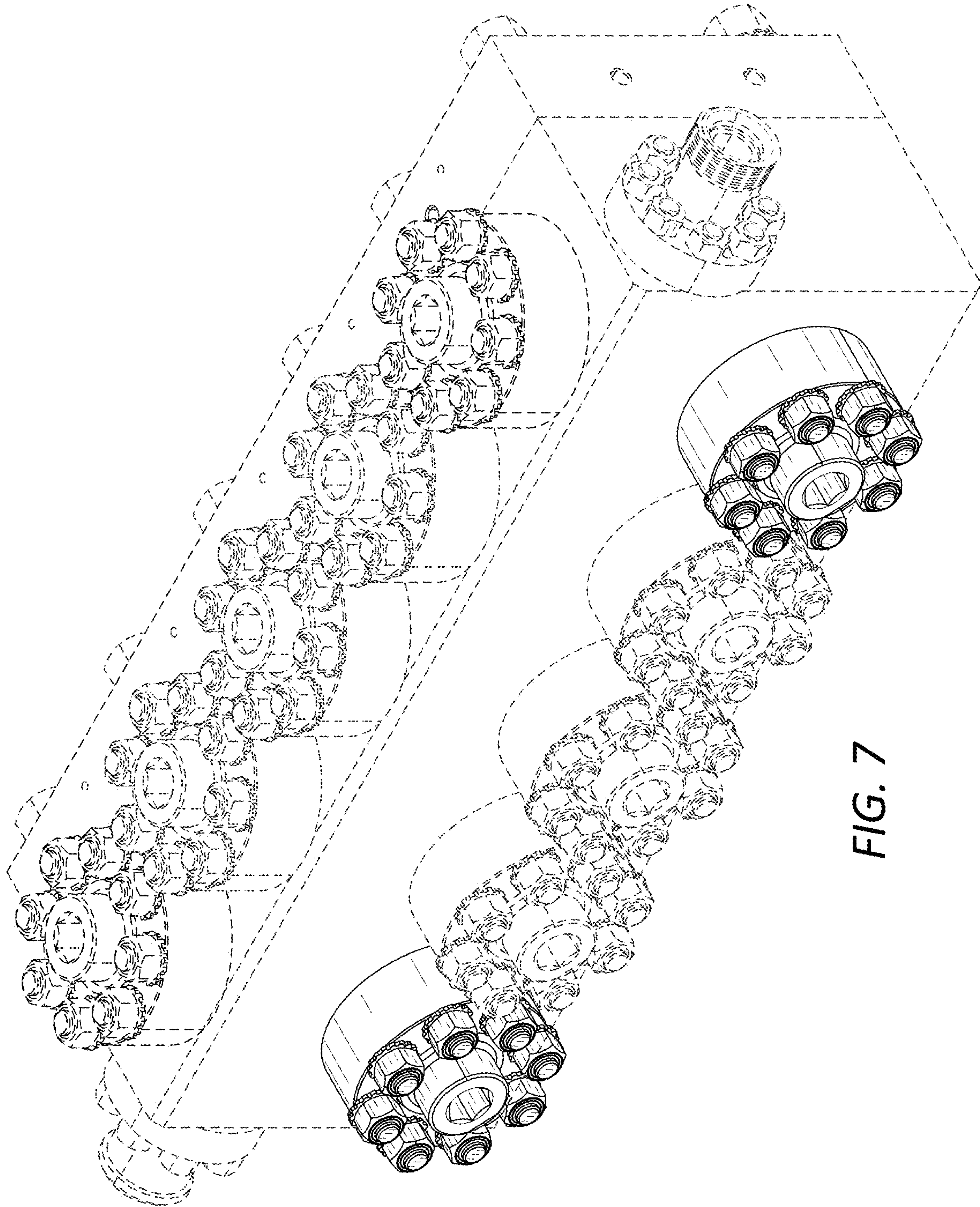

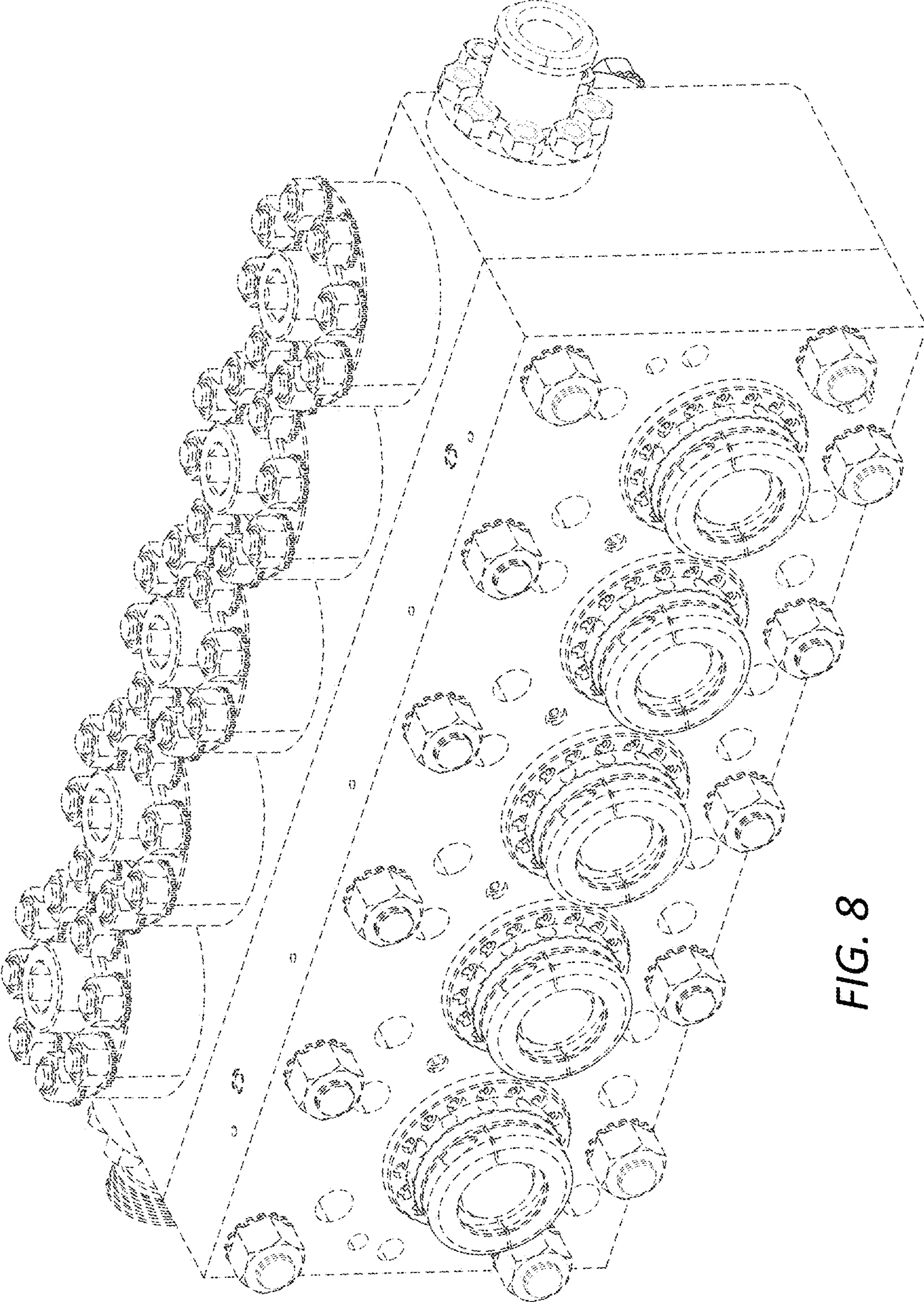
